## Chairman's Statement 主席報告

On behalf of the board (the "Board") of directors (the "Director") of SH Group (Holdings) Limited (the "Company"), I am pleased to present the annual report of the Company and its subsidiaries (collectively as the "Group") for the year ended 31 March 2022 (the "Year" or "FY2022").

The Group is principally engaged in providing electrical and mechanical engineering ("E&M engineering") services in Hong Kong. We focus our efforts on the supply, installation and maintenance of mechanical ventilation and airconditioning system ("MVAC system") and also provide services in relation to low voltage electrical system and other E&M systems, including fire services system, plumbing and drainage system, in both private and public sectors.

#### RESULTS

During the Year, the Group recorded an increase in revenue by approximately HK\$45.7 million, or 6.5%, from approximately HK\$707.6 million for the year ended 31 March 2021 ("Last Year" or "FY2021") to approximately HK\$753.3 million for the Year. The revenue generated by projects of MVAC system contributed 84.4% of total revenue of the Group whilst revenue generated by projects of low voltage electrical system contributed 15.6% of total revenue of the Group.

The Group recorded a profit for the Year of approximately HK\$11.7 million, representing a decrease of 73.5% or HK\$32.4 million from approximately HK\$44.1 million in FY2021.

## DIVIDEND

The Board has recommended a payment of final dividend of HK1.0 cent per ordinary share for the Year (2021: HK3.9 cents per ordinary share).

#### BUSINESS OVERVIEW

#### **MVAC** system

During the Year, the Group was awarded 11 projects in relation to MVAC system installation with an aggregate contract sum of approximately HK\$682.9 million. The awarded projects are in both private and public sectors, which are not limited to residential projects but also involving in community facilities, MVAC system maintenance and replacement projects. The various types of awarded new projects, together with the continual progress of projects awarded in previous years, would provide the Group stable revenue and earnings in the coming years.

本集團主要在香港從事提供機電工程 (「機電工程」)服務。我們專注於在私營 及公營領域供應、安裝及維修機械通風 及空調系統(「機械通風空調系統」),亦 提供低壓電氣系統及其他機電系統的相 關服務,其中包括消防系統及供水和排 污系統服務。

## 業績

本集團於本年度錄得收益增長約4,570 萬港元或6.5%,由截至二零二一年三月 三十一日止年度(「上年度」或「二零二一 財年」)約7億760萬港元增加至本年度約 7億5,330萬港元。機械通風空調系統項 目產生的收益貢獻本集團總收益84.4%, 而低壓電氣系統項目產生的收益貢獻本 集團總收益15.6%。

本集團錄得本年度溢利約1,170萬港元, 較二零二一財年約4,410萬港元減少73.5% 或3,240萬港元。

## 股息

董事會建議派付本年度末期股息每股普 通股1.0港仙(二零二一年:每股普通股3.9 港仙)。

#### 業務概覽

#### 機械通風空調系統

於本年度,本集團獲授11個與機械通風 空調系統安裝有關的項目,合約總值約 為6億8,290萬港元。獲授項目涵蓋私營 及公營領域,不限於住宅項目,亦涉及 社區配套設施、機械通風空調系統的維 修及更換項目。獲授不同類型的新項目 加上過往年度獲授項目的持續進展將可 為本集團未來數年提供穩定收益及盈利。

## Chairman's Statement 主席報告

#### Low voltage electrical system

During the Year, the Group was awarded I project in relation to electrical system installation with a contract sum of approximately HK\$108.7 million. The revenue contributed from projects of low voltage electrical system to the total Group's revenue have been maintaining at similar level from FY2021 to FY2022, around 15% to 20%, while the total revenue of the Group increased by 6.5%. This is consistent with the business plan of the Group to steadily increase the revenue and profit generated from projects of the low voltage electrical system.

### OUTLOOK

In the past year, the Coronavirus Disease 2019 ("Covid-19") pandemic continued to affect worldwide and weighed heavily on the economy. Recently the fifth wave of Covid-19 put pressure on Hong Kong's economic recovery. The construction and E&M engineering services industry was facing severe situations such as manpower shortage and logistic delays, which at the same time led to an increase in material and transportation costs and also the difficulty of the cargo transportation. These situations eventually caused the delay in the projects in progress. The past year was a difficult year for most of the industries in Hong Kong.

Looking forward, in order to address the housing demand of the public and increase the housing supply, the Government has implemented a number of housing policies and measures, including the development plan on the "Northern Metropolis" and long-term initiatives such as "Land Sharing Pilot Scheme", rezoning sites for housing development and brownfield development etc. Together with additional railway property development projects and private development and redevelopment projects, the demand for the construction and E&M engineering services is expected to increase in the coming years. At the same time with the above impacts arising from the Covid-19 is gradually under control in Hong Kong and Mainland China, the progress of the construction and E&M engineering projects in Hong Kong is expected to ramp up. Meanwhile, through the coordination between the relevant departments in Shenzhen and Hong Kong, the time and costs for transportation between Hong Kong and Mainland China are also expected to be back to normal gradually.

#### 低壓電氣系統

#### 未來前景

於過去的一年,2019冠狀病毒病 (「Covid-19」)疫情繼續在世界各地肆虐, 對經濟造成打擊。近期第五波Covid-19 阻礙香港經濟復甦。建築及機電工程服 務業面臨人手短缺及物流延誤等嚴峻情 況,同時導致物料及運輸成本上漲,亦 令貨物運輸困難增加,以致在建項目出 現延誤。過去一年對於香港大多數行業 而言,確實是比較艱辛的一年。

展望將來,政府為滿足市民的房屋需 求,加大房屋供應量,推行多項房屋政 策及措施,包括「北部都會區」的發展計 劃及「土地共享先導計劃」、重新規劃 反「土地共享先導計劃」、重新規劃 民發展用地及發展棕地等長遠措施, 見額外的鐵路物業發展項目及私人發展 及重建項目,預期未來數年對建時及 及重建服務的需求將會增加。同時隨 及重建服務的需求將會增加。同時隨 及重建服務的需求將會增加。同時隨 及 載 一國大陸逐漸得以控制,預期本港的建 來 之機電工程項目將會提速,同時透過 深港兩地有關部門的協調,往返中港之 間的運輸時間及成本亦預期逐步重回正 軌。

Building on our long-established reputation, experience and proven track record in the industry, the Group takes a positive attitude in achieving a steady growth in our business and creating long-term value to our shareholders in the years to come.

### **BUSINESS REVIEW**

Our revenue increased by approximately HK\$45.7 million, or 6.5%, from approximately HK\$707.6 million for FY2021 to approximately HK\$753.3 million for FY2022. Major projects awarded and major projects undertaken in FY2022 are outlined below.

#### Projects awarded in FY2022

During FY2022, we were awarded 12 projects with an aggregate contract sum of approximately HK\$791.6 million (out of which 1 project with a contract sum of approximately HK\$108.7 million was related to electrical system installation).

## Major projects undertaken in FY2022

During FY2022, the Group continued to focus our efforts on the supply, installation and maintenance of MVAC system and low voltage electrical system. Revenue contributed by projects relating to MVAC system and low voltage electrical system accounted for approximately 84.4% and 15.6% respectively (2021:81.1% and 18.9%).

Recent development and future prospects

Subsequent to FY2022 and up to the date of this annual report, we were awarded 1 project with a contract sum of approximately HK160.9 million, which was related to MVAC system installation.

The future prospects of the Group is discussed under the paragraph "Outlook" of the Chairman's Statement on pages 5 to 6 of this annual report.

## 近期發展及未來前景

#### FINANCIAL REVIEW

#### Revenue

Our revenue increased by approximately HK\$45.7 million, or 6.5%, from approximately HK\$707.6 million for FY2021 to approximately HK\$753.3 million for FY2022. Revenue contributed by projects relating to the supply, installation and maintenance of MVAC system and low voltage electrical system was approximately 84.4% and 15.6% respectively (2021: 81.1% and 18.9% respectively).

#### Gross profit and gross profit margin

Our gross profit decreased by approximately HK\$15.8 million, or 25.7% from approximately HK\$61.4 million for FY2021 to approximately HK\$45.6 million for FY2022. Our gross profit margin decreased by approximately 2.6 percentage points, from approximately 8.7% for FY2021 to approximately 6.1% for FY2022. The decrease in gross profit and gross profit margin was mainly attributable to (i) the adoption of a more competitive pricing strategy in securing new projects due to intensified market competition; and (ii) manpower shortage and logistic delay caused by the Covid-19 pandemic which led to the delay of the Group's projects in progress and the increase in projects' material and transportation costs.

### Other income

Other income for FY2022 decreased by approximately HK\$7.3 million, from approximately HK\$10.2 million for FY2021 to approximately HK\$2.9 million for FY2022. The decrease was mainly due to the fact that there was no government grant received from the Employment Support Scheme launched by the Hong Kong Government during FY2022 (2021: HK\$8.0 million).

#### Other gain and loss

We recorded an other loss of approximately HK\$7.5 million for FY2022, which was mainly attributable to the fair value loss of financial assets at fair value through profit or loss ("FVTPL"), comparing to the other gain of approximately HK\$0.2 million for FY2021 due to the fair value gain on financial assets at FVTPL.

### Net impairment loss (recognised) reversed under expected credit loss model

We recognised a net impairment loss under expected credit loss model of approximately HK\$1.3 million for FY2022, comparing to a reversal of net impairment loss under expected credit loss model of approximately HK\$2.7 million for FY2021.

## 財務回顧

#### 收益

我們的收益由二零二一財年約7億760萬 港元增加約4,570萬港元或6.5%至二零 二二財年約7億5,330萬港元。有關供應、 安裝及維修機械通風空調系統及低壓電 氣系統的項目貢獻的收益分別約為84.4% 及15.6%(二零二一年:分別為81.1%及 18.9%)。

#### 毛利及毛利率

我們的毛利由二零二一財年約6,140萬 港元減少約1,580萬港元或25.7%至二零 二二財年約4,560萬港元。我們的毛利率 由二零二一財年約8.7%減少約2.6個百分 點至二零二二財年約6.1%。毛利及毛利 率減少乃主要由於(i)市場競爭加劇,為 確保獲取新項目而採用了更具競爭力的 定價策略;及(ii)Covid-19疫情造成人力資 源短缺和物流延誤,因而導致本集團在 建項目的延遲及項目所需材料及運輸成 本增加。

### 其他收入

二零二二財年的其他收入由二零二一財 年約1,020萬港元減少約730萬港元至二 零二二財年約290萬港元。減少主要由 於二零二二財年並無收取來自香港政府 推出的保就業計劃發出的政府補助(二零 二一年:800萬港元)所致。

#### 其他收益及虧損

我們於二零二二財年錄得其他虧損約750 萬港元,乃主要歸因於按公平值計入損 益(「按公平值計入損益」)的金融資產的 公平值虧損,而二零二一財年則為其他 收益約20萬港元,乃由於按公平值計入 損益的金融資產公平值收益所致。

## 預期信貸虧損模式項下(確認)撥回的淨 減值虧損

我們於二零二二財年錄得預期信貸虧損 模式項下確認的淨減值虧損約130萬港 元,而我們於二零二一財年則錄得預期 信貸虧損模式項下撥回的淨減值虧損約 270萬港元。

#### Administrative expenses

Our administrative expenses mainly represented administrative staff costs, professional fees and depreciation. The amount slightly increased by approximately HK\$0.9 million, from approximately HK\$23.1 million for FY2021 to approximately HK\$24.0 million for FY2022.

#### Finance costs

Our finance costs decreased by approximately HK\$0.2 million, from approximately HK\$0.3 million for FY2021 to approximately HK\$0.1 million for FY2022. The amount of FY2022 represented interest expenses on lease liabilities.

#### Income tax expenses

Our income tax expenses decreased by approximately HK\$3.1 million, from approximately HK\$7.0 million for FY2021 to approximately HK\$3.9 million for FY2022 due to the combined effect of the above factors. The effective tax rate for FY2022 was approximately 24.9% (2021: 13.8%).

#### Profit attributable to owners of the Company

Based on the above factors, profit attributable to owners of the Company decreased by approximately HK\$32.4 million, or approximately 73.5%, from approximately HK\$44.1 million for FY2021 to approximately HK\$11.7 million for FY2022.

## LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE Capital Structure

As at 31 March 2022, the capital structure of the Group consisted of equity of approximately HK\$290.8 million (2021: HK\$294.7 million). The Group did not have any bank borrowing as at 31 March 2022 and 2021.

### Cash position and fund available

During the Year, the Group maintained a healthy liquidity position, with working capital being financed by our operating cash flows and the retained profits.

As at 31 March 2022, the Group held cash and cash equivalents of approximately HK\$249.5 million (2021: HK\$236.0 million).

As at 31 March 2022, the current ratio of the Group was approximately 2.0 times (2021: 2.1 times).

### 行政開支

我們的行政開支主要指行政人員開支、 專業費用及折舊。該款項由二零二一財 年約2,310萬港元略增約90萬港元至二零 二二財年約2,400萬港元。

## **Bank Facilities**

As at 31 March 2022, the Group had a facility agreement entered into with a bank with a facility limit of HK\$150.0 million (2021: HK\$80.0 million). The Company had made undertakings relating to certain performance obligations of the controlling shareholders of the Company (the "Shareholders"), namely Mr. Yu Cheung Choy ("Mr.Yu"), who is the chairman of the Board (the "Chairman") and an executive Director, and Mr. Lau Man Ching ("Mr. Lau"), who is the chief executive officer of the Company (the "Chief Executive Officer") and an executive Director, pursuant to the facility agreement including the following: (i) Mr. Yu and Mr. Lau undertake to maintain as the largest shareholders of the Company directly or indirectly; and (ii) Mr. Yu and Mr. Lau shall remain as the chairman or director of the Company. The facility agreement remains effective as at the date of this annual report.

As at 31 March 2022, the Group had another facility agreement entered into with a bank with a facility limit of approximately HK\$90.2 million (2021: HK\$61.4 million) with the following obligations undertaken by the Group: (i) In case of Mr. Yu and Mr. Lau are not the major shareholders of the Company, the Group should notify the bank 14 days in advance; and (ii) In case of Mr. Yu is not entitled to be chairman of the Company, the Group should notify the bank 14 days in advance.

As at 31 March 2022, the Group had another facility agreement entered into with a bank with a facility limit of HK\$80.0 million (2021: HK\$80.0 million) with the following obligations undertaken by the Group: (i) In case of Mr. Yu and Mr. Lau are not the major shareholders of the Company, the Group should notify the bank 14 days in advance; and (ii) In case of Mr. Yu and Mr. Lau are not entitled to be chairman or director of the Company, the Group should notify the bank 14 days in advance.

#### **GEARING RATIO**

As at 31 March 2022, the Group did not have any bank borrowing and its gearing ratio was nil (2021: nil).

## NET CURRENT ASSETS

As at 31 March 2022, the Group had net current assets of approximately HK\$216.0 million (2021: HK\$232.2 million). The decrease in net current asset position was mainly attributable to i) the purchase of financial assets at FVTPL; and ii) declaration and payment of final dividend in respect of FY2021 to the Shareholders during the Year, offset by the net profit generated from the Group's operations during the Year.

The Group's policy is to regularly monitor its liquidity requirements and its compliance with covenants in relation to banking facility agreements, so as to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from the banks to meet its liquidity requirements. The Board is not aware of any liquidity issue that may cast significant doubt on the Group's ability to continue as a going concern.

## CAPITAL EXPENDITURES

The Group's capital expenditures for FY2022 amounted to approximately HK\$0.2 million (2021: HK\$0.2 million), which was incurred for the purchase of property and equipment.

#### FOREIGN EXCHANGE EXPOSURE

The Group's revenue-generating activities were transacted in Hong Kong Dollar, which is the functional currency of the Group. The Board considers that the Group was not exposed to significant foreign exchange risk, and had not entered into any financial instrument for hedging. The Board will review the Group's foreign exchange risk and exposure from time to time and will apply hedging where necessary.

## PERFORMANCE GUARANTEES AND CONTINGENT LIABILITY

As at 31 March 2022, performance guarantees of approximately HK\$134.8 million (2021: HK\$155.4 million) were given by banks in favour of the Group's customers as security for the due performance and observance of the Group's obligations under the contracts entered into between the Group and its customers. If the Group fails to provide satisfactory performance to its customers to whom performance guarantees have been given, such customers may demand the banks to pay to them the sum or sum stipulated in such demand. The Group will become liable to compensate such banks accordingly. The performance guarantees will be released upon completion of the contracts work.

The Group had no contingent liability as at 31 March 2022 and 2021.

As at 31 March 2022, the Group's leasehold land and buildings amounted to approximately HK\$17.8 million (31 March 2021: HK\$18.5 million) were pledged with a bank to secure the banking facilities including performance guarantees issued by the bank.

#### CAPITAL COMMITMENTS

As at 31 March 2022, the Group had capital commitments of approximately HK\$0.1 million in relation to acquisition of property and equipment contracted but not provided for (2021: HK\$0.1 million).

## EMPLOYEES, TRAINING AND REMUNERATION POLICY

As at 31 March 2022, the Group had a total of 207 employees (2021: 191). The remuneration offered to employees generally includes salaries, medical benefits and bonus. In general, the Group determines salaries of its employees based on each employee's qualification, position and seniority. The Group provides training to its employees according to the work requirements.

### MATERIAL ACQUISITIONS AND DISPOSALS

The Group did not have any material acquisitions and disposals of subsidiaries, associates and joint ventures during FY2022.

### SIGNIFICANT INVESTMENTS HELD

The Group did not have any significant investments held as at 31 March 2022.

The Company aims to achieve high standard of corporate governance which is crucial to the development of the Group and safeguard the interests of the Shareholders.

The Company has adopted the code provisions set out in the Corporate Governance Code (the "CG Code") as set out in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (the "Listing Rules") as its own code of corporate governance.

In the opinion of the Directors, the Company was in compliance with the code provisions set out in the CG Code during the Year.

## DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules as the code of conduct regarding securities transactions by the Directors. Having made specific enquiry of all Directors, all the Directors have confirmed that they have complied with the required standards set out in the Model Code throughout the Year.

## BOARD OF DIRECTORS

The Board is responsible for the leadership and control of the Company, and is responsible for setting up the overall strategy as well as reviewing the operation and financial performance of the Group. The Board reserved for its decision or consideration matters covering overall Group strategy, major acquisitions and disposals, annual budgets, annual and interim results, recommendations on Directors' appointment or re-appointment, approval of major capital transactions and other significant operational and financial matters. The management was delegated the authority and responsibility by the Board for the daily management of the Group. In addition, the Board has also delegated various responsibilities to the Board committees. Further details of these committees are set out in this report.

The three independent non-executive Directors are persons of high caliber, with academic and professional qualifications in the fields of construction, accounting and finance. With their experience gained from various sectors, they provide strong support towards the effective discharge of the duties and responsibilities of the Board. Each independent non-executive Director gave a confirmation of his independence to the Company, and the Company considered each of them is independent under Rule 3.13 of the Listing Rules.

#### Functions of the Board and Management

The Board is primarily responsible for establishing the overall strategies of the Group, setting objectives and business development plans, assuming responsibility of corporate governance and monitoring the performance of senior management.

The management, under the leadership of the executive Directors, is responsible for implementing the strategies and plans established by the Board and reporting on the Group's operations to the Board on a regular basis to ensure effective performance of the Board's responsibilities.

All the Directors have separate and independent access to the Group's senior management to fulfill their duties. Independent professional advice can be sought to assist the relevant Directors to discharge their duties at the Group's expense upon their request. All the Directors have been provided with monthly updates on the Group's performance and financial position to enable the Board as a whole and each Director to discharge their duties.

#### **Board Diversity Policy**

The Board adopted a board diversity policy on 6 December 2016 (the "Board Diversity Policy") which sets out the approach to achieve diversity on the Board. The Company recognises and embraces the benefits of diversity in the Board and is committed to enhancing quality of opportunity in all aspects of its business. The Company seeks to achieve Board diversity through the consideration against a range of objective criteria, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge. The Company will also take into consideration its own business model and specific needs from time to time in determining the optimal composition of the Board.

Agendas and accompanying papers shall be sent not less than 3 days before the date of Board meeting to ensure that the Directors are given sufficient time to review the documents.

During the Year, the Board held 4 meetings. All Directors are given an opportunity to include any matter in the agenda for regular Board meetings and are given sufficient time to review the documents and information to be discussed in Board meetings in advance. The terms of reference of the Audit Committee is currently made available on the websites of the Stock Exchange and the Company.

Terms of reference of the Audit Committee are aligned with the code provisions set out in the CG Code.

The primary duties and roles of the Audit Committee include, but not limited to, (a) making recommendations to the Board on the appointment, re-appointment and removal of the external auditor, approving the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal; (b) monitoring integrity of financial statements and annual report and accounts, half-year report and, if prepared for publication, quarterly reports, and reviewing significant financial reporting judgments contained in them; and (c) reviewing the financial controls, risk management and internal control systems of the Group.

The Audit Committee meets the external auditor regularly to discuss any area of concern during the audit. If within twenty-one days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

# DIRECTORS' RESPONSIBILITIES FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The Board acknowledges its responsibility to prepare the Group's consolidated financial statements for each financial year which give a true and fair view of the financial position of the Group and of the financial performance and cash flows of the Group for that year. In preparing the consolidated financial statements for the Year, the Board has selected suitable accounting policies and applied them consistently; made judgments and estimates that are prudent, fair and reasonable and prepared the accounts on a going concern basis.

The Directors are responsible for taking all reasonable and necessary steps to safeguard the assets of the Group and to prevent and detect fraud and other irregularities.

The Directors, having made appropriate enquiries, consider that the Group has adequate resources to continue in operational existence for the foreseeable future and that, for this reason, it is appropriate to adopt the going concern basis in preparing the consolidated financial statements.

### **RISK MANAGEMENT AND INTERNAL CONTROL**

The Board acknowledges that it is responsible for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has delegated its responsibilities (with relevant authorities) of risk management and internal control to the Audit Committee, who oversees management in the design, implementation and monitoring of the risk management and internal control systems, and management has provided a confirmation to the Audit Committee and the Board on the effectiveness of these systems for the Year.

#### **Risk management**

The Company has already reviewed its risk management framework and processes and has implemented relevant measures resulting from this exercise that aim to enhance its framework and processes. In particular, the Company has developed, approved and implemented a risk management system, which is defined and supported by its endorsed risk management policy. The terms of reference of the Audit Committee has included its responsibility for an effective system of internal control and risk management.

#### 風險管理

本公司已檢討其風險管理框架及程序, 並根據其檢討結果實施相關措施以提升 其框架及程序。尤其是,本公司開發、 批准及實施了一個風險管理系統,該系 統由其認可的風險管理政策所界定及支 持。審核委員會的職權範圍已包括其負 責內部監控及風險管理系統有效的責任。

The Company's methodology for its risk assessment comprises risk identification, risk assessment, risk response, and risk monitoring and reporting. These processes are performed at least once a year to address changes in the Group's business environment.

### Business continuity plan

As an integral part of risk management, the Company has formulated and documented a Business Continuity Plan ("BCP"), which is reviewed regularly and updated from time to time whenever the Board thinks fit. The BCP enables senior management to preserve stakeholder value in the event of a crisis/incident by responding promptly to the situation and resuming the Group's business functions to normal situation as quickly and efficiently as possible.

### Internal control measures

The internal control system of the Group covers its major business aspects such as revenue management, expenditure management, human resources and payroll, cash and treasury management, financial reporting, compliance and information technology. The internal control measures are supervised by management team including executive Directors. The management team is responsible to identify risks and internal control deficiencies, evaluate the internal control system of the Group from time to time and implementing additional control measures, if necessary, to improve the internal control system. Results of the internal assessments would be reported to the Audit Committee, which is responsible to review the financial information and supervise the financial reporting system and internal controls system of the Group.

### Internal audit function

The Board conducted an annual review on the effectiveness of risk management and internal control systems, covering all material controls such as financial, operational and compliance controls. In addition, the Board has appointed an international accountancy firm to review the internal control systems of the Group on an on-going basis which covers all major operations of the Group. The Board considered that the risk management and internal control systems of the Company for the Year were effective and adequate.

#### Accounting and financial reporting functions

The Board conducted a review of the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting functions for the year ended 31 March 2022, and considered the above resource components to be adequate.

#### Handling and dissemination of inside information

The Group regulates the handling and dissemination of inside information according to the "Guidelines on Disclosure of Inside Information" published by the Securities and Futures Commission to ensure inside information remains confidential until the disclosure of such information is appropriately approved, and the dissemination of such information is efficiently and consistently made. The Company regularly reminds the Directors and employees about due compliance with all policies regarding the inside information. Also, the Company keeps Directors, senior management and employees appraised of the latest regulatory updates. The Company shall prepare or update appropriate guidelines or policies to ensure the compliance with regulatory requirements.

## DIVIDEND POLICY

The Company seeks to maintain a balance between meeting Shareholders' expectations and prudent capital management with a sustainable dividend policy. The Company's dividend policy aims to allow Shareholders to participate in the Company's profit and for the Company to retain adequate reserves for the Group's future growth. In proposing any dividend payout, the Company would consider various factors including but not limited to the Group's overall results of operation, financial condition, expected working capital requirements, capital expenditure requirements, liquidity position, future expansions plans, the amount of retained profits and distributable reserves of the Company, general economic conditions, business cycle of the Group's business, other internal or external factors that may have an impact on the business or financial performance and position of the Group and any other factors that the Board deems relevant.

Any declaration and payment of the dividends by the Company will be subject to any restrictions under the Companies Law of the Cayman Islands, the Articles of Association, the Listing Rules and any other applicable laws and regulations. The Company does not have any pre-determined dividend distribution ratio. The Company's dividend distribution record in the past may not be used as a reference or basis to determine the level of dividends that may be declared or paid by the Company in the future. The dividend policy shall in no way constitute a legally binding commitment by the Group in respect of its future dividend and/ or in no way obligate the Group to declare a dividend at any time or from time to time.

During the Year, there was no change in the constitutional documents of the Company.

#### SHARE OPTION SCHEME

The Company adopted a share option scheme (the "Share Option Scheme") pursuant to the written resolutions of the then shareholders passed on 6 December 2016. The purpose of the Share Option Scheme is to enable the Group to grant options to full time or part time employee, Directors (including executive, non-executive or independent non-executive Directors), any supplier, any customer, any service provider, any Shareholder, any adviser or consultant of the Group as incentives or rewards for their contribution to the Group.

The principal terms of the Share Option Scheme are summarised as follows:

(1) The total number of Shares which may be allotted and issued upon exercise of all options (excluding, for this purpose, options which have lapsed in accordance with the terms of the Share Option Scheme and any other share option scheme of the Group) to be granted under the Share Option Scheme and any other share option scheme of the Group must not in aggregate exceed 10% of the Shares in issue at the time dealings in the Shares first commence on the Stock Exchange, i.e. 40,000,000 Shares, unless separate shareholders' approval has been obtained, and which must not exceed 30% of the share capital of the Company in issue from time to time.

As at the date of this report, the total number of shares available for issue under the Share Option Scheme is 40,000,000 Shares, which represents 10% of the issued Shares as at the date of this report.

(2) The total number of Shares issued and which may fall to be issued upon exercise of the options and the options granted under any other share option scheme of the Group (including both exercised or outstanding options) to each grantee in any 12-month period shall not exceed 1% of the issued share capital of the Company for the time being.

Mr. Yu Cheung Choy, Mr. Lau Man Ching, Prosperously Legend and Simply Grace (together, the "Covenantors") have entered into the deed of non-competition on 6 December 2016 (the "Deed of Non-Competition Undertaking") in favour of the Company (for itself and as trustee for each of its subsidiaries from time to time), under which each of the Covenantors has jointly and severally undertaken to the Company that he/it shall not, and shall procure that none of their respective close associates (other than members of the Group) shall, during the period that (a) the Shares remain listed on the Stock Exchange; and (b) either the Covenantors and their respective close associates (other than members of the Group), individually or jointly, are entitled to exercise, or control the exercise of, not less than 30% of the voting power at general meetings of the Company; or (c) any of the Covenantors or their respective close associates remains as a director of any member of the Group, directly or indirectly, either on their own account, in conjunction with, on behalf of, or through any person, firm or company, among other things, carry on, participate or be interested, engaged or otherwise involved in or acquire or hold (in each case whether as a shareholder, partner, agent or otherwise and whether for profit, reward or otherwise) any business that directly or indirectly be involved in or any business that directly or indirectly competes, or may compete, with the business of the Group or undertaking and any other new business which the Group may undertake from time to time after the listing of the Shares on the Main Board of the Stock Exchange.

The Covenantors have confirmed to the Company the compliance with the terms of Deed of Non-Competition Undertaking during the Year. The independent non-executive Directors have reviewed the annual declarations and made reasonable enquiry and confirmed the compliance with the terms of Deed of Non-Competition Undertaking by the Covenantors during the Year.

The Company had made undertakings relating to certain performance obligations of the controlling Shareholders, namely Mr. Yu Cheung Choy and Mr. Lau Man Ching, pursuant to the facility agreement including the following: (i) Mr. Yu and Mr. Lau undertake to maintain as the largest shareholders of the Company directly or indirectly; and (ii) Mr. Yu and Mr. Lau shall remain as the chairman or director of the Company. The facility agreement remains effective as at the date of this annual report.

As at 31 March 2022, the Group had another facility agreement entered into with a bank with a facility limit of approximately HK\$90.2 million (2021: HK\$61.4 million) with the following obligations undertaken by the Group: (i) In case of Mr. Yu and Mr. Lau are not the major shareholders of the Company, the Group should notify the bank 14 days in advance; and (ii) In case of Mr. Yu is not entitled to be chairman of the Company, the Group should notify the bank 14 days in advance.

As at 31 March 2022, the Group had another facility agreement entered into with a bank with a facility limit of HK\$80.0 million (2021: HK\$80.0 million) with the following obligations undertaken by the Group: (i) In case of Mr. Yu and Mr. Lau are not the major shareholders of the Company, the Group should notify the bank 14 days in advance; and (ii) In case of Mr. Yu and Mr. Lau are not entitled to be chairman or director of the Company, the Group should notify the bank 14 days in advance.

#### MAJOR CUSTOMERS AND SUPPLIERS

During the Year, the percentage of revenue attributable to the largest customer and the five largest customers of the Group accounted for approximately 22.2% and 70.7% of the Group's total revenue respectively.

During the Year, the largest supplier and the five largest suppliers of the Group accounted for approximately 5.7% and 10.8% of the total direct costs of the Group respectively.

None of the Directors, their close associates or any other Shareholder (which to the knowledge of the Directors owns more than 5% of the Company's share capital) had an interest in the major suppliers or customers noted above.

#### **EMOLUMENT POLICY**

The remuneration offered to the employees of the Group generally includes salaries, medical benefits and bonus. In general, the Group determines salaries of its employees based on each employee's qualifications, position and seniority. The Group will review its remuneration package annually. The Group provides a defined contribution to the Mandatory Provident Fund as required under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong) for the eligible employees in Hong Kong.

On 6 December 2016, the Company had adopted the Share Option Scheme under which full time or part time employees, including Directors, of the Company and its subsidiaries, might be granted options to subscribe for the Company's ordinary shares.

#### I. GENERAL INFORMATION

SH Group (Holdings) Limited (the "Company") was incorporated and registered as an exempted company with limited liability in the Cayman Islands under the Companies Law of the Cayman Islands on 9 May 2016. The addresses of the Company's registered office and the principal place of business in Hong Kong are Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands and Units 603–606, 6/F., Tower I, Cheung Sha Wan Plaza, 833 Cheung Sha Wan Road, Kowloon, Hong Kong, respectively. Its immediate and ultimate holding company is Prosperously Legend Limited ("Prosperously Legend"), which was incorporated in the British Virgin Islands ("BVI") and wholly owned by Mr.Yu Cheung Choy ("Mr.Yu"), who is also the chairman of the board (the "Board") of directors and executive director of the Company. The Company's shares have been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 3 January 2017.

The Company acts as an investment holding company. The principal activities of its subsidiaries are set out in note 36.

The consolidated financial statements are presented in Hong Kong dollar ("HK\$"), which is also the functional currency of the Company and its subsidiaries (collectively referred to as the "Group").

For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include the applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The directors of the Company have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue its operational existence for the foreseeable future. Thus, they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are accounted for in accordance with HKFRS 16 "Leases" and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets".

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level I inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intra-group assets, liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good and service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9 "Financial Instruments" ("HKFRS 9"). In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

### Variable consideration

For contracts that contain variable consideration, the Group estimates the amount of consideration to which it will be entitled using the most likely amount, which better predicts the amount of consideration to which the Group will be entitled.

The estimated amount of variable consideration is included in the transaction price only to the extent that it is highly probable that such an inclusion will not result in a significant revenue reversal in the future when the uncertainty associated with the variable consideration is subsequently resolved.

At the end of each reporting period, the Group updates the estimated transaction price (including updating its assessment of whether an estimate of variable consideration is constrained) to represent faithfully the circumstances present at the end of the reporting period and the changes in circumstances during the reporting period.

### Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. ### Short-term leases

The Group applies the short-term lease recognition exemption to leases of office premises that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. Right-of-use assets

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;

Property and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes. Property and equipment are stated at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

#### Ownership interests in leasehold land and building

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property and equipment.

Depreciation is recognised so as to write off the cost of assets over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss. The recoverable amount of property and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

Recoverable amount is the higher of fair value less costs of disposal and value in use. The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

### Retirement benefit costs

Payments to the Mandatory Provident Fund Scheme ("MPF Scheme") as defined contribution plan are recognised as an expense when employees have rendered service entitling them to the contributions.

### Short-term and other long-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. #### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of each reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit.

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of each reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of each reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

#### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

### Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligations, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of each reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

In the application of the Group's accounting policies, which are described in note 3, the management is required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of each reporting period that have a significant risk of causing a material adjustment to the carrying amounts of assets within the next financial year.

### Engineering service contracts

The Group reviews and revises the estimates of contract revenue, contract costs, variation orders and contract claims prepared for each engineering service contract as the contract progresses. Budgeted engineering service costs are prepared by the management on the basis of quotations from time to time provided by the major subcontractors, suppliers or vendors involved and the experience of the management. In order to keep the budget accurate and up-to-date, the management conducts periodic reviews of the budgets of contracts by comparing the budgeted amounts to the actual amounts incurred. Such significant estimate may have impact on the profit or loss recognised in each period.

Recognised amounts of engineering service contract revenue and related receivables reflect the management's best estimate of each contract's outcome and stage of completion, which are determined on the basis of a number of estimates. This includes the assessment of the profitability of on-going engineering service contracts. For more complex contracts in particular, costs to complete and contract profitability are subject to significant estimation uncertainty. Notwithstanding that the management frequently reviews and revises the estimates of both the estimated revenue and direct costs as the contracts progress, changes in estimates or the actual outcome will affect the carrying amounts of contract assets/ liabilities with the corresponding adjustments to future revenue and/or direct costs.

During the year ended 31 March 2022, the Group recognised contract revenue and contract costs amounted to HK\$753,327,000 and HK\$707,728,000 respectively (2021: HK\$707,590,000 and HK\$646,192,000 respectively).

### Impairment assessment on trade receivables and contract assets

ECL on trade receivables and contract assets are assessed individually. The assessment is based on the internal credit ratings, ageing, repayment history and/or past due status of the respective customers. Estimated loss rates are based on historical observed default rates over the expected life of the financial instruments and are adjusted for forward-looking information. The loss allowance amount of the credit-impaired trade receivables and contract assets is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows with the consideration of expected future credit losses.

At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

As at 31 March 2022, the trade receivables and contract assets amounting to HK\$34,019,000 and HK\$136,144,000 respectively (2021: HK\$88,834,000 and HK\$110,950,000 respectively).

Such services are recognised as a performance obligation satisfied over time as the Group creates or enhances an asset that the customer controls as the asset is created or enhanced. Revenue is recognised for these services based on the stage of completion of the contract using input method.

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "Bill") which introduced the two-tiered profits tax rates regime. The Bill was signed into law on 28 March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%.

Accordingly, the Hong Kong Profits Tax for the qualifying group entity is calculated at 8.25% on the first HK\$2 million of the estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million.

The income tax expense for the year can be reconciled to the profit before taxation per the consolidated statement of profit or loss and other comprehensive income as follows:

Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. In determining the lease term and assessing the length of the noncancellable period, the Group applies the definition of a contract and determines the period for which the contract is enforceable.

The Group has extension and/or termination options in a number of leases for office premises and workshops. These are used to maximise operational flexibility in terms of managing the assets used in the Group's operations. Retention money is unsecured and interest-free and represented the monies withheld by customers of contract works recoverable after the completion of defect liability period of the relevant contracts or in accordance with the terms specified in the relevant contracts, usually being I to 2 years from the date of completion of respective E&M engineering services projects. Normally the retention money will be accumulated up to 5% or 10% of the contract value.

The Group classifies these contract assets as current because the Group expects to realise them in its normal operating cycle.

Details of impairment assessment of contract assets are set out in note 30.

For the contract liabilities as at 31 March 2021, HK\$48,263,000 were recognised as revenue to profit or loss during the year ended 31 March 2022.

For the contract liabilities as at 1 April 2020, HK\$8,102,000 were recognised as revenue to profit or loss during the year ended 31 March 2021.

The increase in contract assets in current year is resulted from the increase in the Group's right to consideration for completion of E&M engineering services but not yet billed under the relevant contracts as at 31 March 2022.

The decrease in contract liabilities in current year is resulted from recognition as revenue to profit or loss during the year ended 31 March 2022.

Trade receivables and contract assets arising from contracts with customers

In order to minimise the credit risk on trade receivables and contract assets, management of the Group has delegated a team responsible for monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, management of the Group reviews the recoverable amount of each individual debt at the end of each reporting period to ensure that adequate impairment loss allowance are made for irrecoverable amounts on trade receivable and contract assets. The Group applies simplified approach on trade receivables and contract assets to provide for ECL. ECL on trade receivables and contract assets are assessed individually. The assessment is based on the internal credit ratings, ageing, repayment history and/or past due status of the respective customers. As part of the Group's credit risk management, the Group applied internal credit rating for its customers and applying the estimated loss rate ranging from 0.00% to 2.12% (2021: 0.04% to 4.46%) over the gross carrying amounts. In this regard, management of the Group considers that the credit risk on trade receivables and contract assets is significantly reduced.

The Group has concentration of credit risks with exposure limited to certain customers. The Group's largest debtor contributed approximately 24% (2021: 66%) of the Group's trade receivables and 37% (2021: 33%) of the Group's contract assets, respectively. The Group's five largest debtors contributed approximately 81% (2021: 88%) of the Group's trade receivables and 75% (2021: 85%) of the Group's contract assets, respectively.

### Other receivables and deposits

For other receivables and deposits, the management of the Group makes periodic collective assessment as well as individual assessment on the recoverability of other receivables based on historical settlement records, past experience, and also available reasonable and supportive forwardlooking information. The management of the Group believes that there is no material credit risk inherent in the Group's other receivables and deposits.

Debt instruments at amortised cost

The Group's debt instruments at amortised cost mainly comprise listed bonds issued by companies listed in the Stock Exchange. The Group determines whether the debt instruments held by the Group have suffered from significant increase in credit risk since initial recognition by comparing the credit rating and other qualitative benchmarks that affect the credit quality of the debt instruments at initial recognition and at the end of the reporting period.

As at 31 March 2022, as an issuer of a debt instrument has suffered from significant financial difficulty, that debt instrument held by the Group is therefore considered as credit-impaired. The Group estimates the probability of default and the loss given default of the debt instrument with reference to relevant default studies published by the credit rating agencies after taking into account forward-looking information available without undue cost or effort. In view of the above, the Group's management considers the ECL allowance on the debt instruments is adequate at 31 March 2022.

In view of the listed bond prices as at 31 March 2021, the management of the Group believes that there is no material credit risk inherent in the Group's debt instruments at amortised cost.

### Bank balances

As at 31 March 2022 and 2021 the credit risk on bank balances of the Group is limited because the counterparties are banks with good reputation and credit ratings and no history of default in the past and no impairment loss allowance for bank balances was recognised. The Group has limited exposure to any single financial institution.

The lifetime ECL recognised for credit-impaired contract assets as at 1 April 2020 is resulting from a debtor who went into liquidation process during the year ended 31 March 2019. The gross amount of credit-impaired contract assets is approximately HK\$1,499,000. During the year ended 31 March 2021, the Group received settlement of HK\$1,499,000 from customer and reversed the impairment allowance.

The Group writes off a trade receivable when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or when the trade receivables are over two years past due, whichever occurs earlier.

#### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by management to finance the Group's operations and mitigate the effects of unexpected fluctuations in cash flows.

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. The maturity dates for other non-derivative financial liabilities are based on the agreed repayment dates. To the extent that interest flows are floating rate, the undiscounted amount is derived from interest rate at the end of each reporting period.

The MPF Scheme is registered with the Mandatory Provident Fund Schemes Authority under the Mandatory Provident Fund Schemes Ordinance. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of an independent trustee. Under the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at rates specified in the rules. The only obligation of the Group with respect to the MPF Scheme is to make the required contributions. Except for voluntary contribution, no forfeited contribution under the MPF Scheme is available to reduce the contribution payable in future years. The cap of contribution amount is HK\$1,500 per employee per month.

The retirement benefit scheme contributions arising from the MPF Scheme recognised in profit or loss represent contributions paid or payable to the fund by the Group at rates specified in the rules of the MPF Scheme.

The contributions paid and payable to the schemes by the Group are disclosed in notes 6(a) and 9.

#### 32. PERFORMANCE GUARANTEES

As at 31 March 2022, performance guarantees of HK\$134,757,000 (2021: HK\$155,386,000) were given by banks in favour of the Group's customers as security for the due performance and observance of the Group's obligations under the contracts entered into between the Group and its customers. If the Group fails to provide satisfactory performance to its customers to whom performance guarantees have been given, such customers may demand the banks to pay to them the sum or sum stipulated in such demand. The Group will become liable to compensate such banks accordingly. The performance guarantees will be released upon completion of the contract works. The performance guarantees were granted under the banking facilities with details as set out in note 28.

At the end of each reporting period, as represented by the directors of the Company, they do not consider it is probable that a claim will be made against the Group.
