### **POSITIVE PROFIT ALERT**

This announcement is made by Courage Investment Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Board of Directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the unaudited management accounts of the Group for the six months ended 30 June 2022 (“**HY2022**”), the Group expects to record a profit attributable to owners of the Company for HY2022 of not less than US\$1.4 million as compared with the profit of approximately US\$0.7 million recorded for the six months ended 30 June 2021 (“**HY2021**”). Such increase in profit is mainly attributed to the increase in profit contribution from the Group’s marine transportation operation to approximately US\$4 million (HY2021: US\$1.2 million), after partly offsetting by the recognition of the allowance for credit losses on debt instruments at fair value through other comprehensive income of approximately US\$1.6 million (HY2021: nil).

The Company is in the process of finalising the interim results of the Group for HY2022. The information contained in this announcement is only based on a preliminary assessment by the Board according to the unaudited management accounts of the Group for HY2022 which have not been confirmed or reviewed by the Audit Committee of the Company. Accordingly, the Group’s actual results for HY2022 may differ from the information contained in this announcement.

Further details of the Group’s financial results and performance will be disclosed in the interim results announcement of the Company for HY2022 which is expected to be announced before the end of August 2022.
