CHANGE OF COMPANY NAME

The Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in Bermuda on 16 June 2022, certifying the change of English name of the Company from “Sun Entertainment Group Limited” to “Yeah Yeah Group Holdings Limited” and the dispensation of the dual foreign name in Chinese of the Company, being “太陽娛樂集團有限公司”. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 18 July 2022 confirming the registration of the new English name “Yeah Yeah Group Holdings Limited” and the dispensation of its Chinese name “太陽娛樂集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The Shares will be traded on the Stock Exchange under the new English stock short name of “YEAH YEAH GROUP” and the existing Chinese stock short name will be dispensed with and no Chinese stock short name will be adopted by the Company, with effect from 9:00 a.m. on 1 August 2022. The stock code of the Company remains as “8082”.

Following the passing of the special resolution approving the Proposed Change of Company Name by the Shareholders at the AGM held on 6 June 2022, the Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in Bermuda on 16 June 2022, certifying the change of name of the Company from “Sun Entertainment Group Limited” to “Yeah Yeah Group Holdings Limited” and the dispensation of the dual foreign name in Chinese of the Company, being “太陽娛樂集團有限公司”. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 18 July 2022 confirming the registration of the new English name “Yeah Yeah Group Holdings Limited” and the dispensation of its Chinese name “太陽娛樂集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

Following the Change of Company Name becoming effective, the existing English stock short name of the Shares for trading on the Stock Exchange will be changed from “SUN ENT GP” to “YEAH YEAH GROUP” and the existing Chinese stock short name will be dispensed with and no Chinese stock short name will be adopted by the Company, with effect from 9:00 a.m. on 1 August 2022. The stock code of the Company remains as “8082”.
