IN RELATION TO THE RECEIPT OF TOBACCO MONOPOLY PRODUCTION ENTERPRISE LICENSES BY WHOLLY-OWNED SUBSIDIARIES

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Smoore International Holdings Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

Reference is made to the announcement of the Company dated 20 July 2022. After the receipt of Tobacco Monopoly Production Enterprise License by the wholly-owned subsidiary of the Company, Shenzhen Vapresso Technology Co., Ltd. (深圳市韋普萊思科技有限公司), on 3 August 2022, other two wholly-owned subsidiaries of the Company, Shenzhen Smoore Technology Co., Ltd. (深圳麥克韋爾科技有限公司) and Shenzhen Maike Brothers Technology Co., Ltd. (深圳市麥克兄弟科技有限公司) have received the Tobacco Monopoly Production Enterprise Licenses issued by Tobacco Monopoly Administration with validity period from 25 July 2022 to 31 July 2023.

The receipt of the above-mentioned licenses further enhances the Group’s confidence in future development, the overall production and operation of the Group will continue as planned.
