Upon such termination, all rights and obligations of the parties to the Equity Transfer Agreement shall cease to have effect and no party shall have any claim against each other in connection with the Equity Transfer Agreement. The Board considers that termination of the Equity Transfer Agreement will not have any material adverse impact on the existing business, operational or financial conditions of the Group.

Since the Equity Transfer Agreement and the Acquisition contemplated thereunder have been terminated, no SGM will be convened and held by the Company for shareholders to consider and approve the Equity Transfer Agreement and the Acquisition contemplated thereunder. Therefore, no Circular will be dispatched by the Company.
