#### INTRODUCTION

The Group is an integrated group, which is principally engaged in internet advertising agency services and digital assets business during the year.

#### **BUSINESS REVIEW**

#### **Internet Advertising Agency Services**

The Group principally provides internet advertising services to different customer segments in Mainland China. Affected by the macroeconomic environment deterioration of China in 2019, slowdown of games copyright issuance, fierce competition of internet advertising industry, and high industry concentration, profit margin of small and medium-sized independent advertising operators has been squeezed. In order to expand business scale, the Group has adopted a series of marketing and promotion measures including increase of rebates to attract and uplift the customer base.

The Group develops its overseas internet advertising market through its wholly-owned subsidiary, Million Stars Internet Media Limited ("MSIM"). Through a global mainstream online platform, namely Facebook, MSIM provides customers with access to global advertising, including big data support, integrated marketing solutions, local language support and account stabilisation services.

During the first quarter, total operating income of the Group of approximately HK\$22.4 million was achieved.

本集團主要於中國內地為不同客戶提供互聯網廣告投放服務。由於受二零一九年中國宏觀經濟環境惡化及遊戲版號發放放緩的影響,互聯網廣告行業競爭激烈,行業集中度提高,中小獨立廣告運營商的利潤空間受到擠壓。為了拓展業務規模,本集團採取了包括增加返點在內的一系列促銷措施,以吸引和發展客戶。

本集團透過全資附屬公司萬星網絡傳媒有限公司(「萬星網絡」)發展海外互聯網廣告市場。萬星網絡透過全球主流網絡平台Facebook為客戶提供覆蓋全球的廣告投放服務,包括為客戶提供大數據支援、整合營銷方案、當地語系化支持、穩定賬號等服務。

第一季度,本集團共實現約22.4百萬港元 的營業收入。

#### **Digital Assets Business**

The Group has professional management and internal teams in the field of cryptocurrency business. It boasts professional operations and expertise in the construction, quality and operation of mining machines, holds market supply and demand information, and possesses professional capability in the field of cryptocurrency business.

#### **OUTLOOK**

Seizing the opportunity of the rapid development of the Internet, the Group will continue to adjust the investments in the internet advertising business and seek to tap on new customers, businesses and revenue streams. The Group is gradually developing overseas cryptocurrency business to deliver better returns to shareholders in the field of digital assets business.

The outbreak of the Epidemic has caused disruptions to many industries in the PRC as well as other countries and regions. Despite the challenges, governments and international organisations have implemented a series of measures to contain the Epidemic. The Group will closely monitor the development of the Epidemic and assess its impact on its operations.

#### 數字資產業務

本集團在加密貨幣業務領域有專業的管理 層及內部團隊,具備對礦機設備的構造、 質量、運營等的專業經營和專業知識,掌 握市場供求信息,在加密貨幣業務領域具 備專業能力。

#### 展望

本集團繼續抓住互聯網飛速發展的機會, 調整對互聯網廣告業務的投資力度,努力 拓展新的客戶、業務與收入來源。本集團 逐步發展海外加密貨幣業務,以期在數字 資產業務領域為股東帶來更高回報。

疫情爆發對中國以及其他國家及地區的不 少行業造成影響。儘管面臨挑戰,政府及 國際組織已實施一系列措施遏制疫情。本 集團將密切監察疫情發展及評估其對業務 產生的影響。

#### **FINANCIAL REVIEW**

#### Overview

Revenue of the Group for the three months ended 30 September 2021 amounted to approximately HK\$22.38 million, representing a significant decrease of approximately 53.3% as compared with the corresponding period in the previous financial year.

The Group's gross profit for the three months ended 30 September 2021 was approximately HK\$2.04 million, decreased by approximately HK\$0.7 million compared with the same period of last year.

Profit attributable to equity holders of the Company for the three months ended 30 September 2021 amounted to approximately HK\$5 million, increased by approximately 230% compared with loss of HK\$3.8 million for the three months ended 30 September 2020.

#### Revenue

The Group's revenue principally represented income derived from provision of internet advertising agency services.

The Group's revenue for the three months ended 30 September 2021 was approximately HK\$22.38 million, recorded a drop of approximately 53.3% from that of approximately HK\$47.92 million for the three months ended 30 September 2020.

#### Cost of Sales

Cost of sales mainly represents costs incurred for the provision of internet advertising agency services.

The Group's cost of sales for the three months ended 30 September 2021 was approximately HK\$20.34 million, representing an decrease of approximately 55% from that for the three months ended 30 September 2020 mainly due to the decrease in revenue during the period.

#### 財務回顧

#### 概覽

本集團於截至二零二一年九月三十日止三個月的收入約為22.38百萬港元,較上一個財年同期大幅減少約53.3%。

本集團於截至二零二一年九月三十日止三個月的毛利約為2.04百萬港元·較去年同期減少約0.7百萬港元。

本公司權益持有人於截至二零二一年九月 三十日止三個月應佔溢利約為5百萬港元, 較截至二零二零年九月三十日止三個月的 虧損3.8百萬港元增加約230%。

#### 收入

本集團的收入主要指提供互聯網廣告代理 服務所產生的收入。

本集團於截至二零二一年九月三十日止三個月的收入約為22.38百萬港元,較截至二零二零年九月三十日止三個月約47.92百萬港元減少約53.3%。

#### 銷售成本

銷售成本主要指提供互聯網廣告代理服務 產生的成本。

本集團於截至二零二一年九月三十日止三個月的銷售成本約為20.34百萬港元,較截至二零二零年九月三十日止三個月下跌約55%,主要由於期內收入下降所致。

#### Other Income, Gains and Losses, net

During the period, other income, gains and losses, net mainly represents sundry income incidental to our business, principally including interest income, gain on disposal of intangible assets and gain on disposal of interests in associates.

Other income, gains and losses, net amounted to net gains of approximately HK\$10.6 million for the three months ended 30 September 2021 compared with net gains of approximately HK\$6,000 with the three months ended 30 September 2020.

#### **Selling and Distribution Expenses**

Selling and distribution expenses comprised mainly payroll expenses and marketing expenses. The selling and distribution expenses for the three months ended 30 September 2021 were approximately HK\$0.1 million (2020: HK\$0.7 million). The decrease in selling and distribution expenses was mainly due to decrease in the number of practising staff in the internet advertising agency services business.

#### **Administrative Expenses**

Administrative expenses comprised mainly payroll expenses, rent and rates and other office administrative expenses. Administrative expenses were increased from approximately HK\$5.8 million for the three months ended 30 September 2020 to approximately HK\$7.5 million for the three months ended 30 September 2021, representing an increase of approximately 29.3%.

The increase in administrative expenses was mainly due to increase in depreciation charges of machineries and equipment in connection with digital assets business.

#### 其他收入、收益及虧損淨額

於期內,其他收入、收益及虧損淨額主要 指與我們業務相關的雜項收入,主要包括 利息收入、出售無形資產收益及出售聯營 公司權益的收益。

截至二零二一年九月三十日止三個月,其 他收入、收益及虧損淨額為淨收益約10.6 百萬港元,而截至二零二零年九月三十日 止三個月則為淨收益約0.6萬港元。

#### 銷售及分銷開支

銷售及分銷開支主要包括薪金開支及營銷開支。截至二零二一年九月三十日止三個月的銷售及分銷開支約為0.1百萬港元(二零二零年:0.7百萬港元)。銷售及分銷開支減少乃主要由於互聯網廣告代理業務實施人員減少所致。

#### 行政開支

行政開支主要包括薪金開支、租金及差餉 以及其他辦公室行政開支。行政開支由截 至二零二零年九月三十日止三個月的約5.8 百萬港元增加至截至二零二一年九月三十 日止三個月的約7.5百萬港元,增幅約為 29.3%。

行政開支的增加主要由於與數字資產業務 有關的機器及設備折舊費增加導致。

#### **Taxation**

Income tax represents Hong Kong Profits Tax at 16.5% for the Company's subsidiaries in Hong Kong and the PRC Corporate Income Tax at 25% for the Company's subsidiaries in the PRC. Some subsidiaries of the Company, which are incorporated in the Horgos Economic Development Zone and engaged in industries particularly encouraged by the local government, are entitled to a preferential tax treatment of five years exemption from enterprise income tax.

#### Profit/(Loss) for the Period

The Group recorded a profit for the period of approximately HK\$5 million and a loss of HK\$3.8 million for the three months ended 30 September 2021 and for the three months ended 30 September 2020, respectively. The profit for the period was a result of gain on disposal of intangible assets and gain on disposal of associates.

### Financial Position, Liquidity and Financial Resources

The Group adopts a prudent cash and financial management policy. In order to achieve better cost control and minimise the cost of funds, the Group's treasury activities are centralised and cash is generally deposited with banks in Hong Kong and the Mainland China.

The Group has maintained its funds at a sound and healthy financial resource level during the period under review. As at 30 September 2021, included in net current assets were cash and bank balances (including pledged bank deposits) totally approximately HK\$14.31 million (30 June 2021: HK\$1.45 million), the increase in which was mainly attributable to the extension of payment terms on the settlement with suppliers.

#### 税項

所得税指本公司香港附屬公司按16.5%的 税率繳納之香港利得税及本公司中國附屬公司按25%的税率繳納的中國企業所得税。本公司多間附屬公司註冊於霍爾果斯市經濟開發區,主營業務屬於當地政府重點鼓勵發展的產業,享受五年內免徵企業所得稅的税收優惠政策。

#### 期內溢利/(虧損)

本集團於截至二零二一年九月三十日止三個月及截至二零二零年九月三十日止三個月分別錄得期內溢利約5百萬港元及虧損3.8百萬港元。期內溢利乃由於出售無形資產及出售聯營公司收益。

#### 財務狀況、流動資金及財務資源

本集團採取審慎的現金及財務管理政策。 為求能夠更好地控制成本及盡量降低資金 成本,本集團的財資活動均為集中管理, 而現金一般會存放於香港和中國內地的銀 行。

於回顧期間內,本集團維持穩健的財務資源水平。於二零二一年九月三十日,計入流動資產淨值的現金及銀行結餘(包括已抵押銀行存款)總額約為14.31百萬港元(二零二一年六月三十日:1.45百萬港元),有關增加乃主要由於供應商的結算支付限期延長所致。

The Group's outstanding borrowings as at 30 September 2021 amounting to HK\$2.5 million (30 June 2021: HK\$10.2 million) were principally denominated in United States dollar and HK\$ and carried at floating interest rate and fixed interest rates. The Group monitored capital using gearing ratio, which is total debt of the Group divided by total equity of the Group. Total debt to equity ratio of the Group expressed as a percentage of interest bearing borrowings over the total equity was approximately 1.6% as at 30 September 2021 (30 June 2021: 7.7%).

The Group in its ordinary course of business is exposed to market risks such as foreign currency risk and interest rate risk. The Group's risk management strategy aims to minimise the adverse effects of these risks on its financial performance.

本集團於其一般業務過程中面臨外幣風險 及利率風險等市場風險。本集團的風險管 理政策旨在將該等風險對其財務表現的不 利影響降至最低。

Cash is generally deposited at banks in Hong Kong and Mainland China and denominated mostly in HK\$, United States dollar and Renminbi. As at 30 September 2021, no related hedges were made by the Group (30 June 2021: nil).

現金一般存放於香港及中國內地之銀行且 大部分以港元、美元及人民幣計值。於 二零二一年九月三十日,本集團概無作出 相關對沖(二零二一年六月三十日:無)。

As most of the Group's trading transactions, monetary assets and liabilities are denominated in United States dollar, Renminbi and HK\$, the impact of foreign exchange exposure to the Group during the three months ended 30 September 2021 was minimal and there was no significant adverse effect on normal operations.

#### **Charge Over Assets of the Group**

As at 30 September 2021, the Group did not have any significant capital commitment (30 June 2021: the capital commitment of the Group regarding to the acquisition of property, plant and equipment amounting to HK\$13.9 million) and any significant contingent liability (30 June 2021: nil).

During the three months ended 30 September 2021, the Group did not have any material acquisition and disposal.
