FURTHER DELAY IN DESPATCH OF CIRCULAR

References are made to (i) the announcement of the Company dated 11 March 2022 in relation to the Supplemental Agreement for the extension of time for, among other things, the Target Company to meet the Target Profit Level for 18 months; and (ii) the announcements of the Company dated 1 April 2022, 29 April 2022, 1 June 2022, 14 July 2022 and 29 July 2022 (together with the announcement dated 11 March 2022, collectively, the “**Announcements**”) in relation to, among other things, the delay in despatch of a circular (the “**Circular**”) and the extension of the Long Stop Date. Terms used herein shall have the same respective meanings as those defined in the Announcements, unless the context requires otherwise.

As disclosed in the announcement of the Company dated 29 July 2022, the Circular containing, among other things, further details of the Supplemental Agreement, the recommendation of the Independent Board Committee, the advice of the Independent Financial Adviser to the Independent Board Committee and the Independent Shareholders, and a notice of the EGM will be despatched to the Shareholders on or before 31 October 2022. As additional time is required to finalise certain information in the Circular, the despatch date of the Circular is expected to be postponed to a date falling on or before 31 January 2023.
