The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for October 2022 on a consolidated basis amounted to 6,122,329 MWh, representing a year-on-year increase of 20.51% compared with the corresponding period of 2021. In particular, the wind power generation registered an increase of 21.96%, the coal power generation registered an increase of 3.79% and other renewable energy power generation of the Group for 2022 amounted to 57,575,791 MWh, representing a year-on-year increase of 12.70% compared with the corresponding period of 2021. In particular, the wind power generation registered an increase of 14.50%, the coal power generation registered a decrease of 2.26%, and other renewable energy power generation registered an increase of 87.59%.
