- (i) Mr. Lee Hin Kwong, Patrick has attended the 2022 AGM in person and Mr. Zhang Liang, Johnson, Ms. Zhao Wenzhu, Mr. Wang Bo, Mr. Xiang Feng and Mr. Chang Eric Jackson have attended the 2022 AGM through the telecommunication facilities.
