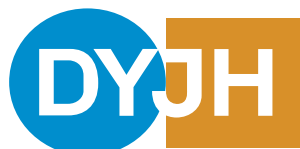

All CCASS Beneficial Owners will receive Interim Dividend payments in Hong Kong dollars.
