The Board hereby announces that on 16 December 2022 (after trading hours), the Company (as the Lessor) entered into the Finance Lease Agreement with the Lessee, pursuant to which (i) the Lessor purchased the Leased Assets from the Lessee at a consideration of RMB1,300,000,000, and (ii) the Lessor agreed to lease the Leased Assets to the Lessee with a lease period of 16 years.

Rent and Method of Payment

Pursuant to the Finance Lease Agreement, the Lessor agreed to lease back the Leased Assets to the Lessee. The rent, including value-added taxes, is calculated and paid in RMB and comprised of lease principal and lease interest. In particular, the lease principal is of the same amount as the transfer consideration, totalling RMB1,300,000,000. The total amount of lease interest for the lease period is approximately RMB637,763,529. The lease principal and lease interest shall be paid by the Lessee to the Lessor on a quarterly basis in installments during the lease period.
