This announcement is made by Shanxi Changcheng Microlight Equipment Co. Ltd. (the “**Company**”) together with its subsidiaries, collectively referred to as the “**Group**”) pursuant to Rule 17.10 of the Rules governing the Listing of Securities on the GEM (the “**GEM Listing Rules**”) of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the provision on inside information under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 17 March 2023 in relation to the meeting of the board of directors (the “**Directors**”) (the “**Board**”) of the Company to be held on 31 March 2023 for, among other things, considering and approving the publication of the audited annual results of the Group for the year ended 31 December 2022 (the “**2022 Audited Annual Results**”).

DELAY IN PUBLICATION OF AUDITED ANNUAL RESULTS ANNOUNCEMENT FOR THE YEAR ENDED 31 DECEMBER 2022 AND DELAY IN DESPATCH OF ANNUAL REPORT FOR THE YEAR ENDED 31 DECEMBER 2022

The Board hereby informs the shareholders and potential investors of the Company that the domestic COVID-19 situation was grim as a result of the completely cut-off of China's COVID-19 prevention and control, which has been gradually stabilised after the Lunar New Year. As a result, the auditors only came into the site after the Lunar New Year for starting the audit and evidence collection work. This seriously caused the subsequent insufficient time of audit work, and thus the publication of the 2022 Audited Annual Results and despatch of annual report for the year ended 31 December 2022 (the“**2022 Annual Report**”) will both be delayed.

Pursuant to Rules 18.48A and 18.49 of the GEM Listing Rules, the Company is required to publish an announcement relating to the Group's 2022 Audited Annual Results and despatch the 2022 Annual Report to the shareholders of the Company not later than three months after the end of the financial year of the Company, i.e. on or before 31 March 2023.

The delay in publication of the 2022 Audited Annual Results and 2022 Annual Report would constitute non-compliance of Rules 18.49 and 18.48A of the GEM Listing Rules. The Company wishes to emphasise that the operations of the Group remain normal. The Company will use its best endeavors to publish the 2022 Audited Annual Results and 2022 Annual Report to the shareholders as soon as possible. The Company expects to publish the 2022 Audited Annual Results and to despatch the 2022 Annual Report on or before 30 April 2023.

DATE OF BOARD MEETING

As explained above, due to the delay in the audit process, the Board meeting originally scheduled for 31 March 2023 to consider and approve, among other things, the publication of the 2022 Audited Annual Results will be postponed to a date not later than 30 April 2023. Further announcement(s) will be made in due course to inform the shareholders of (i) the date of the Board meeting to consider and approve the 2022 Annual Results; (ii) the date of the announcement of the 2022 Annual Results and the despatch of the 2022 Annual Report; and (iii) any significant developments.

Save as disclosed above, the Company does not have any other unpublished inside information.

CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 13 June 2022 and will remain suspended until the Company fulfills the resumption guidance and additional resumption guidance imposed by the Stock Exchange to the Company as described in the announcements of the Company dated 9 August 2022, 10 August 2022 and 1 December 2022.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
