INTRODUCTION

The purpose of this circular is to provide you with, among other things, information regarding the ordinary resolutions relating to (1) the proposed grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate; and (2) the re-election of the retiring Directors, and to give you the notice of the AGM.

1. GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

(i) General Mandate to Repurchase Shares

The general mandate granted to the Directors by the Shareholders at the annual general meeting of the Company held on 25 May 2022 to repurchase Shares will expire at the conclusion of the AGM. At the AGM, the Board will propose an ordinary resolution, the full text of which is set out as resolution No. 6 in the notice of the AGM, to grant an unconditional general mandate to the Directors to exercise all powers of and on behalf of the Company to repurchase Shares up to a maximum of 10% of the total number of Shares in issue as at the date of passing of the relevant resolution. The Repurchase Mandate will continue to be in force until the conclusion of the next annual general meeting of the Company or any earlier date as referred to in resolution No. 6(d) as set out in the notice of the AGM. In accordance with the requirements of the Listing Rules, an explanatory statement on the Repurchase Mandate is set out in Appendix I to this circular to provide you with the requisite information reasonably necessary to enable you to make an informed decision on the proposed resolution.

As at the Latest Practicable Date, the Company had an aggregate of 1,814,056,622 Shares in issue. Subject to the passing of the relevant resolution approving the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase Shares up to a maximum of 181,405,662 Shares, representing 10% of the total number of Shares in issue as at the Latest Practicable Date.

(ii) General Mandate to Issue Shares

The general mandate granted to the Directors by the Shareholders at the annual general meeting of the Company held on 25 May 2022 to issue Shares will expire at the conclusion of the AGM. In order to ensure flexibility and discretion to the Directors, in the event that the Company becomes desirable to issue any Shares, approval is to be sought from the Shareholders for a general mandate to issue Shares pursuant to the Listing Rules. At the AGM, an ordinary resolution, the full text of which is set out as resolution No. 7 in the notice of the AGM, will be proposed to grant the Directors an unconditional general mandate to allot, issue and deal with Shares not exceeding 20% of the total number of the issued Shares at the date of passing of the relevant resolution. The Issue Mandate will continue to be in force until the conclusion of the next annual general meeting of the Company or any earlier date as referred to in resolution No. 7(d) as set out in the notice of the AGM.

Subject to the passing of the relevant resolution approving the Issue Mandate and on the basis that no further Shares are issued or repurchased by the Company between the Latest Practicable Date and the date of the AGM, the Company would be allowed to allot, issue and deal with a maximum of 362,811,324 Shares, representing 20% of the Shares in issue as at the Latest Practicable Date.

(iii) Extension Mandate

In addition, an ordinary resolution, the full text of which is set out as resolution No. 8 in the notice of the AGM, will also be proposed at the AGM to extend the limit of the Issue Mandate by adding thereto the total number of Shares repurchased under the Repurchase Mandate.

The Directors wish to state that they have no immediate plans to repurchase any Shares or to allot and issue any new Shares, other than Shares which may fall to be allotted and issued upon the exercise of any options granted under the 2013 Share Option Scheme or to be granted under the 2022 Share Option Scheme.

2. RE-ELECTION OF RETIRING DIRECTORS

The Board currently consists of six Directors, comprising three executive Directors, namely Mr. Chang Chih-Kai, Mr. Chang Chih-Chiao and Mr. Wang Jungang, and three independent non-executive Directors, namely Mr. Huang Shun-Tsai, Mr. Hon Ping Cho Terence and Mr. Tan Philip.

Pursuant to Article 84(1) of the Articles of Association, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. Accordingly, Mr. Chang Chih-Kai and Mr. Hon Ping Cho Terence will retire and, being eligible, offer themselves for re-election at the AGM.

Each of the retiring Directors has indicated his willingness to offer themselves for re-election at the AGM. As each of Mr. Chang Chih-Kai and Mr. Hon Ping Cho Terence is also a member of the Nomination Committee, he has abstained from voting when considering his own nomination.

In considering and approving the re-election of Mr. Hon Ping Cho Terence, the retiring independent non-executive Director, the Nomination Committee had reviewed and assessed his respective independence based on the independence guidelines as set out in Rule 3.13 of the Listing Rules. Mr. Hon Ping Cho Terence has also confirmed that he fulfils all the requirements set out in Rule 3.13 of the Listing Rules. The Nomination Committee is satisfied that Mr. Hon Ping Cho Terence remains independent.

In addition, the Nomination Committee had considered a wide range of diversity perspectives as set out in the board diversity policy of the Company including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service. Mr. Hon Ping Cho Terence is a fellow member of the Association of Chartered Certified Accountants, a member of the Hong Kong Institute of Certified Public Accountants and a member of the Institute of Chartered Accountants in England and Wales, which enable Mr. Hon Ping Cho Terence to provide professional, valuable, independent and objective view to the Board

on matters relating to the business of the Group. The Nomination Committee considered that the knowledge and experience of Mr. Hon Ping Cho Terence would continue to bring contribution to the diversity of the Board. Taking into consideration the foregoing, the Nomination Committee proposed Mr. Hon Ping Cho Terence to stand for re-election at the AGM.

Having considered the above-mentioned factors, the Board shared the view of the Nomination Committee and is of the opinion that Mr. Hon Ping Cho Terence still maintains an independent view of the Company's affairs and is able to carry out his duties as independent non-executive Director in an impartial manner. The Board, on the recommendation of the Nomination Committee, proposed that all the retiring Directors to stand for re-election as Directors at the AGM.

The biographical details, interests in the Shares and other information required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules, of the retiring Directors proposed for re-election at the AGM are set out in Appendix II to this circular.

AGM AND VOTING BY POLL

The notice of the AGM, at which ordinary resolutions will be proposed to approve, among other matters, the following:

- (a) the grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate; and
- (b) the re-election of the retiring Directors,

is set out on pages AGM-1 to AGM-5 of this circular.

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of the Shareholders at the AGM must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The results of the poll will be published on the websites of the HKEXnews (www.hkexnews.hk) and the Company (www.daphneholdings.com) in the manner prescribed under Rule 13.39(5) of the Listing Rules after the AGM.

To the best knowledge, information and belief of the Directors having made all reasonable enquiries, no Shareholders will be required to abstain from voting on each of the resolutions to be proposed at the AGM.

CLOSURE OF REGISTER OF MEMBERS

The register of members of the Company will be closed from Friday, 19 May 2023 to Wednesday, 24 May 2023, both days inclusive, during which period no transfer of Shares will be effected. In order to qualify for attending the AGM, all transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar in Hong

RECOMMENDATION

The Board considers that the proposals of the Repurchase Mandate, the Issue Mandate, the Extension Mandate and the re-election of the retiring Directors are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of the resolutions to be proposed at the AGM as set out in the notice of the AGM.

APPENDIX I EXPLANATORY STATEMENT ON REPURCHASE MANDATE

This appendix serves as an explanatory statement, as required under Rule 10.06(1)(b) of the Listing Rules, to provide Shareholders with all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the ordinary resolution to approve the grant of the Repurchase Mandate to the Directors.

1. LISTING RULES RELATING TO THE REPURCHASE OF SHARES

The Listing Rules permit companies with a primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange, and any other stock exchange on which securities of the Company are listed and such exchange is recognised by the Securities and Futures Commission of Hong Kong, subject to certain restrictions. Among such restrictions, the Listing Rules provide that all proposed repurchases of shares must be approved by the Shareholders in advance by an ordinary resolution either by way of a general mandate, or by a specific approval of a particular transaction, and that the shares to be repurchased must be fully paid up.

2. ISSUED SHARES

As at the Latest Practicable Date, there were a total of 1,814,056,622 Shares in issue.

Subject to the passing of the proposed resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased for the period from the Latest Practicable Date up to and including the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase up to a maximum of 181,405,662 Shares which represents a 10% of the total number of Shares in issue as at the date of passing such resolution.

3. REASONS FOR REPURCHASES

The Directors believe that the grant of the Repurchase Mandate is in the best interests of the Company and the Shareholders as a whole. Repurchases may, depending on the circumstances and funding arrangements at the time, result in an enhancement in the net asset value and/or earnings per Share. The Directors are seeking the grant of a general mandate to repurchase Shares to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time having regarded to the circumstances then pertaining.

4. FUNDING OF REPURCHASES

There might have a material adverse impact on the working capital or gearing position of the Company in the event that the proposed Shares repurchases were to be carried out in full at any time during the proposed repurchase period. However, repurchases must be made out of funds legally available for such purpose in accordance with the Articles of Association, the laws of the Cayman Islands, the Listing Rules and any other applicable laws. It is envisaged that the funds required for any repurchases would be derived from the distributable reserves of the

Company. The premium payable on repurchase may only be paid out of either the funds of the Company that would otherwise be available for dividend or distribution or out of the Company's share premium before the Shares are repurchased. In accordance with the laws of the Cayman Islands, the Shares so repurchased would be treated as cancelled but the aggregate amount of authorised share capital would not be reduced.

The Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Company.

6. TAKEOVERS CODE

If, as a result of a share repurchase, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

Notes:

- (1) Mr. Chang Chih-Kai, the chairman of the Board and an executive Director and Mr. Chang Chih-Chiao, an executive Director and the chief executive officer of the Company, and their two sisters have beneficial interests of 26%, 26% and 24% each, respectively, in Lucky Earn International Ltd., a company incorporated in the British Virgin Islands.
- (2) Warrior Limited has beneficial interest in 164,914,238 shares of the Company and has subscribed for convertible notes issued by the Company. Assuming full conversion of the convertible notes on their scheduled maturity date, an aggregate of 164,541,807 shares would be issued to Warrior Limited. Warrior Limited is wholly owned by Teresaeleven Inc., which in turn is wholly owned by Ms. Quan Qizi. Teresaeleven Inc. and Ms. Quan are deemed to be interested in 329,456,045 shares of the Company held by Warrior Limited.
- (3) Mr. Chen Tommy Yi-Hsun, an ex-director of the Company, and Ms. Chen Jennifer Yi-Chen have beneficial interests of 50% each in Top Glory Assets Limited, a company incorporated in the British Virgin Islands. By virtue of the SFO, they are deemed to be interested in 174,908,895 shares of the Company held by Top Glory Assets Limited.
- (4) Pushkin Holding Ltd. is solely owned by Mr. Chen Ming-Yuan.

Based on the current holding of the above Shareholders and a total of 1,814,056,622 Shares in issue as at the Latest Practicable Date, an exercise of the Repurchase Mandate in full would not result in any of them becoming obliged to make a mandatory offer under Rule 26 and Rule 32 of the Takeovers Code.

The Directors are not aware of any consequences which may arise under the Takeovers Code as a result of any repurchases made under the Repurchase Mandate. The Company, however, has no intention to exercise the Repurchase Mandate to the effect that it will result in a requirement of any Shareholder, or any other person(s) to make a general offer under the Takeovers Code, or the public float to fall below 25% or such other minimum percentage prescribed by the Listing Rules from time-to-time.

7. SHARE REPURCHASES MADE BY THE COMPANY

No repurchase of Shares (whether on the Stock Exchange or otherwise) has been made by the Company during the six months immediately preceding the Latest Practicable Date.

8. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate only in accordance with the Listing Rules and the applicable laws of the Cayman Islands and in accordance with the regulations set out in the memorandum and articles of association of the Company.

(2) Mr. HON Ping Cho Terence

Mr. Hon Ping Cho Terence, aged 63, has been an independent non-executive Director since September 2019. He is also the chairman of the Audit Committee, and a member of each of the Nomination Committee and Remuneration Committee.
