INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the AGM. These include resolutions relating to, among other things, (i) the general mandates to issue and repurchase Shares; and (ii) the re-election of the Directors.

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

Ordinary resolutions will be proposed at the AGM to (i) grant a general mandate to the Directors to issue, allot and otherwise deal with Shares up to a maximum of 20 per cent. of the aggregate nominal amount of the issued and fully-paid share capital of the Company as at the date of passing of the resolution (the "Issue Mandate") and (ii) approve the addition to the Issue Mandate so granted to the Directors any Shares with a nominal amount equal to the

Shares repurchased by the Company under the authority and upon the granting of the Repurchase Mandate (as defined below). The Directors have no present intention to issue any new Shares.

An ordinary resolution will be proposed at the AGM to grant to the Directors to exercise the powers of the Company to repurchase its own securities on the Stock Exchange at any time during the period ended on the earliest of (i) the conclusion of the next annual general meeting of the Company, (ii) the date upon which such authority is revoked or varied at a general meeting of the Shareholders and (iii) the date by which the next annual general meeting of the Company is required to be held by laws or the Articles of Association of the Company, provided that the aggregate nominal amount of Shares to be purchased shall not exceed 10 per cent. of the aggregate nominal amount of the share capital of the Company in issue at the date of passing of the relevant resolution (the “Repurchase Mandate”).

As at the Latest Practicable Date, the number of Shares in issue was 3,161,105,398. Accordingly, assuming no repurchase or issue of Shares prior to the AGM, the exercise of the Repurchase Mandate in full would enable the Company to repurchase up to 316,110,539 Shares and the exercise of the Issue Mandate in full would enable the Company to allot and issue up to 632,221,078 Shares.

An explanatory statement to provide relevant information in respect of the Repurchase Mandate is set out in Appendix I to this circular.

RE-ELECTION OF DIRECTORS

According to Article 120 of the Articles of Association of the Company, not less than one-third of the Directors for the time being shall retire from office by rotation at every annual general meeting of the Company and the retiring Directors shall be eligible for re-election.

In accordance with Article 120, Mr. Lam Wai Wah (“Mr. Lam”), Mr. Cheung Wing Cheung (“Mr. Cheung”) and Mr. Heung Kai Sing (“Mr. Heung”) shall retire from their offices by rotation at the AGM.

Being eligible, Mr. Lam, Mr. Cheung, and Mr. Heung will offer themselves for re-election as Directors. At the AGM, ordinary resolutions will be proposed for their respective re-election.

Mr. Heung has been appointed as an Independent Non-executive Director for more than nine years. Pursuant to the B.2.3 of Corporate Governance Code in appendix 14 of the Listing Rules, if an independent non-executive director has served more than nine years, his further appointment should be subject to a separate resolution to be approved by shareholders.

The Company has received from Mr. Heung the confirmation of independence pursuant to Rule 3.13 of the Listing Rules. Mr. Heung has not engaged in any executive management of the Group. Taking into consideration of his independent scope of works in the past years, the Board consider Mr. Heung to be independent under the Listing Rules despite the fact that he

has served the Company for more than nine years. Accordingly, Mr. Heung will be subject to retirement by rotation and re-election by way of separate resolution to be approved by the Shareholders at the AGM.

Particulars relating to Mr. Lam, Mr. Cheung and Mr. Heung are set out in Appendix II to this circular.

In accordance to Article 100 of the Articles of Association of the Company, Mr. Cheung Wai Yin, Wilson (“Mr. Wilson Cheung”), who was appointed by the Board as a Director on 25 March 2023, shall hold office until the first AGM at which Mr. Wilson Cheung shall be eligible for re-election at that meeting. The Company has received from Mr. Wilson Cheung the confirmation of independence pursuant to Rule 3.13 of the Listing Rules. Accordingly, the Board considers Mr. Wilson Cheung to be independent under the Listing Rules. Mr. Wilson Cheung has not engaged in any executive management of the Group.

Particulars relating to Mr. Wilson Cheung is set out in Appendix II to this circular.

ANNUAL GENERAL MEETING AND PROXY PROCEDURE

A notice convening the AGM for the purpose of considering and, if thought fit, passing the above-mentioned ordinary resolutions is set out on pages 12 to 15 of this circular. A form of proxy is enclosed for use by Shareholders at the AGM. Shareholders are requested to complete and return the form of proxy to the Company’s principal office at 2nd Floor, Chung Shun Knitting Centre, 1–3 Wing Yip Street, Kwai Chung, New Territories, Hong Kong as soon as possible, but in any event not later than 48 hours before the time appointed for the holding of the AGM or any adjournment thereof. The lodging of a form of proxy will not preclude a Shareholder from attending the AGM and voting in person should he so wish.

Pursuant to Rule 13.39(4) of the Listing Rules, all resolutions set out in the notice of AGM shall be decided by poll.

RECOMMENDATIONS

The Directors believe that the proposed resolutions set out in the notice of AGM are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors recommend that you vote in favour of all the resolutions to be proposed at the AGM.

The following is the Explanatory Statement required to be sent to Shareholders for their consideration by the Listing Rules in relation to the Repurchase Mandate.

REPURCHASE MANDATE

It is proposed that, pursuant to the Repurchase Mandate, up to 10 per cent. of the fully-paid Shares in issue as at the date of the passing of the resolution for the grant of the Repurchase Mandate.

As at the Latest Practicable Date, the number of Shares in issue was 3,161,105,398. Accordingly, assuming that no Shares will be issued or repurchased prior to the AGM, the exercise of the Repurchase Mandate in full would enable the Company to repurchase up to 316,110,539 fully-paid Shares in issue.

Reasons for repurchases

The Directors believe that it is in the best interests of the Company and its Shareholders for the Directors to have a general authority from Shareholders to repurchase Shares in the market. Repurchases of Shares will only be made when and to the extent that the Directors believe that such repurchases will benefit the Company and its Shareholders. Repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the value of the Shares and/or the earnings per Share.

Funding of repurchases

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum and Articles of Association and the laws of the Cayman Islands. It is envisaged that the funds required for any repurchase would be derived from the capital paid up on the Shares to be repurchased and/or from the distributable profits of the Company.

SHARE REPURCHASES MADE BY THE COMPANY

Save as disclosed above, during the six months prior to the Latest Practicable Date, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the Company's Shares.

General

The Repurchase Mandate, if exercised in full, may have a material adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the Company's audited financial statements for the year ended 31 December 2022. The Directors, however, do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse impact on the working capital requirements or the gearing levels of the Company at the time of the relevant purchases.

None of the Directors nor, to the best of the knowledge and belief of the Directors (having made all reasonable enquiries), any of their close associates, has any present intention to sell any Shares to the Company in the event that the Repurchase Mandate is granted by the Shareholders.

No connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is granted by shareholders.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

If as a result of a share repurchase, a Shareholder's proportionate interest in the voting rights of the Company will increase, such increase will be treated as an acquisition for the purposes of Rules 26 and 32 of the Hong Kong Code on Takeovers and Mergers (the "Takeovers Code"). As a result, a Shareholder, or group of Shareholders acting in concert, could obtain or consolidate control of the Company and may become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. As at the Latest Practicable Date, Mr. Lam Wai Wah ("Mr. Lam") and his family are beneficially interested in approximately 47.98 per cent. of the issued share capital of the Company. In the event the Directors exercised in full the power to repurchase Shares pursuant to the Repurchase Mandate, the percentage of the issued share capital of the Company in which Mr. Lam and his family would be beneficially interested would increase to 53.31 per cent. Such an increase would give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. In the event that any exercise of the Repurchase Mandate would, to the knowledge of the Directors, have such a consequence under Rule 26 of the Takeovers Code, the Directors would not exercise the mandate to such an extent.

The details of the Directors who will retire from their offices at the AGM and being eligible, will offer themselves for re-election at the AGM, are set out below:

Mr. Lam Wai Wah (“**Mr. Lam**”), aged 70, is the Chairman, Managing Director and controlling shareholder of the Company. He is the founder of the Group and has over 40 years of experience in the electronics industry. He is primarily responsible for the formulation of the Group’s overall strategic planning and business development. Mr. Lam does not have any relationship with any Director, senior management, substantial or controlling shareholder(s) of the Company, and, as at the Latest Practicable Date, he is deemed to have interest in 1,516,696,000 ordinary shares, of which 74,844,000 ordinary shares are held by his spouse, of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Mr. Lam has entered into a service contract with the Company. His total remuneration was in the total sum of HK\$13,949,000 for the financial year ended 31 December 2022. The amount comprised basic salary of HK\$4,024,000 per annum, a discretionary bonus of HK\$9,925,000. The level of this remuneration was reviewed by the Remuneration Committee and determined on the basis of his responsibilities to be involved in the Company, the prevailing market conditions and the performance of the Company’s results. This service contract does not provide for a fixed term of service and may be terminated by either party at any time upon one party giving to the other party three months’ prior notice in writing or payment in lieu of notice.

Mr. Cheung Wing Cheung (“**Mr. Cheung**”), age 52, is an Executive Director of the Company. He holds a Master of Philosophy Degree and a Bachelor of Engineering Degree from The University of Hong Kong, and a Bachelor of Laws Degree from the University of London. He is responsible for overseas sales and marketing affairs (excluding handheld phone products) of the Group. Mr. Cheung has been serving the Group since year 2000 and in the senior management position for more than 10 years. Before joining the Group, he worked for the technical position from a multi-national technology company. Mr. Cheung does not have any relationship with any Director, senior management, substantial or controlling shareholder(s) of the Company, and, as at the Latest Practicable Date, he does not have any interests in the shares of the Company within the meaning of Part XV of the Securities and Future Ordinance.

There is no service contract between the Company and Mr. Cheung. His total remuneration was in the total sum of HK\$2,313,000 for the financial year ended 31 December 2022. The amount comprised basic salary of HK\$1,380,000, a performance bonus of HK\$915,000 and contribution to retirement benefit scheme of HK\$18,000. The level of this remuneration was reviewed by the Remuneration Committee and determined on the basis of his responsibilities involved in the Company, the prevailing market conditions and the performance of the Company’s results. His employment with the Company may be terminated by either party at any time upon one party giving to the other party three months’ prior notice in writing or payment in lieu of notice.

Save as disclosed above, Mr. Lam and Mr. Cheung do not have any interest of short position in the shares underlying shares of debentures of the Company or any of its association corporation within the meaning of Part XV of the Securities and Future Ordinance.

Save as disclosed above, Mr. Lam and Mr. Cheung did not have other directorships held in listed public companies in the last three years.

Save as disclosed above, there is no other matter concerning Mr. Lam and Mr. Cheung that need to be brought to the attention of the Shareholders or any information that is required to be disclosed pursuant to paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules.

Mr. Heung Kai Sing (“**Mr. Heung**”), aged 74, is an Independent Non-executive Director of the Company since April 1995 and a member of the Audit Committee, Remuneration Committee and Nomination Committee of the Company. He has experience in textile industry. Mr. Heung does not have any relationship with any Director, senior management, substantial or controlling shareholder of the Company.

There is no service contract between the Company and Mr. Heung. The appointment of Mr. Heung as an Independent Non-executive Director of the Company is for a term of one year. The term shall continue thereafter for successive terms of one year unless terminated by either party giving not less than one month’s notice in writing to the other party. For the financial year ended 31 December 2022, Mr. Heung received an annual director’s fee of HK\$132,000. The amount of director’s fee of Mr. Heung was reviewed by the Remuneration Committee and determined by reference to his duties and responsibilities involved in the Company and the prevailing market conditions.

Save as disclosed above, Mr. Heung did not have other directorships held in listed public companies in the last three years.

Mr. Heung does not have any interest of short position in the shares, underlying shares or debentures of the Company or any of its association corporation within the meaning of Part XV of the Securities and Future Ordinance.

Save as disclosed above, there is no other matter concerning Mr. Heung that needs to be brought to the attention of the Shareholders or any information that is required to be disclosed pursuant to paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules.

Mr. Cheung Wai Yin, Wilson (“**Mr. Wilson Cheung**”), age 51, is an independent non-executive Director of the Company and a member of the Audit Committee, Remuneration Committee and Nomination Committee of the Company since 25 March 2023. He has over 27 years of experience in the field of audit, business development, corporate finance and financial management. He is currently an executive director and was the chairman and CEO from 2012 to 2020 of Merdeka Financial Group Limited, a company listed on the Stock Exchange (stock code: 8163).

Mr. Wilson Cheung is a member of The Institute of Chartered Accountants in England and Wales, Hong Kong Institute of Certified Public Accounts and Hong Kong Securities and Investment Institute. He holds a Master of Science degree in Financial Engineering from City University of Hong Kong and Bachelor degrees in Arts and Administrative Studies from York University, Canada.

Mr. Wilson Cheung has entered into an appointment letter dated 25 March 2023 with the Company for an initial term until the next annual general meeting and shall be automatically renewed for another one year, terminable by either party by giving not less than one month's notice in writing, and subject to retirement by rotation and re-election in accordance with the provisions of the articles of association of the Company. Under the appointment letter, Mr. Wilson Cheung is entitled to a director's service fee HK\$180,000 per annum which is determined by the Board after taking into account the recommendation from the remuneration committee of the Board with reference to Mr. Wilson Cheung's duties and responsibilities with the Company.

Save as disclosed herein, Mr. Wilson Cheung has not held any directorship in other listed public companies in the last three years, has no relationship with any Directors, senior management or substantial or controlling Shareholders, has not taken any other major positions in the Group, and does not have any interest of short position in the shares, underlying shares or debentures of the Company or any of its association corporation which are required to be disclosed pursuant to Part XV of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

Save as disclosed above, there is no other matter concerning Mr. Wilson Cheung that needs to be brought to the attention of the Shareholders or any information that is required to be disclosed pursuant to paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules.
