CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders:

On behalf of the Board of Directors (the "Board") of Yu Tak International Holdings Limited (the "Company"), it is my pleasure to present the Annual Report of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2022.

Following a 8.1% growth in 2021, the economic growth of Mainland China slowed down to 3.0% mainly due to the continued disruptions of Covid-19. From 2023, the epidemic had been to formally put to an end and it would unlikely be irritating recovery again. Nevertheless, retail sales might need some more time to dust off the impacts from the persisting financial problems in property development and affected sectors.

The Group's Sales of Gold and Jewellery products business in 2022 fell by 52%. After a year of aggressive rate hikes that the precious metal markets were troubled, international gold price will be expected to return to its ascending trend and sales of the Group for 2023 would be favoured. Compared with the Jewellery Products segment, the IT products and Services segment was less susceptible to negative impacts of the epidemic and these financial uncertainties.

The Group will adopt a prudent but optimistic view on the business environment of 2023. Any expansion plans and investment decisions will be accessed with dual care.

APPRECIATION

On behalf of all Board members, I would like to take this opportunity to express my gratitude to the Shareholders and business partners of the Group for their continued supports and trust during the past years, and my most sincere appreciation to the Directors, management and staff at all levels for their dedication, hard works and contributions to the Group.

本人謹代表御德國際控股有限公司(「本公司」)董事會(「董事會」),欣然呈報本公司及其附屬公司(以下統稱「本集團」)截至二零二二年十二月三十一日止年度的年報。

繼二零二一年8.1%的增長後,中國內地的經濟增長放緩至3.0%,乃主要由於新冠病毒疫情持續干擾。自二零二三年起,疫情正式結束,且不大可能復燃,再次影響經濟復甦步伐。然而,零售銷售可能需要更多時間方能擺脱房地產開發及其受影響行業持續財務問題的影響。

本集團於二零二二年的黃金及珠寶產品銷售業務下降52%。經過一年大幅加息,以致貴金屬市場陷入困境後,國際金價有望重回升勢,並利好本集團於二零二三年的銷售。與珠寶產品分部相比,資訊科技產品及服務分部受到疫情及該等財務不確定因素的負面影響較少。

本集團將對二零二三年的業務環境抱持審慎樂觀 的態度。任何擴張計劃及投資決定將經過雙重審 慎考慮後達致。

管理層討論及分析

FINANCIAL PERFORMANCE

For the year ended 31 December 2022, the Group's loss attributable to the owners of the Company amounted to HK\$6,915,000 (2021: HK\$8,908,000).

The Group's revenue for the year ended 31 December 2022 amounted to HK\$28,785,000 (2021: HK\$41,361,000).

The sales of gold and jewellery products decreased 52% to HK\$11,181,000 (2021: HK\$23,503,000). Revenue from enterprise software products amounted to HK\$13,388,000 (2021: HK\$13,340,000). Revenue from professional services dropped by 39% to HK\$2,775,000 (2021: HK\$4,518,000). Revenue form other operation amounted to HK\$1,441,000 (2021: Nil).

OPERATION REVIEW

According to the National Bureau of Statistics, Mainland China's economy had grown by 3.0% over 2022, adjusted downward from 3.9% of Q3 due to weaker performance in Q4. Besides, retail sales of consumer goods fell by 0.2% in 2022 though online sales were up by 6.2% representing 27.2% of the total retail sales. Disposable income had generally grown at the same pace as the economy.

Gold price finished 2022 at US\$1,824/oz, that a mild gain of 1% over the year was recorded following a significant fall in Q3 as the US Federal Reserves became less hawkish on inflation expectation. More stable gold prices should have favoured jewellery demand in Q4 but it showed a 28% decline from same quarter of 2021, the weakest quarter since 2003 due to COVID-related disruptions.

Revenue from sales of gold and jewellery products of the Group of 2022 fell from HK\$23,503,000 of 2021 to HK\$ 11,181,000 due to weaker demand of luxury products. On the other hand, income from IT Products and Services contracted to HK\$16,163,000 as a result of the Group's strategy to further scale down professional services businesses which demanded disproportionated investment in human resources.

財務表現

截至二零二二年十二月三十一日止年度,本集團之本公司擁有人應佔虧損為6,915,000港元(二零二一年:8,908,000港元)。

本集團截至二零二二年十二月三十一日止年度的 收入為28,785,000港元(二零二一年:41,361,000 港元)。

黃金及珠寶產品銷售下跌52%至11,181,000港元(二零二一年:23,503,000港元)。企業軟件產品的收入為13,388,000港元(二零二一年:13,340,000港元)。專業服務的收入減少39%至2,775,000港元(二零二一年:4,518,000港元)。其他業務的收入為1,441,000港元(二零二一年:零港元)。

業務回顧

根據國家統計局公佈的數據,中國內地經濟於二零二二年增長3.0%,惟由於第四季度表現疲弱,自第三季度的3.9%起有所下調。此外,二零二二年消費品零售銷售額下跌0.2%,惟線上銷售額則增長6.2%,佔零售銷售總額的27.2%。可支配收入與經濟增長大致同步。

金價於二零二二年年末時報每盎司1,824美元,繼第三季度大幅下跌之後,由於美國聯邦儲備局對通脹預期的態度有所緩和,全年錄得溫和上漲1%。金價趨向穩定本應有利帶動第四季度的珠寶需求,但由於與新冠病毒疫情有關的干擾,金價較二零二一年同期下降28%,為自二零零三年以來最疲軟的季度。

本集團於二零二二年的黃金及珠寶產品銷售收入由二零二一年的23,503,000港元減至11,181,000港元,乃由於較疲弱的奢侈品需求。另一方面,由於本集團進一步縮減專業服務業務的策略,專業服務業務的需求與人力資源投資並不匹配,資訊科技產品及服務的收益收縮至16,163,000港元。

管理層討論及分析

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 31 December 2022, the Group remained in a strong financial position with cash and bank balances of HK\$23,438,000 (2021: HK\$19,562,000).

As at 31 December 2022, the Group's issued shares were 1,947,690,000 shares (2021: 1,947,690,000 shares).

The Group monitored its capital structure using the gearing ratio which is net debt divided by total equity. For this purpose, the Group defined net debt as total debt, which comprises long-term and short-term borrowings, less cash and cash equivalents. Total equity comprised equity attributable to owners of the Company and non-controlling interests stated in the consolidated statement of financial position. The gearing ratio is not presented, it was nearly zero (2021: zero).

TREASURY POLICY

The Directors will continue to follow a prudent policy in managing the Group's cash and maintaining a strong and healthy liquidity to ensure that the Group is well placed to take advantage of future growth opportunities.

FOREIGN CURRENCY RISK

The Group does not have significant exposure on foreign currency risk. The functional currencies of the Group's entities are principally denominated in HK\$ and RMB. The Group has certain exposure to foreign currency risk as some of its business transactions, assets and liabilities are denominated in currencies other than the functional currencies of the respective Group entities such as USD. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities.

流動資金、財務資源及資本結構

本集團之財務狀況維持穩健,於二零二二年十二 月三十一日持有現金及銀行存款23,438,000港元 (二零二一年:19,562,000港元)。

於二零二二年十二月三十一日,本集團已發行股份為1,947,690,000股(二零二一年:1,947,690,000股)。

本集團按淨負債除以股權總額計算負債比率,以 此監控其資本結構。本集團將淨負債定義為負債 總額(包含長期與短期借貸)扣除現金及現金等價 物。股權總額由綜合財務狀況表中所列示之本公 司擁有人應佔股權及非控股權益組成。由於負債 比率接近零(二零二一年:零),故並無呈列。

庫務政策

董事將繼續維持審慎政策管理本集團之現金,並 維持穩健的流動資金,以確保本集團作好準備把 握日後之增長機遇。

外幣風險

本集團並無重大外幣風險。本集團實體的功能貨幣主要為港元及人民幣。本集團面臨一定外幣風險,乃由於其部份業務交易、資產及負債以本集團相關實體的功能貨幣以外的貨幣(如美元)計值。本集團目前並無就外幣交易、資產及負債制定外幣對沖政策。

SIGNIFICANT INVESTMENT, MATERIAL 重大投資、重大收購或出售附屬公司 **ACQUISITION OR DISPOSAL OF SUBSIDIARIES**

On 10 January 2021, the Group acquired an additional 19.9% equity interest in a subsidiary for HK\$10,000. After the acquisition, the subsidiary had become a wholly-owned subsidiary of the Group.

During the year ended 31 December 2022, the Group had invested RMB5 million in a newly established subsidiary which engaged in design, production and sales of smart rehabilitation products in Mainland China.

Except for the above, the Group did not have any significant investment and material acquisition and disposal of subsidiaries during the year ended 31 December 2022 (2021: Nil).

CONTINGENT LIABILITIES AND CAPITAL COMMITMENT

As at 31 December 2022, the Group had capital commitments amounting to HK\$396,000 (2021: Nil).

EVENT AFTER THE REPORTING PERIOD

Subsequent to the end of the reporting period, the Group had no significant subsequent event.

SEGMENTAL PERFORMANCE

For the year ended 31 December 2022, the revenue from the Jewellery Products segment and the IT Products and Services segment amounted to HK\$11,181,000 (2021: HK\$23,503,000) and HK\$16,163,000 (2021: HK\$17,858,000) and others HK\$1,441,000 (2021: Nil) respectively.

於二零二一年一月十日,本集團以10,000港元收 購一間附屬公司的額外19.9%股權。於收購後, 該附屬公司已成為本集團的全資附屬公司。

截至二零二二年十二月三十一日止年度,本集團 已向一間新成立附屬公司投資人民幣500萬元, 該公司在中國內地從事設計、製造及銷售智能康 復產品。

除上文所述者外,本集團於截至二零二二年十二 月三十一日止年度概無任何重大投資且並無進行 附屬公司的重大收購及出售(二零二一年:無)。

或然負債及資本承擔

於二零二二年十二月三十一日,本集團的資本承 擔為396,000港元(二零二一年:無)。

呈報期後事項

於呈報期結束後,本集團並無重大期後事項。

分部表現

截至二零二二年十二月三十一日止年度,來自 珠寶產品分部、資訊科技產品及服務分部及其 他之收入分別為11,181,000港元(二零二一年: 23,503,000港元)、16,163,000港元(二零二一年: 17,858,000港元)及1,441,000港元(二零二一年: 無)。

管理層討論及分析

EMPLOYEES AND REMUNERATION POLICIES

As at 31 December 2022, the number of employees of the Group was 55 (2021: 41). Remuneration is determined by reference to market terms and the performance, qualification and experience of individual employee. Year-end bonus based on individual performance will be paid to employees as recognition of and reward for their contributions.

FUTURE PROSPECTS

Economic growth of Mainland China slowed down to 3.0% in 2022 from 8.1% of 2021 due to disruptions of Covid-19. The epidemic had officially ended in Q1 2023 and would unlikely have any further impacts on the economy.

While the pace of global economic recovery is continually disturbed by rate hike expectations, persisting problems of leading real estate developers and also financial stresses of local government and private sectors will be back under the spotlight. It is believed that boosting domestic investments remains the mission of the government in 2023. The Group's businesses will benefit from merits of fiscal efforts in promoting economic growth and domestic demand.

The Group will maintain a prudent but optimistic view on its business environment of 2023. In terms of product segments, the heritage gold jewellery products will continue to dominate the market among higher- end consumers while younger buyers with lower budget gravitate towards lighter, more affordable, trendier, and lightweight gold jewellery in modern designs. For the IT Products and Services segment, the Group will keep looking for opportunities which have synergies with its core business.

僱員及薪酬政策

於二零二二年十二月三十一日,本集團僱員人數為55人(二零二一年:41人)。有關薪酬乃經參考市場水平以及個別僱員之表現、資歷及經驗後釐定。本集團將按個人表現向員工發放年終花紅,作為彼等貢獻之嘉許及獎勵。

未來展望

由於新冠病毒疫情的干擾,中國內地的經濟增長由二零二一年的8.1%放緩至二零二二年的3.0%。疫情已於二零二三年第一季度正式結束,且不太可能對經濟帶來任何進一步的影響。

在加息預期持續干擾全球經濟復甦步伐的同時, 主要房地產開發商持續存在的問題以及地方政府 及私營機構的財務壓力亦將再次成為關注的焦 點,相信促進國內投資仍是政府於二零二三年的 任務。本集團的業務將受惠於推動經濟增長及國 內需求的財務成果。

本集團將對其於二零二三年的業務環境將抱持審 慎樂觀的態度。就產品分部而言,傳統黃金珠寶 產品將繼續主導高端消費者市場,而預算較低的 年輕買家則傾向於現代設計中更輕便、經濟、時 尚、輕巧的黃金珠寶。就資訊科技產品及服務分 部而言,本集團將繼續尋找與核心業務有協同效 應的商機。

The Company is committed to the establishment of good corporate governance practices and procedures. The Directors believe that sound and reasonable corporate governance practices are essential for the growth of the Company and for safeguarding the shareholders' interests and the Company's assets.

Directors are given notice of regular Board meetings of at least 14 days in advance. The Directors will receive details of agenda with comprehensive reports on the management's strategic plans, updates by business unit heads on their lines of business, financial objectives, plans and actions at least 3 days before a Board meeting.

All Directors have access to the Company Secretary who is responsible for ensuring that Board procedures are complied with and advises the Board on corporate governance and compliance matters.

The executive Directors meet every two weeks to review company business pipeline, receivables, and business unit performance. Senior management of the Company (the "Senior Management") meets with Business Unit Management every week to review project status, and business unit issues.

The Company has undertaken several meetings, first with Senior Management, second with the audit committee, and subsequently with the Board, to discuss and review the Group's practice on corporate governance and make specific checks on the Group's compliance via a compliance matrix in accordance to the criteria set forth by the GEM Listing Rules.

The Company Secretary has assisted the chairman of the Board in preparing the agenda for each meeting and the minutes of such meetings are kept by the Company's company secretary or other duly authorised person. All minutes are open for inspection by any Director on reasonable notice. Draft(s) and final version of the minutes are sent to Directors for comment and records, respectively.

Pursuant to Section 58 of the Bye-Laws, any one or more shareholders of the Company holding as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the company secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionists themselves may do so in accordance with the provisions of Section 74 (3) of the Bye-Laws.

C) Right to Put Enquiries to the Board

Shareholders of the Company have the right to put enquiries to the Board. All such enquiries shall be in writing and sent by post to the principal place of business of the Company in Hong Kong for the attention of the Board or the company secretary. Shareholders may also make enquiries with the Board at the general meetings of the Company.

We considered this as key audit matter due to the significance of inventories (representing 36% of total assets) and the involvement of management judgement and • estimation on the net realisable value of inventories.

How the matter was addressed in our audit

the Group had inventories of and valuation of inventories included

- attended physical inventory counts at year end and performed "two-way" count on a sample basis;
 - inspected the external laboratory reports on the authenticity of gold and jewellery products for the samples selected by us;
 - obtained an understanding of management's process for identification of slow-moving inventories and estimation of net realisable value of inventories;
 - assessed, on a sample basis, the accuracy of the ageing of inventories; and
- tested the net realisable value of inventories with reference to subsequent sales information and external market price data, on a sample basis.

1. GENERAL INFORMATION

Yu Tak International Holdings Limited (the "Company") is incorporated in Bermuda as an exempted company with limited liability. The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM11, Bermuda and its principal place of business is Hong Kong. The Company's shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Company and its subsidiaries (together, the "Group") are principally engaged in the (i) development, sale and implementation of enterprise software and provision of professional services, (ii) design and sales of gold and jewellery products, (iii) design, production and sales of smart rehabilitation products and (iv) investment holding. The Group's operations are based in Hong Kong and the People's Republic of China (the "PRC").

The consolidated financial statements for the year ended 31 December 2022 were approved for issue by the board of directors on 21 April 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

These annual consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the accounting principles generally accepted in Hong Kong.

The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and include the applicable disclosure requirements of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the "GEM Listing Rules").

1. 一般資料

The significant accounting policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new and amended HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 3.

These consolidated financial statements have been prepared on the historical cost basis, except for financial assets at FVOCI which are stated at fair values. The measurement bases are fully described in the accounting policies below.

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 4.

2.2 Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries made up to 31 December each year.

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power over the entity, only substantive rights relating to the entity (held by the Group and others) are considered.

The Group includes the income and expenses of a subsidiary in the consolidated financial statements from the date it gains control until the date when the Group ceases to control the subsidiary.

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on sales of intra-group asset are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

Non-controlling interests represent the equity on a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at their proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from the equity attributable to the owners of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the owners of the Company.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

In the Company's statement of financial position, investments in subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost includes directly attributable costs of investment.

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

2.3 Foreign currency translation

The consolidated financial statements are presented in Hong Kong Dollars ("HK\$"), which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transaction date).

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into HK\$. Assets and liabilities have been translated into HK\$ at the closing rates at the reporting date. Income and expenses have been converted into HK\$ at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the exchange reserve in equity.

2.4 Property, plant and equipment

Property, plant and equipment are initially recognised at acquisition cost, including any cost directly attributable to bringing the assets to the location and condition necessary for them to be capable of operating in the manner intended by the Group's management. They are subsequently stated at cost less accumulated depreciation and accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method, at the following rates per annum:

Leasehold improvements 20% to 331/3%

Computer and office equipment 10% to 50%

Furniture and fixtures 20% to 25%

Motor vehicles 25% to 30%

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ("Stage 1"); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ("Stage 2").

"Stage 3" would cover financial assets that have objective evidence of impairment at the reporting date.

"12-month ECL" are recognised for the Stage 1 category while "lifetime ECL" are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade receivables and contract assets

For trade receivables and contract assets, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables and contract assets has been grouped based on shared credit risk characteristics and the days past due. The contract assets relate to unbilled work in progress have substantially the same risk characteristics as the trade receivables for the same types of contracts. The Group has therefore concluded that the ECL rates for trade receivables are a reasonable approximation of the loss rates for the contract assets.

Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in regulatory, business, financial, economic conditions, or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group); or (ii) the financial assets is 90 days past due.

Detailed analysis of the ECL assessment of trade receivables, contract assets and other financial assets measured at amortised cost are set out in note 35.4.

Inventories are carried at the lower of cost and net realisable value and are determined using the first in, first out basis. Net realisable value is the estimated selling price in the ordinary course of business less the applicable selling expenses.

2.8 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand.

2.9 Contract assets and contract liabilities

A contract asset is recognised when the Group recognises revenue before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in note 2.6 and are reclassified to receivables when the right to the consideration has become unconditional.

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Revenue from the development of customised software is recognised over time as the Group's performance creates and enhances an asset that the customer controls. The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the services transferred to the customer to date relative to the services promised under the contract, that best depict the Group's performance in transferring control of goods or services.

When the outcome of the contract cannot be reasonably measured, revenue is recognised only to the extent of contract costs incurred that are expected to be recovered.

If at any time the costs to complete the contract are estimated to exceed the remaining amount of the consideration under the contract, a provision is recognised in accordance with HKAS 37.

Warranties associated with enterprise software products cannot be purchased separately and are served as an assurance that the products sold comply with agreed-upon specifications (i.e. assurance-type warranties). Accordingly, the Group accounts for warranties in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets".

Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

Impairment losses recognised for cash-generating units is charged pro rata to the assets in the cash-generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

Retirement benefits

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund ("MPF") Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

The employees of the Group's subsidiaries which operate in the PRC, Taiwan and Malaysia are required to participate in the central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentage of their payroll costs to the central pension scheme.

Contributions are recognised as an expense in profit or loss as employees rendered services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the end of the reporting period between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the executive directors for their decisions about resources allocation to the Group's business components and for their review of the performance of those components. The business components in the internal financial information reported to the executive directors are determined following the Group's major product and service lines.

The Group has identified the following reportable segments:

- Jewellery Products: design and sales of gold and jewellery products
- IT Products and Services: provision of information technology and professional services and sales of products including enterprise software products
- Others: design, production and sales of smart rehabilitation products

Each of these operating segments is managed separately as each of the product and service lines requires different resources as well as marketing approaches. All inter-segment transfers are carried out at arm's length prices.

The measurement policies the Group uses for reporting segment results under HKFRS 8 "Operating Segments" are the same as those used in its consolidated financial statements prepared under HKFRSs.

No asymmetrical allocations have been applied to reportable segments.

Impairment of property, plant and equipment and right-of-use assets

If circumstances indicate that the carrying amount of a long-lived asset may not be recoverable, the asset may be considered "impaired" and an impairment loss may be recognised in accordance with HKAS 36 "Impairment of Assets".

These assets are tested for impairment whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. When such a decline has occurred, the carrying amount is reduced to the recoverable amount. The recoverable amount is the higher of its fair value less costs of disposal and its value in use.

In determining the value in use, the expected cash flows generated by the assets are discounted to their present value, which requires significant estimation.

As at 31 December 2022, the carrying amount of property, plant and equipment and right-of-use assets were HK\$1,123,000 (2021: HK\$1,323,000) (note 14) and HK\$2,249,000 (2021: HK\$836,000) (note 15) respectively.

Estimated fair values may vary from the actual prices that would be achieved in an arm's length transaction at the reporting date.

Estimation of impairment of trade receivables, other receivables and deposits and contract assets within the scope of ECL

The Group makes allowances on items subjects to ECL (including trade receivables, other receivables and deposits and contract assets) based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period as set out in note 2.6. The Group's objective is to maintain an appropriate level of liquid assets to meet its liquidity requirements in the short and longer term.

The directors believe that the change in fair value (which is included in other comprehensive income) derived from the valuation technique is reasonable and is the most appropriate value at the end of the reporting period.

As at 31 December 2022 and 2021, the fair value of an unlisted equity investment has been arrived at on the basis of a valuation carried out by Avista Valuation Advisory Limited, independent qualified professional valuers, using the adjusted net assets method as the major assets are investment properties to earn rentals. The value of those major assets has been adjusted to their fair value at the reporting date using income capitalisation method for the purpose of determining the Group's share of adjusted net assets value and fair value of the investment.

36. CAPITAL MANAGEMENT

The Group's capital management objectives are to ensure the Group's ability to continue as a going concern and to provide an adequate return for shareholders by pricing goods and services commensurately with the level of risks.

The Group actively and regularly reviews and manages its capital structure and makes adjustments in light of changes in economic conditions. In order to adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, issue new shares and raises new debt financing.
