This announcement is made by China Saftower International Holding Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the unaudited consolidated management accounts of the Group for the three months ended 31 March 2023 (“**3M2023**”) and the information currently available to the Board, the Group is expected to record a net loss of approximately RMB5.4 million for 3M2023, representing an increase in net loss of approximately RMB1.1 million as compared to a net loss of approximately RMB4.4 million for the three months ended 31 March 2022. The increase in net loss was mainly attributable to the combined effect of (1) substantial decrease in government grant of a approximately RMB5.0 million, (2) expense reduction from selling expense, administrative expense and finance cost with aggregated amount of approximately RMB2.7 million and (3) tax credit increased by approximately RMB1.0 million.

As the Company is still in the process of finalising its unaudited consolidated financial results for 3M2023, the information contained in this announcement is only based on the information currently available and the preliminary assessment by the Board with reference to the unaudited consolidated management accounts of the Group for 3M2023, which has not been reviewed or audited by the Company's auditor or reviewed by the audit committee of the Company, and is subject to further adjustments. The actual results for 3M2023 may be different from the information disclosed in this announcement. Shareholders and potential investors are advised to read carefully the first quarterly results announcement of the Group for 3M2023, which is expected to be published on or around 15 May 2023 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
