POLL RESULTS OF 2022 ANNUAL GENERAL MEETING

References are made to the notice of the 2022 annual general meeting (the “**AGM**”) and the circular (the “**Circular**”) of Jilin Province Chuncheng Heating Company Limited* (the “**Company**”) both dated 25 April 2023. Unless otherwise defined in this announcement, capitalized terms used in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

The Board is pleased to announce that the AGM was held on Friday, 19 May 2023 at the Conference Room 711, Chuncheng Heating, No. 998 Nanhу Road, Nanguan District, Changchun City, Jilin Province, the PRC.

As at the date of the AGM, the Shares of the Company in issue, i.e. the total number of Shares entitling the holders to attend the AGM and vote on any resolution proposed at the meeting, was 466,700,000 Shares, comprising 350,000,000 Domestic Shares and 116,700,000 H Shares. To the best knowledge, information and belief of the Board after having made all reasonable enquiries, there were no restrictions on any Shareholders to cast votes on any of the resolutions at the AGM, and there were no Shares entitling the holders to attend the AGM and vote only against the resolutions proposed at the meeting. No person had indicated his, her or its intention in the Circular to vote against the resolutions proposed at the AGM or abstain from voting.

Shareholders or their proxies who hold a total of 350,196,624 voting Shares, representing approximately 75.04% of the issued share capital of the Company in aggregate as at the date of the AGM, attended the AGM. The AGM was legally and validly convened in compliance with the requirements of the PRC Company Law, relevant PRC laws and regulations, the Listing Rules and the Articles of Association. The AGM was chaired by Mr. Sun Huiyong, the chairman of the Board. The voting at the AGM was taken by way of poll.

PAYMENT OF FINAL DIVIDEND

As approved by the Shareholders at the AGM, the Board is pleased to announce the following details in respect of the payment of final dividend for the year ended 31 December 2022 to the Shareholders:

The Company will pay the 2022 Final Dividends on Friday, 7 July 2023 in cash to the Shareholders whose names appear on the register of members of the Company on Wednesday, 7 June 2023. The 2022 Final Dividends shall be denominated and declared in RMB at RMB0.09 per Share (inclusive of tax). Dividends on Domestic Shares will be paid in RMB and dividends on H Shares will be paid in Hong Kong dollars. The exchange rate of RMB into Hong Kong dollar shall be calculated based on the average central parity rates of Hong Kong dollar to RMB as published by the PBOC in the calendar

week before the date which the Company declares such dividends (i.e. HK\$1 to RMB0.8749), i.e. a cash dividend of HK\$0.1029 per H Share (inclusive of tax) will be paid to holders of H Shares. For the matters regarding the taxation relating to the payment of the final dividend and the closure of register of members, please refer to the Circular.
