The Board is pleased to announce that all resolutions (“**Resolutions**”) as set out in the AGM Notice were duly passed by the shareholders of the Company by way of poll at the annual general meeting (the “**AGM**”) held on June 2, 2023.

Tricor Secretaries Limited, the branch share registrar of the Company in Hong Kong, was appointed as scrutineer for the vote-taking at the AGM.

There were no parties that had stated their intention in the Circular to vote against the Resolutions or to abstain from voting on the Resolutions. No Shareholder was required to abstain from voting under the Listing Rules.

The total number of Shares entitling the Shareholders to attend and vote for or against the Resolutions at the AGM was 2,829,753,157 Shares, representing the entire issued share capital of the Company as at the date of the AGM.
