In case of any change in the total number of issued shares of the Company as at 14 July 2023 (the "Record Date") as a result of placing, repurchase, or conversion of convertible bonds into shares, the amount of cash dividend per share will be adjusted accordingly based on the total amount of RMB2,331,574,325.48 (inclusive of tax).

Due to the conversion of the A Share convertible corporate bonds (the "A Share Convertible Bonds") which were publicly issued by the Company on 24 March 2022, the total number of issued shares of the Company increased from 10,137,279,676 shares to 10,347,118,026 shares during the period from 1 January 2023 to 7 July 2023. During the period from 10 July 2023 to the Record Date, the conversion of the A Share Convertible Bonds will be suspended, and therefore it is expected that the total number of issued shares of the Company will remain unchanged at 10,347,118,026 shares on the Record Date. As the total amount of the 2022 Final Dividend will remain unchanged, the amount of cash dividend per share will be adjusted from RMB0.23 (inclusive of tax) to RMB0.22533 (inclusive of tax) based on the enlarged total number of issued shares of the Company. Based on the average benchmark exchange rate of RMB against HK dollars announced by the People's Bank of China for the five business days prior to the date of the AGM (i.e. RMB0.918954 against HK\$1.00), the 2022 Final Dividend will be adjusted from HK\$0.250285 per H Share (inclusive of tax) to HK\$0.245202 per H Share (inclusive of tax).
