

# I FTTER FROM THE BOARD

# 董事會函件

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Director(s)") of Yuk Wing Group Holdings Limited (the "Company") and its subsidiaries (collectively referred to as the "Group"), I would like to present the 2022/23 annual report of the Group for the year ended 31 March 2023.

#### **REVIEW**

For the year ended 31 March 2023 (the "Year"), the Group's revenue was approximately HK\$157.0 million (2022: approximately HK\$141.7 million). Such increase was mainly attributable to the improvement in business environment in Hong Kong, leading to a higher level of construction works and projects available during the Year when compared with the year ended 31 March 2022, resulting in a higher than expected demand for our products.

The Group recorded a net loss of approximately HK\$3.6 million for the Year as compared to the net loss of approximately HK\$1.5 million for the year ended 31 March 2022. This was mainly attributable to the increase in fair value loss in financial assets at fair value through profit or loss, impairment losses under expected credit loss model, freight, transportation and storage costs, and staff costs, partially offset with the increase in revenue, gross profit and taxation credit during the Year.

### **PROSPECTS**

Looking ahead, the Group is cautiously positive about the prospects of the market and will continue to focus on our core business of manufacturing and trading of down-the-hole ("DTH") rockdrilling tools in Hong Kong and Macau, and our efforts to strengthen and extend our presence in the overseas markets. In order to maximise the long term returns to our Shareholders, the Group will devote more resources towards the development of our manufacturing and trading of DTH rockdrilling tools business.

#### APPRECIATION

Lastly, I would like to express our sincere gratitude to our shareholders, customers and business partners for their continuous support, and to our management and staff members for their diligence, dedication and contribution to the growth of the Group.

本人謹代表煜榮集團控股有限公司(「本公司」) 及其附屬公司(統稱「本集團」)董事(「董事」) 會(「董事會」)呈報本集團截至二零二三年三月 三十一日止年度的二零二二/二三年報。

### 回顧

截至二零二三年三月三十一日止年度(「本年度」),本集團收益約為157.0百萬港元(二零二二年:約141.7百萬港元)。該增加主要歸因於香港營商環境改善,令本年度的建築活動及可施工項目較截至二零二二年三月三十一日止年度有所提升,導致對我們產品的預期需求增加。

本集團於本年度錄得淨虧損約3.6百萬港元, 而截至二零二二年三月三十一日止年度則錄得 淨虧損約1.5百萬港元。此乃主要由於透過損 益按公平值入賬之金融資產之公平值虧損、預 期信貸虧損模式項下的減值虧損、運費、交通 及儲存成本以及員工成本增加,惟部分被本年 度收益、毛利及税項抵免增加抵銷所致。

### 前景

展望未來,本集團對市場前景保持審慎且正面的態度,並將繼續專注發展我們於香港及澳門製造及買賣潛孔(「潛孔」)鑿岩工具的核心業務,致力鞏固及拓展在海外市場的份額。為求向股東帶來最大的長期回報,本集團將在發展製造及買賣潛孔鑿岩工具業務方面投放更多資源。

### **BUSINESS REVIEW**

The Group is principally engaged in the manufacturing and trading of DTH rockdrilling tools, trading of piling and drilling machineries and rockdrilling equipment.

During the Year, the market environment in Hong Kong has improved due to the continuous improvement in the timeliness of approval of public works budgets by the Finance Committee ("Finance Committee") of the Legislative Council of Hong Kong ("LegCo"), leading to more construction projects available in the Hong Kong market. At the international level, the revenue generated from the Scandinavia market has slightly increased during the Year as a result of the improvement of business conditions. As a result, this had a favourable contribution to our Group's revenue as our local and international customers have increased their purchases of our products. There have been increases in fair value loss in financial assets at fair value through profit or loss of approximately HK\$1.7 million (2022: fair value gain of approximately HK\$1.6 million), and impairment loss of trade receivables of approximately HK\$4.3 million (2022: approximately HK\$0.8 million) during the Year. The effects as mentioned above have resulted in an increase in the loss position during the Year, where the loss for the Year is approximately HK\$3.6 million, as compared with the loss of approximately HK\$1.5 million for the year ended 31 March 2022.

Hong Kong remains to be the Group's major market, where the revenue generated from Hong Kong contributed to approximately HK\$149.5 million for the Year (2022: approximately HK\$128.9 million), or approximately 95.2% of the total revenue during the Year (2022: approximately 90.9%).

The business in the Scandinavian region has improved, where the revenue generated from Scandinavia contributed to approximately HK\$5.2 million (2022: approximately HK\$2.5 million), or approximately 3.3% of the total revenue during the Year (2022: approximately 1.7%).

# 業務回顧

本集團主要從事製造及買賣潛孔鑿岩工具、買 賣打樁機及鑽機和鑿岩設備。

於本年度,由於香港立法會(「立法會」)財務委員會(「財務委員會」)持續改善審批公共工程開支預算的時間,香港市場環境有所改善,使主意,我們自斯堪的納維亞市場於業務狀況改善,我們自斯堪的納維亞市場。於本年度略為增加。因此,我們的內域產生有利貢獻。於本年度,透過損增加約4.3百萬港元(二零二二年:公平值收益約1.6百萬港元(二零二二年:約0.8百萬港元),而貿易應收款項減值虧損增加約4.3百萬港元(二零二二年:約0.8百萬港元)。上述影響導致本年度虧損狀況增加,本年度虧損約為3.6百萬港元,而截至二零二二年三月三十一日止年度虧損約為1.5百萬港元。

香港仍為本集團的主要市場,其中於本年度在香港產生的收益約為149.5百萬港元(二零二二年:約128.9百萬港元),或佔本年度總收益約95.2%(二零二二年:約90.9%)。

斯堪的納維亞地區的業務已改善,其中於本年 度在斯堪的納維亞產生的收益約為5.2百萬港 元(二零二二年:約2.5百萬港元),或佔本年 度總收益約3.3%(二零二二年:約1.7%)。

# **Manufacturing and Trading of DTH Rockdrilling Tools**

The Group is principally engaged in the manufacturing and trading of DTH rockdrilling tools. Our self-designed and manufactured DTH rockdrilling tools can be categorised into the following main categories, namely DTH hammers, casing systems (comprising driver bits and casing bits), and other miscellaneous products including button bits and bit openers, as well as our newly developed products, drill pipes, cluster drills and casing tubes. Revenue from the manufacturing and trading of DTH rockdrilling tools contributed to approximately 93.3% of the total revenue during the Year (2022: approximately 82.1%).

#### Trading of Piling and Drilling Machineries and Rockdrilling Equipment

The Group is also engaged in the trading of piling and drilling machineries and rockdrilling equipment to our customers as part of our technical rockdrilling solutions. There are no revenue from the trading of piling and drilling machineries during the Year (2022: approximately 7.1% of total revenue), and revenue from trading of rockdrilling equipment contributed to approximately 6.7% of the total revenue during the Year (2022: approximately 10.8%).

### **FINANCIAL REVIEW**

### **Consolidated Results of Operations**

The Group's revenue increased by approximately HK\$15.3 million or 10.8%, to approximately HK\$157.0 million for the Year, from approximately HK\$141.7 million for the year ended 31 March 2022. Our gross profit for the years ended 31 March 2022 and 2023 were approximately HK\$39.6 million and approximately HK\$43.4 million respectively. For the years ended 31 March 2022 and 2023, the revenue from the manufacturing and trading of DTH rockdrilling tools accounted for approximately 82.1% and approximately 93.3% of the total revenue, respectively. The revenue from trading of piling and drilling machineries, and trading of rockdrilling equipment accounted for the rest of our revenue. We sell our products to customers in Hong Kong, Macau, and through distributors in Finland and Japan to end users in Scandinavia and Japan respectively. We generated most of our revenue from sales in Hong Kong, which accounted for approximately 90.9% and approximately 95.2% of our total revenue for the years ended 31 March 2022 and 2023 respectively.

#### 製造及買賣潛孔鑿岩工具

本集團主要從事製造及買賣潛孔鑿岩工具。我們自主設計及製造的潛孔鑿岩工具主要分為以下類別:潛孔錘、套管系統(包括驅導鑽頭及套管鑽頭)及其他雜項產品(包括球齒鑽頭及擴孔器)以及新開發產品、鑽桿、叢式鑽具及套管。製造及買賣潛孔鑿岩工具的收益佔本年度總收益約93.3%(二零二二年:約82.1%)。

### 買賣打樁機及鑽機和鑿岩設備

本集團亦從事根據鑿岩技術解決方案向客戶買賣打樁機及鑽機和鑿岩設備。於本年度概無買賣打樁機及鑽機的收益(二零二二年:佔總收益約7.1%),而本年度買賣鑿岩設備的收益佔本年度總收益約6.7%(二零二二年:約10.8%)。

#### 綜合經營業績

本集團收益由截至二零二二年三月三十一日止年度約141.7百萬港元增加約15.3百萬港元或10.8%至本年度約157.0百萬港元。我們於截至二零二二年及二零二三年三月三十一日止年度的毛利分別約為39.6百萬港元及約43.4百萬港元。於截至二零二二年及二零二三年三十一日止年度,製造及買賣潛孔鑿岩工具的收益分別佔總收益約82.1%及約93.3%。以對方數方別的數學不以及透過芬蘭及日本的分銷商分別的斯堪的納維亞及日本的分銷商分別的斯堪的納維亞及日本三月三十一日止年度,我們大部分收益來自於多約95.2%。

#### Revenue

Revenue for the Group has increased from approximately HK\$141.7 million for the year ended 31 March 2022 to approximately HK\$157.0 million for the year ended 31 March 2023, an increase of approximately HK\$15.3 million or 10.8%. The increase in revenue is primarily caused by the improvement in business environment in Hong Kong, leading to a higher level of construction works and projects available during the Year when compared with the year ended 31 March 2022, resulting in a higher than expected demand for our products.

#### **Gross Profit and Gross Profit Margin**

The Group's gross profit increased by approximately HK\$3.8 million or 9.6%, to approximately HK\$43.4 million for the Year, from approximately HK\$39.6 million for the year ended 31 March 2022, primarily due to the increase in revenue as mentioned above. Gross profit margin was approximately 27.6% for the Year as compared to gross profit margin of approximately 27.9% for the year ended 31 March 2022.

#### **Other Gains and Losses**

The Group recorded net other gains of approximately HK\$0.5 million for the Year as compared to the net other gains of approximately HK\$2.4 million for the year ended 31 March 2022. This was mainly attributable to the increase in fair value loss on financial assets at fair value through profit or loss for the Year.

Fair value changes of financial assets at fair value through profit or loss and securities investment

In March 2022, the Company acquired listed securities on the open markets at an aggregate consideration of approximately HK\$23.4 million. As at 31 March 2023, the fair value of the listed securities held by the Company amounted to approximately HK\$23.3 million (31 March 2022: approximately HK\$25.0 million). Dividend income of approximately HK\$1.1 million (2022: approximately HK\$0.2 million) were received from the investment of listed securities during the Year. Details of which in respect of the acquisition of listed securities are set out in the Company's announcement dated 8 March 2022 and 9 March 2022 respectively. Save as disclosed in this annual report, there was no other additional acquisition or disposal of listed securities during the Year.

The Group regularly monitors its investment performance and make appropriate investment decisions regularly. In addition, the Group would allocate part of its idle resources from time to time to purchase principal-guaranteed wealth management products to increase its overall return.

#### 收益

本集團的收益由截至二零二二年三月三十一日 止年度的約141.7百萬港元增加約15.3百萬港 元或10.8%至截至二零二三年三月三十一日止 年度的約157.0百萬港元。收益增加主要由於 香港營商環境有所改善,與截至二零二二年三 月三十一日止年度相比,於本年度的建築活動 及可施工項目數量處於較高水平,導致對我們 產品的需求高於預期。

#### 毛利及毛利率

本集團的毛利由截至二零二二年三月三十一日 止年度約39.6百萬港元增加約3.8百萬港元或 9.6%至本年度約43.4百萬港元,主要由於上 述收入增加所致。本年度的毛利率約為 27.6%,而截至二零二二年三月三十一日止年 度的毛利率約為27.9%。

#### 其他收益及虧損

本集團於本年度錄得其他收益淨額約0.5百萬港元,而截至二零二二年三月三十一日止年度的其他收益淨額約為2.4百萬港元。主要原因為本年度透過損益按公平值入賬之金融資產之公平值虧損增加。

透過損益按公平值入賬之金融資產之公平值變動及證券投資

於二零二二年三月,本公司於公開市場收購上市證券,總代價約為23.4百萬港元。於二零二三年三月三十一日,本公司持有的上市證券公平值約為23.3百萬港元(二零二二年三月三十一日:約25.0百萬港元)。於本年度自上市證券投資收到股息收入約1.1百萬港元(二零二二年:約0.2百萬港元)。有關收購上市證券的詳情分別載於本公司日期為二零二二年三月八日及二零二二年三月九日的公告。除本年報所披露者外,於本年度概無其他額外上市證券收購或出售事項。

本集團定時監察其投資表現,並定時作出適合的投資決定。此外,本集團將不時分配部分其 閒置資源購買本金擔保的財富管理產品,以增 加其整體回報。

#### **Selling and Distribution Expenses**

The Group's selling and distribution expenses increased by approximately HK\$2.1 million or 27.9%, to approximately HK\$9.5 million for the Year, from approximately HK\$7.4 million for the year ended 31 March 2022, mainly due to the increase in freight, transportation and storage costs as a result of the increase in revenue during the Year.

#### **Administrative Expenses**

The Group's administrative expenses increased by approximately HK\$4.0 million or 11.1%, to approximately HK\$39.8 million for the Year, from approximately HK\$35.8 million for the year ended 31 March 2022, primarily due to the increase in staff costs during the Year.

#### **Net Loss**

The Group recorded a net loss of approximately HK\$3.6 million for the Year as compared to the net loss of approximately HK\$1.5 million for the year ended 31 March 2022. This was mainly attributable to the increase in fair value loss in financial assets at fair value through profit or loss, impairment losses under expected credit loss model, freight, transportation and storage costs, and staff costs, partially offset with the increase in revenue, gross profit and taxation credit during the Year.

#### STRATEGY AND PROSPECTS

During the Year, the Group continued to develop its various business and geographical segments. In Hong Kong, there has been continuous improvement in the progress of the approval of budgets of public works projects by the Finance Committee. It is anticipated that the progress of budget approval and administration of public works projects will continue to improve for the remainder of the year.

Internationally, as the travelling and quarantine restrictions relax, the Group will continue to promote and develop our international businesses at the overseas exhibitions and trade shows when resumed.

Overall, the Group is cautiously positive towards the future of the construction market and the business of the Group in Hong Kong and internationally, and will continue its efforts to capture business opportunities in Hong Kong, Macau and the overseas markets.

#### 銷售及分銷開支

本集團的銷售及分銷開支由截至二零二二年三月三十一日止年度約7.4百萬港元增加約2.1百萬港元或27.9%至本年度約9.5百萬港元,主要由於本年度收益增加令運費、交通及儲存成本增加所致。

#### 行政開支

本集團的行政開支由截至二零二二年三月三十一日止年度約35.8百萬港元增加約4.0百萬港元或11.1%至本年度約39.8百萬港元,主要由於本年度員工成本增加所致。

#### 淨虧損

本集團於本年度錄得淨虧損約3.6百萬港元, 而截至二零二二年三月三十一日止年度則錄得 淨虧損約1.5百萬港元。此乃主要由於透過損 益按公平值入賬之金融資產之公平值虧損、預 期信貸虧損模式項下的減值虧損、運費、交通 及儲存成本以及員工成本增加,惟部分被本年 度收益、毛利及税項抵免增加抵銷所致。

## 策略及前景

本集團於本年度繼續發展其多個業務及區域分部。於香港,財務委員會審批公共工程項目預算的進度已見持續改善。預計於本年度剩餘時間內,公共工程項目預算審批及管理進度將繼續改善。

於國際層面,由於旅行及檢疫限制放寬,本集 團將於海外展會及貿易展恢復後繼續推廣及發 展我們的國際業務。

總括而言,本集團對建築市場以及本集團在香港及國際的業務前景維持審慎樂觀態度,並將繼續致力抓住香港、澳門及海外市場的商機。

### LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2023, the Group's total cash and cash equivalents amounted to approximately HK\$66.0 million of which approximately 67.8%, 27.6%, 2.5% and 2.1% of the cash and cash equivalents were denominated in Hong Kong dollar, Renminbi, United States dollar and Euro respectively (31 March 2022: approximately HK\$64.6 million of which approximately 66.2%, 29.6%, 3.2% and 1.0% of the cash and cash equivalents were denominated in Hong Kong dollar, Renminbi, United States dollar and Euro respectively).

As at 31 March 2023, the Group had bank borrowings of approximately HK\$13.2 million (31 March 2022: nil) with variable interest rate, which were repayable within one year and were guaranteed by the Company. As at 31 March 2023, the Group's other borrowing of approximately HK\$15.0 million (31 March 2022: approximately HK\$20.0 million) had fixed interest rate of 1.0% (31 March 2022: 1.0%) per annum and was repayable within one year, which was unsecured. As at 31 March 2023, the Group's bank borrowings were denominated in Hong Kong dollar and United States dollar. As at 31 March 2023 and 31 March 2022, other borrowing was denominated in Hong Kong dollar.

The gearing ratio of the Group as at 31 March 2023 (defined as the Group's total interest-bearing liabilities divided by the Group's total equity) was approximately 22.4% (31 March 2022: 17.7%). The increase in gearing ratio is mainly due to the increase in bank borrowings during the Year.

### **CAPITAL STRUCTURE**

As at 31 March 2023, the Company's issued share capital was HK\$38,000,000 and the number of its issued ordinary shares was 380,000,000 of HK\$0.1 each.

During the Year, there was no change to the authorised and issued share capital of the Company.

### CASH FLOW MANAGEMENT AND LIQUIDITY RISK

The Group's objective regarding cash flow management is to maintain a balance between continuity of funding and flexibility through a combination of internal resources, bank borrowings, and other debt or equity securities, as appropriate. The Group is comfortable with the present financial and liquidity position, and will continue to maintain a reasonable liquidity buffer to ensure sufficient funds are available to meet liquidity requirements at all times.

### **FOREIGN EXCHANGE RISK**

Our Group's operations are mainly in Hong Kong and the People's Republic of China (the "PRC"), and most of the operating transactions, revenue, expenses, monetary assets and liabilities are denominated in Hong Kong dollars and Renminbi. As such, the Directors are of the view that the Group's risk in foreign exchange is insignificant and that we should have sufficient resources to meet foreign exchange requirements as and if it arises. The Group has not engaged in any derivative to hedge its exposure to foreign exchange risk.

#### **USE OF PROCEEDS FROM THE PUBLIC OFFER**

The net proceeds from the public offer received by the Company, after deduction of the underwriting commissions and other related listing expenses payable by the Company in the public offer, were approximately HK\$88.3 million.

As disclosed in the Company's announcement dated 22 June 2022, the Board has resolved to re-allocate the unutilised net proceeds of approximately HK\$8.0 million to provide funding for our working capital and other general corporate purposes (the "Change in UOP").

# **COMPLIANCE OF THE CODE**

The Company focuses on maintaining a high standard of corporate governance for purposes of enhancing the value for its shareholders and protecting their interests. The Company has established the corporate governance structure in accordance with the Listing Rules and the Corporate Governance Code (the "Code") provided in Appendix 14 to the Listing Rules and has set up a series of corporate governance measures. The Company has adopted and complied with such provisions of the Code (the "Code Provision(s)") as stated in the Code during the Year except for the Code Provision of C.2.1.

In accordance with Code Provision C.2.1, the roles of chairman and chief executive should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing. The Company currently does not have any officer with the title of chairman or chief executive. The functions of chairman and chief executive officer were performed by the Executive Directors and the general manager respectively. Notwithstanding the aforementioned, the Board will review the current structure from time to time and as and when appropriate if candidate with suitable leadership, knowledge, skills and experience is identified, the Company may make the necessary modification to the management structure.

The Board will examine and review, from time to time, the Company's corporate governance practices and operations in order to meet the relevant provisions under the Listing Rules and to protect the shareholders' interests.

# MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") as its code of conduct for regulating securities transactions by Directors. Following a specific enquiry to all Directors by the Company, all Directors have confirmed that they have complied with the required standard set out in the Model Code throughout the Year.

There are no financial, business, family or other material relationships among members of the Board.

During the Year, the Company has at least three Independent Non-executive Directors (representing at least one-third of the Board), in compliance with the requirements of Rules 3.10(1) and (2) and 3.10A of the Listing Rules and among whom, at least one Independent Non-executive Director possess professional qualifications or accounting knowledge or professional knowledge related to finance management. The Board believes there is sufficient independence element in the Board to safeguard the interest of Shareholders.

#### Confirmation of independence

After taking into consideration of the factors regarding the evaluation of the independence of the Independent Non-executive Directors pursuant to Rule 3.13 of the Listing Rules, and the annual written confirmation of independence given by each of the Independent Non-executive Directors, the Board believes that all Independent Non-executive Directors shall be independent individuals.

#### Independence mechanisms

The Company has put in place mechanisms to ensure independent views and input are available to the Board. All the Directors, including the Independent Non-executive Directors, have the right to express their views to the Board and separately and independently access to the management of the Group to make informed decisions. The Directors are entitled to seek advice from the company secretary of the Company or, upon reasonable request, seek independent professional advice at the Company's expenses to assist the Directors to discharge their duties to the Company. All Independence Non-executive Directors attended all the meetings of the Board and its relevant committees held during the Year. The Board has reviewed and considered that the mechanisms are effective in ensuring that independent views and input are provided to the Board during the Year.

#### **Directors' Responsibilities**

The Board has an ultimate oversight of the Group's activities. Its primary functions are to set and direct the Company's strategy and to monitor and measure the management's performance. The Board is accountable for the overall strategic development of the Group with the objective to enhance shareholder value. Material matters are reserved for the Board's considerations or decisions which include, among other things, overall strategy of the Group, business plans, annual budgets, significant capital expenditure, interim and annual results and reports, dividend policy and payments, material acquisitions, disposals or investment proposals, directors' appointments, re-appointments or removal, and other material transactions.

The Board has delegated certain of its responsibilities to the Audit and Compliance Committee, the Remuneration Committee and the Nomination Committee. It has also delegated the day-to-day operations of the Group's business to the senior management.

#### **Delegation to Management**

The senior management is responsible for the specific implementation of the resolutions of the Board and of the daily business management and operations of the Group, which includes formulating (i) the Company's operating plan and investment proposal, (ii) the plan of establishing the internal management authority, (iii) the basic management system of the Company and (iv) the Company's specific regulations. The Executive Directors and senior executives meet regularly to review the performance of the businesses of the Group as a whole, co-ordinate overall resources and make financial and operational decisions. The Board also gives clear directions as to their powers of management including circumstances where management should report back, and will review the delegation arrangements on a periodic basis to ensure that they remain appropriate to the needs of the Group.

The Board is provided with adequate, timely and reliable information about the Group's business and developments before each Board meeting at which the Directors actively participate and hold informed discussions. A notice of regular board meeting shall be given to all directors at least 14 days before the meeting is convened pursuant to the requirements of the Code, and such notice shall state the date, time and venue of the meeting to be convened and the format to be adopted of such meeting. Other interim Board meetings have reasonable notices be delivered to all Directors.

The quorum for a Board meeting shall be the presence of two Directors. The Directors may participate in any meeting of the Board either in person or through electronic means of communications, for the purpose of counting a quorum, such participation shall constitute presence at a meeting as if those participating were present in person. The secretary of the Company's Board is responsible for preparing and safekeeping the minutes of the Board meetings and ensuring that the Directors can enquire about such minutes.

## **Appointment, Re-election and Removal of Directors**

In accordance with relevant laws, regulations, the Articles of Association and the certain rules and regulations, we have formed three board committees, namely the Audit and Compliance Committee, the Remuneration Committee and the Nomination Committee.

#### **Audit and Compliance Committee**

The Company has established the Audit and Compliance Committee with written terms of reference in accordance with Rule 3.21 of the Listing Rules and the Code. The Audit and Compliance Committee consists of three Independent Non-executive Directors, namely Mr. Yiu To Wa (being the chairman of the Audit and Compliance Committee), Mr. Lau Leong Yuen and Ms. Lam Hoi Yu Nicki. Mr. Yiu To Wa possesses the appropriate professional and accounting qualifications.

The principal duties of the Audit and Compliance Committee include, among other things, (i) recommending to the Board on the appointment, re-appointment and removal of the Company's external auditor and on its remuneration; (ii) reviewing the Company's interim and annual financial statements and other financial reports; and (iii) reviewing the Company's financial reporting system, internal control procedures (including monitoring the effectiveness of the internal audit function) and risk management system.

During the Year, the Audit and Compliance Committee held three meetings with the independent auditors and the senior management of the Company to consider the independence and audit scope of independent auditor, and to review and discuss the risk management and internal control systems of the Group, the effectiveness of the Company's internal audit and risk control function, consolidated interim and annual financial statements of the Group and the opinion and report of independent auditor before reporting and submitting to the Board for their approval.

The Remuneration Committee consists of three Independent Non-executive Directors, namely Ms. Lam Hoi Yu Nicki (being the chairman of the Remuneration Committee), Mr. Lau Leong Yuen and Mr. Yiu To Wa.

The principal responsibilities of the Remuneration Committee are to establish and review the policy and structure of the remuneration for the Directors and senior management, to establish the performance evaluation standard, procedures and system, to annually evaluate the performance of the Directors and senior management, to make corresponding recommendations to the Board, and to perform other duties and responsibilities as assigned by the Board.

The emoluments of the Executive Directors are determined based on the skills, knowledge, individual performance as well as contributions, the scope of responsibility and accountability of such Directors, taking into consideration the Company's performance and prevailing market conditions. The remuneration policy of the Independent Non-executive Directors is to ensure that they are adequately compensated for their efforts and time dedicated to the Company's affairs including their participation in respective Board committees. The emoluments of Independent Non-executive Directors are determined with reference to their skills, experience, knowledge, duties and market trends. The remuneration of Directors and senior management is reviewed at least annually.

During the Year, the Remuneration Committee held one meeting to review the remuneration structure of the Directors and senior management and made recommendation to the Board for approval.

Pursuant to code provision E.1.5 of the Code, details of the remuneration payable to members of senior management by band for the Year are set out in Note 11 to the consolidated financial statements.

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

Selection of candidates will be based on a range of diversity perspectives including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

The Nomination Committee is responsible for ensuring the diversity of the Board members and compliance with relevant codes governing board diversity under the Listing Rules. The Nomination Committee and the Board will monitor the implementation of the Board Diversity Policy and review the Board Diversity Policy and the Board composition under diversified perspectives annually to ensure its continued effectiveness. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

When making the appointment and re-appointment of Directors in the future, the Nomination Committee will nominate new Directors pursuant to the requirements of the Board Diversity Policy to achieve the objective of diversity in Board members.

#### **Gender diversity**

The Company has also taken steps to promote gender diversity at all levels of the Company, including but not limited to the Board and the management levels. During the Year and currently, 2 out of the 5 Directors are female. The Board will use its best endeavour to maintain the gender diversity at the Board and at mid to senior level of the Group.

Gender ratio in the workforce is set out in the Environmental, Social and Governance ("ESG") Report of the Company to be published at the same time as this annual report is published on the websites of the Stock Exchange and the Company respectively. The Group make its best endeavour to encourage gender diversity since recruitment and selection process and across its workplace.

- The candidate should be of good character, integrity and competent to act as director of the Company;
- The candidate should possess qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Group's business and corporate strategy;
- The candidate should be able to devote sufficient time to discharge duties as a Board member and other directorships and significant commitments:
- The candidates should be considered on merit, against objective criteria and with due regard to the diversity perspectives set out in the Board Diversity Policy of the Company; and
- The candidates for independent non-executive directorship should meet the "independence" criteria as required under the Listing Rules and the composition of the Board is in conformity with the provisions of the Listing Rules.

The Nomination Committee may also consider such other factors as it may deem are in the best interests of the Company and the Shareholders as a whole.

The Board and the senior management are accountable for the overall responsibility in respect of monitoring the implementation of internal control and risk management procedures and other measures in the Group. The Company's risk management and internal control system aims at managing but not eliminating the risk of not being able to achieve the business objectives. Moreover, only reasonable but not absolute warranties can be given for statements which are not materially untrue or will not result in material losses.

The Board has conducted an annual review of the effectiveness of the Company's risk management and internal control systems through discussion with the Audit and Compliance Committee. The Board believed that the Company's risk management and internal control systems are effective and sufficient, and is satisfied that the Group has fully complied with the Code in respect of internal controls during the Year.

We have appointed external professional advisors (including the auditor or other advisors) for provision of professional advice in respect of how we observe applicable laws and regulations.

The Board has reviewed the need for an internal audit function and is of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost effective to appoint external independent professionals to perform internal audit function for the Group in order to meet its needs.

董事會已檢討內部審計職能之需要,且認為基於本集團業務之規模、性質及複雜程度,為符合其需要,委任外部獨立專業人士為本集團執行內部審計職能更具成本效益。

During the Year, the Group appointed BT Corporate Governance Limited (originally known as Baker Tilly Hong Kong Risk Assurance Limited and subsequently known as Corporate Governance Professionals Limited) ("BTCGL") to:

- assist in identifying and assessing the risks of the Group, including ESG-related risks, through a series of discussions and interviews;
   and
- independently perform internal control review and assess the effectiveness of the Group's risk management and internal control systems.

The results of the independent review and assessment were reported to the Audit and Compliance Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by BTCGL to enhance the risk management and internal control systems, and risk mitigating measures of the Group were adopted by the Board. Based on the findings and recommendations of BTCGL, as well as the comments from the Audit and Compliance Committee, the Board considered the internal control and risk management systems are effective and adequate.

#### **Enterprise Risk Management Framework**

The Group has established its enterprise risk management framework. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing internal control systems to manage all kinds of risks faced by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritised and treated. The Group's risk management framework follows the COSO Enterprise Risk Management — Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit and Compliance Committee that oversees risk management and internal audit functions.

#### **Compliance Risk**

This is the risk of exposure to legal penalties and/or financial loss due to the fact that the Group fails to comply with the relevant laws and regulations as well as internal policies. This also includes reputation risk.

#### **Financial Risk**

The financial risk, which covers credit risk, liquidity risk, exchange rate risk and interest rate risk, etc, is associated with the financial impacts of the transactions.

#### **Operational Risk**

The operational risk results from inadequate or failed internal processes, and inadequate, inefficient or ineffective people and system. This includes fraud risk, vendor outage and/or processing errors, etc.

#### **Strategic Risk**

The current and prospective adverse impact on earnings and/or capital arises from adverse business development decisions, improper strategic decision-making process, and/or lack of responsiveness to industry changes, etc.

#### **Risk Control Mechanism**

The Group adopts a "three lines of defence model" corporate governance structure with operational management and controls performed by operations management, coupled with risk management monitoring carried out by the finance team and independent internal audit function outsourced to and conducted by BTCGL. The Group has adopted risk management policy and procedures (the "Risk Management Policy") and maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit and Compliance Committee, and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk owners have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient and timely manner.

The Group's risk management activities are performed by management on an ongoing basis. The effectiveness of the Group's risk management framework is evaluated at least annually, and periodic management meeting is held to update the progress of risk monitoring efforts. Management is committed to ensure that risk management forms part of the daily business operation processes in order to align risk management with corporate goals in an effective manner.

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management annually to further enhance the Group's internal control and risk management systems as appropriate.

The responsibilities of Baker Tilly Hong Kong Limited as to the consolidated financial statements are set out on pages 60 to 62 of this annual report.

Non-audit services provided to the Group during the Year of approximately HK\$0.2 million for review of interim results and approximately HK\$0.1 million for other non-audit services.

### Convening an extraordinary general meeting

In accordance with the provisions of the Articles of Association of the Company, the Shareholders shall be entitled to the following right: Any one or more Shareholder(s) holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

As regards proposing a person for election as a Director by the Shareholders, please refer to the procedures available on the website of the Company.

#### **Putting forward proposals at general meetings**

There is no provision in the Articles of Association setting out procedures for the Shareholders to put forward new resolutions at general meetings. Shareholders who wish to put forward a new resolution may request the Company to convene a general meeting in accordance with the procedures set out in the preceding paragraph heading "Convening an extraordinary general meeting".

#### Shareholders are entitled to the inquiry right

# NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

# 綜合財務報表附註

## 1 GENERAL INFORMATION

Yuk Wing Group Holdings Limited (the "Company") was incorporated and registered as an exempted company with limited liability in the Cayman Islands under the Companies Law Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The shares of the Company are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The registered office address of the Company is located at Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business of the Company is located at Unit B, 13/F, Eton Building, 288 Des Voeux Road Central, Hong Kong. The directors of the Company consider that the Company's immediate and ultimate holding company is Colour Shine Investments Limited, a private limited company incorporated in the British Virgin Islands (the "BVI").

The Company is an investment holding company. The Company and its subsidiaries (collectively referred to as the "**Group**") are principally engaged in the manufacturing and trading of down-thehole ("**DTH**") rockdrilling tools and trading of piling and drilling machineries and rockdrilling equipment.

The consolidated financial statements are presented in Hong Kong Dollars ("**HK\$**") which is also the functional currency of the Company.

HKAS 1 is amended to replace all instances of the term "significant accounting policies" with "material accounting policy information". Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

HKFRS Practice Statement 2 Making Materiality Judgements (the "**Practice Statement**") is also amended to illustrate how an entity applies the "four-step materiality process" to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. The amendments define accounting estimates as "monetary amounts in financial statements that are subject to measurement uncertainty". An accounting policy may require items in financial statements to be measured in a way that involves measurement uncertainty — that is, the accounting policy may require such items to be measured at monetary amounts that cannot be observed directly and must instead be estimated. In such a case, an entity develops an accounting estimate to achieve the objective set out by the accounting policy. Developing accounting estimates involves the use of judgements or assumptions based on the latest available, reliable information.

In addition, the concept of changes in accounting estimates in HKAS 8 is retained with additional clarifications.

#### 3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange (the "Listing Rules") and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are accounted for in accordance with HKFRS 16 "Leases" ("HKFRS 16"), and measurements that have some similarities to fair value but are not fair value. such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets".

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs are to be used to measure fair value in subsequent periods, and valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date:
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

#### Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

#### Rendering of services

Service income of piling and drilling machineries and equipment is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation, as the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs. The Group bills a fixed amount for each month of service provided. The Group elected to apply the practical expedient by recognising revenue in the amount to which the Group has right to invoice. As permitted under HKFRS 15 "Revenue from Contracts with Customers" ("HKFRS 15"), the transaction price allocated to these unsatisfied contracts is not disclosed. The service income is not derived from the Group's ordinary course of business and is presented as other income.

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

Non-lease components are separated from lease component and are accounted for by applying other applicable standards.

#### **Short-term leases**

The Group applies the short-term lease recognition exemption to leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. Lease payments on short-term leases are recognised as expense on a straight-line basis over the lease term.

The recoverable amounts of property, plant and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporates assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

Cash and cash equivalents presented on the consolidated statement of financial position include:

- (a) cash, which comprises of cash on hand and bank balances, excluding bank balances that are subject to regulatory restrictions that result in such balances no longer meeting the definition of cash; and
- (b) cash equivalents, which comprises of short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts which are repayable on demand and form an integral part of the Group's cash management. Such overdrafts are presented as short-term borrowings in the consolidated statement of financial position.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Cost necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

#### Deposits placed at an insurance company

Deposits placed at an insurance company is stated in the consolidated statement of financial position at cost adjusted for interest income and service charges, less impairment losses, if any.

Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets including trade receivables, other receivables, deposits and bank balances which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

Significant increase in credit risk
In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if (i) it has a low risk of default, (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of 'investment grade' as per globally understood definitions.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

#### (iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.

The Group writes off a financial asset, when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Lifetime ECL for certain trade receivables are considered on a collective basis taking into consideration past due information and relevant credit information such as forward looking macroeconomic information.

Financial liabilities and equity

#### Classification as debt or equity

Debt and equity instruments are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### **Equity instruments**

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

#### Financial liabilities at amortised cost

Financial liabilities including trade and other payables and bank and other borrowings are subsequently measured at amortised cost, using the effective interest method.

#### Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other income".

#### Retirement benefit costs

Payments to Mandatory Provident Fund Scheme ("MPF Scheme") and state-managed retirement benefit schemes are recognised as an expense when employees have rendered service entitling them to the contributions.

All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. Any changes in the liabilities' carrying amounts resulting from service cost, interest and remeasurements are recognised in profit or loss except to the extent that another HKFRS requires or permits their inclusion in the cost of an asset.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case, the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

#### **Taxation**

Taxation credit (charge) represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before tax because of income or expenses that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxation entity by the same taxable authority.

Current and deferred tax are recognised in profit or loss.

In the application of the Group's accounting policies, which are described in Note 3, the directors of the Company are required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and the future periods if the revision affects both current and future periods.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets within the next financial year.

#### Impairment assessment of trade receivables

The Group calculates ECL for the trade receivables individually or collectively. Except for significant balances or credit-impaired amounts which are assessed for impairment individually, the remaining trade receivables are grouped under a collective assessment after considering internal credit ratings of trade debtors, ageing, repayment history and/or past due status of respective trade receivables. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for supportable forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in Note 30 and Note 18 respectively.

As at 31 March 2023, the carrying amount of trade receivables is HK\$47,999,000 (2022: HK\$39,596,000), net of impairment loss of HK\$6,146,000 (2022: HK\$3,237,000).

#### **Estimated write down of inventories**

The management assesses whether the inventories are stated at the lower of cost and net realisable values and estimates the allowance for inventories based on their industry knowledge and experience at the end of the reporting period. The management estimates the amount of allowance for inventories based on the lower of cost and their estimated net realisable value. In determining the net realisable values of the Group's inventories, the management considers the current market conditions, material price fluctuation and subsequent usage or sales. When the actual net realisable values are lower than expectation, such difference will impact the carrying amounts of inventories. During the year ended 31 March 2023, the Group recognises a reversal of write down of inventories of HK\$360,000 (2022: a reversal of write down of inventories of HK\$441,000). As at 31 March 2023, the carrying amount of inventories is HK\$56,471,000 (2022: HK\$55,740,000).

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to the shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of net debt, which includes bank and other borrowings and lease liabilities disclosed in Notes 23 and 24 respectively, net of cash and cash equivalents and equity attributable to owners of the Company, comprising share capital and reserves.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost and the risks associates with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt.

Interest rate risk

The Group is exposed to fair value interest rate risk in relation to fixed-rate other borrowings and lease liabilities as disclosed in Notes 23 and 24. The management continuously monitors interest rate exposure.

The Group's cash flow interest rate risk relates primarily to variablerate bank balances and bank borrowings as disclosed in Notes 20 and 23 due to the fluctuation of the prevailing market interest rate. The Group currently does not have a policy on hedging interest rate risk. However, the management monitors interest rate exposure and will consider hedging significant interest rate risk should the need arise.

#### Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate bank borrowings. The analysis is prepared assuming the amount of liability outstanding at each reporting period end was outstanding for the whole year. A 100 basis point increase or decrease is used which represents management's assessment of the reasonably possible change in interest rates. If interest rates had been 100 basis points higher/lower and all other variables were held constant, the Group's profit after tax for the year ended 31 March 2023 would decrease/increase by HK110,000 (2022: nil).

Bank balances are excluded from sensitivity analysis as the directors of the Company consider that the exposure of cash flow interest rate risk arising from variable-rate bank balances is insignificant.

Credit risk and impairment assessment

Credit risk refers to the risk that the Group's counterparties default on their contractual obligations resulting in financial losses to the Group. The Group's credit risk exposures are primarily attributable to trade receivables, other receivables, deposits and bank balances. The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

Trade receivables arising from contracts with customers

Before accepting any new customers, the Group assesses the potential customer's credit quality and defines credit limits by customer. Credit limits granted to customers are reviewed periodically. In order to minimise the credit risk, the management has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group calculates ECL for the trade receivables individually or collectively. Except for significant balances or credit-impaired amounts which are assessed for impairment individually, the remaining trade receivables are grouped under a collective assessment after considering internal credit ratings of trade debtors, ageing, repayment history and/or past due status of respective trade receivables. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for supportable forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forwardlooking information are considered. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group has concentration of credit risk as 22% (2022: 11%) of the total gross trade receivables was due from the Group's largest customer as at 31 March 2023 and 49% (2022: 46%) of the total gross trade receivables was due from the five largest customers as at 31 March 2023.

The directors of the Company make periodic individual assessment on the recoverability of other receivables and deposits based on historical settlement records, past experience, and also quantitative and qualitative information that is reasonable and supportable forward-looking information. The directors of the Company believe that there are no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. For both years ended 31 March 2022 and 2023, the Group assessed the ECL for other receivables and deposits to be insignificant and thus no loss allowance was recognised.

#### Bank balances

Credit risk on bank balances is limited because the counterparties are reputable banks with high credit ratings assigned by international credit agencies. The Group assessed 12m ECL for bank balances by reference to information relating to probability of default and loss given default of the respective credit rating grades published by external credit rating agencies. Based on the average loss rates, the 12m ECL on bank balances is considered to be insignificant.

#### 32 RETIREMENT BENEFIT PLAN

The Group participates in a defined contribution scheme which is registered under the MPF Scheme established under the Mandatory Provident Fund Scheme Ordinance. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. For members of the MPF Scheme, the Group contributes at the lower of HK\$1,500 per month or 5% of relevant payroll costs each month to the MPF Scheme, in which the contribution is matched by the employee. There is no forfeited contributions utilised by the Group during the year.

The employees of the Group's subsidiary in the PRC are members of a state-managed retirement benefit plan operated by the government of the PRC. The subsidiary is required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefit plan is to make the specified contributions.

The total expenses recognised in profit or loss of HK\$1,628,000 for the year ended 31 March 2023 (2022: HK\$1,579,000) represent contributions paid and payable to these plans by the Group at rates specified in the rules of the plans.

### 32 退休福利計劃

本集團參與根據強制性公積金計劃條例設立的強積金計劃註冊的定額供款計劃。該計劃的資產與本集團資產分開處理,由信託人管理的基金持有。強積金計劃成員方面,本集團每月按1,500港元或相關薪酬成本的5%(以較低者為準)向強積金計劃供款,而僱員亦須作出等額供款。本集團於本年度並無動用被沒收的供款。

本集團的中國附屬公司僱員均為中國政府營辦的國家管理退休福利計劃的成員。該附屬公司須按薪酬成本的特定百分比向退休福利計劃供款,以資助有關福利。本集團就該退休福利計劃承擔的責任僅為作出指定供款。

截至二零二三年三月三十一日止年度於 損益確認的總開支1,628,000港元(二零 二二年:1,579,000港元)指本集團按計 劃規則所規定的比率已付及應付予該等 計劃的供款。
