All directors of the Company attended the AGM in person or by means of electronic communication except Mr. Zhu Linan, Mr. Zhao John Huan, Mr. Yang Chih-Yuan Jerry and Ms. Yang Lan, who were not able to attend the AGM due to other business commitment.

Notes:

- As at the date of the AGM, a total of 12,128,130,291 shares of the Company were in issue and the holders of which were entitled to attend and vote at the AGM.
- There were no restrictions on any shareholders to cast votes on any of the proposed resolutions at the AGM.
- There was no share of the Company entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no shareholder of the Company was required to abstain from voting at the AGM under the Listing Rules.
- No parties have stated their intention in the circular to the shareholders dated June 27, 2023 containing the notice of the AGM to vote against or abstain from voting on any of the resolutions at the AGM.
- Tricor Abacus Limited, the Company’s share registrar, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
