	(iii) To re-elect Mr. Rui Jinsong as an executive Director; and		
	(iv) To authorize the board of Directors (the “Board”) to fix the Directors’ remuneration.		
4.	To appoint the Auditors and to authorize the Board to fix the remuneration of the Auditors.		
5.	To grant a general mandate to the Directors to allot, issue and deal with the Shares in accordance with ordinary resolution number 5 as set out in the notice of the AGM.		
6.	To grant a general mandate to the Directors to repurchase the Shares in accordance with ordinary resolution number 6 as set out in the notice of the AGM.		
7.	Conditional upon ordinary resolutions number 5 and 6 being passed, to extend the general mandate to the Directors to allot, issue and deal with additional Shares by the number of Shares repurchased in accordance with ordinary resolution number 7 as set out in the notice of the AGM.

A holder entitled to attend and vote at the AGM is entitled to appoint one or more proxies to attend and vote on his/her behalf. **ANY ALTERATION MADE TO THIS PROXY FORM MUST BE INITIALED BY THE PERSON WHO SIGNS IT.** The proxy needs not be a member of the Company, but must attend the AGM (or any adjournment thereof) to represent you.

- This proxy form must be signed and dated by the shareholder or his/her attorney duly authorized in writing. In the case of joint shareholders, any one shareholder may sign this proxy form. The vote of the senior joint shareholder who tenders a vote, whether personally or by proxy, will be accepted to the exclusion of the votes of the other joint shareholder(s), and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company in respect of the joint shareholding.

- In order to be valid, a proxy form and the power of attorney or other authority (if any) under which it is signed, or a certified copy of such power of attorney, must be deposited at the Hong Kong branch share registrar of the Company, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong, not less than 48 hours before the time appointed for holding the AGM or any adjournment thereof.
- Completion and return of this proxy form will not preclude you from attending and voting at the AGM via the Online Platform if you so wish.

- For the avoidance of doubt, we do not accept any special instructions written on this proxy form.
