# CHAIRLADY'S STATEMENT

## 主席報告書

Dear Shareholders,

On behalf of the Board of Directors (the "Board"), I am pleased to present the annual report of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 March 2023.

FY2023 presented a challenging operating environment, with the retail market being severely impacted by the fifth wave of COVID-19 in early 2022. External factors affecting the international supply chain, ongoing inflationary pressure, and the uncertainty in the global economic environment further contributed to the uncertainty of the future economy. Although the COVID-19 pandemic began to be contained during the year and the government's implementation of a series of economic stimulus measures led to the gradual improvement in market and consumer sentiment, the business environment remained challenging.

In the difficult business environment of the past few years, we have constantly reviewed our operation and made adjustments accordingly. I am pleased to see that the Group's business in Hong Kong has maintained good momentum. In FY2023, the Group's revenue increased to a record high of HK\$463.1 million. All treatment centres and skincare retail stores saw significant growth in customer numbers and revenue. The core brand CosMax+ continued to hold a leading position in the high-end medical aesthetic industry. The revenue and profit potential of the VITAE treatment centres has gradually become apparent. The high-end skincare brand XOVĒ also adjusted its sales network. It is hoped that the three brands will continue to provide momentum for the Group in 2024, enabling the Group's business to capitalise on another wave of rapid growth as the economy back to the right track.

致各股東：

本人謹代表董事會（「董事會」）欣然提呈本公司及其附屬公司（以下統稱「本集團」）截至2023年3月31日的周年報告。

2023財政年度的經營環境仍然困難重重。2022年初受第五波新冠疫情影響，零售市場備受打擊。外圍因素對國際供應鏈造成的影響、通脹壓力持續以及全球經濟環境不明朗等因素增加了未來經濟的不確定性。雖然新冠疫情於年內開始得到遏制，政府亦實施一連串的刺激經濟方案，令市場氣氛和消費情緒逐步改善，但經營環境仍然充滿挑戰。

在過去數年困難的營商環境下，我們不斷調整和審視自身。喜見本集團於香港本地業務保持良好勢頭。2023財政年度，本集團錄得歷史新高的收入四億六千三百一十萬港元。各療程中心和護膚品零售網點，在服務人次和收入上均有顯著增長。核心品牌CosMax+一如既往地佔據了高端醫美產業的領先地位，VITAE的療程中心在收入和利潤的潛力也逐步體現，高端護膚品品牌XOVĒ亦調整了網點佈局。期望三個品牌於2024年繼續為集團提供動力，使集團的業務能把握經濟重回正軌所帶來的另一波高速增長。

In addition to local business growth, the Group is actively equipping itself and planning for the future. In FY2023, our high-end skincare brand XOVĒ officially launched in the Mainland China stores of Sephora, an internationally renowned beauty retail group and a brand under the French LVMH group. It has more than 1,000 stores worldwide, including over 360 stores in Mainland China, it offers a outstanding platform for the Group and XOVĒ to increase brand awareness. XOVĒ's sales from Sephora for the first three months were encouraging, and it ranked among the best-selling beauty brands of Sephora in Mainland China, representing a significant step forward for the development of the brand and the Group. The Group's entry into the Mainland China market during the year led to an increase in marketing expenses and other expenses, and thus a net loss of approximately HK\$20.5 million (last year: net profit approximately HK\$25.4 million) was recorded. However, as the business in Mainland China is in the seeding period, it is expected to bring a positive contribution and effect to the Group's revenue and profit when economies of scale are gained in the future.

In FY2024, we will continue to invest in R&D and introduce new projects to enhance and enrich the overall customer experience, in addition to providing quality services and products based on professionalism and safety. The Group will continue to explore potential business opportunities while deeply cultivating the local market in Hong Kong and actively developing the Mainland market in order to accelerate the Group's overall business development. In terms of corporate governance, we will continue to optimise the Group's operations and management in order to maintain a competitive advantage in the dynamic environment, increase the Group's revenue and profit, and create better value and return for shareholders.

On behalf of the Board, I would like to thank our shareholders, business partners, suppliers and customers for their support. My heartfelt appreciation also goes to our management and team for their dedication and contributions over the past year.

除了本地業務增長外，本集團亦積極裝備自身和為未來佈局。於2023財政年度，我們的高端護膚品品牌XOVĒ於中國內地正式進駐國際知名美妝零售集團絲芙蘭。絲芙蘭是法國路威酩軒(LVMH)旗下品牌，在全球擁有超過1,000家門店，單在中國內地已擁有超過360家門店，為本集團和XOVĒ提高品牌知名度提供了絕佳的舞台。XOVĒ於絲芙蘭的首三個月的銷售數據令人鼓舞，在絲芙蘭中國內地美妝品牌銷售中名列前茅，為品牌和集團在中國內地的發展邁出了重要的一步。雖然年內集團因進軍中國內地市場，導致市場營銷費用和其他費用有所增加，而錄得淨虧損約為二千零五十萬港元(去年：淨利潤約二千五百四十萬港元)。但由於中國內地業務正處於播種期，預期未來進入規模效應收穫期後，將對本集團收入和盈利帶來正面的貢獻和影響。

在2024財政年度，我們除了貫徹以專業和安全為本，提供優質的服務和產品外，將繼續投資研發和引入新項目，以提升和豐富整體客戶體驗。在深耕香港本地市場、積極開發內地市場時繼續探求潛在商機，以加速集團整體業務發展。在企業管治上，我們將持續優化集團的營運和管理，務求在瞬息萬變的環境下保持競爭優勢，提升集團收入和利潤、為股東創造更佳的價值和回報。

# MANAGEMENT DISCUSSION AND ANALYSIS

### Business Review

The business environment in Hong Kong remained difficult in the year ended 31 March 2023 (the “Year Under Review”). The market was dealt a significant blow by the fifth wave of COVID-19 in early 2022, which severely impacted the retail market. This was further compounded by external factors affecting the global supply chain, rising inflationary pressures, and an unclear global economic environment, all of which added to the uncertainty about the future economy. Despite the introduction of a series of economic stimulus measures by the government, which gradually improved market and consumer sentiment following the containment of the COVID-19 pandemic during the Year Under Review, the operating environment remained challenging.

Nevertheless, leveraging on our reputation and solid foundation established over the years, the Group was able to maintain strong growth momentum in its main business segments. It has been preparing for society’s full return to normalcy while actively deploying for its long-term business growth. In order to better meet future development, the Group has given full play to its competitive advantages, explored new business areas and expanded into new markets, all of which have helped in maintaining its market leading position.

During the Year Under Review, the Group’s revenue increased by approximately HK\$99.2 million, or 27.3%, to HK\$463.1 million compared with the year ended 31 March 2022 (the “Previous Year”). The number of closure days that the Group’s medical aesthetic centres also decreased significantly (Year Under Review: 20 days; Previous Year: 84 days) as a result of the containment of the pandemic and the government’s economic stimulus measures. The treatment centres and skincare retail outlets recorded notable growth in footfall and revenue, showing consumers’ recognition of the Group’s brand and the quality of its services and products. This also bodes well for another wave of rapid growth for the Group, supported by strong market demand in the wake of the pandemic.

### 業務回顧

回顧2023年3月31日止年度(「回顧年度」)，香港的經營環境仍然困難重重。香港於2022年初受第五波新冠疫情影響，零售市場備受打擊。國際供應鏈受外圍因素影響、通脹壓力不斷升溫，以及全球經濟環境不明朗等，均增加了未來經濟的不確定性。儘管新冠疫情於回顧年度開始得到遏制，政府亦實施一連串的刺激經濟方案，逐步改善市場氣氛和消費者情緒，但經營環境仍然充滿挑戰。

幸而本集團受惠於多年來建立起的良好商譽和堅實的基礎，於主要業務範疇仍保持良好增長勢頭。本集團同時為社會全面復常做好準備和為長遠業務增長積極佈局。為更切合未來發展所需，本集團在發揮現有競爭優勢的同時，開拓新業務領域和進軍新市場以保持市場領先地位。

本集團回顧年度的收益較截至2022年3月31日止年度(「去年」)增加約九千九百二十萬港元或27.3%至四億六千三百一十萬港元。除受惠於新冠疫情得到遏制和政府的刺激經濟方案外，回顧年度內集團醫美中心暫停營業的天數也大幅減少(回顧年度：20天；去年：84天)。各療程中心和護膚品零售網點在服務人次和收入上均有顯著增長，可見消費者對本集團品牌以及服務和產品質素的認可，這亦可預視本集團於新冠疫情後市場龐大的需求的支持下，將迎來下一波高速增長。

During Year Under Review, the Group's premium skincare brand XOVĒ officially marched into Sephora, an internationally renowned beauty products retail group, in Mainland China, which has provided an excellent platform for the Group and XOVĒ to increase brand awareness. Due to its entry into the Mainland China market, the Group incurred higher marketing costs and other expenses and resulted a net loss of approximately HK\$20.5 million (Previous Year: net profit of HK\$25.4 million) during the year. The business in Mainland China is currently in the seeding period and is expected to reach harvesting period and achieve stronger economies of scale in the future which is forecasted to positively contribute and impact the Group's revenue and profit.

The Group operates three CosMax+ medical aesthetic centres in prime and strategic locations, enabling it to attract and build a diverse customer base. All devices and treatments have been clinically evaluated by doctors before adoption to ensure the provision of safe and high-quality customised treatment services. In addition, drawing on its solid foundation built over the years, CosMax+ has established a leading position in the high-end medical aesthetics market.

The Group also operates three VITAE treatment centres in prime locations. The brand emphasises the need to maintain an optimal balance between beauty and health, so that customers have beauty that emanates from within. By adhering to the above service philosophy for a year, VITAE has already built a steadily expanding customer base. After the COVID-19 pandemic was brought under control, both footfall and revenue of the VITAE centres have increased substantially. As public awareness of health and beauty increases, the Group believes that "healthy beauty" will become a new trend in the market and VITAE will further contribute to the Group's overall customer base, revenue and profitability.

### 業務回顧(續)

於回顧年度，本集團的高端護膚品品牌XOVĒ於中國內地正式進駐國際知名美妝零售集團絲芙蘭，為本集團和XOVĒ提高品牌知名度提供了絕佳的舞台。由於進軍中國內地市場，本集團市場營銷費用和其他開支有所增加，導致錄得淨虧損約為二千零五十萬港元(去年：淨利潤約二千五百四十萬港元)。但由於中國內地業務正處於播種期，預期未來進入規模效應收穫期後，將對本集團收入和盈利帶來正面的貢獻和影響。

本集團三間CosMax+醫學美容中心，均位處一線且具策略性的地段，有助吸引和建立多元化客戶群。其所有設備及療程服務均經醫生臨床評估後方予以採用，確保為客戶提供安全、優質的定制療程服務。建基於多年來堅實的基礎，CosMax+於高端醫美產業佔據了領先地位。

美容品牌VITAE於黃金地段經營三間療程中心。以「維持美容與健康的完美平衡及煥發由內而外的美麗光採」為服務概念，經過一年的營運，已建立了持續穩定增長的客戶群。受惠於新冠疫情受遏制，服務人次和收入均有顯著增長。預期隨著大眾對健康和美的意識不斷提高，「健康的美」將成為市場新趨勢，VITAE將為本集團總體客戶群、收益和盈利等進一步帶來貢獻。

XOVĒ is a premium skincare product brand developed by a team of Swiss skincare experts. At the end of the Year Under Review, the Group had 10 retail stores in first-tier shopping malls in Hong Kong and promoted and sold its products online through various platforms in Mainland China and Hong Kong. During Year Under Review, XOVĒ officially landed Sephora, an internationally renowned beauty product retail group, in Mainland China. With more than 360 stores across Mainland China, Sephora has provided an excellent platform for the Group and XOVĒ to raise brand awareness. The Group also plans to launch new product lines during the year to further enlarge its market share and attract more potential customers.

In order to enhance the image of the brands and secure new customers, the Group launched a number of advertising and promotional activities during the Year Under Review.

In April 2022, CosMax+ expanded its Central branch and relocated to New World Tower. The new centre is more spacious and has a stronger artistic atmosphere, creating a superior and more comfortable treatment experience for customers. In the same year, CosMax+ collaborated with international fashion magazine VOGUE to interview socialites and entrepreneurs, who shared their insights on beauty based on the theme “Authentic Beauty”. The campaign has helped CosMax+ strengthen its “exquisite beauty” brand image among consumers. The brand also introduced new medical aesthetic equipment and products, including Sofwave™, to provide more diversified treatment services.

Observing the growing market demand for facial contouring treatments, medical aesthetic brand VITAE upgraded its “FaceGym™” treatment in November 2022 and once again invited international celebrity Fala Chen to take part in a series of promotional videos, which received positive feedback from the market. Both CosMax+ and VITAE received the “Quality Service Recognition” from the Hong Kong Retail Management Association (HKRMA) this year, recognising the brands’ achievements in providing consumers with quality medical aesthetic services.

### 業務回顧(續)

XOVĒ是由瑞士專業科研團隊研發的優質護膚產品系列。回顧年度末，其於香港的一線購物商場共開設十個零售網點，並透過中國內地及香港的多個網上平台於網上推廣和銷售。同時，於回顧年度，XOVĒ於中國內地正式進駐國際知名美妝零售集團絲芙蘭。絲芙蘭於中國內地擁有超過360家門店，為本集團和XOVĒ提高品牌知名度提供了絕佳的舞台。為進一步擴大市場佔比，本集團計劃於年內推出新的產品系列以吸納更多潛在客戶。

為進一步提升品牌的形象和吸納新客戶，本集團於回顧年度內展開了多項廣告及推廣活動。

CosMax+於2022年4月將中環分店擴張並遷至新世界大廈，新店裝潢不僅更具空間感，亦滿載藝術氣息，為客人締造更優越、舒適的療程體驗。同年，CosMax+與國際時尚雜誌VOGUE攜手以Authentic Beauty為主題，廣邀城中名媛及企業家進行訪談，分享對美的詮釋，強化消費者心目中精緻唯美的品牌形象。與此同時，品牌亦致力引入嶄新醫美儀器及產品，當中包括Sofwave™，用以提升更多元化的療程服務。

另一方面，VITAE輕醫美品牌因應市場對面部輪廓療程的需求日益殷切，品牌於2022年11月昇華「FaceGym™」療程，並再度邀請國際級名人陳法拉女士拍攝一系列宣傳短片，廣獲好評。CosMax+和VITAE亦於本年度榮獲由香港零售管理協會「優質服務認證」，肯定品牌為消費者提供優質醫學美容服務體驗的成果。

As for XOVĒ, the brand has increased the number of sales outlets to ten. To complement the upgrade of the official website, XOVĒ has optimised the interface and operation process to improve the user experience and further deepen its omni-channel advantage. Meanwhile, as a way to raise brand awareness and strengthen relationships with customers, XOVĒ held a two-day “White Truffle Five Senses Journey” event at Rosewood Hong Kong in November 2022. The event garnered widespread attention, inviting more than 100 socialites, celebrities and loyal customers, and was widely covered by the media. In addition, XOVĒ engaged celebrities and internet celebrities, including Kary Ng, Cecilia Choi and Cecilia Yeung, to promote the benefits of XOVĒ products and raise brand recognition. The brand also participated in the “Pink Revolution” campaign organised by the Cancer Fund for the second year in a row, demonstrating its commitment to corporate social responsibility and deepening its positive brand image.

In addition to capitalising on the rapid growth momentum of the medical aesthetic industry in the past few years, the Group has also actively made long-term deployments for its future business development. Its entry into the Mainland China market during the Year Under Review represented one of the major strategic milestones for the Group, and the advertising and promotional activities have had a positive impact on the Group’s sales. It is expected that the brands will bring more financial and non-financial contributions to the Group, especially when the Mainland business enters the harvest period and gains economies of scale, thereby supporting the Group’s overall performance.

XOVĒ持續擴充銷售點至十間，配合官方網頁更新項目，優化介面及操作流程，提升用戶體驗，以取得全方位市場營銷(Omni-channel)的優勢。XOVĒ亦繼續提升品牌知名度及鞏固客戶關係。其於2022年11月假香港瑰麗酒店舉行一連兩日的XOVĒ「白松露五感體驗活動」，場面盛大，邀得過百城中名媛、明星及忠實顧客參與，亦獲傳媒廣泛報道。此外，XOVĒ與不同明星及網絡紅人如吳雨霏、蔡思韻、楊文蔚等合作，以推廣XOVĒ產品功效及提升品牌認受性。XOVĒ亦連續兩年參加「癌症基金會粉紅革命」活動，履行企業社會責任，深化品牌正面形象。

本集團過去數年除成功把握醫學美容產業的高速增長態勢外，亦積極按未來發展作出長遠的業務佈局，回顧年度內進軍中國內地市場是本集團具重要策略性的里程碑之一，各項廣告及推廣活動亦將對本集團銷售帶來正面影響，預期各品牌特別是中國內地業務進入規模效應收穫期後，將為本集團帶來更多財務和非財務的正面貢獻，支持本集團的整體表現。

### Financial Review

#### Revenue

Our revenue is mainly derived from the provision of medical aesthetic services, which include treatment services, prescription and dispensing of medical products. In addition, we sell skincare products to our clients.

Our Group's revenue amounted to approximately HK\$463.1 million for the Year Under Review, representing an increase of approximately HK\$99.2 million or 27.3% as compared with HK\$363.9 million for the Previous Year. During the Year Under Review, our Group opened 1 new treatment centre and 6 retail stores for the sale of skincare products. The effective implementation of our sales and marketing activities increased the public awareness for our brands, revenue from both treatment services and sale of skincare products increased significantly as compared to Previous Year.

### 財務回顧

#### 收益

我們的收益主要來自提供醫學美容服務，包括療程服務、醫療產品處方及配藥。此外，我們向客戶出售護膚產品。

於回顧年度，本集團的收益約為四億六千三百一十萬港元，較去年的三億六千三百九十萬港元增加約九千九百二十萬港元或27.3%。於回顧年度，本集團開設一間新的療程中心及六間銷售護膚產品的零售店。實施有效的銷售及市場推廣活動已提高我們品牌的公眾知名度，來自療程服務及銷售護膚產品的收益均較去年大幅增加。

#### Revenue (Continued)

##### (i) Revenue from treatment services

Revenue from treatment services amounted to approximately HK\$333.2 million for the Year Under Review and approximately HK\$289.1 million for the Previous Year, representing 72.0% and 79.4% of our total revenue, respectively. The increase of approximately HK\$44.1 million or 15.3% was primarily due to (1) introduction of new treatment services; (2) steady growth of customer base of VITAE; (3) the implementation of effective sales and marketing activities which increase the public awareness of the brands and (4) decrease in number of closure days of the Group's medical aesthetic centres during the Year Under Review (Year Under Review: 20 days; Previous Year: 84 days).

##### (ii) Revenue from sale of skincare products

Skincare products represents series of products include cleanser, toner, serum, moisturiser, eye care products, ultraviolet (UV) protection products and masks, etc., which backed up by a team of Swiss skincare experts.

Revenue from sale of skincare products amounted to approximately HK\$129.6 million for the Year Under Review and approximately HK\$74.3 million for the Previous Year, representing 28.0% and 20.5% of our total revenue, respectively. The increase of approximately HK\$55.3 million, or 74.4%, was primarily due to (1) well acceptance of our existing & new products; (2) loyalty of customers built over the years; and (3) increase in brand awareness and sales in Mainland China.

##### (iii) Revenue from prescription and dispensing of medical products

Based on clients' skin conditions, their specific needs and requirements, our doctors may prescribe medication and/or recommend certain skincare products which are dispensed at our medical aesthetic centres.

Revenue from prescription and dispensing of medical products amounted to approximately HK\$0.3 million for the Year Under Review and approximately HK\$0.5 million for the Previous Year, representing 0.0% and 0.1% of our total revenue, respectively.

##### (i) 來自療程服務的收益

於回顧年度及去年，來自療程服務的收益分別約為三億三千三百二十萬港元及約二億八千九百一十萬港元，分別佔總收益的72.0%及79.4%。增幅約為四千四百一十萬港元或15.3%，主要由於(1)引入新療程服務；(2) VITAE客戶群穩步增長；(3)有效實施銷售及市場推廣從而提高品牌的公眾知名度；及(4)本集團醫美中心於回顧年度內關閉的日數減少(回顧年度：20天；去年：84天)。

##### (ii) 來自銷售護膚產品的收益

護膚產品指由瑞士專業科研團隊主理的面部清潔用品、爽膚水、精華液、保濕液、眼部護理產品、紫外線(UV)防護產品及面膜等產品系列。

於回顧年度及去年，來自銷售護膚產品的收益分別約為一億二千九百六十萬港元及約七千四百三十萬港元，分別佔我們總收益的28.0%及20.5%。增幅約為五千五百三十萬港元或74.4%，主要由於(1)我們現有及新產品獲顧客青睞；(2)過去建立了的客戶忠誠度；及(3)在中國內地的品牌知名度及銷售額均有所提升。

##### (iii) 來自醫療產品處方及配藥的收益

根據客戶的皮膚狀況、特定需要及要求，我們的醫生可能會開出藥物處方及／或推薦在我們醫學美容中心配發的若干護膚產品。

於回顧年度及去年，來自醫療產品處方及配藥的收益約為三十萬港元及約五十萬港元，分別佔我們總收益的0.0%及0.1%。

#### Other income and gain, net

Other income and gain, net amounted to approximately HK\$9.4 million for the Year Under Review and HK\$1.3 million for the Previous Year. The increase of approximately HK\$8.1 million or 623.1% was primarily due to approximately HK\$6.7 million government subsidies received in relation to Employment Support Scheme and other subsidy scheme under the Anti-epidemic Fund during the Year Under Review, whereas there was approximately HK\$0.6 million government subsidies received in Previous Year.

#### Cost of inventories and consumables

Cost of inventories and consumables amounted to approximately HK\$47.4 million for the Year Under Review and HK\$29.0 million for the Previous Year. The increase of approximately HK\$18.4 million or 63.4% was primarily due to increase in revenue during the Year Under Review.

#### Staff costs

Staff costs increased by approximately HK\$52.2 million, or 41.7%, from approximately HK\$125.3 million for the Previous Year to approximately HK\$177.5 million for the Year Under Review. The increase in staff costs during the Year Under Review was mainly attributable to the increase in number of staff due to 6 retail stores for the sale of skincare products opened during the Year Under Review and commission paid to doctors and front-line staff whose incentive scheme tied to various key performance indicators such as number of treatment conducted and number of package sold.

#### Property rentals and related expenses

Property rentals and related expenses and depreciation of right-of-use assets increased by approximately HK\$21.4 million, or 44.0%, from approximately HK\$48.6 million for the Previous Year to HK\$70.0 million for the Year Under Review. The increase was primarily due to full year impact for the 2 new treatment centres opened in Previous Year and 6 retail stores for the sale of skincare products opened during the Year Under Review.

#### Depreciation of property, plant and equipment

Depreciation in relation to property, plant and equipment increased by approximately HK\$19.6 million, or 79.0%, from approximately HK\$24.8 million for the Previous Year to approximately HK\$44.4 million for the Year Under Review.

#### 其他收入及收益淨額

於回顧年度及去年，其他收入及收益淨額分別約為九百四十萬港元及一百三十萬港元。升幅約為八百一十萬港元或623.1%，主要由於回顧年度收取有關「保就業」計劃及防疫抗疫基金下的其他資助計劃的政府資助約六百七十萬港元，而去年則收取政府資助約六十萬港元。

#### 存貨及消耗品成本

於回顧年度及去年，存貨及消耗品成本分別約為四千七百四十萬港元及二千九百萬港元。增加約一千八百四十萬港元或63.4%，主要由於回顧年度的收益增加。

#### 員工成本

員工成本由去年約一億二千五百三十萬港元增加約五千二百二十萬港元或41.7%至回顧年度約一億七千七百五十萬港元。回顧年度的員工成本增加，主要由於在回顧年度開設六間銷售護膚產品的零售店，導致員工人數上升以及向醫生及前線員工支付的佣金增加，其激勵計劃與進行的療程數目及售出療程數目等不同主要表現指標掛鉤。

#### 物業租金及相關開支

物業租金及相關開支以及使用權資產折舊由去年約四千八百六十萬港元增加約二千一百四十萬港元或44.0%至回顧年度的七千萬港元。有關增加主要由於去年開設兩間新的療程中心及於回顧年度開設六間銷售護膚產品的零售店的全年影響。

#### 物業、廠房及設備折舊

物業、廠房及設備折舊由去年約二千四百八十萬港元增加約一千九百六十萬港元或79.0%至回顧年度約四千四百四十萬港元。

Other expenses, net increased by approximately HK\$50.3 million from approximately HK\$103.2 million for the Previous Year to approximately HK\$153.5 million for the Year Under Review. The increase was primarily attributable to (1) increase in operation scale; and (2) higher advertising and promotion expenses for the launch of new promotions and active promotional campaigns mounted on various social media platforms to increase the public awareness of the brands.

#### Finance costs

Finance costs increased by approximately HK\$0.7 million from approximately HK\$3.0 million for the Previous Year to approximately HK\$3.7 million for Year Under Review.

#### Income tax

Income tax expense amounted to approximately HK\$5.8 million for the Previous Year and income tax credit of approximately HK\$3.4 million for the Year Under Review. The tax credit was primarily attributable to deferred tax during the Year Under Review.

#### Loss for the year

Loss attributable to the owners of the Company was approximately HK\$20.5 million for the Year Under Review.

The Board does not recommend or declare the payment of any dividend for the Year Under Review (2022: Nil).

### Liquidity and Financial Resources

#### Financial Resources

We continue to maintain a stable financial position with cash and cash equivalents HK\$116.9 million as at 31 March 2023 (2022: HK\$65.7 million). Our working capital, excluding those lease liabilities relating to properties leased for own use, was HK\$31.2 million (2022: HK\$35.1 million). With our steady cash inflow from operations, coupled with sufficient cash and bank balances, we have adequate liquidity and financial resources to meet the working capital requirements as well as to fund its expansion plans in the next financial year.

As at 31 March 2023, most of our cash and bank balances were denominated in Hong Kong Dollar, United State Dollar and Renminbi.

### Indebtedness

#### Interest-bearing Bank Borrowings

As at 31 March 2023, our Group had approximately HK\$19.2 million outstanding interest-bearing bank borrowings (2022: Nil).

#### Contingent Liabilities and Guarantees

As at 31 March 2023, our Group had no significant contingent liabilities and guarantees (2022: Nil).

#### Charge of Assets

As at 31 March 2023, there was no charge on the assets of our Group except for the time deposits of approximately HK\$62.4 million (2022: approximately HK\$62.5 million) pledged for banking facilities as security for credit card services programmes.

#### Gearing Ratio

The gearing ratio of the Group, calculated as total borrowings divided by total share capital and reserves, was approximately 12.7% as at 31 March 2023 (2022: Nil).

#### Foreign Currency Risk

Our Group carries out its business mainly in Hong Kong and most of its transactions are denominated in Hong Kong Dollar. Our Group did not experience any material impact or difficulties in liquidity on its operations resulting from the fluctuation in exchange rate, and no hedging transaction or forward contract arrangement was made by the Group during the years ended 31 March 2023 and 2022. The Group will closely monitor related risk in the future.

#### Interest Rate Risk

Our Group has no significant interest rate risk. Our Group currently does not have any specific policies in place to manage interest rate risk and has not entered into any interest rate swap transactions to mitigate interest rate risk, but will closely monitor related risk in the future.

#### Significant Investments, Material Acquisitions and Disposals of Subsidiaries, Associates and Joint Ventures, and Future Plans for Material Investments or Capital Assets

Save as disclosed in this report, there were no significant investments held by the Company during the year ended 31 March 2023, nor were there any material acquisitions or disposals of subsidiaries, associates and joint ventures during the reporting period. Save as disclosed in this report, there is no plan authorised by the Board for other material investments or additions of capital assets as at the date of this report.

#### Employees and Remuneration Policies

As at 31 March 2023, the Group has a total of 334 employees (2022: 366). Staff costs, including Directors' remuneration, of our Group were approximately HK\$177.5 million for the year ended 31 March 2023 (2022: approximately HK\$125.3 million). Remuneration is determined with reference to various factors such as comparable market salaries and work performance, time commitment and responsibilities of each individual. Employees are provided with relevant in-house and/or external training from time to time. In addition to a basic salary, year-end bonuses are offered to employees who performed outstandingly to attract and retain eligible employees to contribute to our Group.

#### 外匯風險

### Prospects

The business environment in Hong Kong remained challenging during the Year Under Review. Nevertheless, the Group did not slow down its pace of development amid the uncertain economic environment. Instead, it actively formulated deployment plans and invested resources to capture the anticipated surge in demand for medical aesthetic services and products following the pandemic. During the Year Under Review, the Group launched a number of advertising and promotional activities, including the expansion and relocation of the CosMax+ Central branch to enhance customer experience with a brand-new environment and facilities. In addition, socialites and entrepreneurs were invited to share their insights on “Authentic Beauty”; VITAE also worked with international celebrity Fala Chen again for advertising and promotion. With the omni-channel advantage, XOVĒ launched several product promotion campaigns with celebrities and influencers, and organised large-scale customer events to enhance brand awareness and customer loyalty. The aforementioned advertising and promotional activities further enhanced the image of the three brands and attracted new customers.

As the core brand of the Group, in addition to enhancing its brand image and continuing to introduce new treatment services in the past year, CosMax+ is also actively considering the expansion of its existing operation scale in order to serve more customers and provide them with a more spacious and more comfortable environment, thus optimising and enriching the customer experience.

Since launch, VITAE has established a steadily growing customer base. In the future, it will continue to uphold the concept of “maintaining a perfect balance between beauty and health, and emanating beauty from within”, and serve more customers who value “healthy beauty”.

During Year Under Review, XOVĒ was officially staged in Sephora, a world-renowned beauty retail group, in Mainland China. Sephora has more than 360 stores in Mainland China, offering an excellent platform for the Group and XOVĒ to increase brand awareness. In order to expand and improve the coverage of its products, the Group plans to launch new product series during the year to attract more potential customers.

### 前景

雖然回顧年度內香港的經營環境仍然充滿挑戰，但本集團在相對不明確的經濟環境下並沒有放慢步伐，反之更積極佈局和投入資源，為新冠疫情得到遏制後所預期對醫美服務及產品的需求作好準備。於回顧年度內，本集團展開了多項廣告及推廣活動，其中包括CosMax+擴遷中環分店，以嶄新的環境設備強化客戶體驗，並邀請城中名媛及企業家分享對Authentic Beauty的探索心得；VITAE亦再度與國際級藝人陳法拉女士合作廣告宣傳，XOVĒ繼續取得全方位市場營銷(Omni-channel)的優勢，推出多個與明星及網絡紅人的產品推廣項目，並舉行大型顧客活動，以提升品牌知名度及客人忠誠度。以上多項廣告及推廣活動有助進一步提升三個品牌的形象和吸納新客戶。

作為本集團的核心品牌，CosMax+在過去一年除了提升品牌形象和持續引入新療程服務外，亦正積極考慮擴充現有營業面積，旨在服務更多客戶並提供更寬敞和舒適的空間，進一步優化和豐富客戶的體驗。

自VITAE推出以來，已建立了持續穩定增長的客戶群。未來將繼續秉持「維持美容與健康的完美平衡及煥發由內而外的美麗光採」的理念，服務更多注重「健康的美」的客戶。

XOVĒ於回顧年度，於中國內地正式進駐國際知名美妝零售集團絲芙蘭。絲芙蘭於中國內地擁有超過360家門店，為本集團和「XOVĒ」提高品牌知名度提供了絕佳的舞台。為擴大並完善其產品的覆蓋面，本集團計劃於年內推出新的產品系列，以吸納更多潛在客戶。

Although marketing expenses and other expenses increased during the year due to the development of the Mainland market, the Group's financial position remained healthy, with a significant increase in revenue from the Previous Year and ample cash to support future development.

With the containment of the COVID-19 pandemic and the government's economic stimulus measures, consumer confidence has continued to improve, and the number of tourists visiting Hong Kong has gradually increased. The Group is optimistic about the local market and future economic recovery. In addition to the investments made last year to prepare for the post-COVID rebound, the team has worked hard to expand into new markets and mapped out the Group's future development. Some plans are already beginning to bear fruit. Among them, the sales of XOVĒ products in Sephora, for the first three months in Mainland China were encouraging, and it ranked among Sephora's best-selling beauty brands in Mainland China, marking a significant step forward for the brand and the Group's growth in the country.

From 2023 to 2024, the Group will strive to build on the foundation it has established over the years and consolidate the development of the past year for long-term, steady growth. Leveraging its good reputation and loyal customer base, coupled with the strategic long-term business layout, the Group is confident that it can continue to utilise its advantages in the future, maintain its leading position in the market, further increase its revenue and profit contribution, and create returns for shareholders and long-term value for stakeholders.

### 前景(續)

雖然年內因進軍中國內地市場，導致市場營銷費用和其他費用有所增加，但本集團的財務狀況依然穩健，收益較去年有顯著增長、現金充裕，可支持未來的持續發展。

隨著新冠疫情得到遏制，加上政府一連串的刺激經濟方案，消費者信心持續改善，訪港旅客人數亦逐步上升，本集團對香港本地市場和未來經濟復甦抱有樂觀態度。去年除了加強投入為疫後的反彈作好準備外，亦在團隊的共同努力下開拓新的市場，為本集團未來發展積極佈局，部分計劃已初見成效。其中「XOVĒ」於中國內地正式落戶絲芙蘭產品的首三個月，銷售令人鼓舞，在絲芙蘭中國內地美妝品牌銷售中名列前茅，為品牌和本集團在中國內地的發展邁出了重要的一步。

在2023至2024年度，本集團將在過去多年的基礎上致力鞏固過去一年的發展，務求達致長遠和穩步的增長。憑藉良好的商譽和忠實的客戶群，加上具策略性的長遠業務佈局，本集團有信心能於未來繼續發揮優勢，保持市場領先地位，並進一步提升收入和利潤貢獻，為股東創造回報，為持份者創造長期價值。

### Executive Director

**Ms. LAI Ka Yee Gigi (黎珈而)** (with former name Lai Chi, Gigi (黎姿)), aged 51, is an executive Director, chairlady of the Board and chief executive officer. She is also the chairlady of the nomination committee and a member of the remuneration committee. She is responsible for the overall management, branding and strategic planning, marketing and development of the Group. Ms. LAI Ka Yee Gigi (“Mrs. Gigi Ma”) joined the Group in July 2009 and was appointed as a Director on 6 July 2016, re-designated as an executive Director and appointed as chairlady of the Board and the chief executive officer on 19 December 2016. She is also a director of certain subsidiaries of the Group.

Before founding the Group, Mrs. Gigi Ma was active in the film and television entertainment industry between 1985 and 2008. She withdrew from the film and television entertainment industry in late 2008 and has since devoted her full effort to the development of the business in the medical aesthetic service industry.

**Mr. HO, Tsz Leung Lincoln (何子亮)**, aged 47, joined the Group in July 2019 as the chief brand officer in which he has been responsible for formulating and leading the Group’s brand strategies, as well as overseeing the Group’s marketing and sales operations. Mr. Ho was appointed as an executive Director on 22 April 2020 and promoted to Chief Operation Officer effective at May 2020. Prior to joining the Group, Mr. Ho worked in the role of art/creative director in a number of advertising firms, namely DDB Worldwide, Leo Burnett etc., whose clients included a world renowned international fast-food corporation, personal skin care corporations, an automobile corporation and a major transport corporation in Hong Kong. He has also contributed in the film industry that earned him a nomination in The 24th Hong Kong Film Awards in 2005.

### 執行董事

**黎珈而女士**(前名黎姿), 51歲, 為執行董事、董事會主席兼行政總裁。彼亦為提名委員會主席及薪酬委員會成員。彼負責本集團的整體管理、品牌及策略計劃、市場推廣及發展。黎珈而女士(「馬黎珈而女士」)於2009年7月加入本集團, 於2016年7月6日獲委任為董事, 並於2016年12月19日調任為執行董事並獲委任為董事會主席兼行政總裁。彼亦是本集團若干附屬公司的董事。

創立本集團之前, 馬黎珈而女士於1985年至2008年活躍於電影及電視演藝界。彼於2008年末退出電影及電視演藝工作, 自此全力在醫學美容服務行業發展業務。

### Corporate Governance Code

The Group recognises the importance of achieving the highest standard of corporate governance consistent with the needs and requirements of its businesses and the best interest of all of its stakeholders, and the Board is fully committed to doing so. The Board believes that high standards of corporate governance provide a framework and solid foundation for the Group to manage business risks, enhance transparency, achieve high standard of accountability and protect stakeholders' interests.

The Company has adopted the principles and the code provisions set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 of Listing Rules. During the year ended 31 March 2023, the Company had complied with all the applicable code provisions of the CG Code, except the deviation stipulated below.

According to the code provision C.2.1 of the CG Code, the roles of the chairman and chief executive should be separate and should not be performed by the same individual. Under the current management structure of the Company, Ms. LAI Ka Yee Gigi ("Mrs. Gigi Ma") is the chairlady of the Board (the "Chairlady") and chief executive officer of the Company (the "Chief Executive Officer"). As Mrs. Gigi Ma has been leading the Group as the Group's Chief Executive Officer and sole director of each of major subsidiaries since the establishment of the relevant major subsidiaries, the Board believes that it is in the best interest of the Group to continue to have Mrs. Gigi Ma acting as the Chairlady and Chief Executive Officer for more effective management and planning of the Group. Therefore, the Board considers that the deviation from provision C.2.1 of the CG Code is acceptable and appropriate in the circumstances and currently does not propose to separate the functions of chairman and the chief executive officer.

### Purpose, Values, Strategy and Culture

The core purpose of the Company is to create value for its shareholders. It strives to become a well renowned enterprise in the provision of medical aesthetic services and sale of skin care products and aims to be the powerhouse of Women's Love Brands that uplift women to be the best vision of themselves with our comprehensive range of customized medical aesthetics treatment services, skincare & cosmetic products, and health supplements. Its mission is to lead the development of the industry and set the industry benchmarks. In this connection, it endeavours to maintain accountability to its employees, consumers, shareholders, the society, and the environment. These purposes and values shape the Company's strategy, which are geared towards building a trusted and beloved enterprise whereby values for shareholders are created.

### Mechanism on Independent Views to the Board

The Company recognises that board independence is critical to good corporate governance. The Board has established a mechanism to enable Directors to seek independent professional advice when exercising Directors' duties to ensure a strong independent element to the decision made by the Board which is key to an effective Board.

According to the mechanism, subject to the prior approval by the executive Director of the Company (which approval shall not be unreasonably withheld or delayed), the Directors may seek independent legal, financial or other professional advice from advisors independent of those advising the Company as and when necessary in appropriate circumstances to enable them to discharge their responsibilities effectively, either on the Company's affairs or in respect of their fiduciary or other duties, at the Company's expense. In case of the Board is seeking independent professional advice, prior approval must be given by the executive Director of the Company (which approval shall not be unreasonably withheld or delayed).

The Board will review this mechanism on an annual basis to ensure the implementation and effectiveness of this mechanism.

### Chairlady and Chief Executive Officer

Mrs. Gigi Ma is the Chairlady and Chief Executive Officer. As Mrs. Gigi Ma has been leading the Group as the Group's Chief Executive Officer and sole director of each of major subsidiaries since the establishment of the relevant major subsidiaries, the Board believes that it is in the best interest of the Group to continue to have Mrs. Gigi Ma acting as the Chairlady and Chief Executive Officer for more effective management and planning of the Group. Therefore, the Board considers that the deviation from code provision C.2.1 of the CG Code is acceptable and appropriate in the circumstances and currently does not propose to separate the functions of chairman and the chief executive officer.

Mrs. Gigi Ma is the Chairlady and Chief Executive Officer who is responsible for overall management, branding and strategic, planning, marketing and development of our Group. She also is a member of remuneration committee and chairing the Nomination Committee.

### Roles and Responsibility of the Board

The Board is responsible for the overall management of the Group, which includes controlling resources allocation of the Company and leading the Company to strive for success. It oversees the Group's businesses, strategic decisions, internal control, risk management and performances. The management team is delegated with the authority and responsibility by the Board for the daily management of the Group. The delegated functions and work tasks are periodically reviewed. Major corporate matters that are specifically delegated by the Board to the management include (1) the preparation of interim and annual reports and announcements for the Board's approval before publishing; (2) implementation of adequate systems of internal controls and risk management procedures; and (3) compliance with relevant statutory and regulatory requirements and rules and regulations. It is the responsibility of the Board to determine the appropriate corporate governance practices applicable to the Company's circumstances and to ensure processes and procedures are in place to achieve the Company's corporate governance objectives.

### Board/Board Committee Meetings

The Board meets regularly to discuss the overall strategy as well as the operation and financial performance of the Company, and to review and approve the Company's interim and annual results. Four regular board meetings were held during the year ended 31 March 2023 and the attendance of each Director at the Board meetings is set out on page 31 of this report. At the Board meeting held on 26 June 2023, the Board has approved, among other matters, the audited consolidated financial statements of the Company and its subsidiaries for the year ended 31 March 2023.

Regular Board meetings for each year are scheduled in advance to facilitate maximum attendance of Directors. All Directors are given an opportunity to include matters for discussion in the agenda. The Company Secretary assists the Chairlady in preparing the agenda for meetings to comply with all applicable rules and regulations. The agenda and the accompanying Board papers are normally sent to Directors at least three days before the intended date of a Board meeting. Draft minutes of each Board meeting are circulated to Directors for their comment before signature of the chairperson. The minutes are kept by the Company Secretary and are open for inspection at any reasonable time on reasonable notice by any Director.

### Appointment, Re-election, Rotation and Removal of Directors

In accordance with the Articles of Association, the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an addition to the existing Board. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of Members after his appointment and be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election.

At each annual general meeting of the Company, not less than one-third of the Directors shall retire from office by rotation provided that each Director shall be subject to retirement by rotation at the annual general meeting at least once every three years.

### Audit Committee

An audit committee has been established by the Board with specific written terms of reference following the Rules 3.21 to 3.23 of the Listing Rules and the CG Code. The audit committee of the Company (the "Audit Committee") is authorised to commit Company funds in order to obtain advice from outside legal counsel, accountants, investigatory services or other expert advice. Details of the authority and responsibilities of the Audit Committee are available on the websites of the Company and the Stock Exchange.

The Audit Committee comprises three INEDs, namely Mr. Cheng Fu Kwok David, Mr. Cheng Yuk Wo and Mr. Li Wai Kwan and Mr. Cheng Yuk Wo is the chairman of the Audit Committee.

The Audit Committee held two meetings during the year ended 31 March 2023 and the meeting was attended by the Company's external auditor so that the members of the Audit Committee could exchange their views and concerns on the financial reporting process of the Group with the auditor.

During the Year Under Review, the Audit Committee had reviewed with the management and the external auditor the accounting principles and practices adopted by the Group and discussed auditing, internal controls, and financial reporting matters including the following:

- the review of the audited financial statements for the year ended 31 March 2022;
- the review of the interim results for the six months ended 30 September 2022;
- the recommendation to the Board for the proposal for re-appointment of the external auditor of the Company and approval of the remuneration and terms of engagement of the external auditor; and
- the review of the risk management and internal control systems of the Company and its subsidiaries.

### Remuneration Committee

A remuneration committee has been established by the Board (the “Remuneration Committee”) with specific written terms of reference following the Rules 3.25 to Rules 3.26 of the Listing Rules and the CG Code and the majority of the members of the Remuneration Committee are INEDs and responsible to make recommendations to the Board on the remuneration packages of individual executive directors and senior management. Details of the authority and responsibilities of the Remuneration Committee are available on the websites of the Company and the Stock Exchange.

The Remuneration Committee comprises one executive Director, namely Mrs. Gigi Ma and two INEDs, namely Mr. Cheng Yuk Wo and Mr. Li Wai Kwan. Mr. Cheng Yuk Wo is the chairman of the Remuneration Committee.

The Remuneration Committee held one meeting during the year ended 31 March 2023 with the presence of all committee members. During the year, the Remuneration Committee made recommendations to the Board regarding the remuneration packages and performance bonuses for the Directors and senior management of the Company and assessed performance of executive Directors.

The Group’s businesses are under the direct responsibility of the above executive Directors who are the senior management of the Company. Details of the amount of Directors’ emoluments for the year ended 31 March 2023 are set out in note 8 to the financial statements.

### Remuneration Policy for Directors

The Company has a remuneration policy for directors. Each of the directors will receive a fee which is subject to an annual adjustment at a rate to be reviewed by the remuneration committee and be determined at the discretion of the Board. The remuneration of the directors is determined, inter alia, by reference to the relevant director’s experience, responsibilities, workload and time devoted to the Group.

本集團之業務由上列執行董事（即本公司的高級管理人員）直接負責。截至2023年3月31日止年度之董事薪酬金額詳情載於財務報表附註8。

### Nomination Committee

A Nomination Committee has been established by the Board with specific terms of reference following the CG Code. The Nomination Committee is responsible for, amongst other things, identifying individuals suitably qualified to become Board members, considering the reappointment of the Directors and succession planning for Directors and making recommendations to the Board in respect of the aforesaid matters. Details of the authority and responsibilities of the Nomination Committee are available on the websites of the Company and the Stock Exchange.

The Nomination Committee comprises one executive Director, namely Mrs. Gigi Ma and two INEDs, namely Mr. Cheng Fu Kwok David and Mr. Cheng Yuk Wo. Mrs. Gigi Ma is the chairlady of the Nomination Committee.

The Nomination Committee held one meeting during the year ended 31 March 2023 with the presence of all committee members. During the year ended 31 March 2022, the Nomination Committee reviewed the structure, size and composition of the Board and board diversity policy, discussed matters regarding the retirement and re-election of Directors and succession planning for directors and assessment of the independence of INEDs. The Nomination Committee concluded that members of the Board have possessed the expertise and independence to carry out the Board's functions and responsibilities.

The Board has also adopted a nomination policy (the "Nomination Policy") which sets out the selection criteria and procedure of appointing and re-appointing a Director. The selection criteria used in assessing the suitability of a candidate include, inter alia, such candidate's academic background and professional qualifications, relevant experience in the industry, character and integrity etc.

於截至2023年3月31日止年度，提名委員會已舉行一次會議，所有委員會成員均有出席。於截至2022年3月31日止年度，提名委員會已審閱董事會之架構、規模及組成及董事會成員多元化政策，討論有關董事退任及重選的事宜及董事的承替計劃及評估獨立非執行董事之獨立性。提名委員會認為董事會成員具備專業知識及獨立性以履行董事會職能及職責。

董事會亦已採納提名政策(「提名政策」)，其載列委任及重新委任董事的甄選標準及程序。用於評估候選人是否為合適的甄選標準包括(其中包括)有關候選人的學術背景及專業資格、相關的行業經驗、品格及誠信等。

Pursuant to the Nomination Policy, the nomination committee reviews the structure, size and composition of the Board periodically and make recommendation on any proposed changes to the Board to complement the Company's corporate strategy. When it is necessary to fill a casual vacancy or appoint an additional director, the nomination committee identifies or selects candidates as recommended to the committee pursuant to the criteria set out in the Nomination Policy. Based upon the recommendation of the nomination committee, the Board deliberates and decides on the appointment. In addition, every director shall be subject to retirement by rotation or re-election at least once every three years and shall be eligible for re-election at each annual general meeting. The nomination committee shall review the overall contribution and service to the Company, expertise and professional qualifications of the retiring directors, who offered himself/herself for re-election at the annual general meeting, to determine whether such director continues to meet the criteria as set out in the Nomination Policy.

### Board Diversity Policy

The Board has adopted a board diversity policy (the "Policy") which sets out the basis to achieve diversity on the Board.

The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. All Board appointments will be based on meritocracy, and candidates will be considered against selection criteria.

For selection of candidates will be based on a range of diversity perspectives, which would include but not be limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board taking into account factors based on its own business model and specific needs from time to time and with due regard for the benefits of diversity on the Board. The Board's composition will be disclosed in the annual report of the Company. The Board will give adequate consideration to this policy when it identifies suitably qualified candidates to become members of the Board.

### 董事會成員多元化政策

本公司認同及贊同設立成員多元化的董事會以提高其表現質素的裨益。所有董事會成員的委任均以用人唯才為原則，並在考慮候選人時採用甄選標準。

甄選候選人將按一系列多元化範疇為基準，包括（但不限於）性別、年齡、文化及教育背景、專業經驗、技能、知識及服務任期。最終將按經甄選候選人的長處及可為董事會提供的貢獻而作決定，當中根據本身的業務模式及不時的特定需要考慮各種因素，並適當考慮董事會成員多元化的裨益。董事會的組成將在本公司之年報內披露。董事會將充份考慮本政策以物色具備適當資格的候選人擔任董事會成員。

As at the date of this report, the Board comprises six Directors, amongst them, three are INEDs, thereby promoting critical review and control of the management process. The Board is also characterized by significant diversity, regardless in terms of age, professional experience, skills and knowledge.

Having reviewed the Policy and the Board's composition, the Nomination Committee considered that the requirements of the Policy had been met.

The Nomination Committee will review the Policy, as appropriate, to ensure its effectiveness.

The Board comprises 5 male directors and 1 female director. As at 31 March 2023, the Company has 334 employees in total comprising of approximately 306 females and 28 males (a female-to-male ratio of 1:0.092).

The Group when hiring employees considers a number of factors, including but not limited to gender, age, cultural and education background, qualification, ethnicity, professional experience, skills, knowledge and length of service. The nomination committee of the Company will review annually gender diversity in the Group.

### Dividend Policy

Under the Companies Law of Cayman Islands and the Memorandum and Articles of Association of the Company, dividends may be paid out of the profits of the Company, or subject to solvency of the Company, out of sums standing to the credit of the share premium account of the Company. However, no dividend shall exceed the amount recommended by Directors of the Company.

於本報告日期，董事會由六名董事組成，其中三名為獨立非執行董事，因此有助於嚴格檢討及監控管理程序。董事會無論從年齡、專業經驗、技能及知識而言亦具有濃厚的多元化特色。

經審閱政策及董事會的組成後，提名委員會認為已滿足政策要求。

提名委員會將審閱政策(如適用)，以確保其成效。

董事會由5名男性董事及1名女性董事組成。於2023年3月31日，本公司總共僱用334名僱員，由約306名女性及28名男性(女性對男性比率為1:0.092)組成。

本集團於聘用僱員時考慮多項因素，包括但不限於性別、年齡、文化及教育背景、資歷、種族、專業經驗、技能、知識及服務年期。本公司提名委員會將每年檢討本集團的性別多元化。

Declaration and recommendation of payment of dividends of the Company is subject to the approval of the Directors of the Company, depending on results of operations, working capital, financial position, future prospects, and capital requirements, as well as any other factors which the Directors of the Company may consider relevant from time to time. Any future declaration, recommendation and payment of dividends of the Company may or may not reflect the historical declarations and payments of dividends and will be at the absolute discretion of the Directors of the Company. The Company does not have any predetermined dividend payout ratio.

### Accountability and Audit

The Board is responsible for overseeing the preparation of financial statements on an on-going concern basis, with supporting assumptions or qualifications as necessary, for each financial period with a view to ensure that such financial statement gives a true and fair view of the state of affairs of the Group, and of the results and cash flows for the financial year. In preparing the financial statements for the year ended 31 March 2023, the Board has selected appropriate accounting policies, applied them consistently in accordance with the Hong Kong Financial Reporting Standards which are pertinent to its operations and relevant to the financial statements, made judgements and estimates that are prudent and reasonable, and ensured the preparation of the financial statements on the going concern basis.

The Group endeavours to present a balanced, clear and comprehensive assessment of the Group's performance, position and prospects. The interim and annual results of the Company are announced in a timely manner within the limit of two months and three months, respectively, after the end of the relevant periods in accordance with the Listing Rules.

The Directors have acknowledged their responsibility for preparing all information and representation contained in the financial statements of the Company for the year ended 31 March 2023.

The responsibility of the Company's auditor, Ernst & Young, is set out in the section headed "Independent Auditor's Report".

### Risk Management and Internal Control

The Board is responsible for the risk management and internal control systems of the Company and reviewing their effectiveness. The Board oversees the overall risk management of the Group and endeavours to identify, control impact of the identified risks and facilitate implementation of coordinated mitigating measures. The risk management and internal control systems of the Company are designed to manage rather than eliminate the risk of failures to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

### 風險管理及內部監控

董事會負責本公司之風險管理及內部監控系統以及檢討其成效。董事會監督本集團整體風險管理，並致力於識別風險、監控已識別風險之影響及推動實行配合減輕風險之措施。本公司之風險管理及內部監控系統旨在管理（但非完全杜絕）未能達致業務目標之風險，亦只會就重大錯誤陳述或損失提供合理（但並非絕對）保證。

Risk Identification: Identifies risks that may potentially affect the Group's business and operations.

Risk Response: Prioritises the risks by comparing the results of the risk assessment; and determines the risk management strategies and internal control processes to prevent, avoid or mitigate the risks.

Risk Monitoring and Reporting: Performs ongoing and periodic monitoring of the risk and ensures that appropriate internal control processes are in place; revises the risk management strategies and internal control processes in case of any significant change of situation; and reports the results of risk monitoring to the management and the Board regularly.

- (b) The main features of the risk management and internal control systems are summarised as follows:

Control procedures have been designed to safeguard assets against misappropriation and disposition; ensure compliance with relevant laws, rules and regulations; ensure proper maintenance of accounting records for provision of reliable financial information used within the business or for publication; ensure that unauthorized access and use of inside information are strictly prohibited; and to provide reasonable assurance against material misstatement, loss or fraud.

The Company does not have an internal audit function and is currently of the view that there is no immediate need to set up an internal audit function within the Group in light of the size, nature and complexity of the Group's business. Nevertheless the Company engaged an external professional firm to carry out internal audit functions. It was decided that the Board would be directly responsible for internal control of the Group and for reviewing its effectiveness.

The Board has engaged an external professional firm as its risk management and internal control review adviser ("the Adviser") to conduct the annual review of the risk management and internal control systems for the year ended 31 March 2023. Such review is conducted annually and cycles reviewed are under rotation basis. The scope of review was previously determined and approved by the Board. The Adviser has reported to the Audit Committee and management for findings and areas for improvement, if any. The Board and Audit Committee are of the view that there are no material internal control defeats noted. All recommendations from the Adviser are properly followed up by the Group to ensure that they are implemented within a reasonable period of time. The Board therefore considered that the risk management and internal control systems are effective and adequate.

- (b) 風險管理及內部監控系統之主要特徵概述如下：

本集團已制定監控程序，旨在保障資產不會被挪用及處置；確保遵守有關法例、規則及規例；確保妥善保管會計記錄以提供可靠財務資料用於業務用途或公眾使用；確保嚴格禁止未授權獲取及利用內部資料；及針對重大錯誤陳述、損失或欺詐行為提供合理保證。

本公司並無內部審核職能，而鑒於本集團業務之規模、性質及複雜性，其認為現時並無必要立即於本集團內設立內部審核職能。然而，本公司已委聘一間外部專業機構進行內部審核職能。本公司決定董事會將直接負責本集團之內部監控，並檢討其成效。

董事會已委聘一間外部專業機構擔任其風險管理及內部監控檢討顧問（「顧問」）以對截至2023年3月31日止年度的風險管理及內部監控系統進行年度檢討。該項檢討每年進行並依環節輪流審核。檢討範圍早前已由董事會制訂及審批。顧問已向審核委員會及管理層匯報結果及需改進（如有）之範疇。董事會及審核委員會認為，並無發現重大內部監控缺失。本集團將適當跟進顧問的全部建議，並確保於合理時間內落實執行。因此，董事會認為，風險管理及內部監控系統有效且充足。

### Whistleblowing Policy

The Board has adopted a whistleblowing policy (the “Whistleblowing Policy”). The purpose of the Whistleblowing Policy is to (i) foster a culture of compliance, ethical behavior and good corporate governance across the Group; and (ii) promote the importance of ethical behavior and encourages the reporting of misconduct, unlawful and unethical behavior.

The nature, status and the results of the complaints received under the Whistleblowing Policy are reported to the chairman of the Audit Committee or the general manager of the risk management department of the Group. No incident of fraud or misconduct that have material effect on the Group’s financial statements or overall operations for the year ended 31 March 2023 has been discovered. The Whistleblowing Policy is reviewed annually by the Audit Committee to ensure its effectiveness.

### Anti-corruption Policy

The Board has adopted an anti-corruption policy (the “Anti-corruption Policy”). The Group is committed to achieve the highest standards of integrity and ethical behaviour in conducting business. The Anti-corruption Policy forms an integral part of the Group’s corporate governance framework. The Anti-corruption Policy sets out the specific behavioural guidelines that the Group’s personnel and business partners must follow to combat corruption. It demonstrates the Group’s commitment to the practice of ethical business conduct and the compliance of the anti-corruption laws and regulations that apply to its local and foreign operations. In line with this commitment and to ensure transparency in the Group’s practices, the Anti-corruption Policy has been prepared as a guide to all employees of the Group and third parties dealing with the Group.

The Anti-corruption Policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice.

### 舉報政策

董事會採納舉報政策（「舉報政策」）。舉報政策旨在(i)於整個本集團培養合規、合乎道德行為及良好企業管治；及(ii)宣傳道德行為的重要性及鼓勵舉報行為不當、非法及不道德行為。

根據舉報政策所接獲的投訴的性質、狀況及處理結果須向審核委員會主席或本集團風險管理部總經理匯報。截至2023年3月31日止年度，概無發現對本集團的財務報表或整體營運產生重大影響的欺詐或不當行為事件。審核委員會每年檢討舉報政策，以確保其成效。

### 反貪污政策

董事會採納反貪污政策（「反貪污政策」）。本集團致力在經營業務方面達致最高誠信及道德行為標準。反貪污政策構成本集團企業管治框架的一部分。反貪污政策載列本集團員工及業務夥伴必須遵守以打擊貪污的具體行為指引。這表明本集團對踐行合乎道德的商業行為以及遵守適用於其本地及海外業務的反貪污法律及法規的承諾。為貫徹此承諾及確保本集團常規的透明度。本集團制定反貪污政策，作為本集團所有僱員及與本集團有業務往來的第三方的行為指引。

反貪污政策會定期檢討及更新，以符合適用法律法規及行業最佳常規。

### Dissemination of Inside Information

The Company is committed to a consistent practice of timely, accurate and sufficiently detailed disclosure of material information about the Group. The Company has adopted a Policy on Disclosure of Inside Information which sets out the obligations, guidelines and procedures for handling and dissemination of inside information. With those guidelines and procedures, the Group has management controls in place to ensure that potential inside information can be promptly identified, assessed and escalated for the attention of the Board to decide about the need for disclosure.

### Company Secretary

The Company engages an external service provider to provide Company secretarial service and has appointed Mr. LO Tai On as its Company Secretary. Mr. Lo is a member of HKICPA and has over 25 years of experience in the field of company secretarial services. Mr. Lo has confirmed that for the Year Under Review, he has taken no less than 15 hours of relevant professional training. Mr. Lo is not an employee of our Group and he is responsible for advisory to the Group on corporate governance matters. Mr. Gordon Leung, our finance director, is the person who Mr. Lo can contact for the purpose of code provision C.6.1 of the Code.

### Shareholders' Right

Procedures for shareholders to convene an extraordinary general meeting and to put forward proposal at general meetings.

Pursuant to Article 58 of the articles of association of the Company, the Board may whenever it thinks fit call extraordinary general meetings. Any one or more members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

### 發佈內幕消息

本公司致力貫徹執行及時、準確及充足地詳細披露本集團之重大消息。本公司已採納內幕消息披露政策，當中載有處理及發佈內幕消息之責任、指引及程序。在該等指引及程序下，本集團已設有管理監控，確保可即時識別、評估及提交潛在內幕消息以供董事會決定是否需要作出披露。

### 公司秘書

本公司委聘一間外聘服務供應商提供公司秘書服務，並已委任羅泰安先生擔任其公司秘書。羅先生為香港會計師公會會員，於公司秘書服務領域擁有逾25年經驗。羅先生已確認，於回顧年度，彼已接受不少於15小時的相關專業培訓。羅先生並非本集團之僱員，彼負責就企業管治事宜向本集團提供顧問服務。我們的財務總監梁家傑先生為羅先生根據守則C.6.1條守則條文可聯繫的人士。

### 股東權益

股東召開股東特別大會及於股東大會上提呈議案之程序。

根據本公司組織章程細則第58條，董事會可於其認為適當的任何時候召開股東特別大會。任何一位或以上於遞呈要求當日持有不少於本公司繳足股本（具本公司股東大會之投票權）十分之一的股東於任何時候有權透過向本公司董事會或秘書發出書面要求，要求董事會召開股東特別大會，以處理有關要求中指明的任何事項；且該大會應於遞呈該要求後兩(2)個月內舉行。若於遞呈當日起二十一(21)日內，董事會未有開展召開有關大會之程序，則遞呈要求人士可自行以同樣方式召開會議，而遞呈要求人士因董事會未能召開會議而產生的所有合理開支應由本公司向遞呈要求人作出償付。

Article 85 of the articles of association of the Company provides that no person other than a Director retiring at the meeting shall, unless recommended by the Directors for election, be eligible for election as a Director at any general meeting unless a notice signed by a member (other than the person to be proposed) duly qualified to attend and vote at the meeting for which such notice is given of his intention to propose such person for election and also a notice signed by the person to be proposed of his willingness to be elected shall have been lodged at the head office or at the registration office provided that the minimum length of the period, during which such notice(s) are given, shall be at least seven (7) days and that (if the notices are submitted after the despatch of the notice of the general meeting appointed for such election) the period for lodgment of such notice(s) shall commence on the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting. The written notice must state that person's biographical details as required by Rule 13.51 of Listing Rules. The procedures for shareholder of the Company to propose a person for election as director is posted on the Company's website.

Shareholder(s) may at any time send their enquiries and concerns to the Board in writing by post at 18/F, Nan Fung Tower, 88 Connaught Road Central, Central, Hong Kong. The Company shall forward the Shareholder(s)' enquiries and concerns to the Board and/or relevant Board committees of the Company, where appropriate, to respond to the Shareholder(s)' enquiries.

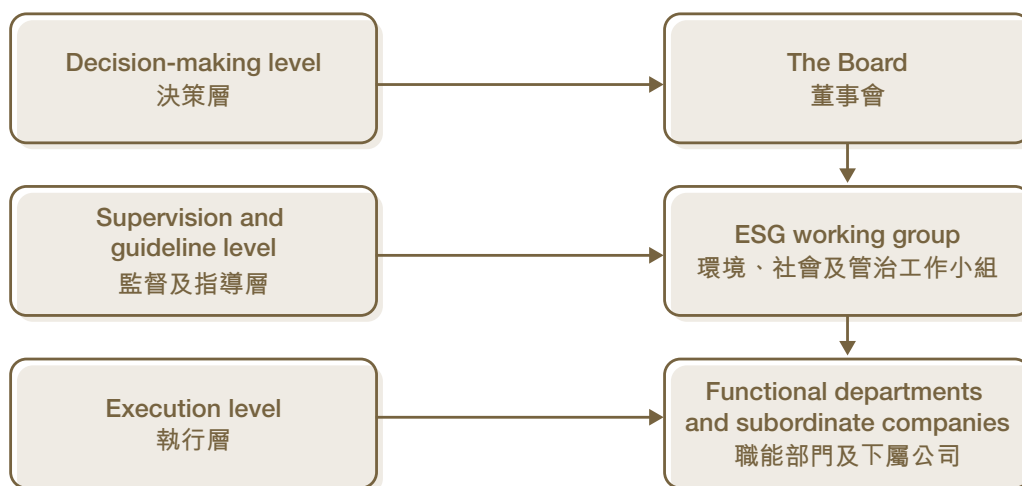

### Environmental Aspects

#### Emissions

To demonstrate the Group's commitment to sustainable development and compliance with laws and regulations relating to environmental protection, the Group endeavors to minimise the environmental impact of the business activities and maintain green operations and green office practices.

The Group has established system to ensure environmental compliance. It seeks to optimise its production by adopting low energy consumption and environmental pollution techniques and enhancing the environmental awareness of the employees through regular trainings. The management team has the overall responsibility for environmental protection matters within the Group. The management team reviews the Group's environmental compliance on a regular basis. The Group was in strict compliance with related environmental laws and regulation, including but not limited to Waste Disposal Ordinance. The Group was not subject to any environmental claims, lawsuits, penalties or administrative sanctions during the reporting period.

In the daily operation of the Group, the major emissions are clinical wastes and the greenhouse gas ("GHG") incurred by the purchased energy resources. Clinical wastes generated by the operations can be divided into two categories. Category A includes syringes, needles, cartridges and other sharp instruments which have been used or which have become contaminated. Category B includes surgical dressings, swabs dribbling with blood, caked with blood or containing free-flowing blood. Clinical wastes collection box is placed in each doctor's room. Category A waste is collected in Sharps Collector. Once it is filled up, it must be covered and wait for recycle. Category B waste is collected in red biochemical wastes plastic bags. All wastes are separately stored and handled with ledger for record. Qualified clinical waste recycling companies are engaged to perform waste disposal and treatment so as to minimize the impact on the nature. During the reporting period, the total amount of clinical wastes recycled by qualified clinical waste recycling companies is 211 kg (2022: 108 kg).

為展示本集團對可持續發展的承諾及與環保相關法例及規例合規事宜，本集團盡力將業務活動的環境影響降至最低以及維持綠色營運及綠色辦公室常規。

本集團已建立系統以確保環境合規事宜。本集團尋求透過採納低能源消耗及環境污染技術，以及通過定期培訓提升僱員的環保意識，以優化其生產。管理團隊對本集團內環保事宜有整體責任。管理團隊定期檢討本集團的環境合規事宜。本集團嚴格遵守相關環境法例及規例，包括但不限於《廢物處置條例》。於報告期間，本集團並無任何環境索償、法律訴訟、處罰或行政制裁。

本集團於日常營運中的主要排放物為醫療廢物及購買能源資源產生的溫室氣體（「溫室氣體」）。營運產生的醫療廢物可分為兩個類別。A類包括已用或已受污染的注射器、針筒、藥筒及其他利器。B類包括滴著血液、凝有血塊或含有自由流動血液的外科敷料及棉棒。醫療廢物收集箱放置於每名醫生的房間。A類廢物收集於利器收集箱。一旦放滿，其必須上蓋及等待回收。B類廢物收集於紅色生化廢物塑膠袋。所有廢物獨立儲存及以賬簿處理以供記錄。合資格醫療廢物回收公司獲聘請從事廢物處置及處理，從而將對大自然的影響降至最低。於報告期間，經合資格醫療廢物回收公司回收的醫療廢物總重量為211千克（2022年：108千克）。

#### The Environment and Natural Resources

According to the Group's "Environmental, Health and Safety Policy", the Group raises staff's awareness of environmental issues through education and training and enlist their support in improving our performance, promote environmental awareness amongst our customers, business partners and shareholders and support community activities in relation to environmental protection and sustainability and evaluate regularly and monitor past and present business activities impacting upon health, safety and environmental matters. With the integration of policies mentioned in sessions "Emissions" and "Use of Resource", the Group is allowed to minimize the impacts to the environment and natural resources.

#### Climate Change

The Group is committed to mitigating the climate change and enhancing its resilience to adapt to the increasing threat of climate-related consequences.

The processes used to identify, evaluate and manage significant risks (including significant climate-related issues) by the Group are summarised as follows:

**Risk Identification:** Identifies risks that may potentially affect the Group's business and operations.

**Risk Assessment:** Assesses the risks identified by using the assessment criteria developed by the management; and considers the impact and consequence on the business and the likelihood of their occurrence.

**Risk Response:** Prioritises the risks by comparing the results of the risk assessment; and determines the risk management strategies and internal control processes to prevent, avoid or mitigate the risks.

Risk Monitoring and Reporting: Performs ongoing and periodic monitoring of the risk and ensures that appropriate internal control processes are in place; revises the risk management strategies and internal control processes in case of any significant change of situation; and reports the results of risk monitoring to the management and the Board regularly.

As a result of above risk management process, physical risk and transitions risks arising from climate change may not bring significant impacts to the Group's business. As a supporter of the recommendations of the Taskforce on Climate-Related Financial Disclosure (TCFD), the Group has assessed the potential climate related risks and identified the rising mean temperature and increasing severity and likelihood of extreme weather events such as rainstorms, floods, fire and heatwaves as major physical risks impacting our daily operation.

The Group's ESG working group is responsible for identifying and assessing any climate-related risks to which the Group's operations are exposed, and updating the Board with the latest news and developments on climate regulations and industry benchmark. In order to cope with climate-related risk, the Group implemented various emergency response mechanism and purchase adequate insurance against natural disasters so as to cope with extreme weather.

In the future, we will continue to identify potential business activities impacting the environment and develop corresponding improvement measures, so as to further prevent the possible negative impacts of our operation on climate change.

The Group considers human resources as its most important asset, employees are encouraged to invest in career growth where the Group provides on-the-job training, and further education supports that enhance their professional knowledge and skills, thus improving the overall calibre of its workforce. In addition, the Group also evaluates employee performance on a regular basis and recognises and rewards outstanding employees. The Group has established and implemented “Staff Handbook”, which contains the policies relating to human resources, covering areas such as compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunities, diversity, anti-discrimination and other benefits and welfare.

The remuneration package of our employees includes basic salary, commission and discretionary performance bonus. In order to incentivise our staff for their contribution to improve our business performance, we have formulated an incentive scheme for certain front-line employees with their commission linked to the amount of sales of our services and products. We offer a fixed commission rate which applies uniformly across all services and products we offer, including the sales of one-off treatment, prepaid packages and skin care products.

It is our objective to provide equality of opportunity for all staff in relation to all human resources matters. We shall recognize and reward meritorious performance and provide equal opportunity of employment irrespective of sex, age, marital status, race, religion, disability or employment status. The principle of equal opportunities is applied in all employment policies, in particular to recruitment, training, career development and promotion of employees. If employee is treated unequally in the workplace, he/she can report to the supervisors.

##### Supply Chain Management

The Group has established “Procurement Policy and Guide to Procedures” which aims to comply with all applicable laws and regulations and appropriate social practices governing our businesses, provide suppliers with equal opportunities for transactions with the Group; and promote procurement activities based on mutual understanding and trust. In order to manage the environmental or social risks in the supply chain, we have strengthened the control in procurement of treatment devices/consumables and skin care products as below.

##### *Treatment devices/treatment consumables*

We place great emphasis on ensuring that treatment devices to be introduced for use in our medical aesthetic centres are reliable and capable of delivering desired results for our clients. To this end, we have established policies and procedures to evaluate and assess treatment devices. Our marketing and business development department is primarily responsible for keeping abreast of the latest technologies and conducting market research on the latest and prevailing treatment technologies and skin care products. Periodic meetings are held among our management, doctors and marketing and business development department to discuss the latest technologies and skin care products, during which our marketing and business development department may recommend the types of treatment devices to procure. From time to time, suppliers of treatment devices visit us and demonstrate their treatment devices to us, which may also provide us with a trial period during which we can evaluate and assess the use and effectiveness of the treatment devices.

When deciding whether to procure a new treatment device, we take into account factors such as (i) whether it is approved by national government agencies such as the Food and Drug Administration (FDA) and/or whether such devices bear CE mark(s); (ii) whether there are similar devices on the market; (iii) whether it is complementary to our existing treatment offerings; (iv) whether it is accredited with certification and qualification related to environmental protection; and (v) our internal test results. The approval of our chief executive officer and doctors must be obtained before we procure a new treatment device.

We select and source skin care products carefully based on factors such as the suppliers' background, credentials and reputation, product quality and cost. The approval of our chief executive officer and laboratory technician must be obtained before we take in any new product for sale.

### **Product Responsibility**

The Group is committed to offering an excellent customer experience and ensuring that our products and services are safe and high quality. We adhere to applicable laws regulating health and safety standards, as well as those governing testing, advertising and labeling. The Group was in strict compliance with related laws and regulations, including but not limited to Trade Description Ordinance, Consumer Goods Safety Ordinance and Consumer Goods Safety Regulation during the reporting period. Our aim is for our customers to have confidence in our products and services, and sufficient information to make informed choices. Therefore, the Group has a set of policies and procedures to oversee and manage issues related to responsibilities of our products and services.

Providing quality non-surgical medical aesthetic services is one of our management priorities. We have adopted comprehensive and stringent quality assurance and control measures throughout our business processes that covers, among others, the following aspects:

##### Recruitment of professional staff

In selecting new doctors and therapists to join us, we assess, among others, their academic and professional qualifications, years of relevant experience as well as their character and integrity.

##### Performance of consultation and treatments

The carrying out of consultation services that involve the practice of medicine, medical diagnosis, prescription of pharmaceutical products and medicines (each as defined under the Pharmacy and Poisons Ordinance (Chapter 138 of the Laws of Hong Kong)) and certain types of treatments (such as injection of botulinum toxin type A and dermal fillers) constitute the practice of medicine and therefore must be carried out by registered medical practitioners pursuant to the Medical Registration Ordinance (Chapter 151 of the Laws of Hong Kong). Our doctors carry out consultation services and such certain treatment procedures which are specified under the relevant laws and regulations as well as selective treatment procedures perceived by our doctors as being high risk, whereas our trained therapists perform other selective treatment procedures as directed by our doctors. Based on our doctors' professional experience and judgment on the risk of severe complication, selective energy-based procedures are performed by doctors only if there is potential risk of irreversible organ or tissue damage including nerve injury, muscle burn, fat necrosis or skin necrosis.

Standard operation procedures and clear division of labour

We implemented standard operation procedures at our medical aesthetic centres and a clear division of labour to improve operational and administrative efficiency and enhance the quality of our services. Our doctors (assisted by medical assistants) and trained therapists are mainly responsible for performing treatments while our aesthetic service specialists are mainly responsible for sales and promotion. To monitor our client's satisfaction towards the treatment received, we contact the client within several days after the treatment by phone or text message to gather his/her feedback. We maintain a log book on feedback for management review. Such internal structure and well defined responsibilities are established for the purpose of segregating the powers of operations, sales and client service to achieve effective check and balance.

##### *Intellectual Property Rights*

We operate our business under the brand name "CosMax+", "VITAE" and "XOVĚ", which we believe embodies our established reputation for quality services and products. We believe that our intellectual property rights are critical to our continued success. We primarily rely on laws and regulations on trademarks and trade secrets and our employees' and third parties' contractual commitments to confidentiality to protect our intellectual property rights.

The Group's research and development department is the department responsible for the work related to intellectual property rights, responsible for the acquisition, modification, renewal, licensing, pledge, transfer, logout, and monitoring of intellectual property of all units including trademarks, functional variable names, copyrights, patents, responsible for guiding, supervising, and managing the intellectual property rights maintenance and rights protection and anti-counterfeiting of all units. The Group regularly conducts intellectual property rights business training for relevant staff of various units to enhance employees' awareness of intellectual property rights protection. The research and development department conducts random inspections on the management of intellectual property rights of various units from time to time.

Employees who are suspected of violating relevant rules of intellectual property rights of the Group shall be under investigation and the Group would take appropriate actions to this.

##### Customer Data Information Protection

The Group upholds a belief that information security and privacy is the key principle for operation. We comply with Personal Data (Privacy) Ordinance. According to the Group's Staff Handbook, employee is required protect all the customers' information. Information only can be used in authorized business activities. If employee disclose those information to other parties, it is considered as data theft. The related employee's employment will be terminated and report to police for prosecution.

During the year, there was no products sold/service provided subject to recalls for safety and health reasons and no material complaints about our products and services received.

Once discovered and confirmed, related personnel will be published or his/her employment will be terminated. The Group will be report to Independent Commission Against Corruption (ICAC) or other institution depends on the cases. Besides, anti-corruption training were provided to senior management through internal training during the reporting period.

The Directors present their report together with the audited financial statements for the year ended 31 March 2023.

### Corporate Information

The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 6 July 2016 under the Companies Law of the Cayman Islands. The Company's shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

### Principal Activities and Business Review

The principal activity of the Company is investment holding. The principal activities of the Company's subsidiaries are the provision of medical aesthetic services and sale of skin care products.

Business review of the Group for the year ended 31 March 2023 as required by Schedule 5 to the Hong Kong Companies Ordinance, including a fair review of the Group's business and an indication of likely future development in the Group's business, can be found in the Management Discussion and Analysis set out on pages 7 to 18 of this annual report which forms part of this report of the directors.

### Principal Risks and Uncertainties

The Group's financial condition, results of operations, and business prospects may be affected by a number of risks and uncertainties directly or indirectly pertaining to the Group's business. The following are the key risks and uncertainties identified by the Group.

#### Government Policies Risk

Following certain adverse incidents in relation to the beauty service industry in recent years, the Hong Kong Government has been reviewing the existing legal framework and considering tightening its supervision over the beauty service industry by promulgating certain laws and regulations to regulate, among other things, the types of medical aesthetic procedures that should be performed by registered medical practitioners. See "Regulatory Overview — Recent Development in relation to Regulation of Medical Procedures and Beauty Services, as well as Private Healthcare Facilities" in the prospectus of the Company dated 30 December 2016 for further details.

### 公司資料

本公司於2016年7月6日根據開曼群島公司法在開曼群島註冊成立為獲豁免有限公司。本公司股份在香港聯合交易所有限公司(「聯交所」)主板上市。

### 主要業務及業務回顧

本公司的主要業務為投資控股。本公司附屬公司的主要業務為提供醫學美容服務及護膚產品銷售。

按照香港公司條例附表5規定本集團截至2023年3月31日止年度之業務回顧(包括本集團業務之公平回顧以及本集團業務未來可能發展之揭示)可於本年報第7至18頁所載管理層討論及分析內查閱，其構成本董事會報告之一部分。

### 主要風險及不明朗因素

本集團的財務狀況、經營業績及業務前景可能受到與本集團業務直接或間接相關的眾多風險及不明朗因素的影響。以下為本集團知悉的主要風險及不明朗因素。

#### 政府政策風險

近年來美容服務行業發生若干不利事故後，香港政府一直在檢討現有法律框架，並考慮透過頒佈若干法例及規例，加緊對美容服務行業的監督，以監管(其中包括)應由註冊醫生施行的醫學美容程序類別。有關進一步詳情，請參閱本公司日期為2016年12月30日的招股章程「監管概覽 — 有關醫療程序和美容服務以及私營醫療機構法規的近期進展」。

There is no assurance that the Hong Kong Government will not impose more stringent laws, rules, regulations or industry standards in connection with the provision of medical aesthetic services. Any change in the regulatory framework may render it more restrictive for us to conduct our business. There is also no assurance that we will be able to adapt to such changes in a timely manner. In addition, compliance with such new laws, rules, regulations or industry standards may significantly increase our operating costs, which may in turn lower our profit margins. Any of the above-mentioned circumstances may materially and adversely affect our business, results of operations, financial condition and prospects.

### **Risk of Adverse Economic, Social or Political Conditions**

Our business operations are mainly based in and we derive most of our revenue from Hong Kong. Our business operations and the demand for our medical aesthetic services and the sale of skin care products are therefore subject to the economic, social and political conditions in Hong Kong. Furthermore, any incidence of social unrest, strike, riot, civil disturbance or disobedience in Hong Kong may cause inconvenience to clients who wish to visit our medical aesthetic centres and weaken their desire or willingness to undergo medical aesthetic treatments. Any of the above circumstances may have a material and adverse impact on our business, results of operations and financial condition.

In addition, in the past years, a portion of our revenue was derived from visitors and tourists from the PRC who do not reside in Hong Kong. Any reduction in the spending willingness of such PRC visitors and tourists and any decrease in the number of PRC visitors and tourists to Hong Kong as a result of anti-mainland sentiment may significantly reduce our revenue derived from such clients, which could materially and adversely affect our results of operations and financial condition.

### **Environmental Policies and Performance**

The Group considers the importance of environmental affairs and believes business development and environment affairs are highly related. The Group has implemented certain environmental protection measures to save energy and reduce the consumption of resources. These policies were supported by our staff and were implemented effectively.

In addition, details regarding the Group's environmental policies and performance can be found in the Environmental, Social and Governance Report set out on pages 45 to 79 of this annual report.

我們的業務經營主要以香港為基地，而我們大部分收益均產生自香港。我們的業務經營及對我們醫學美容服務及銷售護膚產品的需求因此受到香港的經濟、社會及政治狀況影響。此外，香港任何社會動盪、罷工、暴動、公民抗命或擾亂事件可能對欲到訪我們醫學美容中心的客戶造成不便，減低彼等進行醫學美容療程的意欲或意願。任何上述情況均可能對我們的業務、經營業績及財務狀況構成重大不利影響。

此外，於過往年度，我們收益一部分產生自非居住在香港的中國訪客及旅客。反內地情緒導致有關中國訪客及旅客的任何消費意欲下降以及中國到訪香港的訪客及旅客人數減少，可能大幅減少產生自有關客戶的收益，從而對我們的經營業績及財務狀況構成重大不利影響。

### **環境政策及表現**

本集團認可環境事務的重要性，並認為業務發展及環境事務高度相關。本集團已實施若干環保措施以節約能源及減少資源消耗。該等政策已獲得我們員工的支持並獲有效執行。

The Group recognises the importance of compliance with regulatory requirements and the risks of non-compliance with the applicable laws and regulations. During the year ended 31 March 2023 and up to the date of this report, the Group has complied in material respects with the relevant laws and regulations that have a significant impact on the business and operation of the Group. There was no material breach or non-compliance with the applicable laws and regulations by the Group during the year ended 31 March 2023 and up to the date of this report.

### Relationship with Key Stakeholders

The Group fully understands that staff, customers and suppliers are the key to our sustainable and stable development. We are committed to establishing a close relationship with our staff, enhancing cooperation with our suppliers and providing high-quality services to our customers so as to ensure the Group's sustainable development.

### Results and Appropriations

The results of the Group for the year are set out in the consolidated statement of profit or loss and other comprehensive income on page 101 of this annual report.

The Board does not recommend or declare the payment of any dividend for the year ended 31 March 2023 (2022: Nil).

### Annual General Meeting

The annual general meeting ("AGM") of the Company will be held on Friday, 15 September 2023. A notice convening the meeting will be issued and sent to the Shareholders in due course.

### Closure of Register of Members

For determining the entitlement to attend and vote at the AGM, the register of members of the Company will be closed from Monday, 11 September 2023 to Friday, 15 September 2023 both dates inclusive, during which period no transfer of shares can be registered. In order to be eligible to attend and vote at the AGM, all transfers accompanied by the relevant share certificates must be lodged with the Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong for registration not later than 4:30 p.m. on Friday, 8 September 2023.

Charitable donations made by the Group during the year amounted to HK\$129,000 (2022: HK\$29,000).

### Pre-Emptive Rights

There is no provision for pre-emptive rights under the Company's articles of association and there was no restriction against such rights under the laws of the Cayman Islands, which would oblige the Company to offer new shares on a pro-rata basis to existing shareholders.

### Purchase, Sale or Redemption of Securities

During the year ended 31 March 2023, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the Company's shares.

### Share Option Scheme

The Company has a share option scheme (the "Share Option Scheme") which was approved and adopted by the sole shareholder of the Company by way of written resolutions passed on 19 December 2016 for a term of 10 years from the date of adoption of the Share Option Scheme. The principal terms of the Share Option Scheme are set out in note 27 to the consolidated financial statements.

No share option has been granted, exercised, cancelled or lapsed under the Share Option Scheme since its adoption and there was no outstanding share option as at 31 March 2023.

Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The retirement benefit scheme contributions made by the Group amounted to HK\$6,595,000 (2022: HK\$4,705,000) for the year ended 31 March 2023.

### Permitted Indemnity Provision

The Company has arranged appropriate liabilities insurance to indemnify the Directors from any liabilities and costs arising from the business of the Group.

Pursuant to the Company's articles of association, every director of the Company shall be entitled to be indemnified out of the assets of the Company against all losses or liabilities which he may sustain or incur in or about the execution of the duties of his office or otherwise in relation thereto. The Company maintains directors and officers liability insurance, which gives appropriate cover for any legal action brought against its Directors. The level of the coverage is reviewed annually.

#### *Revenue recognition from prepaid packages*

Revenue from treatment services is recognised when such services have been rendered to customers.

Prepaid treatment services not yet rendered, which are non-refundable, are deferred and reported as contract liabilities in the consolidated statement of financial position. Customers may not exercise all of their contractual rights of the prepaid packages before expiry of the service period, and such unexercised rights are referred to as breakage.

The Group recognised an expected breakage amount as revenue in proportion to the expected pattern of rights exercised by the customers. Upon expiry of the service period, the unutilised portion of the prepaid packages is fully recognised in profit or loss. As at 31 March 2023, the carrying amount of contract liabilities amounted to HK\$144,192,000. During the year ended 31 March 2023, revenue recognised from treatment services amounted to HK\$333,213,000.

The recognition of revenue from the prepaid packages involves significant management's judgement to determine the appropriate amount and timing based on the Group's accounting policy for revenue recognition. The determination of the expected breakage amount involves significant estimates based on the Group's historical experience on the utilisation of prepaid packages and the expected utilisation pattern, as appropriate.

The related disclosures are included in notes 2.4, 3, 5 and 22 to the consolidated financial statements.

貴集團按客戶行使權利的預期模式的比例確認預期未使用權利金額為收益。於服務期屆滿後，預付療程的未使用部分於損益中悉數確認。於2023年3月31日，合約負債的賬面值為144,192,000港元。截至2023年3月31日止年度，已確認來自療程服務的收益為333,213,000港元。

確認來自預付療程的收益涉及管理層的重大判斷，根據 貴集團的收益確認會計政策釐定的合適金額及時間。釐定預期未使用權利金額涉及重大估計，基於 貴集團對預付療程的過往使用經驗及預期使用模式(如適用)作出估計。

### 1. Corporate and Group Information

Miricor Enterprises Holdings Limited is a limited liability company incorporated in the Cayman Islands. The principal place of business of the Company is located at 18/F, Nan Fung Tower, 88 Connaught Road Central, Central, Hong Kong.

During the year, the Company and its subsidiaries (collectively referred to as the “Group”) were principally engaged in the provision of medical aesthetic services and the sale of skincare products.

In the opinion of the directors, the immediate holding company and the ultimate holding company of the Company is Sunny Bright Group Holdings Limited, a company incorporated in the British Virgin Islands.

#### Information about subsidiaries

Particulars of the Company’s principal subsidiaries are as follows:

### 1. 公司及本集團資料

### 2.1 Basis of Preparation

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention. These financial statements are presented in Hong Kong dollars (“HK\$”) and all values are rounded to the nearest thousand except when otherwise indicated.

As at 31 March 2023, the Group’s current liabilities exceeded its current assets by HK\$13,236,000. The net current liabilities position was mainly due to the contract liabilities of HK\$144,192,000 classified under current liabilities as at the end of the reporting period. Taking into account the stable operating cash inflows to be generated from the provision of medical aesthetic services and the sale of skincare products, the directors of the Company consider the Group will have adequate resources to meet its liabilities, commitments and funding requirements as and when they fall due within one year from the end of the reporting period. Accordingly, the directors of the Company are satisfied that it is appropriate to prepare these consolidated financial statements on a going concern basis.

#### **Basis of consolidation**

The consolidated financial statements include the financial statements of the Group for the year ended 31 March 2023. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

### 2.1 編製基準

此等財務報表乃根據香港會計師公會（「香港會計師公會」）所頒佈之香港財務報告準則（「香港財務報告準則」）（當中包括所有香港財務報告準則、香港會計準則（「香港會計準則」）及詮釋）、香港公認會計原則及香港公司條例之披露規定而編製。此等財務報表乃根據歷史成本法編製。除另有註明外，此等財務報表乃以港元（「港元」）呈列，而所有金額均調整至最接近之千位。

於2023年3月31日，本集團的流動負債超出其流動資產13,236,000港元。流動負債淨額狀況主要由於報告期末分類為流動負債的合約負債144,192,000港元所致。考慮到提供醫學美容服務及銷售護膚產品將產生穩定的經營現金流入，本公司董事認為本集團將有足夠資源應付其自報告期末起一年內到期的負債、承擔及資金需求。因此，本公司董事信納，按持續經營基準編製該等綜合財務報表屬恰當。

#### **綜合基準**

本綜合財務報表包括本集團截至2023年3月31日止年度之財務報表。附屬公司指由本公司直接或間接控制的實體（包括結構實體）。當本集團就自參與被投資方而產生的可變回報承擔風險或有權獲取有關回報且有能力透過其對被投資方的權力影響該等回報（即賦予本集團指導被投資方進行相關活動的現有能力及現時權利）時，則獲得控制權。

#### **Basis of consolidation (Continued)**

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above.

Instead, an entity recognises the proceeds from selling any such items, and the cost of those items as determined by HKAS 2 *Inventories*, in profit or loss. The Group has applied the amendments retrospectively to items of property, plant and equipment made available for use on or after 1 April 2021. Since there was no sale of items produced prior to the property, plant and equipment being available for use, the amendments did not have any impact on the financial position or performance of the Group.
- (c) Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Further information about those HKFRSs that are expected to be applicable to the Group is described below.

Amendments to HKFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16 (i.e., 1 April 2019). Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 1 *Classification of Liabilities as Current or Non-current* clarify the requirements for classifying liabilities as current or non-current, in particular the determination over whether an entity has a right to defer settlement of the liabilities for at least 12 months after the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. In 2022, the HKICPA issued the 2022 Amendments to further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. In addition, the 2022 Amendments require additional disclosures by an entity that classifies liabilities arising from loan arrangements as non-current when it has a right to defer settlement of those liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively. Earlier application is permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The Group is currently assessing the impact of the amendments and whether existing loan agreements may require revision. Based on a preliminary assessment, the amendments are not expected to have any significant impact on the Group's financial statements.

香港財務報告準則第16號修訂明賣方一承租人於計量售後租回交易產生的租賃負債時使用的規定，以確保賣方一承租人不曾確認與其所保留使用權有關的任何收益或虧損金額。該等修訂於2024年1月1日或之後開始的年度期間生效，並應追溯應用於初步應用香港財務報告準則第16號當日(即2019年4月1日)後訂立的售後租回交易。允許提前應用。預期該等修訂不會對本集團的財務報表產生任何重大影響。

香港會計準則第1號修訂將負債分類為流動或非流動釐清將負債分類為流動或非流動的規定，尤其是釐定實體是否有權將負債的結算遞延至報告期後至少12個月。負債的分類不受實體將行使其權利延遲清償負債的可能性影響。該等修訂亦釐清被認為是清償負債的情況。於2022年，香港會計師公會頒佈2022年修訂本，以進一步釐清在貸款安排產生的負債契諾中，僅實體須於報告日期或之前遵守的契諾會影響該負債分類為流動或非流動。此外，2022年修訂本要求實體作出額外披露，倘實體有權延遲結算該等負債(實體須於報告期後12個月內遵守未來契諾)，則將貸款安排產生的負債分類為非流動。該等修訂於2024年1月1日或之後開始之年度期間生效，並應追溯應用。允許提前應用。提早應用2020年修訂本的實體須同時應用2022年修訂本，反之亦然。本集團目前正在評估該等修訂的影響及現有貸款協議是否需要修訂。根據初步評估，該等修訂預期不會對本集團的財務報表產生任何重大影響。

Amendments to HKAS 1 *Disclosure of Accounting Policies* require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to HKAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to HKFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently revisiting the accounting policy disclosures to ensure consistency with the amendments.

Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 12 narrow the scope of the initial recognition exception in HKAS 12 so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability for temporary differences arising from these transactions. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

#### **Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

業務合併乃採用收購法入賬。所轉讓代價乃按收購日期的公平值計量，收購日期公平值是本集團所轉讓資產之收購日期公平值、本集團為被收購方前擁有人所承擔之負債及本集團為交換被收購方控制權而發行之股權的總值。就各業務合併而言，本集團選擇是按公平值還是被收購方可識別資產淨值的應佔比例，計量於被收購方的非控制權益，即於被收購方中賦予持有人在清盤時按比例分佔資產淨值的現有所有權權益。非控制權益的所有其他組成部分均按公平值計量。收購相關成本於產生時支銷。

當所收購的一組活動及資產包含共同對創造產出的能力有重大貢獻的一項投入及一項實質性程序，本集團認為其已收購一項業務。

本集團收購業務時根據按合約條款、收購日期的經濟狀況及相關條件所作適當分類及指定用途評估接收的金融資產及負債，其中包括分離被收購方主合約中的嵌入式衍生工具。

倘業務合併分階段進行，則先前所持股權按收購日期公平值重新計量，而就此產生的任何收益或虧損於損益確認。

收購方將轉讓的任何或然代價按收購日期之公平值確認。歸類為資產或負債的或然代價按公平值計量，而公平值的變動於損益確認。歸類為權益之或然代價毋須重新計量，隨後結算於權益列賬。

#### **Business combinations and goodwill** (Continued)

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

商譽初始按成本計量，即所轉讓代價、已確認非控制權益金額以及本集團先前所持被收購方權益的任何公平值超出所收購可識別資產及所承擔負債之差額。倘該代價及其他項目總額低於所收購資產淨值的公平值，則差額經重新評估後於損益確認為議價購買收益。

於初始確認後，商譽按成本減任何累計減值虧損計量。每年對商譽進行減值測試，倘出現任何事件或情況轉變而顯示賬面值可能減值，則會更頻密測試。本集團於每年3月31日對商譽進行減值測試。就減值測試而言，業務合併所得商譽自收購當日起分配至本集團的各個現金產生單位或各組現金產生單位（預期會產生合併協同效益），而不論本集團其他資產或負債有否指定撥往該等單位或單位組別。

減值金額透過評估商譽所屬的現金產生單位（現金產生單位組別）的可收回金額而釐定。倘現金產生單位（現金產生單位組別）的可收回金額低於賬面值，則確認減值虧損。就商譽所確認的減值虧損不會於其後期間撥回。

倘商譽分配至現金產生單位（或現金產生單位組別），且該單位內部分業務已出售，則於釐定出售的盈虧時，有關所出售業務的商譽計入業務的賬面值。在該等情況下出售的商譽根據所出售業務的相關價值及所保留的部分現金產生單位而計量。

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

倘出現減值跡象，或須對資產進行年度減值測試(存貨、遞延稅項資產及金融資產除外)，則估計資產的可收回金額。資產之可收回金額是資產或現金產生單位之使用價值與其公平值扣除銷售成本兩者中之較高者，並就個別資產釐定，除非該資產並無產生大致上獨立於其他資產或資產組別的現金流入，在此情況下，則就資產所屬之現金產生單位釐定可收回金額。於對現金產生單位進行減值測試時，倘能夠在合理且一致的基礎上分配予個別現金產生單位，則將公司資產的賬面值的一部分分配予個別現金產生單位，否則，將其分配予最小的現金產生單位組別。

減值虧損僅於資產賬面值超過其可收回金額時確認。在評估使用價值時，估計日後現金流量乃按除稅前折現率計算其現值，該折現率反映目前市場對貨幣時間值及該資產特定風險之評估。減值虧損於產生期間自損益中扣除。

於各報告期末會評估有否跡象顯示先前確認之減值虧損已不再存在或有所減少。倘出現有關跡象，則估計可收回金額。當用以釐定該資產可收回金額之估計有變，方會撥回該資產先前確認之減值虧損(不包括商譽)，惟所撥回金額不可超過過往年度在並無就該資產確認減值虧損的情況下釐定之賬面值(扣除任何折舊)。撥回減值虧損於產生期間計入損益。

A party is considered to be related to the Group if:

#### Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

物業、廠房及設備按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目成本包括購買價及使資產達至營運狀況及地點以作擬定用途產生之任何直接應佔成本。

物業、廠房及設備項目投入運作後產生之開支，如維修及保養費，一般於產生期間在損益中扣除。倘符合確認標準，主要檢查開支於資產賬面值中資本化為重置成本。如須不時更換物業、廠房及設備的重要部分，則本集團將該等部分確認為具有特定使用年期的個別資產，並按各自使用年期折舊。

折舊以直線法按各項物業、廠房及設備項目之估計使用年期撇銷成本至剩餘價值計算。就此用途採用之主要年率如下：

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

#### **Leases**

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### **Group as a lessee**

The Group applies a single recognition and measurement approach for all leases, except for short-term leases. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets. At inception or on reassessment of a contract that contains a lease component and non-lease components, the Group adopts the practical expedient not to separate non-lease components and to account for the lease component and the associated non-lease components as a single lease component.

#### **租賃**

本集團於合約開始時評估合約是否為租賃或包含租賃。倘合約為換取代價而附帶權利可在一段時間內控制使用可識別資產，則該合約為租賃或包含租賃。

#### **本集團作為承租人**

###### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the lease terms.

###### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

###### (c) Short-term leases

The Group applies the short-term lease recognition exemption to its short-term leases (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). Lease payments on short-term leases are recognised as an expense on a straight-line basis over the lease term.

#### Financial assets

##### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost, it needs to give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

金融資產於初步確認時的分類視乎金融資產合約現金流量的特徵及本集團管理該等資產的業務模式。除並無重大融資成分或本集團並未就此應用不調整重大融資成分影響實際權宜方法的貿易應收賬款外，本集團初步按其公平值加(倘並非按公平值入損益的金融資產)交易成本計量金融資產。根據下文「收益確認」所載政策，並無重大融資成分或本集團並未就此應用實際權宜方法的貿易應收賬款按香港財務報告準則第15號釐定的交易價格計量。

為使金融資產按攤銷成本分類及計量，需產生僅為支付本金及未償還本金利息的現金流量。

本集團管理金融資產的業務模式指為產生現金流量而管理金融資產的方式。業務模式釐定現金流量會否來自收取合約現金流量、出售金融資產或以上兩者。按攤銷成本分類及計量的金融資產以持有金融資產以收取合約現金流量為目的之業務模式中持有。

所有以常規方式購買及出售的金融資產均於交易日(即本集團承諾購買或出售資產之日)確認。以常規方式購買或出售指需在市場規例或慣例規定的期限內交付資產的金融資產購買或出售。

##### Subsequent measurement of financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

##### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

本集團以擔保形式持續涉及轉讓資產。該已轉讓資產乃以該項資產之原賬面值及本集團可能需要支付之最高代價兩者之較低者計量。

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

本集團就所有並非按公平值計入損益持有的債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃以根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額為基準，按原有實際利率相近的差額折現。預期現金流量將包括來自銷售所持有抵押品或其他信用增級的現金流量，此乃合約條款不可或缺的部分。

#### 一般方法

預期信貸虧損於兩個階段進行確認。對於自初步確認後並無顯著增加的信貸風險，預期信貸虧損就可能於未來12個月內(12個月預期信貸虧損)出現的違約事件計提撥備。對於自初步確認以來有顯著增加的信貸風險，須在信貸虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(全期預期信貸虧損)。

於各報告日期，本集團評估自初步確認以來金融工具的信貸風險是否顯著增加。於作出評估時，本集團將於報告日期金融工具發生的違約風險與於初步確認日期金融工具發生的違約風險進行比較，並考慮合理且具支持性的資料，包括無需付出不必要的成本或努力而可得的歷史及前瞻性資料。本集團認為，當合約付款逾期超過30日時，信貸風險已大幅增加。

##### General approach (Continued)

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Stage 1 — Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 — Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 — Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

倘無法合理預期可收回合約現金流量，則撇銷金融資產。

按攤銷成本計量的金融資產在一般方法下可能會減值，且除應用簡化法的貿易應收賬款(如下文詳述)外，有關資產於以下階段分類以計量預期信貸虧損。

##### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

#### Financial liabilities

##### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings and payables.

All financial liabilities are recognised initially at fair value and net of directly attributable transaction costs.

##### Subsequent measurement of financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is recognised in profit or loss.

#### 金融負債

##### 初步確認及計量

金融負債於初步確認時分類為貸款及借款及應付賬款。

所有金融負債初步按公平值確認並扣除直接應佔交易成本。

##### 按攤銷成本計量的金融負債的後續計量(貸款及借款)

於初步確認後，計息貸款及借款於其後採用實際利率法按攤銷成本計量，惟倘折現影響並不重大，則會按成本列賬。收益及虧損在負債終止確認時及按實際利率進行攤銷時於損益確認。

計算攤銷成本時，考慮收購產生的任何折讓或溢價以及屬實際利率組成部分的費用或成本。實際利率攤銷於損益確認。

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

#### **Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to disposal.

#### **Cash and cash equivalents**

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### **抵銷金融工具**

倘於現時存在可依法執行的合法權利以抵銷已確認金額及有意按淨額基準結算，或同時變現資產及清償負債，金融資產及金融負債會予以抵銷，並於財務狀況表呈報淨金額。

#### **存貨**

存貨按成本與可變現淨值兩者間的較低者列賬。成本按加權平均數基準釐定。可變現淨值按估計售價減估計出售將產生的成本計算。

#### **現金及現金等價物**

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時轉換為已知金額現金、所涉價值變動風險不大且一般在收購後三個月內到期的短期高流通投資，減須於要求時償還的銀行透支，並構成本集團現金管理組成部分。

就綜合財務狀況表而言，現金及現金等價物包括手頭現金及並無限制用途的銀行存款(包括定期存款及類似現金性質的資產)。

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is recognised in profit or loss.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries/jurisdictions in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

倘因過往事件導致現時責任(法定或推定)，而承擔該責任可能導致日後資源的外流，且責任金額能可靠估計，則確認撥備。

當有重大折現影響時，會就預期須用作償付責任的未來開支於報告期末確認其現值以作撥備。因時間流逝而引致的折現現值的增加於損益確認。

#### 所得稅

所得稅包括即期及遞延稅項。所得稅如涉及在損益以外確認的項目，不在損益確認，而在其他全面收益或直接於權益確認。

即期稅項資產及負債，乃根據於報告期末已頒佈或實質上已頒佈的稅率(及稅法)，並考慮本集團經營業務所在國家／司法權區的現行法例詮釋及慣例，按預期將獲稅務機構退回或支付予稅務機構的金額計算。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and future taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

#### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

遞延稅項資產及負債基於截至報告期末已頒佈或實質上已頒佈的稅率(及稅法)按變現資產或償還負債期間的預期適用稅率計量。

當及僅當本集團有可合法執行權利可將即期稅項資產與即期稅項負債抵銷，且遞延稅項資產與遞延稅項負債與同一稅務機關對同一應稅實體或於各未來期間預期有大額遞延稅項負債或資產需要清償或收回時，擬按淨額基準清償即期稅務負債及資產或同時變現資產及清償負債之不同稅務實體徵收之所得稅相關，則遞延稅項資產與遞延稅項負債可予抵銷。

#### 政府補助

政府補助在合理確保將收取有關補助且將符合所有附帶條件的情況下，按其公平值予以確認。倘補助與開支項目有關，則於擬用作補償的成本支銷期間按系統基準確認為收入。

#### Revenue recognition

##### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to be that which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

##### 客戶合約收益

客戶合約收益乃於商品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等商品或服務有權獲得的代價。

當合約中的代價包括可變金額時，估計代價金額為本集團就向客戶轉讓貨品或服務而有權換取的金額。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素隨後得到解決時，確認的累計收益金額極有可能不會發生重大收益撥回。

當合約中包含融資部分，該融資部分為客戶提供超過一年的貨品或服務轉讓融資的重大利益時，收益按應收賬款的現值計量，使用折現率折現，該折現率將反映在本集團與客戶在合約開始時的單獨融資交易中。倘合約包含為本集團提供超過一年的重大融資利益的融資部分，則根據該合約確認的收益包括按實際利率法計算的合約負債所產生的利息開支。就客戶付款與轉讓承諾貨品或服務之間的期限為一年或以下的合約而言，交易價格不會採用香港財務報表準則第15號的可行權宜方法就重大融資部分的影響作出調整。

##### Revenue from contracts with customers (Continued)

(a) *Provision of medical aesthetic services*

Revenue from treatment services, medical consultation services, prescription and dispensing of medical products are recognised when the services have been rendered to customers.

Prepaid treatment services not yet rendered, which are non-refundable, are deferred and reported as contract liabilities in the consolidated statement of financial position. Customers may not exercise all of their contractual rights of the prepaid packages before expiry of the service period, and such unexercised rights are referred to as breakage. The Group recognised an expected breakage amount as revenue in proportion to the expected pattern of rights exercised by the customers. Upon expiry of the service period, the unutilised portion of the prepaid packages are fully recognised in profit or loss.

(b) *Sale of skincare products*

Revenue from the sale of skincare products is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the skincare products.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

(a) *提供醫學美容服務*

療程服務、醫療諮詢服務、處方及配藥服務的收益於服務已向客戶提供時確認。

尚未提供的預付療程服務不可退款，其被遞延及於綜合財務狀況表內呈報為合約負債。客戶可能不會於服務期屆滿前行使其所有預付療程的合約權利，而該等未行使權利會被稱為未使用權利。本集團按客戶行使權利的預期模式的比例確認預期未使用權利金額為收益。於服務期屆滿後，預付療程的未使用部分悉數於損益確認。

(b) *銷售護膚產品*

來自銷售護膚產品的收益於資產的控制權轉讓予客戶的某一時間點(一般為交付護膚產品時)確認。

#### 其他收入

利息收入乃使用實際利率法按累計基準確認，採用的利率為在金融工具的預期年期或更短期間(如適用)將估計未來現金收入準確折現至金融資產賬面淨值。

#### 合約負債

倘客戶於本集團轉讓貨品或服務予客戶前支付代價，則於支付款項或到期應付款項時(以較早者為準)確認合約負債。當本集團履約(即將相關貨品或服務控制權轉讓至客戶)時，合約負債確認為收益。

#### Contract costs

Costs incurred to obtain a contract with a customer are capitalised as an asset if the costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

#### Employee benefits

##### Retirement benefit schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions.

資本化合約成本按系統基準進行攤銷並自損益中扣除，與向客戶作出與資產相關的貨品或服務的轉讓一致。其他合約成本於產生時列為開支。

#### 僱員福利

##### 退休福利計劃

本集團根據香港強制性公積金計劃條例為合資格參與強積金計劃的僱員運作一項定額供款強制性公積金退休福利計劃(「強積金計劃」)。供款乃按僱員基本薪金的若干百分比作出，並於按照強積金計劃規則應付時自損益扣除。強積金計劃的資產於獨立管理基金與本集團的資產分開持有。本集團的僱主供款於向強積金計劃供款時全數歸屬於僱員。

本集團於中國內地營運的附屬公司的僱員須參與由地方市政府營運的中央退休金計劃。該等附屬公司須按其工資成本的若干百分比向中央退休金計劃供款。供款於根據中央退休金計劃規則應付時自損益扣除。

#### 外幣

此等財務報表以港元呈列，而港元亦為本公司的功能貨幣。本集團旗下各實體自行決定其功能貨幣，而各實體財務報表內的項目均以該功能貨幣計量。本集團實體的外幣交易初步按交易當日的各功能貨幣匯率入賬。以外幣計值的貨幣資產及負債按報告期末的功能貨幣匯率換算。結算或換算貨幣項目時產生的差額於損益確認。根據外幣過往成本計算的非貨幣項目按首次交易日期的匯率換算。

#### Foreign currencies (Continued)

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

### 3. Significant Accounting Judgements and Estimates

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

##### Revenue recognition from prepaid packages

The recognition of revenue from the prepaid packages involves significant management's judgement to determine the appropriate amount and timing based on the Group's accounting policy for revenue recognition in note 2.4 to the financial statements.

##### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

##### Utilisation pattern of medical aesthetic services

Customers may not exercise all of their contractual rights of the prepaid packages before expiry of the service period, and such unexercised rights are referred to as breakage. The Group determines the expected breakage amount with reference to the Group's historical experience on the utilisation of prepaid packages and the expected utilisation pattern, as appropriate. Estimates of expected breakage amount are sensitive to changes in circumstances and the Group's past experience may not be representative of the actual outcome in the future.

##### Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

##### 估計不確定因素

有關未來及於報告期末有重大風險導致須於下一財政年度對資產及負債的賬面值作出重大調整的主要假設及估計不確定因素其他主要來源於下文論述。

##### 醫學美容服務的使用模式

客戶可能不會於服務期屆滿時行使其所有預付療程的合約權利，而該等未使用權利會被稱為未使用權利。本集團經參考本集團對使用預付療程及預期使用模式(如適用)的過往經驗釐定預期未使用權利金額。對預期未使用權利金額的估計對環境變化敏感，而本集團的過往經驗可能無法代表未來的實際結果。

##### 非金融資產(商譽除外)減值

本集團會於各報告期末評估所有非金融資產(包括使用權資產)有否出現任何減值跡象。非金融資產則於出現賬面值或不可收回的跡象時進行減值測試。資產或現金產生單位賬面值超逾其可收回金額(即其公平值減出售成本與其使用價值的較高者)時，則存在減值。計量公平值減出售成本時，按類似資產的公平交易中的約束銷售交易可得數據，或可觀察市價減出售資產所產生的增量成本而得出。當計算使用價值時，管理層必須估計來自資產或現金產生單位的預期未來現金流量，並選擇合適的折現率以計算該等現金流量的現值。

##### Provision for expected credit losses on trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns.

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the medical aesthetic services sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 17 to the financial statements.

##### Leases – Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available or when it needs to be adjusted to reflect the terms and conditions of the lease. The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.

##### 貿易應收賬款預期信貸虧損撥備

本集團使用撥備矩陣計算貿易應收賬款的預期信貸虧損。撥備率乃基於具有類似虧損模式的不同客戶分部組合逾期日數釐定。

撥備矩陣初步基於本集團過往觀察所得違約率而釐定。本集團將調整矩陣，藉以按前瞻性資料調整過往信貸虧損經驗。舉例而言，倘預測經濟環境(即本地生產總值)預期將於未來一年惡化，而可能導致醫學美容服務業界違約數目增加，則會調整過往違約率。於各報告日期，過往觀察所得違約率將予更新，並會分析前瞻性估計變動。

對過往觀察所得違約率、預測經濟環境及預期信貸虧損之間的關連性進行的評估屬重大估計。預期信貸虧損金額對情況及預測經濟環境的變化敏感。本集團過往信貸虧損經驗及預測經濟環境亦可能無法代表客戶日後的實際違約情況。有關本集團貿易應收賬款的預期信貸虧損資料已於財務報表附註17內披露。

##### 租賃 – 估計增量借貸利率

本集團無法輕易釐定租賃內所隱含的利率，因此，使用增量借貸利率(「增量借貸利率」)計量租賃負債。增量借貸利率為本集團於類似經濟環境中為取得與使用權資產價值相若之資產而按相若條款以類似抵押品借入所需資金應付之利率。因此，增量借貸利率反映本集團「應支付」的款項，要求於並無可觀察的利率時或須對利率進行調整以反映租賃之條款及條件時作出估計。當可觀察輸入數據可用時，本集團會使用可觀察輸入數據(如市場利率)估計增量借貸利率及須作出若干實體特定估計。

##### Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that future taxable profits will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies.

### 4. Operating Segment Information

The Group has one reportable operating segment, namely the non-surgical medical aesthetic services segment, and is principally engaged in the provision of medical aesthetic services and the sale of skincare products in Hong Kong and Mainland China. Information reported to the Group's chief operating decision maker for the purpose of making decisions about resource allocation and performance assessment is focused on the operating results of the Group as a whole as the Group's resources are integrated and no discrete operating segment financial information is available. Accordingly, no operating segment information is presented.

#### Impairment testing of goodwill

Goodwill of HK\$4,305,000 acquired through business combination has been allocated to a non-surgical medical aesthetic service cash-generating unit (the "CMM CGU") for impairment testing.

The recoverable amount of the CMM CGU has been determined based on a value in use calculation using cash flow projections based on financial budgets approved by senior management covering a 36-month (2022: 36-month) period. Assumptions were used in the value in use calculation of the CMM CGU for 31 March 2023 and 31 March 2022. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

- Revenue is estimated based on the business trend in the industry of medical aesthetic operation, historical average spending per client and client cover, taking into account the number of treatment rooms in each medical aesthetic centre, centre locations, market conditions and economic outlook.

The exercise period of the share options granted is determinable by the directors, and shall not exceed ten years from the date of offer of the share options.

The exercise price of share options is determinable by the directors, but may not be less than the higher of (i) the closing price of the Company's shares as stated in the Stock Exchange's daily quotation sheet on the date of offer; (ii) the average of the closing prices of the Company's shares as stated in the Stock Exchange's daily quotation sheets for the 5 trading days immediately preceding the date of offer; and (iii) the nominal value of a share of the Company on the date of offer.

### 35. Financial Risk Management Objectives and Policies

The Group's principal financial instruments comprise cash and cash equivalents, pledged time deposits and interest-bearing bank borrowings. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as trade receivables, financial assets included in prepayments, deposits, other receivables and other assets, trade payables, financial liabilities included in other payables and accruals, and lease liabilities, which mainly arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

#### Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's interest-bearing bank borrowings with floating interest rates. The Group does not use derivative financial instruments to hedge its interest rate risk. The Group mitigates this risk by closely monitoring the movements in interest rates and reviewing its available credit facilities and their utilisation regularly.

At the end of the reporting period, if the interest rates on bank borrowings had been 25 basis points higher/lower, which was considered reasonably possible by management, with all other variables held constant, the loss before tax for the year would have been increased/decreased by HK\$48,000 (2022: Nil) as a result of higher/lower interest expenses on bank borrowings.

#### Credit risk

The Group mainly transacts with recognised and creditworthy third parties. Receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

#### Maximum exposure and year-end staging

The tables below show the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 31 March. The amounts presented are gross carrying amounts for financial assets.

At the end of the reporting period, the Group had certain concentrations of credit risk as 61% (2022: 52%) and 84% (2022: 89%) of the Group's gross trade receivables were due from the Group's largest debtor and five largest debtors, respectively.

#### Liquidity risk

In order to manage liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The Group regularly reviews its major funding positions to ensure that it has adequate financial resources in meeting its financial obligations.
