**FURTHER UPDATE ON THE CAPITAL REORGANISATION AND
FURTHER REVISED EXPECTED TIMETABLE**

References are made to the announcements dated 19 January 2023, 6 February 2023, 12 May 2023 and 21 July 2023, and the circular of E&P Global Holdings Limited (the “**Company**”) dated 17 February 2023 (the “**Circular**”) in relation to, among others, the Capital Reorganisation. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

FURTHER REVISED EXPECTED TIMETABLE

As disclosed in the Circular, the Capital Reorganisation is conditional upon, among others, an order being made by the Court confirming the Capital Reorganisation and compliance with any conditions which the Court may impose in relation to the Capital Reorganisation. The Company made announcements on 12 May 2023 and 21 July 2023 in relation to the expected timetable of the Capital Reorganisation.

The Board wishes to announce that pursuant to the directions given by the Court, the hearing of the petition for confirmation of the Capital Reduction will be held on Tuesday, 26 September 2023 (Cayman Islands time). Accordingly, the Board wishes to update the Shareholders on the further revised expected timetable for the Capital Reorganisation as follows (references below to times and dates are references to Hong Kong times and dates, except as otherwise specified):
