PROFIT WARNING

This announcement is made by FSM Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2023 (the “**Period**”) and other information currently available to the Board, it is expected that the Group would record a loss attributable to the owners of the Company in the range of approximately S\$10,000 to approximately S\$200,000 for the Period as compared to a profit attributable to the owners of the Company of approximately S\$1,800,000 for the corresponding period in 2022. The expected loss for the Period is primarily attributable to (i) decrease in revenue of our manufacturing business due to reduction in sales orders as a result of the slow-down of the economic growth; and (ii) increase in costs incurred in operating and developing mobile games from our online business.

As the Company is still in the process of finalising the Group’s interim results for the Period, the information contained in this announcement is only a preliminary assessment performed by the management of the Company based on the latest information currently available to the Board. Such information has not been audited by the Company’s auditors nor reviewed by the audit committee of the Company. As such, the actual interim results of the Group for the Period may be different from the information contained in this announcement. The interim results announcement of the Group for the Period is expected to be published in late August 2023 in accordance with the Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
