POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 21 AUGUST 2023

The board (the “**Board**”) of directors (the “**Directors**”) of Bright Smart Securities & Commodities Group Limited (the “**Company**”) is pleased to announce the voting results of the Annual General Meeting (the “**AGM**”) of the Company held on 21 August 2023. All the resolutions proposed at the AGM were duly passed by way of poll. Tricor Investor Services Limited, the Company’s branch share registrar in Hong Kong, was appointed by the Company as the scrutineer for the vote-taking at the AGM.

Voting Results of the AGM

As at the date of AGM, the total number of issued shares in the Company was 1,697,296,308 shares, which was the total number of shares in the Company entitling the holders to attend and vote on the resolutions at the AGM. There was no share of the Company entitling the holders to attend and abstain from voting in favour of any resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), and no shareholder of the Company (the “**Shareholders**”) was required under the Listing Rules to abstain from voting at the AGM. No party has stated its intention in the circular of the Company dated 17 July 2023 (the “**Circular**”) to vote against or to abstain from voting on any resolutions at the AGM. The Directors including Mr. Hui Yik Bun, Mr. Yu Yun Kong, Mr. Szeto Wai Sun, Mr. Ling Kwok Fai, Joseph and Ms. Wong Ting Ting, Priscilla attended the AGM in person; while Mr. Yip Mow Lum and Mr. Chan Wing Shing, Wilson did not attend the AGM due to other engagement.
