Remarks: The "No. of shares" and "Issued shares as a % of existing number of issued shares before relevant share issue" represented the Conversion Shares that were convertible from the opening balance of Bonds before the above redemption and the Conversion Shares that were convertible from the Outstanding Bonds as a percentage of the total number of Conversion Shares that were convertible from the Bonds before the above redemption issued respectively, while there were no actual

shares redeemed. The Outstanding Bonds were convertible to 972,844 Conversion Shares. The "issue price per share" represented the average redemption price per Conversion Share. The conversion price of HKD12.5630 and exchange rates of EUR1.00 = HKD8.7299 were used for calculation.

The "Price per share or highest price paid" and "Lowest price paid" represented the average redemption price per Conversion Share that was convertible from the Outstanding Bonds. The redemption price was EUR104,841.68 for every EUR100,000 principal amount of Bonds pursuant to the redemption notice served to the bondholders on 26 July 2023, being a total sum of EUR1,467,783.52 for the Outstanding Bonds and EUR1.5088 per Conversion Share.
