**FURTHER DELAY IN DESPATCH OF CIRCULAR IN RESPECT OF  
CONTINUING CONNECTED TRANSACTION**

References are made to the announcements of Tat Hong Equipment Service Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) dated (i) 28 July 2023 in respect of the continuing connected transaction under the 2023 Yongmao Master Agreement; and (ii) dated 12 September 2023 in respect of the delay in despatch of circular (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

As set out in the Announcements, it was expected that a circular containing, among others, (i) further details of the 2023 Yongmao Master Agreement and the transaction contemplated thereunder (including the Annual Caps); (ii) a letter of recommendation from the Independent Board Committee to the Independent Shareholders in relation to the 2023 Yongmao Master Agreement and the transactions contemplated thereunder (including the Annual Caps); (iii) a letter from the Independent Financial Adviser containing its advice to the Independent Board Committee and the Independent Shareholders in relation to the 2023 Yongmao Master Agreement and the transactions contemplated thereunder (including the Annual Caps); and (iv) a notice convening the EGM, will be despatched by the Company to the Shareholders on or before 28 September 2023.

As additional time is required for finalising the translation and logistic arrangement of the circular, the Company expects that the despatch of the circular will be postponed to a date falling on or before 13 October 2023.
