POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING HELD ON 11 OCTOBER 2023

The Board hereby announces that all the proposed ordinary resolutions set out in the EGM Notice were duly passed by the Independent Shareholders by way of poll at the EGM held on 11 October 2023.

References are made to the joint announcement of Sino-Ocean Service Holding Limited (the "**Company**") and Sino-Ocean Group Holding Limited dated 21 July 2023, the circular of the Company dated 25 September 2023 (the "**Circular**") and the notice of the extraordinary general meeting of the Company dated 25 September 2023 (the "**EGM Notice**") in relation to the entering into of the Assets Transfer Framework Agreements. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise defined.

The Board hereby announces that all the proposed ordinary resolutions set out in the EGM Notice were duly passed by the Independent Shareholders by way of poll at the EGM held on 11 October 2023 at Meeting Room, 2nd Floor, Tower A, No. A518 East Road of Chaoyang Sports Center, Chaoyang District, Beijing, PRC.

As at the date of the EGM, the total number of issued Shares was 1,184,000,000 Shares. As stated in the Circular, in view of their interests in the transactions as contemplated under the Assets Transfer Framework Agreements, Shine Wind and its associates (which held 822,282,500 Shares in aggregate, representing approximately 69.45% of the total number of issued Shares as at the date of the EGM) were required under the Listing Rules to abstain and had abstained from voting at the EGM on all the proposed ordinary resolutions as set out in the EGM Notice to avoid any conflict of interest. Accordingly, the total number of Shares entitling the Independent Shareholders to attend and vote for or against the proposed ordinary resolutions as set out in the EGM Notice at the EGM was 361,717,500 Shares.

None of the Shares entitled the Shareholders to attend the EGM and abstain from voting in favour of the proposed resolutions as set out in rule 13.40 of the Listing Rules. Save as disclosed above, no Shareholder was required under the Listing Rules to abstain from voting at the EGM, and no party has stated its intention in the Circular that it would vote against any resolution or that it would abstain from voting at the EGM.

All the resolutions as set out in the EGM Notice, which were voted by poll, were duly passed by the Independent Shareholders at the EGM. The poll results in respect of the resolutions proposed at the EGM were as follows:
