PROPOSED DECLARATION OF INTERIM DIVIDEND OF RMB0.238 PER ORDINARY SHARE (BEFORE TAX) FOR THE SIX MONTHS ENDED 30 JUNE 2023" in the Circular, the register of members of the Company for H Shares would be closed from Friday, 3 November 2023 to Friday, 10 November 2023, both days inclusive, during which period no transfer of H Shares will be registered. The record date for entitlement of H Shareholders to the 2023 Interim Dividend is Friday, 10 November 2023. In order to qualify for receiving the 2023 Interim Dividend, all transfer documents must be lodged with the Company's H share registrar in Hong Kong, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong (for holders of H Shares), for registration before 4:30 p.m. on Thursday, 2 November 2023.
