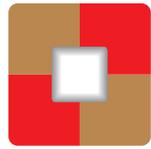

## VOLUNTARY ANNOUNCEMENT

This announcement is made by China Development Bank Financial Leasing Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis.

Reference is made to the Group’s 2022 annual report in relation to the termination of leasing of certain aircraft with Russian airlines and relevant financial treatment.

Reference is also made to the voluntary announcement made by the Company on 12 October 2023 in relation to the receipt of certain insurance settlement amount by the Group.

On 22 December 2023, certain wholly-owned subsidiaries of CDB Aviation Lease Finance Designated Activity Company (“**CDB Aviation**”), a wholly-owned subsidiary of the Company, received an insurance settlement amount of approximately RMB145 million from Limited Liability Company “Insurance Company NSK” (“**NSK**”), a Russian insurance company, in respect of one aircraft previously leased to JSC Siberia Airlines.

The insurance settlement and receipt of the settlement proceeds from NSK were carried out in full compliance with all applicable laws, sanctions and regulations.

CDB Aviation will continue to actively pursue its litigation in the Irish courts under its own insurance policies with other insurers. CDB Aviation will also continue its efforts to seek to mitigate its losses in respect of its aircraft that were previously leased to other Russian airlines.
