If the Company does not receive a duly completed and signed Reply Form or receive a response indicating the objection from you by 26 January 2024 and until you inform the Company c/o the Registrar, by reasonable prior notice in writing, you will be deemed to have consented to the Website Option and notifications of the publication of the Corporate Communications on the Company's website will be sent to you in future by post or by email.

If you elect to access and accept the Website Option of all future Corporate Communications in place of receiving the printed version(s), you are requested to provide an email address in the Reply Form for the purpose of receiving (i) future notification letters for the publication of Corporate Communications on the Company's website ("Notification Letters"); and (ii) all future actionable corporate communications? ("Actionable Corporate Communications") of the Company in electronic form by email. If no functional email address is provided by you in the Reply Form, the Company will send you such Notification Letters and Actionable Corporate Communications in printed form, until such time when you have provided a functional email address to the Company for receiving the same.
