Electronic Dissemination of Corporate Communications

- (1) to receive an email notification of the publication of the Corporate Communications on the Company’s website at www.pico.com and the website of The Stock Exchange of Hong Kong Limited at www.hkexnews.hk (collectively the “**Websites**”) (the “**Email Option**”); or
- (2) to receive a printed notification letter of the publication of the Corporate Communications on the Websites.

The Company is making these arrangements with a view to increasing efficiency, cost-effectiveness and protecting the environment and accordingly recommends you to elect for the Email Option and provide a valid email address to the Company.

To make your election, please mark (✓) in the appropriate box on the enclosed Reply Form, and fill in the necessary information and then sign and return it by email to 752-corpcomm@unionregistrars.com.hk or by post or by hand to the Company c/o the Company’s Hong Kong share registrar, Union Registrars Limited (the “**Hong Kong Share Registrar**”) at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King’s Road, North Point, Hong Kong. If you post the Reply Form within Hong Kong, you may use the mailing label at the bottom of the Reply Form and need not affix a stamp. Otherwise, please affix an appropriate stamp.

If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by February 9, 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Share Registrar at the above address or by email to 752-corpcomm@unionregistrars.com.hk, to have elected to receive printed notification letter of the publication of the Corporate Communications. In future, when the Company publishes any Corporate Communication on the Websites, it will only send to you a notification letter that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a valid email address) or by post (if you have not provided an email address or the email address is invalid) at your address as it appears in the Company’s register of members maintained by the Hong Kong Share Registrar.

Actionable Corporate Communications ^(Note) are sent to you individually and in electronic form if valid email addresses have been provided to the Company. If no valid email address has been provided, an actionable Corporate Communication will be sent to you in hard copy form. Please be reminded to provide valid email addresses to the Company’s Hong Kong Share Registrar to receive Corporate Communications in a timely and sustainable manner.

You may at any time send your request in writing to the Company (c/o its Hong Kong Share Registrar at the above address or by email to 752-corpcomm@unionregistrars.com.hk) to request for printed copy of the Corporate Communications. If you have received notification of the publication of the Corporate Communications on the Websites and for any reason have difficulty in gaining access to the Corporate Communications on the Websites, the Company will upon request send the Corporate Communications to you in printed form free of charge. For the details of arrangement regarding request for printed copy of the Corporate Communications, please visit the Company’s website.

It is the responsibility of the shareholders of the Company to provide email address that is functional. If the Company does not possess the email address of a shareholder of the Company or the email address provided is not functional, the Company will act according to the above arrangements. The Company will be considered to have complied with the Listing Rules if it sends Corporate Communications to the email address provided by a shareholder of the Company without receiving any "non-delivery message".
