Reference is made to the announcement of Tongda Hong Tai Holdings Limited (the “**Company**”) dated 12 January 2024 in relation to, among other things, the Share Consolidation, the Change in Board Lot Size, the Increase in Authorised Share Capital and the Rights Issue (the “**Announcement**”). Capitalised terms used herein shall have the same meanings as those defined in the Announcement unless the context requires otherwise.

DELAY IN DESPATCH OF THE CIRCULAR

As disclosed in the Announcement, a circular including, among other things, details of (i) details of the Share Consolidation; (ii) details of the Increase in Authorised Share Capital; (iii) further information regarding the Rights Issue and the transactions contemplated thereunder; (iv) a letter of recommendations from the Independent Board Committee to the Independent Shareholders in respect of the Rights Issue; (v) a letter of advice from the Independent Financial Adviser to the Independent Board Committee and the Independent Shareholders in respect of the Rights Issue; (vi) other information required under the Listing Rules; and (vii) the notice of the EGM will be despatched to the Shareholders on or before 24 January 2024.

As additional time is required to finalise certain information contained in the Circular in relation to the Rights Issue, it is expected that the despatch date of the Circular will be postponed to a date on or before 21 February 2024 and the closure of register of members of the Company will be changed accordingly.
