Remarks:

Dekon Food and Agriculture Group (the "Company") has received the filing notice from the China Securities Regulatory Commission and the approval from The Stock Exchange of Hong Kong Limited (the "Stock Exchange") of the conversion of 61,944,501 domestic shares of the Company (the "Domestic Shares") into H shares of the Company (the "H Shares") and their listing on the Stock Exchange, as disclosed in the announcements of the Company dated 26 December 2023, 19 January 2024, 23 January 2024, respectively. The relevant conversion was completed on 30 January 2024, as disclosed in the announcement of the Company dated 30 January 2024. The listing of the converted H Shares on the Stock Exchange commences on 31 January 2024.

The opening balance as at 31 December 2023 was 66,119,684 H Shares and 322,755,952 Domestic Shares, amounting to a total of 388,875,636 issued shares of the Company. Following the conversion, the H Shares increased by 61,944,501 shares, while the Domestic Shares decreased by 61,944,501 shares. The total number of issued shares of the Company after the conversion remains unchanged, comprising 128,064,185 H Shares and 260,811,451 Domestic Shares.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
