TERMINATION OF SUBSCRIPTION AGREEMENTS

The Board announces that, after further negotiation and discussion, the Subscribers were unable to carry out their respective obligations under the Subscription Agreements, taking into account (among other matters) the current market condition, the Company and each of the Subscribers have decided not to proceed with the Subscriptions.

Taking into consideration of the above, on 1 February 2024, the Company entered into a deed of termination with each of the Subscribers, pursuant to which the Company and each of the Subscribers agreed that the relevant Subscription Agreement shall be terminated and shall cease to be of any further force or effect immediately and each of the Company and the relevant Subscriber released and discharged each other from its present and future obligations, liabilities, losses, damages, demands, claims, suits or actions of whatsoever nature arising from or in any way relating to each of the relevant Subscription Agreement.

The Directors consider that the termination of the Subscription Agreements will not have any material adverse impact on the business operation and financial position of the Group.
