among which Subsidiary Wind Farms Increased by 1.5%,
Photovoltaic Plants Increased by 224.6%**

Total net generation of subsidiary power plants in January 2024 increased by 28.9% year on year to 18,901,457 MWh, among which, subsidiary wind farms increased by 1.5% year on year to 3,738,996 MWh, subsidiary photovoltaic plants increased by 224.6% year on year to 388,962 MWh.
