It is therefore expected that the change of auditor will not have any material impact on the annual audit and the release of annual results of the Group for financial year ending 31 March 2024.

APPOINTMENT OF AUDITOR

The Board, with the recommendation from the Audit Committee, has resolved to appoint CWK CPA Limited ("CWK") as the auditor of the Company with effect from 29 February 2024 to fill the casual vacancy following the resignation of BDO and to hold office until the conclusion of the next annual general meeting of the Company. The Board has the power to fill any casual vacancy in the office of auditor and to fix the remuneration of the auditor so appointed. Accordingly, no extraordinary general meeting will be held for such purpose.

The Audit Committee has considered a number of factors in assessing the appointment of CWK, including but not limited to (i) experience, knowledge, technical competence, and caliber of CWK in handling audit work for listed companies; (ii) the audit proposal and audit plan of CWK; (iii) CWK's independence from the Group and objectivity; (iv) CWK's market reputation; (v) CWK's resources and capability to complete the audit work within the stipulated schedule; and (vi) the relevant guidelines and guidance notes issued by the Accounting and Financial Reporting Council.

Based on the above, the Audit Committee has assessed and considered CWK is eligible and suitable to act as the auditor for the annual audit of the Company for the year ended 31 March 2024. The Board and the Audit Committee are of the view that the change of auditor would enhance the cost-effectiveness of the Company's annual audit and is in the interest of the Company and the Shareholders as a whole.

The Board welcomes to the appointment of CWK as the new auditor of the Company.
