Please refer to (a) the online versions to be published on the Company's website and the website of the Stock Exchange for all Corporate Communications (a notification of the publication of Corporate Communications will be sent to you by email or by post on the publication date of the Corporate Communications (only if the Company does not possess a functional email address of a shareholder of the Company (the "Shareholder(s)")); or (b) the electronic form of actionable corporate communications (the "Actionable Corporate Communications") to be received by email (as the case may be) (the "Electronic Version"), which means any Corporate Communications that seek instructions from the Shareholders on how they wish to exercise their rights or make elections as the Shareholders.

You are therefore requested to provide your email address in the enclosed reply form (the "Reply Form"). If no functional email address is provided by you in the Reply Form, the Company will send you such notification of the publication of Corporate Communications in printed form, until such time when you have provided a functional email address to the Company for receiving the same. In cases of Actionable Corporate Communications, if the Company does not possess the email address of a Shareholder or the email address provided is not functional, the Company will send the Actionable Corporate Communications in printed form together with a Request Form for soliciting your functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future. You are reminded to use legible handwriting if you are filling in your email address in a paper form using handwriting.

Alternatively, if you wish (a) to receive the printed English version ONLY for all future Corporate Communications and Actionable Corporate Communications by mail; or (b) to receive the printed Chinese version ONLY for all future Corporate Communications and Actionable Corporate Communications by mail; or (c) to receive both the printed English and Chinese versions of all future Corporate Communications and Actionable Corporate Communications (up to the time when the Company publishes its annual report in the following year) by mail, please complete the Reply Form and send it to the Company c/o the Company's Hong Kong branch share registrar and transfer office (the "Share Registrar"), Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong.

To make your election, please mark "X" in the appropriate box on the Reply Form and sign and return it by post using the mailing label at the bottom of the Reply Form (a stamp is not needed if posted in Hong Kong; otherwise, please affix an appropriate stamp), or delivery to the Share Registrar, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong.

You are entitled to change the choice of language and/or means of receipt of the Corporate Communications and Actionable Corporate Communications at any time by notice in writing to the Share Registrar or by email to the Company at cgservices-ecom@hk.tricorglobal.com. If you have elected (or are deemed to have consented) to receive the Electronic Version of the Corporate Communications, and if for any reason, you have difficulty in accessing the Corporate Communications and Actionable Corporate Communications via the Company's website, or have failed to receive the Actionable Corporate Communications by email the Company or the Share Registrar will upon your request, promptly send the requested Corporate Communications and Actionable Corporate Communications to you in printed form free of charge.

Your request for the printed copy of future Corporate Communications and Actionable Corporate Communications issued by the Company will remain valid until the instruction has been revoked or superseded or until the time when the Company publishes its annual report in the following year (whichever is earlier). If you wish to continue receiving printed copies of future Corporate Communications and Actionable Corporate Communications, you should complete and submit a new Reply Form to the Share Registrar.

Please note that (a) printed copies of the Chinese and English versions of all the Corporate Communications and Actionable Corporate Communications will be available from the Company or the Share Registrar upon request; and (b) the Electronic Version of all the Corporate Communications and Actionable Corporate Communications in both Chinese and English will be available on the Company's website at http://www.bgyfw.com and the website of the Stock Exchange at http://www.hkexnews.hk.
