**In the First Two Months of 2024,
Net Generation of Subsidiary Power Plants Increased by 7.4%,
among which Subsidiary Wind Farms Increased by 9.3%,
Photovoltaic Plants Increased by 201.9%**

Due to the Chinese New Year holiday, total net generation of subsidiary power plants in February 2024 decreased by 12.6% year on year to 13,742,685 MWh, among which, subsidiary wind farms increased by 18.8% year on year to 3,553,353 MWh, subsidiary photovoltaic plants increased by 179.5% year on year to 338,892 MWh.

Total net generation of subsidiary power plants for the first two months of 2024 increased by 7.4% year on year to 32,644,142 MWh, among which, subsidiary wind farms increased by 9.3% year on year to 7,292,349 MWh, subsidiary photovoltaic plants increased by 201.9% year on year to 727,854 MWh.
