COMPLETION OF PLACING OF NEW SHARES UNDER GENERAL MANDATE

Reference is made to the announcements of Huakang Biomedical Holdings Company Limited (the “**Company**”) dated 9 February 2024, 14 February 2024 and 5 March 2024 (the “**Announcements**”) in respect of the Placing. Unless defined otherwise, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

COMPLETION OF THE PLACING

The Board is pleased to announce that the conditions of the Placing have been fulfilled and Completion took place on 21 March 2024. A total of 31,000,000 Placing Shares have been successfully placed by the Placing Agent to not less than six Placees at the Placing Price of HK\$0.104 per Placing Share pursuant to the terms and conditions of the Placing Agreement. The net proceeds from the Placing (after deduction of commission and other expenses of the Placing) amount to approximately HK\$3.18 million, which will be utilised for general working capital of the Group for its operations outside of the PRC.

The Placing Shares represent approximately 7.07% of the existing issued share capital of the Company immediately before completion of the Placing and approximately 6.60% of the issued share capital of the Company as enlarged by the Placing Shares. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiry, the Placees and their respective ultimate beneficial owners are Independent Third Parties. None of the Placees has become a substantial Shareholder (as defined in the GEM Listing Rules) upon Completion.
