If the Company does not receive your functional email address from your Intermediaries via HKSCC Nominees Limited, (i) no Notice of Publication will be sent to you by email; (ii) you will need to proactively check the Company's website and the HKEXnews website to keep up with the publication of the Website Version of Corporate Communications; and (iii) the Company will send the Notice of Publication in printed form in the future (if the Company has received your postal address from your Intermediaries).
