The above receivables are: (i) generated in the daily operations of the Group; (ii) arising from the transactions conducted on normal commercial terms; (iii) repaid based on the progress of project sales, and the repayment method is mainly based on funds obtained from project sales, with the completion date of the project as the due date; and (iv) primarily funded by the internal resources of the Company, with diversified channels for financing;
- 2. The Group invest in the associates and joint ventures with the cooperation parties in proportion to their shareholding. The commercial terms of amounts due from associates and joint ventures of the Company are the same as those of the other shareholders of such companies, either interest-free or ranging between Hong Kong Prime Rate minus 3.5% p.a. and 9.5% p.a. based on market interest rates. As at 31 December 2023, the balance of the receivables bearing interest at the market interest rate is RMB21,612.5 million, and the interest collected in 2023 is RMB907.7 million. There is no collateral for the Group's receivables from its associates and joint ventures;
 - 3. As at 31 December 2023, the Group has not made any commitment to inject capital into its affiliates;
- 4. As at 31 December 2023, the cap of the financing amount under the financing agreements of the affiliates still in existence and guaranteed by the Group was approximately RMB387 million, and the balance of the guarantees provided by the Group based on the actual withdrawal amount of the affiliates amounted to approximately RMB130 million. As at 31 December 2023, the Group have not fulfilled any payment obligations under guarantees provided in

relation to the financing agreements of the affiliated companies, and if such obligations need to be fulfilled, the sources of funding would be mainly from internal resources of the Company, with diversified channels for financing.
