CORPORATE PROFILE 公司簡介

Maoye International Holdings Limited (the "Company") was incorporated in the Cayman Islands with limited liability on 8 August 2007. The Company and its subsidiaries (the "Group") are principally engaged in the operation and management of department stores and property development in the People's Republic of China (the "PRC"). The shares of the Company were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 5 May 2008 (the "Listing Date").

With a unique operation model of "retail + commercial property", the Group has been growing rapidly since its establishment, and has achieved scale expansion across the country by duplicating this model. Supported by lands acquired at low costs, the Group uses its physical retail to nurture property, building a closed ecological cycle in which its core business supplements and supports each other.

Since Shenzhen Dongmen store, the first store of the Group, opened in 1997, the Group has been concentrating on development and careful planning for over 20 years, and leveraging its strong competitiveness and reform and innovation keeping pace with times, the leading position of the Group in Southern China has been strengthened step by step. The Group has also further expanded into the most developed markets with the fastest growth rate in Eastern China, Southwestern China and Northern China, becoming the industry leader in numbers of regions. As at 31 December 2023, the Group had 49 stores with total gross floor area of approximately 3.1 million sq.m., of which self-owned properties accounted for 78.1% in gross floor area. The major cities under its coverage include Shenzhen and Zhuhai in Guangdong; Chengdu, Nanchong and Mianyang in Sichuan; Chongging; Wuxi, Yangzhou, Taizhou, Nanjing and Huai'an in Jiangsu; Zibo, Laiwu and Heze in Shandong; Qinhuangdao and Baoding in Hebei; Shenyang and Jinzhou in Liaoning; Taiyuan in Shanxi; and Hohhot and Baotou in Inner Mongolia.

The Group actively grasps the development trend of medium-to-high end commercial retail in China, leverages the Group's years of experience in operation and brand resource advantages of strategic cooperation, empowers innovation, integrates online and offline business development, deeply cultivates consumer experience and technology applications, and strives to achieve the transformation from traditional department store retail to new retail business model.

茂業國際控股有限公司(「本公司」)為於2007年8月8日在開曼群島註冊成立的有限責任公司。本公司及其附屬公司(「本集團」)主要在中華人民共和國(「中國」)經營及管理百貨店和物業發展業務。本公司之股份於2008年5月5日(「上市日」)在香港聯合交易所有限公司(「聯交所」)主板上市。

本集團自成立以來,以獨有的「零售+商業地產」模式迅速崛起,並在全國範圍內實現規模 化複製擴張。本集團以低成本拿地鋪路,實 體零售商業反哺,打造核心業務互補互助的 生態閉環。

自1997年第一家門店深圳東門店開業以來,本集團歷經20多年潛心發展及審慎佈局,憑藉自身強大的競爭力及與時俱進的改新,逐步夯實於華南區域的領先地位,並取入拓展至中國經濟最發達、發展速度最快的區域內的行業龍頭。截至2023年12月31日,本集團擁有門店數達49家,總建築面積約3.1日萬平方米,其中自有物業面積佔比達78.1%,覆蓋的重點城市包括廣東深圳和珠海;四川、泰州、南京和淮安;山東淄博、萊蕪和菏澤;成都、南京和淮安;山東淄博、萊蕪和菏澤;对北秦皇島和保定;遼寧瀋陽和錦州;山西,以及內蒙古呼和浩特和包頭。

本集團積極把握中國中高端商業零售的發展 趨勢,借助集團運營多年經驗與戰略合作的 品牌資源優勢,賦能創新,融合線上線下的 業務發展,深耕消費者體驗與技術應用,努 力實現商業模式由傳統百貨零售向新零售的 戰略轉型。





CHAIRMAN'S STATEMENT

董事長報告書

In 2023, we have witnessed continued recovery in domestic macro economy and a rise in retail sales after the lift of anti-pandemic measures, despite complexity in the global geopolitical and economic landscape. During the reporting period in 2023, with increased macro financial measures and positive fiscal policies in hope of stimulating domestic demands and consumption, the domestic market gathered momentum and was well on track back to an organic growth model. According to the National Bureau of Statistics, China's 2023 GDP was RMB126 trillion, up 5.2% yoy, falling within the target range for the year. Driven by policy, consumption grew marginally in the first half but was subdued towards the end of the year as commodity consumption slowed down. During the period, high-end catering and automotive were among the first to rebound as retail sales grew. Looking ahead to 2024, despite a challenged and uncertain domestic environment, we will seek and maintain progressive growth leveraging the nation's supportive policies and gather new momentum with new drivers, over the expectation of a healthy economic growth.

With COVID-19 finally coming to an end, as well as the advancement and latest development in technology, the world of commercial and retail sales has been changing. As consumers nowadays emphasize quality over quantity, and are now after products or services with good value, they shop less and therefore consumption shrank in general after the pandemic. We also saw a more diversified landscape in retail, as consumers now go to an integrated online-offline model in pursuit of a more tailored shopping experience. In the face of these new market challenges, opportunities and the more diversified needs ahead, the Group, on one hand, continues to step up its effort in optimizing our strategy and priorities and also in the provision of more options with higher quality, based on the Group's strategy and positioning, and taking into account the features of different sales regions. On the other hand, the Group invested more in digitalization and automation, for the sake of a complete online-offline and two-way integration for higher operational efficiency, as well as a sound and sustainable development ecology.

After more than 20 years of rapid development, the Group, as an established player in the department store and retail sector, has built a complete supply chain, unparalleled edge in property services and modern management practical experiences. The Group has been able to maintain a unique competitive edge over its peers and progressive growth in the up and downs and in times of changes and challenges facing the economy and the sector. As of the end of 2023, the Group has 49 stores nationwide. Further analyzed by the type of stores, the Group has 19 shopping centers, 27 department stores and 3 outlets. The prime business districts where our stores are located and the traffic, together with the reputation of these locations, are ramping up the positive publicity for our stores and brands.

2023年,國際政治和經濟環境依舊錯綜復 雜,國內宏觀經濟隨著疫情防控的全面放開 而呈現出復甦態勢,消費亦迎來了一波恢復 式的增長。期內(2023年報告期內),國家加 大財政宏觀調控力度,實施積極的財政政 策,擴內需、促消費助力國內經濟逐步步入 正軌,增長動能逐步切換,助推經濟重回內 生增長軌道。根據國家統計局的數據,2023 年國內生產總值(GDP)126萬億元,同比增長 5.2%,完成年度增長目標。在政策推動下, 消費於上半年呈現恢復式增長,於下半年顯 現疲弱,商品消費增速放緩。期間,中高端餐 飲及汽車行業率先反彈,在期內迎來一波銷 售增長。展望2024國內經濟,雖面臨挑戰與 不確定性,仍將在政策支持下穩中求進,以 進促穩,先立後破,實現新舊動能轉換,經濟 平穩回升向好可期。

CHAIRMAN'S STATEMENT

In 2023, JW Marriott Hotel Chengdu, a subsidiary of the Group, seized the opportunities in the market, adhered to the quality of JW brand services, adopted the strategy of flexible pricing and dedicated brand services, and achieved a breakthrough among its international peer group in Chengdu and other hotels in the central and western regions under JW Marriott's umbrella. In 2023, the Company's revenue from hotel operations increased by 50.8% year-on-year, hitting a record high. At the same time, the Group's JW Marriott Hotel Taiyuan had also been preparing for its grand opening in the Lantern Festival in 2024.

Looking ahead to 2024, the recovery in consumption is expected to be optimistic as macroeconomic recovery remains positive. The Group will continue to focus on its principal business, take commercial retail business as the core, continue to optimise its operations across the board, pursue progress while maintaining stability, and actively leverage the overall recovery of the retail industry. The Group will seize the opportunities in consumption space and business recovery and development, adhere to high-quality operation and lean management and services, continue to deepen the Group's diversified and cross-regional collaborative development, actively promote the transformation of storeto-shopping centers and community life centers and the construction of new stores, continue to improve the Group's overall capabilities, brand influence and core competitiveness, and achieve sustainable and highquality development for the Group. At the same time, the Group will get with the times and keep up with its development, adhere to the practice and innovation of comprehensive digital intelligence, continue to develop and iterate digital infrastructures, actively expand into new areas of business growth, continue to forge new core advantages of the Company, consolidate the Group's diversified business ecology, and inject more vitality into the long-term quality development of the Group.

Finally, on behalf of the Board, I would like to thank all of our employees for their dedication and to express my gratitude to our shareholders and customers.

I. MACROECONOMIC OVERVIEW

2023 continued to see a mixed political and economic environment in a global context. Domestic economy improved with the full release of pandemic controls, with the momentum of consumption recovery moderating after reaching its peak. Domestic economy, however, has demonstrated strong resilience amid challenges in recovery. Since the beginning of this year, the nation continued to adopt a progressive strategy across all regions and departments while pursuing stability, and with our focus on expanding domestic demand and optimised structures, economic recovery picked up marginally towards high-quality development. According to Economic Daily, in 2023, China's GDP reached RMB126 trillion, representing a year-on-year increase of 5.2% at constant prices. Total retail sales of social consumer goods for the year amounted to RMB47.1 trillion, representing a year-on-year increase of 7.2%. In 2023, retail services continued to recover rapidly and outperformed, growing at a year-on-year rate of 20.0%, compared with the 14.2% posted by retail sales of goods for the same period. Online consumption grew rapidly, with online retail sales of physical goods increased by 8.4% year-on-year, accelerating by 2.2% year-on-year, and accounting for 27.6% of total social retail sales, a 0.4% increase over the same period last year. During the year, retail sales of physical stores also continued to recover, with retail sales of physical stores above designated size increased by 5.0% as compared with the same period last year. In general, the overall domestic economy showed a trend of balanced and stable recovery, as efforts in expanding domestic demand and promoting consumption and value creation have started to surface.

2024 is a year where we expect to witness macro stability and micro improvement, progress amid stability, and the replenishment of new drivers and momentum. In 2024, the growth momentum of domestic demand will transition towards a sustainable model subsequent to the pandemic. With the introduction of a dual-wheel drive of fiscal and monetary policies, the government expects the expansionary fiscal and monetary easing policies could effectively promote sustainable consumption and investment growth in the domestic market. In 2024, we are aiming to make progress while maintaining stability, and resume a growth profile model ultimately.

2023年,國際政治經濟環境依然錯綜復 雜,國內經濟隨疫情防控的全面放開而 逐步復甦,消費復甦動能見頂後有所降 溫,恢復面臨挑戰,國內經濟仍顯示較強 韌性。今年以來,全國各地區各部門堅 持穩中求進,聚力擴大內需、優化結構、 經濟復甦態勢平穩回升,高質量發展獲 得成效。據經濟日報,2023年,國內生產 總值達人民幣126萬億元,按不變價格計 算,同比增長5.2%;全年社會消費品零售 總額實現人民幣47.1萬億元,同比增長 7.2%。2023年,服務零售持續較快恢復, 表現相對突出,比上年同期增長20.0%, 增速高於同期商品零售額14.2%;線上 消費增長較快,實物商品網上零售同比 增長8.4%,增速同比加快2.2%,佔社零 總額27.6%,佔比較同期提升0.4%;本年 度,實體店鋪零售亦持續恢復向好,限額 以上零售業實體店商品零售額較上年同 期增長5.0%。總體而言,國內經濟總體 呈現平穩恢復態勢,擴內需,促消費亟待 持續發力。

展望2024年,宏觀平穩、微觀改善、穩中求進、先立後破,實現新舊動能轉換。2024年,內需增長動能將自疫情後恢復向可持續增長結構轉換,國家出臺財政貨幣政策雙輪驅動,期待財政擴張和貨幣寬松政策共同有效促進可持續的消費和投資內需增長。2024年,穩中求進,穩步恢復增長可期。

II. OPERATIONAL REVIEW

For the year ended 31 December 2023, the Group operated and managed a total of 49 stores in 21 cities nationwide with gross floor area of approximately 3.1 million sq.m., of which operating area attributable to self-owned properties accounted for 78.1% (including gross floor area leased from related parties, 84.5%). Coverage of key cities included Shenzhen and Zhuhai in Guangdong; Chengdu, Nanchong and Mianyang in Sichuan; Chongqing; Wuxi, Yangzhou, Taizhou, Nanjing and Huai'an in Jiangsu; Zibo, Laiwu and Heze in Shandong; Qinhuangdao and Baoding in Hebei; Shenyang and Jinzhou in Liaoning; Taiyuan in Shanxi; Hohhot and Baotou in Inner Mongolia. As at 31 December 2023, the distribution of stores of the Group was as follows:

MAJOR OPERATIONAL HIGHLIGHTS

 Continue to promote the strategy of transforming concessionaire sales to leasing, and adhere to the upgrading of business formats and content to improve core competitiveness

During the reporting period, the Group continued to promote the strategy of upgrading business formats and optimising store contents. In terms of the adjustment to business types and operating contents, the Group continued to deepen the transformation of concessionaire sales to leasing and department stores to shopping centers. At the same time, combined with the Group's positioning and characteristics of regional markets, in terms of business contents, the proportion of retail services has been increased, with the addition of emerging business formats and product categories such as catering support, night economy, sports, contemporary tea culture and modern lifestyle. At the same time, the Group focused on the creation of diversified consumption scenarios, providing customers with more emotional value, and was committed to deepening and strengthening the emotional connection with customers, integrating online and offline services to improve customers' in-store experience and loyalty. and hence enhancing the commercial value of the Group.

During the reporting period, the Group's Huaqiangbei store achieved a 27.6% growth in rental income over the same period under the strategic steer from concessionaire sales to leasing. Besides, the addition of a unique mix of catering offering has contributed to a surge in both store traffic and performance.

2. Enhance brand awareness and selection of products

During the reporting period, the Group continued to promote the iteration, optimisation and upgrading of store contents in terms of brand and quality, and implemented it in an orderly and phased manner. In 2023, the Qinhuangdao Maoye Complex store introduced China fashion brands recommended by KOLs and best-selling products from first-to-region brands. high-end beauty brands, light luxury, luxury brands and luxury watches. The store achieved a double-digit growth again with our continued efforts in brand building and quality upgrading. establishing its leading position in the local department store retail industry in Qinhuangdao. With the continued influx of highquality affordable luxury brands, luxury brands and luxury watch dealers, as well as the presence of first-tier cosmetics brands, the Group's Taiyuan Maoye Complex store has transformed from a fashion and trendy shopping center to a high-end shopping center. At the same time, with the consumers' preference for big-health products post-pandemic, the Group also made targeted adjustments to the sports product categories of key stores, and introduced professional outdoor sports brands, professional sports and affordable luxury sports products with cost-effectiveness.

In addition, in terms of leasing strategy, the Group has conducted in-depth research on market trend and made precise layout, positioning and strategic adjustments to stores. While striving to achieve full occupancy and promoting store innovation, the Group has strengthened the national strategic alliance of brands, continued to introduce high-quality products and brands, introduced new business formats, and improved the effectiveness of leasing and operation. In terms of business adjustment, the Group continued to focus on the transformation and creation of stores to shopping centers and community life centers, adding experiential consumption scenarios, enhancing emotional connection with customers, enriching diversified business formats and leading lifestyles.

3. Promote the construction of digital intelligence, develop business through multiple channels, enhance digital management, and drive business growth

During the reporting period, the Group continuously developed and improved the Group's online marketing APPs such as "Mao Yue Hui" and "Mao Le Hui" with the aim of "digital retail and smart business". The Group continued to expand the depth and width of the Group's online business layout through digital applications such as WeChat official account, enterprise WeChat, and Tik Tok live-streaming.

The Group continued to follow new forms, new channels and new contents of marketing activities, and actively researched differentiated, trendy and youthful brand strategies in response to the consumption upgrading and consumption stratification trends in the current economic environment. In addition, the Group adheres to the interaction and innovation of online and offline marketing, strengthens the coordination and linkage of omni-channel marketing activities, in order to achieve two-way traffic attraction between online and offline. During the reporting period, the Group continued its in-depth integration of offline store sales with the online marketing APP "Mao Le Hui", promoted the functional integration and data interconnection of online APPs such as "Mao Yue Hui" and "Mao Lehui", and realized the synchronization of online and offline products.

During the reporting period, the Group's stores comprehensively promoted the live broadcast among sales team, carried out marketing activities with implemented overall marketing plans, improved cross-merchant marketing linkages, and enhanced the explosive power of marketing activities. At the same time, the stores have increased the promotion points of the online APP to help attract new fans. The functions of the online platform have also been continuously optimized and upgraded according to the ever-changing market trends, and constantly carried out innovative marketing activities and optimized online product functions. The WeChat mini-program "Mao Le Hui" increased its exposure through WeChat Moments advertising and attracted more than 2 million visits throughout the year. At present, there are more than 300 brands on "Mao Le Hui", among which the online sales of various brands including Lancome, SK-II, Shiseido, La Mer have exceeded RMB20 million annually. In 2023, sales across our online platform achieved RMB540 million.

3. 推進數智化建設,多渠道發展業務, 增強數字化管理,助力業務增長

報告期內,本集團繼續以「數字零售、智慧商業」為目標,不斷開發與完善本集團的「茂悅薈」、「茂樂惠」等線上營銷APP,並通過微信公眾號、企業微信、抖音直播等數字化應用,持續拓展本集團線上業務佈局的深度和廣度。

報告期內,本集團旗下門店全面推 進導購直播帶貨,各門店舉行營銷 達波活動,推行整體營銷方案,提高 跨商戶的營銷聯動,增強營銷活動 的爆發力。同時,各門店增加在線 APP的促點以提高拉新吸粉,在線平 台亦持續進行功能優化升級,並不 斷基於變化的市場趨勢和營銷動態 推陳出新,開展創新的營銷活動及 優化在線產品功能。「茂樂惠」微信小 程序通過微信朋友圈廣告投放的形 式增加曝光度,全年引流訪客超200 萬人次。目前,「茂樂惠」在售品牌超 過300個,其中蘭蔻、SKII、資生堂、 海藍之迷等多個品牌全年在線售賣 金額超過人民幣2,000萬元。2023 年,線上全平台銷售額達到人民幣 5.4億元。

As the main bridge for maintaining and communicating with members of the Group, the "Mao Yue Hui" membership management system has been continuously upgraded in various aspects during the reporting period. The membership management system has been further improved. All aspects of the membership management system have been connected through digital operation, and the data review and refined analysis of marketing costs have been achieved. During the reporting period, the Group continue to promote enterprise WeChat as a new channel for linking members, stores and brands, and achieved favorable member interaction effects. In 2023, the Group's "Mao Yue Hui" membership management system attracted 1.09 million new members. As of the end of 2023, the total number of members served by "Mao Yue Hui" reached 17.9 million people and the total consumption of members reached RMB4.25 billion.

4. Continue to innovate and promote multi-business development, and improve overall capabilities

In 2023, JW Marriott Hotel Chengdu, a subsidiary of the Company, seized the opportunities in the market, adhered to the quality of JW brand services, adopted the strategy of flexible pricing and dedicated brand services, and achieved a breakthrough among its international peer group in Chengdu and other hotels in the central and western regions under JW Marriott's umbrella. In 2023, the Company's revenue from hotel operations increased by 50.8% year-on-year, hitting a record high.

At the same time, the Group's JW Marriott Hotel Taiyuan had also been preparing for its grand opening in the Lantern Festival in 2024.

FINANCIAL REVIEW

Total Sales Proceeds and Rental Income

For the year ended 31 December 2023, total sales proceeds and rental income of the Group were RMB8,526.9 million, representing a decrease of 5.1% as compared to 2022, mainly due to the impact of the gradual transformation of the business model from department store direct sales and concessionaire store to the leasing of shopping centers, and the Group's same-store sales proceeds and rental income amounted to RMB8,453.2 million, representing a decrease of 5.2% as compared with that in 2022.

During the year ended 31 December 2023, among the total sales proceeds and rental income of the Group, total sales proceeds from concessionaire sales accounted for 69.1%, those derived from direct sales income accounted for 17.7%, and those derived from rental income accounted for 13.2%. For the year ended 31 December 2023, the Group's total sales proceeds from concessionaire sales were RMB5,890.2 million, representing a decrease of 8.5% as compared to 2022; direct sales income was RMB1,512.5 million, representing an increase of 0.7% as compare to 2022; rental income was RMB1,124.2 million, representing an increase of 6.9% as compared to 2022.

For the year ended 31 December 2023, sales of apparels (including men's and ladies' apparels) accounted for 27.3% (2022: 27.8%), jewelries accounted for 21.8% (2022: 22.9%), leisure and sports goods accounted for 12.2% (2022: 10.9%), cosmetics accounted for 19.4% (2022: 17.4%), shoes and leather goods accounted for 5.9% (2022: 5.1%), and others (including branded merchandise, children's items, bedroom and household goods, home appliances, supermarket and others) accounted for 13.4% (2022: 15.9%).

For the year ended 31 December 2023, revenue of the Group's main business amounted to RMB4,180.8 million, representing a reduction of approximately RMB168.9 million as compared to RMB4,349.7 million in 2022. The main reason for the decrease in revenue was attributable to the impact of the difference in the progress of delivery of property projects, resulting in a year-on-year decrease of RMB323.3 million in the Group's revenue from property sales for the period. On the other hand, revenue from retail business increased by RMB71.4 million year-on-year and revenue from hotel business increased by RMB94.5 million year-on-year.

截至2023年12月31日止年度,本集團的主營業務收入為人民幣4,180.8百萬元,較2022年人民幣4,349.7百萬元減少約人民幣168.9百萬元。收入減少的主要原因是受地產項目交付進度差異影響,致使本集團的本期物業銷售收入同比減少人民幣323.3百萬元。而零售業務收入同比增加人民幣71.4百萬元,酒店業務收入同比增加人民幣94.5百萬元。

管理層討論及分析

Other Income

For the year ended 31 December 2023, other income of the Group amounted to RMB1,125.5 million, representing an increase of RMB79.2 million as compared to RMB1,046.3 million in 2022. Other income mainly includes management fee income from franchised counters in stores, promotion income and credit card handling fee income. The amount of such income is generally linked to the sales level of the stores. Moreover, there was an increase in other income for the period as the income from government incentives received by the Group for the Chengdu North Railway Station demolition and relocation transaction in the amount of RMB78.8 million was included in other income.

Cost of Sales

For the year ended 31 December 2023, cost of sales of the Group amounted to RMB1,760.7 million, representing a decrease of 4.9% as compared to RMB1,851.0 million in 2022. The cost of sales mainly includes the cost of purchase of and changes in inventory in stores, as well as the cost of properties sold. Due to the decrease in cost of properties sold, the total cost of sales has decreased in the reporting period.

Employee Expenses

For the year ended 31 December 2023, employee expenses of the Group amounted to RMB414.3 million, representing a decrease of 8.9% as compared to RMB454.6 million in 2022, mainly due to the Group's continuous effort in reducing cost and improving human resources efficiency in 2023, which resulted in a year-on-year decrease in employee expenses.

Depreciation and Amortization

For the year ended 31 December 2023, depreciation and amortization of the Group amounted to RMB990.1 million, representing a decrease of 5.6% as compared to RMB1,049.2 million in 2022, mainly due to the completion of depreciation and amortization of the Group's certain store assets.

Other Operating Expenses

For the year ended 31 December 2023, other operating expenses of the Group amounted to RMB1,041.8 million, representing an increase of 3.1% as compared to RMB1,010.8 million in 2022. The increase in other operating expenses was mainly due to a decrease in utility expenses as a result of short-term closures or shortened operating hours of the Group's stores in various locations due to the spread of the COVID-19 epidemic in many domestic areas in 2022, and a year-on-year increase in utility expenses, such as water and electricity, as a result of the normal operation of the stores nationwide throughout the year in 2023.

其他收入

截至2023年12月31日止年度,本集團的其他收入為人民幣1,125.5百萬元,較2022年的人民幣1,046.3百萬元增加人民幣79.2百萬元。其他收入主要包括門店特許專櫃的管理費收入、促銷收入及信用卡手續費收入,該等收入的金額與門店銷售水平總體掛鈎,此外,由於本集團於成都北站拆遷交易中獲得的政府獎勵收入計入其他收入人民幣78.8百萬元,致使本期其他收入有所增長。

銷售成本

截至2023年12月31日止年度,本集團的銷售成本為人民幣1,760.7百萬元,較2022年的人民幣1,851.0百萬元減少4.9%。銷售成本主要包括門店銷售商品的存貨採購及其變動成本以及房地產銷售的成本,本期由於房地產銷售成本的減少,致使整體銷售成本有所降低。

僱員開支

截至2023年12月31日止年度,本集團的僱員開支為人民幣414.3百萬元,與2022年人民幣454.6百萬元相比減少了8.9%。主要原因是由於本集團於2023年持續人力資源降本增效,促進了僱員開支的同比減少。

折舊及攤銷

截至2023年12月31日止年度,本集團的折舊 及攤銷為人民幣990.1百萬元,較2022年人民 幣1,049.2百萬元相比減少了5.6%,主要由於 本集團旗下之部分門店資產折舊攤銷完畢所 致。

其他經營開支

截至2023年12月31日止年度,本集團的其他經營開支為人民幣1,041.8百萬元,較2022年的人民幣1,010.8百萬元增加了3.1%。其他經營開支的增加主要由於2022年新冠疫情在國內多地散發,致使本集團各地門店有短期的閉店或縮短營業時間,造成公用設施開支下降,2023年全年全國門店正常經營,水電等公用設施開支同比增加。

管理層討論及分析

Other Gains and Losses

For the year ended 31 December 2023, the Group recorded other losses of RMB84.9 million, representing a decrease of 117.4% as compared to other gains of RMB486.7 million in 2022, mainly attributable to gain of RMB328.2 million from converting certain of the Group's investment in associates to financial assets, gain of RMB196.1 million from the relocation transaction of Chengdu North Railway Station, and the provision for impairment of long-term equity investments in Shenzhen UGO E-Commerce Co., Ltd., an associate, of RMB200.6 million in 2022.

Operating Profit

Due to the combined effects of the above-mentioned factors, the Group recorded operating profit of RMB1,012.3 million for the year ended 31 December 2023, representing a decrease of 33.0% as compared to RMB1,510.4 million in 2022.

Finance Costs

For the year ended 31 December 2023, finance costs of the Group amounted to RMB965.3 million, representing a decrease of 8.1% as compared to RMB1,050.3 million in 2022. This was primarily due to (i) a decrease in finance costs due to a decrease in the principal amount of interest-bearing liabilities in the year as compared to 2022; and (ii) a slight decrease in the interest rates of interest-bearing liabilities.

Income Tax Expense

For the year ended 31 December 2023, income tax expense of the Group amounted to RMB116.4 million, representing a decrease of 50.7% as compared to RMB236.3 million in 2022. The decrease in income tax was mainly due to the decrease in total operating profit for the year.

Profit for the Year

As a result of the foregoing, net loss for 2023 was RMB78.2 million, representing a decrease of 138.1% as compared to the corresponding period of 2022.

其他收益及虧損

經營利潤

由於受到上述因素的綜合影響,本集團於截至2023年12月31日止年度錄得經營利潤人民幣1,012.3百萬元,較2022年人民幣1,510.4百萬元下降33.0%。

融資成本

截至2023年12月31日止年度,本集團的融資成本為人民幣965.3百萬元,較2022年人民幣1,050.3百萬元減少8.1%。主要原因為(i)本年度計息負債本金相較於2022年度減少,導致財務費用減少;及(ii)計息負債融資利率略有下降。

所得稅開支

截至2023年12月31日止年度,本集團的所得稅開支為人民幣116.4百萬元,較2022年人民幣236.3百萬元下降50.7%。所得稅減少主要原因是由於本年度經營利潤總額減少所致。

本年利潤

基於上述原因,2023年度錄得淨虧損為人民幣78.2百萬元,較2022年同期下降138.1%。

Liquidity and Financial Resources

As at 31 December 2023, the Group's cash and cash equivalents amounted to RMB722.8 million, representing an increase of RMB166.5 million as compared to the balance of RMB556.3 million as at 31 December 2022. The main cash inflow and cash outflow are set out as follows:

Interest-bearing Liabilities

The interest-bearing gearing ratio¹ and net interest-bearing debt to equity ratio² were 24.1% and 69.6%, respectively (as at 31 December 2022: 25.6% and 75.3%, respectively).

Charge on Assets

Foreign Currency Risks

During the reporting period, the Group recorded a net foreign exchange loss of approximately RMB3.7 million. Since the business of the Group was mainly focused in mainland China, its operation was not exposed to any foreign exchange fluctuation risk.

As of 31 December 2023, the Group had not entered into any arrangement to hedge its foreign currency risk. The Business of the Group is mainly concentrated in Mainland China, and the Group's operating cash flow was not exposed to foreign exchange fluctuation risks.

Mr. Gao Yajun (高亞軍) ("Mr. Gao"), aged 49, is an independent nonexecutive Director of the Company and a member of Audit Committee and Remuneration Committee. He joined the Group in April 2020. Mr. Gao is a senior accountant in Hong Kong, Certified Public Accountant in the PRC and Australia, and member of the Chartered Institute of Management Accountants. He is also a member of the Hong Kong Independent Non-Executive Director Association Limited. Mr. Gao graduated from Deakin University in Australia with a master's degree in professional accounting in 2002, holds a PhD in applied economics (Financial Mathematics and Financial Engineering) from Shanghai University of Finance and Economics and has been an executive director and a partner of Baker Tilly Hong Kong since February 2010. He had been an independent non-executive director of Nanjing Panda Electronics Company Limited (a company listed on the Main Board of the Stock Exchange, stock code: 553.HK, and Shanghai Stock Exchange, stock code: 600775.SH) since 29 June 2018, and he ceased to serve as its director on 29 June 2021. Mr. Gao has engaged in auditing and consulting work for a long time and has extensive experience in financial management.

CORPORATE GOVERNANCE PRACTICES

The Group recognises the vital importance of good corporate governance to its success and sustainability. The Company is committed to achieving a high standard of corporate governance practices as an essential component of high quality and has introduced corporate governance practices appropriate to the operation and growth of its business.

The Company has applied the principles set out in the Corporate Governance Code (the "Code") as contained in Appendix C1 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules"). In the opinion of the board of directors of the Company (the "Board"), the Company has complied with the code provisions set out in the Code throughout the year ended 31 December 2023, save and except for the deviation from code provision C.2.1. Key corporate governance principles and practices of the Company as well as the details of the deviation are summarised below.

The Board will continue to enhance its corporate governance practices appropriate to the operation and growth of its business and to review such practices from time to time to ensure that the Company complies with statutory and professional standards and aligns with the latest developments.

THE BOARD OF DIRECTORS

Responsibilities and Delegation

The Board is responsible for overall management and control of the Company. Its main roles are to provide leadership and to approve strategic policies and plans with a view to enhancing the interests of shareholders. All directors carry out their duties in good faith and in compliance with applicable laws and regulations, making decisions objectively, and acting in the interests of the Company and its shareholders at all times.

All directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary and senior management. Any director may request independent professional advice under appropriate circumstances at the Company's expense, upon making reasonable request to the Board.

企業管治常規

本集團認為良好的企業管治對本集團的成功 及持續發展至為重要。本公司致力於維持高 水準的企業管治慣例,作為高質素的重要元 素,並引入適合其業務營運及發展的企業管 治常規。

本公司已採用載於聯交所證券上市規則(「上市規則」)附錄C1的企業管治常規規守(「守則」)所載的原則。本公司董事會(「董事會」)認為,本公司於截至2023年12月31日止年度一直遵守所有守則條文,惟對守則條文第C.2.1條的偏離除外。本公司主要企業管治原則及常規以及有關偏離的詳情在下文概述。

董事會將繼續提升適合本公司業務營運及發展的企業管治常規,並不時檢討該等常規, 以確保本公司符合法定及專業標準,以及參 照標準的最新發展。

董事會

職責與委任

本公司的整體管理及控制由董事會負責。其主要職責為批准策略政策與計劃,並領導本公司提升股東利益。全體董事忠實地執行職務,並須遵守適用法例及規例,客觀地作出決定以及每時每刻為本公司及其股東的利益行事。

所有董事均可全面及時地取得所有相關資料,以及獲得公司秘書與高級管理層的意見及服務。任何董事均可於適當情況下,向董事會作出合理要求以尋求獨立專業意見,費用由本公司支付。

The Board reserves its rights for making decision on all major matters of the Company, including approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant financial and operational matters.

The Board has delegated a schedule of responsibilities to the executive directors and senior management of the Company. These responsibilities include implementing decisions of the Board and directing and coordinating day-to-day operation and management of the Company. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the aforesaid officers.

Board Composition

The biographical details of the directors are disclosed under the section headed "Biographies of Directors and Secretary" in this annual report.

The Company has established different mechanisms to ensure independent views and input are available to the Board.

During the year ended 31 December 2023, the Board has at all times met with the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors (representing at least one-third of the Board) with one of them possessing appropriate professional qualifications and accounting and related financial management expertise.

All directors have brought a wide range of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Moreover, through active participation in Board meetings, taking the lead in managing issues involving potential conflict of interests and serving on the Board committees, all independent non-executive directors have made various contributions to the effective business direction of the Company.

Apart from regular Board meetings, the Chairman also held 1 meeting with the independent non-executive directors without the presence of other directors during the year.

The Company has received written annual confirmation from each independent non-executive director in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive directors are independent.

All independent non-executive directors receive fixed fees for their role as members of the Board and Board committees. There is no other emoluments paid to the independent non-executive directors to avoid the potential biases in their decision making.

The Board also reviews the attendance of each of the independent non-executive directors at Board and Board committees meetings, as well as the time contributed to his roles in the Board and Board committees to ensure that he has devoted sufficient time to discharge his responsibilities as a Director of the Company.

The implementation and effectiveness of the above mechanisms are reviewed on an annual basis. The Board considers that such mechanisms had been implemented properly and effectively in the year ended 31 December 2023.

本公司已制定不同機制以確保董事會可以獲得獨立的觀點和意見。

截至2023年12月31日止年度,董事會一直符合上市規則的規定,委任最少三名獨立非執行董事(佔董事會最少三分之一席位),而其中一名獨立非執行董事擁有相關專業資格以及會計及相關財務管理專業知識。

全體董事為董事會投入寶貴的業務經驗、知識及專業水準,使董事會有效率及效益地運作。此外,透過積極參與董事會會議、帶領管理涉及潛在利益衝突的事宜及為董事委員會服務,全體獨立非執行董事對本公司的有效業務方針作出多項貢獻。

本公司已取得各獨立非執行董事根據上市規則第3.13條所載的獨立指引就其獨立性作出的年度確認書。本公司認為全體獨立非執行董事均屬獨立人士。

所有獨立非執行董事作為董事會和董事會委 員會成員都領取固定酬金。公司不向獨立非 執行董事支付其他酬金,以避免其在決策時 可能出現的偏差。

董事會亦審查每位獨立非執行董事出席董事 會和董事會委員會會議的情況,以及其在董 事會和董事會委員會中履行其職責所用的時 間,以確保其有足夠的時間履行公司董事的 職責。

上述機制的實施情況和有效性於每年進行 一次審查。董事會認為,截至2023年12月31 日的年度里,上述機制得到了妥善有效的實施。

Chairman and Chief Executive Officer

Code provision C.2.1 stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual.

Mr. Huang Mao Ru is Chairman of the Board and Chief Executive Officer of the Company. As Mr. Huang is the founder of the Group and has extensive experience in the department store industry and commercial real estate industry, the Board believes that it is in the best interest of the Group to have Mr. Huang taking up both roles for continuous effective management and business development of the Group.

The Board considers that the current structure of vesting the roles of Chairman and Chief Executive Officer in the same person will not impair the balance of power and authority between the Board and the management of the Company.

Appointment and Re-election of Directors

All directors are appointed for a specific term. All the executive directors, non-executive director and independent non-executive directors of the Company are engaged on a service contract/letter of appointment with the Company for a term of three years.

According to the Company's Articles of Association (the "Articles of Association"), all directors of the Company are subject to retirement by rotation at least once every three years and are eligible for re-election at annual general meetings of the Company. Any new director appointed by the Board to fill a casual vacancy shall submit himself/herself for re-election by shareholders at the first general meeting and any new director appointed by the Board as an addition to the Board shall submit himself/herself for re-election by shareholders at the following annual general meeting.

Mr. Tang Haifeng, who has been appointed as the Executive Director during the financial year ended 31 December 2023, has obtained the legal advice on 10 March 2023, and he has confirmed he understood his obligations as a director of a listed issuer.

Mr. Tony Huang, who has been appointed as the Non-executive Director during the financial year ended 31 December 2023, has obtained the legal advice on 10 March 2023, and he has confirmed he understood his obligations as a director of a listed issuer.

In accordance with the Articles of Association, Mr. Huang Mao Ru, Ms. Lu Xiaojuan and Mr. Gao Yajun are subject to retirement by rotation at the forthcoming 2024 annual general meeting of the Company (the "2024 AGM"). Each of them, being eligible, has offered himself/herself for reelection at the 2024 AGM. The Board and the Nomination Committee recommend their re-appointments. The Company's circular, sent together with this annual report, contains detailed information of the above three directors as required by the Listing Rules.

守則條文第C.2.1條列明,董事長及首席執行官的角色應予區分,不應由同一人擔任。

黃茂如先生為本公司董事長兼首席執行官。 由於黃先生為本集團創辦人,並於百貨行業 及商業房地產行業擁有豐富經驗,故董事會 相信,為了本集團的持續有效管理及業務發 展而由黃先生擔任兩個角色,符合本集團的 最佳利益。

董事會認為現時由同一人士擔任董事長及首 席執行官的架構,不會影響本公司董事會與 管理層之間的權力平衡。

董事的委任及重撰

全體董事任期固定。本公司全體執行董事、 非執行董事及獨立非執行董事均與本公司訂 有服務合約/委任書,任期三年。

根據本公司的組織章程細則(「組織章程」),本公司全體董事須最少每三年輪值退任一次,並符合資格於本公司股東週年大會上重選連任。由董事會委任以填補臨時空缺的新董事,須於下一次股東大會上由股東重選的任,而由董事會委任作為董事會新增成員的新董事,須於下屆股東週年大會上由股東重撰連任。

唐海峰先生在截至2023年12月31日的財政年度被任命為執行董事,他已於2023年3月10日取得法律意見,並確認他了解作為上市發行人董事的義務。

黃維正先生在截至2023年12月31日的財政年度被任命為非執行董事,他已於2023年3月10日取得法律意見,並確認他了解作為上市發行人董事的義務。

根據組織章程,黃茂如先生、盧小娟女士及高亞軍先生須於本公司即將召開的2024年股東週年大會」)上輪值退任。彼等每一位董事,符合資格並願意於2024年股東週年大會上重選連任。董事會及提名委員會建議彼等重獲委任。連同本年報一併寄發的本公司通函,根據上市規則的規定載有上述三位董事的詳細資料。

Training and Continuing Development for Directors

Directors shall keep abreast of responsibilities as directors of the Company and of the business activities and development of the Company and comply with the code of conduct of the Company at all times.

Each newly appointed director receives induction on the first occasion of his/her appointment, so as to ensure that he/she has appropriate understanding of the business and operations of the Company and that he/she is fully aware of his/her responsibilities and obligations under the Listing Rules and relevant regulatory requirements. Such induction is normally supplemented with visits to the Group's key business sites and/ or meetings with the senior management of the Company.

Under code provision C.1.4, directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. Internally-facilitated briefings for directors will be arranged and reading material on relevant topics will be issued to directors where appropriate. All directors are encouraged to attend relevant training courses at the Company's expenses.

During the year ended 31 December 2023, all the directors have participated in appropriate continuous professional development activities by way of attending training arranged by the legal advisor of the Group and receiving reading materials or regulatory update on corporate governance matters and responsibilities of the directors.

Model Code for Securities Transactions

The Company has adopted the Model Code for Securities Transaction by Directors of Listed Issuers (the "Model Code") as its code of conduct governing directors' dealings in the Company's securities. Specific enquiry has been made of the Company's directors and all the existing directors have confirmed that they have complied with the required standards set out in the Model Code throughout the period from 1 January 2023 to the date of this annual report.

The Company has also established written guidelines no less exacting than the Model Code (the "**Employees Written Guidelines**") for securities transactions by employees who are likely to possess inside information of the Company. No incident of non-compliance of the Employees Written Guidelines by the employees was noted by the Company.

In case when the Company is aware of any restricted period for dealings in the Company's securities, the Company will notify its directors and relevant employees in advance.

截至2023年12月31日止年度,全體董事均已 通過參加由本集團法律顧問安排的培訓課程 及獲取關於企業管治事宜及董事職責的閱讀 材料及更新,以參與合適的持續職業發展活 動。

證券交易的標準守則

本公司已採納上市發行人董事進行證券交易的標準守則(「標準守則」),作為規管董事買賣本公司證券的行為守則。本公司已向其董事作出特定查詢,而所有現有董事已確認由2023年1月1日起至本年報日期止期間一直遵守標準守則所載的規定標準。

董事會已就可能擁有本公司內部資料的有關僱員買賣本公司證券制訂嚴格程度不低於標準守則的書面指引(「僱員書面指引」)。本公司概未發現僱員違反僱員書面指引。

倘本公司知悉買賣本公司證券的任何限制期 間,則將提前通知其董事及相關僱員。

BOARD COMMITTEES & CORPORATE GOVERNANCE FUNCTIONS

The Board has established three Board committees, namely, the Audit Committee, the Remuneration Committee and the Nomination Committee, for overseeing particular aspects of the Company's affairs. All Board committees have been established with defined written terms of reference, which are posted on the Company's website "www.maoye.cn" and the Stock Exchange's website. All Board committees should report to the Board on their decisions or recommendations made.

All Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expense.

Audit Committee

The Audit Committee comprises a total of three members, namely, Mr. Rao Yong (Chairman), Mr. Pao Ping Wing and Mr. Gao Yajun, all of whom are independent non-executive directors. The chairman of the Audit Committee is Mr. Rao Yong who possesses the appropriate professional qualification, and accounting and financial management expertise as required under Rule 3.10(2) of the Listing Rules. None of the members of the Audit Committee is a former partner of the Company's existing external auditors.

The main duties of the Audit Committee are to (i) review the financial statements and reports and consider any significant or unusual items raised by the financial officers of the Group or external auditors before submission to the Board; (ii) review and monitor the external auditors' independence and the objectivity and the effectiveness of the audit process; (iii) make recommendations to the Board on the appointment, re-appointment and removal of external auditors; and (iv) review the accuracy and effectiveness of the Company's financial reporting system, internal control system and risk management system as well as internal audit function.

董事委員會及企業管治職能

審核委員會

審核委員會共有三名成員,分別為饒永先生 (主席)、浦炳榮先生及高亞軍先生,彼等均 為獨立非執行董事。饒永先生為審核委員會 主席,擁有上市規則第3.10(2)條所規定的專 業資格及會計及財務管理相關專業知識。審 核委員會成員均非本公司現有外聘核數師的 前任合夥人。

審核委員會的主要職務為(i)審閱財務報表及報告,並在提交董事會前考慮本集團財務主任或外聘核數師提出的任何重大或特別事項;(ii)審閱及監察外聘核數師的獨立性及核數過程的客觀性及效率;(iii)就委任、重新委任及罷免外聘核數師向董事會提供建議;及(iv)審閱本公司財務報告系統、內部監控系統、風險管理系統及內部審計職能的準確性及效率。

During the year ended 31 December 2023, the Audit Committee has held 2 meetings and performed the following major tasks:

- Review of the scope of audit work and the auditors' remuneration;
- Review and discussion of the annual financial results and report in respect of the year ended 31 December 2022 and interim financial results and report for the six months ended 30 June 2023 and discussion with the management of the accounting principles and practices adopted by the Group;
- Discussion and recommendation of the re-appointment of the external auditors; and
- Review of the financial reporting and internal control and risk management systems of the Group together with the effectiveness of the internal audit function of the Group.

The external auditors were invited to attend the Audit Committee meetings held during the year to discuss with the Audit Committee members issues arising from the audit and financial reporting matters. The Chairman of the Audit Committee provided the Board with a briefing on the significant issues after each Audit Committee meeting. There was no disagreement between the Board and the Audit Committee on the selection and appointment of the external auditors.

Remuneration Committee

The Remuneration Committee comprises a total of three members, namely, Mr. Pao Ping Wing (Chairman), Mr. Rao Yong and Mr. Gao Yajun, all of whom are independent non-executive directors.

The duties of the Remuneration Committee are mainly to (i) make recommendations to the Board on the Company's remuneration policy and structure and the remuneration packages of executive directors and senior management (i.e. the model described in the code provision E.1.2(c)(ii) of the Code); and (ii) review and approve performance-based remuneration by reference to corporate goals and objectives.

截至2023年12月31日止年度,審核委員會曾舉行2次會議並進行以下主要工作:

- 審閱核數工作範圍及核數師薪酬;
- 審閱及討論截至2022年12月31日止年度 的年度財務業績及報告,以及截至2023 年6月30日止六個月的中期財務業績及 報告,並與管理層討論本集團採納的會 計原則及慣例;

外聘核數師獲邀出席年內舉行的審核委員會會議,並就審計及財務報告事宜引起的問題 與審核委員會成員展開討論。審核委員會主 席於每次審核委員會會議後向董事會提供重 大事宜簡報。董事會與審核委員會之間並無 就甄選及委任外聘核數師而存在任何歧議。

GOVERNANCE STRUCTURE

The Board is the highest governing body of the Company and holds the ultimate responsibility on the overall strategic development and corporate governance of the Company. To ensure high governance standards in ESG matters, the Company has a stable ESG governance structure with clearly defined responsibilities in place.

The formulation of ESG strategy and the day-to-day management and reporting on ESG matters resides with the ESG Group, which is headed by the Executive Director and comprises members from all major departments. The responsibilities of the ESG Group include formulating ESG strategies, sustainability reporting, stakeholder engagement, materiality assessment, monitoring the performance of ESG initiatives and promotion of ESG issues both internally and externally.

Through the Executive Director, the ESG Group has been providing updates to the Board on the latest ESG performance of the Company on an annual basis. The ESG Group has continuously worked upon enhancing its reporting mechanism that will enable the Directors to effectively oversee the effectiveness of the ESG risk management and internal control systems.

To ensure effective implementation of ESG strategies and identify any potential ESG-related risks and opportunities, the ESG Group conducts regular meetings to discuss a range of pre-defined ESG initiatives and to follow up upon the works of business units which are charged with carrying out measures and setting appropriate policies to align with our overall ESG strategy. The ESG Group is also assisted by the internal audit team in identifying and evaluating the potential ESG related-risks (including climate change related risks), so as to devise appropriate strategies for risk mitigation.

The ESG Group continues to keep abreast of the latest developments on sustainability issues and remains committed towards promoting the integration of sustainable and socially responsible best practices into our daily operations and decision making processes across all levels of the Group. With the collaborative efforts of all business units, we are dedicated towards improving our ESG performance and fulfilling the expectations of our stakeholders.

環境社會管治小組每年透過執行董事,向董事會提供本公司最新環境社會管治表現之更新資料,並一直致力提升匯報機制,讓董事會有效監督環境社會管治風險管理及內部監控系統的有效性。

為確保環境社會管治策略得到有效落實,以及識別任何與環境社會管治相關的潛在風險與機遇,環境社會管治小組定期舉行會議,以討論一系列預先界定的環境社會管治措施,並跟進負責推行措施的業務單位的作,同時制定與我們整體環境社會管治策略相符的適當政策。在識別及評估潛在的環境社會管治相關風險(包括氣候變化相關的風險)上,環境社會管治小組亦獲內部審核團隊協助,從而制定適當的風險減緩策略。

環境社會管治小組不斷跟進可持續發展事宜 的最新發展,並繼續致力推動將可持續及具 社會責任的最佳實務,與本集團各層面的日 常營運及決策過程相融合。憑藉各業務單位 的通力合作,我們致力改善我們的環境社會 管治表現,並滿足我們的持份者的期望。

A. ENVIRONMENTAL

A1 Emission^{Note 1}

The Group complies with the relevant requirements of environmental protection laws and common principles of corporate management. It correctly handles the relationship between business and environment in accordance with characteristics of corporate environmental management, so that the economy and environmental protection are mutually reinforcing.

Our environmental policy advocates the prevention of environmental pollution, with integration of governance for comprehensive management to achieve maximum economic benefits under minimum impact on the environment. Meanwhile, we also attach importance to education and technical trainings to raise awareness of all employees about the environmental protection. In view of this, we have established a sound environmental responsibility system for the garbage from construction or renovation of the stores and kitchen waste from restaurants, under which special personnel supervise the classification and disposal of garbage.

The Group continues to monitor the operation of environmental protection facilities and regularly checks the implementation of environmental protection facilities.

All subsidiaries and retail department stores of the Group are required to strictly abide by the internal environmental management system to ensure the compliance with laws and regulations. During the reporting period, no violations of environment laws and regulations were found.

Note 1: Since the main business of the Group is operation of retail department stores, there was no significant emissions and hazardous waste generated during the reporting period, hence the relevant disclosure requirements in the ESG Guidelines (Key Performance Indicators A1.1, A1.3 and A1.5) are not applicable to the Group.

A. 環境

A1 排放物^{附註1}

本集團遵守環境保護法有關規定和 企業管理的共同原則,根據企業環 境管理的特點,正確處理經營和環 境的關系,使經濟與環保相輔相承。

本集團會持續監督環保設施的運行,定期檢查環保設施的執行效果。

本集團所有附屬公司及百貨零售門店需嚴格遵守內部有關環保的管理制度,確保其符合法律法規。本集團於報告期間並無發現違反與環境有關之法律及規例之個案。

附註1: 由於本集團的主營業務為百貨零售門店,我們於報告期間沒有顯著的廢氣及有害廢棄物產生,因此ESG指引中相關之披露要求(關鍵績效指標A1.1、A1.3及A1.5)並不適用於本集團。

Disposal of harmless waste

During the reporting period, the direct production of harmless waste in the course of business of the Group was mainly papers, ink cartridges, cartridges, plastic bottles and paper cups. During the reporting period, the generated equivalents are as follows.

The Group classified and collected different types of waste and carried out fixed storage and centralised processing. Recyclable harmless waste was recycled as far as possible, while the non-recyclable waste was handled by professional qualified service providers in accordance with the relevant environmental protection regulations.

A2 Use of resources

The Group is committed to becoming an environmentally friendly enterprise by saving electricity and encouraging the collection and recycling of office supplies and other resources to save natural resources. Our stores also integrate environmental protection publicity with marketing activities to advocate green lifestyle, so as to strive to become a model store for recycling economy.

We adhere to the preparation of analysis report on statistics of water and electricity consumption, and continue to update the standing book for equipment to enhance the management level. During the reporting period, the energy saving indicators was even included as the performance indicators of the employees to reward outstanding model of energy efficiency, as well as penalizing irregularities.

Use of energy

Our energy consumption during the reporting period which is mainly due to the electricity consumption of the 49 retail department stores (excluding the electricity consumption that are not directly controlled by the Group) is as follows.

A2 資源使用

本集團致力成為環境友好的企業, 我們通過節約用電和鼓勵回收、循 環使用辦公用品和其他資源的方式,以節約天然資源。我們的門店亦 把環保知識宣傳結合營銷活動,倡 導綠色生活方式,爭取成為循環經 濟樣板店。

我們堅持制定水、電能源消耗統計分析報表,並持續更新設備台賬信息,提升管理技術水平。於報告期內,我們更將節能降耗指標加入員工的業績指標中,獎勵優秀節能個案,並對違規案例進行處罰。

能源使用

本集團於報告期間內的能源消耗主要為49間百貨零售門店的市電消耗 (不包括集團無法直接管控的市電 消耗)如下表所示。

The electricity consumption increased by 0.4% as compared with 2022, which was due to the full liberalization of epidemic control during the year, but the epidemic still occurs in some areas at the beginning of this year, and still affected store business hours and customer traffic that resulting in only a slight increase in electricity consumption.

In order to strengthen the monitoring of the energy consumption of the Group, a number of energy saving measures were implemented during the reporting period in addition to the preparation of statistical analysis reports, namely:

- Enhancement of annual and monthly budget management to continuously promote water and electricity saving;
- Strict implementation of the operating time for various types of electrical equipment, with timely adjustment of air conditioning temperature;
- Enhancement of inspection and examination, with timely troubleshooting and repairs for failure in energy consumption and prevention of waste of water and electricity;
- Continuous innovation for upgrade of energy-saving equipment and techniques, such as energy-saving lightings, zone management on lighting, elevator frequency conversion, energy-saving water valves and use of energysaving environmental protection materials; and
- Capital investment for optimisation of environment of stores to establish a model enterprise for clean energy and environmental protection.

Water consumption

The total water consumption of 49 retail department stores of the Group during the reporting period is as follows. 為加強監察本集團的能源消耗量, 我們除了制定統計分析報表,亦已 於報告期間實行若干節能減排措施:

- 強化年度及月度預算管理,持續 推進水電節能降耗;
- 嚴格執行各類用電設備開啟、關 閉時間,適時調整空調水溫;
- 加強巡檢巡查,及時排查及修複 能耗故障,杜絕水電浪費;
- 繼續嘗試創新設備節能改造、技術改良:如節能燈具改造、照明分區管理、電梯變頻運用、節能水閥和節能環保材料使用等;及
- 投入改造資金,優化門店經營環境,打造能源清潔、環保模範企業。

The water consumption increased by 27.72% as compared with 2022, which was due to the full liberalization of the epidemic control during the year, the gradual resumption of business and the intensive cleaning efforts after the epidemic led to the increase in water consumption.

Some of the water saving measures implemented by the Group during the reporting period are as follows:

- Regularly carry out water conservation education on various departments of the Group to raise awareness of staff on water conservation and conduct supervision;
- Send special personnel to check whether the water taps are closed or pipelines are in a leakage condition;
- Promote water saving awareness by posting reminders of water conservation in public toilets;
- Install sensor valves in public toilets to control the amount of water used; and
- Reduce water consumption through regular water management and strict control of waste.

A3 Environmental and natural resources

The Group supports environmental protection and constantly assess the effectiveness of the measures taken to minimise the impact of our business operation to the surrounding environment so that appropriate improvement actions could be taken promptly. These measures include the use of energy-efficient lightings, paper usage reduction, turning off idle lightings, computers and electrical appliances and other facilities and equipment to save energy. We are also committed to promoting the use of recycle paper and shopping bags made of recycle paper in our department stores.

Appropriate actions are taken to manage and minimise the impacts of our operations to the environment and natural resources. We actively promote environmental protection and emphasise green operation and green office. Policies and measures are implemented to enhance energy conservation and emission reduction management. Relevant policies and measures taken during the reporting period are as follows:

- Enhance the DingTalk electronic office system, optimise office procedures and streamline processes to reduce the use of office paper and promote the Group's paperless office operation;
- Implementing double-sided printing and reusing and recycling toner cartridges, paper, envelope and paper files; relevant forms will be printed according to actual demand to facilitate the reduction of paper consumption at our stores. At the same time, printing facilities are being adjusted to reduce the consumption of consumables. Centralised collection and disposal of used consumables is adopted to minimise environmental pollution resulting from improper waste disposal;

本集團於報告期間實行的若干節水 措施如下:

- 定期對集團各部門進行節水教育,提高員工節水意識,並作出 監督;
- 派專人巡查用水開關是否關閉及管道是否存在漏水的情況;
- 在公共洗手間張貼節約用水的 提示,提高公眾的節水意識;
- 在公共洗手間內的設施增加感 應閥來控制用水量;及
- 通過定時用水管理及嚴控浪費 行為,降低耗水量。

A3 環境及天然資源

本集團一貫支持環保並持續執行綠 化營運環境的活動,更不時評場 護面程中有關對於問遭環境的 措施,從而即時作出改環 關措施包括使用節能照明及環 張,減少用紙,關閉閒置照明、電 器等設備以節省能耗 長團亦在可行情況下致力於推動環 保紙張的使用,並在各百貨 用以環保紙張製造的購物袋。

本集團已採取行動管理業務活動對環境及天然資源的重大影響,配合積極宣傳環保理念,制定多項優化經營及辦公環境的政策及措施,加強節能減排管理,強調綠色運營、綠色辦公。報告期間,相關政策及措施載列如下:

- 提升釘釘電子辦公系統,以優化 辦公程式,簡化流程,以減少辦 公用紙使用,推廣本集團無紙化 辦公模式;
- 實施辦公用紙雙面列印及碳粉 盒、廢紙、舊信封、公文袋等回 收再利用;對於有關表單依據調 際需求,繼續推動本集團店鋪減 少用紙。同時,合理調整列印設 施,以減少耗材損耗,並採用廢 舊耗材集中回收處理方式,集中 收集,統一處理,避免隨處丟棄 造成環境污染;

- To advocate environmentally responsible shopping, the Group uses recycled paper bags instead of traditional packaging bags. We provide customers with recycled paper bags made of recycled paper to enhance its recyclability. We take appropriate measures to comply with "General Technical Requirements of the environmental protection, safety and labelling for plastic shopping bags" and "Notice on restrictions of manufacturing and the sale of plastic bags" issued by the government. Reduction on plastic bag consumption was achieved through charging customers for plastic bags, and provide plastic bags when necessary to lower waste production; and
- Encouraging the use of environmental friendly materials and energy efficient equipment in our construction projects; incorporating environmental friendly concept and design into our office and stores, including maximising the use of natural light and share lightings in common areas, and utilising and refurbishing existing furniture and resources where possible during renovations.
- A4 Climate change

With the growing effects from global warming, saving energy and minimising greenhouse gas emission become our first priority.

Our administration and engineering departments constantly maintain all the policies to optimise energy consumption. These policies include daily maintenance and replacement of energy-inefficient equipment, switching-on of outdoor lightings according to local sunset time and using fresh air to replace hot air instead of air-conditioning in mild temperature. Other policies adopted in our shops and offices are as follows:

- 本集團提倡環保購物,使用以再 生紙加工的環保袋取代傳統包 裝袋,同時為顧客提供由可回 環保紙製作的紙制購物袋,增加 廢物回收機會;嚴格執行國安全 佈的《塑膠購物袋的環保、關 報通用技術要求》及《關於 限制生產銷售使用塑膠購物袋 的通知》;透過實行塑膠購物袋 有償使用制度,推廣節能減排; 同時嚴格審核使用要求,合理發 放使用數量,以減少產生廢物; 及
- 在項目施工過程中,鼓勵使用環保材料和高效能源裝置。在辦公室及商鋪裝修設計方面,本集團採用開放式的環保設計,最大限度利用室外自然光源及共用同區燈光照明,裝修時也盡可能保留原有的傢俱或對其進行改裝翻新,以配合環保概念。

A4 氣候轉變

鑒於全球暖化影響與日俱增,節約 能源和減少溫室氣體排放成為了我 們的首要任務。

我們的行政及工程部時刻維護各項設施以優化能源使用。這些措施包括日常維修或更換耗電設備、根據當地日落時間開啟室外照明、於氣溫較涼時抽取更多鮮風換熱以取代空調。其他於分店和辦事處採用的措施如下表所示:

B. SOCIAL

B1 Employment

The Group regards employees as the most important assets and is committed to providing employees with a fair and sound working environment having open space for personal development to ensure that Maoye International keeps company with its employees for advancement.

The Group has established the corporate values, which employees are guided to recognise, so that attitudes and behaviors of every employee will conform to and reflect the corporate culture. We have established a sound compensation system to provide all employees with remuneration level and welfare policies that are competitive in the market, so as to ensure that employees enjoy fair remuneration and benefits.

For the recruitment and promotion, fair opportunity is provided for each employee under a just and non-discriminatory principle to ensure that employees are not affected by gender, race and other factors in hiring and promotion. At the same time, while ensuring the contribution of employees to the Company, the personal ability and value are also promoted to have a rapid improvement and development.

We also strictly adhere to national and local laws and regulations in terms of working hours and holiday arrangements. Apart from paid annual leave, the Group also provides different types of leaves to employees, such as sick leave, marriage leave, maternity leave and paternity leave so that employees can enjoy their due leaves to maintain physical and mental health after industrious works.

Furthermore, the Group takes steps and initiations to maintain a harmonious labour relationship. We also work with labour unions to organise a wide range of leisure and cultural activities to express our care to our employees and promote healthy lifestyle and strengthen their sense of belonging and cohesiveness to the Group.

During the reporting period, there was no violation of the labour related laws and regulations.

B2 Health and safety

The Group provides employees with an ideal and safe working environment. In addition to taking all appropriate measures to protect the health and safety of employees, the Group also pays attention to the balance of work and healthy living among employees. Corresponding system and measures for leaves and medical needs of employees in special stages (such as pregnancy, illness, work injury etc.) have been developed to ensure that there is a reasonable guarantee for rights and interests of the employees.

To enhance employees' safety knowledge and skills to prevent accidents, the Group adopts the following policies:

- Maintaining proper lightings and ventilation systems and a clean environment both in office and on sales floors, and providing sufficient working space in the offices;
- · Smoking is prohibited in office and store areas; and
- Following government guidelines relating to severe weather warnings such as typhoons and rainstorms.

At the same time, employee is expected to share the responsibility in the making and monitoring of procedures and arrangements in respect of safety and health. All employees will:

- identify, report and rectify hazards at work in relation to health and safety and report such hazards immediately to superiors or the security department;
- participate in the investigation of any accidents or hazards to prevent any re-occurrence; and
- co-operate with management in adopting safe working methods and procedures.

B2 健康與安全

B3 Development and training

The Group focuses on the growth of employees and establishes a scientific and effective training system to formulate and implement training programs according to job nature and needs of employees to promote their improvement and growth. The training contents are divided into induction training, business training, quality training and personnel training program of "Maoye University".

Induction training

In order to help new employees to integrate into the Company as soon as possible and quickly adapt to job requirements, regular new staff trainings are organised. Through these trainings, employees can understand the development, corporate culture and the rules and regulations of the Group.

Business training

In-service employees regularly receive different types of trainings in accordance with the needs of their works. For example, retail stores regularly held services etiquette trainings, while financial department held skills training for financial employees.

Quality training

Through arrangements such as "reading club" and online learning platform, the Group provides employees with personal quality training programs to enable them to obtain personal growth and advancement.

Personnel training program of "Maoye University"

With deep integration of the Internet economy and traditional industries, the transformation of department stores is imperative. In order to meet the needs of talent in the "new retail" era, the Group provides employees with more systematic and rich personnel training programs. By formulating comprehensive training plans, employees can grow rapidly to realise personal value in the Company and make contribution to the growth and development of the Company.

B4 Labour standards

All of our departments and stores comply with local laws and regulations and strictly prohibit the use of child labour and forced labour. Maoye International pays special attention to the verification of identity information of employees. Comprehensive recruitment review procedures will be conducted by the human resources department to ensure that the information provided by the candidates is accurate. In addition, the Group will regularly examine whether there is existence of children labour or forced labour in the operation of the business.

During the reporting period, there was no violation of the laws and regulations relating to children or forced labour.

The relevant policies adopted by the Group are:

- Strictly prohibiting any departments to request and/ or employ any person who age below 16. The Human Resources Department is responsible for the review of the age during recruitment to ensure that no minors under the age of 16 are employed; and
- All employment must be on a voluntary basis and we do not allow forced labour, or using any form of deception to allure employee to work.

B5 Supply Chain Management

The Group has been considering environmental issues from various perspectives when negotiating the store leasing with the suppliers. The Group will directly examine the qualifications of the customers for new storage goods and supply of new products, including environmental protection indicators, and the quality of portfolio of regional and store suppliers to provide consumers with a variety of choices. The Group will directly interface with large suppliers to introduce attractive products that comply with environment regulations to promote the strategic cooperation between the two parties. In addition, environmental information is also shared with retail tenants and other visitors from time to time to promote sustainable green business model.

B4 勞工準則

For the employees of suppliers, we also require suppliers and their staff to provide written supporting documents and records to ensure that interests of the employees of the suppliers are guaranteed.

B7 Anti-corruption

The Group has been committed to upholding the principle of integrity and all employees are required to strictly abide by personal and professional conducts. The internal control and human resources centre of the Group have standardized channels to accept internal and external reports on corruption, bribery and other violations of professional conducts, together with investigation and disposal of reports having evidence. During the reporting period, there was no violation of the laws and regulations relating to corruption.

The Board is pleased to present the audited consolidated results of the Company and the Group for the year ended 31 December 2023.

PRINCIPAL ACTIVITIES

The Company is an investment holding company incorporated in the Cayman Islands with limited liability on 8 August 2007. The Group principally engages in the operation and management of department stores and property development in the PRC. There were no significant changes in the nature of the Group's principal activities during the year.

RESULTS AND APPROPRIATIONS

The results of the Group for the year ended 31 December 2022 are set out in the consolidated statement of profit or loss on page 98.

BUSINESS REVIEW

DEED OF NON-COMPETITION

Under the deed of non-competition dated 17 April 2008 given by Mr. Huang Mao Ru. Maove Holdings Limited and Richon Holdings Limited (collectively known as the "Controlling Shareholder Group") in favour of the Company, details of which were stated in the prospectus of the Company dated 21 April 2008 (the "Prospectus"), the Controlling Shareholder Group had undertaken to use its best endeavour within three years to (i) resolve the existing litigation between Chongqing Jiefangbei Maoye Department Store Co., Ltd. (重慶解放碑茂業百貨 有限公司) ("Chongqing Jiefangbei Store") and Chongqing Xin Long Da Real Estate Development Company Limited (重慶鑫隆達房地產 開發有限公司)("Xin Long Da"); (ii) obtain all necessary consents and approvals for the transfer of the interest of the Controlling Shareholder Group in Chongging Jiefangbei Store and Wuxi Maoye Department Store Company Limited (無錫茂業百貨有限公司) and Wuxi Maoye Baifu Supermarket Company Limited (無錫茂業百福超級市場有限公 司)(the latter two collectively known as "Maoye Wuxi Store") to the Group (note); and (iii) obtain all necessary consents and approvals for the transfer of the Controlling Shareholder Group's interest in Guiyang Friendship Group Holdings Company Limited (貴陽友誼 (集團) 股份有限 公司) ("Guiyang Friendship Group"), to serve a notice on the Group within ten business days of any of the issues in clauses (i) to (iii) above having been resolved, and to use his/its best endeavour to transfer the interest in Chongging Jiefangbei Store, Maoye Wuxi Store and Guiyang Friendship Group to the Group as soon as practicable once the relevant issues impeding such transfer have been resolved. The Controlling Shareholder Group had further undertaken to keep the Company informed every six months from the Listing Date as regards the progress on the matters described above.

Note: The ownership of Maoye Wuxi Store has been changed to Wuxi Maoye Property Co., Ltd., and such company was controlled by the Controlling Shareholders.

根據黃茂如先生、Maove Holdings Limited及 Richon Holdings Limited (統稱為「控股股東 集團」)與本公司於2008年4月17日訂立的不 競爭契據,詳情載於本公司於2008年4月21 日之招股章程中(「招股章程」),控股股東集 團於三年內盡最大努力(i)解決重慶解放碑茂 業百貨有限公司(「**重慶解放碑店**」)及重慶鑫 隆達房地產開發有限公司(「鑫隆達」)當時進 行的訴訟;(ii)就向本集團轉讓控股股東集團 於重慶解放碑店、無錫茂業百貨有限公司及 無錫茂業百福超級市場有限公司(後兩者統稱 「茂業無錫店」) 的權益(附註),取得全部所 需的同意及批文;及(iii)取得控股股東集團轉 讓貴陽友誼(集團)股份有限公司(「貴陽友誼 集團」)的權益所需的全部同意及批文,並於 上述(i)至(iii)任何一項獲得解決後十個營業日 內向本集團發出通知,以及待阻礙該等轉讓 的相關事宜獲得解決後,盡最大努力儘快向 本集團轉讓重慶解放碑店、茂業無錫店及貴 陽友誼集團的權益。控股股東集團已進一步 承諾自本公司上市日起保持每6個月通知本 公司有關該等事宜的進展。

Since the Supreme People's Court has adjudged that the leasing agreement entered into between Chongging Jiefangbei Store and Xin Long Da was valid and binding, the litigation between Chongging Jiefangbei Store and Xin Long Da has been resolved. However, the Group is still considering as to whether to acquire the interests of the Controlling Shareholder Group in the Chongging Jiefangbei Store and Maoye Wuxi Store. As the original master management agreement has terminated on 31 December 2019, the Company entered into the new master management agreement (the "New Master Management Agreement") with Maoye Holdings Limited on 1 January 2020 for a term of three years to govern the terms upon which the Group will provide store management services to the Controlling Shareholder Group with respect to the Maoye Wuxi Store and/or department stores owned by the Controlling Shareholder Group, in order to avoid conflict of interests between the Group and the Controlling Shareholder Group. On 1 January 2023, the parties have entered into the renewed New Master Management Agreement (the "2023 Master Management Agreement") for a term of three years, for the continuing provision of store management services by the Group to the Controlling Shareholder Group with respect to the Maove Wuxi Store and/or department stores owned by the Controlling Shareholder Group. As Maoye Holdings Limited is a connected person (as defined under the Listing Rules) of the Company, the entering into of the New Master Management Agreement and the 2023 Master Management Agreement constituted connected transactions for the Company under Chapter 14A of the Listing Rules. However, as all the applicable percentage ratios in relation to the New Master Management Agreement and the 2023 Master Management Agreement were less than 0.1%, these agreements were fully exempt from the reporting, announcement and shareholders' approval requirements under the Listing Rules. As Chongging Jiefangbei Store has ceased operation since February 2011, the Group did not manage Chongging Jiefangbei Store thereafter. Approval from the relevant government departments has not been obtained in relation to the Group's application for transfer of interest in Guiyang Friendship Group.

CONTINUING CONNECTED TRANSACTIONS

Internet Promotion Service Agreement

On 18 August 2021, Maoye Digital Intelligence Information Technology (Shenzhen) Co., Limited ("Maoye Digital Intelligence", an indirect non-wholly owned subsidiary of the Company) entered into the Internet Promotion Service Agreement with Shenzhen Shijin Business Consulting Co., Ltd. ("Shenzhen Shijin"), pursuant to which Maoye Digital Intelligence agreed to pay, and Shenzhen Shijin agreed to provide, among others, promotion services relating to the information designated by Maoye Digital Intelligence on multi-channel online platforms including Tencent and ByteDance.

由於最高人民法院已經判決認定:重慶解放 碑店及鑫降達之租賃合約有效,重慶解放碑 店及鑫隆達的訴訟已經解決。然而,本集團 就收購控股股東集團於重慶解放碑店及茂業 無錫店權益的問題仍然在考慮中。由於現有 管理總協議已於2019年12月31日終止,本集 團基於盡量減少與控股股東集團之同業競 爭的原則,本公司於2020年1月1日與Maove Holdings Limited訂立為期三年的新管理總協 議(「新管理總協議」),以規管本集團向控股 股東集團就茂業無錫店及/或其他控股股東 集團擁有的門店提供商店管理服務的條款。 於2023年1月1日,訂約方已訂立為期三年的 經重續之新管理總協議(「2023年管理總協 議」),以便本集團繼續向控股股東集團就茂 業無錫店及/或其他控股股東集團擁有的門 店提供商店管理服務。由於Maoye Holdings Limited為本公司關連人士(根據上市規則定 義),根據上市規則第14A章訂立新管理總協 議及2023年管理總協議構成了本公司關連交 易。然而,由於有關新管理總協議及2023年 管理總協議所有適用比率均低於0.1%,根據 上市規則,該等協議全面豁免遵守申報、公 告及獨立股東批准之規定。而由於重慶解放 碑店已經於2011年2月起停止運營,本集團 亦不再管理該店。本集團就轉讓貴陽友誼集 團的權益而提出的申請,尚未獲得相關政府 部門的批覆。

於2021年8月18日,茂業數智聯合信息技術 (深圳)有限公司(「**茂業數智**」,其為本公司 間接非全資附屬公司)與深圳世金商貿諮詢 有限公司(「**深圳世金**」)簽訂網絡推廣服務協 議。據此,茂業數智同意支付,深圳世金同意 (其中包括)在騰訊系、字節跳動系等多渠 道線上平台進行網絡推廣茂業數智指定的信息。

The Internet Promotion Service Agreement is effective for three years commencing from 18 August 2021 to 17 August 2024. According to the Internet Promotion Service Agreement, the total service fees payable by Maoye Digital Intelligence for the advertising services and value-added services to Shenzhen Shijin and the proposed annual caps are RMB5.0 million, RMB20.0 million, RMB30.0 million and RMB30.0 million from 18 August 2021 to 31 December 2021, for the year 2022, for the year 2023 and from 1 January 2024 to 17 August 2024, respectively.

According to the Internet Promotion Service Agreement, the service fees paid by Maoye Digital Intelligence to Shenzhen Shijin for the advertising services and value-added services was RMB1.767 million for the year ended 31 December 2023.

ELEVATOR MAINTENANCE FRAMEWORK AGREEMENT

On 24 March 2023, the Company entered into an Elevator Maintenance Framework Agreement with Zhongzhao Building, pursuant to which Zhongzhao Building will be entrusted to provide maintenance services for the elevators owned or used by the Group's stores or buildings, and the agreement term is lasted from from 24 March 2023 to 31 December 2025 (both days inclusive). The relevant members of the Group will enter into specific elevator maintenance agreements separately with Zhongzhao Building. Details of the transaction were disclosed in the Company's announcement dated 24 March 2023.

Zhongzhao Building is beneficially owned by Mr. Huang, the controlling shareholder and a Director. Therefore, Zhongzhao Building is a connected person of the Company under Chapter 14A of the Listing Rules, and the Elevator Maintenance Framework Agreement and the transactions contemplated thereunder constitute continuing connected transactions of the Company.

The amount payable is set out in the specific elevator maintenance agreements to be entered into by the relevant members of the Group with Zhongzhao Building, the prices and terms shall not deviate from the prices and terms offered by independent third parties for the provision of similar services to the Group.

The aggregated transaction amount and the proposed annual caps are RMB3.00 million, RMB3.00 million and RMB3.00 million respectively for 24 March 2023 to 31 December 2023, and the year ending 2024 and 2025.

During the year ended 31 December 2023, pursuant to the Elevator Maintenance Framework Agreement, total RMB1.874 million maintenance fee was paid by the Company to Zhongzhao Building for the maintenance service of the Company and the relevant members.

電梯維修保養框架協議

於2023年3月24日,本公司與中兆樓宇訂立電梯維修保養框架協議,委託中兆樓宇就本集團旗下門店或樓宇所屬或使用的電梯提供維修保養服務,合同期限自2023年3月24日起至2025年12月31日止(包括首尾兩日)。本集團相關成員公司分別與中兆樓宇訂立具體電梯維修保養協議。該交易之詳情已在本公司於2023年3月24日刊發之公告內披露。

中兆樓宇由控股股東兼董事黃先生實益擁有。因此,根據上市規則第14A章,中兆樓宇為本公司的關連人士,而電梯維修保養框架協議及其項下進行的交易構成本公司的持續關聯交易。

協議應付金額載列於相關成員公司與中兆樓 宇訂立的具體電梯維修保養協議的條款作 出,定價與條款不偏離獨立第三方向本集團 提供類似服務所提出的定價及條款。

自2023年3月24日至2023年12月31日,2024年度、2025年度期間,就中兆樓宇為本公司及相關成員公司提供的電梯維修保養服務應付的費用總額以及建議年度上限分別為人民幣3.00百萬元、人民幣3.00百萬元人民幣3.00百萬元。

截至2023年12月31日止年度,根據電梯維修保養框架協議,本公司及相關成員公司就中兆樓宇所提供的電梯維修保養服務支付的服務費為人民幣1.874百萬元。

CONNECTED TRANSACTION & CONTINUING CONNECTED TRANSACTIONS

By 8 February 2023, Chengshang Holding and Chengdu Maoye Property, both being subsidiaries of the Company entered into the Property Service Agreements with each of Jinjiang Chongde and Shuangliu Chongde for providing property management services for properties owned by Chengshang Holding and/or Chengdu Maoye Property. The terms of the Property Service Agreements range from one-year to three-years. Details of the transaction were disclosed in the Company's announcement dated 8 February 2023 and 13 February 2023 respectively.

Both Jinjiang Chongde and Shuangliu Chongde are beneficially owned by Mr. Huang, the controlling shareholder and a director of the Company. Therefore, both Jinjiang Chongde and Shuangliu Chongde are connected persons of the Company under Chapter 14A of the Listing Rules.

PRINCIPAL TERMS OF THE PROPERTY SERVICE AGREEMENTS

Chengshang Holding and Shuangliu Chongde have entered into the No. 1 Property Service Agreement for one year pursuant to which Shuangliu Chongde provides property management services for Chengdu Shuangliu Maoye Times Square in respect of shopping malls and office buildings with a floor area of 30,610.74 square meters. The property service fee is RMB14 per square meter per month, and the total amount of the agreement is approximately RMB5.14 million.

The No. 1 Property Service Agreement is a one-off connected transaction pursuant to the Listing Rules. As the relevant percentage ratios (other than the profits ratio) calculated pursuant to Rule 14.07 of the Listing Rules in respect of the No. 1 Property Service Agreement and the transactions contemplated thereunder are all less than 5%, the No. 1 Property Service Agreement and the transactions contemplated thereunder is subject to the reporting, announcement and annual review requirements pursuant to Chapter 14A of the Listing Rules but is exempt from the circular (including independent financial advice) and independent shareholders' approval requirement.

Chengshang Holding and Jinjiang Chongde entered into the No. 2 Property Service Agreement for three years pursuant to which Jinjiang Chongde provides property management services to Chengdu Yanshikou Maoye Complex (South Zone), in respect of office buildings with a floor area of 1,260.37 square meters. The property service fee is RMB19.5 per square meter per month. Based on the floor area of the said property, the annual transaction amount is approximately RMB0.29 million for each of the three years ended 31 December 2023, 2024 and 2025, and the aggregated transaction amount of the No. 2 Property Service Agreement for the entire duration of the three years ended 31 December 2023, 2024 and 2025 is estimated to be approximately RMB0.88 million.

錦江崇德和雙流崇德均為本公司控股股東兼董事黃先生實益擁有,根據上市規則第14A章,為本公司的關聯人士。

各項物業服務協議的主要內容:

成商控股與雙流崇德簽定為期一年的物業服務協議一,雙流崇德向成都雙流茂業時代廣場提供商場及辦公物業管理服務,其建築面積30,610.7平方米。服務費為每平方米每月人民幣14元,協議總金額約為人民幣514萬元。

物業服務協議一根據上市規則屬一次性交易,而根據上市規則第14.07條計算的物業服務協議一及其項下的交易的相關百分比率(盈利比率除外)均低於5%,因此物業服務協議一及其項下的交易須遵守上市規則第14章的申報、公告及年度審閱規定,但豁免遵守通函(包括獨立財務意見)及獨立股東批准的規定。

成商控股與錦江崇德簽定為期三年的物業服務協議二,錦江崇德向成都鹽市口茂業天地(南區)提供辦公物業管理服務,其範圍為建築面積1,260.37平方米。物業服務費為每平方米每月人民幣19.5元。根據上述物業的建築面積計算,截至2023年、2024年和2025年12月31日的三年期間,每年交易金額約為人民幣29萬元,而截至2023年、2024年和2025年12月31日的三年期間,預計物業服務協議二的總交易金額約為人民幣88萬元。

Chengdu Maoye Property and Shuangliu Chongde entered into the No. 3 Property Service Agreement for three years pursuant to which Shuangliu Chongde provides operation services for the parking lot of Chengdu Shuangliu Maoye Times Square, which consists of 592 parking spaces. The parking lot will be operated by Shuangliu Chongde who shall be responsible for its own profits and losses. After deducting all expenses (excluding all taxes) from the operating income of the parking lot, the remaining income will be distributed between Shuangliu Chongde and Chengdu Maoye Property as to 30% and 70%, respectively. Shuangliu Chongde will bear the costs of operation, maintenance, management and taxes of the parking lot. According to the estimated income of the parking lot, it is estimated that Shuangliu Chongde will charge a parking lot operating fee of approximately RMB0.31 million per year for each of the three years ended 31 December 2023, 2024 and 2025, and the aggregated transaction amount of the No. 3 Property Service Agreement for the entire duration of the three years ended 31 December 2023, 2024 and 2025 will be approximately RMB0.93 million.

The aggregated transaction amount and the proposed annual caps are RMB0.60 million, RMB0.60 million, and RMB0.60 million respectively for each of the three years ended 31 December 2023, 2024 and 2025 for the No. 2 Property Service Agreement and No. 3 Property Service Agreement.

During the year ended 31 December 2023, total RMB5.076 million property management fee was paid by Chendu Shuangliu Maoye Times Square to Shuangliu Chongde for property service in respect of shopping malls and office buildings.

The independent non-executive directors of the Company have reviewed and confirmed that such Connected Transaction and Continuing Connected Transaction are:

- (i) in the ordinary and usual course of business of the Group;
- (ii) on normal commercial terms or better; and

We have audited the consolidated financial statements of Maoye International Holdings Limited (the "Company") and its subsidiaries (the "Group") set out on pages 98 to 242, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. Management performs an impairment test for the cash-generating unit to which goodwill is allocated annually, and whenever there is an indication that the unit may be impaired, by comparing the carrying amount of the unit, including the goodwill, with the recoverable amount of the unit. The impairment test is complex, and significantly relies on management's judgement and estimation about the discount rate and the expected future operating results, such as the long-term growth rate, revenue and margin development which are affected by future market and economic conditions.

The Group is engaged in the operation and management of department stores and property development in Chinese Mainland. The completed investment properties in operation and investment properties under construction are recognised as investment properties and measured at fair value. Management engaged external appraisers to evaluate the fair values of the investment properties annually. As of 31 December 2023, the Group's investment properties amounted to approximately RMB21,806,780,000. The fair value measurement of investment properties is complex and highly dependent on a range of estimates made by management, such as the rental value, rental growth, vacancy rate, discount rate, budgeted construction cost, remaining percentage to completion and profit margin on construction.

2. ACCOUNTING POLICIES 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs"), which comprise standards and interpretations approved by the International Accounting Standards Board ("IASB"), and International Accounting Standards and Standing Interpretations Committee Interpretations approved by the International Accounting Standards Committee, and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties, financial assets at fair value through profit or loss ("FVPL"), and equity investments designated at fair value through other comprehensive income ("FVOCI") which have been measured at fair value. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

As at 31 December 2023, the Group had net current liabilities of approximately RMB6,232,484,000. The Group's ability to repay its debts when they fall due relies heavily on its future operating cash flows and its ability to renew the bank loans and other borrowings. The directors have carefully assessed the Group's liquidity position having taken into account:

- the Group's expected cash inflows from operating activities in 2024;
- (2) the bank borrowings that will expire during the next 12 months, which the directors of the Company are confident that could be renewed upon expiration based on the Group's past experience and credit standing; and
- (3) RMB1,778,563,000 and RMB734,588,000 of current liabilities as at 31 December 2023 are contract liabilities and deposits received in nature of which the Group will not be expecting any cash outflow.

The directors of the Company believe that the Group has adequate resources to continue operation for the foreseeable future of not less than 12 months from the end of the reporting year. The directors of the Company therefore are of the opinion that it is appropriate to adopt the going concern basis in preparing the consolidated financial statements.

Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2023.

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee:
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Investment in an associate and a joint venture

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investment in an associate and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. The Group's share of the post-acquisition results and other comprehensive income of an associate and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its an associate or joint ventures are eliminated to the extent of the Group's investments in the an associate or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of an associate or joint ventures is included as part of the Group's investment in an associate or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other case, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with IFRS 5 Non-current Assets Held for Sale and Discontinued Operations.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its investment properties, derivative financial instruments and equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets, deferred tax assets, financial assets, investment properties and non-current assets/a disposal group classified as held for sale). the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cashgenerating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cashgenerating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost (Or valuation) less accumulated depreciation and any impairment losses. When an item of property, plant and equipment is classified as held for sale or when it is part of a disposal group classified as held for sale, it is not depreciated and is accounted for in accordance with HKFRS 5, as further explained in the accounting policy for "Non-current assets and disposal groups held for sale". The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Cost may also include transfers from equity of any gains or losses on qualifying cash flow hedges of foreign currency purchases of property, plant and equipment.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Valuations are performed frequently enough to ensure that the fair value of a revalued asset does not differ materially from its carrying amount. Changes in the values of property, plant and equipment are dealt with as movements in the asset revaluation reserve. If the total of this reserve is insufficient to cover a deficit, on an individual asset basis, the excess of the deficit is charged to the statement of profit or loss. Any subsequent revaluation surplus is credited to the statement of profit or loss to the extent of the deficit previously charged. An annual transfer from the asset revaluation reserve to retained profits is made for the difference between the depreciation based on the revalued carrying amount of an asset and the depreciation based on the asset's original cost. On disposal of a revalued asset, the relevant portion of the asset revaluation reserve realised in respect of previous valuations is transferred to retained profits as a movement in reserves.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Investment properties

Investment properties are interests in land and buildings (including right-of-use assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

For a transfer from investment properties to owner-occupied properties or inventories, the deemed cost of a property for subsequent accounting is its fair value at the date of change in use. If a property occupied by the Group as an owner-occupied property becomes an investment property, the Group accounts for such property in accordance with the policy stated under "Property, plant and equipment and depreciation" for owned property and/ or accounts for such property in accordance with the policy stated under "Right-of-use assets" for property held as a right-of-use asset up to the date of change in use, and any difference at that date between the carrying amount and the fair value of the property is accounted for as a revaluation in accordance with the policy stated under "Property, plant and equipment and depreciation" above. For a transfer from inventories to investment properties, any difference between the fair value of the property at that date and its previous carrying amount is recognised in the statement of profit or loss.

Properties under development

Properties under development are stated at cost, which include all development expenditures, including land costs, interest charges and other costs directly attributable to such properties.

Properties under development are classified as current assets unless the construction period of the relevant property development project is expected to complete beyond the normal operating cycle.

Properties under development are valued at the lower of cost and net realisable value at the end of the reporting period and any excess of cost over the net realisable value of an individual item of properties under development is accounted for as a provision. Net realisable value is based on estimated selling price in the ordinary course of business as determined by management with reference to the prevailing market conditions, less further costs expected to be incurred to completion and selling and marketing costs.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Gains and losses on these financial assets are never recycled to the statement of profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

After initial recognition, trade and other payables, and interest-bearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the consolidated statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the consolidated statement of profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

Convertible bonds

The component of convertible bonds that exhibits characteristics of a liability is recognised as a liability in the statement of financial position, net of transaction costs. On issuance of convertible bonds, the fair value of the liability component is determined using a market rate for an equivalent non-convertible bond; and this amount is carried as a long term liability on the amortised cost basis until extinguished on conversion or redemption. The remainder of the proceeds is allocated to the conversion option that is recognised and included in shareholders' equity, net of transaction costs. The carrying amount of the conversion option is not re-measured in subsequent years. Transaction costs are apportioned between the liability and equity components of the convertible bonds based on the allocation of proceeds to the liability and equity components when the instruments are first recognised.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories comprise merchandise purchased for resale and are stated at the lower of cost and net realisable value. Cost of merchandise is determined on the moving weighted average method basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Completed properties held for sale

Completed properties held for sale are stated at the lower of cost and net realisable value. Cost is determined by an apportionment of the total land and buildings costs attributable to unsold properties. Net realisable value is estimated by the directors based on the prevailing market prices, on an individual property basis.

Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the Group expects some or all of a provision to be reimbursed, the reimbursement is recognised as a separate asset, but only when the reimbursement is virtually certain. The expense relating to a provision is presented in the statement of profit or loss net of any reimbursement.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the consolidated statement of profit or loss.

Coupon liabilities

Coupon liabilities are recognised based on the fair value of bonus points or coupons granted to customers in accordance with the announced bonus point scheme and the Group's past experience on the level of redemption of coupons and are recorded in other payables. The revenue of the Group is deducted when the coupon liabilities are recognised.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities for the current periods are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Retirement benefits

The employees of the Group's subsidiaries which operate in Chinese Mainland are covered by government-regulated defined contribution retirement benefit schemes under which the employees are entitled to a monthly pension. The Group contributes to these retirement benefit schemes on a monthly basis at a percentage of the employees' salaries. Under these schemes, the Group has no legal obligation for retirement benefits beyond the contributions made. Contributions to these schemes are expensed as incurred.

The Group operates a defined benefit pension plan which requires contributions to be made to a separately administered fund. The benefits are unfunded. The cost of providing benefits under the defined benefit plan is determined using the projected unit credit actuarial valuation method.

Re-measurements arising from the defined benefit pension plan, comprising actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability) are recognised immediately in the consolidated statement of financial position with a corresponding debit or credit to retained profits through other comprehensive income in the period in which they occur. Remeasurements are not reclassified to profit or loss in subsequent periods.

Net interest is calculated by applying the discount rate to the net defined benefit liability or asset. Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Where funds have been borrowed generally, and used for the purpose of obtaining qualifying assets, a capitalisation rate of 5.55% has been applied to the expenditure on the individual assets.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

The Company and other investment holding subsidiaries incorporated in the Cayman Islands, the British Virgin Islands and Hong Kong use the Hong Kong dollar ("HK\$") as their functional currency. The functional currency of the PRC subsidiaries is RMB. As the Group mainly operates in Chinese Mainland, RMB is used as the presentation currency of the Group. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the consolidated statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas subsidiaries are currencies other than RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in the statement of profit or loss.

於釐定相關資產初始確認的匯率、終止確認與墊付代價有關的非貨幣資產或非貨幣負債的開支或收入時,首次交易日期為本集團初步確認墊付代價產生的非貨幣資產或非貨幣負債當日。倘涉及多筆墊付款項或預收款項,則本集團會釐定每次支付或收取墊付代價的交易日期。

若干海外附屬公司的功能貨幣為人民幣以外的貨幣。於報告期末,該等實體的資產及負債按各報告期末的通行匯率換算為人民幣,而其損益表則按與交易日適用的匯率相若之匯率轉換為人民幣。

For the purpose of the consolidated statement of cash flows, the cash flows of subsidiaries outside Chinese Mainland are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of subsidiaries outside Chinese Mainland which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's consolidated financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements:

Property lease classification – Group as lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a major part of the economic life of the commercial property and the present value of the minimum lease payments not amounting to substantially all the fair value of the commercial property, that it retains substantially all the significant risks and rewards incidental to ownership of these properties which are leased out and accounts for the contracts as operating leases.

• 物業租約歸類-本集團為出租人

本集團已就其投資物業組合訂立商 用物業租約。本集團已根據對此項 安排之條款及條件之評估確定,例 如租賃期並不構成商業物業經濟年 期的主要部分及最低租賃付款的足 值未達至商業物業的絕大部分公允 價值,其保留該等出租物業的所有 權附帶的絕大部分重大風險及回報 並將該等合約列賬為經營租賃。

 Classification between investment properties and owneroccupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Owneroccupied properties generate cash flows that are attributable not only to property but also to other assets used in the department store operations. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. The Group based its assumptions and estimates on parameters available when the consolidated financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising beyond the control of the Group. Such changes are reflected in the assumptions when they occur.

· Useful lives of property, plant and equipment

The Group determines the estimated useful lives and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. Management will revise the depreciation charge where useful lives are different to previously estimated, or will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold.

投資物業及自用物業之歸類

本集團確定一幢物業是否可列作投 資物業,並已制定判斷之準則。投資 物業乃持作賺取租金或資金增值或 持作兩者之物業。因此,本集團考 慮一幢物業在產出現金流量時,是 否大都獨立於本集團所持之其他資 產。業主自佔物業產生的現金流量 不僅來自物業,亦來自百貨店業務 所用的其他資產。若干物業包括乃 持作賺取租金或資本增值的部分, 及持作供貨或提供服務或作行政管 理用途的部分。如該等部分能獨立 出售或以融資租賃方式獨立出租, 本集團將獨立處理該等部分。如該 等部分不能獨立出售,持作供貨或 提供服務或作行政管理用途佔極少 部分,該物業則列作投資物業。本集 團對各項物業作出判斷,以確定配 套服務是否重要到使物業不符合投 資物業的資格。

估計不確定因素

有關未來之主要假設以及其他於報告期末會為下個財政年度資產與負債賬面值帶來重大調整風險之主要估計不明朗因素討論如下。本集團所作出的假設與估計均基於在編製本綜合財務報表時可獲取的參數。然而,由於市場改變或本集團不可控之環境,對當前環境及未來發展所作出的假設可能會發生改變。此類變化將會在其發生時反映在假設中。

• 物業、廠房及設備的可使用期

本集團釐定物業、廠房及設備的估計可使用期及相關折舊支出。該估計基於性質及功能相若的物業、廠房及設備的實際可使用期過往記錄計算。管理層會於可使用期有別於原先估計時修訂折舊支出,或會撇銷或撇減技術陳舊或已廢棄或出售的非策略資產。

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2023 was RMB1,260,531,000 (31 December 2022: RMB1,270,349,000). Further details are given in note 20.

 Provision for expected credit losses on trade receivables and other receivables

The Group uses a provision matrix to calculate ECLs for trade receivables and other receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by geography, product type, customer type and rating, and coverage by letters of credit and other forms of credit insurance).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables and other receivables is disclosed in note 28 and note 29 to the financial statements, respectively.

商譽減值

本集團最少每年確定商譽有否減值,當中需要估計商譽所屬現金產生單位的使用價值。估計使用價值 需要本集團估計現金產生單位的預期未來現金流量,亦要選用合適的 貼現率,以計算該等現金流量的的 值。於2023年12月31日商譽的賬面 值為人民幣1,260,531,000元(2022 年12月31日:人民幣1,270,349,000元)。進一步詳情載於附註20。

• 應收貿易款項及其他應收款項的預 期信用損失撥備

本集團使用撥備矩陣計算應收貿易款項及其他應收款項的預期信用損失。撥備率是基於就損失模式(即按地域、產品類型、客戶類型及評級、信用證及其他信貸保險類型的承保範圍劃分)類似的多個客戶分部分組的逾期日數計算。

撥備矩陣最初基於本集團的過往觀察違約率。本集團將根據前瞻性資料調整矩陣,從而調整過往信用損失經驗。例如,倘預測經濟狀況(如國內生產總值)預期於未來一年內惡化,並可能導致製造業的違約率將入數上升,則過往違約率將予以調整。於各報告日,過往觀察違約率將予以更新並分析前瞻性估計的變動。

Leases – Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

Estimation of fair value of investment properties

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences;
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the dates of the transactions that occurred at those prices; and
- (c) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

The carrying amount of investment properties at 31 December 2023 was RMB21,806,780,000 (31 December 2022: RMB21,480,749,000). Further details, including the key assumptions used for fair value measurement and a sensitivity analysis, are given in note 18 to the financial statements.

• 租賃一估計增量借款利率

本集團無法輕易釐定租賃內所隱 含的利率,因此,使用增量借款利率 (「增量借款利率」) 計量租賃負債。 增量借款利率為本集團於類似經濟 環境中為取得與使用權資產價值相 近之資產,而以類似抵押品與類似 期間借入所需資金應支付之利率。 因此,增量借貸利率反映了本集團 「應支付」的利率,當無可觀察的利 率時(如並無訂立融資交易的附屬公 司)或當須對利率進行調整以反映租 賃之條款及條件時(例如並非以附屬 公司的功能貨幣租賃),則須作出利 率估計。當可觀察輸入數據可用時, 本集團使用可觀察輸入數據(如市場 利率) 估算增量借款利率並須作出若 干實體特定的估計(如附屬公司之個 別信貸評級)。

投資物業的公允價值估計

倘缺乏類似物業於活躍市場的現有 價格,則本集團會考慮從多個途徑 所收集之資料,包括:

- (a) 不同性質、狀況或地點的物業於 活躍市場的現有價格(經調整以 反映該等差異);
- (b) 活躍程度稍遜的市場所提供類似物業的近期價格(經調整以反映自按該等價格進行交易的有關日期以來經濟狀況的任何變動);及
- (c) 根據未來現金流量所作可靠估計預測的貼現現金流量,此項預測以任何現有租約及其他合約的條款以及(在可行情況下)外來證據(如地點及狀況相同的類似物業現有市場租金)為憑證,並採用可反映當時市場對有關現金流量金額及時間不明朗因素評估的貼現率。

Deferred tax assets

Deferred tax assets are recognised for all deductible temporary differences and unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. The carrying value of deferred tax assets relating to recognised tax losses at 31 December 2023 was RMB147,552,000 (31 December 2022: RMB147,783,000). The amount of unrecognised tax losses at 31 December 2023 was RMB2,447,763,000 (31 December 2022: RMB2,631,611,000). Further details are contained in note 25 to the financial statements.

Net realisable value of inventories and completed properties held for sale

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated selling expenses. Net realisable value of completed properties held for sale is estimated by the directors based on the prevailing market prices. These estimates are based on the current market conditions and the historical experience of selling merchandise of a similar nature. It could change significantly as a result of changes in customer taste or competitor actions. The Group reassesses these estimates at the end of the reporting period.

• Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-ofuse assets) at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows. Further details, including a sensitivity analysis of key assumptions, are given in note 42 to the financial statements.

存貨的可變現淨值指日常業務過程中的估計售價減估計出售開支。 持有待售已落成物業的可變現淨值 由董事根據現行市價進行估計。該 等估計乃基於當時市況及過往出售 同類商品的經驗,或會因客戶輻變或競爭對手的行動而有大幅改 變。本集團會於報告期末重新評估 該等估計。

• 非金融資產減值(商譽除外)

本集團於各報告期末評估所有非金 融資產(包括使用權資產)是否存 在減值跡象。無限定年期的無形資 產每年或於出現跡象時進行減值測 試。其他非金融資產於有跡象顯示 賬面值可能無法收回時進行減值測 試。當資產或現金產生單位的賬面 值超出其可收回金額(為公平值減 出售成本及使用價值兩者中的較高 者) 時,即存在減值。公平值減出售 成本乃按類似資產的公平原則交易 中具約束力銷售交易所得數據或可 觀察市價扣除出售資產的號增成本 計算。於計算使用價值時,管理層須 估計來自資產或現金產生單位的預 期未來現金流量,及選擇適當貼現 率以計算該等現金流量的現值。進 一步詳情(包括主要假設的敏感度分 析) 載於財務報表附註42。

Fair value of unlisted equity investments

The unlisted equity investments have been valued based on a market-based valuation technique as detailed in note 41 to the financial statements. The valuation requires the Group to determine the comparable public companies (peers) and select the price multiple. In addition, the Group makes estimates about the discount for illiquidity and size differences. The Group classifies the fair value of these investments as Level 3. The fair value of the unlisted equity investments at 31 December 2023 was RMB186,613,000 (2022: RMB545,815,000). Further details are included in note 24 to the financial statements.

• Recognition of deferred tax liabilities for withholding taxes

Deferred tax liabilities are recognised for withholding tax levied on dividends declared to foreign investors from the foreign investment enterprise established in Chinese Mainland. Significant management judgement is required to determine the amount of deferred tax liabilities that can be recognised, based upon the likely dividends declared. Further details are contained in note 25 to the financial statements.

4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on the nature of their operations and their products and services and has three reportable operating segments as follows:

- (a) the operation of department stores segment comprises concessionaire sales, direct sales of merchandise and the leasing out of commercial properties for the operation of department stores by third parties;
- (b) the property development segment is principally engaged in the development and sale of commercial and residential properties as well as the leasing out of commercial properties other than for the operation of department stores; and
- (c) the "others" segment comprises, principally, operations of hotels, and the provision of ancillary services.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/loss attributable to owners of the parent.

- (a) 百貨店分部的經營包括特許專櫃銷售、商品直銷以及出租商用物業供第三方經營百貨店;
- (b) 物業發展分部,主要從事開發及銷售商用與住宅物業、以及出租商用物業而非經營百貨店;及
- (c) 「其他」分部,主要包括酒店經營及 提供配套服務。

管理層對本集團各經營分部業績分別進 行監控以就資源分配及績效評估作出決 策。分部績效是基於歸屬於母公司權益 持有人之可報告分部利潤/虧損進行評 估。

The Company was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands and accordingly, is exempt from the payment of the Cayman Islands income tax.

Pursuant to the rules and regulations of the British Virgin Islands, the Group is not subject to any tax in the British Virgin Islands.

The provision for Hong Kong profits tax was calculated at 16.5% of the estimated assessable profits for the year ended 31 December 2023 (2022: 16.5%).

The duration of the cash flows and the specific timing of inflows and outflows are determined by events such as rent reviews, lease renewal and related reletting, redevelopment or refurbishment. The appropriate duration is driven by market behaviour that is a characteristic of the class of property. The periodic cash flow is estimated as gross income less vacancy, non-recoverable expenses, collection losses, lease incentives, maintenance costs, agent and commission costs and other operating and management expenses. The series of periodic net operating income, along with an estimate of the terminal value anticipated at the end of the projection period, is then discounted.

A significant increase (decrease) in the estimated rent growth rate and market rent growth rate per annum in isolation would result in a significant increase (decrease) in the fair value of the investment properties. A significant increase (decrease) in the long term vacancy rate and the discount rate in isolation would result in a significant decrease (increase) in the fair value of the investment properties. Generally, a change in the assumption made for the estimated rental value is accompanied by a directionally similar change in the rent growth per annum and the discount rate and an opposite change in the long-term vacancy rate.

The residual method of valuation is commonly used in valuing development sites by establishing the market value of the properties on an "as-if" completed basis with appropriate deduction on construction costs, professional fees, contingency, marketing and legal cost, and interest payments to be incurred, anticipated developer's profits, as well as land acquisition costs, interest payment and profit on land.

The fair values of investment properties are determined using the comparison method by referring to comparable sales evidence as available in the relevant market. Comparable properties of similar size, characteristics and location are analysed and selected for each investment property in order to arrive at a fair comparison of their fair values. The fair value measurement is positively correlated to the market unit sale rate.

The fair value of the liability portion of the convertible bonds is estimated using an equivalent market interest rate for a similar convertible bond.

The fair values of listed equity investments are based on quoted market prices. The fair values of unlisted equity investments designated at fair value through other comprehensive income have been estimated using a market-based valuation technique based on assumptions that are not supported by observable market prices or rates. The valuation requires the directors to determine comparable public companies (peers) based on industry, size, leverage and strategy, and to calculate an appropriate price multiple, such as price to sales ("P/S"), price to book ("P/B") multiple and price to earnings ("P/E") multiple, for each comparable company identified. The multiple is calculated by dividing the enterprise value of the comparable company by an earnings measure. The trading multiple is then discounted for considerations such as illiquidity and size differences between the comparable companies based on companyspecific facts and circumstances. The discounted multiple is applied to the corresponding earnings measure of the unlisted equity investments to measure the fair value. The directors believe that the estimated fair values resulting from the valuation technique, which are recorded in the consolidated statement of financial position, and the related changes in fair values, which are recorded in other comprehensive income, are reasonable, and that they were the most appropriate values at the end of the reporting period.

The Group invests in unlisted investments, which represent wealth management products issued by banks in Chinese Mainland. The Group has estimated the fair value of these unlisted investments by using a discounted cash flow valuation model based on the market interest rates of instruments with similar terms and risks.

The Group's principal financial instruments comprise interest-bearing bank loans, amounts due from/to related parties, and cash and cash equivalents. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk, liquidity risk and equity price risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's debt obligations with floating interest rates.
