New Arrangements on Dissemination of Corporate Communications

Pursuant to the new Rule 2.07A¹ of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") and the Amended and Restated Articles of Association of the Company, the Company will disseminate future corporate communications of the Company (the "Corporate Communications")² to its Shareholders³ electronically and only send Corporate Communications in printed form to the Shareholders upon request.

ARRANGEMENTS

Actionable Corporate Communications⁴

The Company will send the Actionable Corporate Communications to its Shareholders individually in electronic form by email. Corporate Communications

A notice of publication of the Website Version⁶ of Corporate Communications, in both English and Chinese, will be sent by the Company to the Shareholders by email or by post (where the Company does not possess the functional email address of a Shareholder).

Provision of Shareholder's email address to the Company
