GENERAL OVERVIEW

The Board of Directors of the Company (the "Board") hereby presents the audited consolidated annual results of the Company and its subsidiaries (collectively the "Group") for the year ended 31st December, 2023. It reports that there was a significant increase in the consolidated profit after taxation of the Group for the year under review, which was mainly attributable to the improvement in performance of the property development and trading business of the Group and in results of the Group's joint venture.

There was a rise in the revenue generated from the property development and trading segment during the year under review. However, an unrealized loss on fair value changes of the investment properties of the Group in Shanghai, the People's Republic of China ("China") of HK\$109,255,000 (2022: HK\$75,204,000) was recorded upon market valuation as at year end pursuant to applicable accounting standards. Hence, it only resulted in a slight improvement in the segment profit of property development and investment business to HK\$99,085,000 for the year under review (2022: HK\$98,828,000).

During the year 2023, the Group recorded a net gain on trading securities investment of HK\$2,287,000 (2022: HK\$8,161,000) and received dividend from a long-term equity investment of the Group of HK\$18,470,000 (2022: HK\$22,054,000). There were an increment in the interest income to HK\$72,633,000 (2022: HK\$70,210,000) and a reduction in a net exchange loss to HK\$5,907,000 (2022: HK\$28,577,000), but both the administrative expenses and finance costs increased.

As a result, excluding the loss on fair value changes of the investment properties, the Group reported operating profit before taxation of HK\$223,819,000 for the year under review (2022: HK\$217,288,000).

In addition, the Group shared a net profit of a joint venture of HK\$22,645,000 (2022: net loss of HK\$15,289,000).

概覽

本公司董事局(「董事局」) 謹此呈報本公司及其附屬公司(統稱「本集團」) 截至二零二三年十二月三十一日止年度之已審核全年綜合業績。本公司報告本集團於回顧年度之除稅後綜合溢利錄得大幅上升,主要歸因於本集團的物業發展及銷售業務的表現以及本集團合資企業的業績有所改善。

物業發展及銷售分類於回顧年度產生之收入增加。然而,本集團於年末根據適用之會計準則對位於中華人民共和國(「中國」)上海市之投資物業作出市場估值後錄得公平值變動所產生之未變現虧損109,255,000港元(二零二二年:75,204,000港元)。因此,物業發展及投資業務之分類溢利於回顧年度僅輕微增加至99,085,000港元(二零二二年:98,828,000港元)。

於二零二三年度內,本集團錄得待售證券投資之收益淨額2,287,000港元(二零二二年:8,161,000港元),而自本集團長期股本投資收取之股息為18,470,000港元(二零二二年:22,054,000港元)。利息收入增加至72,633,000港元(二零二二年:70,210,000港元),而匯兑虧損淨額減少至5,907,000港元(二零二二年:28,577,000港元),惟行政費用及融資費用有所增加。

因此,撤除投資物業公平值變動所產生之虧損,本集團於回顧年度錄得除稅前經營溢利223,819,000港元(二零二二年:217,288,000港元)。

此外,本集團從一家合資企業分佔溢利 淨額22,645,000港元(二零二二年:虧損 淨額15,289,000港元)。

Taking account of taxation of HK\$90,201,000 (2022: HK\$107,806,000), it was reported a consolidated profit after taxation attributable to shareholders of the Company of HK\$42,684,000 for the year ended 31st December, 2023, a significant increase of approximately 1.49 times as compared with that of HK\$17,168,000 for the corresponding period in 2022. Basic earnings per share amounted to 2.12 HK cents (2022: 0.87 HK cents).

於截至二零二三年十二月三十一日止年度,經計及税項90,201,000港元(二零二二年:107,806,000港元),本集團錄得本公司股東應佔除税後綜合溢利42,684,000港元,較二零二二年同期的17,168,000港元大幅增加約1.49倍。每股基本盈利為2.12港仙(二零二二年:0.87港仙)。

DIVIDEND

The Board has declared an interim dividend of 10 HK cents per share for the year ended 31st December, 2023 (2022: 8.50 HK cents per share) payable to the shareholders whose names appear on the register of members of the Company on Friday, 3rd May, 2024 (the "Record Date"). Shareholders will be given an option to elect to receive shares of HK\$0.50 each in the capital of the Company credited as fully paid in lieu of cash in respect of all or part of the interim dividend (the "Scrip Dividend Scheme").

The Scrip Dividend Scheme is conditional upon consent of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") to grant listing of and permission to deal in the new shares of the Company to be allotted thereunder. For the purpose of determining the number of new shares of the Company to be allotted under the Scrip Dividend Scheme, the market value of a new share will be calculated as an amount equal to 95% of the average of the closing prices per share of the Company traded on the Stock Exchange for the five consecutive trading days up to and including the Record Date. A circular providing full details of the Scrip Dividend Scheme, together with a form of election, will be sent to the shareholders of the Company in electronic form by email or in printed form by post (as the case may be) in due course. Cash dividend warrants and/or share certificates for the scrip dividend are expected for despatch on Thursday, 13th June, 2024.

OPERATIONS REVIEW

The Mainland of China, particularly Shanghai, is the principal base of the Group's operations.

股息

董事局宣佈向於二零二四年五月三日 (星期五)(「記錄日期」)名列本公司股東 名冊之股東宣派截至二零二三年十二月 三十一日止年度之中期股息每股10港仙 (二零二二年:每股8.50港仙)。股東將 有權選擇就全部或部份中期股息收取本 公司股本中每股面值0.50港元之股份以 代替現金,且該等股份將被記入為已繳 足股本(「以股代息計劃」)。

業務回顧

中國內地(特別是上海市)為本集團營運之主要基地。

For the year ended 31st December, 2023, the property investment segment was the Group's primary profit maker by contributing a segment profit of HK\$54,091,000 (2022: HK\$94,780,000), which was derived from the rental and property management fee from the investment properties of the Group in Shanghai, however, this was partly offset by the unrealized loss on fair value changes of these investment properties upon revaluation at year end.

The property development and trading segment was the secondary profit contributor of the Group and this generated a segment profit of HK\$44,994,000 (2022: HK\$4,048,000) which was attributable to the properties sales in Shanghai.

Securities trading business reported a segment profit of HK\$2,104,000 (2022: HK\$7,984,000) which was mainly attributable to the sale proceeds from the trading securities held by the Group in the Hong Kong Special Administrative Region ("Hong Kong") of China. This business ranked third in terms of profit contribution amongst the operating segments of the Group.

The other business segments of the Group reported loss during the year under review.

Property Development and Investment

Property development and investment remained the core business and the principal source of profit of the Group for the year ended 31st December, 2023 by contributing a total segment profit of HK\$99,085,000 (2022: HK\$98,828,000). Tomson Riviera was the prime source of operating profit of the Group.

This business segment generated total revenue of HK\$459,870,000 which accounted for approximately 81.05% of the gross proceeds from operations of the Group for the year 2023 and was solely derived from the projects in Pudong of Shanghai, China. Nevertheless, an unrealized loss on fair value changes of the investment properties of the Group in Pudong of HK\$109,255,000 was recorded at year end. The property projects in Hong Kong and the Macao Special Administrative Region ("Macau") of China did not record any revenue.

於截至二零二三年十二月三十一日止年度,物業投資分類為本集團之首要溢利來源,貢獻分類溢利54,091,000港元(二零二二年:94,780,000港元),此乃來自本集團於上海市之投資物業之租金及物業管理費收入,惟部份收益已被於年末重估此等投資物業之價值後錄得公平值變動所產生之未變現虧損所抵銷。

物業發展及銷售分類為本集團之第二大 溢利貢獻者,並產生分類溢利44,994,000 港元(二零二二年:4,048,000港元),此 乃歸因於上海市之物業銷售。

證券買賣業務錄得分類溢利2,104,000港元(二零二二年:7,984,000港元),此乃主要歸因於本集團在中國香港特別行政區(「香港」)持有的待售證券之出售收益。此業務於本集團營運分類中之溢利貢獻排名第三。

本集團其他業務分類於回顧年度錄得虧 損。

物業發展及投資

物業發展及投資業務仍為本集團於截至二零二三年十二月三十一日止年度之核心業務及主要溢利來源,貢獻分類溢利總額99,085,000港元(二零二二年:98,828,000港元)。湯臣一品為本集團之首要經營溢利來源。

此業務分類產生總收入459,870,000港元,佔本集團於二零二三年度之經營收益總額約81.05%,且該收入僅來自中國上海市浦東之項目。然而,本集團於浦東之投資物業於年結日錄得公平值變動所產生之未變現虧損109,255,000港元。位於香港及中國澳門特別行政區(「澳門」)之物業項目並無錄得任何收入。

Tomson Riviera, Shanghai

Tomson Riviera is a notable high-rise residential development along the riverfront of Lujiazui of Pudong and right opposite the Bund. There are four residential towers of which two towers are earmarked for sale while the other two towers are for leasing to maximize the return on investment.

As at 31st December, 2023, the total residential gross floor area available for sale of Towers A and C was approximately 3,200 square meters while of the total residential gross floor area of Towers B and D of approximately 58,400 square meters, about 67% was leased.

For the year 2023, total revenue of HK\$293.39 million was recognized and this accounted for approximately 51.71% of the gross proceeds from operations of the Group. The revenue was principally attributable to sale proceeds recognized with the rest derived from rental income and property management fee.

上海市湯臣一品

湯臣一品為一項著名的高樓住宅發展項目,聳立於浦東陸家嘴江畔,對望外灘。 該項目共有四棟住宅大樓,而為了對投 資帶來最大回報,其中兩棟大樓劃作銷 售,而另外兩棟大樓則作租賃用途。

於二零二三年十二月三十一日,A棟及 C棟大樓中約有總住宅樓面面積3,200平 方米可供出售,而B棟及D棟大樓之總住 宅樓面面積約58,400平方米中已租出約 67%。

於二零二三年度,已確認總收入約為 293,390,000港元,佔本集團之經營收益 總額約51.71%。收入主要來自已確認之 銷售收益,其餘則來自租金收入及物業 管理費。



TOMSON RIVIERA 湯臣一品









Commercial and Industrial Buildings, Shanghai

Rental income and property management fee from the Group's commercial and industrial property portfolio in Pudong, which comprised, inter alia, Tomson Commercial Building, Tomson International Trade Building, Tomson Waigaoqiao Industrial Park, the commercial podium of Tomson Business Centre and the office premises on the entire 72nd Floor of Shanghai World Financial Center, provided a steady recurrent revenue of HK\$90.71 million to the Group and this accounted for approximately 15.99% of the gross proceeds from operations of the Group for the year under review. Nevertheless, the Group recorded an unrealized net loss on fair value changes of the aforesaid investment properties of HK\$109.26 million in the annual results of the Group for the year 2023.

上海市之商業及工業物業

來自本集團位於浦東之商業及工業物業組合(其中包括湯臣金融大廈、湯臣國際貿易大樓、湯臣外高橋工業園區、湯臣商務中心大廈之商場部份及上海環球金融中心72樓全層辦公室物業)之租金收入及物業管理費為本集團帶來穩定之來入及物業管理費為本集團帶來穩定於回顧年度內之經營收益總額約15.99%。然而,本集團於二零二三年度之全年數頻上述投資物業錄得公平值變動所產生之未變現虧損淨額約109,260,000港元。

Miscellaneous Residential Developments in Shanghai

Tomson Golf Villas and Garden have been developed in phases around the periphery of Tomson Shanghai Pudong Golf Club in Pudong since 1996 and there are now less than ten residential units and around one hundred car parking spaces available for sale. During the year under review, the project recognized revenue of HK\$75.78 million from sale of both residential unit and car parking spaces as well as leasing of the residential units and this represented approximately 13.35% of the gross proceeds from operations of the Group.

In addition, the Group holds less than ten car parking spaces at Xingguo Garden, a residential development of the Group in Puxi, for sale.

上海市之其他住宅發展項目

湯臣高爾夫別墅及花園自一九九六年起沿位於浦東之湯臣上海浦東高爾夫球會周邊分期開發,現時僅餘不足十個住宅單位及約一百個停車位可供出售。於回顧年度內,該項目確認住宅單位及停車位銷售收入以及住宅單位租賃收入共約75,780,000港元,佔本集團之經營收益總額約13.35%。

此外,本集團在位於浦西之住宅發展項目-湯臣怡園中持有不足十個停車 位待售。

TOMSON GOLF VILLAS AND GARDEN

湯臣高爾夫別墅及花園





Jinqiao Town Project, Shanghai

The Group holds three land lots with aggregate site area of approximately 328,687.5 square meters located in Jinqiao Town of Pudong and to the north of a stream named Zhangjiabang for residential purpose. Real estate ownership certificates of the said land lots were obtained in June 2020. The project is known as "Tomson Foresta" and it is scheduled to complete the project development in six phases over the coming four years.

上海市金橋鎮項目

本集團持有位於浦東金橋鎮及一條名 為張家浜之河流北面地區內總地塊面 積約328,687.5平方米作住宅用途之三幅 土地。上述地塊之不動產權證已於二零 二零年六月取得。該項目名為「湯臣君 品」,現計劃於未來四年內分六期完成 開發該項目。

The first phase of the project is a low-density residential development with total gross floor area of approximately 25,900 square meters and the construction works are under way. Subject to the policies of and approval from the local government, it is expected to launch the first phase for sale in the second quarter of 2024 and deliver the properties to the buyers by the end of 2024.

Construction of the second and the third phases of the residential development of the project started in November 2022 and April 2023 respectively. There will be low-rise apartment buildings with total residential gross floor area of approximately 61,300 square meters and townhouses with total residential gross floor area of approximately 38,700 square meters. It is expected to complete the development of these two phases in 2026.

It is now targeted to carry out the construction of low-rise apartment buildings with total residential gross floor area of approximately 108,700 square meters in mid-2024 and resume in the end of 2024 the construction of a low-density residential development with total gross floor area of approximately 29,400 square meters, where the superstructure has been topped out.

The construction works of the last phase of the project are expected to commence in 2025 and will comprise townhouses with total residential gross floor area of approximately 55,800 square meters.


第一期項目為一項低密度住宅發展項目,總樓面面積約為25,900平方米,建築工程現正進行當中。視乎當地政府之政策及批覆,預期於二零二四年第二季推售第一期項目,並於二零二四年年底向買方交付物業。

第二期及第三期住宅發展項目分別於二 零二二年十一月及二零二三年四月開始動工興建。該等項目將提供總住宅樓 面面積約為61,300平方米的低層公寓大 樓及總住宅樓面面積約為38,700平方米 的聯排住宅。預期該兩期項目將於二零 二六年完成開發。

現目標旨在於二零二四年年中動工興建總住宅樓面面積約為108,700平方米的低層公寓大樓,並於二零二四年年底恢復一項總樓面面積約為29,400平方米的低密度住宅發展項目的施工,其主體結構已封頂。

最後一期項目將由總住宅樓面面積約為 55,800平方米的聯排住宅組成。預計建 築工程將於二零二五年開始動工。

TOMSON FORESTA 湯臣君品







One Penha Hill, Macau

The Group holds a 70% interest in the development of a residential condominium, namely One Penha Hill, at Penha Hill within a designated World Heritage Zone of Macau.

The project is earmarked for sale purpose and no revenue was generated during the year under review under the impact of poor market sentiment. As at 31st December, 2023, residential units with saleable area of approximately 6,700 square meters were available for sale.

澳門湯臣主教山壹號

本集團持有座落於澳門被列為世界遺產 區內之主教山上之住宅發展項目(即湯 臣主教山壹號)之70%權益。

該項目劃作銷售用途,於回顧年度內在市場氣氛低迷之影響下並無收入產生。 於二零二三年十二月三十一日,實用面 積約6,700平方米之住宅單位可供出售。

ONE PENHA HILL 湯臣主教山壹號





Office premises in Tower II, Admiralty Centre, Hong Kong

The Group acquired an office premises situated at the whole 13th Floor of Tower II, Admiralty Centre, Hong Kong by tender in 2022 as a strategic long-term investment for the Group. The Group recovered the possession of the property through legal procedures in the first half of 2023.

Having considered that the property is situated in a Grade A commercial-cum-office building in a strategic location in the key financial and commercial district in Hong Kong, the Group expects that the property will generate stable recurring rental income and it may be used as the Company's headquarter in Hong Kong at opportune time.

香港海富中心二座辦公室物業

本集團於二零二二年經投標方式購入位 於香港海富中心二座13樓全層的辦公室 物業作為本集團之一項策略性長期投資。 本集團已於二零二三年上半年透過法律 程序收回該物業的管有權。

經考慮該物業位於香港核心金融及商業 區之戰略性地點的甲級商辦大樓,本集 團預期該物業將產生穩定的經常性租金 收入,而本公司於適當時候可能將該物 業用作為香港之總部。

Hospitality and Leisure Industry

Tomson Shanghai Pudong Golf Club, Shanghai

The Group operates an 18-hole golf course of international standards, Tomson Shanghai Pudong Golf Club, in Pudong of Shanghai. The Club generated revenue of HK\$51,361,000, being approximately 9.05% of the gross proceeds from operations of the Group, and reported gross profit of HK\$26.33 million for the year ended 31st December, 2023. The revenue was mainly attributable to golfing activities of the Club and the annual membership fee was the secondary source of income. After making provision for depreciation of fixed assets, the Club reported a segment loss of HK\$4,132,000 for the year under review (2022: HK\$8,923,000).

款客及消閒業務

上海市之湯臣上海浦東高爾夫球會

本集團在上海市浦東經營一個符合國際標準的18個洞高爾夫球場一湯臣上海浦東高爾夫球會。該球會於截至二零二三年十二月三十一日止年度產生收入51,361,000港元,佔本集團經營收益總額約9.05%,並錄得毛利約26,330,000港元。收入主要來自該球會之高爾夫球活動,而年度會籍費用則為次要收入來源。經撥備固定資產之折舊後,該球會於回顧年度錄得分類虧損4,132,000港元(二零二二年:8,923,000港元)。

TOMSON SHANGHAI PUDONG GOLF CLUB 湯臣上海浦東高爾夫球會







InterContinental Shanghai Pudong, Shanghai

The Group holds a 50% interest in InterContinental Shanghai Pudong hotel in Lujiazui of Pudong. The hotel reported an average occupancy rate of approximately 71.20% during the year under review and the Group shared a net profit of HK\$22,645,000 from this investment (2022: net loss of HK\$15,289,000). The great improvement in results was mainly attributable to the recovery of economic activities in post pandemic era. In addition, during the year 2023, the hotel confirmed with the local government the amount of the rental for provision of quarters to the medical professionals from other provinces in the first half of 2022 when the COVID-19 spread in Shanghai and such amount was received in full. It is expected that the operation results of the hotel will be further improved in 2024. The hotel management will continue to focus on controlling operating costs, increasing marketing efforts on guest rooms operations and food and beverage operations to maintain the profitability of the hotel.

上海市之上海錦江湯臣洲際大酒店

本集團持有位於浦東陸家嘴之上海錦 江湯臣洲際大酒店之50%權益。該酒店 於回顧年度錄得平均入住率約71.20%, 而本集團從該項投資中攤分溢利淨額 22,645,000港元 (二零二二年:虧損淨額 15,289,000港元)。業績大幅改善主要歸 因於後疫情時代經濟活動復甦。此外, 於二零二三年內,酒店跟當地政府確認 就2019冠狀病毒病於二零二二年上半年 在上海市蔓延而為來自其他省份的醫務 人員提供宿舍的租金金額,且該款項已 全額收妥。預計該酒店於二零二四年的 經營業績將進一步改善。該酒店管理層 將繼續集中力量控制經營成本、加強客 房業務及餐飲業務之推廣,以維持酒店 之盈利。

Securities Trading

For the year under review, the Group's securities trading business in Hong Kong reported revenue of HK\$53,554,000 and this accounted for approximately 9.44% of the gross proceeds from operations of the Group. The revenue was mainly attributable to gross proceeds from sale of trading securities while the dividend income from those securities was the secondary source. After taking account of an unrealized gain on changes in fair value, the Group recorded a net gain on its trading securities investments of HK\$2,287,000 (2022: HK\$8,161,000).

As at 31st December, 2023, the aggregate fair value of the Group's listed securities investments held for trading amounted to HK\$49,257,000, representing approximately 0.27% of the Group's total assets. Those securities are in the property development and investment industry.

Media and Entertainment Business

The Group has participated in the production of live entertainment shows for years and has also set up its film distribution business. Gross revenue received and receivable from this segment for the year ended 31st December, 2023 amounted to HK\$2,579,000 and this accounted for approximately 0.46% of the Group's gross proceeds from operations. The revenue for the year under review was solely derived from investments in the production of live entertainment shows in Hong Kong and a segment loss of HK\$276,000 (2022: HK\$650,000) was recorded. The Group intends to continue in participating in investments in various live performances under appropriate conditions in the future.

證券買賣

於回顧年度內,本集團於香港之證券買賣業務錄得收入53,554,000港元,佔本集團之經營收益總額約9.44%。收入主要來自待售證券之銷售所得款項,其次是源自該等證券之股息收入。經計及公平值變動所產生之未變現收益,本集團錄得待售證券投資之收益淨額2,287,000港元(二零二二年:8,161,000港元)。

於二零二三年十二月三十一日,本集團之上市待售證券投資之公平值總額為49,257,000港元,佔本集團資產總值約0.27%。該等待售證券為物業發展及投資業之證券。

媒體及娛樂業務

本集團已參與現場表演節目製作多年,並建立了電影發行業務。於截至二零二三年十二月三十一日止年度,此分類之已收及應收總收入為2,579,000港元,佔本集團之經營收益總額約0.46%。於回顧年度內之收入僅來自香港現場表演節目製作之投資,並錄得分類虧損276,000港元(二零二二年:650,000港元)。本集團擬在未來適當的情況下繼續參與投資各類現場表演節目。





Investment Holding

In addition to its own property development projects, the Group holds a 13.483% interest in the registered capital of Shanghai Zhangjiang Micro-electronics Port Co. Ltd. ("SZMP") as a long-term equity investment and the fair value of this investment amounted to HK\$293,949,000, representing approximately 1.60% of the Group's total assets, as at 31st December, 2023. SZMP is an unlisted company established in Shanghai and is principally engaged in property development and investment in Shanghai. Dividend of HK\$18,470,000 (2022: HK\$22,054,000) was received from SZMP during the year under review and an unrealized loss on change in fair value of such investment of HK\$8,421,000 was charged to the investment reserve of the Group in 2023 (2022: gain of HK\$44,240,000) pursuant to applicable accounting standards.

Discloseable Transaction

As disclosed in the announcements published by the Company on 22nd September, 2023, 21st December, 2023 and 15th March, 2024, the Group has entered into an equity transfer agreement as supplemented by two supplemental agreements, pursuant to which the Group has agreed to sell and transfer 100% equity interest in Shanghai Cheng Qi Technology Limited, which is an indirect wholly owned subsidiary of the Company and holds the entire interests in a non-core project of the Group, Tomson Waigaoqiao Industrial Park, to an independent third party at a consideration of RMB405.84 million (the "Disposal"). Pursuant to the Rules Governing the Listing of Securities on the Stock Exchange, the Disposal constitutes a discloseable transaction of the Company. The Group has received 40% of the consideration and the Disposal is expected to be completed in mid-April 2024 upon receipt of the remaining 60% of the consideration.

投資控股

FINANCIAL REVIEW

Share Capital

The Company issued 81,122,062 new shares of HK\$0.50 each on 15th June, 2023 at a price of HK\$1.5998 per share to the shareholders of the Company who have elected to receive shares of the Company, credited as fully paid, in lieu of cash under scrip dividend scheme in respect of the interim dividend for the year ended 31st December, 2022. There were 2,052,147,187 issued shares in the capital of the Company as at 31st December, 2023.

Liquidity and Financing Position

As at 31st December, 2023, total assets of the Group decreased by approximately 2.31% to HK\$18,361,211,000 (2022: HK\$18,795,314,000). Equity attributable to owners of the Company was HK\$12,006,560,000 (2022: HK\$12,388,347,000) in total, representing a decrease of approximately 3.08% which was mainly attributable to depreciation in value of Renminbi during the year under review, while the equity attributable to owners of the Company per share amounted to approximately HK\$5.85 (2022: HK\$6.29).

The Group's operations and investments for the year ended 31st December, 2023 were funded by cash on hand, revenue from operating and investing activities, and bank borrowings.

At the end of the reporting period, the cash and cash equivalents of the Group amounted to HK\$3,541,040,000 (2022: HK\$3,966,071,000), a decrease of approximately 10.72%. During the year under review, the Group achieved net cash inflow of HK\$102,810,000 from its investing activities. After taking account of net cash outflows of HK\$299,903,000 and HK\$100,603,000 from its operating and financing activities respectively, the Group recorded a net decrease in cash and cash equivalents of HK\$297,696,000 during the year under review (2022: HK\$136,246,000). The net cash outflow was mainly attributable to the payment of construction cost of the properties under development of the Group.

財務回顧

股本

流動資金及財政狀況

於二零二三年十二月三十一日,本集團之資產總值減少約2.31%至18,361,211,000港元(二零二二年:18,795,314,000港元)。本公司權益持有人應佔權益總額為12,006,560,000港元(二零二二年:12,388,347,000港元),減少約3.08%,主要原因為於回顧年度內人民幣貶值,而本公司權益持有人應佔權益每股約5.85港元(二零二二年:6.29港元)。

本集團於截至二零二三年十二月三十一 日止年度之業務及投資所需資金來自手 頭現金、經營及投資業務之收入,以及 銀行借款。

於報告期末,本集團之現金及現金等值項目為3,541,040,000港元(二零二二年:3,966,071,000港元),減少約10.72%。於回顧年度內,本集團從其投資業務產生現金流入淨額102,810,000港元。經計及其經營業務及融資活動之現金流出淨額分別為299,903,000港元及100,603,000港元後,本集團於回顧年度錄得現金及現金等值項目淨額減少297,696,000港元(二零二二年:136,246,000港元)。現金流出淨額主要歸因於支付本集團發展中物業的建築成本。

Cash and cash equivalents of the Group are mainly denominated in the local currencies of the jurisdictions in which it operates. Hence, of the Group's cash and cash equivalents of HK\$3,541,040,000 as at 31st December, 2023, around 88.32% and 10.04% were denominated in Renminbi and Hong Kong Dollar respectively.

As at 31st December, 2023, of the liabilities of the Group of HK\$6,218,040,000 (2022: HK\$5,967,079,000 excluding contract liability which represented the deposits received from sale of properties), about 60.30% were tax payables under current liabilities, about 14.64% were deferred tax liabilities, about 17.39% were trade and other payables and accruals, about 6.04% were borrowings, about 1.35% were liabilities classified as held for sale and the remainder was lease liability. Details of the trade and other payables and accruals, lease liability, borrowings and deferred taxation are shown in Notes 24(d), 25, 27 and 28 to the consolidated financial statements of the Group for the year under review on pages 152 and 153, and pages 155 to 157 respectively.

The Group's borrowings as at 31st December, 2023 amounted to HK\$375,811,000 (2022: HK\$242,451,000), equivalent to approximately 3.13% (2022: 1.96%) of the equity attributable to owners of the Company at the same date. All of the borrowings were under security and subject to floating interest rates. Approximately 55.43% of the borrowings were denominated in Renminbi while the rest was denominated in Hong Kong Dollar. Of these borrowings, approximately 51.50% were due for repayment within one year from the end of the reporting period, approximately 6.93% were repayable more than one year but not exceeding two years from the end of the reporting period, approximately 20.79% were due for repayment more than two years but not exceeding five years from the end of the reporting period while the remaining 20.78% were repayable more than five years from the end of the reporting period. The Group did not employ any other financial instruments for financing and treasury management.

At the end of the reporting period, the Group had commitments in relation to expenditure on properties under development of HK\$2,308,957,000 (2022: HK\$384,951,000) which were contracted but not provided for. The increase in commitments was mainly attributable to the development of Jinqiao Town project in Shanghai. The Group anticipates that these commitments will be funded from its future operating revenue, bank borrowings and other sources of finance where appropriate.

As at 31st December, 2023, the Group recorded a current ratio of 2.05 times (2022: 2.12 times) and a gearing ratio (total liabilities to equity attributable to the owners of the Company) of 51.79% (2022: 49.15%). There was no significant change in the current ratio while a slight rise in the gearing ratio was mainly attributable to raising of new borrowing.

Charge on Assets

As at 31st December, 2023, assets of the Group with an aggregate carrying value of HK\$648,980,000 (2022: HK\$476,321,000) were pledged for securing the Group's borrowings of HK\$375,811,000 (2022: HK\$242,451,000). Details of the assets pledged are set out in Note 36 to the consolidated financial statements of the Group for the year under review on page 178.

Foreign Exchange Exposure

The majority of the Group's assets and liabilities are denominated in Renminbi, and the liabilities are well covered by the assets. Should there be a depreciation in value of Renminbi, there may be an adverse impact on the Group's results and net asset value. The other assets and liabilities of the Group are denominated in either Hong Kong Dollar or United States Dollar. Hence, the Group anticipates that the exchange risk exposure is manageable.

Contingent Liabilities

The Group had no material contingent liabilities as at 31st December, 2023 (2022: Nil).

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's financial situation, operating results and business prospects may be directly or indirectly affected by a number of risks and uncertainties including business risks, operational risks, financial risks and changes of local laws and regulations in the jurisdictions in which it operates. Information on the estimation uncertainty, capital risk management and financial risks management is set out respectively in Notes 4, 29 and 30(b) to the consolidated financial statements of the Group for the year under review on pages 117 to 119, and pages 158 to 171.

Property development and investment is the principal business segment of the Group and price fluctuation is a major risk that may affect the Group's results and asset value. The management holds a positive view of the potential demand from target customers for properties in Shanghai and Macau of China and will be cautious in formulating the Group's business plan and monitor closely the marketing and pricing strategies of the Group's property projects to maximize the return on investment.

There may be other risks and uncertainties in addition to those stated above which are not known to the Group or which may not be imminent or material now but could turn out to be impending or significant in the future.

PROSPECTS

Worldwide economy has been recovering in the post pandemic era. However, the recent Israel-Palestine conflict and prolonged military conflicts between Russia and Ukraine result in severe uncertainties in the financial and political situation of the whole world and other geo-political factors have further negatively affected the global economic development. The Group would keep monitoring the international situation closely especially when contemplating any future development, and any financial impact on the operations of the Group, should this happen, would be reflected in the financial statements of the Group for the year 2024. Whilst property development and investment will remain the focus of the Group's business and investment strategies, the Board would regularly review the business portfolio of the Group and prudently explore and evaluate other potential investment opportunities. It will be the objective of the Group to maintain an optimum balance in the allocation of its resources both geographically and in different business segments.

The property market will likely be volatile in the short term under the weight of high interest rates and subdued sentiment. The Board is cautiously optimistic about the economic development of the Mainland of China in the long run. The Group has built up its reputation as a developer of high-end residential properties in the Mainland and will endeavour to maintain the momentum in its sale and leasing plans for the property portfolio. It is anticipated that Tomson Riviera and One Penha Hill will be the Group's principal sources of profit in the year 2024. At the same time, the Group is actively carrying out the construction works and preparing for the

Discretionary bonus may be paid based on individual contribution.

On the other hand, the Company welcomes Mr Ng Chi Him to join the Board as an independent non-executive Director of the Company with effect from 1st January, 2023. It also expresses its sincere gratitude to Mr Sean S J Wang, who had retired by rotation at the conclusion of the annual general meeting of the Company in 2023 and did not seek for re-election, for his contributions to the Company during his tenure of office as an independent non-executive Director.

Taking this opportunity, the Board would like to express its gratitude to the management and all the staff members of the Group for their devotion and hard work over the years.

CORPORATE GOVERNANCE PRACTICES

The Company has applied the principles set out in Part 2 of Appendix C1 (previously known as Appendix 14) to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), the Corporate Governance Code (the "CG Code"), and has complied with the applicable code provisions contained therein during the year ended 31st December, 2023 and up to the date of this Report, except that:

(a) Madam Hsu Feng takes up both the posts of Chairman of the Board and Managing Director of the Company. While this is a deviation from the CG Code, dual role leadership provides the Company and its subsidiaries (collectively the "Group") with a strong and consistent leadership and allows for more effective operation of the business. The Board is of the view that adequate check and balance of power is in place. Responsibilities for the Company's daily business management are shared amongst Madam Hsu and other members of the executive committee of the Board. Besides, all major decisions are made in consultation with members of the Board or appropriate committees of the Board in accordance with the provisions of the code on risk management and internal control of the Group.

CORPORATE CULTURE

The Board has established the Group's purposes, values and strategies, and has satisfied itself that the Group's culture is aligned. Acting with integrity and leading by example, the Directors promote the desired culture to instill and continually reinforce across the Group the values of acting lawfully, ethically and responsibly. A healthy corporate culture is important to good corporate governance, which is crucial for achieving sustainable long-term success of the Group. The Group has adopted anti-corruption and whistleblowing policies to uphold business integrity in its operations, and to provide forums for reporting issues and concerns on any misconduct.

The Group is committed to seeking progress while maintaining stability and strives to improve operational efficiency and strengthen the risk control measures. Effective risk control will remain as the core competitiveness and investment highlight of the Group, while the Group will strive to explore other business opportunities.

In addition, the Group aspires to create an environment that values diversity. The Group takes into consideration diverse background, experience, perspectives and gender in staff recruitment and development. The gender ratio (male: female) in the workforce including senior management as at the end of the year under review was approximately 53:47.

THE BOARD

The Board commits itself to acting in the best interests of the Group and the shareholders of the Company. It is accountable to the shareholders for the long-term performance of the Group, while taking into consideration the interests of other stakeholders. Since the retirement of Mr Sean S J Wang as an independent non-executive Director at the conclusion of the Company's annual general meeting held on 8th June, 2023 (the "2023 AGM"), the Board is composed of six members, including three executive Directors, namely Madam Hsu Feng (Chairman and Managing Director), Mr Albert Tong (Vice-Chairman) and Mr Tong Chi Kar Charles (Vice-Chairman), and three independent non-executive Directors, namely Mr Cheung Siu Ping, Oscar, Mr Lee Chan Fai and Mr Ng Chi Him. The Board has established an executive committee, an audit committee, a nomination committee and a remuneration committee (collectively, the "Board Committees") to assist the operation of the Board.

Accordingly, in selection of candidates to the Board, the nomination committee of the Board (the "Nomination Committee") takes into account a range of measurable objectives, including but not limited to gender, age, cultural and educational background, professional experience and qualifications, skills, knowledge and length of service, having due regard to the Company's own business model and specific needs from time to time. The ultimate decision will be based on merit and contribution that the candidates will bring to the Board with due regard to the benefits of diversity on the Board. During the year under review, the Nomination Committee has conducted an annual review of the structure, size and composition of the Board with reference to the above measurable objectives and the implementation and effectiveness of the Diversity Policy and the Nomination Committee agreed that the diversity of the Board was achieved. With reference to the opinion from the Nomination Committee, the Board considers that its members coming from a variety of business and professional background, the Board has an appropriate size and balanced structure and composition with diverse mix of skills, experience, expertise and diversity of perspectives appropriate to the requirements of the Company's business and development.

In addition, there are one female Director and five male Directors, so the Board considers that the Company has achieved gender diversity at the Board level and targets to maintain at least the current level of female representation. The Company will ensure that gender diversity is taken into account when recruiting staff members of senior level and ensure that sufficient resources are available for providing appropriate trainings and career development to develop a pipeline of potential successors to the Board and maintain gender diversity.

All the Directors have signed service contracts or letters of appointment with the Company which set out the key terms and conditions of their appointment. Biographical details of the existing Directors and relevant relationships among them together with their respective roles on the Board and its committees are set out in the Profile of the Directors and Officers on pages 40 to 44.

All existing Directors have disclosed to the Company the offices held in other public companies or organisations and the time involved and the Company has received confirmations from each Director that he/she has devoted sufficient time to perform his/her responsibilities as a Director and has given sufficient attention to the affairs of the Company during their tenure of office.

Throughout the year 2023, not less than one-half of the Board members were independent non-executive Directors. Since the retirement of Mr Sean S J Wang at the conclusion of the 2023 AGM, there are three independent non-executive Directors of the Company representing one-half of the Board and one of them has appropriate professional accounting qualifications as required by the Listing Rules. The independent non-executive Directors have contributed valuable independent views and proposals for the Board's deliberation and decisions. The Company has received a written confirmation from each of the incumbent independent non-executive Directors of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules and considers all of the independent non-executive Directors to be independent.

None of the independent non-executive Directors of the Company are appointed for a specific term, but they are subject to retirement and re-election at least once every three years at annual general meetings of the Company pursuant to the Articles of Association of the Company (the "Articles").

The Board has reserved for its decision or consideration matters covering formulation of corporate strategies, approval of annual and interim results, changes of members of the Board and its committees, major acquisitions, disposals and capital transactions, and monitoring and controlling other significant operational and financial matters of the Group. The Board Committees oversee particular aspects of the Company's affairs and assist in sharing the Board's responsibilities according to their respective clear written terms of reference. The Board Committees report regularly to the Board on their decisions and recommendations.

The Company has also established mechanisms to ensure independent views are available to the Board. This is achieved by maintaining an appropriate proportion of independent non-executive Directors in the Board and providing the Directors with sufficient resources to perform their duties including, inter alia, seeking, at the Company's expenses, external independent professional advice, if necessary, as well as encouraging all Directors to express freely their independent views and opinions during the Board meetings or the Board Committees' meetings. On the recommendation from the Nomination Committee after conducting an annual review, the Board considers that the implementation of mechanisms is effective.

The day-to-day management, administration and operation of the Group are delegated to the management and the management also provides support to the Board to formulate overall strategic direction, long term objectives and business plans of the Group. Both the Board and the management have clearly defined authorities and responsibilities under various risk management, internal control and check-and-balance mechanisms. The management is responsible for implementing the strategies and plans adopted by the Board and the Board Committees and assumes full accountability to the Board for the operation of the Group.

The Board meets regularly throughout the year and as and when required. Sufficient notices are given to all Directors at least 14 days before the regular Board meetings. All Directors are consulted whether to include any matters in the agenda. Agenda and accompanying board papers are given to all Directors in a timely manner before the appointed date of each regular Board meeting. Drafts and final versions of minutes are circulated to the Directors for comment and record respectively. During the year 2023, there were four regular Board meetings. Besides, a Vice-Chairman of the Board had an annual meeting in 2023 to exchange opinions with the independent non-executive Directors of the Company without the presence of the other Directors.

All members of the Board have been provided with monthly management updates to keep them up-to-date with material developments of the Group's operations, performance, financial position and prospects. The Board has agreed on a procedure to enable the Directors to seek external independent professional advice whenever deemed necessary, at the Company's expense, to assist them to perform their duties.

The Company has arranged appropriate liability insurance to indemnify its Directors for their liabilities arising out of the discharge of their duties. The insurance coverage is reviewed on an annual basis.

Corporate Governance Functions

The Company strives to attain and maintain high standards of corporate governance best suited to the needs and interests of the Group. Good corporate governance is crucial to an orderly and effective operational system, which will enhance operational efficiencies, thereby bolstering shareholder value. The Board is responsible for the corporate governance functions. During the year ended 31st December, 2023, the Board has discharged the following corporate governance duties:

- (a) review the Company's policies and practices on corporate governance;
- (b) review and monitor the Company's policies and practices on compliance with legal and regulatory requirements, including reviewing and revising the provisions of the code on risk management and internal control of the Group;
- review, monitor and revise the Company's code of practice for securities transactions by the Directors and relevant employees (the "Code of Practice for Securities Transactions");
- (d) review the Company's compliance with the code provisions of the CG Code and relevant disclosure in interim and annual reports; and
- (e) arrange seminars and briefings to Directors, review and monitor the training and continuous professional development of the Directors, details of which are set out in the paragraph headed "Directors' Induction and Continuous Professional Development" in this Report.

- (e) 為董事安排培訓課程及簡報,檢討 及監察董事的培訓及持續專業發 展,詳情載於本報告內標題為「董 事之入職指引及持續專業發展」一 節。

Executive Committee

An executive committee (the "Executive Committee") was established by the Board in June 2005 with specific written terms of reference. The Executive Committee is composed of all the executive Directors of the Company, namely Madam Hsu Feng, Mr Albert Tong and Mr Tong Chi Kar Charles. Madam Hsu Feng is the chairman of the Executive Committee. The Executive Committee may convene meetings as it considers necessary for reviewing and approving, inter alia, any matters concerning the day-to-day management of the business of the Company and any matters to be delegated to it by the Board from time to time.

Audit Committee

An audit committee (the "Audit Committee") was set up by the Board in April 1999 with specific written terms of reference. The Audit Committee is composed of all the independent non-executive Directors of the Company at all times during the year under review. Subsequent to the retirement of Mr Sean S J Wang and up to the date of this Report, Mr Cheung Siu Ping, Oscar, Mr Lee Chan Fai and Mr Ng Chi Him are the members of the Audit Committee. The Audit Committee is chaired by Mr Cheung Siu Ping, Oscar who possesses appropriate professional accounting qualifications as required under the Listing Rules.

Under its terms of reference, the Audit Committee is required to monitor the integrity of the financial statements of the Company, to review significant financial reporting judgements, to evaluate the overall effectiveness of the risk management and internal control systems of the Group, and to oversee the relationship with the Company's auditor (the "Auditor"). The terms of reference of the Audit Committee are available on the Company's website.

During the year 2023, the Audit Committee held three meetings for reviewing the interim and annual financial statements as well as the accounting and financial reporting matters of the Group; evaluating the risk management and internal control systems of the Group, the significant risks faced by the Group and also the resource adequacy and effectiveness of internal audit function; reviewing the internal audit and enterprise risk assessment reports of the Group for approval by the Board; reviewing the Group's whistleblowing policy and considering the engagement and scope of services and the remuneration of the Auditor.

根據審核委員會之職權範圍,審核委員 會須監察本公司財務報表的完整性,審 閱財務申報之重大意見,評估本集團之 風險管理及內部監控系統之整體效益, 以及監督與本公司核數師(「核數師」)的 關係。審核委員會之職權範圍書已載於 本公司網站上。

於二零二三年度內,審核委員會共舉行了三次會議,以審閱本集團的中期和年度財務報表以及審視會計和財務匯報報。 宣;檢討本集團的風險管理及內部監監內 系統、本集團所面對的重大風險以及等 系統、本集團所面對的重大風險以及; 不集團所面對的重大風險以及; 不集團之內部審核及企業風險評估報 也以供董事局審批;審視本集團之舉 對師提供的服務範疇以及其酬金。 The Audit Committee concluded that in 2023 the risk management and internal control systems of the Group and the internal audit function of the Company were implemented effectively. The Audit Committee was satisfied with the related resources of the internal audit function and the resources, staff qualifications and experience, training programmes and related budget of the Company's accounting and financial reporting functions as well as the implementation, application and effectiveness of the whistleblowing policy of the Group.

In March 2024, the Audit Committee held a meeting to review the annual consolidated financial statements of the Group for 2023 and consider the re-appointment and proposed remuneration of the Auditor. On the recommendation of the Audit Committee, the Board resolved to submit the consolidated financial statements for review and to propose the re-appointment and proposed remuneration of the Auditor for approval by the shareholders at the annual general meeting of the Company for 2024 (the "2024 AGM").

Nomination Committee

The Nomination Committee was established by the Board with effect from 31st December, 2021 with specific written terms of reference. The terms of reference of the Nomination Committee are available on the Company's website. Subsequent to the retirement of Mr Sean S J Wang and up to the date of this Report, Mr Cheung Siu Ping, Oscar, Mr Lee Chan Fai and Mr Ng Chi Him, being all independent non-executive Directors of the Company, and Mr Albert Tong, an executive Director of the Company, are members of the Nomination Committee while Mr Cheung Siu Ping, Oscar acts as the chairman of the Nomination Committee.

The Nomination Committee is responsible for reviewing the Board structure, size and composition (including the skills, knowledge and experience of the Board members), and makes recommendations on any proposed changes to the Board. The Nomination Committee is also responsible for assessing the independence of the independent non-executive Directors and makes recommendations to the Board on the appointment or re-election of Directors and succession planning for Directors. The Board has adopted a director nomination policy that the Nomination Committee will evaluate and recommend candidates for directorship to the Board by giving due consideration to the criteria, including but not limited to gender, age, cultural and educational background, professional experience and qualifications,

At the 2023 AGM, Mr Ng Chi Him, who was appointed as an independent non-executive Director of the Company with effect from 1st January, 2023, was subject to retirement while Madam Hsu Feng was subject to retirement by rotation. The Nomination Committee recommended the Board to propose re-election of Mr Ng and Madam Hsu as Directors at the 2023 AGM and they were duly re-elected.

Pursuant to the Articles, Mr Albert Tong and Mr Lee Chan Fai shall retire by rotation at the 2024 AGM. Having considered the selection criteria of the Company including the review of the overall contribution and service to the Company and a range of diversity perspectives at a meeting held in March 2024, the Nomination Committee recommended to the Board to propose re-election of Mr Tong and Mr Lee as Directors at the 2024 AGM.

In addition, Mr Lee Chan Fai has been serving on the Board as an independent non-executive Director for more than eighteen years since his appointment in 2005. According to the requirement of the CG Code, further appointment of Mr Lee shall be subject to a separate resolution to be approved by the shareholders of the Company. The Company shall state in the circular in respect of the 2024 AGM the reasons why the Board considers Mr Lee is still independent and the Company's recommendation to its shareholders to vote in favour of the re-election of Mr Lee.

Remuneration Committee

A remuneration committee (the "Remuneration Committee") was established by the Board in June 2005 with specific written terms of reference. The terms of reference of the Remuneration Committee are available on the Company's website. The principal duties of the Remuneration Committee are to make recommendations to the Board on the Company's policy and structure for all Directors and senior management's remuneration and the remuneration packages of individual Directors and senior management of the Company. Subsequent to the retirement of Mr Sean S J Wang and up to the date of this Report, Mr Cheung Siu Ping, Oscar, Mr Lee Chan Fai and Mr Ng Chi Him, being all independent non-executive Directors of the Company, and Mr Albert Tong, an executive Director of the Company, are members of the Remuneration Committee while Mr Cheung Siu Ping, Oscar acts as the chairman of the Remuneration Committee.

According to the remuneration policy of the Company, no Director or any of his or her associates is involved in deciding his or her own remuneration. The remuneration of the Directors and senior management of the Company is determined with reference to their expertise and experience, level of responsibility, the performance and remuneration benchmarks from other companies and prevailing market conditions.

During the year 2023, a meeting of the Remuneration Committee was held for an annual review of the remuneration policy and packages for all the Directors and senior management of the Company. Details of the emoluments paid to the Directors and senior management of the Company for the year ended 31st December, 2023 are set out in Note 11 to the consolidated financial statements on pages 130 to 132.

The Board, based on the review of the Audit Committee, considered that the Group's risk management and internal control systems had been adequate and effectively implemented and the Group had complied with the provisions on risk management and internal control as set out in the CG Code and the Group's code on risk management and internal control during the year ended 31st December, 2023.

An external service provider has been engaged for providing internal audit services to the Group during the year under review. The Board reviewed and approved, after a review made by the Audit Committee, the internal audit and enterprise risk assessment reports of the Group for 2023.

The Board also considered that, after a review made by the Audit Committee, the Group's internal audit function had been effectively implemented and adequately resourced with experienced external service provider in 2023 and the resources, staff qualifications and experience, training programmes and related budget of the Company's accounting and financial reporting functions were adequate.

EXECUTIVE DIRECTORS

Madam Hsu Feng, aged 73, has been a director of the Company and its subsidiaries (collectively the "Group") since January 1990 and now acts as an executive Director of the Company. She was appointed Managing Director of the Company in December 2001 and the chairman of the executive committee of the Board of Directors of the Company (the "Board") in June 2005. She was also elected as Chairman of the Board in December 2006.

Madam Hsu has been engaged in the property development, and hospitality and leisure business in the Mainland of the People's Republic of China ("China") over three decades. She is also the Honorary Consul of the Principality of Monaco in Shanghai, China. She has been a director of Rivera (Holdings) Limited ("RHL") since 1990. RHL had been a listed company in the Hong Kong Special Administrative Region ("Hong Kong") of China since 1970's and withdrew the listing of its shares on the Main Board of The Stock Exchange of Hong Kong Limited in August 2021. RHL has been engaged in property development and investment. In addition, she has over 10 years' experience in film production, and in property development and investment as well as retail industry in Taiwan.

Madam Hsu Feng is the mother of Mr Albert Tong and Mr Tong Chi Kar Charles, who are Vice-Chairmen of the Board and executive Directors of the Company. Madam Hsu, Mr Albert Tong and Mr Tong Chi Kar Charles (collectively "Tong Family") are all directors of Step Famous Investment Limited ("Step Famous") and altogether hold the entire interests in the issued capital of Step Famous. In addition, both Madam Hsu and Mr Albert Tong are directors of King China Holdings Limited ("King China") while Tong Family are all directors of E-Shares Investments Limited ("E-Shares"). Madam Hsu is the owner of King China and E-Shares. Mr Albert Tong, Mr Tong Chi Kar Charles and King China are substantial shareholders of the Company while Step Famous and E-Shares are shareholders of the Company. All of them have notifiable interests in the Company under Part XV of the Hong Kong Securities and Futures Ordinance (the "SFO").

As at the date of the Report of the Directors, pursuant to the SFO, Madam Hsu is interested and taken to be interested in a total of 857,764,478 issued shares of the Company.

Mr Albert Tong, aged 41, has been appointed an executive Director of the Company since December 2001 and a member of the executive committee and remuneration committee of the Board since June 2005. He was elected as Vice-Chairman of the Board in December 2006. He has also been appointed to act as a member of the nomination committee of the Board with effect from December 2021. He has joined the Group and taken up directorships of the subsidiaries of the Company since March 2001. He has actively participated in the Group's business development, corporate management, property trading and securities investment for more than two decades. He also has been a director of RHL since March 2001.

Mr Albert Tong is a son of Madam Hsu Feng, Chairman of the Board and Managing Director of the Company, and the younger brother of Mr Tong Chi Kar Charles, Vice-Chairman of the Board and executive Director of the Company. They all are directors of Step Famous and altogether hold the entire interests in the issued capital of Step Famous. They are also directors of E-Shares. In addition, both Mr Albert Tong and Madam Hsu Feng are directors of King China. Madam Hsu is a controlling shareholder of the Company, Mr Tong Chi Kar Charles and King China are substantial shareholders of the Company while Step Famous and E-Shares are shareholders of the Company. All of them have notifiable interests in the Company under Part XV of the SFO.

As at the date of the Report of the Directors, pursuant to the SFO, Mr Albert Tong is interested in 304,108,315 issued shares of the Company.

The total of the annual basic salary and housing allowance of Mr Albert Tong for his services in management of the Company has been increased from HK\$3,325,000 to HK\$3,378,300 with effect from 1st January, 2024, which was approved by the Board on recommendation of its remuneration committee with reference to his responsibilities and prevailing market conditions.

The Group provides competitive remuneration packages and makes regular review to attract and motivate its employees. Remuneration and benefits packages are generally structured by reference to market terms, individual responsibilities, performance and qualifications.

Directors' emoluments are determined with reference to their responsibilities and prevailing market conditions. The emoluments of the executive Directors of the Company for their services in management of the Group are determined by the Board on the recommendation of its remuneration committee (the "Remuneration Committee"). The fees of the independent non-executive Directors of the Company are fixed by the Board under the authorization of the shareholders of the Company and on the recommendation of the Remuneration Committee.

PENSION SCHEMES

The Company participates in a pension scheme, which was registered under the Hong Kong Mandatory Provident Fund Schemes Ordinance (the "MPF Ordinance"), for all its employees in Hong Kong. The scheme is a defined contribution scheme effective from December 2000 and is funded by contributions from employer and employees in accordance with the provisions of the MPF Ordinance. If the employer makes any voluntary contributions for the employees under the scheme, forfeited contributions in this nature can be applied to reduce the amount of future voluntary contributions payable by the employer.

The employees of the Group in the Mainland of China are members of respective state-managed defined contribution retirement benefits schemes operated by the local governments. The employers and the employees are obliged to make contributions at a certain percentage of the payroll under rules of the schemes.

Furthermore, the Group and its employees in the Macao Special Administrative Region ("Macau") of China shall make contributions of a fixed amount per quarter to the Social Security Fund under the obligation system pursuant to the laws of Macau.

OPINION

We have audited the consolidated financial statements of Tomson Group Limited (the "Company") and its subsidiaries (collectively referred to as "the Group") set out on pages 68 to 190 which comprise the consolidated statement of financial position as at 31st December, 2023, and the consolidated statement of profit or loss, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information and other explanatory information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31st December, 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

我們認為,該等綜合財務報表已根據香港會計師公會頒佈的《香港財務報告準則》真實而中肯地反映了 貴集團於二零二三年十二月三十一日的綜合財務狀況及截至該日止年度的綜合財務表現及綜合現金流量,並已遵照香港《公司條例》的披露要求妥為擬備。

我們已根據香港會計師公會頒佈的《香港審計準則》進行審計。我們在該等準則下承擔的責任已在本報告書「核數師就審計綜合財務報表承擔的責任」部份中作進一步闡述。根據香港會計師公會頒佈的《專業會計師道德守則》(「守則」),我們獨立於 貴集團,並已履行,則」),我們獨立於 貴集團,並已履行守則中的其他專業道德責任。我們相信,我們所獲得的審計憑證能充足及適當地為我們的審計意見提供基礎。

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Valuation of investment properties

We identified the valuation of investment properties as a key audit matter due to the significance of the assets and involvement of the management judgement and estimation in determining the fair value.

The fair value of investment properties (which included commercial properties, residential properties and industrial properties in Shanghai of the People's Republic of China (the "Mainland China")) at 31st December, 2023 was HK\$6,993,381,000 with loss on fair value changes recognised in the consolidated statement of profit or loss of HK\$109,255,000 for the year then ended.

As disclosed in Notes 4 and 15 to the consolidated financial statements, in estimating the fair value of these investment properties, the Group engaged a professional independent valuer (the "Valuer") to establish and determine the appropriate valuation technique and inputs to the valuation. The valuation was arrived by capitalising the net rental income derived from existing tenancies with due allowance for reversionary income potential of the properties on a recurring basis. This involves making certain assumptions and the use of estimates in respect of the reversionary yield by the Valuer. A slight increase in the reversionary yield would result in a significant decrease in fair value, and vice versa.

關鍵審計事項

關鍵審計事項是根據我們的專業判斷, 認為對本期綜合財務報表的審計最為重要的事項。這些事項是在我們審計整體 綜合財務報表及出具意見時進行處理的。 我們不會對這些事項提供單獨的意見。

投資物業估值

我們識別投資物業的估值為關鍵審計事項,因其涉及的資產重大和涉及管理層的判斷及估計來釐定其公平值。

於二零二三年十二月三十一日,投資物業(包括位於中華人民共和國上海市(「中國內地」)的商用物業、住宅物業及工業物業)的公平值為6,993,381,000港元,在截至該日止年度的綜合損益表中確認的公平值變動時產生之虧損為109,255,000港元。

於綜合財務報表附註4及15中披露,在估計投資物業的公平值時, 貴集團聘請獨立專業估值師(「估值師」)以設立及釐定合適估值技術及估值之輸入數據包括值乃透過按經常性原則資本化來自稅在值方透過按經常性原則資本化來自稅在值人不過數人之潛力。這涉及估值師作出業復歸收入之潛力。這涉及估值師作出表干假設及使用有關復歸收益率之估計。復歸收益率輕微上升將導致公平值大幅下跌,反之亦然。

How our audit addressed the key audit matter

Our procedures in relation to the valuation of investment properties included:

- Evaluating the competence, capabilities and objectivity of the Valuer;
- Obtaining an understanding of the valuation process and significant assumptions and critical judgement areas from the management to assess if the investment approach is appropriate for the respective properties and industry norms;
- Evaluating the appropriateness of the estimations used, in particular, the underlying assumptions and methodologies, based on our knowledge of the properties market of the relevant locations; and
- Assessing the reasonableness of the key inputs used by the Valuer in the valuation model, including the reversionary yield, net rental income derived from existing tenancies and annual unit market rental by comparing them against current market data and entity specific information on a sample basis.

Provision for land appreciation tax

We identified the provision for land appreciation tax ("LAT") calculations as a key audit matter since significant judgement and estimation are required in determining the amount of LAT to be paid by the Group within each of the property development projects.

The Group is subject to LAT in the Mainland China. As disclosed in Note 12 to the consolidated financial statements, the Mainland China LAT of HK\$111,150,000 was recognised in the consolidated statement of profit or loss for the year ended 31st December, 2023. The Group had provision for LAT payable amounted to HK\$3,729,394,000 as at 31st December, 2023.

LAT has been provided at ranges of progressive rates of the appreciation value, with certain allowable deductions including land costs, borrowing costs and the relevant property development expenditures, which are the key inputs in the calculation of the LAT based on the management's best estimates.

我們就投資物業估值執行的程序包括:

- 評估估值師的資歷、能力及客觀性;
- 從管理層取得對估值過程、重大假設及重要判斷的瞭解,以評估投資方式是否符合相關物業及行業規範;
- 根據我們對相關地點的房地產市場的知識,評估所用之估算的適當性,特別是相關假設及方法;及
- 評估估值師在估值模型中所採用之關鍵輸入數據的合理性,包括復歸收益率、來自現有租賃之租金收入淨額及單位市場年度租金,並抽樣與目前市場數據及實體特定資料進行比較。

土地增值税撥備

我們識別土地增值税撥備的計算為關鍵 審計事項,因其涉及重大判斷及估計來 釐定 貴集團在每一個物業發展項目中 需要支付的土地增值税。

貴集團須繳納中國內地之土地增值税。 於綜合財務報表附註12中披露,截至二 零二三年十二月三十一日止年度的綜合 損益表中確認的土地增值税為 111,150,000港元。於二零二三年十二月 三十一日, 貴集團的應付土地增值税 撥備金額為3,729,394,000港元。

於計及根據管理層之最佳估計以計算土 地增值稅之關鍵輸入數據,即若干獲准 扣減項目(包括土地成本、借貸成本及 相關物業發展開支)後,已就增值部份 按一系列遞增稅率作出土地增值稅撥備。

How our audit addressed the key audit matter

Our procedures in relation to the provision for LAT included:

- Obtaining an understanding from the management of the Group about the basis adopted in arriving at the provision for LAT;
- Assessing the Group's provision for LAT computation prepared by the management of the Group with reference to relevant rules and regulations with the assistance of our tax specialists; and
- Checking the financial information, including land costs, borrowing costs and relevant development expenditures, used in the calculation of provision for LAT to the Group's historical financial data.

OTHER INFORMATION

The directors of the Company are responsible for the other information. The other information comprises the information included in the annual report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

The SSR may be converted to increase capital subject to certain restrictions set out in the Company Law of the Mainland China.
- (e) Of the retained earnings of HK\$9,585,651,000 (2022: HK\$9,410,846,000), retained earnings of HK\$18,369,000 (2022: accumulated losses of HK\$4,276,000) and accumulated losses of HK\$6,369,000 (2022: HK\$4,325,000) are attributable to a joint venture and associates of the Group respectively.

GENERAL INFORMATION

The Company is a public limited company incorporated in the Cayman Islands and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

The Practice Statement is also amended to illustrate how an entity applies the "four-step materiality process" to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. Guidance and examples are added to the Practice Statement.

Change in accounting policy as a result of application of the HKICPA guidance on the accounting implications of the abolition of the Mandatory Provident Fund ("MPF") – Long Service Payment ("LSP") offsetting mechanism in Hong Kong

The Company is operating in Hong Kong which is obliged to pay LSP to employees under certain circumstances. Meanwhile, the Company makes mandatory MPF contributions to the trustee who administers the assets held in a trust solely for the retirement benefits of each individual employee. Offsetting of LSP against an employee's accrued retirement benefits derived from employers' MPF contributions was allowed under the Hong Kong Employment Ordinance (Cap.57). In June 2022, the Hong Kong Government gazetted the Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the "Amendment Ordinance") which abolishes the use of the accrued benefits derived from employers' mandatory MPF contributions to offset severance payment and LSP (the "Abolition"). The Abolition will officially take effect on 1st May, 2025 (the "Transition Date"). In addition, under the Amendment Ordinance, the last month's salary immediately preceding the Transition Date (instead of the date of termination of employment) is used to calculate the portion of LSP in respect of the employment period before the Transition Date.

In July 2023, the HKICPA published "Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong" which provides guidance for the accounting for the offsetting mechanism and the impact arising from abolition of the MPF-LSP offsetting mechanism in Hong Kong. In light of this, the Group has implemented the guidance published by the HKICPA in connection with the LSP obligation retrospectively so as to provide more reliable and more relevant information about the effects of the offsetting mechanism and the Abolition.

The Group considered the accrued benefits arising from employer MPF contributions that have been vested with the employee and which could be used to offset the employee's LSP benefits as a deemed contribution by the employee towards the LSP. The consolidated financial statements have been prepared in accordance with HKFRSs issued by HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules") and by the Hong Kong Companies Ordinance.

The Directors of the Company have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis, except for investment properties and certain financial instruments, which are measured at fair values, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. The results of subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date of the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by the Group.

All significant inter-group transactions, balances, income and expenses are eliminated on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interest entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Goodwill

Goodwill arising on an acquisition of net assets and operations of another entity for which the agreement date is before 1st January, 2005 represents the excess of the cost of acquisition over the Group's interest in the fair value of the identifiable assets and liabilities of the relevant acquiree at the date of acquisition.

From 1st January, 2005 onward, the Group will carry goodwill at cost less any accumulated impairment losses.

Goodwill arising on an acquisition of a business is presented separately in the consolidated statement of financial position.

For the purposes of impairment testing, goodwill arising from an acquisition is allocated to each of the relevant cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the acquisition. A cash-generating unit to which goodwill has been allocated is tested for impairment annually, and whenever there is an indication that the unit may be impaired. For goodwill arising on an acquisition in a financial year, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that financial year. When the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is allocated to reduce the carrying amount of any goodwill allocated to the unit first, and then to the other assets of the unit pro rata on the basis of the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in the consolidated statement of profit or loss. An impairment loss for goodwill is not reversed in subsequent periods.

On subsequent disposal of the relevant cash-generating unit, the attributable amount of goodwill capitalised is included in the determination of the amount of profit or loss on disposal.

Interests in associates and joint ventures

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of associates and joint ventures are incorporated in these consolidated financial statements using the equity method of accounting. Under the equity method, investments in associates or joint ventures are carried in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture, less any identified impairment loss. When the Group's share of losses of an associate or a joint venture exceeds its interest in that associate or joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate or joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payment on behalf of that associate or joint venture.

The associate's and joint venture's financial statements used for the application of equity method of accounting are prepared using uniform accounting policies with the Group for transactions and events in similar circumstances.

Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

Any excess of the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities over the cost of acquisition, after reassessment, is recognised immediately in the consolidated statement of profit or loss. When a group entity transacts with an associate or a joint venture of the Group, profits or losses are eliminated to the extent of the Group's interest in the relevant associate or joint venture.

The difference between the carrying amount of the associate or joint venture and the fair value of any retained interest, and any proceeds from disposing of the relevant interests is included in the determination of the gain or loss on disposal of the associate or joint venture. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate or joint venture on the same basis as would be required if that associate or joint venture had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate or joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate or joint venture.

Non-current assets held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving loss of control of a subsidiary, all of the assets and liabilities of that subsidiary are classified as held for sale when the criteria described above are met, regardless of whether the Group will retain a non-controlling interest in its former subsidiary after the sale.

The Group performs impairment assessment under expected credit losses ("ECL") model on financial assets (including trade and other receivables, amount due from an associate, pledged bank deposit, bank deposit and bank balances) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment is done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables individually.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. For a lease receivable, the cash flows used for determining the ECL is consistent with the cash flows used in measuring the lease receivable in accordance with HKFRS 16.

Gains or losses arising from changes in the fair value of investment property are included in the consolidated statement of profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use or no future economic benefits is expected from its disposals. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the consolidated statement of profit or loss in the year in which the property is derecognised.

Property, plant and equipment

Property, plant and equipment, including leasehold land and buildings held for use in the production or supply of goods or services, or for administrative purposes, are stated at cost less accumulated depreciation and accumulated impairment losses, if any.

If a property becomes an investment property because its use has changed as evidenced by end of owner-occupation, any difference between the carrying amount and the fair value of that item (including the relevant leasehold land classified as right-of-use assets) at the date of transfer is recognised in other comprehensive income and accumulated in revaluation reserve. On the subsequent sale or retirement of the property, the relevant revaluation reserve will be transferred directly to retained earnings.

Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in the consolidated statement of profit or loss in the year in which the item is derecognised.

Ownership interests in leasehold land and building

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "right-of-use assets" under property, plant and equipment in the consolidated statement of financial position except for those that are classified and accounted for as investment properties under the fair value model. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model.

Changes in considerations of lease contracts that were not part of the original terms and conditions are accounted for as lease modifications, including lease incentives provided through forgiveness or reduction of rentals.

Refundable rental deposits received are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

The recoverable amounts of its fixed assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero value. Properties held for sale/properties under development (current asset)

Except for the leasehold land element which is measured at cost model in accordance with the accounting policies of right-of-use assets, properties held for sale/properties under development (current asset) are stated at the lower of cost/ deemed cost and estimated net realisable value. Cost is determined on a specific identification basis including allocation of the related development expenditure incurred and where appropriate, borrowing costs capitalised. Net realisable value represents the estimated selling price less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale. No depreciation charge is made on the leasehold lands included in the properties held for sale/properties under development (current asset). Properties under development which are intended for sale in the ordinary course of business upon completion are classified as current assets.

Properties under development are transferred to properties held for sale upon completion.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct goods or service.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from customer.

The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the goods or services transferred to the customer to date relative to the remaining goods or services promised under the contract, that best depict the Group's performance in transferring control of goods or services.

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained.

The Group recognises sales commissions as an asset if it expects to recover these costs. The asset so recognised is subsequently charged to the consolidated statement of profit or loss when the Group transfers to the customer of the relevant goods to which the assets relate.

The Group applies the practical expedient of expensing all incremental costs to obtain a contract if these costs would otherwise have been fully amortised to profit or loss within one year.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity "foreign currencies" are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date.

Exchange differences on monetary items are recognised in consolidated statement of profit or loss in the period in which they arise except for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to the consolidated statement of profit or loss on disposal or partial disposal of the Group's interest in associates/a joint venture.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group at the rate of exchange prevailing at the end of the reporting period, and their income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of foreign currencies translation reserves (attributed to non-controlling interests as appropriate). Such exchange differences accumulated in equity in respect of that operations attributable to the owners of the Company are reclassified to the consolidated statement of profit or loss in the period in which the foreign operation is disposed of.

Taxation

Taxation represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such deferred tax is not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and interests in associates and joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred taxes for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time. If the presumption is rebutted, deferred tax for such investment properties are measured in accordance with the general principles set out in HKAS 12 "Income Taxes" (i.e. based on the expected manner as to how the properties will be recovered).

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Cash and cash equivalents

Cash and cash equivalents include cash in hand and held at call deposits with banks with original maturities of three months or less.

Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

For the purposes of measuring deferred tax arising from investment properties that are measured using the fair value model, the Directors of the Company have reviewed the Group's investment property portfolios and concluded that the certain Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time. Therefore, in measuring the Group's deferred taxation on investment properties, the Directors of the Company have determined whether the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is rebutted and the Group has recognised deferred tax on changes in fair value of investment properties on the basis that the deferred tax reflects the tax consequences that will follow from the manner in which the Group expects at the end of the reporting period to recover the carrying amount of the investment properties. Land Appreciation Tax ("LAT")

The Group is subject to LAT in the Mainland China. However, the implementation and settlement of the tax vary amongst different jurisdictions in various cities in the Mainland China and certain subsidiaries of the Group have not finalised its LAT calculation and payments with local tax authorities in the Mainland China. Accordingly, significant judgement is required in determining the amount of the LAT and its related income tax provisions. LAT has been provided at ranges of progressive rates of the appreciation value, with certain allowable deductions including land costs, borrowing costs and the relevant property development expenditures, which are the key inputs in the calculation of the LAT, the Group recognised the LAT based on the management's best estimates. The final tax outcome could be different from the amounts that were initially recorded, and these differences will have impact on the income tax provisions in the periods in which such tax is finalised with local tax authorities. The carrying amount of Group's LAT provision at 31st December, 2023 was HK\$3,729,394,000 (2022: HK\$3,765,303,000).

Valuation of investment properties

Investment properties are carried in the consolidated statement of financial position at 31st December, 2023 at their fair values, details of which are disclosed in Note 15. The fair value of the investment properties was determined by reference to valuations conducted on these properties by an independent firm of qualified professional valuers (the "Valuer") using investment approach which is reflective of current market conditions. Property valuation techniques involve key inputs including reversionary yield, net rental income derived from existing tenancies and annual unit market rentals. This involves making certain assumptions and the use of estimates in respect of the reversionary yield by the Valuer.

Judgements and estimation are required in establishing the relevant valuation techniques and the relevant inputs thereof. The Group considers these valuations are the best estimates. Changes in assumptions relating to these factors could affect the reported fair values of the instruments. The carrying amount of Group's unlisted equity instrument at 31st December, 2023 was HK\$293,949,000 (2022: HK\$312,824,000).

34. RETIREMENT BENEFITS SCHEMES

The Group participates in a MPF Scheme established under the Hong Kong Mandatory Provident Fund Schemes Ordinance in December 2000. The assets of the MPF Scheme are held separately from those of the Group, in funds under the control of an independent trustee. Under the rules of the MPF Scheme, the employer and the employees are obliged to make contributions at the specified rate under the scheme.

The contributions arising from the MPF Scheme charged to the consolidated statement of profit or loss represent contributions paid and payable to the fund by the Group at rates specified in the rules of the scheme.

The employees in the Mainland China are members of respective state-managed defined contribution retirement benefits schemes operated by the local governments. The employers and the employees are obliged to make contributions at a certain percentage of the payroll under rules of the schemes. The only obligation of the Group with respect to the retirement benefit schemes is to make the specified contributions.

35. RELATED AND CONNECTED PARTY TRANSACTIONS

The Group had the following significant transactions with related and connected parties:

A substantial shareholder of Rivera (Holdings) Limited ("RHL") together with her close family members control the Company and that shareholder has significant influence over RHL. Accordingly, RHL and its wholly owned subsidiaries are considered as related parties of the Company. The Company agreed to share administrative resources and office premises with RHL and its subsidiaries in Hong Kong, and in return, RHL or its wholly owned subsidiary is required to share an attributable portion of the administrative expense of the Company on a cost basis. During the year ended 31st December, 2023, the administrative expenses of the Company shared by RHL and its wholly owned subsidiary were totally amounted to HK\$3,199,000 (2022: RHL amounted to HK\$4,164,000). As at 31st December, 2023 and 2022, no outstanding balance was owed by RHL and its wholly owned subsidiary.
