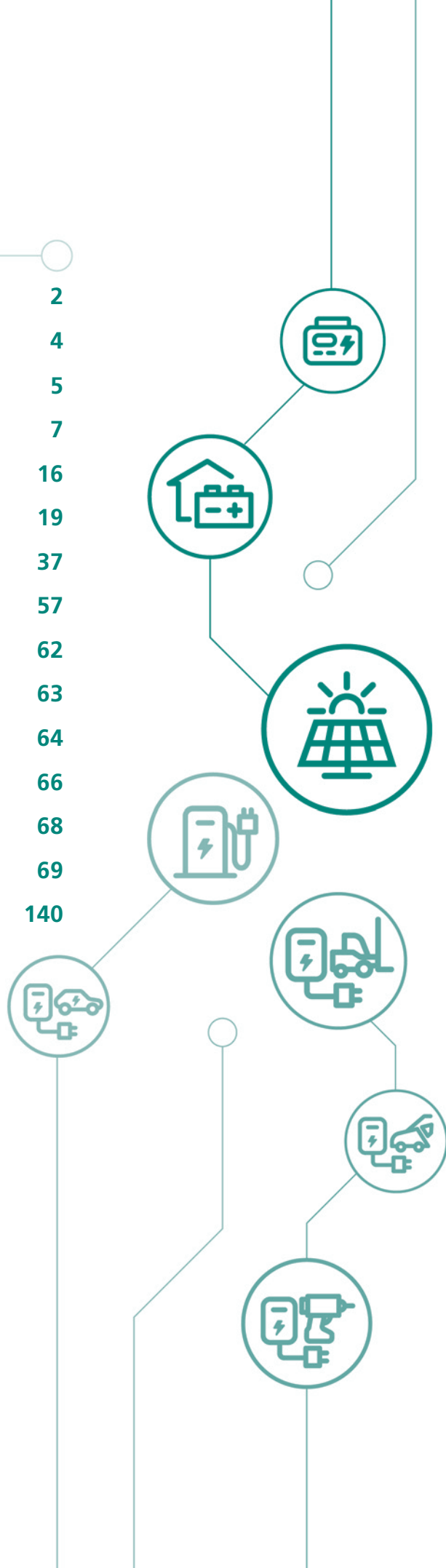

CHAIRMAN'S STATEMENT

On behalf of the board (the "Board") of directors (the "Directors") of Ten Pao Group Holdings Limited ("Ten Pao" or the "Company" and, together with its subsidiaries, the "Group"), I am pleased to present the audited consolidated results of the Group for the year ended 31 December 2023 (the "Year").

The global economy and consumer market demand had yet to recover in 2023 due to the impact of high US interest rates, a weak global economy, and ongoing geopolitical tensions. Under the premise of prudent management, customers primarily focused on reducing inventory first, which inevitably affected upstream suppliers. Over the Year, the Group strengthened strategic inventory deployment and logistics supply chain management, upgraded the configuration of intelligent manufacturing automation equipment and streamlined operational structures to achieve long-term cost reduction and efficiency improvement goals. These measures freed up resources and accelerated the development of the new energy business. As a result, although the annual revenue decreased by 12.0% year-on-year to HK\$4,823.5 million, the gross profit margin increased from 16.7% to 18.8%. The profit attributable to the owners of the Company increased by 10.8% compared to last year.

During the Year, the Group's financial planning continued to be prudent. Leveraging the advantages of varying interest rates in different regions and different currencies, and the financial products available, coupled with advice from banks, the Group was able to capture considerable returns which resulted in lower financial expenses in a high interest rate environment particularly using full deposits as security for issuing bank's acceptance bills. While maintaining sufficient cash, some loans were repaid in advance to reduce interest expenses. As of 31 December 2023, the Group's borrowings, excluding the bank's acceptance bills payable of HK\$507.6 million which were secured by the same amount of full deposits in the same bank, amounted to HK\$147.3 million, the lowest level in the past few years, which allowed the Group to maintain strong financial strength for flexible deployment at any time and make appropriate investments where required.

Over the Year, the development of the Group's new energy business has been promising. With the continuous growth and expansion of the business, the Group has expanded its new energy business into an independent segment during the Year. Under vigorous policy support and increasing public awareness of environmental protection, the new energy vehicle industry is becoming increasingly mature and the demand is growing. This has also driven the demand for core charging modules of charging piles, various energy storage products and automotive electronics. The Group has also formulated three new energy product application areas centering on charging modules, energy storage and automotive electronics as the core product strategy, which will result in a more efficient business development roadmap. Research and development ("R&D") is also more focused on power supply products with higher power and faster charging speed.

Both the consumer power supply segment and the industrial power supply segment were affected by the conservative and cautious consumption behavior of the market. However, with satisfactory progress in customer destocking during the Year, together with the Group's efforts in continually enriching product types, developing serialized product solutions to meet market needs and extending R&D and manufacturing to high-power fast charging equipment, we believe these segments will bring considerable and stable contributions to performance in the future.

R&D and innovation have always been the strategic focus of the Group, enabling us to have a diverse and comprehensive product portfolio that covers different power ranges, which gives us a clear advantage in the industry. To further consolidate our advantages, we will increase our investment in R&D overseas in the future.

The Group's global production capacity network continued to realise its advantages. Our production bases in Huizhou (in Guangdong, China), Dazhou (in Sichuan, China), Hungary and Vietnam allow the Group to respond to customer needs and conduct effective resources allocation and logistics management based on the geographical advantages, production costs and procurement advantages of each factory, reducing the risk of reliance on a single production base. It is precisely by relying on the advantages of these multiple geographical locations that Ten Pao could still ensure the supply of raw materials and the stability of product delivery even as the current Red Sea conflict continues to worsen and the impact on the global supply chain is becoming increasingly serious.

During the Year, the first phase of the Huizhou Intelligent Manufacturing Industrial Park has been completed and production equipment has been gradually moved to the new site. It is expected that the relocation will be completed in an orderly manner from 2024 to early 2025. The production plan for the Mexico factory is currently progressing as planned. In the future, we will invest more resources into the production equipment of intelligent controllers on overseas platforms. The production process will become more automated, and the products will become more sophisticated and professional. At the same time, the Group will continue to conduct R&D and optimise artificial intelligence ("AI") manufacturing technology and strengthen the application of AI-driven production lines, enhancing the digitalisation of production processes. Through continuous upgrading of digitalisation and AI manufacturing technology, the Group is advancing towards its goal of establishing state-of-the-art intelligent factories.

Even though the external macroeconomic situation remains unclear, the positive fundamentals of China's long-term economic growth remain unchanged, and the market generally predicts that consumer sentiment will improve. The Group will actively develop existing businesses and continue to explore new business opportunities. As our R&D and production footprint expand to more regions, the Group will also strengthen its sales network deployment to further enhance the advantages of a global presence, enabling us to seize opportunities as they arise.

Finally, on behalf of the Board, I would like to express my heartfelt thanks to our shareholders, investors, customers, and business partners for their trust and support of Ten Pao. I also wish to express my sincere appreciation to all the staff for their efforts and contributions, which have led to the continuous development of Ten Pao's business. In the future, Ten Pao will actively develop the new energy business, improve the power supply business, and explore a wider range of product types, aiming to become a leading one-stop intelligent power supply solution provider in the market, creating long-term and sustainable returns for our shareholders.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

Overview

As an industry-leading provider of smart power supply solutions, Ten Pao has, over the years, been consistently providing value-added services to customers through its strong R&D capabilities, quality management team and diverse product portfolio. The Group is widely recognised in the industry for its product quality and service standards, earning the continued trust and recognition of its valued partners. During the Year, the Group won the title of “Best Supplier” from several partners and maintained lasting, friendly relationships with many customers. In addition, the Group has been continuously strengthening its business in the new energy sector in recent years, cooperating with a number of well-known companies in the industry and contributing to the development of the new energy business.

Looking back on 2023, the global economy and consumer market demand remained on a path to recovery, amidst various challenges including persistent hikes in US interest rates, a weak global economy, and growing risk-averse tendencies fueled by geopolitical unrest. For the year ended 31 December 2023, the Group’s revenue experienced a year-on-year decline of 12.0%, amounting to HK\$4,823.5 million. In the face of market volatility, the Group adopted a prudent financial strategy. In addition to maintaining a healthy cash flow, the Group also made appropriate investments based on business development needs to sustain a strong financial position. Operationally, the Group actively strengthened strategic inventory deployment and logistics supply chain management to ensure a stable supply of raw materials; and continued to invest in intelligent manufacturing automation equipment and streamline operational structures to improve production efficiency and reduce operating costs. Benefiting from the above measures, the gross profit margin increased from 16.7% to 18.8%, pre-tax profit was HK\$387.9 million; and the profit attributable to the owners of the Company increased by 10.8% year-on-year to HK\$328.9 million compared to last year.

The Group maintains a stable, long-term dividend policy. The Board has recommended the payment of a final dividend of HK9.6 cents per ordinary share for the year ended 31 December 2023 (2022: HK3.3 cents per ordinary share). Together with the interim dividend of HK2.8 cents per ordinary share for the six months ended 30 June 2023 already paid out (2022: HK2.8 cents per ordinary share), the total dividend for the year ended 31 December 2023 will be HK12.4 cents per ordinary share, representing a yearly dividend payout ratio of 38.9%.

Market and Business Review

Driven by vigorous policy support, China’s new energy vehicle industry has become increasingly mature. According to data from the China Passenger Car Association, the monthly penetration rate of China’s new energy passenger vehicles exceeded 40% for the first time in November 2023. The annual production and sales volume of new energy vehicles reached 9.587 million and 9.495 million respectively, representing a year-on-year growth of 35.8% and 37.9%, reaching a record high. The market demand for core charging modules of charging piles, automotive electronics and various types of energy storage products has also been driven up, with the number of orders continuing to increase throughout the Year. In response to market demand, the Group has established a three-pronged new energy product strategy centering on charging modules, energy storage, and automotive electronics applications, enabling a more efficient business development strategy.

The Group's R&D will continue to focus on improving charging currents, accelerating charging speed, diversifying power supply products and providing customers with professional electronic product OEM services. In response to market trends, the Group has expanded its product portfolio of energy storage products from portable power suppliers (300W-5KW) to home energy storage systems (5KW-10KW); intelligent charging products have also been extended from low power (84W) to medium and high power intelligent digital power supply (3.5KW) products, covering more niche areas including outdoor power equipment, new energy low-speed electric vehicles and other segments. Furthermore, the Group has also been focusing on the R&D of higher-power charging modules of charging piles. The revenue contribution from the new energy business continued to grow significantly, increasing by 20.4% year-on-year, accounting for 15.8% of total revenue, which helped offset the impact of the decline in revenue from the power supply business. Looking ahead to 2024, the Group anticipates stable and positive performance in its new energy business.

The demand for power supply products is closely intertwined with the performance of the consumer market. For the consumer power supply segment, performance remained flat due to the slowdown in smartphone sales, recording a revenue of HK\$3,155.6 million. For the industrial power supply segment, customers actively destocking and conservative market demand forecasts resulted in cautious orders. Revenue of our smart chargers and controllers segment was HK\$1,667.8 million for the year ended 31 December 2023, compared to HK\$2,328.4 million of last year. In response to customer needs, the Group will launch new industrial power supply products that meet market demand, which is expected to benefit the revenue of industrial power supply in 2024. Furthermore, customers effectively reducing their inventory levels throughout the Year is expected to improve the Company's performance in 2024.

The Group has established a leading global production capacity network, with factories in Huizhou (in Guangdong, China), Dazhou (in Sichuan, China), Hungary and Vietnam. This reduces the risk of relying on a single production base and facilitates appropriate resources allocation in line with customer needs in accordance with the competitive advantage of each factory in geographical location, production costs and procurement ease. During the Year, the first phase of the Huizhou Intelligent Manufacturing Industrial Park has been completed, and production equipment has been gradually moved into the new factory, which will help improve production processes and efficiency. In addition, the Group has expanded its production capacity in Vietnam in view of the increasing orders from customers. Such move has also expedited the Group's business development in Southeast Asia.

The Group has always focused on product quality over the years, adhering to the business philosophy of "customer first, value-led", constantly innovating, and earning widespread recognition in the industry. During the Year, the Group won the "Global Supplier" award from a globally renowned top electric power tool brand, which commends partners with excellent quality and continuous innovation. The Group is the only supplier to win the award in the field of electronic component assembly. In addition, the Group also won the "Best Collaboration Award" and "Best Delivery Award" from two well-known mobile phone brand companies in China. As the only supplier to receive these accolades from both companies, it serves as a testament to the Group's acclaimed R&D efforts and the exceptional quality of its products.

Prospect

In view of the uncertain economic landscape in 2024, the Group will maintain a prudent attitude and adopt a robust management policy, continue to deepen and improve internal corporate reforms, enhance the benefits of automation at production bases, adjust cost structures and maintain financial stability.

R&D and innovation have always been strategic focuses of the Group, with the intention to achieve a large and diverse product portfolio. By covering products of different power levels, the Group could maintain a significant advantage in the industry. To further consolidate R&D strength, the Group will strengthen overseas R&D investment in the future. In terms of its production capacity network, the production lines of Huizhou Intelligent Manufacturing Industrial Park will be relocated in an orderly manner from 2024 to early 2025; the production plan of the Mexico factory will proceed as planned in response to customer needs; and the expansion of production capacity in Vietnam will accelerate the deployment of the Group in Southeast Asia while bringing performance contributions. On the other hand, in response to market demand, the Group will invest more resources into its product layout strategy on overseas platforms. In addition to the deployment of automated production equipment capable of mass production, the Group will also set up professional lean production lines that can flexibly handle high-precision manufacturing, along with the continuous research and increasing application of AI production lines, making production more digitalised. With the continuous upgrading of digital and AI manufacturing technology, the Group will continue to strive towards the goal of building intelligent factories. As the configuration of R&D and production continues to be upgraded, the Group will also strengthen the deployment of its global sales network, further perfecting its global coverage.

In terms of logistics configuration, in response to the escalating Red Sea situation, the Group has already started to stabilise strategic inventory, flexibly adjusted production deployment, and enhanced the capability of local material supply at each production base, effectively reducing the risk of supply chain disruption.

With the continuous growth and expansion of business, the Group expanded its new energy business into an independent segment in 2023. The new energy product strategy revolves around three core areas of charging modules, energy storage, and automotive electronic applications, and actively moves in the development direction of greater efficiency. At the beginning of 2024, a number of Chinese car companies were vying to release new energy models. Canalys, an independent analyst company, predicts that the global new energy vehicle market will grow by 27% to 17.5 million vehicles in 2024. The National Development and Reform Commission of the People's Republic of China announced earlier that it is actively expanding the consumption of new energy vehicles, strengthening promotion activities to bring new energy vehicles to rural areas, and accelerating the construction of a high quality charging infrastructure system to continuously optimise and improve the coverage of its charging network, thus providing strong support for the development of the new energy vehicle industry. The Group believes that the speed of construction of car charging piles in different cities in China will accelerate in the future, and the demand for more energy storage and automotive electronics-related peripheral equipment will also increase, which will be beneficial to the development of the three core areas of the new energy business.

Power supply customers have made satisfactory progress in destocking in 2023, which will help improve the performance of the segment in the new year. The Group will continue to enrich product types and provide serialised product solutions. Whether it is investment in industrial power supply or consumer power supply, the Group will move towards the direction of high-tech digital power supply. Considering the market demand for fast charging technology, the Group will extend efforts to the R&D and manufacturing of higher-power fast charging equipment and conduct a full range of overall planning for electric vehicle charging solutions that meet the needs of customers and segmented markets.

Over the years, under the leadership of the management team, the Group has steadily moved forward in the industry and maintained growth momentum. In addition to consolidating existing businesses, Ten Pao continues to explore new business opportunities to create a more comprehensive business strategy that better meets the needs of the Company and the market. Faced with numerous challenges from geopolitical turmoil and economic uncertainty, the Group remains determined to forge ahead, adhering to a steadily progressing business strategy and continuing to develop a more competitive intelligent and digital production model; at the same time optimising production bases and product portfolio to meet customer needs, and actively investing in R&D and sales to further strengthen its competitive advantage while leveraging the synergies brought by a global business network.

FINANCIAL REVIEW

Revenue

The Group's revenue is derived from the sales of switching power supply units for consumer products and sales of smart chargers and controllers for industrial use.

The total revenue decreased by 12.0% from HK\$5,481.4 million for the year ended 31 December 2022 to HK\$4,823.5 million for the year ended 31 December 2023. The decrease was mainly attributable to the decrease in the volume of products sold as a result of the decrease in the demand from our customers, particularly the demand from smart chargers and controllers segment which recorded a drop of 28.4% during the year ended 31 December 2023. However, the new energy business received good responses from customers and mitigated the drop in the revenue by the above business.

Revenue by Product Segment

The following table sets forth the breakdown of our revenue by product segments for the year ended 31 December 2023 and the comparative figures for the year ended 31 December 2022.

During the year ended 31 December 2023, the sales of switching power supply units for telecommunication equipment decreased by 2.1% from HK\$1,578.7 million for the year ended 31 December 2022 to HK\$1,545.0 million for the year ended 31 December 2023, due to the slowdown in the business of the smartphone manufacturing clients in the PRC. Revenue from new energy business increased by 20.4% during the year ended 31 December 2023 as compared with the year ended 31 December 2022. Sales of smart chargers and controllers decreased by 28.4% to HK\$1,667.8 million for the year ended 31 December 2023 as compared with the year ended 31 December 2022, mainly due to customers strategy of continuing destocking and conservative market strategy.

Revenue by Geographic Location

The following table sets out an analysis of the total revenue by geographic location, and is based on the destination to which we delivered our products to our customers, whereas the ultimate products produced by our customers were sold globally. As such, the delivery destination of our products might not be the same as the countries in which the relevant final products were sold.

Cost of Sales

Cost of sales primarily consists of cost of raw materials, direct labour costs and production overheads. Cost of raw materials mainly includes expenses relating to our purchases of raw materials such as plastic parts, integrated circuits, cables, metal parts, transformers and inductors, capacitors, diodes, printed circuit board components, triodes, copper and aluminium materials, and resistors. Direct labour costs mainly comprise wages, pension costs and social security costs for those who are directly involved in the manufacturing of our products. Production overheads mainly comprise depreciation of plant and machinery, administrative staff costs relating to production, subcontracting expenses, utility expenses and other miscellaneous production costs.

Cost of sales decreased by 14.2% for the year ended 31 December 2023 as compared with the year ended 31 December 2022, which was consistent with the decrease in revenue by 12.0% for the Year.

Gross Profit and Gross Profit Margin

During the year ended 31 December 2023, the Group recorded a gross profit of HK\$907.2 million, representing a decrease of 0.9% from the year ended 31 December 2022.

The gross profit margin of the Group increased from 16.7% for the year ended 31 December 2022 to 18.8% for the year ended 31 December 2023. Such increase was primarily due to the achievement of long-term cost reduction and efficiency improvement, including the rise in the level of automation, streamlining the operational structures and strengthening of the supply chain management.

Other Income

Other income mainly consists of sales of scrap materials from our manufacturing process, sales of raw materials, samples and moulds, inspection and certification fee income for obtaining standard certifications as requested by customers and others. The increase in other income in the Year was mainly attributable to the increase in the sales of scrap materials.

Other Gains — Net

Net other gains mainly consists of fair value changes on derivative financial instruments, net foreign exchange difference for transactions denominated in foreign currencies, government grants for approved technology projects, and gain on disposal of property, plant and equipment. The increase of net other gains during the year ended 31 December 2023 was primarily due to the gain on fair value changes on financial assets at fair value through profit or loss and increase in government grants during the Year.

Selling Expenses

Selling and marketing expenses primarily consist of employee benefit expenses, transportation and travelling expenses, commission expenses to salespersons and agents, certificate and detection fees mainly for obtaining safety certifications, consultancy fee, entertainment expenses, operating lease payments, advertising costs, commercial insurance for our trade receivables and others.

Selling and marketing expenses decreased by 6.9% from HK\$194.3 million for the year ended 31 December 2022 to HK\$180.8 million for the year ended 31 December 2023. The decrease was in line with the decrease in revenue.

Administrative Expenses

Administrative expenses primarily consist of employee benefit expenses for administrative staff, depreciation, amortisation and impairment charges, consultancy fee, transportation and travelling expenses, entertainment expenses, bank charges, research and development costs and others.

Administrative expenses increased by 0.5% from HK\$414.4 million for the year ended 31 December 2022 to HK\$416.4 million for the year ended 31 December 2023, which was mainly due to the increase in depreciation and amortisation charges for the newly set up production facility in both the PRC and overseas.

Finance Expenses — Net

Net finance expenses represent interest charges on our interest-bearing bank borrowings and interest income on our bank deposits. The Group had net finance expenses of HK\$3.6 million and HK\$12.5 million for the years ended 31 December 2023 and 2022, respectively. For the year ended 31 December 2023, interest expenses of HK\$8.3 million was capitalised (2022: HK\$4.8 million).

Income Tax Expense

Income tax expense represents income tax payable by the Group under relevant income tax rules and regulations where the Group operates.

Income tax expense consists of current income tax and deferred income tax. Current income tax consists of the PRC corporate income tax at a rate of 15% for three PRC subsidiaries of the Company which were recognised as “New and High Technology Enterprises” and enjoy a preferential corporate income tax rate and at a rate of 25% for the other PRC subsidiaries of the Company, respectively. Hong Kong profits tax is calculated at 16.5% of the estimated assessable profits for the Company’s subsidiaries in Hong Kong. Deferred income tax is recognised on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts. Income tax expense increased from HK\$55.2 million for the year ended 31 December 2022 to HK\$59.7 million for the year ended 31 December 2023. Profits contribution from the Hong Kong subsidiaries of the Company increased during the year under review and were taxed at the rate of 16.5%. As of 31 December 2023, the Group had fulfilled all its tax obligations and did not have any unresolved tax disputes.

The effective corporate income tax rate of the Group is 15.4% for the year ended 31 December 2023, which was approximately consistent with the effective corporate income tax rate for the year ended 31 December 2022.

TOTAL COMPREHENSIVE INCOME FOR THE YEAR ATTRIBUTABLE TO OWNERS OF THE COMPANY

Total comprehensive income for the year attributable to owners of the Company increased by 96.3% to HK\$304.2 million for the year ended 31 December 2023 from HK\$154.9 million for the year ended 31 December 2022, including currency translation loss of HK\$23.5 million as a result of the devaluation of RMB in 2023.

LIQUIDITY AND FINANCIAL RESOURCES

The Group maintains a strong and healthy position. As of 31 December 2023, net current assets was HK\$342.7 million as compared with HK\$438.0 million at 31 December 2022. As of 31 December 2023, current ratio was 1.14 times (2022: 1.21 times) (current ratio is calculated by using the following formula: current assets/current liabilities). Gearing ratio was 39.6% (2022: 31.9%) (gearing ratio is calculated by using the following formula: total borrowings/total equity). The gearing ratio excluding the banks’ acceptance bill payable which were secured by full deposits in the same bank was 8.9% for the year ended 31 December 2023.

Cash generated from operations for the year ended 31 December 2023 was HK\$484.7 million (2022: HK\$595.9 million) and the decrease was mainly in line with the decrease in revenue during the year under review.

Cash used in investing activities for the year ended 31 December 2023 was HK\$295.0 million (2022: HK\$228.0 million). The increase was primarily due to the substantial addition of plant and machineries and the construction of new factory premises.

During the year ended 31 December 2023, net cash used in financing activities was HK\$377.3 million (2022: HK\$300.4 million) as the Group continued to repay the bank borrowings during the year ended 31 December 2023.

FINANCIAL RISK MANAGEMENT

Foreign Exchange Risk

The Group operates mainly in the PRC, with notable portion of our revenue derived from our export sales to overseas countries. The Group is exposed to foreign currency risks, in particular fluctuation in currency exchange rates of HK\$ and USD against RMB.

The Group generates a notable portion of revenue and receivables in USD and HK\$, while our cost of sales is primarily denominated in RMB. For the year ended 31 December 2023, our revenue denominated in USD and HK\$ amounted to approximately 49.6% of our total revenue.

The Group manages its foreign exchange risk by performing regular reviews of the Group's net foreign exchange exposures and may enter into certain forward foreign exchange contracts, when necessary, to manage its exposure against foreign currencies and to mitigate the impact on exchange rate fluctuations. During the year ended 31 December 2023, no new forward foreign exchange contracts had been entered into by the Group.

Cash Flow and Fair Value Interest Rate Risk

As the Group has no significant interest-bearing assets (other than bank balances and cash), the Group's income and operating cash flows are substantially independent of changes in market interest rates. As of 31 December 2023, the Group had bank borrowings of HK\$654.9 million (2022: HK\$451.5 million) which were primarily denominated in HK\$ and RMB.

Credit Risk

The Group has no significant concentrations of credit risk. The carrying amounts of trade receivables, deposits and other receivables, amounts due from related parties, bank balances and cash included in the consolidated balance sheet represent the Group's maximum exposure to credit risk in relation to its financial assets. The Group has policies in place to ensure credit terms are only granted to customers with an appropriate credit history, and credit evaluations on them were performed periodically, taking into account their financial position, past experience and other factors. For customers to whom no credit terms were offered, the Group generally requires them to pay deposits and/or advances prior to delivery of products. The Group typically does not require collaterals from customers. Provisions are made for the balances when they are past due and the management considers the default risk is high.

As at 31 December 2023, all of the bank balances and restricted bank deposits were deposited with highly reputable and sizable banks and financial institutions without significant credit risk in the PRC and Hong Kong. The management does not expect to incur any loss from non-performance by these banks and financial institutions. As at 31 December 2023 and 2022, the Group held bank balances and restricted bank deposits totalling HK\$828 million, and HK\$512 million, respectively, with four major banks in the PRC and Hong Kong.

Liquidity Risk

The liquidity position is monitored closely by the management. The Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance its operations and mitigate the effects of fluctuations in cash flows.

CONTINGENT LIABILITIES

As at 31 December 2023, the Group did not have any significant contingent liabilities.

HUMAN RESOURCES

The Group employed a total of approximately 7,200 full-time employees as of 31 December 2023 (2022: approximately 7,300). The Group believes its human resources are its valuable assets and maintains its firm commitment to attracting, developing and retaining talented employees, in addition to providing dynamic career opportunities and cultivating a favourable working environment. The Group constantly invests in training across diverse operational functions and offer competitive remuneration packages and incentives to all employees. The Group regularly reviews its human resources policies for addressing corporate development needs.

BIOGRAPHIES OF DIRECTORS AND SENIOR MANAGEMENT

BOARD OF DIRECTORS

The Board consists of six Directors, of whom three are executive Directors and the remaining three are independent non-executive Directors.

EXECUTIVE DIRECTORS

Mr. Hung Kwong Yee (洪光椅先生) (“Chairman Hung”), aged 65, is the chairman of the Board, an executive Director, the chief executive officer, the chairman of the nomination committee (the “Nomination Committee”) and a member of the remuneration committee (the “Remuneration Committee”) of the Company. He is also a director of certain subsidiaries of the Company. Chairman Hung is responsible for the overall strategic planning and overseeing the general management of the Group. He was appointed as a Director in January 2015 and redesignated as the chairman of the Board and an executive Director with effect from June 2015. Besides, Chairman Hung is the director and sole shareholder of “Even Joy Holdings Limited”, a substantial Shareholder, and the director of “TinYing Investments Limited” and “TinYing Holdings Limited”, both being substantial Shareholders.

Chairman Hung is the founder of the Group. He established his business under the trading name “Ten Pao Company (天寶公司)” in Hong Kong in December 1979 and established the production plant in Huizhou, Guangdong Province in October 1988. Accordingly, he has accumulated over 40 years of experience in the power supply industry. Chairman Hung holds social titles and offices in various statutory bodies and charitable organizations, including the executive vice president of the Huizhou City Foreign Investment Enterprise Association (惠州市外商投資企業協會); the honorary life chairman of Huizhou Ganghui Love Foundation (惠州市港惠愛心基金會); the executive vice president of Huizhou Overseas Chinese Enterprises Association (惠州市僑商協會); the honorary president of the Huizhou City Huicheng District Foreign Investment Enterprise Association (惠州市惠城區外商投資企業協會); a member of the Standing Committee of Pearl River Delta Council, the Federation of Hong Kong Industries (香港工業總會珠三角工業協會); the vice chairman of the Hong Kong Shine Tak Foundation (香港善德基金會); the honorary life chairman of the Hong Kong Baptist University Foundation (香港浸會大學基金會). In addition, the Hong Kong Baptist University has conferred Honorary University Fellowship on Chairman Hung.

Chairman Hung graduated from the High School of Yinglin Middle School of Jinjiang City, Fujian Province (福建省晉江市英林中學高中部) in the PRC in July 1976.

Mr. Tse Chung Shing (謝仲成先生), aged 53, has been appointed as an executive Director with effect from 1 January 2024. He joined the Group in December 2010 as a financial controller, and has been appointed as the company secretary and chief financial officer of the Company with effect from June 2015 and November 2015, respectively. He is currently responsible for the financial reporting, corporate secretarial and investors’ relationship matters of the Group. Mr. Tse has approximately 30 years of experience in auditing, accounting and corporate finance. Prior to joining the Group, he worked in the advisory assurance department in Ernst & Young, an international accounting firm, from 1992 to 2003, with his last position as a senior manager. From 2004 to 2009, he worked as a financial controller in an automation equipment manufacturing company in Hong Kong. Mr. Tse received his bachelor’s degree in accountancy (honours) from the City University of Hong Kong in November 1992. He has been a member of the Association of Chartered Certified Accountants since December 1997 and became a fellow member in December 2002.

Ms. Hung Sui Lam (洪瑞琳女士), aged 30, has been appointed as an executive Director with effect from 1 January 2024. She is also a director of certain subsidiaries of the Company. Ms. Hung joined the Group as a special assistant to the chairman in January 2021, and is principally responsible for the administrative management and conducting marketing research for the operation of the subsidiaries of the Company. Prior to joining the Group, Ms. Hung worked as an executive assistant in the Hospital Authority from 2016 to 2020. She received her Business (International Business) honours degree from School of Professional Education and Executive Development, The Hong Kong Polytechnic University in May 2015. Ms. Hung has been appointed as a member of the Young Entrepreneur Committee of Hong Kong Baptist University Foundation since 1 January 2024.

Ms. Hung is the daughter of Chairman Hung, the chairman of the Board, an executive Director, the chief executive officer and controlling Shareholder of the Company.

INDEPENDENT NON-EXECUTIVE DIRECTORS

Mr. Lam Cheung Chuen (林長泉先生), aged 70, has been appointed as an independent non-executive Director since 23 November 2015, and is responsible for overseeing the management of the Group independently. He is also a member of the Company's audit committee (the "Audit Committee"), the Remuneration Committee and the Nomination Committee. Mr. Lam is a founder of Sun Tin Lun Garment Accessories (Huizhou) Co., Ltd. (新天倫服裝配料(惠州)有限公司), a garment accessories manufacturing company in the PRC, and Sun Tin Lun Apparel Accessories (Huizhou) Co., Ltd. (新天倫服裝輔料(惠州)有限公司), an apparel accessories manufacturing company in the PRC.

Mr. Lam completed his primary school education in the PRC in July 1966 and was conferred Honorary University Fellowship by the Hong Kong Baptist University in September 2015. Mr. Lam has over 30 years of experience in the garment accessories manufacturing industry. Mr. Lam was a special committee member of the 11th session and a member of the 12th session of Huizhou City Committee of Guangdong Province of the Chinese People's Political Consultative Conference (中國人民政治協商會議廣東省惠州市委員會). Mr. Lam holds a number of social titles including the president of the 6th council of Huizhou City Huicheng District Foreign Investment Enterprise Association (惠州市惠城區外商投資企業協會), the executive vice president of the 7th council of Huizhou City Foreign Investment Enterprise Association (惠州市外商投資企業協會), the executive vice chairman of the 1st council of Huizhou Overseas Chinese Enterprises Association (惠州市僑商投資企業協會), an executive member of the Huizhou Division of the Federation of Hong Kong Industries of Pearl River Delta Council (香港工業總會珠三角工業協會惠州分部), a consultant of the Hong Kong Shine Tak Foundation (香港善德基金會), the honorary life chairman of the Hong Kong Baptist University Foundation (香港浸會大學基金會) and the vice president of the Hong Kong Lin Commerce of Chamber (香港林氏總商會). Mr. Lam has resigned as the chairman of the board of directors and a non-executive director of Reach New Holdings Limited (stock code: 8471), a company listed on the GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), with effect from 26 September 2023.

Mr. Chu Yat Pang Terry (朱逸鵬先生), aged 52, has been appointed as an independent non-executive Director since 23 November 2015, and is responsible for overseeing the management of the Group independently. He is also the chairman of the Audit Committee and a member of the Remuneration Committee and the Nomination Committee. At present, Mr. Chu is a Managing Director of Halcyon Capital Limited which specializes in initial public offerings and corporate advisory in mergers and acquisitions. Mr. Chu possesses over 30 years of experience in corporate finance and auditing. Mr. Chu used to work for an international accounting firm and other corporate finance arms of listed financial institutions in Hong Kong. Mr. Chu graduated from the University of Western Ontario in Canada with a Bachelor of Arts degree in 1992 and from the University of Hull in the United Kingdom with a Master of Business Administration (Investment & Finance) degree in 1997. He also obtained a Diploma in Accounting from the School of Business and Economics of the Wilfrid Laurier University in Canada in 1993. Mr. Chu is a member of the Hong Kong Institute of Certified Public Accountants. Mr. Chu is also an independent non-executive director of the following companies listed on the Main Board of the Stock Exchange: Hong Kong Finance Group Limited (stock code: 1273) and AB Builders Group Limited (stock code: 1615).

Mr. Lee Kwan Hung Eddie (李均雄先生), aged 58, has been appointed as an independent non-executive Director since 23 November 2015, and is responsible for overseeing the management of the Group independently. He is also the chairman of the Remuneration Committee and a member of the Audit Committee and the Nomination Committee. Mr. Lee has over 30 years of experience in legal services. Mr. Lee commenced working in Woo Kwan Lee & Lo, a law firm in Hong Kong, in 1989 and worked as a partner from 2001 to 2011. He worked in the Listing Division of the Stock Exchange, where he successively served as a manager and senior manager from 1992 to 1994. He joined Howse Williams Bowers (now known as Howse Williams), a law firm in Hong Kong, as a consultant lawyer in 2014. Mr. Lee received a bachelor's degree in laws (honours) and a postgraduate certificate in laws from The University of Hong Kong in November 1988 and September 1989 respectively. He was admitted as a solicitor in Hong Kong in 1991 and in the United Kingdom in 1997.

SENIOR MANAGEMENT

During the Year, the organisation structure was streamlined. Various business and functions of the Group are under the direct responsibilities of the executive Directors and the chief executive officer who are regarded as senior management of the Group. The Board will review the organisation structure from time to time to complement the Company's corporate strategy.

CORPORATE GOVERNANCE REPORT

The Board is pleased to report to the Shareholders on the corporate governance of the Company for the year ended 31 December 2023.

CORPORATE GOVERNANCE CULTURE AND VALUES

The Company is committed to ensuring that its affairs are conducted in accordance with high ethical standards. As a group with diversified businesses, by recognising the importance of stakeholders at the Board level and throughout the Group, we strive to provide high quality and reliable products and services, and to create values to the stakeholders through sustainable growth and continuous development.

The Board has set out the following core values to provide guidance on employees' conduct and behaviours as well as the business activities, and to ensure they align with the Group's culture and are embedded throughout the Group's vision, mission, policies and business strategies:

- Excellence: we aim to deliver excellence to impress our customers
- Integrity: we strive to do what is right
- Accountability: we are accountable for delivering on our commitments
- Empathy: we care about our stakeholders, being our employees, customers, suppliers and the community
- Sustainability: we pursue innovation and are committed to a sustainable future

The Group will continuously review and adjust, if necessary, its business strategies and keep track of the changing market conditions to ensure prompt and proactive measures will be taken to respond to the changes and meet the market needs to foster the sustainability of the Group.

CORPORATE GOVERNANCE PRACTICES

The Board is committed to maintaining good corporate governance standards. The Board believes that good corporate governance standards are essential in providing a framework for the Company to safeguard the interests of Shareholders, enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

The Company has in place a corporate governance framework and has established a set of policies and procedures based on the Corporate Governance Code (the "CG Code") contained in Appendix C1 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules"). Such policies and procedures provide the infrastructure for enhancing the Board's ability to implement governance and exercise proper oversight on business conduct and affairs of the Company.

The Board is of the view that throughout the year ended 31 December 2023, the Company has complied with the code provisions set out in the CG Code, except for the code provision C.2.1. Key corporate governance principles and practices of the Company as well as the details of the foregoing code provision deviation are summarized below.

A THE BOARD

A1. Responsibilities and Delegation

The Company is headed by an effective Board which is responsible for the leadership, control and management of the Company and oversees the Group's business, strategic decision and performances in the attainment of the objective of ensuring effective functioning and growth of the Group and enhancing value to investors. All the Directors carry out their duties in good faith, take decisions objectively and act in the interests of the Company and the Shareholders at all times.

All Directors have full and timely access to all relevant information of the Group as well as the advice and services of the company secretary and senior management, with a view to ensuring compliance with Board procedures and all applicable laws and regulations. Any Director may request for independent professional advice in appropriate circumstances at the Company's expense for discharging his/her duties, upon reasonable request made to the Board.

The Board reserves for its decision on all major matters of the Company, including the approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters.

The Executive Committee (the "Executive Committee") and the management and department heads of the Company are delegated the authority and responsibilities by the Board for the day-to-day management and operation of the Group. The delegated functions and work tasks are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the above-mentioned officers. The Board has the full support of the management and department heads to discharge its responsibilities.

Chairman Hung is the father of Ms. Hung Sui Lam. Save as disclosed above, there is no relationship (including financial, business, family or other material/relevant relationship) between the Board members.

A3. Chairman and Chief Executive

According to code provision C.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same person. The Company has deviated from this code provision because Chairman Hung performs both the roles of the chairman of the Board and the chief executive officer of the Company. Chairman Hung, the founder of the Group with the established market reputation in the switching power supply industry in the PRC, has extensive experience in the Group’s business operation and management in general. The Board believes that vesting the two roles in the same person provides the Company with strong and consistent leadership and facilitates the implementation and execution of the Group’s business strategies which is in the best interests of the Company. Under the leadership of Chairman Hung, the Board works effectively and performs its responsibilities with all key and appropriate issues discussed in a timely manner. In addition, as all major decisions are made in consultation with members of the Board and relevant Board committees, and there are three independent non-executive Directors (representing one half of the Board members) offering independent perspectives, the Board is of the view that there are adequate safeguards in place to ensure sufficient balance of powers within the Board. The Board shall nevertheless review the structure and composition of the Board from time to time in light of prevailing circumstances, to maintain a high standard of corporate governance practices of the Company.

A4. Independent Non-executive Directors

Rules 3.10 and 3.10A of the Listing Rules require an issuer to have a minimum of three independent non-executive directors (representing at least one-third of the board) with at least one of them possessing appropriate professional qualifications or accounting or related financial management expertise.

Throughout the year ended 31 December 2023, the Board has met the above Listing Rule requirements. Actually, the proportion of independent non-executive Directors is higher than what is required by the Listing Rules since the three independent non-executive Directors represent more than one-third of the Board.

The members of the Board have skills and experience appropriate for the business requirements and objectives of the Group. Each executive Director is responsible for different business and functional division of the Group in accordance with his/her expertise. The independent non-executive Directors bring different business and financial expertise, experiences and independent judgment to the Board and they are invited to serve on the Board committees. Through participation in Board meetings, and taking the lead in managing issues involving potential conflicts of interests, the independent non-executive Directors have made contributions to the effective direction of the Company and provided adequate checks and balances to safeguard the interests of both the Group and the Shareholders.

The Company has received written annual confirmation from each independent non-executive Director of his independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive Directors to be independent in light of the independence guidelines set out in the Listing Rules.

A5. Appointment and Re-election of Directors

All Directors are appointed for a specific term. Chairman Hung has entered into a service contract with the Company and it has been renewed for a term of 3 years from 11 December 2021. Each of Mr. Tse Chung Shing and Ms. Hung Sui Lam, who have been appointed as executive Directors with effect from 1 January 2024, entered into a service contract with the Company for a term of 3 years commencing on 1 January 2024. The letters of appointment of the three independent non-executive Directors have been renewed for a term of 3 years commencing on 11 December 2021. The Directors' service contracts and letters of appointment are subject to termination in accordance with their respective terms.

According to clause 84 of the articles of association of the Company (the "Articles"), one-third of the Directors for the time being (if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation at each annual general meeting of the Company (the "AGM") provided that every Director shall be subject to retirement by rotation at least once every three years and that any Directors so to retire shall be those who have been longest in office since their last re-election or appointment. The retiring Directors should be eligible for re-election at the relevant AGM. In addition, pursuant to clause 83 of the Articles, any new Director appointed by the Board, either to fill a casual vacancy on the Board or as an addition to the existing Board, shall hold office until the first AGM after his/her appointment. The Director appointed by the Board as aforesaid shall be eligible for re-election at the relevant AGM.

At the forthcoming AGM to be held on 14 June 2024 (the "2024 AGM"), Chairman Hung and Mr. Lam Cheung Chuen shall retire by rotation pursuant to clause 84 of the Articles whereas Mr. Tse Chung Shing and Ms. Hung Sui Lam, who have been appointed by the Board with effect from 1 January 2024, shall retire from office in accordance with clause 83 of the Articles. All of the above four Directors, being eligible, will offer themselves for re-election at the 2024 AGM. At the 2024 AGM, separate ordinary resolutions will be put forward to the Shareholders in relation to the proposed re-election of Chairman Hung, Mr. Lam Cheung Chuen, Mr. Tse Chung Shing and Ms. Hung Sui Lam as Directors. The Board and the Nomination Committee recommended their re-appointment. The circular of the Company, sent together with this annual report, contains detailed information of these four Directors as required by the Listing Rules.

A6. Continuous Professional Development of Directors

Directors shall keep abreast of regulatory developments and changes in order to effectively perform their responsibilities and to ensure that their contribution to the Board remains informed and relevant.

Each newly appointed Director shall receive a formal induction on the first occasion of his/her appointment to ensure that he/she has appropriate understanding of the business and operations of the Group and that he/she is fully aware of his/her responsibilities and obligations under the Listing Rules and relevant regulatory requirements.

The existing Directors are continually updated with legal and regulatory developments, and the business and market changes to facilitate the discharge of their responsibilities. Trainings and professional development for Directors are arranged whenever necessary. In addition, relevant reading materials on new or changes to salient laws and regulations applicable to the Group are provided to Directors from time to time for their reference and studying.

Directors are required to submit to the Company details of the training they received in each financial year for the Company's maintenance of proper training records of Directors. A8. Directors' and Employees' Securities Transactions

The Company has adopted the "Model Code for Securities Transactions by Directors of Listed Issuers" (the "Model Code") contained in Appendix C3 to the Listing Rules as its own code of conduct regarding Directors' dealings in the securities of the Company.

Specific enquiry has been made of all the Directors and the Directors have confirmed that they have complied with the Model Code throughout the year ended 31 December 2023.

The Company has also established written guidelines (the "Employees Written Guidelines") on terms no less exacting than the Model Code for securities transactions by employees of the Group who are likely to possess inside information of the Company and/or its securities. No incident of non-compliance of the Employees Written Guidelines by the employees was noted by the Company throughout the year ended 31 December 2023.

In case when the Company is aware of any restricted period for dealings in the Company's securities, the Company will notify its Directors and relevant employees of the Group in advance.

A9. Board Independence

The Group has established mechanisms to ensure independent views and input are available to the Board and such mechanisms will be reviewed annually by the Board. The Board has reviewed the implementation and effectiveness of the following mechanisms:

- Three out of the six Directors are independent non-executive Directors, which exceeds the requirement of the Listing Rules that at least one-third of the Board are independent non-executive Directors.
- Apart from complying with the requirements prescribed by the Listing Rules as to the composition of certain Board committees, independent non-executive Directors will be appointed to all Board committees as far as possible to ensure independent views are available.
- The Nomination Committee will assess the independence of a candidate who is nominated to be a new independent non-executive Director before appointment and the continued independence of the existing independent non-executive Directors on an annual basis.
- Each independent non-executive Director is also required to inform the Company as soon as practicable if there is any change in his own personal particulars that may materially affect his independence.
- Each independent non-executive Director is required to submit a written confirmation to the Company annually to confirm the independence of himself and his immediate family members.
- All Directors are entitled to seek further information and documentation from the management on the matters to be discussed at Board meetings. They can also seek assistance from the Company's secretary and, where necessary, independent advice from external professional advisers at the Company's expense.
- All Directors are encouraged to express their views in an open and candid manner during the Board/Board committees' meetings.
- Any Director who has material interests in any contract, transaction or arrangement shall abstain from voting and not be counted in the quorum on any Board resolution approving the same.

A10. Corporate Governance Functions

The Audit Committee is responsible for performing the corporate governance functions set out in the code provision A.2.1 of the CG Code.

During the year under review, the Audit Committee has performed corporate governance functions as follows: (i) reviewed and monitored the Company's corporate governance policies and practices; (ii) reviewed and monitored the training and continuous professional development of Directors and senior management; (iii) reviewed and monitored the Company's policies and practices on compliance with legal and regulatory requirements; (iv) reviewed and monitored the compliance of the Model Code; and (v) reviewed the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

B. BOARD COMMITTEES

The Board has established four Board committees, namely, the Executive Committee, the Audit Committee, the Remuneration Committee and the Nomination Committee, for overseeing particular aspects of the Company's affairs. All Board committees are established with specific written terms of reference which deal clearly with their authority and duties. These terms of reference are posted on the Stock Exchange's website and the Company's website (except for the terms of reference of the Executive Committee which are available to Shareholders upon request). All the Board committees should report to the Board on their decisions or recommendations made.

All Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expenses.

B1. Executive Committee

The Executive Committee comprises all the executive Directors with Chairman Hung acting as the chairman of the Committee. The Executive Committee operates as a general management committee under the direct authority of the Board to increase the efficiency for the business decisions. It monitors the execution of the Company's strategic plans and operations of all business units of the Group and discusses and makes decisions on matters relating to the management and day-to-day operations of the Company.

B2. Audit Committee

The Company has met the Listing Rules requirements regarding the composition of the Audit Committee throughout the year ended 31 December 2023. The Audit Committee comprises all of the three independent non-executive Directors, with Mr. Chu Yat Pang Terry acting as the chairman of the Committee. Mr. Chu Yat Pang Terry possesses the appropriate professional qualification, and accounting and financial management expertise as required under Rule 3.10(2) of the Listing Rules. None of the members of the Audit Committee is a former partner of the Company's existing external auditor.

The terms of reference of the Audit Committee are of no less exacting terms than those set out in the CG Code. The main duties of the Audit Committee are reviewing the financial information and reports of the Group and considering any significant or unusual items raised by the financial officers of the Group or external auditor before submission to the Board; reviewing the relationship with and the terms of appointment of the external auditor and making the relevant recommendation to the Board; reviewing the Company's financial reporting system, internal control system and risk management systems and effectiveness of the internal audit function; and performing the Company's corporate governance functions.

During the year ended 31 December 2023, the Audit Committee has held three meetings (the attendance records of each Committee member are set out in section A7 above) and performed the following major works:

- Reviewed and discussed the annual financial statements, results announcement and annual report for the year ended 31 December 2022, the relevant audit findings of the Company's external auditor; and the recommendation of the re-appointment of the external auditor;
- Reviewed and discussed the interim financial statements, results announcement and interim report for the six months ended 30 June 2023 and the relevant review findings of the Company's external auditor;
- Reviewed the Group's continuing connected transactions;
- Discussed the major internal audit issues;
- Reviewed the Group's financial reporting system and risk management and internal controls systems, and the existing internal audit function of the Company, and made relevant recommendation to the Board;
- Reviewed the compliance with and enforcement of the terms of the Deed of Non-competition by the controlling Shareholders;
- Reviewed the arrangements for employees of the Group to raise concerns about possible improprieties in the Group's financial reporting, internal control or other matters;
- Performed the corporate governance functions as set out in section A10 above; and
- Discussed with the external auditor about the scope of audit work for the year ended 31 December 2023.

The Company's external auditor has also attended the three Audit Committee meetings held during the year ended 31 December 2023.

Besides, there is no disagreement between the Board and the Audit Committee regarding the appointment of external auditor.

B3. Remuneration Committee

The Remuneration Committee consists of a total of four members, being one executive Director, Chairman Hung, and three independent non-executive Directors, Mr. Lee Kwan Hung Eddie (chairman of the Committee), Mr. Lam Cheung Chuen and Mr. Chu Yat Pang Terry. Throughout the year ended 31 December 2023, the Company has met the Listing Rule requirements of having the majority of the Remuneration Committee members being independent non-executive Directors as well as having the Committee chaired by an independent non-executive Director.

The terms of reference of the Remuneration Committee are of no less exacting terms than those set out in the CG Code. The principal responsibilities of the Remuneration Committee include reviewing and making recommendations to the Board on the Company's remuneration policy and structure and the remuneration packages of Directors and members of senior management (i.e. the model described in the code provision E.1.2(c)(ii) of the CG Code is adopted). The Remuneration Committee is also responsible for establishing transparent procedures for developing such remuneration policy and structure to ensure that no Director or any of his/her associates will participate in deciding his/her own remuneration.

During the year ended 31 December 2023, the Remuneration Committee has held two meetings (the attendance records of each Committee member are set out in section A7 above), in which the Committee members have (i) reviewed the existing remuneration policy and structure of the Company and the remuneration packages of Directors and senior management of the Company and made relevant recommendations to the Board; and (ii) recommended to the Board the emoluments of Mr. Tse Chung Shing and Ms. Hung Sui Lam, being the newly appointed executive Directors with effect from 1 January 2024.

The Company's remuneration policy is to ensure that the remuneration offered to employees, including Directors and senior management, is based on skill, knowledge, responsibilities and involvement in the Company's affairs. The remuneration packages of executive Directors are also determined with reference to the Company's performance and profitability, the prevailing market conditions and the performance or contribution of each executive Director. The remuneration for the executive Directors comprises basic salary, pensions and discretionary bonus. Executive Directors may also receive options to be granted under the Company's share option scheme. The remuneration policy for independent non-executive Directors is to ensure that they are adequately compensated for their efforts and time dedicated to the Company's affairs, including their participation in Board committees. The remuneration for the independent non-executive Directors mainly comprises Director's fee which is determined with reference to their duties and responsibilities as well as market practice and conditions. Individual Directors and senior management have not been involved in deciding their own remuneration.

Details of the remuneration of each Director for the year ended 31 December 2023 are set out in note 39 to the financial statements contained in this annual report.

B4. Nomination Committee

The Nomination Committee comprises a total of four members, being Chairman Hung (chairman of the Committee), and three independent non-executive Directors, Mr. Chu Yat Pang Terry, Mr. Lam Cheung Chuen and Mr. Lee Kwan Hung Eddie. Throughout the year ended 31 December 2023, the Company has met the Listing Rule provision, which requires the majority of a nomination committee being independent non-executive directors and the committee chairman being the chairman of the board or an independent non-executive director.

The terms of reference of the Nomination Committee are of no less exacting terms than those set out in the CG Code. The principal responsibilities of the Nomination Committee are to review the structure, size and composition (including the skills, knowledge, experience and diversity perspectives) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy; identify qualified and suitable individuals to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships; assess the independence of independent non-executive Directors; and make recommendations to the Board on relevant matters relating to the appointment or re-appointment of Directors and succession planning for Directors, in particular the chairman and the chief executive of the Company.

In assessing the Board composition, the Nomination Committee would take into account various aspects as well as factors concerning Board diversity as set out in the Company's Board Diversity Policy.

In identifying and selecting suitable candidates for directorships, the Nomination Committee would consider the candidate's relevant criteria as set out in the Director Nomination Policy that are necessary to complement the corporate strategy and achieve Board diversity, where appropriate, before making recommendation to the Board.

During the year ended 31 December 2023, the Nomination Committee has held two meetings (the attendance records of each Committee member are set out in section A7 above) in which the Committee members have (i) reviewed the existing structure, size and composition of the Board to ensure that it has a balance of expertise, skills and experience appropriate to the requirements for the business of the Group; (ii) recommended the reappointment of the retiring Directors standing for re-election at the Company's AGM held on 2 June 2023; (iii) assessed the independence of the existing independent non-executive Directors; and (iv) recommended the appointment of Mr. Tse Chung Shing and Ms. Hung Sui Lam as executive Directors, which took effect from 1 January 2024.

Board Diversity Policy

The Company has adopted a Board Diversity Policy which sets out the approach to achieve diversity of the Board. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. The Company aims to maintain an appropriate balance of diversity perspectives that are relevant to the Company's business growth and is also committed to ensuring that the selection and nomination of Board positions are appropriately structured so that a diverse range of candidates can be considered.

Pursuant to the Board Diversity Policy, the Nomination Committee will review annually the structure, size and composition of the Board and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy and to ensure that the Board maintains a balanced diverse profile. In relation to reviewing and assessing the Board composition, the Nomination Committee is committed to diversity at all levels and will consider a number of aspects, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and regional and industry experience.

As at the date of this annual report, the Board comprises six Directors, one of whom is female. The Board considers that the current Board composition has provided the Company with a good balance and diversity of skills and experience appropriate to the requirements of the Group's business and allowed opinion from different gender and background be heard and discussed, and Board diversity (including gender diversity) has been achieved.

The Board will consider setting measurable objectives to implement the Board Diversity Policy and review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives. At present, the Nomination Committee considered that the Board is sufficiently diverse and the Board has not set any measurable objectives.

The Nomination Committee shall review the Board Diversity Policy on an annual basis to ensure its effectiveness.

Gender Ratio in the Workforce

The Company values gender diversity across all levels of the Group. The gender ratio in the workforce of the Group (including senior management) as at 31 December 2023 was 43:57 (female: male). The Company considers the above gender ratio satisfactory.

Director Nomination Policy

The Board has delegated its responsibilities and authority for selection and appointment of Directors to the Nomination Committee of the Company.

The Company has adopted a Director Nomination Policy which sets out the selection criteria and process and the Board succession planning considerations in relation to nomination and appointment of Directors of the Company and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company and the continuity of the Board and appropriate leadership at Board level.

The Director Nomination Policy sets out the factors for assessing the suitability and the potential contribution to the Board of a proposed candidate, including but not limited to the following:

- Character and integrity;
- Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
- Diversity in all aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service;
- Requirements of independent non-executive Directors on the Board and independence of the proposed independent non-executive Directors in accordance with the Listing Rules; and
- Commitment in respect of available time and relevant interest to discharge duties as a member of the Board and/or Board committee(s) of the Company.

The Director Nomination Policy also sets out the procedures for the selection and appointment of new Directors and re-election of Directors at general meetings.

The Nomination Committee will review the Director Nomination Policy, as appropriate, to ensure its effectiveness.

C. DIRECTORS' RESPONSIBILITY IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors have acknowledged their responsibility for preparing the financial statements of the Company for the year ended 31 December 2023.

The Board is responsible for presenting a balanced, clear and understandable assessment in annual and interim reports, inside information announcements and other financial disclosures required under the Listing Rules and other regulatory requirements. The management has provided such explanation and information to the Board as necessary to enable the Board to make an informed assessment of the financial information and position of the Group put forward to the Board for approval.

The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The statement of the external auditor of the Company about their reporting responsibilities on the Company's financial statements for the year ended 31 December 2023 is set out in the section headed "Independent Auditor's Report" in this annual report.

D. RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has the overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal control systems. The Audit Committee assists the Board in leading the management and overseeing their design, implementation and monitoring of the risk management and internal control systems. The Board reviews the effectiveness of the risk management and internal control systems as well as the internal audit function of the Company on an annual basis through the Audit Committee.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including project management, finance, human resources and information technology. Self-evaluation has been conducted annually to confirm that control policies are properly complied with by each department.

All departments conducted internal control assessment regularly to identify risks that potentially impact the business of the Group and various aspects including key operational and financial processes, regulatory compliance and information security. The management, in coordination with department heads, assess the likelihood of risk occurrence, provide treatment plans, and monitor the risk management progress. The management has reported to the Board and the Audit Committee on the effectiveness of the risk management and internal control systems for the year ended 31 December 2023.

The Company's internal audit unit is responsible for performing independent review of the adequacy and effectiveness of the risk management and internal control systems. The internal audit unit examined key issues in relation to the accounting practices and all material controls and provided its findings and recommendations for improvement to the Audit Committee.

During the year ended 31 December 2023, the Board, as supported by the Audit Committee as well as the report from the management and the internal audit findings, reviewed the effectiveness of the Group's risk management and internal control systems, including the financial, operational and compliance controls, and considered that such systems are effective and adequate.

The Company has developed a policy for handling and dissemination of inside information. The policy provides a general guide to the Company's Directors, senior management and relevant employees in handling confidential information, monitoring information disclosure and responding to enquiries. Directors who have come across any potential inside information or any information subject to disclosure should bring such information immediately to the notice of the Board and employees at different levels should have the same responsibility to identify and escalate such information to their immediate superiors. In addition, the policy sets out measures for preserving the confidentiality of inside information and access to confidential information is limited to a minimum number of employees on a 'need to know' basis. In handling enquiries from Shareholders and external parties relating to the Group's affairs and in dealing with investors, analysts and the media, etc., only designated persons are authorized to speak on behalf of the Company.

In addition, the Company has in place a whistleblowing policy for employees of the Group and those who deal with the Group to raise concerns with the Company about possible improprieties in any matters related to the Group.

The Company has also in place an anti-corruption policy to safeguard against corruption and bribery within the Group. The Company has an internal reporting channel that is open and available for employees of the Group to report any suspected corruption and bribery. The Company continues to carry out anti-corruption and anti-bribery activities to cultivate a culture of integrity, and organizes anti-corruption training to ensure the effectiveness of anti-corruption and anti-bribery.

E. COMPANY SECRETARY

The secretary of the Company is Mr. Tse Chung Shing, who is also an executive Director and the chief financial officer of the Company. Mr. Tse fulfils the qualification requirements laid down in the Listing Rules. Biographical details of Mr. Tse are set out in the section headed “Biographies of Directors and Senior Management” of this annual report. For the year ended 31 December 2023, Mr. Tse has undertaken not less than 15 hours of relevant professional training in compliance with Rule 3.29 of the Listing Rules.

G. SHAREHOLDERS’ RIGHTS

To safeguard Shareholders’ interests and rights, separate resolution is proposed for each substantially separate issue at general meetings, including the election of individual Director. All resolutions put forward at Shareholders’ meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each Shareholders’ meeting.

Pursuant to the Articles, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall have the right, by written requisition to the Board or the Company's secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

There is no provision allowing Shareholders to move new resolutions at general meetings under the Cayman Islands Companies Act or the Articles. Shareholders who wish to move a resolution may request the Company to convene a general meeting following the procedures set out in the preceding paragraph.

For the avoidance of doubt, Shareholders must deposit and send the original duly signed written requisition to the address as specified in paragraph J2e(ii) below. The requisitionist(s) shall provide his/her/their full name(s), contact details and identification in order to give effect thereto. Shareholders' information may be disclosed as required by law. Shareholders may call the Company at (852) 2790 5566 for any assistance.

With respect to the Shareholders' right in proposing persons for election as Directors, please refer to the procedures available on the website of the Company.

H. CONSTITUTIONAL DOCUMENTS

At the annual general meeting of the Company held on 2 June 2023, the Company amended its Articles, mainly for the purposes of bringing them in line with the latest applicable laws of the Cayman Islands and the Listing Rules, in particular the core shareholder protection standards laid down in the Listing Rules. Details of the amendments were set out in the circular of the Company dated 25 April 2023.

The latest version of the Articles is available on the websites of the Company and the Stock Exchange.

I. DEED OF NON-COMPETITION

J. POLICIES RELATING TO SHAREHOLDERS

J1. Dividend Policy

The Company intends to strike a balance between maintaining sufficient capital to develop and operate the business of the Group and rewarding the Shareholders. According to the dividend policy adopted by the Company (the "Dividend Policy"), the Company does not have any pre-determined dividend payout ratio. In deciding whether to propose a dividend and in determining the dividend amount, the Board shall take into account, inter alia, the following factors of the Group:

- Financial results;
- Cash flow situation;

- Business conditions and strategies;
- Future operations and earnings;
- Capital requirements and expenditure plans;
- Interests of Shareholders;
- Any restrictions on payment of dividends; and
- Any other factors that the Board may consider relevant.

The declaration and payment of dividends by the Company is also subject to the provisions set out in the Articles, any restrictions under the Companies Act of the Cayman Islands, and any applicable laws, rule and regulations. Any declaration and payment of dividends under the Dividend Policy is subject to the Board's determination that the same would be in best interests of the Group and the Shareholders as a whole. The Board will review the Dividend Policy from time to time and may exercise at its sole and absolute discretion to update, amend and/or modify the Dividend Policy at any time as it deems fit and necessary.

J2. Shareholders' Communication Policy

The Company has in place a Shareholders' communication policy (the "Shareholders' Communication Policy"). Such policy aims to set out various provisions with the objective of ensuring the Shareholders are provided with equal and timely access to information about the Company, in order to enable them to exercise their rights in an informed manner and to allow them to engage actively with the Company. The Board has reviewed the implementation and effectiveness of the Shareholders' Communication Policy and considered it satisfactory since the Company has established a number of channels, as detailed below, for maintaining on-going dialogues with its Shareholders:

(a) Corporate Communication

"Corporate Communication" as defined under the Listing Rules refers to any document issued or to be issued by the Company for the information or action of holders of any of its securities, including but not limited to the following documents of the Company: (a) the Directors' report, annual accounts together with a copy of the auditor's report; (b) the half-year report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form. The Corporate Communication of the Company will be published on the Stock Exchange's website (www.hkexnews.hk) in a timely manner as required by the Listing Rules. Corporate Communication will be provided to Shareholders and non-registered holders of the Company's securities in both English and Chinese versions in a timely manner as required by the Listing Rules.

(b) Announcements and Other Documents pursuant to the Listing Rules

The Board is pleased to present their report together with the audited consolidated financial statements of the Group for the year ended 31 December 2023.

PRINCIPAL ACTIVITIES

The Company is an investment holding company. The Group is engaged in the sales and manufacturing of switching power supply units for consumer products and smart chargers and controllers for industrial use.

RESULTS AND APPROPRIATIONS

The results of the Group for the year ended 31 December 2023 are set out in the consolidated financial statements on pages 62 to 68.

The Board has recommended the payment of a final dividend of HK9.6 cents (2022: HK3.3 cents) per ordinary share of the Company for the year ended 31 December 2023 to the Shareholders whose names are to be appeared on the register of members of the Company on Friday, 28 June 2024. The proposed final dividend is subject to the approval of the Shareholders at the 2024 AGM to be held on Friday, 14 June 2024.

It is expected that the cheques for the proposed final dividend will be sent by ordinary mail to the Shareholders at their own risk on Monday, 15 July 2024.

The Company is incorporated in the Cayman Islands with its shares listed on the Main Board of the Stock Exchange. The Group's operations are mainly carried out by the Group's subsidiaries in the PRC while the Group also has a headquarter in Hong Kong. The Group's principal business activity is engaged in the developing, manufacturing and sales of electric charging products in the PRC. Set out below is a summary of certain laws and regulations relating to the Group's operations and business which may have significant impact to the Group:

1. the Companies Ordinance (Chapter 622 of the Laws of Hong Kong);
2. the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong);
3. the Companies Act, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands; and
4. the Listing Rules.

If there is any non-compliance with the above rules and regulations, it will affect the Group's operations, development and financial performance. During the year ended 31 December 2023, the Group complied with all the relevant laws and regulations in the Cayman Islands and Hong Kong that have a significant impact on the Group.

ENVIRONMENTAL POLICY AND PERFORMANCE

The Group complies with environmental legislation, encourages “Green Development, Energy Conservation and Emission Reduction”, and promotes its awareness to all employees of the Group. The Group’s business is inextricably linked to the use of energy. Therefore, the Group has achieved energy conservation and water saving through rectification of its operations and production models. In addition, the Group is closely following the national environmental protection laws and policies to achieve green development.

Further details of the Company’s environmental policy and performance for the year under review are set out in the “Environmental, Social and Governance Report” of the Company, which will be published on the websites of the Company and of the Stock Exchange at the same time as the publication of this annual report.

EQUITY-LINKED AGREEMENTS

During the year under review, other than the share option scheme adopted by the Company on 23 November 2015 (the "Share Option Scheme") as set out in the section headed "Share Option Scheme" below, the Company has not entered into any equity-linked agreement.

SHARE OPTION SCHEME

The Company adopted the Share Option Scheme, which falls within the ambit of, and is subject to the provisions under the old Chapter 17 of the Listing Rules (i.e. prior to the amendments made to such Chapter 17 which took effect on 1 January 2023). The purpose of the Share Option Scheme is to recognise and acknowledge the contributions the eligible participants (the "Eligible Participants") have had or may have made to the Group. The Share Option Scheme will provide the Eligible Participants an opportunity to have a personal stake in the Company with the view to achieving the following objectives: (i) motivating the Eligible Participants to optimise their performance efficiency for the benefit of the Group; and (ii) attracting and retaining or otherwise maintaining on-going business relationships with the Eligible Participants whose contributions are or will be beneficial to the long-term growth of the Group.

Eligible Participants of the Share Option Scheme include: (i) any full-time or part-time employees, executives or officers of the Company or any of its subsidiaries; (ii) any Directors (including independent non-executive Directors) or any directors of the Company's subsidiaries; (iii) any advisers, consultants, suppliers, customers and agents to the Company or any of its subsidiaries; and (iv) such other persons who, in the sole opinion of the Board, will contribute or have contributed to the Group.

The maximum number of shares in respect of which options may be granted (including shares in respect of which options, whether exercised or still outstanding, have already been granted, but excluding shares which would have been issuable pursuant to options which have lapsed in accordance with the terms of the Share Option Scheme) under the Share Option Scheme shall not exceed 100,000,000 shares, being approximately 9.71% of the total number of issued shares of the Company as at the date of this annual report. Since the adoption of the Share Option Scheme, a total of 19,348,000 share options have been granted, of which 456,000 share options were exercised and 18,892,000 share options were lapsed in accordance with the terms of the Share Option Scheme. Accordingly, the total number of shares currently available for issue under the Share Option Scheme is 99,544,000 shares, being approximately 9.66% of the total number of issued shares of the Company as at the date of this annual report.

The total number of shares of the Company issued and to be issued upon exercise of the options granted under the Share Option Scheme (including exercised, cancelled and outstanding options) to each Eligible Participant in any 12-month period shall not, without Shareholders' approval, exceed 1% of the shares of the Company in issue. Where the Eligible Participant is an independent non-executive Director or a substantial Shareholder (as defined in Chapter 1 of the Listing Rules), independent Shareholders' approval is required for grants of options (including exercised, cancelled and outstanding options) to any of them in excess of 0.1% of the issued shares of the Company over a 12-month period.

The offer of a grant of share options under the Share Option Scheme may be accepted within 30 days from the date of offer upon payment of a consideration of HK\$1 by the grantee.

The Share Option Scheme will remain in force for a period of 10 years from 23 November 2015, the date of adoption of the Share Option Scheme. The period during which an option may be exercised will be determined by the Board in its absolute discretion, save that no option may be exercised more than 10 years after it has been granted. Options may be vested over such period(s) as determined by the Board in its absolute discretion subject to compliance with the requirements under any applicable laws, regulations or rules.

The exercise price of share options under the Share Option Scheme is determined by the Board, but shall not be less than the highest of (i) the closing price of the shares of the Company as stated in the daily quotation sheet of the Stock Exchange on the date of grant, which must be a business day; (ii) the average closing price of the shares of the Company as stated in the daily quotation sheets of the Stock Exchange for the five business days immediately preceding the date of grant; and (iii) the nominal value of a share of the Company.

No movement of share options for the year ended 31 December 2023 is shown in this annual report since (i) there were no outstanding share options as at 1 January 2023; and (ii) there was no grant of share options during the year ended 31 December 2023.

Upon implementation of the amended Chapter 17 of the Listing Rules with effect from 1 January 2023, the Company may continue to grant share options under the Share Option Scheme, but it must follow the provisions set out in the amended Chapter 17 of the Listing Rules (including the amended definition of eligible participants).

TEN PAO ELECTRONIC (HUIZHOU) SHARE AWARD SCHEME

On 28 February 2024, the board of directors of Ten Pao Electronic (Huizhou) Co., Ltd.* (天寶電子(惠州)有限公司) (“Ten Pao Electronic (Huizhou)”), an indirect wholly-owned subsidiary of the Company, resolved to propose (i) the adoption of a share award scheme for Ten Pao Electronic (Huizhou) (the “Ten Pao Electronic (Huizhou) Share Award Scheme”) and (ii) the conditional grant of award shares to (a) Ms. Yang Bingbing (“Ms. Yang”), the chief executive officer and a director of Ten Pao Electronic (Huizhou); and (b) Mr. Hong Guangdai (“Mr. G.D. Hong”), a director of Ten Pao Electronic (Huizhou). Pursuant to Rule 17.13 of the Listing Rules, Rules 17.02 to 17.04 and Rules 17.06 to 17.09 of the Listing Rules apply to share schemes of a principal subsidiary of a listed issuer as if they were share schemes of the issuer as described in Rule 17.01(1) of the Listing Rules. Ten Pao Electronic (Huizhou) is a principal subsidiary of the Company. Therefore, pursuant to Rule 17.13 of the Listing Rules, the Ten Pao Electronic (Huizhou) Share Award Scheme, as a share award scheme of a principal subsidiary of the Company, is subject to Rule 17.02 of the Listing Rules and the approval of the Shareholders in general meeting. The proposed adoption of the Ten Pao Electronic (Huizhou) Share Award Scheme and the conditional grant of share awards to Ms. Yang and Mr. G.D. Hong were approved by the independent Shareholders by way of ordinary resolutions at the extraordinary general meeting of the Company held on 8 April 2024.

The purpose of the Ten Pao Electronic (Huizhou) Share Award Scheme is to (i) further establish an effective long-term incentive mechanism of Ten Pao Electronic (Huizhou) and its subsidiaries and associated companies (“Ten Pao Electronic (Huizhou) Group”); (ii) provide the eligible participants with additional incentives in order to retain them, fully motivate the employees of the Ten Pao Electronic (Huizhou) Group and effectively align their interests with the interest of the Ten Pao Electronic (Huizhou) Group and its shareholders, and to enable all parties to focus on the long-term development of the Ten Pao Electronic (Huizhou) Group and to contribute to the sustainable operation and development of the Ten Pao Electronic (Huizhou) Group; and (iii) attract suitable personnel for further development of the Ten Pao Electronic (Huizhou) Group.

Eligible participants of the Ten Pao Electronic (Huizhou) Share Award Scheme include: (i) any director or employee of the Ten Pao Electronic (Huizhou) or any of its subsidiaries (including a person who is granted a share award under the Ten Pao Electronic (Huizhou) Share Award Scheme as a means of procuring a contract of employment with Ten Pao Electronic (Huizhou) or any of its subsidiaries) pursuant to the Ten Pao Electronic (Huizhou) Share Award Scheme, Listing Rules and any applicable laws and regulations; and (ii) any director or employee of the holding company or fellow subsidiary of Ten Pao Electronic (Huizhou).

The maximum number of equity available for issue under the Ten Pao Electronic (Huizhou) Share Award Scheme shall not exceed 10% of the total issued share capital of Ten Pao Electronic (Huizhou) as at the adoption date (i.e. 10% of the registered capital in the amount of RMB24,746,341), being 10% of the total issued share capital of Ten Pao Electronic (Huizhou) as at the date of this annual report. As at 1 January 2023 and 31 December 2023, as the Ten Pao Electronic (Huizhou) Share Award Scheme was not yet adopted, the total number of equity available for grant was nil and nil, respectively. The total number of equity available for grant under the Ten Pao Electronic (Huizhou) Share Award Scheme as at the date of this annual report is RMB14,046,341, representing approximately 5.68% of the total issued share capital of Ten Pao Electronic (Huizhou).

Where any grant of award to an eligible participant would result in the number of award shares transferred or to be transferred or allotted and issued or to be allotted and issued to such eligible participant under all options and awards granted to such eligible participant (excluding any options and awards that have lapsed in accordance with the terms of the relevant scheme) in the 12-month period up to and including the date of such grant representing in aggregate over 1% of total issued shares capital of Ten Pao Electronic (Huizhou), such grant must be approved by the Shareholders in the general meeting of the Company with such eligible participant and his/her close associates (or his/her associates if the eligible participant is a connected person) abstaining from voting.

The award shares granted under the Ten Pao Electronic (Huizhou) Share Award Scheme will vest immediately on the date of grant. The Ten Pao Electronic (Huizhou) Share Award Scheme does not impose a vesting period, and therefore, does not impose performance targets with regard to the vesting of the award shares granted under the Ten Pao Electronic (Huizhou) Share Award Scheme, but the award shares are subject to a lock-up period of 5 years (the "Lock-up Period"). Considering that the award shares granted under the Ten Pao Electronic (Huizhou) Share Award Scheme will be subject to a total holding period (i.e. the Lock-up Period) of 5 years, and such lock-up arrangements are appropriate for retaining, incentivising, rewarding, remunerating and compensating valuable employees, the Directors and the Remuneration Committee are of the view that such arrangement with no vesting period is justifiable and aligns with the purposes of the Ten Pao Electronic (Huizhou) Share Award Scheme.

For the first grant of awards, the price required to be paid by the selected participants to acquire the award shares for each RMB1 registered capital of Ten Pao Electronic (Huizhou) is RMB1/registered capital. For subsequent grant of awards, the grant price is RMB1.55/registered capital. The grant price is determined based on combined factors such as Ten Pao Electronic (Huizhou)'s operating conditions and market conditions. The selected participant shall pay the grant price as provided in the award notice. The funds used by the selected participants to pay the grant price shall be their own funds or other legal self-raised funds.

The Ten Pao Electronic (Huizhou) Share Award Scheme will remain in force for a period of 10 years from 8 April 2024, being the date of adoption of the Ten Pao Electronic (Huizhou) Share Award Scheme.

As the Ten Pao Electronic (Huizhou) Share Award Scheme was not yet adopted during the year ended 31 December 2023, there were no movements of the award shares granted under the Ten Pao Electronic (Huizhou) Share Award Scheme during the year ended 31 December 2023.

PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Articles or the relevant laws of the Cayman Islands which would oblige the Company to offer new shares on a pro-rata basis to its existing Shareholders.

On 6 May 2022, the Company and Golden Ocean Copper entered into a supplemental agreement (the "Supplemental Agreement") to, among other things, revise and increase the annual caps for the years ended 31 December 2022 and 2023 of HK\$95,000,000 and HK\$95,000,000, respectively, to the revised annual caps of HK\$200,000,000 and HK\$230,000,000 (the "Revised Annual Caps"), respectively. The Revised Annual Caps were approved at the extraordinary general meeting of the Company held on 17 June 2022. Such estimate is based on the following considerations: (a) the expected demand for the Group's products for the three years ending 31 December 2024, 2025 and 2026; (b) the projected demand of the DC cables and copper wires that the Group would purchase from Golden Ocean Copper to be used in the Group's products for the three years ending 31 December 2024, 2025 and 2026; (c) the demand of the smart chargers and controllers for the Group's power tools segment; and (d) the estimated market prices of the DC cables and copper wires in the PRC market.

OPINION

What we have audited

- the notes to the consolidated financial statements, comprising material accounting policy information and other explanatory information.

Our opinion

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

The Audit Committee is responsible for overseeing the Group's financial reporting process.

NOTES TO THE FINANCIAL STATEMENTS

1 GENERAL INFORMATION

Ten Pao Group Holdings Limited (天寶集團控股有限公司) (the “Company”) was incorporated in the Cayman Islands on 27 January 2015 as an exempted company with limited liability under the Companies Act, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company’s registered office is Cricket Square, Hutchins Drives, P.O. Box 2681 Grand Cayman KY1-1111, Cayman Islands.

The Company, an investment holding company, and its subsidiaries (collectively, “the Group”) are principally engaged in the developing, manufacturing and sales of electric charging products in the People’s Republic of China (the “PRC”). The controlling shareholder of the Group is Mr. Hung Kwong Yee (洪光禧) (the “Controlling Shareholder” or “Chairman Hung”).

On 11 December 2015, shares of the Company were listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

These financial statements are presented in Hong Kong dollars (HK\$), unless otherwise stated, and have been approved for issue by the Board of Directors of the Company on 22 March 2024.

2 BASIS OF PREPARATION

2.1 Compliance with HKFRS and HKCO

The consolidated financial statements of the Company have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”) as issued by the Hong Kong Institute of Certified Public Accountants and requirements of the Hong Kong Companies Ordinance (“HKCO”) (Cap. 622).

HKFRSs comprise the following authoritative literature:

- Hong Kong Financial Reporting Standards
- Hong Kong Accounting Standards
- Interpretations developed by the Hong Kong Institute of Certified Public Accountants.

2.2 Historical cost convention

The consolidated financial statements have been prepared under the historical cost convention, as modified by the derivative financial instruments, the financial assets at fair value through profit or loss (“FVPL”), the financial assets at fair value through other comprehensive income (“FVOCI”) and investment properties, which are carried at fair value.

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, price risk, cash flow and fair value interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. Risk management is carried out by senior management of the Group approved by the board of directors.

(a) Foreign exchange risk

The Group operates mainly in the PRC, and is exposed to foreign currency risks arising from various currency exposures, mainly with respect to HK\$ and US dollar ("USD"). Exchange rate fluctuations and market trends have always been a concern of the Group. Foreign currency hedging of the Group has been managed by the Group's chief financial officer, and overseen by the Group's chief executive officer. In accordance with the hedging needs and the then foreign exchange situation, the Group's chief financial officer would gather and analyse information regarding various hedging instruments and determine stop-loss thresholds. The Group's chief financial officer would then obtain quotations from various banks as to the financial instrument and present such quotations to the Group's chief executive officer, who would then evaluate and make a decision as to whether to enter into a hedging agreement. Several hedging contracts have been entered into during the past years.

The conversion of Renminbi ("RMB") into foreign currencies is subject to the rules and regulations of foreign exchange control promulgated by the PRC government.

(b) Price risk

The Group is not exposed to equity securities price risk as it has no investment in equity securities that were publicly traded.

(c) Credit risk

The Group is exposed to credit risk mainly in relation to its cash and cash equivalents, restricted bank deposits, trade and other receivables, amounts due from related parties and FVPL.

(i) Risk management and Security

For cash and cash equivalents and restricted bank deposits, the management manages the credit risk by placing all the bank deposits in state-owned financial institutions or reputable banks which are all high-credit-quality financial institutions.

To manage the credit risk in respect of trade receivables, the Group performs ongoing credit evaluations of its debtors' financial condition and does not require collateral from the debtors on the outstanding balances. Based on the expected recoverability and timing for collection of the outstanding balances, the Group maintains an allowance for doubtful accounts and actual losses incurred have been within management's expectations. In addition, in order to reduce the credit risks involved in export sales, the Group maintains a policy of short-term export credit insurance with the China Export and Credit Insurance Corporation (中國出口信用保險公司), an independent insurance company established in the PRC, which covers various credit risks such as customers' bankruptcy, inability to settle payment and refusal to accept our finished products and political risks.

As at 31 December 2023, the Group's credit risk was concentrated to the extent that its five largest customers accounted for 67% (2022: 57%) of the total trade receivables.

Trade receivables

The Group applies the HKFRS 9 simplified approach to measuring expected credit losses (“ECL”) which uses a lifetime expected loss allowance for all trade receivables. To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics.

The expected loss rates are based on the estimated default rates and loss rates, together with the forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables. The Group has identified the gross domestic products and the consumer price indexes of the countries in which it sells its goods and services to be the most relevant factors, and accordingly adjusts the historical loss rates based on expected changes in these factors.

Trade receivables is written off when there is no reasonable expectation of recovery. The Group has considered that credit risk on other receivables and amounts due from related parties has not increased significantly since initial recognition and has assessed the expected credit loss rate under 12-month expected credit loss method based on the Group's assessment in the risk of default of the respective counterparties.

As at 31 December 2023, the Group has assessed that the expected loss rates for other receivables and amounts due from related parties were insignificant. Thus, no loss allowance for other receivables and amounts due from related parties was recognized.

(v) Financial assets at fair value through profit or loss in relation to debt investments

The entity is also exposed to credit risk in relation to debt investments that are measured at fair value through profit or loss. The maximum exposure at the end of the year is the carrying amount of these investments of HK\$3,395,000 (2022 HK\$3,270,000).

(d) Liquidity risk

The Group maintains prudent liquidity risk management by maintaining sufficient cash and bank balances. The Group's liquidity risk is further mitigated through the availability of financing through its own cash resources and the availability of banking facilities to meet its financial commitments. In the opinion of the directors, the Group does not have any significant liquidity risk.

(e) Cash flow and fair value interest rate risk

The Group's interest-rate risk arises from bank borrowings. Bank borrowings at variable rates expose the Group to cash flow interest-rate risk. Bank borrowings at fixed rates expose the Group to fair value interest-rate risk. The Group has entered into fixed-to-floating interest rate swaps to hedge the fair value interest rate risk. If the interest rate for variable rate borrowings had been 1% higher for the year ended 31 December 2023 with all other variables being held constant, the Group's profit before tax would have been higher by HK\$1,473,000 (2022: HK\$4,515,000).

3.2 Capital risk management

As at 31 December 2022 and 2023, changes in interest rates within an expected range had no material impact on the interest income of restricted bank deposits and cash and cash equivalents.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may vary the amount of dividends paid to shareholders, issue new shares or sell assets to reduce debt.

The Group monitors capital on the basis of the gearing ratio. This ratio is calculated as total borrowings divided by total equity.

As these investments and instruments are not traded in an active market, the majority of their fair values have been determined using applicable valuation techniques including comparable transactions approach, cost approach and income approach in the form of a discounted cash flow (“DCF”) methodology. Unlisted investments are primarily valued based on the available transaction price of the latest round of financing of the investees. Where such information is not available, other valuation techniques are used, such as the discounted cash flow method or cost approach. The estimated fair values were based on assumptions, such as the forecasted revenue and discount rates, etc.

The main level 3 inputs used by the Group are derived and evaluated as follows:

- Discount rates for financial assets are determined using a weighted-average cost of capital model to calculate a post-tax rate that reflects current market assessments of the time value of money and the risk specific to the asset.
- Net profit rate for unlisted equity investments are estimated based on the reasonable projections by the Group.
- Discount for lack of marketability (“DLOM”) are estimated based on the Stout Restricted Stock Study Companion Guide published by Stout Risius Ross, LLC.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

4.1 Critical accounting estimates and assumptions

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next financial year are discussed below.

(a) Impairment of trade receivables

Management estimated the ECL on trade receivables based on estimation about default rates and loss rates of customers, taking into the consideration of the forward looking information. Management applied judgments in making the estimation and selecting the inputs used in the ECL calculation, based on the customers' credit risk characteristics, financial position of major customers as well as forward looking information. Details are disclosed in Note 3.1(c).

(b) Allowance for inventories

In determining the amount of allowance required for obsolete and slow-moving inventories, the Group would evaluate ageing analysis of inventories and compare the carrying amount of inventories to their respective net realisable value. A considerable amount of judgment is required in determining such allowances. If conditions which have impact on the net realisable value of inventories deteriorate, additional allowances may be required.

(c) Fair value of derivatives and other financial instruments

The fair value of financial instruments that are not traded in an active market is determined by using valuation techniques. The Group uses its judgment to select a variety of methods and make assumptions that are mainly based on market conditions existing at the end of each reporting period.

(d) Useful lives of property, plant and equipment

The Group's management determines the estimated useful lives of its property, plant and equipment and consequently the related depreciation charges. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. It could change significantly as a result of technical innovations and competitor actions in response to changes of the industry cycles of its products. Management will increase the depreciation charge where useful lives are less than previously estimated lives, or it will write off or write down technically obsolete or non-strategic assets that have been abandoned.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS (CONTINUED)

4.1 Critical accounting estimates and assumptions (Continued)

(e) Income taxes and deferred taxation

Significant judgment is required in determining the provision for income tax. There are many transactions and calculations for which the ultimate determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and tax losses are recognised when management considers to be probable that future taxable profit will be available against which the temporary differences or tax losses can be recognised. The outcome of their actual recognition may be different.

(f) Impairment of goodwill

The Group tests whether goodwill has suffered any impairment annually or, whenever there is an indication of impairment, in accordance with the accounting policy stated in Note 40.5. The recoverable amounts of cash-generating units have been determined based on the value in use. These calculations require the use of estimates (Note 16).

5 SEGMENT INFORMATION

The chief operating decision maker has been identified as the executive directors of the Company. The executive directors review the Group's internal reporting in order to assess performance and allocate resources and have determined the operating segments based on the internal reports that are used to make strategic decisions. The executive directors considered the nature of the Group's business and determined that the Group's electric charging products can be categorised into six reportable segments as follows: (i) telecommunication, (ii) media and entertainment, (iii) lighting, (iv) smart chargers and controllers, (v) new energy business, and (vi) others.

In view of the increased scale and business importance of the development of new energy business, and to help investors better understand the Group's revenue structure and margin trends, a new segment named "New Energy Business" has been separated from "Others" segment from 2023, both in the internal reports to the chief operating decision makers and in the consolidated financial statements of the Group. The New Energy Business segment primarily consists of products relating to (a) charging modules and energy storage of outdoor power equipment; and (b) automotive electronics applications. The comparative figures in the consolidated income statement and the notes have been restated to conform with the new presentation. The Board believes that the above changes in segment information better reflect current market trends, as well as resource allocation and future business development of the Group.

In light of the reduction in size of the Group's electrical home appliances business, the segment information previously presented under the "Electrical home appliances" segment has been reclassified to the "Others" segment from 2023 onwards, both in the internal reports to the chief operating decision makers and in the consolidated financial statements of the Group. The comparative figures have also been reclassified to conform to the new presentation. The Board believes that the above changes in segment information better reflect current market trends, as well as resource allocation and future business development of the Group.

(i) Sales of goods in the PRC and overseas

Revenue from the sale of good directly to the customers is recognised at the point that the control of the inventory have passed to the customers, which is primarily upon the acceptance of the products by the customers. The customers have full discretion over the products and there is no unfulfilled obligation that could affect the customers' acceptance of the products. The Group collects cash or bank acceptance notes from the customers before or upon deliveries of products through banks. Cash or bank acceptance notes collected from the customers before product delivery is recognised as contract liability.

(ii) Interest income

Interest income is recognised on a time-proportion basis using the effective interest method.

Under the current Hong Kong Inland Revenue Ordinance, from the year of assessment 2018/2019 onwards, the subsidiaries in Hong Kong are subject to profits tax at the rate of 8.25% on assessable profits up to HK\$2,000,000, and 16.5% on any part of assessable profits over HK\$2,000,000. The payments of dividends by these companies to their shareholders are not subject to any Hong Kong withholding tax.

(c) PRC CIT

CIT is provided on the assessable income of entities within the Group incorporated in the PRC, calculated in accordance with the relevant regulations of the PRC after considering the available tax benefits.

Pursuant to the PRC Corporate Income Tax Law passed by the Tenth National People's Congress on 16 March 2007 (the "CIT Law"), the CIT rate for domestic and foreign enterprises has been unified at 25%, effective from 1 January 2008.

Ten Pao Electronic (Huizhou) Co., Ltd. ("Ten Pao Electronic (Huizhou)") and Dazhou Ten Pao Jin Hu Electronic Co., Ltd. ("Ten Pao Electronic (Dazhou)") are recognized as "New and High Technology Enterprises" and enjoys a preferential CIT rate of 15%. Their CIT rate for the year ended 31 December 2023 was 15% (2022: 15%).

Shanxi Huifeng Electronic Technology Co., Ltd. and Huizhou Ten Pao Chuangneng Technology Co., Ltd. are recognized as "New and High Technology Enterprise" in 2023 and enjoys a preferential CIT rate of 15%. Their CIT rate for the year ended 31 December 2023 was 15% (2022: 25%).

According to the CIT Law, starting from 1 January 2008, a withholding income tax of 10% will be levied on the immediate holding companies outside the PRC when their PRC subsidiaries declare dividend out of profits earned after 1 January 2008. 40.1 Consolidation

Subsidiaries

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Business combination

The Group applies the acquisition method to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

The Group recognises any non-controlling interest in the acquiree on an acquisition-by-acquisition basis, either at fair value or at the non-controlling interest's proportionate share of the recognised amounts of acquiree's identifiable net assets.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability is recognised in accordance with HKAS 39 in profit or loss. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

The excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identifiable net assets acquired is recorded as goodwill. If the total of consideration transferred, non-controlling interest recognised and previously held interest measured is less than the fair value of the net assets of the subsidiary acquired in the case of a bargain purchase, the difference is recognised directly in the statement of profit or loss.

Intra-group transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. When necessary, amounts reported by subsidiaries have been adjusted to conform with the Group's accounting policies.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.2 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). RMB is the functional currency of principal operating subsidiaries of the Group. These consolidated financial statements are presented in HK\$, which is the presentation and functional currency of the Company.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the statement of profit or loss, except when deferred in other comprehensive income as qualifying cash flow hedges and qualifying net investment hedges.

(c) Group companies

The results and financial position of all the Group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that statement of financial position;
- (ii) income and expenses for each statement of profit or loss are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting currency translation differences are recognised in other comprehensive income.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised as a separate component of equity in other comprehensive income.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.3 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated statement of profit or loss over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to property, plant and equipment are included in non-current liabilities as deferred government grants and are credited to the consolidated statement of profit or loss on a straight-line basis over the expected lives of the related assets.

40.4 Property, plant and equipment

All property, plant and equipment are stated at historical cost less depreciation and impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Construction in progress is property, plant and equipment on which construction work has not been completed and stated at cost. Cost includes acquisition and construction expenditure incurred, interest and other direct costs attributable to the development. Depreciation is not provided on construction in progress until the related asset is completed for intended use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are expensed in the consolidated statement of profit or loss during the financial period in which they are incurred.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within 'Other gains — net' in the statement of profit or loss.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.5 Impairment of non-financial assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows cash-generating units. Non-financial assets other than goodwill that suffered impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

40.6 Investments and other financial assets

(i) Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at FVOCI.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

(ii) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

(iii) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at FVPL, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

(iii) Measurement (Continued)

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are two measurement categories into which the Group classifies its debt instruments:

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains-net together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of profit or loss.
- FVPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in profit or loss and presented net within other gains-net in the period in which it arises.

Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at FVPL are recognised in 'Other gains — net' in the statement of profit or loss as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

(iv) Impairment

The Group assesses on a forward looking basis the expected credit losses associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see Note 3.1(c) for further details.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.7 Current and deferred income tax

The tax expense for the period comprises current and deferred tax. Tax is recognised in the consolidated statement of profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantially enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Offsetting

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income tax assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

40.8 Share-based payment

The Group operates a number of equity-settled, share-based compensation plans, under which the entity receives services from employees as consideration for equity instruments (options) of the Group. The fair value of the employee services received in exchange for the grant of the options is recognised as an expense. The total amount to be expensed is determined by reference to the fair value of the options granted.

When the options are exercised, the Company issues new shares. The proceeds received net of any directly attributable transaction costs are credited to share capital (and share premium).

40.9 Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of real estate for which the Group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.9 Leases (Continued)

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Group under residual value guarantees
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option, and payments of penalties for terminating the lease, if the lease term reflects the Group exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- makes adjustments specific to the lease e.g. term, country, currency and security.

The Group is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

40.9 Leases (Continued)

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and
- restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life. While the Group revalues its land and buildings that are presented within property, plant and equipment, it has chosen not to do so for the right-of-use buildings held by the Group.

Payments associated with short-term leases of equipment and vehicles are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term (Note 14). Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. The respective leased assets are included in the balance sheet based on their nature. The Group did not need to make any adjustments to the accounting for assets held as lessor as a result of adopting the new leasing standard.

40.10 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

40.11 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the steering committee that makes strategic decisions.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.12 Land use rights

Land use rights are up-front payments to acquire long-term interests in the usage of land. They are stated at cost and charged to the consolidated statement of profit or loss over the remaining period of the lease on a straight-line basis, net of any impairment losses.

40.13 Investment property

Investment property, principally comprising buildings, is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group. It also includes properties that are being constructed or developed for future use as investment properties. Land held under operating leases are accounted for as investment properties when the rest of the definition of an investment property is met. In such cases, the operating leases concerned are accounted for as if they were finance leases. Investment property is initially measured at cost, including related transaction costs and where applicable borrowing costs. After initial recognition, investment properties are carried at fair value, representing open market value determined at each reporting date by external valuers. Fair value is based on active market prices, adjusted, if necessary, for any difference in the nature, location or condition of the specific asset. If the information is not available, the Group uses alternative valuation methods such as recent prices on less active markets or discounted cash flow projections. Changes in fair values are recorded in the statement of profit or loss as part of a valuation gain or loss in 'Other gains — net'.

40.14 Intangible assets

(a) Patents, computer software and trademarks at historical costs

Patents are amortised on a straight-line basis over useful lives of 10 years.

Acquired computer software programmes are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised over the estimated useful lives of 3 to 10 years on a straight-line basis.

Trademarks have a finite useful life and are carried at cost less accumulated amortisation. Amortisation is calculated using the straight-line method to allocate the cost of trademarks and licenses over their estimated useful lives of 10 years.

(b) Goodwill

Goodwill is allocated to cash-generating units for the purpose of impairment testing. The allocation is made to those cash-generating units or groups of cash-generating units that are expected to benefit from the business combination in which the goodwill arose. The units or groups of units are identified at the lowest level at which goodwill is monitored for internal management purposes, being the operating segments.

40.15 Research and development expenditure

Research expenditures is recognised as an expense as incurred. Costs incurred on development projects relating to the design and testing of new and improved products are recognised as intangible assets when the following criteria are met:

- it is technically feasible to complete the intangible asset so that it will be available for use;
- management intends to complete the intangible asset and use or sell it;
- there is an ability to use or sell the intangible asset;
- it can be demonstrated how the intangible asset will generate probable future economic benefits;
- adequate technical, financial and other resources to complete the development and to use or sell the intangible asset are available; and
- the expenditure attributable to the intangible asset during its development can be reliably measured.

Other development expenditures that do not meet these criteria are recognised as an expense as incurred. Development cost previously recognised as an expense is not recognised as an asset in a subsequent period. Capitalised development costs are recorded as intangible assets and amortised from the point at which the asset is ready for use on a straight-line basis over their estimated useful lives.

40.16 Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold in the ordinary course of business. If collection of trade and other receivables is expected in one year or less or in the normal operating cycle if longer, they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment.

40.17 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. In the consolidated and entity balance sheet, bank overdrafts are shown within borrowings in current liabilities.

40.18 Restricted bank deposits

Restricted bank deposits represent deposits held by the bank in a segregated account as security for borrowings from the bank. Such restricted bank deposits will be released when the Group repays the related bank borrowings.

40.19 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

40.20 Trade payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

40.21 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds net of transaction costs and the redemption value is recognised in the statement of profit or loss over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

40.22 Borrowing costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

40 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES (CONTINUED)

40.23 Employee benefits

Pension obligations

The Group contributes on a monthly basis to various defined contribution plans organised by the relevant governmental authorities. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior years. The contributions are recognised as employee benefit expense when they are due.

Housing funds, medical insurance and other social insurances

Full-time employees of the Group's subsidiaries in the PRC participate in a government mandated multi-employer defined contribution plan pursuant to which certain pension insurance, medical insurance, unemployment insurance, maternity insurance, occupational injury insurance, employee housing fund and other welfare benefits are provided to employees. Chinese labor regulations require that the subsidiaries of the Group make contributions to the government for these benefits based on certain percentages of the employees' salaries. The Group has no legal obligation for the benefits beyond the contributions made.

40.24 Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

41 SUBSEQUENT EVENTS

On 28 February 2024, the Company announced the proposed adoption of the share award scheme ("Ten Pao Electronic (Huizhou) Share Award Scheme") of Ten Pao Electronic (Huizhou), an indirect wholly-owned subsidiary of the Company; and the proposed conditional grant of award shares of Ten Pao Electronic (Huizhou) to (i) Ms. Yang Bingbing, the chief executive officer and a director of Ten Pao Electronic (Huizhou); and (ii) Mr. Hong Guangdai, a director of Ten Pao Electronic (Huizhou) (the "Conditional Grant"). The Ten Pao Electronic (Huizhou) Share Award Scheme and the Conditional Grant were approved by the independent shareholders by way of ordinary resolutions at the extraordinary general meeting of the Company held on 8 April 2024.
