CHAIRMAN'S STATEMENT

主席致辭

Dear shareholders.

On behalf of Dexin China Holdings Company Limited (the "Company"), I am pleased to present the audited annual results and business review and future prospects of the Company and its subsidiaries (collectively, the "Group") for the year ended 31 December 2023 (the "Reporting Period").

The year 2023 was a year full of challenges and opportunities for China's real estate market. As the population has entered an era of negative growth and urbanization has entered a latter stage, the supply-demand relationship of China's real estate market has changed, and the industry as a whole has presented a complex and changeable situation. At the beginning of the year, due to the concentrated release of backlog demand during the pandemic, the property market in many places across the country ushered in a wave of "modest recovery", but the overall market fundamentals were still weak, after a short-lived rally, the property market was frozen again. The real estate industry has experienced a difficult time, access to financing encountered obstacles, market transactions declined, presale funds were under stringent regulation, liquidity continued to tighten, and the industry entered a period of profound adjustment.

In the face of severe market environment and fierce competitive pressure, the Company insists on ensuring delivery as the focus, and endeavours to warrant the smooth delivery of its projects. As we recognize well that on-time delivery is crucial to meeting the expectations of buyers and is also one of the key elements in maintaining people's livelihood. Therefore, we have taken a series of measures to strengthen project management and quality control to ensure that our projects are delivered on time, and in agreed quality and quantity.

Throughout 2023, the Group has delivered approximately 40,000 units in 49 batches, with a delivered area of 6.20 million sg.m., representing 100% delivery as contracted.

In order to achieve the goal of on-time delivery, we work with policymakers, financial institutions and real estate companies to jointly promote on-time delivery. From the "ensuring on-time delivery" policy first mentioned in July last year to the implementation of "three arrows" to support the financing of real estate companies, and then to increase the financial support for guaranteeing the delivery of housing projects this year, the three parties of policymakers, financial institutions and housing enterprises have worked together to ensure the smooth delivery of projects. At the same time, we also actively responded to the call of the government to strengthen the supervision of pre-sale funds for real estate projects, prevent the channelling of funds from their original purposes, and ensure the safety and stability of project funds.

By the end of 2023, our land reserve in first - and second-tier cities has reached 80% of our portfolio. The Company has always taken the first- and second-tier cities as an essential component of the Company's land reserve, and consolidating high-quality land resources in the Yangtze River Delta region will be a strong backup for the future development of the Company.

For the year ended 31 December 2023, the Group recorded a total revenue of approximately RMB24.51 billion, representing a year-on-year increase of approximately 10.7%. Among which, revenue from the sales of properties was RMB23.98 billion, representing a year-on-year increase of 12.9%. The main revenue contributors were those cities like Hangzhou, Wenzhou and Shanghai where the Group has involved in their development for a long time, which played the functional role of the Company by focusing on the core regions at the critical moment.

GENERAL OVERVIEW

In 2023, economic activities in different countries were slowly recovering from the COVID-19. However, there was insufficient momentum for economic growth. In the first year of recovery after the COVID-19, although the global supply chain had returned to normal, production and demand were still affected by high interest rates and economic downturn. Political risks and energy supply issues were gradually receding, but the United States and the euro zone were still plaqued by inflation and monetary policy tightening. High interest rates posed a challenge to economic recovery. In 2023, both the US and Europe saw significant changes in their interest rate policies as they navigated the economic challenges of the post-pandemic era. The European Central Bank maintained historically high interest rates. This was part of a broader strategy to balance recession risks with inflationary pressures. Similarly, the Federal Reserve in the US ended the year with high federal funds rate. These rates were set against the backdrop of inflation stabilization and were expected to decrease gradually between 2024 and 2026.

In terms of the domestic economy, the annual GDP of China grew by 5.2% year-on-year. Under the optimization and upgrade of the domestic economic structure, the real estate sector was still in the process of deep adjustment and transformation. The national real estate development investment amounted to RMB11,091.3 billion, representing a decrease of 9.6% as compared to last year. The sales area of commercial housing was 1,117.35 million sq.m., representing a decrease of 8.5% as compared to last year. The sales of commercial housing amounted to RMB11,662.2 billion, representing a decrease of 6.5%. The construction area for housing was 8,383.64 million sq.m., representing a decrease of 7.2% as compared to last year. The data showed that both the investment and sales have declined. At the policy level, despite the gradual relaxation of controls in many areas, the effect on demand was trivial and sales remained sluggish. There was a circular impact on the investment and supply ends due to the continuous lack of improvement in sales and financing. Positive progress was made on the delivery front. The gross floor area of housing completed amounted to 998.31 million sq.m., representing an increase of 17.0%.

The year 2023 was marked by a slow and cautious recovery from the COVID-19. While there were signs of improvement, such as the normalization of the global supply chain and the receding of political risks and energy supply issues, challenges remained. High interest rates, economic downturn, inflation, and the tightening of monetary policies in the United States and the Eurozone were significant hurdles on the path to recovery. The global economy was on the mend, but the journey to full recovery was still underway.

BUSINESS REVIEW

The Group derives its revenue primarily from sales of properties and, to a lesser extent, property construction and project management services, lease of commercial properties and hotel operations. For the year ended 31 December 2023, the Group recorded a total revenue of approximately RMB24,509.8 million, representing a year-on-year increase of approximately 10.7%.

For the year ended 31 December 2023, including those of joint ventures and associates, the Group recorded contracted sales of approximately RMB22,160 million, representing a year-on-year decrease of approximately 38.6%, and contracted GFA sales of approximately 1,195,000 sq.m., representing a year-on-year decrease of approximately 39.4%. The average selling price ("ASP") of our contracted sales for the year ended 31 December 2023 was approximately RMB18,544 per sq.m., representing a year-on-year increase of approximately 1.4%.

Sales of properties

For the year ended 31 December 2023, the revenue from sales of properties increased by approximately 12.9% year-on-year to approximately RMB23,976 million, accounting for approximately 97.8% of the total revenue of the Group. For the year ended 31 December 2023, the Group recognised total GFA of approximately 1,320,337 sq.m., representing an increase of approximately 24.3% as compared to the year ended 31 December 2022. The ASP of the properties recognised as property sales was approximately RMB18,159 per sq.m., representing a decrease of approximately 9.2% year-on-year. The decrease of ASP was mainly due to the increase in the recognised GFA of areas with lower ASP.

管理層討論及分析

Property construction and project management services

For the year ended 31 December 2023, the revenue from property construction and project management services decreased by approximately 57.4% year-on-year to approximately RMB246.2 million, accounting for approximately 1.0% of the total revenue of the Group. The decrease was primarily attributable to a decrease in the volume of our construction and project management services for our projects in operation.

Management and consulting service income

For the year ended 31 December 2023, the revenue from management and consulting service income decreased by approximately 14.2% year-on-year to approximately RMB141.9 million, accounting for approximately 0.6% of the total revenue of the Group. The decrease was primarily attributable to the decrease in the sales of the joint ventures and associates in service during the Reporting Period.

Lease of commercial properties

For the year ended 31 December 2023, the revenue from rental income decreased by approximately 12.0% year-on-year to approximately RMB91.5 million, accounting for approximately 0.4% of the total revenue of the Group. The decrease was primarily attributable to the decrease in the occupancy rate of rental properties during the Reporting Period.

Hotel operations

For the year ended 31 December 2023, the revenue from hotel operations decreased by approximately 0.6% year-on-year to approximately RMB54.1 million, accounting for approximately 0.2% of the total revenue of the Group. The decrease was primarily attributable to the decrease of occupancy rate for the year ended 31 December 2023 as compared to the previous year.

物業建築及項目管理服務

The Group will further improve the efficiency in development and operation of its investment properties to ensure stable rental income growth, and to strengthen earnings sustainability.

Land reserves

Leveraging on the Group's deep understanding of the property markets in our key development areas and intensive studies on its target cities, the Group continued to strategically select and acquire parcels of land at strategic and advantageous locations in those regions and cities in order to further develop the Group's presence in those markets. As of 31 December 2023, the Group (together with its joint ventures and associates) had 134 projects with land reserves amounting to approximately 10,110,017 sq.m., of which 113 projects were located in the Yangtze River Delta Region, and the remaining 21 projects were located in the Pearl River Delta, Chengdu-Chongqing economic areas, the economic belt of middle reaches of Yangtze River and other regions.

FINANCIAL REVIEW

Overall performance

During the year ended 31 December 2023, total revenue of the Group was approximately RMB24,509.8 million, representing a year-onyear increase of approximately 10.7%. Gross profit was approximately RMB1,799.3 million, representing a year-on-year decrease of approximately 17.4%. Gross profit margin was approximately 7.3%, representing a year-on-year decrease of approximately 2.5 percentage points. Net loss of the Group recorded approximately RMB1,960.3 million for the year ended 31 December 2023. Loss attributable to owners of the Company decreased by approximately 685.7% yearon-year to approximately RMB2,188.9 million for the year ended 31 December 2023.

Revenue

For the year ended 31 December 2023, the Group recorded a total revenue of approximately RMB24,509.8 million, representing a yearon-year increase of approximately 10.7%. The increase was primarily attributable to the increase in revenue from sales of properties. Specifically, revenue from the sales of properties was approximately RMB23,976.2 million, representing a year-on-year increase of approximately 12.9%, accounting for approximately 97.8% of the total revenue of the Group; revenue from property construction and project management service was approximately RMB246.2 million, representing a year-on-year decrease of approximately 57.4% accounting for approximately 1.0% of the total revenue of the Group; revenue from management and consulting services was approximately RMB141.9 million, representing a year-on-year decrease of approximately 14.2%, accounting for approximately 0.6% of the total revenue of the Group; rental income from the lease of commercial properties was approximately RMB91.5 million, representing a year-on-year decrease of approximately 12.0%, accounting for approximately 0.4% of the total revenue of the Group; and revenue from hotel operations was approximately RMB54.1 million, representing a year-on-year decrease of approximately 0.6%, accounting for approximately 0.2% of the total revenue of the Group.

財務回顧

整體表現

截至2023年12月31日止年度,本集團總收 入約為人民幣24.509.8百萬元,同比上升約 10.7%。毛利約為人民幣1,799.3百萬元,同比 減少約17.4%。毛利率約為7.3%,同比減少約 2.5個百分點。截至2023年12月31日止年度, 本集團錄得淨虧損約為人民幣1.960.3百萬元。 截至2023年12月31日止年度,本公司擁有人應 佔虧損同比減少約685.7%至約人民幣2.188.9 百萬元。

收入

截至2023年12月31日止年度,本集團錄得總 收入約為人民幣24,509.8百萬元,同比上升 約10.7%。有關上升主要是由於物業銷售收入 增加所致。具體而言,物業銷售收入約為人民 幣23,976.2百萬元,同增加約12.9%,佔本集 團總收入的約97.8%;物業建築及項目管理服 務收入約為人民幣246.2百萬元,同比減少約 57.4%,佔本集團總收入的約1.0%;管理及 諮詢服務收入約為人民幣141.9百萬元,同比 減少約14.2%,佔本集團總收入的約0.6%; 商業物業租賃的租金收入約為人民幣91.5百萬 元,同比減少約12.0%,佔本集團總收入的約 0.4%;以及酒店運營收入約為人民幣54.1百 萬元,同比減少約0.6%,佔本集團總收入的約 0.2% °

管理層討論及分析

Cost of sales

The cost of sales of the Group primarily consists of the costs incurred directly in relation to the property development and sales activities, property construction and project management services, lease of commercial properties and hotel operations.

For the year ended 31 December 2023, the cost of sales of the Group was approximately RMB22,710.6 million, representing a year-on-year increase of approximately 13.7%.

Gross profit

For the year ended 31 December 2023, the gross profit of the Group was approximately RMB1,799.3 million, representing a year-on-year decrease of approximately 17.4%. The decrease was primarily because overall gross profit margin decreased from approximately 9.8% for the year ended 31 December 2022 to approximately 7.3% for the year ended 31 December 2023. The overall gross profit margin decreased by approximately 2.5 percentage points. The decrease in overall gross profit margin is primarily attributable to the increase in the cost of sales of the recognized projects during the Reporting Period.

Other income

The Group had other income of approximately RMB92.6 million for the year ended 31 December 2023, as compared to approximately RMB126.4 million for the year ended 31 December 2022. The other income mainly included interest income from related party and third party amounts of approximately RMB7.9 million, income of guarantee provided for the borrowings of joint ventures and associates of approximately RMB0.7 million and others of approximately RMB84.0 million (for the year ended 31 December 2022: interest income from related party and third party amounts of approximately RMB36.5 million, income of guarantee provided for the borrowings of joint ventures and associates of approximately RMB8.5 million and others of approximately RMB81.3 million). The decrease was primarily attributable to a year-on-year decrease in the number of the joint ventures and associates in service during the Reporting Period.

銷售成本

本集團的銷售成本主要包括物業開發及銷售活動、物業建築及項目管理服務、商業物業租賃 及酒店運營直接產生的成本。

截至2023年12月31日止年度,本集團的銷售成本約為人民幣22,710.6百萬元,同比增加約13.7%。

毛利

截至2023年12月31日止年度,本集團的毛利約 為人民幣1,799.3百萬元,同比減少約17.4%。 有關減少主要是由於整體毛利率由截至2022年 12月31日止年度的約9.8%減至截至2023年12 月31日止年度的約7.3%。整體毛利率下降約 2.5個百分點。整體毛利率下降主要由於報告期 內項目結轉的銷售成本增加所致。

其他收入

截至2023年12月31日止年度,本集團錄得其他收入約為人民幣92.6百萬元,截至2022年12月31日止年度則錄得約為人民幣126.4百萬元。其他收入主要包括來自關聯方及第三方款項約為人民幣7.9百萬元的利息收入、就合營企業及聯營公司借款提供擔保的收入約為人民幣0.7百萬元及其他約為人民幣84.0百萬元(截至2022年12月31日止年度:來自關聯方及第三方款項約為人民幣36.5百萬元的利息收入、就合營企業及聯營公司借款提供擔保的收入約為人民幣8.5百萬元及其他約為人民幣81.3百萬元),有關減少主要由於報告期內提供服務的合營企業及聯營公司數目同比減少。

Other losses - net

The Group recorded net other losses of approximately RMB212.4 million for the year ended 31 December 2023 (for the year ended 31 December 2022: net other losses of approximately RMB85.1 million). The Group's net other losses for the year ended 31 December 2023 mainly included exchange losses of approximately RMB48.1 million, losses on disposal of subsidiaries of approximately RMB88.5 million and other losses of approximately RMB103.4 million. The Group's net other losses for the year ended 31 December 2022 mainly included losses on financial assets at fair value through profit or loss of approximately RMB36.0 million, losses on disposal of subsidiaries approximately RMB121.3 million and exchange losses of approximately RMB110.3 million.

Fair value (losses)/gains on investment properties

The Group develops and holds certain of its commercial properties such as commercial centres, office buildings, shopping malls, serviced apartments and car parks for rental income or capital appreciation, or both. Any increase or decrease in the Group's investment property value is recognised as fair value gains or losses in the Group's consolidated financial statements.

For the year ended 31 December 2023, the Group recorded fair value losses on investment properties of approximately RMB533.4 million (for the year ended 31 December 2022: fair value losses on investment properties of approximately RMB25.8 million), which was primarily attributable to the fair value losses of some projects.

Selling and marketing expenses

The Group's selling and marketing expenses increased by approximately 22.73% year-on-year from approximately RMB689.2 million for the year ended 31 December 2022 to approximately RMB845.8 million for the year ended 31 December 2023. Taking the selling and marketing expenses that were capitalized in contract acquisition costs into account, total selling and marketing expenses for the year ended 31 December 2023 increased, compared to the previous year. The increase was primarily attributable to the increase in the capitalized sales of recognized properties and the selling expenses during the Reporting Period.

其他虧損淨額

截至2023年12月31日止年度,本集團錄得其 他虧損淨額約為人民幣212.4百萬元(截至2022 年12月31日止年度:其他虧損淨額約為人民幣 85.1百萬元)。本集團截至2023年12月31日止 年度的其他虧損淨額主要包括匯兑虧損約為人 民幣48.1百萬元、出售附屬公司虧損約為人民 幣88.5百萬元及其他虧損約為人民幣103.4百 萬元。本集團截至2022年12月31日止年度的其 他虧損淨額主要包括按公允價值計量且其變動 計入損益的金融資產虧損約為人民幣36.0百萬 元、出售附屬公司的虧損約為人民幣121.3百 萬元及匯兑虧損約為人民幣110.3百萬元。

投資物業公允價值(虧損)/收益

本集團開發並持有若干商業物業(例如商業中 心、辦公樓、購物商場、酒店式公寓及停車 場),以賺取租金收入或取得資本增值或兩者兼 得。本集團投資物業的升值或貶值部分會於本 集團綜合財務報表中確認為公允價值收益或虧 損。

截至2023年12月31日止年度,本集團錄得投資 物業公允價值虧損約為人民幣533.4百萬元(截 至2022年12月31日止年度:投資物業公允價值 虧損約為人民幣25.8百萬元),主要是由於部份 項目公允價值虧損。

銷售及營銷開支

本集團的銷售及營銷開支由截至2022年12月31 日止年度的約為人民幣689.2百萬元同比增加 約22.73%至截至2023年12月31日止年度的約 為人民幣845.8百萬元。經計及於合約收購成 本資本化之銷售及營銷開支後,截至2023年12 月31日止年度之銷售及營銷開支總額較上年有 所增加。該增加主要是由於報告期內結轉物業 的資本化銷售及行致銷售開支增加所致。

管理層討論及分析

Administrative expenses

The Group's administrative expenses increased by approximately 21.2% year-on-year from approximately RMB870.5 million for the year ended 31 December 2022 to approximately RMB1,054.8 million for the year ended 31 December 2023. The increase was primarily attributable to the impact of provision for impairment of inventories and receivables during the Reporting Period as a result of the impact of the macroeconomic situation and the downturn in the real estate market.

Finance costs - net

Finance costs of the Group increased by approximately 260.2% year-on-year from approximately RMB97.9 million for the year ended 31 December 2022 to approximately RMB352.5 million for the year ended 31 December 2023. The increase was primarily attributable to the increase in finance costs of amounts due to non-controlling interests and related parties and the decrease in deductible capitalised interest and income from bank deposits.

Share of results of joint ventures and associates

The Group accounts for the results of joint ventures and associates using the equity method, which mainly represent the share of profits related to the projects delivered during the relevant period that have been offset by losses incurred by other joint ventures and associates.

Share of results of joint ventures and associates decreased by approximately 132.6% year-on-year from profits of approximately RMB626.1 million for the year ended 31 December 2022 to a loss of approximately RMB204.1 million for the year ended 31 December 2023. The decrease was primarily attributable to the GFA of properties delivered from joint ventures and associates decreased year-on-year during the year.

Income tax expenses

Income tax expenses of the Group decreased by approximately 35.1% year-on-year from approximately RMB1,000.4 million for the year ended 31 December 2022 to approximately RMB649.2 million for the year ended 31 December 2023, which was primarily attributable to a year-on-year decrease in the profit before tax during the year and the decrease in the overall gross profit margin of the projects.

行政開支

本集團的行政開支由截至2022年12月31日止年度的約為人民幣870.5百萬元同比增加約21.2%至截至2023年12月31日止年度的約為人民幣1,054.8百萬元。該增加主要是由於受宏觀經濟形勢及房地產市場低迷的影響,報告期內計提存貨和應收款項減值準備之影響所致。

融資成本淨額

本集團的融資成本由截至2022年12月31日止年度的約為人民幣97.9百萬元同比增加約260.2%至截至2023年12月31日止年度的約為人民幣352.5百萬元。該增加乃主要由於應付非控股權益及關聯方融資成本增加、可扣減資本化利息及銀行存款利息收入減少所致。

分佔合營企業及聯營公司業績

本集團採用權益法將合營企業及聯營公司的業績入賬,有關業績主要是與相關期間內交付的項目有關的應佔利潤,有關利潤已被其他合營企業及聯營公司產生的虧損抵銷。

應佔合營企業及聯營公司的業績由截至2022年 12月31日止年度的利潤約為人民幣626.1百萬 元同比減少約132.6%至截至2023年12月31日 止年度的虧損約為人民幣204.1百萬元。有關 減少主要是由於年內合營企業及聯營公司交付 物業的建築面積同比減少。

所得税開支

本集團的所得税開支由截至2022年12月31日 止年度的約為人民幣1,000.4百萬元同比減少約 35.1%至截至2023年12月31日止年度的約人民 幣649.2百萬元,其主要是由於年內稅前溢利 同比減少以及項目整體毛利率下降所致。

管理層討論及分析

Profit and total comprehensive income for the year

As a result of the foregoing reasons, the Group's profit and total comprehensive income decreased by approximately 1,313.6% from approximately RMB161.5 million for the year ended 31 December 2022 to loss of approximately RMB1,960.3 million for the year ended 31 December 2023. The profit attributable to owners of the Company decreased by approximately 685.7% from approximately RMB373.7 million for the year ended 31 December 2022 to the loss attributable to owners of the Company approximately RMB2,188.9 million for the year ended 31 December 2023.

The basic and diluted losses per share of the Company is RMB0.74 per share for the year ended 31 December 2023, representing a decrease of approximately 628.6% from earnings per share of RMB0.14 for the year ended 31 December 2022.

Liquidity and financial resources

The Group has always pursued a prudent treasury management policy and actively manages its liquidity position with sufficient standby banking facilities to cope with daily operation and any demands for capital for future development.

During the year ended 31 December 2023, the Group funded its operations, working capital, capital expenditure and other capital requirements primarily from cash generated from its operations, mainly including proceeds from the pre-sales and sales of properties, receipt of rental income, income generated from investment properties, as well as bank loans and borrowings from other financial institutions.

As of 31 December 2023, the Group had a total cash and cash equivalents and restricted cash of approximately RMB4,745.2 million as compared to approximately RMB7,375.2 million as of 31 December 2022. The decrease was primarily due to the decrease in proceeds from sales of properties. Substantially all of the Group's cash and cash equivalents were denominated in RMB, USD and HKD.

年內利潤及全面收益總額

截至2023年12月31日止年度,本公司的每股基 本及攤薄虧損為每股股份人民幣0.74元,較截 至2022年12月31日止年度的每股盈利人民幣 0.14元減少約為628.6%。

流動資金及財務資源

本集團一貫奉行審慎的財資管理政策,積極管 理其流動資金頭寸,具備足夠的備用銀行授信 額度,可應對日常經營和未來發展的資金需 求。

截至2023年12月31日止年度,本集團主要以 經營所得現金(主要包括物業預售及銷售所得款 項、收取租金收入、投資物業所得收入)及銀行 貸款以及自其他金融機構借款撥付其經營、營 運資金、資本開支及其他資本需求。

截至2023年12月31日,本集團有現金及現金 等價物及受限制現金合共約為人民幣4,745.2 百萬元,截至2022年12月31日則為約人民幣 7,375.2百萬元。有關減少主要是由於物業銷售 所得款項減少。本集團絕大部分現金及現金等 價物以人民幣、美元及港元計值。

管理層討論及分析

During the year ended 31 December 2023, addition of borrowings obtained by the Group amounted to approximately RMB1,483.0 million and reduction of borrowings amounted to approximately RMB6,265.4 million. As of 31 December 2023, the Group's total borrowings amounted to approximately RMB16,408.7 million, representing a decrease of approximately 22.6% compared to approximately RMB21,191.1 million as of 31 December 2022. Amongst the borrowings, approximately RMB13,449.9 million (as at 31 December 2022: approximately RMB9,340.6 million) shall be repayable within one year and approximately RMB2,958.8 million (as at 31 December 2022: approximately RMB11,850.5 million) shall be repayable after one year.

As of 31 December 2023, the Group had total facilities from banks and other financial institutions of approximately RMB48,500 million and unused facilities from banks and other financial institutions of approximately RMB37,340 million.

Key financial ratios

As of 31 December 2023, the Group's net gearing ratio (calculated as the total borrowings from banks and other financial institutions net of restricted cash, cash and cash equivalents divided by total equity) was approximately 96.4%, an increase by 27.8 percentage points as compared with approximately 68.7% as of 31 December 2022. The increase was primarily attributable to the decrease in total assets.

The Group's current ratio was calculated based on its total current assets divided by its total current liabilities as of the respective dates. The Group's current ratio had slightly decreased from approximately 1.26 times as of 31 December 2022 to approximately 1.08 times as of 31 December 2023.

截至2023年12月31日,本集團的銀行及其他金融機構授信額度總額為約為人民幣48,500百萬元,未動用銀行及其他金融機構授信額度為約為人民幣37,340百萬元。

主要財務比率

截至2023年12月31日,本集團的淨資本負債比率(按銀行及其他金融機構借款總額扣除受限制現金以及現金及現金等價物後除以權益總額計算)約為96.4%,相較於截至2022年12月31日的約68.7%增加27.8個百分點。有關增加主要歸因於資產總額減少。

本集團的流動比率按截至各日期的總流動資產 除以總流動負債計算。本集團的流動比率由截 至2022年12月31日的約1.26倍小幅下降至截至 2023年12月31日的約1.08倍。

Foreign exchange risk

The Group mainly operates its business in China. Other than the foreign currency denominated bank deposits, bank borrowings and senior notes, the Group did not have any other material direct exposure to foreign exchange fluctuations for the year ended 31 December 2023. Although RMB depreciated against U.S. dollar and Hong Kong dollar in 2023, the Directors expect that such fluctuation of RMB's exchange rate would not have material adverse effects on the operation of the Group.

The Group will closely monitor the exchange rate risk regularly and make foreign exchange hedging arrangement when necessary. The Group considers that no foreign exchange hedging arrangement is needed currently.

Pledge of assets

As of 31 December 2023, certain of the Group's borrowings from banks and other financial institutions were secured by its properties held for sale, properties under development, land use rights and investment properties, with carrying value of approximately RMB20,315.0 million as of 31 December 2023 (31 December 2022: approximately RMB34,514.9 million). The Group's equity interests in certain subsidiaries were pledged as security for borrowing as at 31 December 2023.

The Group has arranged bank mortgage financing for certain purchasers of the Group's property units and provided guarantees to the relevant banks to secure repayment obligations of such purchasers. As of 31 December 2023, the maximum amount of guarantees provided by the Group to the relevant banks for the mortgage arrangements of the Group's purchasers amounted to approximately RMB5,374.1 million (31 December 2022: approximately RMB16,036.1 million). These include guarantees which will be terminated upon the earlier of the following two dates: (i) the date when the property ownership rights are transferred to the purchasers. and the related building ownership certificates to which banks are beneficiaries are registered, or (ii) the date when mortgage loans are settled between the mortgagee banks and the purchasers, under the circumstance that the purchasers pay off the purchase price in advance.

EMPLOYEES AND REMUNERATION POLICY

The Group firmly believes that talent is the most important corporate resource and always adheres to a people-oriented human resources development strategy, creating a sound working environment featuring harmonious development and positive interaction between the Group and its staff. As of 31 December 2023, the Group had a total of 1,273 (31 December 2022: 1,561) employees. Total expenditure on salary and welfare of the Group's employees for the year ended 31 December 2023 amounted to approximately RMB423.2 million (for the year ended 31 December 2022: approximately RMB713.2 million).

Besides, the Group endeavors to establish an incentive system aligned to the corporate development objective to improve employee engagement. Meanwhile, with an aim to establish an open-ended organization, the Group keeps optimizing the organizational structure, empowering the base-level employees and improving efficiency.

The Group has adopted a system of determining the remuneration of employees based on the performance of employees. In general, the Group provides competitive remuneration packages to employees, which include basic salaries, performance-based rewards and year-end bonus. The Group also pays social security insurance for the Group's employees, including medical insurance, work-related injury insurance, endowment insurance, maternity insurance, unemployment insurance and housing funds. In addition, the Group has formulated a project co-investment scheme and has adopted a share option scheme on 11 January 2019 to fully enhance the enthusiasm of the Group's employees. In terms of employee training, the Group provides consistent and systematic training to employees based on their positions and expertise, in order to enhance their expertise in real estate and their related fields.

本集團堅信人才是企業最重要的資源,始終堅持以人為本的人力資源開發策略,構築起企業與員工和諧發展、良性互動的工作氛圍。截至2023年12月31日,本集團共有1,273名僱員(2022年12月31日止年度,本集團的僱員薪金福利開支總額約為人民幣423.2百萬元(截至2022年12月31日止年度:約人民幣713.2百萬元)。

FUTURE PROSPECTS

As the largest economic zone in China, the Yangtze River Delta Region accounts for approximately one-fourth of China's GDP. The Group has been focusing on the Yangtze River Delta Region for years, and will continue to seize the development opportunities in the region by leveraging on its local brand advantages, while expanding into other core and potential cities in China. Upholding a long-termism view, the Group will stay true to its original aspiration of developing high quality products with repeated calculations and upgrading, thus providing good products and services to create value for customers. The Group will rely on years of extensive development and management experience and operation capabilities, continue to expand into cities with diversified development potential, support the future sales growth of the Company with high-efficiency operation as well as sell-through and cash collection rates outperforming the market level, and also respond to changes and control risks with prudent judgment.

The Group will continue to emphasize the business concept of "improving internal skills for resilient development and sticking to customer-oriented approach to create value for customers", and maintain the quality image of "Hangzhou workmanship". Against the backdrop of the central government's general policy of "housing is used for living, not for speculation" and "ensuring delivery", the Group will persist in the steady development, adhere to the strategy of focusing on deep cultivation, stick to prudent financing, optimize the capital structure, continue to improve financing costs, deepen the "selective and strategic" capital cooperation strategy, so as to achieve a balanced development of scale, profit and brand, achieve quality and resilient growth, and bring long-term and stable investment returns to all investors.

The Directors consider the Share Option Scheme, with its broadened basis of participation, will enable the Group to reward employees, Directors and other selected participants for their contributions to the Group. Given that the Directors are entitled to determine the performance targets to be achieved as well as the minimum period that an option must be held before an option can be exercised on a case by case basis, and that the exercise price of an option cannot in any event fall below the price stipulated in the Listing Rules or such higher price as may be fixed by the Directors, it is expected that grantees of an option will make an effort to contribute to the development of the Group so as to bring about an increased market price of the Shares in order to capitalize on the benefits of the options granted.

The total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option scheme of the Group shall not in aggregate exceed 10% of the Shares in issue on the day on which trading of the Shares commence on the Stock Exchange, such 10% limit represents 263,200,000 Shares, but excluding any Shares which may be issued upon the exercise of the Over-allotment Option.

As at the date of this annual report, no hearing has taken place in relation to the Petition and no winding-up order has been made by the High Court against the Company. The Petition is scheduled to be heard on 5 June 2024.

The Board sets and promotes corporate culture and expects and requires all employees to reinforce. All of our new employees are required to attend orientation and training programs so that they may better understand our corporate culture, structure and policies, learn relevant laws and regulations, and raise their quality awareness. In addition, from time to time, the Company will invite external experts to provide training to our management personnel to improve their relevant knowledge and management skills.

The Board considers that the corporate culture and the purpose, values and strategy of the Group are aligned.

THE BOARD

(1) Responsibilities

The Board is responsible for the overall leadership of the Group, oversees the Group's strategic decisions and monitors business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. To oversee particular aspects of the Company's affairs, the Board has established three Board Committees including the Audit Committee, the Remuneration Committee and the Nomination Committee. The Board has delegated to the Board Committees responsibilities as set out in their respective terms of reference. All Board Committees are provided with sufficient resources to perform their duties.

All Directors shall ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and its Shareholders at all times.

For the year ended 31 December 2023, the Board at all times met the requirements of Rules 3.10(1), 3.10(2) and 3.10(A) of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications or accounting or related financial management expertise and the appointment of independent non-executive Directors representing at least one-third of the Board. Among the three independent non-executive Directors, Dr. Wong Wing Kuen Albert has appropriate professional qualifications or accounting or related financial management expertise as required by Rule 3.10(2) of the Listing Rules.

(4) Board diversity policy

Pursuant to Rule 13.92 of the Listing Rules, the nomination committee (or the Board) shall have a policy concerning diversity of board members, and shall disclose the policy on diversity or a summary of the policy in the corporate governance report. The board diversity policy of the Company (the "Board Diversity Policy") specifies that in designing the composition of the Board, Board diversity shall be considered from a number of aspects, including but not limited to age, cultural and educational background, professional experience, skills and knowledge. The appointment of Directors will be based on meritocracy, and candidates will be evaluated against objective criteria, having due regard for the benefits of diversity of the Board. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, professional experience, knowledge and skills.

The composition of the Board will be disclosed in the Corporate Governance Report every year and the Nomination Committee will supervise the implementation of this policy. The Nomination Committee will review the effectiveness of this policy, as appropriate, discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval. The Board will annually review the implementation of the Board Diversity Policy and its effectiveness.

The Board targets to appoint at least a female director no later than 31 December 2024, with the ultimate goal of achieving gender parity.

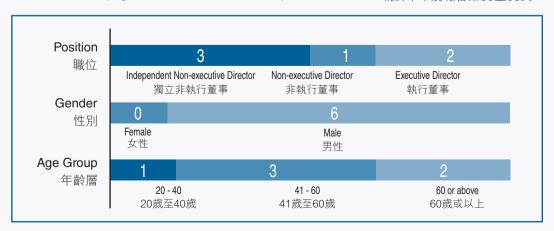

The Nomination Committee has reviewed the membership, structure and composition of the Board, and is of the opinion that the structure of the Board is reasonable, and the experiences and skills of the Directors in various aspects and fields can enable the Company to maintain high standard of operation.

(5) Measurable objectives

For the purpose of implementation of the Board Diversity Policy, the following measurable objectives were adopted:

- (i) Independence: The Board should include a balanced composition of executive and non-executive Directors (including independent non-executive Directors) so that there is a strong element of independence in the Board. The independent non-executive Directors shall be of sufficient calibre and stature for their views to carry weight.
- (ii) Skills and experience: The Board possesses a balance of skills appropriate for the requirements of the business of the Company. The Directors have a mix of finance, academic and management backgrounds that taken together provide the Company with considerable experience in a range of activities.

Apart from the above objectives, the Board Diversity Policy has the following objectives to comply with the Listing Rules:

- 1. at least one third of the members of the Board shall be independent non-executive Directors;
- 2. at least three of the members of the Board shall be independent non-executive Directors;
- 3. at least one of the members of the Board shall have obtained appropriate professional qualifications or accounting or related financial management expertise; and
- 4. at least one of the members of the Board shall be female.

Save that the Board is currently comprised of male directors and targets to appoint a female director no later than 31 December 2024, the Board has achieved the measurable objectives in the Board Diversity Policy.

(5) 可衡量目標

(6) Confirmation of independence by the independent non-executive Directors

The Company has received written annual confirmation from each independent non-executive Director of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers all independent non-executive Directors to be independent in accordance with the independence guidelines as set out in the Listing Rules.

Except that Mr. Hu Yiping (an executive Director) is the father of Mr. Hu Shihao (a non-executive Director), none of the Directors has any personal relationship (including financial, business, family or other material/relevant relationship), with any other Director.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee and the Nomination Committee.

As regards the CG Code provision requiring Directors to disclose the number and nature of offices held in public companies or organisations and other significant commitments as well as their respective identity of the public companies or organisations and the time involved to the issuer, the Directors have agreed to disclose, and already disclosed their commitments to the Company in a timely manner.

(7) Induction and continuous professional development

Pursuant to the code provision C.1.4 of the CG Code, all Directors should participate in continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant.

Pursuant to the code provision C.1.1 of the CG Code, each newly appointed Director should be provided with necessary induction and information to ensure that he/she has a proper understanding of the Company's operations and businesses as well as his/her responsibilities under relevant statutes, laws, rules and regulations.

就企業管治守則有關要求董事披露本身在公眾公司或組織所擔任職務的數目及性質及其他重大承諾,以及公眾公司或組織的各自身份及向發行人投入的時間,董事已同意披露且已及時披露其對本公司的承諾。

(7) 入職及持續專業發展

根據企業管治守則守則條文第C.1.1條,各 新任董事應獲提供必要的就任須知及資訊 以確保其對本公司的經營及業務以及其於 相關法令、法律、法規及規例下的責任有 適當的理解。

(8) Chairman and Chief Executive Officer

Under the code provision C.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and performed by different individuals. Under the current organisation structure of the Company, Mr. Hu Yiping is the Chairman of the Company and Mr. Fei Zhongmin is the president of the Company (namely, the chief executive officer of the Company).

The Board and the senior management, which comprises experienced individuals with high calibre, can ensure the balance of power and authority. As at 31 December 2023, the Board comprised two executive Directors, one non-executive Director and three independent non-executive Directors.

(9) Appointment and re-election of Directors

Each of Mr. Hu Yiping and Mr. Fei Zhongmin, being an executive Directors, has entered into a service contract with the Company for an initial term of three years commencing from the Listing Date.

Mr. Hu Yiping and Mr. Fei Zhongmin, being the executive Directors, have renewed the service contract with the Company for a term of three years commencing from 26 February 2022.

Mr. Hu Shihao, being the non-executive Director, has entered into a letter of appointment with the Company for an initial term of three years commencing from the Listing Date.

Mr. Hu Shihao, being the non-executive Director, has renewed the letter of appointment with the Company for a term of three years commencing from 26 February 2022.

Each of Dr. Wong Wing Kuen Albert, Mr. Ding Jiangang and Mr. Chen Hengliu, being an independent non-executive Director, has entered into a letter of appointment with the Company for an initial term of three years commencing from the Listing Date.

Dr. Wong Wing Kuen Albert, Mr. Ding Jiangang and Mr. Chen Hengliu, being the independent non-executive Directors, have renewed the letter of appointment with the Company for a term of three years commencing from 26 February 2022.

Save as disclosed above, none of the Directors has or is proposed to have entered into any service agreement or letter of appointment with any member of the Group (excluding agreements expiring or determinable by any member of the Group within one year without payment of compensation other than statutory compensation).

In accordance with the Articles, at each annual general meeting one-third of the Directors for the time being shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years.

Any new Director appointed to fill a casual vacancy shall submit himself/herself for election by shareholders at the first general meeting of the Company after appointment and any new Director appointed as an addition to the Board shall submit himself/herself for re-election by the Shareholders at the next following annual general meeting of the Company after appointment.

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles. The Nomination Committee is responsible for reviewing the Board composition, monitoring and make recommendations to the Board on the appointment, re-election and succession planning of Directors, in particular the Chairman and the Chief Executive Officer.

(10) Board meetings and committee meetings

The Company adopts the practice of holding board meetings regularly, at least four times a year, and at approximately quarterly intervals. Both the Nomination Committee and the Remuneration Committee shall meet at least once every year and the Audit Committee shall meet at least twice a year. Notices of not less than fourteen days are given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting. For other Board and committee meetings, reasonable notice is generally given. The agenda and accompanying board papers are dispatched to the Directors or committee members at least three days before the intended date of the meeting to ensure that they have sufficient time to review the papers and be adequately prepared for the meeting. When Directors or committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the chairman of the Board or the committee members prior to the meeting. Minutes of meetings are kept by the Company Secretary with copies circulated to relevant Board or Board Committee for comments and records.

(12) Delegation by the Board

The Board reserves for its decision on all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters. The Directors could have recourse to seek independent professional advice in performing their duties at the Company's expense and are encouraged to access and to consult with the Company's senior management independently.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board to ensure that they remain appropriate to the Company's needs. Approval has to be obtained from the Board prior to any significant transactions entered into by the management on the Company's behalf.

(13) Corporate governance function

The Board recognizes that corporate governance should be the collective responsibility of Directors and has delegated the corporate governance duties to the Audit Committee which include:

- (a) to develop and review the Group's policies and practices on corporate governance and make recommendations to the Board:
- (b) to review and monitor the training and continuous professional development of Directors and senior management of the Group;
- (c) to review and monitor the Group's policies and practices on compliance with legal and regulatory requirements;

INDEPENDENT OPINION MECHANISM OF THE BOARD

The Company recognizes that Board independence is key to good corporate governance. The Company has in place effective mechanisms that underpin an independent Board and independent views. The current composition of the Board comprises one third of the independent non-executive Directors. The majority of the members of the Audit Committee, Nomination Committee and Remuneration Committee are independent non-executive Directors. The Audit Committee and Remuneration Committee are both chaired by independent non-executive Directors. The remuneration of independent non-executive Directors are subject to a regular review to maintain competitiveness and commensurate with their responsibilities and workload. The independence of each independent non-executive Director is assessed upon his/her appointment and annually.

Directors are requested to declare their direct or indirect interests, if any, in proposals or transactions to be considered by the Board at the Board meetings and abstain from voting, where appropriate. External independent professional advice is available to all Directors, including independent non-executive Directors, whenever deemed necessary. The independent non-executive Directors have consistently demonstrated strong commitment and the ability to devote sufficient time to discharge their responsibilities at the Board.

The majority of the committee members are independent non-executive Directors. Mr. Hu Yiping is the chairman of this committee.

The principal duties of the Nomination Committee include the following:

- To review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually and to make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- To develop the criteria for identifying and assessing the qualifications of and evaluating candidates for directorship;
- To identify individuals who are suitably qualified to become a member of the Board and to select or make recommendations to the Board on the selection of individuals nominated for directorships;
- To assess the independence of independent non-executive directors of the Company:

The Board has adopted the following policy with regard to nomination of Directors.

1. Objective

The Policy aims to:

- set out the criteria and process in the nomination and appointment of directors of the Company;
- ensure that the Board of the Company has a balance of skills, experience and diversity of perspectives appropriate to the Company; and
- ensure the Board's continuity and appropriate leadership at Board level.

2. Scope

The Policy applies to the Directors of the Company and where applicable, senior management prepared for Board positions under the succession planning of the Company.

3. Nomination and Appointment of Directors

3.1 Criteria

In evaluating and selecting any candidate for directorship, the Nomination Committee shall consider the following criteria in evaluating and selecting candidates for directorships:

- Character and integrity.
- Qualifications including professional qualifications, skills, knowledge and experience and diversity aspects under the Board Diversity Policy that are relevant to the business and corporate strategies of the Company.
- Any measurable objectives adopted for achieving diversity on the Board.
- Willingness to devote adequate time to discharge duties as a Board member and other directorships and significant commitments.

3.2 Nomination Procedures

3.2.1 Appointment of directors

- (i) The Nomination Committee identifies individual(s) suitably qualified to become Board members, having due regard to the board diversity policy and the nomination policy of the Company, and assesses the independence of the proposed independent nonexecutive director(s) as appropriate.
- (ii) The Nomination Committee makes recommendation(s) to the Board.
- (iii) The Board considers the individual(s) recommended by the Nomination Committee, having due regard to the board diversity policy and the nomination policy of the Company.
- (iv) The Board confirms the appointment of the individual(s) as director(s) or recommends the individual(s) to stand for election at a general meeting. Individual(s) appointed by the Board to fill a casual vacancy or as an addition to the Board will be subject to re-election by shareholders of the Company at the next annual general meeting after initial appointment in accordance with the articles of association of the Company.
- (v) The chairman of the Nomination Committee shall attend the annual general meeting of the Company to answer the questions raised by the shareholders on the nomination of directors and other matters in relation to the Policy.

- (v) 提名委員會主席應出席本公司 股東週年大會,回答股東就董 事提名及與本政策有關的其他 事宜所提出的問題。

3.2.2 Re-appointment of directors

- (i) The Nomination Committee shall review the overall contribution and service to the Company of the retiring director including his attendance of Board meetings and, where applicable, general meetings, and the level of participation and performance of the Board.
- (ii) The Nomination Committee shall also review and determine whether the retiring director continues to meet the criteria as set out in 3.1.
- (iii) The Board considers each retiring director recommended by the Nomination Committee, having due regard to the board diversity policy and the nomination policy of the Company.
- (iv) The Board recommends the retiring directors to stand for re-election at the annual general meeting in accordance with the Articles.
- (v) The shareholders approve the re-election of directors at the annual general meeting.

The Nomination Committee shall review the structure, size, composition (including skills, knowledge and experience) of the Board on a regular basis at least annually and diversity of the Board to ensure that it has a balance of expertise, skills and experience and diversity of perspective appropriate to the requirements for the business of the Company.

The Nomination Committee shall keep under review the leadership needs of the Company, both executive and non-executive, with a view to ensuring the continued ability of the Company to complete effectively in the marketplace.

The Nomination Committee shall keep up to date and fully informed about strategic issues and commercial changes affecting the Company and the market in which it operates.

As at 31 December 2023, the audit committee of the Company (the "Audit Committee") comprised three members, namely Mr. Hu Shihao (a non-executive Director), Dr. Wong Wing Kuen Albert (an independent non-executive Director) and Mr. Ding Jiangang (an independent non-executive Director), the majority of whom are independent non-executive Directors. Dr. Wong Wing Kuen Albert is the chairman of this committee. The main duties of the Audit Committee include the following:

- To be primarily responsible for making recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;
- To review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards. The Committee should discuss with the auditor the nature and scope of the audit and reporting obligations before the audit commences;
- To develop and implement policies on engaging an external auditor to provide non-audit services. For this purpose, "external auditor" includes any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The committee should report to the Board, identifying and making recommendations on any matters where action or improvement is needed;
- To monitor the integrity of the Company's financial statements, annual reports, accounts, half yearly reports and, if prepared for publication, quarterly reports, and to review significant financial reporting judgments contained in them;
- To review the Company's financial controls, risk management and internal control systems;

THE DISCLAIMER OF OPINION REGARDING THE COMPANY'S ABILITY TO CONTINUE AS A GOING CONCERN

The Company's auditor, Elite Partners CPA Limited, issued a disclaimer of opinion on the consolidated financial statements of the Group, details of which are set out in the sections headed "Disclaimer of Opinion" and "Basis for Disclaimer of Opinion" in the independent auditor's report on pages 131 to 132 of this annual report, note 2.1 to the consolidated financial statements on pages 143 to 150 of this annual report.

Pursuant to code provision D.1.3 of the CG Code, the Board would like to provide additional details on the disclaimer of opinion regarding the Company's ability to continue as a going concern.

Basis for Disclaimer of Opinion

The Group incurred net loss of RMB1,960,305,000 for the year ended 31 December 2023. As at 31 December 2023, the Group's net current assets amounted to RMB4,821,819,000. As of that date, the Group's current portion of borrowings amounted to RMB13,449,949,000, while its cash and cash equivalents amounted to RMB4,599,819,000.

As at 31 December 2023, the Group had not repaid certain senior notes according to their scheduled repayment date and the corresponding restructuring support agreement did not proceed as scheduled and certain bank borrowings and other borrowings had become default or cross default as described in Note 30 to the consolidated financial statement.

On 20 March 2024, a winding-up petition against the Company was filed by China Construction Bank (Asia) Corporation Limited in the High Court of the Hong Kong Special Administrative Region against the Company, in relation to the non-payment of the abovementioned senior notes issued by the Company in the principal amount of US\$350,000,000 and accrued interests of US\$17,413,000.

The above conditions indicate the existence of material uncertainties which may cast significant doubt on the Group's ability to continue as a going concern. For further details of the multiple material uncertainties relating to continue as a going concern as well as the basis to the independent auditor's disclaimer of opinion, please refer to the independent auditor's report as well as Note 2.1(iii).

於2023年12月31日,如綜合財務報表附註30 所述,本集團並未按預定還款日期償還若干優 先票據,相應重組支持協議並無按計劃進行, 若干銀行及其他借款借款已違約或交叉違約。

於2024年3月20日,中國建設銀行(亞洲)股份有限公司向香港特別行政區高等法院提交針對本公司的清盤呈請,內容有關未支付本公司發行的本金額為350,000,000美元的上述優先票據及應計利息17,413,000美元。

上述情況表明現有的重大不確定性可能對本集團持續經營之能力構成重大疑問。有關持續經營的多種重大不確定因素的進一步詳情及獨立核數師不發表意見的依據,請參閱獨立核數師報告及附註2.1(iii)。

The Management's Position, View and Assessment on the Disclaimer of Opinion

The Board has given careful consideration to the matters raised by the independent auditor, the liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial sources to continue as a going concern. The Board is of the view that there are no differences between the views of the Board and the auditors on the preparation of the consolidated financial statements on a going concern basis with the disclosures of multiple material uncertainties relating to events and conditions that may cast significant doubt upon the Group's ability to continue as a going concern.

In view of the uncertainties relating to going concern, the directors of the Company have been undertaking the following measures to improve the Group's liquidity and financial position:

- (i) the Group will actively negotiate with its creditors of the senior notes and seek external financial advisers for various feasible solutions to the relevant notes;
- (ii) the Group is actively negotiating with several existing financial institutions and investors on the extension of certain borrowings. The Group is also actively negotiating with various financial institutions to secure new loans at reasonable costs;
- (iii) the Group will continue to implement measures to accelerate the pre-sales and sales of its properties under development and completed properties, and to speed up the collection of outstanding sales proceeds and other receivables. Recent relaxation of policies with regards to pre-sale requirements have been encouraging to increase buyer interests and stimulate demand. The Group will also continue to actively adjust sales and pre-sale activities to better respond to changing markets to achieve the latest budgeted sales and pre-sales volumes and amounts:
- (iv) the Group continues to identify suitable buyers and engage in discussions with certain potential buyers regarding the possible disposal of the equity interests in certain property development projects or shopping malls of the Group in order to raise additional funds; and

The directors of the Group have reviewed the Group's cash flow projections prepared by management, which cover a period of not less than twelve months from 31 December 2023. They are of the opinion that, taking into account the abovementioned plans and measures and its available sources of financing, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from 31 December 2023. Accordingly, the directors of the Group are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

The effects of these adjustments have not been reflected in these consolidated financial statements.

matters involving management's substantial judgments. The Audit Committee agrees that the Group's measures as mentioned above are carefully planned and closely monitored, which will significantly improve the Group's financial position if successfully implemented. The Audit Committee also concurs with the Directors' view as to the preparation of the consolidated financial statements of the Company on a going concern basis with multiple material uncertainties disclosed. Moreover, the Audit Committee requested the management to take all necessary actions to address the uncertainties regarding going concern underlying the disclaimer of opinion that no such disclaimer of opinion will be made in the forthcoming audited financial statements.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is responsible for monitoring the risk management and internal control systems of the Group on an ongoing basis and review their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss.

The management of the Group updates and reports the key risk areas, including any remedial plans, if deemed necessary or appropriate, to the Audit Committee for consideration. The identified key risk areas and the appropriate risk mitigation strategies were reviewed and commented by the Board at its meeting annually.

The Board, through the Audit Committee, conducted review of both design and implementation effectiveness of the risk management and internal control systems of the Group for the year ended 31 December 2023, covering all material controls, including financial, operational and compliance controls, with a view to ensuring that resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions are adequate. In this respect, the Audit Committee communicates any material issues to the Board.

During the year ended 31 December 2023, our internal control department performed internal control review and carries out the analysis and independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems.

Our Enterprise Risk Management Framework

The Company has established its enterprise risk management framework in 2019. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing an internal control system to manage all kinds of risks facing by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritized and allocated treatments. Our risk management framework follows the COSO Enterprise Risk Management – Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit Committee that oversees risk management and internal audit functions.

Our Risk Control Mechanism

The effectiveness of the risk management and internal control systems for the year ended 31 December 2023 was conducted by our internal audit department. The review is conducted annually. The Group maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit Committee, and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk owners have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient manner.

Based on the overall ESG management philosophy, the Group has established an ESG management framework and performed review on our ESG works in good time. We were engaged to audit the consolidated financial statements of Dexin China Holdings Company Limited (the "Company") and its subsidiaries (hereinafter collectively referred to as the "Group"), which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of material accounting policy information.

We do not express an opinion on the consolidated financial statements of the Group. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these consolidated financial statements. In all other respects, in our opinion the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR DISCLAIMER OF OPINION

Going concern

As set out in Note 2.1 (iii) to the consolidated financial statements, the Group incurred net loss of RMB1,960,305,000 for the year ended 31 December 2023. As at 31 December 2023, the Group's net current assets amounted to RMB4,821,819,000. As of that date, the Group's current portion of borrowings amounted to RMB13,449,949,000, while its cash and cash equivalents amounted to RMB4,599,819,000.

These conditions, together with other matters disclosed in note 2.1 to the financial statements, indicate the existence of material uncertainties which may cast significant doubt on the Group's ability to continue as a going concern.

The validity of the use of going concern assumption on which the consolidated financial statements have been prepared depends on the outcome of these measures, which are subject to uncertainties, including: (i) successfully negotiating with the creditors of senior notes for various feasible solutions to the relevant notes: (ii) successfully carrying out the Group's business strategy plan including the acceleration of the sales of properties; (iii) successfully obtaining of additional new sources of financing as and when needed and extending of certain borrowings; (iv) successfully disposing of the Group's equity interest in property development projects or shopping malls when suitable; and (v) successfully implementing measures to speed up the collection of outstanding sales proceeds.

However, we have not obtained sufficient appropriate audit evidence in relation to verify the assumption or input or existence in relation to the measures describe above and regarding the Group's ability to meet its financial obligations and we have disclaimed our opinion.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

1. GENERAL INFORMATION

Dexin China Holdings Company Limited (the "Company") was incorporated in the Cayman Islands on 16 January 2018 as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The Company is an investment holding company. The Company and its subsidiaries (the "Group") are principally engaged in the property development and construction services, property investment and hotel operations in the People's Republic of China (the "PRC").

The Company's shares were listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 26 February 2019.

These consolidated financial statements are presented in Renminbi ("RMB"), unless otherwise stated.

2. MATERIAL ACCOUNTING POLICIES **INFORMATION**

This note provides a list of the material accounting policies information adopted in the preparation of these consolidated financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial statements are for the Group consisting of the Company and its subsidiaries.

2.1 Basis of preparation

(i) Compliance with Hong Kong Financial Reporting Standards ("HKFRSs") and Hong Kong Companies Ordinance ("HKCO")

The consolidated financial statements of the Group have been prepared in accordance with HKFRSs and disclosure requirements of the HKCO.

(ii) Historical cost convention

The consolidated financial statements have been prepared under the historical cost convention, as modified by the revaluation of financial assets at fair value through profit or loss and investment properties, which are carried at fair value.

(iii) Going concern basis

For the year ended 31 December 2023, the Group incurred net loss of RMB1,960,305,000. As at 31 December 2023, the Group's net current assets amounted to RMB4,821,819,000. As of that date, the Group's current portion of borrowings amounted to RMB13,449,949,000, while its cash and cash equivalents amounted to RMB4,599,819,000.

On 13 December 2023, the Company announced that the restructuring support agreement for restructuring of senior notes was not proceed as scheduled such that the aggregate principal amount of the relevant outstanding senior notes of US\$350,000,000 and the accrued interest of US\$17,413,000 became overdue. As of the date of approval of these consolidated financial statements, the Company has not made such payments.

In additions, as at 31 December 2023, certain bank borrowings and other borrowings of the Group with the principal balance of RMB2,219,550,000 became cross-default and repayable on demand under the circumstances that the unpaid senior notes as described above.

此外,於2023年12月31日,本集 團本金餘額人民幣2,219,550,000 元的若干銀行借款及其他借款在上 述未付優先票據的情況下交叉違約 且須按要求償還。

On 20 March 2024, a winding-up petition against the Company (the "Petition") was filed by China Construction Bank (Asia) Corporation Limited in the High Court of the Hong Kong Special Administrative Region (the "High Court") against the Company, in relation to the nonpayment of the above mentioned senior notes issued by the Company.

The above conditions indicated the existence of material uncertainties that may cast significant doubt on the Group's ability to continue as a going concern.

In view of aforesaid mentioned, the directors of the Group have given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial sources to continue as a going concern. The following plans and measures are formulated to mitigate the liquidity pressure and to improve the financial position of the Group:

- (i) The Group will actively negotiate with its creditors of the senior notes and seek external financial advisers for various feasible solutions to the relevant notes:
- (ii) The Group is actively negotiating with several existing financial institutions and investors on the extension of certain borrowings. The Group is also actively negotiating with various financial institutions to secure new loans at reasonable costs:

- (iii) The Group will continue to implement measures to accelerate the pre-sales and sales of its properties under development and completed properties, and to speed up the collection of outstanding sales proceeds and other receivables. Recent relaxation of policies with regards to pre-sale requirements have been encouraging to increase buyer interests and stimulate demand. The Group will also continue to actively adjust sales and pre-sale activities to better respond to changing markets to achieve the latest budgeted sales and pre-sales volumes and amounts;
- (iv) The Group continues to identify suitable buyers and engage in discussions with certain potential buyers regarding the possible disposal of the equity interests in certain property development projects or shopping malls of the Group in order to raise additional funds; and
- (v) The Group will continue to take active measures to control administrative costs and maintain containment of capital expenditures.

The directors of the Group have reviewed the Group's cash flow projections prepared by management, which cover a period of not less than twelve months from 31 December 2023. They are of the opinion that, taking into account the above mentioned plans and measures and its available sources of financing, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from 31 December 2023. Should the Group be unable to achieve the abovementioned plans and measures, it might not be able to continue to operate as a going concern, adjustments would have to be made to write down the carrying values of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and noncurrent liabilities as current assets and current liabilities, respectively. Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

(a) Business combinations

Business combinations under common control

The consolidated financial statements incorporates the financial statement items of the combining entities or businesses in which the common control combination occurs as if they had been consolidated from the date when the combining entities or businesses first came under the control of the controlling party.

The net assets of the combining entities or businesses are consolidated using the existing book values from the controlling party's perspective. No amount is recognised in respect of goodwill or excess of acquirer's interest in the net fair value of acquiree's identifiable assets, liabilities and contingent liabilities over cost at the time of common control combination, to the extent of the continuation of the controlling party's interest.

The consolidated income statements and the consolidated statements of comprehensive income includes the results of each of the combining entities or businesses from the earliest date presented or since the date when the combining entities or businesses first came under the common control, where this is a shorter period, regardless of the date of the common control consolidation.

A uniform set of accounting policies is adopted by those entities. All intra-group transactions, balances and unrealised gains on transactions between combining entities or business are eliminated on consolidation.

The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date. The Group recognises any non-controlling interest in the acquiree on an acquisitionby-acquisition basis. Non-controlling interests in the acquiree that are present ownership interest and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation are measured at either fair value or the present ownership interest's proportionate share of the recognised amounts of acquiree's identifiable net assets. All other components of non-controlling interests are measured at their acquisition date fair value, unless another measurement basis is required by HKFRS.

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date. Any gains or losses arising from such re-measurement are recognised in profit or loss.

Transactions with non-controlling interests that do not result in loss of control are accounted for as equity transactions – that is, as transactions with the owners of the subsidiary in their capacity as owners. The difference between fair value of any consideration paid and the relevant share acquired of the carrying value of net assets of the subsidiary is recorded in equity. Gains or losses on disposals to non-controlling interests are also recorded in equity.

(c) Disposal of subsidiaries

When the Group ceases to have control, any retained interest in the entity is re-measured to its fair value at the date when control is lost, with the change in carrying amount recognised in profit or loss. The fair value is the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category if equity as specified/permitted by applicable HKFRSs.

For structured entities, the Group assesses whether they should be consolidated based on the contractual terms as to whether the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Third-party beneficiaries' interests in the consolidated structured entities with a limited life or puttable instruments issued and are classified as liabilities in the Group's consolidated balance sheets, and net profits or losses attributable to third-party beneficiaries are recorded in consolidated profit or loss as "finance costs".

(e) Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment and is being either the cash consideration amount or the amount of net asset value of the subsidiaries for share-settled transaction under reorganisation and business combination under common control. The results of subsidiaries are accounted for by the company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting. Under the equity method of accounting, the investments are initially recognised at cost, and the carrying amount is increased or decreased to recognise the investor's share of the profit or loss of the investee after the date of acquisition. Dividends received or receivable from associates are recognised as a reduction in the carrying amount of the investment. The Group's investment in associates includes goodwill identified on acquisition. Upon the acquisition of the ownership interest in an associate, any difference between the cost of the associate and the Group's share of the net fair value of the associate's identifiable assets and liabilities is accounted for as goodwill.

If the ownership interest in an associate is reduced but significant influence is retained, only a proportionate share of the amounts previously recognised in other comprehensive income is reclassified to profit or loss where appropriate.

The Group's share of post-acquisition profit or loss is recognised in the income statement, and its share of post-acquisition movements in other comprehensive income is recognised in other comprehensive income with a corresponding adjustment to the carrying amount of the investment. When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associate.

The Group determines at each reporting date whether there is any objective evidence that the investment in the associate is impaired. If this is the case, the Group calculates the amount of impairment as the difference between the recoverable amount of the associate and its carrying value and recognises the amount adjacent to "share of results of an associate" in profit or loss.

Profits and losses resulting from upstream and downstream transactions between the Group and its associate are recognised in the Group's consolidated financial statements only to the extent of unrelated investor's interests in the associates. Unrealised losses are eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

Gain or losses on dilution of equity interest in associates are recognised in profit or loss.

2.4 Joint arrangements

Investments in joint arrangements are classified as either joint operations or joint ventures. The classification depend on the contractual rights and obligations of each investor, rather than the legal structure of the joint arrangement. The Group has assessed the nature of its joint arrangements and determined them to be joint ventures. Joint ventures are accounted for using the equity method.

Under the equity method of accounting, interests in joint ventures are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses and movements in other comprehensive income. The Group's investments in joint ventures include goodwill identified on acquisition. Dividends received or receivable from joint ventures are recognised as a reduction in the carrying amount of the investment. Upon the acquisition of the ownership interest in a joint venture, any difference between the cost of the joint venture and the Group's share of the net fair value of the joint venture's identifiable assets and liabilities is accounted for as goodwill. When the Group's share of losses in a joint venture equals or exceeds its interests in the joint ventures (which includes any long-term interests that, in substance, form part of the Group's net investment in the joint ventures), the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the ioint ventures.

The Group determines at each reporting date whether there is any objective evidence that the investment in the joint venture is impaired. If this is the case, the Group calculates the amount of impairment as the difference between the recoverable amount of the joint venture and its carrying value and recognises the amount adjacent to "share of results of a joint venture" in profit or loss.

Unrealised gains on transactions between the Group and its joint ventures are eliminated to the extent of the Group's interest in the joint ventures. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of the joint ventures have been changed where necessary to ensure consistency with the policies adopted by the Group.

2.5 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decisionmaker ("CODM"), who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors that makes strategic decision.

2.6 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in RMB, which is the Company's functional and the Group's presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss.

The results and financial positions of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet
- income and expenses for each statement of profit
 or loss and statement of comprehensive income are
 translated at average exchange rates (unless this is
 not a reasonable approximation of the cumulative
 effect of the rates prevailing on the transaction dates,
 in which case income and expenses are translated at
 the dates of the transactions), and
- all resulting exchange differences are recognised in other comprehensive income.

2.7 Property, plant and equipment

Property, plant and equipment are stated at historical cost less depreciation and any impairment loss. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within "other gains-net" in profit or loss.

Construction in progress represents the direct costs of construction incurred of property, plant and equipment less any impairment losses. No provision for depreciation is made on construction in progress until such time the relevant assets are completed and ready for use. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

The carrying amount of an asset under construction is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Computer software

Acquired computer software licences are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised over their estimated useful lives (2 to 5 years). Costs associated with maintaining computer software programs are recognised as an expenses as incurred.

2.9 Investment properties

Investment properties, such as right-of-use assets, are held for long-term rental yields or for capital appreciation or both, and that are not self-use by the Group. They also include properties that are being constructed or developed for future use as investment properties. Land held under operating leases are accounted for as investment properties when the rest of the definition of an investment property is met. In such cases, the operating leases concerned are accounted for as if they were finance leases. Investment properties are initially measured at cost, including related transaction costs and where applicable borrowing costs. After initial recognition, investment properties are carried at fair value, representing open market value determined at each reporting date by external valuers. Fair value is based on active market prices, adjusted, if necessary, for any difference in the nature, location or condition of the specific asset. If the information is not available, the Group uses alternative valuation methods such as recent prices on less active markets or discounted cash flow projections. Changes in fair values are presented in profit or loss as part of a valuation gain or loss.

購買的計算機軟件許可證按購買特定 軟件並將其達致可用狀態而產生的成 本予以資本化。該等成本於其估計可 使用年期(2至5年)內攤銷。與維護計 算機軟件有關的成本於產生時確認為 開支。

2.9 投資物業

2.10 Impairment of non-financial assets

Intangible assets that have an indefinite useful life or intangible assets not ready to use are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purpose of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows ("cash-generating unit"). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

2.11 Properties under development

Properties under development are stated at the lower of cost and net realisable value. Net realisable value is determined by reference to the sale proceeds of properties sold in the ordinary course of business, less applicable variable selling expenses and the anticipated costs to completion, or by management estimates based on prevailing marketing conditions.

Development cost of property mainly comprises cost of land use rights, construction costs, borrowing costs capitalised for qualifying assets and professional fees incurred during the development period. On completion, the properties are transferred to completed properties held for sale.

Properties under development are classified as current assets when the construction of the relevant properties commences unless the construction period of the relevant property development project is expected to complete beyond normal operating cycle. The normal operating cycle is usually between 2 and 3 years.

Costs to fulfil a contract comprise the development cost and land use right cost directly related to an existing contract that will be used to satisfy performance obligations in the future. The costs to fulfil a contract are recorded in properties under development if they are expected to be recovered. The amount is amortised on a systematic basis, consistent with the pattern of revenue recognition of the contract to which the asset relates.

2.12 Completed properties held for sale

Completed properties remaining unsold at reporting period end are stated at the lower of cost and net realisable value.

Cost comprises development costs attributable to the unsold properties.

Net realisable value is determined by reference to the sale proceeds of properties sold in the ordinary course of business, less applicable variable selling expenses, or by management estimates based on prevailing marketing conditions.

除非預期有關物業開發項目的建築期 長於一般營運週期,否則開發中物業 於有關物業的建築工程開始時分類為 流動資產。一般營運週期通常為2至3 年。

2.13 Financial assets

2.13.1 Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in debt instruments, this will depend on the business model in which the investment is held. For investments in equity instruments, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in the consolidated income statements.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are two measurement categories into which the Group classifies its debt instruments:

• Amortised cost: assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in the consolidated statements of comprehensive income when the asset is derecognised or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.

Fair value through profit or loss: assets that do not meet the criteria for amortised cost or financial assets at fair value through other comprehensive income are measured at fair value through profit or loss. A gain or loss on a debt investment that is subsequently measured at fair value through profit or loss and is not part of a hedging relationship is recognised in profit or loss and presented net in the consolidated statements of comprehensive income within 'other losses - net' in the period in which it arises. Interest income from these financial assets is included in the 'finance income'.

Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in OCI, there is no subsequent reclassification of fair value gains and losses to the consolidated statements of comprehensive income. Dividends from such investments continue to be recognised in the consolidated income statements as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at fair value through profit or loss are recognised in 'other losses net' in the consolidated income statements as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at financial assets at fair value through other comprehensive income are not reported separately from other changes in fair value.

2.14 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated balance sheets when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Company or the counterparty.

2.15 Impairment of financial assets

The Group assesses on a forward looking basis the expected credit losses associated with its assets carried at amortised cost and debt investment at fair value through other comprehensive income. The impairment methodology applied depends on whether there has been a significant increase in credit risk. Note 3.1.2 details how the Group determines whether there has been a significant increase in credit risk.

Expected credit losses are a probability-weighted estimate of credit losses (i.e. the present value of all cash shortfalls) over the expected life of the financial assets.

For contract assets and all trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the assets. The provision matrix is determined based on historical observed default rates over the expected life of the contract assets and trade receivables with similar credit risk characteristics and is adjusted for forward-looking estimates. At every reporting date the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

Impairment on other receivables are measured as either 12-month expected credit losses or lifetime expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime expected credit losses.

2.16 Land use rights

All land in the PRC is state-owned or collectively-owned and no individual ownership right exists. Land use rights are acquired by the Group for development of properties. Land use rights held for development for sale are inventories and measured at lower of cost and net realisable value, of which those within normal operating cycle are classified as current assets and included in properties under development or completed properties held for sale, while those out of the normal operating cycle are classified as non-current assets. Land use rights to be developed for hotel properties and selfuse buildings, are non-current assets, which are stated at cost and subsequently amortised to the profit or loss on a straightline basis.

2.17 Trade and other receivables

Trade receivables are amounts due from customers for properties sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment.

2.18 Contract assets and liabilities and costs for obtaining contracts

Upon entering into a contract with a customer, the Group obtains rights to receive consideration from the customer and assumes performance obligations to transfer goods or services to the customer. The combination of those rights and performance obligations gives rise to a net asset or a net liability depending on the relationship between the remaining rights and the performance obligations. The contract is an asset and recognised as contract assets if the measure of the remaining conditional rights to consideration exceeds the satisfied performance obligations. Contract assets are transferred to trade receivables when the rights become unconditional. Conversely, the contract is a liability and recognised as contract liabilities if the measure of the remaining performance obligations exceeds the measure of the remaining rights. Contract liabilities are recognised as revenue when the Group performs under the contract.

The Group recognises the incremental costs of obtaining a contact with a customer within contract assets if the Group expects to recover these costs.

2.19 Cash and cash equivalents and restricted cash

For the purpose of presentation in the consolidated statements of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with banks and other short-term, highly liquid investments with original maturities of three months or less. Bank deposits which are restricted to use are included in "restricted cash" of the consolidated balance sheets. Restricted cash is excluded from cash and cash equivalents.

2.20 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares are shown in equity as a deduction, net of tax, from the proceeds.

2.21 Trade and other payables

These amounts represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. The amounts are unsecured. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the balance sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any noncash assets transferred or liabilities assumed, is recognised in profit or loss as other income or finance costs.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, like properties under development, assets under construction and investment properties under construction, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Group's entities operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and considers whether it is probable that a taxation authority will accept an uncertain tax treatment. The group measures its tax balances either based on the most likely amount or the expected value, depending on which method provides a better prediction of the resolution of the uncertainty.

(b) Deferred income tax

Inside basis differences

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences.

In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred income tax is determined using the tax rates(and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Outside basis differences

Deferred income tax liabilities are provided on taxable temporary differences arising from investments in subsidiaries, associates and joint arrangements, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future. Generally the Group is unable to control the reversal of the temporary difference for associates. Only when there is an agreement in place that gives the Group the ability to control the reversal of the temporary difference in the foreseeable future, deferred tax liability in relation to taxable temporary differences arising from the joint venture's or associate's undistributed profits is not recognised.

Deferred income tax assets are recognised on deductible temporary differences arising from investments in subsidiaries, associates and joint ventures only to the extent that it is probable the temporary difference will reverse in the future and there is sufficient taxable profit available against which the temporary difference can be utilised.

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income tax assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

2.24 Employee benefits

(a) Pension obligations

The group companies incorporated in the PRC contribute based on certain percentage of the salaries of the employees to a defined contribution retirement benefit plan organised by relevant government authorities in the PRC on a monthly basis. The government authorities undertake to assume the retirement benefit obligations payable to all existing and future retired employees under these plans and the Group has no further obligation for post-retirement benefits beyond the contributions made.

Contributions to these defined contributions plans are expensed as incurred.

(b) Housing benefits, medical insurances and other social insurances

PRC employees of the Group are entitled to participate in various government-supervised housing funds, medical insurance and other social insurance plan. The Group contributes to these funds based on certain percentages of the salaries of these employees on a monthly basis. The Group's liability in respect of these funds is limited to the contribution payable in each period. Contributions to the housing funds, medical insurances and other social insurances are expensed as incurred.

(c) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or when an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits at the earlier of the following dates: (a) when the Group can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of terminations benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to present value.

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

2.25 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

2.26 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable for the sales of properties in the PRC and services in the ordinary course of the Group's activities. Revenue is shown, net of discounts and after eliminating sales with the Group companies. The Group recognises revenue when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the entity; and when specific criteria have been met for each of the Group's activities, as described below.

(i) Sales of properties and construction services

Revenues are recognised when or as the control of the asset is transferred to the purchaser. Depending on the terms of the contract and the laws that apply to the contract, control of the asset may transfer over time or at a point in time. Control of the asset is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the purchaser; or
- creates and enhances an asset that the purchaser controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the asset transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the purchaser obtains control of the asset.

The progress towards complete satisfaction of the performance obligation is measured based on the Group's efforts or inputs to the satisfaction of the performance obligation, by reference to the contract costs incurred up to the end of reporting period as a percentage of total estimated costs for each contract.

For property development and sales contract for which the control of the property is transferred at a point in time, revenue is recognised when the purchaser obtains the physical possession or the legal title of the completed property and the Group has present right to payment and the collection of the consideration is probable.

In determining the transaction price, the Group adjusts the promised amount of consideration for the effect of a financing component if it is significant.

For construction services, the Group's performance creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced, thus the Group satisfies a performance obligation and recognises revenue over time. Revenue in respect of the construction services is recognised over time on a cost-to-cost method. It is measured by reference to the contract costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract. Costs incurred in the year/period in connection with future activity on a contract are excluded from contract costs in determining the stage of completion. The directors consider that this input method is an appropriate measure of the progress towards complete satisfaction of these performance obligations under HKFRS15. The Group becomes entitled to invoice customers based on achieving a series of performance-related milestones. The Group recognises a contract asset for any work performed, and the amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is invoiced to the customer. If the milestone payment exceeds the revenue recognised to date under the cost-to-cost method then the Group recognises a contract liability for the difference. There is no significant financing component in construction contracts with customers as the period between the recognition of revenue under the cost-to-cost method and the milestone payment is always less than one year.

Financial guarantee contracts are recognised as a financial liability at the time the guarantee is issued. The liability is initially measured at fair value and subsequently at the higher of

- the amount determined in accordance with the expected credit loss model under HKFRS 9 Financial Instruments and
- the amount initially recognised less, where appropriate, the cumulative amount of income recognised in accordance with the principles of HKFRS 15 Revenue from Contracts with Customers.

The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instrument and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

Where guarantees in relation to loans or other payables of joint ventures and associates are provided for no compensation, the fair values are accounted for as contributions and recognised as part of the cost of the investment.

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of real estate for which the Group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets may not be used as security for borrowing purposes.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Group under residual value guarantees

If that rate cannot be readily determined. which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Group, which does not have recent third party financing, and
- makes adjustments specific to the lease, e.g. term, country, currency and security.

If a readily observable amortising loan rate is available to the individual lessee (through recent financing or market data) which has a similar payment profile to the lease, then the group entities use that rate as a starting point to determine the incremental borrowing rate.

The Group is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- · any initial direct costs, and
- restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straightline basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life.

Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Shortterm leases are leases with a lease term of 12 months or less without a purchase optim. Low-value assets comprise IT equipment and small items of office furniture.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term (Note 16). Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. The respective leased assets are included in the balance sheet based on their nature. The Group did not need to make any adjustments to the accounting for assets held as lessor as a result of adopting the new leasing standard.

2.32 Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

The Group's activities expose it to a variety of financial risks: interest rate risk, credit risk, and liquidity risk. The Group's principal activities are conducted in RMB.

The Group's principal activities are conducted in RMB. except that certain cash in banks, other receivables, other payables and borrowings are denominated in Unites State Dollar ("USD") and Hong Kong Dollar ("HKD"). As at 31 December 2023, the carrying amounts of the Group's monetary assets and liabilities denominated in USD amounted to RMB185,138,000 (2022: RMB175,602,000) and RMB2,969,038,000 (2022: RMB2,643,183,000) respectively, and monetary assets and liabilities denominated in HKD amounted to RMB347,082,000 (2022: RMB392,500,000) and RMB272,000 (2022: RMB268,000). If there is a 6% increase/ decrease in RMB against USD, the effect of decrease/increase in the loss for the year is RMB167,034,000 (2022: increase/ decrease in profit of RMB148,054,000), If there is a 6% increase/decrease in RMB against HKD, the effect of increase/ decrease in the loss for the year is RMB20,808,600 (2022: increase/decrease in profit of RMB23,533,000).

The directors are of the opinion that the Group's activities do not expose it to any significant foreign exchange risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

除若干銀行現金、其他應收款項、 其他應付款項及借款以美元(「美 元」)及港元(「港元」)計值外,本集 團的主要業務以人民幣進行。截至 2023年12月31日,本集團以美元 計值的貨幣資產及負債賬面值分別 為人民幣185,138,000元(2022年: 人民幣175.602.000元)及人民幣 2,969,038,000元(2022年:人民 幣2,643,183,000元),以港元計值 的貨幣資產及負債賬面值為人民幣 347,082,000元(2022年:人民幣 392,500,000元)及人民幣272,000元 (2022年:人民幣268,000元)。如果 人民幣兑美元增加/減少6%,則本 年度虧損減少/增加的影響為人民 幣167,034,000元(2022年:利潤增 加/減少人民幣148,054,000元)。如 果人民幣兑港元增加/減少6%,本 年度虧損增加/減少的影響為人民幣 20,808,600元(2022年:利潤增加/ 減少人民幣23,533,000元)。

董事認為本集團的業務活動不會面臨 任何重大外匯風險。本集團的整體風 險管理計劃著眼於金融市場的不可預 測性,並力求將對本集團財務業績的 潛在不利影響降至最低。

3.1.1 Interest rate risk

The Group's interest rate risk arises from long-term borrowings. Borrowings obtained at variable rates expose the Group to cash flow interest rate risk which is partially offset by cash held at variable rates. Borrowings obtained at fixed rates expose the Group to fair value interest rate risk. The Group closely monitors trend of interest rate and its impact on the Group's interest rate risk exposure. The Group currently has not used any interest rate swap arrangements but will consider hedging interest rate risk should the need arise.

As at 31 December 2023, borrowings of the Group which were bearing at floating rates amounted to RMB8,771,254,000 (2022: RMB10,842,559,000). If interest rates on borrowings at floating rates had been 50 basis points higher or lower with all other variables held constant and without taking into account interest capitalisation, interest charges for the year ended 31 December 2023 would have been approximately RMB43,856,270 higher/lower (2022: RMB54,213,000 higher/lower).

3.1.2 Credit risk

The Group has no concentrations on credit risk. Cash transactions are limited to high credit quality institutions. The Group's maximum exposure to credit risk in relation to financial assets is the carrying amounts of cash and cash equivalents (excluding cash on hand), restricted cash, trade and other receivables, amounts due from related parties and financial assets at fair value through profit or loss shown in the consolidated balance sheet.

於2023年12月31日,本集團以 浮動利率計息的借款為人民幣 8,771,254,000元(2022年:人民 幣10,842,559,000元)。倘浮動利 率的借款利率上升或下降50個基 點且所有其他變量保持不變,同時 不考慮利息資本化,則截至2023 年12月31日止年度的利息支出將 增加/減少約人民幣43,856,270 元(2022年:增加/減少人民幣 54,213,000元)。

As at 31 December 2023 and 2022, in order to manage this risk, the Group's bank deposits are mainly deposited with reputable banks which are all high-credit-quality financial institutions incorporated in the PRC.

For the trade receivables arising from sales of properties, the Group manages the credit risk by fully receiving cash or properly arranging the purchasers' mortgage loans financing procedures before delivery of properties unless strong credit records of the customers could be established. The Group closely monitors the collection of progress payments from customers in accordance with payment schedule agreed with customers. The Group has policies in place to ensure that sales are made to purchasers with an appropriate financial strength and appropriate percentage of down payments.

Meanwhile, the Group has the right to cancel the contracts once repayment from the customers is in default; it also has monitoring procedures to ensure that follow-up actions are taken to recover overdue balances. In addition, the Group regularly reviews the recoverable amount of each individual trade receivables to ensure that adequate impairment provisions are made for irrecoverable amounts. The Group has no significant concentrations of credit risk, with exposure spread over a number of counterparties and customers.

The Group has arranged bank financing for certain purchasers of the Group's property units and provided guarantees to secure obligations of such purchasers for repayments. Detailed disclosure of such guarantees is made in Note 34. A purchaser defaults on the payment of its mortgage loan during the guarantee period, the bank holding the guarantee may demand the Group to repay the outstanding principal of the loan and any interest accrued thereon. Under such circumstances, the Group is able to forfeit the customer's deposit and resell the property to recover any amounts paid by the Group to the bank. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

For other receivables and amounts due from related parties, the Group assessed the credit quality of the counter parties by taking into account their financial position, credit history and other factors. Management also regularly reviews the recoverability of these receivables and follow up the disputes or amounts overdue, if any. The directors are of the opinion that the risk of default by counter parties is low.

The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forward-looking information. Especially the following indicators are incorporated:

- internal credit rating
- external credit rating
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations
- actual or expected significant changes in the operating results of individual property owner or the borrower
- significant changes in the expected performance and behaviour of the borrower, including changes in the payment status of borrowers in the Group and changes in the operating results of the borrower.

The Group uses four categories for those receivables which reflect their credit risk and how the loss provision is determined for each of those categories. These internal credit risk ratings are aligned to external credit ratings.

Management of the Group aims to maintain sufficient cash and cash equivalents or have available funding through proceeds from pre-sale of properties and an adequate amount of available financing including short-term and long-term borrowings and obtaining additional funding from shareholders. Due to the dynamic nature of the underlying businesses, the Group maintains flexibility in funding by maintaining adequate amount of cash and cash equivalents and through having available sources of financing.

The Group has a number of alternative plans to mitigate the potential impacts on anticipated cash flows should there be significant adverse changes in economic environment. These include reducing land acquisition, adjusting project development timetable to adapt the changing local real estate market environment, implementing cost control measures, promotion of sales of completed properties, accelerating sales with more flexible pricing and seeking joint venture partners to develop projects. The Group will pursue such options basing on its assessment of relevant future costs and benefits. The directors consider that the Group will be able to maintain sufficient financial resources to meet its operation needs.

The table below sets out the Group's financial liabilities by relevant maturity grouping at each balance sheet date. The amounts disclosed in the table are the contractual undiscounted cash flows.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for the owner and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to the owner, issue new shares or sell assets to reduce debt.

The Group monitors capital on the basis of the gearing ratio. This ratio is calculated as net borrowings divided by total capital. Net borrowings are calculated as total borrowings (including current and non-current borrowings as shown in the consolidated balance sheets) less total of cash and cash equivalents and restricted cash.

This valuation method takes into account the net rental income of a property derived from its existing leases and/or achievable in the existing market with due allowance for the reversionary income potential of the leases, which have been then capitalised to determine the fair value at an appropriate capitalisation rate.

Fair values of the Group's investment properties under development are derived on the basis that they will be developed and completed in accordance with the latest development proposals provided to us by the Group. It is assumed that all consents, approvals and licenses from relevant government authorities for the development proposals have been obtained without onerous conditions or delays. In arriving at the fair values, the direct comparison approach is adopted by making reference to comparable sales transactions as available in the market and also taken into account the costs that will be expended to complete the developments to reflect the quality of the completed developments. The "market value as if completed" represents the opinion of the aggregate selling prices of the property assuming that it would be completed as at the valuation date.

All resulting fair value estimates for investment properties are included in level 3.

The Group's investment properties were valued by an independent professionally qualified valuer, who holds a recognised relevant professional qualification and has recent experience in the locations and segments of the investment properties valued. For all investment properties, their current use equates to the highest and best use.

The Group's finance department has a team to review the valuations performed by the independent valuer for financial reporting purposes. This team reports directly to the executive directors. Discussion of valuation processes and results are held amongst the executive directors, the valuation team and the valuer at least once every six months for the Group's interim and annual reporting process.

At each reporting period end, the finance department:

- Verifies all major inputs to the independent valuation report;
- Assess property valuations movements when compared to the prior period valuation report; and
- Holds discussions with the independent valuer.

Estimates and judgements used in preparing the consolidated financial statements are evaluated and based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that may have a significant effect on the carrying amounts of assets and liabilities within the next financial year are discussed below.

(a) Provisions for properties under development and completed properties held for sale

The Group assesses the carrying amounts of properties under development and completed properties held for sale according to their net realisable values based on the reliability of these properties. As a result, provisions for properties under development and completed properties held for sale involve critical accounting estimates on the future selling prices and variable selling expenses for the properties, as well as the costs to completion for properties under development.

(b) Fair value of investment properties

Investment properties including those completed investment properties and investment properties under construction, are carried at their fair value. The fair value of the investment properties was determined by reference to valuations conducted on these properties by an independent professional property valuer using property valuation techniques which involve certain assumptions of prevailing market conditions.

(c) Income taxes and deferred taxation

The Group is subject to income taxes in the PRC. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such difference will impact the income tax and deferred tax provision in the year in which such determination is made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised when management considers to be probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. The outcome of their actual utilisation may be different.

(d) PRC land appreciation taxes

The Group is subject to land appreciation taxes in the PRC. The Group has not finalised its PRC land appreciation taxes calculations and payments with local tax authorities in the PRC. Accordingly, significant judgement is required in determining the amount of the land appreciation and the related land appreciation taxes. The Group recognised the land appreciation taxes based on management's best estimates according to the interpretation of the tax rules. The final tax outcome could be different from the amounts that were initially recorded, and these differences will impact the taxation and tax provisions in the years in which such taxes have been finalised with local tax authorities.

(e) Classification of subsidiaries, joint ventures and associates

The classification of an investment as a subsidiary, a joint venture or an associate is based on whether the Group is determined to have control, joint control or significant influence over the investee, which involves judgements through the analysis of various factors, including the Group's representation on the chief decision making authorities of an investee, such as board of directors' meetings and shareholders' meetings, as well as other facts and circumstances.

Subsidiaries are consolidated, which means each of their assets, liabilities and transactions are included line-by-line in the Group's consolidated financial statements, whereas the interests in joint ventures and associates are equity accounted for as investments on the consolidated balance sheet.

Accordingly, any inappropriate classification as a result of recognition or derecognition of the investments could have a material and pervasive impact on the consolidated financial statements.

5. SEGMENT INFORMATION

The Executive Directors have been identified as the CODM. Management has determined the operating segments based on the reports reviewed by the Executive Directors, which are used to allocate resources and assess performance. The Group is organised into three business segments: property development and construction, property investment, and other businesses. Other businesses mainly include hotel operations. As the CODM of the Group considers most of the revenue and results of the Group are attributable to the market in the PRC, and only an immaterial part (less than 10%) of the Group's assets are located outside the PRC, no geographical segment information is presented.

The directors of the Company assess the performance of the operating segments based on a measure of segment results, which is a measure of revenue and gross profit of each operating segment.

PRC corporate income tax

The income tax provision of the Group in respect of operations in PRC has been calculated at the applicable tax rate on the estimated assessable profits for the year, based on the existing legislation, interpretations and practices in respect thereof.

The corporate income tax rate applicable to the group entities located in mainland China is 25% according to the Corporate Income Tax Law of the People's Republic of China (the "CIT Law") effective on 1 January 2008.

PRC land appreciation tax ("LAT")

Pursuant to the requirements of the Provisional Regulations of the PRC on LAT effective 1 January 1994, and the Detailed Implementation Rules on the Provisional Regulations of the PRC on LAT effective on 27 January 1995, all income from the sale or transfer of state-owned land use rights, buildings and their attached facilities in the PRC is subject to LAT at progressive rates ranging from 30% to 60% of the appreciation value, with an exemption provided for sales of ordinary residential properties if their appreciation values do not exceed 20% of the sum of the total deductible items.

The Group has made provision of LAT for sales of properties according to the aforementioned progressive rate.

Overseas income tax

The Company was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands and, is exempted from Cayman Islands income tax. The Company's direct subsidiary in the BVI was incorporated under the BVI Business Companies Act of the British Virgin Islands and is exempted from British Virgin Islands income tax. The Group's subsidiaries in Hong Kong are subject to profits tax at the rate of 16.5%.

The Group has not accrued any withholding income tax for these undistributed earnings of its PRC subsidiaries as the Group does not have a plan to distribute these earnings out of the PRC.

The above notes were consolidated and formed into a single class on 13 January 2021.

On 9 December 2022, sufficient votes were obtained by the Company to further proceed with the restructuring support agreement by a vote of creditors of the senior notes. On 15 December 2023, the Company announced that the restructuring support agreement was not proceed as scheduled.

As at 31 December 2023, the Company has not repaid the last tranche of interest and principal of the above mentioned senior notes. The unpaid principal amount and accrued interest are US\$350,000,000 and US\$17,413,000, respectively.

In additions, as at 31 December 2023, certain bank borrowings and other borrowings of the Group with the principal balance of RMB2,219,550,000 became cross-default and repayable on demand under the circumstances that the unpaid senior notes as described above.
