Whether a Shareholder is a Hong Kong or an overseas Shareholder will be determined by the address of that Shareholder appearing on the Register of Members of the Company maintained by the Company’s branch share registrar in Hong Kong.

If you choose electronic means, we will send you e-mail notification of the release of the relevant Corporate Communication(s) on the Company’s website on the day such Corporate Communication(s) is/are sent to Shareholders. In case where the electronic means is chosen, but e-mail address has not been provided, printed Corporate Communications will be sent out in accordance with the arrangements described in the previous paragraph.
