## 公司介紹

# COMPANY INTRODUCTION

### 概覽

我們是中國最大的水果零售經銷商，連續十年（二零一四年—二零二三年）全國水果連鎖門店銷售額第一，已經建成一個全國性的貼近社區，店倉一體的及線上線下一體化的水果專營零售網絡。二零二三年為明確本集團長期發展目標，推動本集團持續增長，我們優化組織架構為三大事業群，分別為：零售事業群、2B事業群及品類事業群。

二零二三年，我們主要聚焦在零售事業群的發展，重點是擴張門店規模並提升存量門店的運營效率。在擴張門店規模方面，我們不僅在高線城市加密門店，加強用戶心智發揮規模效應；與此同時，我們也抓住下沉市場機會，圍繞現有的29個倉配中心積極拓展新城市。二零二三年我們淨增了443家門店，總門店數達到6,093家，覆蓋了22個省和直轄市的170多個城市。基於水果零售的特性以及滿足消費者便利性的需求，我們以線下門店網絡為基礎，採用多元化的線上渠道，包括自營APP、微信小程序、以及抖音、美團、餓了麼等第三方平台，以便擴大門店的銷售半徑，提高門店的運營效率。二零二三年我們的線上訂單佔比約為27.6%。

我們的2B事業群在二零二三年保持良好增長態勢，較上年同比增加約42.5%。我們的2B事業群主要是利用現有的供應鏈資源優勢，做大做強單品，擴大海內外銷售渠道及客戶基礎。同時，我們在本年實現了對深圳般果的控制，通過與深圳般果的協同發展，我們能進一步提升供應鏈優勢並擴大市場份額。

### OVERVIEW

We are the largest fruit retail operator in China as we have been ranking No. 1 in terms of sales of fruit chain stores in China for ten consecutive years (2014-2023), and we have built a nationwide community-based fruit specialty retail network with store-as-warehouse and OMO features. In 2023, to navigate the Group's long-term development goals and drive its sustainable growth, we optimized our organizational structure into three major business units, namely, retail business unit (零售事業群), business-to-business or 2B business unit (2B 事業群) and category business unit (品類事業群).

In 2023, we focused on the development of the retail business unit, with an emphasis on expanding the scale of our retail stores and improving the operational efficiency of our existing stores. In terms of expanding the scale of our retail stores, we not only increased the quantity of our stores in first- and second-tier cities to increase brand recognition for greater branding impact, but also seized the opportunity of the lower-tier cities market, actively expanding into new cities around the existing 29 warehouses and distribution centers. In 2023, we had a net increase of 443 new stores, and the total number of our stores reached 6,093, covering more than 170 cities in 22 provinces and municipalities. Based on the characteristics of fruit retail and satisfying the consumers' demand of convenience, we have adopted diversified online channels, including self-operated APP, WeChat Mini-program (微信小程序), as well as Douyin (抖音), Meituan (美團), Ele.me (餓了麼) and other third party platforms, based on our offline store network, to expand the sales radius and improve the operational efficiency of our stores. In 2023, our orders placed through online channels accounted for approximately 27.6%.

Our 2B business unit maintained a positive upward trend in 2023, representing a year-on-year increase of approximately 42.5%. Our 2B business unit mainly capitalizes on our existing supply chain resources to expand and strengthen our products, and to expand domestic and overseas sales channels as well as customer base. Meanwhile, we gained control over Shenzhen Banguo this year. Through the synergistic development with Shenzhen Banguo, we are able to further enhance the advantages of our supply chain and expand our market share.

為打造品類品牌及提升產品的競爭力，支持零售事業群及2B事業群的發展，我們通過為上游供應商提供獨家品種、農業技術服務、全週期農事管理、採後保鮮技術及資金等，支持供應商降低產品成本提升產品品質。截至二零二三年年底，我們已經成功向市場推出37個品類品牌，該等品類品牌的銷量佔我們門店總銷量的約14%。

In order to build branding awareness and enhance the competitiveness of our products, also to support the development of the retail business unit and the 2B business unit, we support our upstream suppliers in lowering product costs and improving product quality by providing them with exclusive varieties, agricultural technology services, full-cycle agricultural management, post-harvest preservation technology and capital resources. As of the end of 2023, we have successfully introduced 37 brands to the market, and the sales volume of such brands accounted for approximately 14% of the total retail sales of our retail stores.

## CHAIRMAN'S STATEMENT

致各位股東：

本人謹代表深圳百果園實業(集團)股份有限公司及其附屬公司董事會向各位股東提呈本集團截至二零二三年十二月三十一日止年度報告。

### 業績

截至二零二三年十二月三十一日止年度，本集團實現收入為人民幣11,390.6百萬元，較二零二二年同期增加約0.7%，毛利為人民幣1,314.8百萬元，較二零二二年同期增加約0.04%，本公司擁有人應佔年內利潤為人民幣361.7百萬元，較二零二二年同期增加約11.9%。董事會建議派發末期股息每股人民幣0.043元(含稅)。

### 二零二三年業務回顧

二零二三年是全球經濟復蘇的一年，經歷疫情影響後，行業洗牌調整不斷，新的挑戰和機遇湧現。就水果行業而言亦孕育着三大機遇：水果產業規模過萬億且仍持續增長，市場滲透潛力巨大；消費多元化持續，高品質消費需求持續增長；大牌高勢佔優，產品質量和穩定性成為消費者關注重點。在此背景下，一方面我們直面市場形勢與時俱進，調整戰略方向，將「好吃」戰略升級為「高品質水果專家與領導者」戰略，以進一步提升我們的品牌影響力，凸顯我們在行業中的優勢和地位。另一方面我們優化調整組織架構，將業務板塊劃分為零售事業群、2B事業群及品類事業群三大事業群。這一舉措使得我們更加清晰本集團短期、中期及長期的發展策略，確保在不同發展階段能夠集中資源和精力，更有效地推動本公司的持續成長。

Dear Shareholders:

On behalf of the Board of Directors of Shenzhen Pagoda Industrial (Group) Corporation Limited and its subsidiaries, I am pleased to present the Group's annual report for the year ended December 31, 2023.

### PERFORMANCE

For the year ended December 31, 2023, the Group achieved revenue of RMB11,390.6 million, representing an increase of approximately 0.7% as compared to the year of 2022; gross profit of RMB1,314.8 million, representing an increase of approximately 0.04% as compared to the year of 2022; and profit attributable to owners of the Company for the year of RMB361.7 million, representing an increase of approximately 11.9% as compared to the year of 2022. The Board has recommended the payment of a final dividend of RMB0.043 per share (tax inclusive).

### LOOKING BACK TO 2023

2023 was a year of global economic recovery. As a result of the pandemic, the continuous reshuffle and adjustment of the industry have created new challenges coming together with opportunities. The fruit industry is breeding three opportunities: the industry has recorded a total sales amount of more than RMB1 trillion and continued to grow with tremendous potential for market penetration; consumption diversification continues and consumer's demand of high-quality consumption keeps growing; and major brands take the advantage, and product quality and stability have become the key focuses of consumers. In this context, we have kept abreast of the market dynamics by adjusting our strategic direction and upgrading the "delicious" strategy to the "high-quality fruit expert and leader" strategy to further enhance the impact of our brand and showcase our strengths and leading position in the industry. On the other side, we have optimized our organizational structure and divided our business segments into three business groups, including the retail business unit, the 2B business unit and the category business unit. This move will further clarify the short-, medium- and long-term development strategies of the Group and ensure we stand in a fair position to focus resources and energy at different development stages and propel our continuous growth more effectively.

# CHAIRMAN'S STATEMENT

零售事業群是二零二三年的發展重心，這一年我們持續不斷拓展門店規模，淨增加443家門店，總門店數達到6,093家，位於全國22個省／直轄市的170多個城市。我們進一步豐富銷售渠道和消費場景，採用多元化的線上渠道，包括自營APP、微信小程序，以及抖音、美團、餓了麼等第三方平台；同時與多品牌聯名營銷，打造節日禮盒。我們的付費會員超過1.17百萬，較上一年增長約21%，普通會員總數超過8,000萬。

2B事業群是我們的第二增長曲線，收入同比增速達到42.5%。二零二三年十一月我們控股深圳般果，旨在通過深圳般果B2B一站式採購服務平台，拓寬覆蓋渠道，提升整體行業影響力。與此同時，我們持續深化、拓展2B客戶群，秉承「買全球、賣全球」理念，將各產區優質水果在全球範圍內流通貿易，發揮我們高質水果供應鏈的優勢。

品類事業群為打造高品質及獨特性產品提供支持，是零售事業群和2B事業群發展的基礎。我們通過農業技術服務、獨家品種授權、品牌營銷支持、品控保鮮技術及少數股權投資等賦能手段，與我們的優質供應商進行深度合作，旨在提高產品規模和質量。現在已經打造37個品類品牌，其中招牌產品約佔門店零售總額的14%。

In 2023, we focused our development on the retail business unit by continuously expanding our store network, increasing the total number of store by 443 to 6,093 covering more than 170 cities in 22 provinces and municipalities nationwide. We have further diversified our sales channels and consumption scenarios and introduced diversified online channels, including self-operated APP, WeChat mini program, Douyin, Meituan, Ele.me and other third party platforms. Meanwhile, we have initiated the joint marketing with multiple brands and developed festive gift boxes. We have seen an increase in the paying members by approximately 21% as compared to previous year to over 1.17 million and a total of more than 80 million ordinary members.

The 2B business unit, our second growth curve, has achieved a year-on-year revenue growth rate of up to 42.5%. In November 2023, we gained control over Shenzhen Banguo to expand the channel network and upgrade our overall industry influence based on its B2B integrated procurement service platform. In addition, we have developed the 2B customer group to greater depth and to greater width, and marketed high-quality fruits from various production areas to every corner of the world under the “buying globally, selling globally” concept to exert our strength of the high-quality fruit supply chain.

The category business unit sustains high-quality and unique products, which are the cornerstone of the retail business unit and the 2B business unit. To improve the quantity and quality our products offerings, we have collaborated in depth with our quality suppliers by empowering them with agricultural technical service, exclusive variety licensing, brand marketing support, quality control & preservation technology, minority equity investment, etc. Now, we have 37 product brands, of which the Excellent products contribute approximately 14% of the total retail volume of our stores.

## 未來展望

Finally, on behalf of the Group, I would like to express sincere gratitude to all business partners, investors and shareholders for their constant support and trust, and to all the staff of Pagoda, franchisees and store employees, being Pagoda’s family members, for their hard work in the past year. We will continue to adhere to our operating guideline of “clear strategy, long-term commitment, innovation and enterprising, sustainable profit, financial health, integrity and reliability”, meet various challenges with all of our strength, pursue the longer-term and better development to bring more values to our Shareholders and the society.

# PERFORMANCE REVIEW

### 市場概覽

二零二三年，國民經濟回升向好，並錄得5.2%的GDP增長。此外，於二零二三年，中國社會消費品零售總額達人民幣471,495億元，同比增長約7.2%。

二零二三年，中國消費者對水果質量及品種的需求不斷增加。根據農業農村部的資料，二零二三年中國水果進口總額達18,340百萬美元，較二零二二年同比增長約16.3%。二零二三年海外進口水果中，鮮榴蓮全年增長顯著，進口總額6,720百萬美元，較二零二二年同比增長約66.0%。本集團對品質、產品創新及客戶體驗的堅定承諾與消費者對精細化服務以及獨特及季節性水果產品日益增長的需求產生共鳴。

### 公司表現概覽

本集團收入由截至二零二二年十二月三十一日止年度的人民幣11,312.0百萬元增長約0.7%至截至二零二三年十二月三十一日止年度的人民幣11,390.6百萬元。本集團毛利由截至二零二二年十二月三十一日止年度的人民幣1,314.3百萬元略微增加約0.04%至截至二零二三年十二月三十一日止年度的人民幣1,314.8百萬元。本公司所有者應佔本集團利潤由截至二零二二年十二月三十一日止年度的人民幣323.3百萬元增長約11.9%至截至二零二三年十二月三十一日止年度的人民幣361.7百萬元。

### MARKET OVERVIEW

In 2023, the economy in China continued to rebound and improve, and recorded a GDP growth of 5.2%. In addition, in 2023, the total retail sales of consumer goods in China amounted to RMB471,495 billion, representing a year-on-year growth of approximately 7.2%.

In China, consumers' demand for fruit quality and variety continued to increase in 2023. According to the Ministry of Agriculture and Rural Development, China's total fruit imports reached US\$18,340 million in 2023, representing a year-on-year increase of approximately 16.3% as compared to the year of 2022. Among fruit imported from overseas in 2023, fresh durian witnessed a notable growth during the year, with total amount of imports valued at US\$6,720 million, indicating a year-on-year growth of approximately 66.0% as compared to the year of 2022. The Group's strong commitment to quality, product innovation, and customer experience well resonates with the growing appetite of consumers for refined services, and unique and seasonal fruit offerings.

### COMPANY PERFORMANCE REVIEW

The Group's revenue increased by approximately 0.7% from RMB11,312.0 million for the year ended December 31, 2022 to RMB11,390.6 million for the year ended December 31, 2023. The Group's gross profit slightly increased by approximately 0.04% from RMB1,314.3 million for the year ended December 31, 2022 to RMB1,314.8 million for the year ended December 31, 2023. The Group's profit attributable to owners of the Company increased by approximately 11.9% from RMB323.3 million for the year ended December 31, 2022 to RMB361.7 million for the year ended December 31, 2023.

二零二三年，本集團戰略性地優化了業務運營的組織結構，將其組織部門重組為三大事業群，即零售事業群、2B事業群，以及品類事業群，以更好地配合本集團的長期增長目標。此次重組使本集團能夠更加專注於核心業務，提高業務效率，並挖掘新的收入來源，如進一步收購深圳般果，其為一家為2B企業提供採購平台服務的平台企業。

二零二三年對本集團各層面而言都是不平凡的一年。本公司於二零二三年一月完成全球發售及上市，其H股股份成功於二零二三年一月十六日在聯交所主板上市，實現公司歷史上的一個重要里程碑。這不僅表明本集團作為中國領先的水果零售經營商的地位，也開啟了本集團實現其使命的新篇章，即百果園將讓越來越多的人享受美味實惠的水果，向彼等傳播水果知識及文化，為彼等帶來健康及幸福。

In 2023, the Group strategically optimized its organizational structure of business operations by restructuring its organizational divisions into three business units, namely, retail business unit (零售事業群), 2B business unit (2B事業群), and category business unit (品類事業群), to better align with the Group's long-term growth goal. This restructuring allows the Group to sharpen focus on core business, enhance business efficiency and explore new revenue streams such as further acquisition of Shenzhen Banguo, a platform enterprise that provides procurement platform services to 2B business enterprises.

2023 has been a remarkable year for the Group on all levels. The Company completed the Global Offering and the Listing in January 2023 and its H shares were successfully listed on the Main Board of the Stock Exchange on January 16, 2023, representing a significant milestone in its corporate history. This not only demonstrates the position of the Group as a leading fruit retail operator in China, but also starts a new chapter for it to realize its mission that Pagoda would let more and more people enjoy delicious and affordable fruits, spread fruit knowledge and culture to them, and bring them health and happiness.

## 公司業務摘要

零售事業群 – 持續開發本集團的零售業務

### 線下門店網絡開發

於二零二三年，本集團通過增加高線城市的門店密度及進一步擴大其在低線城市的覆蓋範圍，繼續在全國範圍內擴大其零售店網絡。截至二零二三年十二月三十一日，本集團錄得零售門店較二零二二年十二月三十一日淨增加443家。截至二零二三年十二月三十一日，本集團線下門店網絡共有6,093家門店，位於中國22個省及直轄市的170多座城市。

下表載列本集團截至所示日期的加盟門店及自營門店總數。

RETAIL BUSINESS UNIT – CONTINUED DEVELOPMENT OF THE GROUP'S RETAIL BUSINESS

### OFFLINE STORE NETWORK DEVELOPMENT

In 2023, the Group continued to expand its retail store network nationwide by increasing the store density in higher tier cities and further broadening its reach in lower-tier cities. As of December 31, 2023, the Group recorded a net increase of 443 retail stores as compared to December 31, 2022. And as of December 31, 2023, the Group's offline store network had a total of 6,093 stores located in over 170 cities covering 22 provinces and municipalities in China.

The table below sets forth the Group's total number of franchised stores and self-operated stores as of the dates indicated.

截至二零二三年十二月三十一日，本集團零售門店總數較二零二二年十二月三十一日增加約7.8%，主要是由於本集團持續拓展及開發零售門店網絡的策略，及老加盟商及門店僱員對水果零售行業、本集團品牌及本集團加盟門店經營業務模式充滿信心持續多開店。

As of December 31, 2023, the total number of the Group's retail stores increased by approximately 7.8% as compared to December 31, 2022, mainly due to the Group's continuous endeavours to implement its strategy to continue to expand and develop its retail store network, as well as the continuous opening of additional retail stores by existing franchisees and store employees who are confident in the fruit retail industry, the Group's brand and the Group's franchised store operational business model.

加盟門店現時構成本集團大部分線下門店網絡。本集團的加盟門店根據本集團的標準化管理機制運營。本集團為加盟商提供穩健的品牌、供應鏈及運營支援，包括持續對加盟商進行門店管理及運營方面的全面培訓，以及由指定區域督導經理進行及時帶教指導。同時，本集團為加盟門店提供全鏈路的信息技術系統，包括為門店匹配個性化產品組合及定價的智能訂貨系統、全域會員營銷系統等，旨在提升加盟商的運營能力。二零二三年，為了最大限度地提高本集團特許經營模式的效率，進一步提升加盟商的滿意度，本集團成立了加盟商委員會，並組織了六次加盟商委員會交流學習活動。本集團一方面努力打造優秀的加盟模式，激勵擁有一家以上加盟店及／或加盟概率有所提升的加盟商的信心；另一方面，本集團組織了專門的導師團隊，為業績不佳的零售店提供指導及幫助。作為本集團最新採取的措施，自二零二三年末，本集團也正在與加盟商一起對門店的招牌、價格標識及店內宣傳材料進行更新，以進一步提升本集團品牌的影響力。

Franchised stores currently consist of the majority of the Group's offline store network. The Group's franchised stores are operated under the Group's standardized management mechanism. The Group provides its franchisees with strong brand, supply chain and operational support, including ongoing comprehensive franchisee training for store management and operation, as well as in-time guidance by designated regional supervisory managers. In addition, the Group provides franchised stores with chain-wide information technology systems, including a smart ordering system that matches stores with personalized product mix and pricing, and a territory-wide membership marketing system that is designed to improve franchisee's operational capabilities. In 2023, in order to maximize the efficiency of the Group's franchise business model and further enhance the franchisees' satisfaction, the Group set up a franchisee committee (加盟商委員會) and organized six franchisee committee exchange and learning activities. The Group, on one hand, strived to build up an excellent franchise model to incentivise franchisees with more than one franchised store and/or with improved probability; on the other hand, the Group organized a dedicated mentor team to provide guidance and assistance to retail stores with poor performance. As a more recent initiative of the Group, since late 2023, the Group has also been working with the franchisees to update the signboards, price labels and in-store promotional materials to further strengthen the influence of the Group's brand.

### 線上線下一體化（「OMO」）模式

為追求讓「百果園」成為消費者購買水果的首選品牌，於二零二三年，本集團繼續擴大其線上及線下渠道，以提高市場覆蓋範圍及客戶忠誠度。本集團認為，鑒於其固有的不可預測性和高頻的購買模式，貼近社區的，店倉一體化的及線上線下一體化的門店模式是水果消費的最佳選擇。本集團廣泛的線下零售網絡可快速觸達客戶並高效收集用戶反饋。本集團多元化的線上渠道，包括自營APP、微信小程序，以及抖音、美團、餓了麼等第三方外賣平台，為門店取件或送貨上門提供了便捷的選擇，進一步提升了用戶滲透率。此外，本集團的社區微信群聊有助於更好地與客戶互動，留住忠實用戶並促進交叉銷售，從而提高其交易頻率。

截至二零二三年十二月三十一日，本集團在所有經銷渠道的會員數累計超過83百萬名，付費會員數超過1,170千名，及使用微信小程序的用戶累計達68百萬人次，較二零二二年增長約26%。

二零二三年，本集團通過多個線上渠道下達的訂單比例仍然佔本集團訂單總量的約27.6%。此外，本集團繼續指導店長建立門店微信群，推動有趣互動的產品推廣及會員活動，並即時與微信社群粉絲進行互動和溝通。截至二零二三年十二月三十一日，本集團店長建立的門店微信群總數增至約27,455個，微信粉絲群粉絲總數超過16.2百萬名，較二零二二年同比增長約25.6%。

### ONLINE-MERGE-OFFLINE (“OMO”) MODEL

In pursuit to make “Pagoda” a go-to-brand for consumers purchasing fruits, in 2023, the Group continued to expand its online and offline channels to boost market reach and customer loyalty. The Group believes that a community-based store model with OMO and store-as-warehouse features is the best suit for fruit consumption given its inherent unpredictability and high-frequency purchase patterns. The Group’s extensive offline retail network allows for rapid customer outreach and efficient collection of user feedback. The Group’s diverse online channels, including self-operated APP, WeChat mini-program (微信小程序), and third party food delivery platforms such as Douyin (抖音), Meituan (美團), and Ele.me (餓了麼), offer convenient options for in-store pickup or home delivery, further driving user penetration. In addition, the Group’s community WeChat group chats help better interact with its customers, retain the loyal users and promote cross selling, thereby boosting their transaction frequency.

As of December 31, 2023, the Group had accumulated over 83 million members across all distribution channels with over 1,170 thousand paying members, and the cumulative number of users of the WeChat mini-program reached 68 million, representing an increase of approximately 26% as compared to the year of 2022.

In 2023, the proportion of the Group’s orders placed through various online channels remained approximately 27.6% out of the total orders of the Group. Furthermore, the Group continued to provide guidance to its store managers to establish store-based WeChat groups, pushing interesting and interactive product promotions and membership activities, and interacting and communicating with WeChat community followers in real time. As of December 31, 2023, the total number of store-based WeChat groups established by the Group’s store managers increased to approximately 27,455 with an aggregate of over 16.2 million WeChat community followers, representing a year-on-year increase of approximately 25.6% as compared to the year of 2022.

同時，為滿足消費者多場景多渠道消費的訴求，本集團也正在積極探索內容電商板塊，在抖音、小紅書、天貓、京東等多個平台開展線上業務並進行品牌宣傳。本集團通過二零二三年十月舉辦的好吃水果節，本集團於網絡上發佈的內容吸引超過1.2億播放，登微博全國熱搜。此外，二零二三年，透過抖音渠道下單購買本集團水果及水果產品的客戶總數較二零二二年增加190%，本集團水果及水果產品透過抖音渠道的零售銷售總額位列抖音水果及水果產品交易第一名。

## 2B 事業群 – 進一步拓展本集團的 2B 業務

二零二三年十一月，本集團完成了對深圳般果的進一步股權收購，因此，本集團間接合計持有深圳般果51%的股權，實現對深圳般果的控制。深圳般果是一家以總倉為集配中心，通過城市倉為小型商業企業如區域小零售店和夫妻老婆店提供採購平台。深圳般果為一家面向小型商業企業的供應鏈解決方案提供商，其致力於解決生鮮零售行業的難題和挑戰如小終端客戶採購難、採購成本高以及上游供應商流通成本高、時效性低及客戶分散等。二零二三年，深圳般果的商品交易總額達到人民幣3,068百萬元。本集團相信，滿足中國小型企業對綜合採購平台的需求具有巨大潛力，從而增強流動資金，並促進更精簡及更具成本效益的水果供應鏈。本集團預期與深圳般果產生更多協同效應，進一步提升其供應鏈效率及擴大其於2B領域的市場份額。

Meanwhile, in order to meet consumers' demand for multi-scene and multi-channel consumption, the Group is also actively exploring the content e-commerce segment by launching its online business and brand promotion on multiple platforms such as Douyin, RED, Tmall and JD.com. Through the Tasty Fruit Festival (好吃水果節) held in October 2023, contents released by the Group on the internet attracted over 120 million displays, and has been featured on the list of national trending topics on Weibo. In addition, in 2023, the total number of customers who placed orders to purchase the Group's fruits and fruit products through the Douyin increased by 190% as compared to the year of 2022, and the total retail sales amount of the Group's fruits and fruit products through Douyin ranked first among all fruits and fruit products traded through Douyin.

## 2B BUSINESS UNIT – FURTHER EXPANSION OF THE GROUP'S 2B BUSINESS

In November 2023, the Group completed a further equity acquisition of Shenzhen Banguo, as a result of which, the Group indirectly held a total of 51% equity interest in Shenzhen Banguo and realizing the control over Shenzhen Banguo. Shenzhen Banguo is a platform enterprise that provides procurement platform to small business enterprises such as regional fruit stores and mom-and-pop stores through city warehouses with the main warehouse as the distribution center. Shenzhen Banguo is a supply chain solutions provider for small business enterprises, and it focuses on solving difficulties and challenges in the fresh retail industry, such as difficulty in procurement and high procurement cost for small end-customers, and high circulation cost, low timeliness and client fragmentation for the upstream suppliers. In 2023, the gross merchandise value (GMV) of Shenzhen Banguo amounted to RMB3,068 million. The Group believes in the substantial potential in catering to the needs of small business enterprises in China for an integrated procurement platform, which enhances liquidity and fosters a more streamlined and cost-effective fruit supply chain. The Group expects to generate more synergies with Shenzhen Banguo, further enhancing its supply chain effectiveness and expanding its market share in the 2B sector.

本集團的2B事業群專注於特色品類，繼續利用本集團強大的供應鏈，擴大國內及海外市場的客戶基礎及市場覆蓋範圍。本集團來自直銷水果及其他食品的銷售收入由截至二零二二年十二月三十一日止年度的人民幣723.8百萬元增加約42.5%至截至二零二三年十二月三十一日止年度的人民幣1,031.5百萬元，其中海外市場直銷水果銷售同比增加約62.0%。

### 品類事業群 – 持續開發及多元化品牌組合及產品組合

除本集團的渠道品牌外，本集團的品類品牌體現了本集團發展成為全球領先的果業生態科技型公司的長期願景。該等品牌不僅旨在賦能本集團的零售及2B業務，亦為其未來在所有渠道的擴張鋪平道路。本集團品類事業群致力於通過為關鍵供應商提供資金、農業技術和管理專長來發展本集團品類品牌。

本集團已就水果產品建立全面及有系統的以口感為導向的四級水果品質分類制度，將水果分為四大類別（即招牌、A級、B級及C級）進行評級及標籤，以不同價格迎合不同消費者。其中，招牌及A級類別產品深受消費者歡迎，且其零售價一般高於同類B級水果。截至二零二三年十二月三十一日止年度，招牌及A級水果銷售總額約佔百果園門店的門店零售銷售總額的66.5%。

With a focus on distinctive category, the Group's 2B business unit continued to leverage the Group's robust supply chain to broaden the customer base and enhance the market reach in both domestic and overseas markets. The Group's revenue from direct sales of fruits and other food products increased by approximately 42.5% from RMB723.8 million for the year ended December 31, 2022 to RMB1,031.5 million for the year ended December 31, 2023, of which the direct sales of fruits in overseas market increased by approximately 62.0% as compared to the year of 2022.

### CATEGORY BUSINESS UNIT – CONTINUED DEVELOPMENT AND DIVERSIFICATION OF BRAND PORTFOLIO AND PRODUCT OFFERINGS

Apart from the Group's channel brands, the Group's category brands embody the Group's long-term vision to evolve into a world-leading fruit eco-technology company. These brands are designed not only to empower the Group's retail and 2B business, but also to pave the way for its future expansion across all channels. The Group's category business unit is dedicated to develop the Group's category brands by providing key suppliers with capital, agricultural technology, and management expertise.

The Group has established a comprehensive and systematic written flavor-oriented 4-grade fruit quality classification system for fruit products where fruits are rated and labeled under four categories, namely Excellent (招牌), Grade A, B and C, with different prices catering to different consumers. Amongst, products under the Excellent and Grade A categories were well accepted by consumers and whose retail prices were generally higher than those of Grade B fruits of the same type. Aggregate sales of fruits under Excellent and Grade A categories accounted for approximately 66.5% of the total store retail sales of Pagoda stores for the year ended December 31, 2023.

於二零二三年，本集團繼續開發自有品牌作為招牌果，向市場推出共六個招牌果新產品品牌。因此，截至二零二三年十二月三十一日，本集團已成功向市場推出共計37個招牌果自有產品品牌，且全部自有品牌水果的零售銷售總額佔二零二三年百果園門店的門店零售銷售總額約14.0%。

此外，本集團於二零二三年一直在積極多元化水果組成及向市場推出新產品，例如紅果參、水果玉米、紫玉胡蘿蔔、茄食百香果、黃金維納斯蘋果，其中，與二零二二年相比，二零二三年水果玉米的銷售總額增長了約3,076%，黃金維納斯蘋果的銷售總額增長了約515%。通過指派專門的總經理監督各產品類別（如品類管理人），本集團能夠確保為每個品牌提供實現卓越市場表現及促進創新所需的針對性重點及資源。截至二零二三年十二月三十一日，本集團擁有八個品牌的八位品類管理人，包括紅果參及紫玉胡蘿蔔。

## 其他業務更新

### 智能倉儲及供應鏈管理

截至二零二三年十二月三十一日，本集團在中國各地有29個倉庫，該等倉庫亦為當地的初步加工配送中心，位於29個城市，總建築面積超過20.7萬平方米。在29個初步加工配送中心中，其中16個中心由本集團運營，其餘13個中心由本集團的區域代理嚴格按照本集團的品質要求運營。

In 2023, the Group continued to develop its own brands as Excellent fruits and has introduced a total of six new product brands which are Excellent fruits to the market. As such, as of December 31, 2023, the Group had successfully introduced to the market a total of 37 self-owned product brands which are Excellent fruits, and the aggregate retail sales of all self-branded fruits accounted for approximately 14.0% of total store retail sales of Pagoda stores in 2023.

In addition, the Group has been actively diversifying its fruit offerings and introducing new products to the market in 2023, such as Red Guoseng (紅果參), Fruit Corn (水果玉米), Purple Jade Carrot (紫玉胡蘿蔔), Passion Fruit (茄食百香果) and Golden Venus Apple (黃金維納斯蘋果); amongst, the total sales amount of Fruit Corn (水果玉米) increased by approximately 3,076% and the total sales amount of Golden Venus Apple (黃金維納斯蘋果) increased by approximately 515% in 2023, as compared to the year of 2022. By assigning specialized general managers to oversee each product category (i.e., category managers), the Group is able to ensure that each brand is provided with the targeted focus and resources necessary for achieving superior market performance and fostering innovation. As of December 31, 2023, the Group had eight category managers for eight brands, including Red Guoseng (紅果參) and Purple Jade Carrot (紫玉胡蘿蔔).

## OTHER BUSINESS UPDATES

### SMART WAREHOUSING AND SUPPLY CHAIN MANAGEMENT

As of December 31, 2023, the Group had 29 warehouses across China which also functioned as local preliminary processing and distribution centers which were located in 29 cities with an aggregate floor area of more than 207 thousand sq.m. Out of the 29 preliminary processing and distribution centers, 16 centers were operated by the Group, and the remaining 13 centers were operated by the Group's regional dealers by strictly following the Group's quality requirements.

就倉儲而言，於二零二三年，本集團已通過進一步提高倉儲自動化及優化倉儲設計持續升級其數字化智能倉儲物流系統，有效減少普遍的倉儲及物流失誤，包括提貨失誤、數量錯誤及錯誤配送等。此外，本集團於二零二三年第二季度推出了新版運輸管理系統(TMS)。升級後的運輸管理系統能夠生成更準確的信息及數據，從而使本集團能夠進一步優化其運輸定價策略，進一步提高成本效率。於二零二三年，本集團的運輸成本較二零二二年下降了約4.7%。

二零二三年，本集團進一步加強供應鏈能力，積極推進相關水果產地的本地倉庫設立。該舉措源於其堅信優質水果的基礎在於其優質的原產地種植。因此，本集團透過產品選擇、土壤改良、農業管理及採後保護，維持全面支援上游供應商的方針。通過從培育階段直接參與，本集團旨在提高其產品的質量和數量，確保其供應來源，並發展高標準的供應鏈生態系統。本集團向其提供農業技術及相關服務的供應商採購金額佔同年水果採購總額的佔比由截至二零二二年十二月三十一日的約35.0%提升至二零二三年十二月三十一日的約41.0%。此外，截至二零二三年十二月三十一日，本集團已與16個產地供應商合作完成16個產地倉的建設，涉及10種水果，覆蓋全國11個省市。

In terms of warehousing, in 2023, the Group continued to upgrade its digitalized intelligent warehousing and logistics system through further improving warehousing automation and optimizing warehousing designs to effectively minimize common warehousing and logistics mistakes, including picking error, inaccurate quantity, or mistaken delivery. Further, the Group launched a new version of transportation management system or TMS in the second quarter of 2023. The upgraded TMS is able to generate more accurate information and data, which in turn allows the Group to further optimize its pricing strategy on transportation, further improving cost efficiency. In 2023, the Group's transportation costs decreased by approximately 4.7% as compared to the year of 2022.

In 2023, the Group has further strengthened its supply chain capability by actively promoting the establishment of local warehouses at the origin of relevant fruits. This initiative stems from its belief that the foundation of high-quality fruits lies in their origin-based quality cultivation. Consequently, the Group has maintained its comprehensive approach to support upstream suppliers through product selection, soil enhancement, agricultural management, and post-harvest care. By engaging directly from the cultivation phase, the Group aims to elevate both the quality and quantity of its products, secure its supply sources, and develop a high-standard supply chain ecosystem. The purchase amount from suppliers to whom the Group provided agricultural technology and related services out of the total fruit purchases increased from approximately 35.0% as of December 31, 2022 to approximately 41.0% as of December 31, 2023. Moreover, as of December 31, 2023, the Group partnered with 16 local suppliers and completed the construction of 16 warehouses, relating to 10 types of fruits, covering 11 provinces and cities across China.

## 二零二四年業務展望及集團戰略

展望二零二四年，本集團面對中國經濟復甦步伐緩慢及通脹低迷帶來的挑戰。儘管如此，在進一步的政府政策支持及不斷增長的消費能力的支持下，本集團對宏觀經濟復甦的回溫保持樂觀。本集團有信心能夠渡過艱難時期。於二零二四年，本集團相信轉向高質量增長戰略將進一步增強其核心競爭力，為其核心客戶創造更大價值，並抓住新的市場機會。就本集團的零售業務而言，本集團旨在透過提供更具特色的產品、優質服務及更佳的購物體驗，提高客戶參與度。此外，本集團的2B業務分部作為額外的增長途徑，將通過新渠道擴張維持其勢頭並取得更高的市場份額。作為水果零售行業的領導者，本集團的使命是通過提供更優質、穩定及具成本效益的水果及水果產品，引領高質量的發展軌跡。二零二四年，本集團將繼續實施其發展策略，並進一步推動及實施以下各項：

- **持續提升零售門店盈利能力並進一步拓展OMO經銷網絡**

本集團將通過策略煥新、招牌果銷售佔比提升、水果禮盒打造等方式全面提升品牌知名度和美譽度，從而進一步提升零售門店的盈利能力。具體來說，本集團會(1)繼續升級門店形象，簽約名人代言，提高百果園品牌影響力；(2)繼續全年對招牌果進行季節性推廣，並致力提供更多的新品類，引領市場走勢；及(3)做強高品質水果禮盒，搶佔送禮市場，提升銷量。與此同時，本集團將通過持續向低線城市滲透、進一步擴張現有城市門店，持續拓展經銷網絡的廣度與深度。

## 2024 BUSINESS OUTLOOK AND GROUP STRATEGIES

Looking into 2024, the Group faces challenges from a tepid recovery pace of the economy and low inflation in China. Nevertheless, the Group remains optimistic on a back-loaded macroeconomic recovery, backed by further government policy support and growing consumer spending power. The Group is confident that it will be able to navigate through hard times. In 2024, the Group believes that pivoting towards a high-quality growth strategy will further strengthen its core competitiveness, deliver greater value to its core customers, and capture new market opportunities. With regards to the Group's retail business, the Group aims to increase customer engagement by providing more distinctive products, premium services, and an enhanced shopping experience. Moreover, the Group's 2B business segment, representing an additional avenue for growth, will sustain its momentum and achieve a higher market share through new channel expansion. As a leader in the fruit retail industry, the Group is on the mission to lead high-quality development trajectory by offering more superior, stable and cost-effective fruits and fruit products. In 2024, the Group will continue to implement its development strategies and further promote and implement the following:

- **Continue to improve profitability of retail stores and further expand OMO distribution network**

The Group will comprehensively enhance its brand awareness and reputation through refreshing strategies, increasing the proportion of sales of Excellent fruits and creating fruit gift boxes, thereby further improving the profitability of its retail stores. Specifically, the Group will (1) continue to upgrade the store image and engage celebrity for endorsement to enhance the influence of Pagoda brand; (2) continue to promote seasonal Excellent fruits throughout the year, and endeavour to offer more new types of products to lead the market trend; and (3) develop high-quality fruit gift boxes to seize the gift-giving market and boost the Group's overall sales amount. Meanwhile, the Group will continue to expand the breadth and depth of its distribution network through continued penetration into low-tier cities, further expansion of stores in existing cities.

- **積極全面拓展2B經銷渠道**

此外，本集團將繼續加強2B業務，進一步深化與現有2B客戶的合作，例如，針對2B客戶對福利品的個性化需求打造全新果品禮盒；發掘全渠道的2B客戶，進一步拓展2B客戶群；同時加強產品開發能力，通過獲得國產和進口水果的獨家代理權，提升產品的競爭力。另外，本集團還將秉承「買全球、賣全球」理念，將各產區優質水果在全球範圍內流通貿易，讓全世界的人都能享受優質的水果。最後，本集團將進一步透過深圳般果平台搶佔下沉水果市場份額，保持深圳般果的穩健增長。

- **進一步改善供應鏈管理，優化倉儲、物流及品控體系**

本集團將繼續擴大及升級其初加工配送中心網絡，提升單位倉儲面積、所覆蓋門店數、日均配送量等核心指標，支持加盟門店網絡的擴張以及企業對企業(2B)水果業務與優質大生鮮業務的快速增長。本集團亦將對倉儲及運輸管理系統進行升級，進一步推行自動化管理及探索自動倉儲體系，提升倉儲及物流效率，降低成本。

- **Actively and comprehensively develop the 2B distribution channels**

In addition, the Group will continue to strengthen its 2B business through further deepening its cooperation with its existing 2B customers, such as developing new fruit gift boxes to meet the customized needs of 2B customers for welfare gifts; exploring omni-channel 2B customers to further expand the 2B customer base; meanwhile strengthening product development capabilities and enhancing the competitiveness of its products through its exclusive rights to distribute domestically produced and imported fruits. In addition, the Group will firmly implement its strategy of “Buy Globally, Sell Globally” to promote its high-quality fruits from various production areas to be circulated and traded globally, so that people all over the world can enjoy high-quality fruits. Lastly, the Group will further increase its market share in fruit markets in lower-tier cities through Shenzhen Banguo and strive to maintain the steady growth of Shenzhen Banguo.

- **Further enhance supply chain management and optimize warehousing, logistic and quality control system**

The Group will continue to expand and upgrade its network of preliminary processing and distribution centers to improve core metrics such as unit storage area, number of stores covered and average daily delivery volume to support the expansion of its franchised store network and the rapid growth of the business-to-business, or 2B, fruit business and quality fresh grocery business. It will also upgrade the warehousing and transportation management system, further implement automated management and explore automated warehousing system to improve warehousing and logistics efficiency and reduce costs.

- 通過信息技術投入及賦能，加快全運營及產業鏈數字化

本集團計劃持續投資於信息技術的研發及升級，通過對全產業鏈各環節的技術賦能，促進業務的數字化，提升全產業鏈運營效率及協同能力。具體而言，本集團擬透過建立動態、高效及以結果為導向的信息科技系統，深化數字化轉型，以盡量提升表現成果及企業價值。為此，本集團計劃利用人工智能、深度學習及其他先進技術提升數據處理、分析及管理能力，從而優化算法，並改善集團內信息科技系統及基礎設施之間的協同效應。本集團亦預期其信息科技系統於數字化轉型後，可容納水果行業生態系統的外部行業參與者並使其受益。

- **Accelerate the digitalization of the whole operation and industry chain through IT investments and empowerments**

The Group plans to continue to invest in IT research and development and upgrade, and through the technological empowerment of all links of the industry chain, to promote the digitalization of its business and improve the operational efficiency and synergy of the entire industry chain. In particular, the Group intends to deepen the digital transformation by establishing dynamic, efficient, and result-driven IT systems to maximize performance outcomes and corporate values. To this end, the Group plans to leverage artificial intelligence, deep learning and other advanced technologies to improve the data processing, analysis and management capabilities, so as to optimize algorithms and improve the synergies among intra-group IT systems and infrastructure. The Group also expects its IT systems, upon the digital transformation, could accommodate and benefit external industry players in its ecosystem in the fruit industry.

本集團的總收入由截至二零二二年十二月三十一日止年度的人民幣11,312.0百萬元增加約0.7%至截至二零二三年十二月三十一日止年度的人民幣11,390.6百萬元。銷售水果及其他食品的收入佔本集團總收入的大部分，分別約佔二零二二年及二零二三年總收入的97.1%及97.2%。

The Group's total revenue increased by approximately 0.7% from RMB11,312.0 million for the year ended December 31, 2022 to RMB11,390.6 million for the year ended December 31, 2023. Revenue generated from sales of fruits and other food products represented the majority portion of the Group's total revenue, representing approximately 97.1% and 97.2% of total revenue in 2022 and 2023, respectively.

本集團主要透過線下門店網絡（包括通過我們自行招募或通過區域代理引薦的加盟商開設的加盟門店及自營門店）分銷水果及其他食品。其亦通過線上渠道進行分銷。此外，其從事向若干主要客戶的直銷及小規模從事批發業務。

The Group mainly distributes fruits and other food products through offline store network, comprising franchised stores operated by franchisees recruited by itself or referred by its regional dealers and self-operated stores. It also distributes through online channels. In addition, it engages in direct sales to certain major customers and on a small scale, it engages in wholesale business.

銷售水果及其他食品的收入增加主要是由於來自2B業務的銷售（如直銷）收入增加，由截至二零二二年十二月三十一日止年度的人民幣723.8百萬元增加約42.5%至截至二零二三年十二月三十一日止年度的人民幣1,031.5百萬元，抵銷來自加盟門店的銷售收入由截至二零二二年十二月三十一日止年度的人民幣8,851.5百萬元減少約4.0%至截至二零二三年十二月三十一日止年度的人民幣8,499.8百萬元。

The increase in revenue from sales of fruits and other food products was primarily due to increase in revenue of sales derived from 2B business (i.e., direct sales) by approximately 42.5% from RMB723.8 million for the year ended December 31, 2022 to RMB1,031.5 million for the year ended December 31, 2023, net with the decrease in revenue of sales derived from franchised stores by approximately 4.0% from RMB8,851.5 million for the year ended December 31, 2022 to RMB8,499.8 million for the year ended December 31, 2023.

直銷收入增長主要是由於本集團在海外及國內市場的業務增長所致。由於海外市場對優質水果的需求增加，本集團向海外市場2B客戶出口水果及水果產品產生的銷售總額由截至二零二二年十二月三十一日止年度的人民幣154.4百萬元增加約62.0%至截至二零二三年十二月三十一日止年度的人民幣250.0百萬元。本集團來自國內市場2B客戶的銷售總額由截至二零二二年十二月三十一日止年度的人民幣569.4百萬元增加約37.2%至截至二零二三年十二月三十一日止年度的人民幣781.5百萬元，乃由於本集團自二零二二年起持續實施有利的定價策略，以擴大本集團的2B業務客戶基礎。

The increase in revenue from direct sales was primarily due to the Group's business growth in both overseas and domestic markets. The Group's total sales amount derived from exporting fruits and fruit products to 2B customers in overseas market increased by approximately 62.0% from RMB154.4 million for the year ended December 31, 2022 to RMB250.0 million for the year ended December 31, 2023 due to increase in demand of quality fruits in overseas markets. The Group's total sales amount derived from 2B customers in domestic market increased by approximately 37.2% from RMB569.4 million for the year ended December 31, 2022 to RMB781.5 million for the year ended December 31, 2023 due to the continuous implementation of the Group's favorable pricing strategy since 2022 in order to expand the Group's 2B business customer base.

來自加盟門店的收入減少主要是由於以下各項的淨影響：(i)本集團監管的加盟門店數目由截至二零二二年十二月三十一日的4,577家淨增加約5.3%至截至二零二三年十二月三十一日的4,818家；及(ii)本集團監管的每家加盟門店的平均年收入由截至二零二二年十二月三十一日止年度的人民幣2.0百萬元減少約9.8%至截至二零二三年十二月三十一日止年度的人民幣1.8百萬元，乃由於中國經濟社會全面恢復常態化，居民於假期（尤其是暑假）出遊增多，導致以社區為基礎的小店的進店客流減少。

### 銷售成本

銷售成本由截至二零二二年十二月三十一日止年度的人民幣9,997.7百萬元增加約0.8%至截至二零二三年十二月三十一日止年度的人民幣10,075.7百萬元，主要是由於已出售存貨成本增加。已出售存貨成本佔本集團銷售成本的大部分，分別佔截至二零二二年及二零二三年十二月三十一日止年度本集團銷售成本總額約95.2%及95.4%。已出售存貨成本增加與水果及其他食品銷售收入波動一致。

### 毛利及毛利率

由於以上所述，本集團的毛利由截至二零二二年十二月三十一日止年度的人民幣1,314.3百萬元略微增加約0.04%至截至二零二三年十二月三十一日止年度的人民幣1,314.8百萬元。本集團的毛利率由截至二零二二年十二月三十一日止年度的11.6%略微減少至截至二零二三年十二月三十一日止年度的11.5%。

The decrease in revenue from franchised stores was primarily due to net impact of (i) net increase in number of franchised stores supervised by the Group by approximately 5.3% from 4,577 stores as of December 31, 2022 to 4,818 stores as of December 31, 2023, and (ii) decrease in average annual revenue per franchised store supervised by the Group by approximately 9.8% from RMB2.0 million for the year ended December 31, 2022 to RMB1.8 million for the year ended December 31, 2023, which was due to full resumption to normal operations of economy and society in China that people travel more during holidays, especially in summer holiday, resulting in decrease of in-flow of customers in small community-based stores.

### COST OF SALES

Cost of sales increased by approximately 0.8% from RMB9,997.7 million for the year ended December 31, 2022 to RMB10,075.7 million for the year ended December 31, 2023, mainly due to the increase in cost of inventories sold. Cost of inventories sold represented the majority portion of the Group's cost of sales, accounting for approximately 95.2% and 95.4% of the Group's total cost of sales for the years ended December 31, 2022 and 2023, respectively. The increase in cost of inventories sold was in line with the fluctuation in revenue from sales of fruits and other food products.

### GROSS PROFIT AND GROSS PROFIT MARGIN

As a result of the foregoing, the Group's gross profit slightly increased by approximately 0.04% from RMB1,314.3 million for the year ended December 31, 2022 to RMB1,314.8 million for the year ended December 31, 2023. The Group's gross profit margin slightly decreased from 11.6% for the year ended December 31, 2022 to 11.5% for the year ended December 31, 2023.

### 其他收入

本集團的其他收入由截至二零二二年十二月三十一日止年度的人民幣40.8百萬元減少約9.8%至截至二零二三年十二月三十一日止年度的人民幣36.8百萬元。該減少主要是由於與銀行借款產生的財務成本相關補貼有關的政府補貼減少人民幣1.9百萬元所致，及加盟商罰款收入（即本集團根據相關特許經營協議自加盟商收取的各種偶然性罰款）減少人民幣1.3百萬元。

### 其他收益淨額

本集團的其他收益淨額由截至二零二二年十二月三十一日止年度的人民幣25.4百萬元增加約16.7%至截至二零二三年十二月三十一日止年度的人民幣29.6百萬元。該增加主要是由於外幣升值，導致於二零二三年確認的主要由海外直銷產生的匯兌收益淨額為人民幣9.3百萬元，而於二零二二年，匯兌收益淨額為人民幣2.9百萬元。

### 銷售費用

本集團的銷售費用由截至二零二二年十二月三十一日止年度的人民幣498.8百萬元減少約3.4%至截至二零二三年十二月三十一日止年度的人民幣482.0百萬元。該減少主要是由於(i)運輸成本減少人民幣10.0百萬元，由截至二零二二年十二月三十一日止年度的人民幣214.6百萬元減少約4.7%至截至二零二三年十二月三十一日止年度的人民幣204.6百萬元，乃由於本集團升級TMS，使本集團可進一步優化其運輸定價策略，及(ii)本集團銷售及營銷人員人數由截至二零二二年十二月三十一日的1,452名減少至截至二零二三年十二月三十一日的1,224名。

### OTHER INCOME

The Group's other income decreased by approximately 9.8% from RMB40.8 million for the year ended December 31, 2022 to RMB36.8 million for the year ended December 31, 2023. The decrease was primarily due to a decrease of RMB1.9 million in government grants, mainly in connection with subsidies in connection with finance costs arising from banks borrowings, and a decrease of RMB1.3 million in penalty income from franchisees which represented various occasional penalty payments the Group collected from franchisees pursuant to the relevant franchise arrangements.

### OTHER GAINS, NET

The Group's other gains, net increased by approximately 16.7% from RMB25.4 million for the year ended December 31, 2022 to RMB29.6 million for the year ended December 31, 2023. The increase was primarily due to appreciation of foreign currencies which led to exchange gains, net derived mainly from overseas direct sales in the amount of RMB9.3 million recognized in 2023, while in 2022, exchange gains, net was RMB2.9 million.

### SELLING EXPENSES

The Group's selling expenses decreased by approximately 3.4% from RMB498.8 million for the year ended December 31, 2022 to RMB482.0 million for the year ended December 31, 2023. The decrease was primarily due to (i) decrease of transportation costs of RMB10.0 million, representing a decrease of approximately 4.7% from RMB214.6 million for the year ended December 31, 2022 to RMB204.6 million for the year ended December 31, 2023 which was attributable to the Group's upgraded TMS that allows the Group to further optimize its pricing strategy on transportation, and (ii) decrease in headcounts of the Group's sales and marketing staff from 1,452 as of December 31, 2022 to 1,224 as of December 31, 2023.

## 管理費用

本集團的管理費用由截至二零二二年十二月三十一日止年度的人民幣321.6百萬元減少約2.5%至截至二零二三年十二月三十一日止年度的人民幣313.5百萬元。該減少主要是由於本集團管理人員的人數由截至二零二二年十二月三十一日的538名減少至截至二零二三年十二月三十一日的525名。

## 金融資產減值虧損撥備淨額

二零二二年及二零二三年的金融資產減值虧損淨額主要為貿易及其他應收款項的一般預期信貸虧損。金融資產減值虧損撥備淨額由截至二零二二年十二月三十一日止年度的人民幣2.2百萬元增加至截至二零二三年十二月三十一日止年度的人民幣23.5百萬元，乃由於賬齡超過一年的貿易應收款項增加，其主要歸因為少數2B企業客戶違約、無力償債或破產，本集團已對該等債務人提出索償。

## 研發費用

本集團的研發費用由截至二零二二年十二月三十一日止年度的人民幣173.0百萬元減少約15.8%至截至二零二三年十二月三十一日止年度的人民幣145.6百萬元。該減少主要是由於本集團研發人員的人數由截至二零二二年十二月三十一日的491名減少至截至二零二三年十二月三十一日的361名。

## ADMINISTRATIVE EXPENSES

The Group's administrative expenses decreased by approximately 2.5% from RMB321.6 million for the year ended December 31, 2022 to RMB313.5 million for the year ended December 31, 2023. The decrease was primarily due to decrease in headcounts of the Group's administrative staff from 538 as of December 31, 2022 to 525 as of December 31, 2023.

## NET PROVISION OF IMPAIRMENT LOSS ON FINANCIAL ASSETS

Net impairment losses on financial assets in 2022 and 2023 mainly represented a general expected credit loss on trade and other receivables. Net provision of impairment losses on financial assets increased from RMB2.2 million for the year ended December 31, 2022 to RMB23.5 million for the year ended December 31, 2023 due to increase in trade receivables aged over 1 year which mainly attributable to default, insolvency or bankruptcy of a few 2B business customers and the Group has submitted claims against those debtors.

## RESEARCH AND DEVELOPMENT EXPENSES

The Group's research and development expenses decreased by approximately 15.8% from RMB173.0 million for the year ended December 31, 2022 to RMB145.6 million for the year ended December 31, 2023. The decrease was primarily due to decrease in headcounts of the Group's research and development staff from 491 as of December 31, 2022 to 361 as of December 31, 2023.

### 財務成本，淨額

財務收入由截至二零二二年十二月三十一日止年度的人民幣31.8百萬元增加約28.7%至截至二零二三年十二月三十一日止年度的人民幣40.9百萬元，主要是由於銀行存款產生利息收入增加。

財務成本由截至二零二二年十二月三十一日止年度的人民幣83.7百萬元減少約9.5%至截至二零二三年十二月三十一日止年度的人民幣75.8百萬元，主要是由於與本集團的銀行借款及租賃負債有關的利息開支減少。

### 分佔聯營公司及合營企業（虧損）／利潤，淨額

本集團不時以少數股權方式對公司進行投資，例如初創公司，包括專門從事農業技術及設備開發或提供種植管理諮詢解決方案的公司，以利用其學術或技術專長來補充本集團的自有研發能力。

截至二零二三年十二月三十一日止年度，本集團錄得的分佔於聯營公司及合營企業虧損淨額為人民幣0.7百萬元，而截至二零二二年十二月三十一日止年度，本集團錄得的分佔於聯營公司及合營企業收益淨額為人民幣13.3百萬元。該減少主要是由於一些參與種植牛油果和火龍果的聯營公司出現虧損。

### FINANCE COST, NET

Finance income increased by approximately 28.7% from RMB31.8 million for the year ended December 31, 2022 to RMB40.9 million for the year ended December 31, 2023, which was mainly attributable to increase in interest income arising from bank deposits.

Finance costs decreased by approximately 9.5% from RMB83.7 million for the year ended December 31, 2022 to RMB75.8 million for the year ended December 31, 2023, which was mainly attributable to decrease in interest expense in connection with the Group's bank borrowings and lease liabilities.

### SHARE OF (LOSSES)/PROFITS OF ASSOCIATES AND JOINT VENTURE, NET

The Group from time to time makes minority investments in companies, such as start-ups specializing in agricultural technique and equipment development or delivering cultivation management consulting solutions, to leverage their academic or technical expertise to supplement the Group's in-house research capabilities.

For the year ended December 31, 2023, the Group recorded share of losses of associates and joint venture, net of RMB0.7 million, while the Group recorded share of profits of associates and joint ventures, net of RMB13.3 million for the year ended December 31, 2022. The decrease was mainly attributable to loss-making of some associates involved in cultivating avocado and pitaya.

### 除所得稅前利潤

由於以上所述，本集團截至二零二三年十二月三十一日止年度錄得除所得稅前利潤人民幣381.0百萬元，較截至二零二二年十二月三十一日止年度的人民幣346.4百萬元增加約10.0%。

### 所得稅費用

所得稅費用由截至二零二二年十二月三十一日止年度的人民幣40.2百萬元增加約2.0%至截至二零二三年十二月三十一日止年度的人民幣41.0百萬元，主要是由於本集團的應課稅收入增加。本集團於二零二三年的除所得稅前利潤及其應課稅收入的增量幅度差異主要由於本集團若干附屬公司於截至二零二三年十二月三十一日止年度享有稅收優惠及免稅所致。

### 年內利潤

由於以上所述，本集團的淨利潤由截至二零二二年十二月三十一日止年度的人民幣306.1百萬元增加約11.1%至截至二零二三年十二月三十一日止年度的人民幣340.0百萬元。本集團的淨利潤率由截至二零二二年十二月三十一日止年度的約2.71%提高至截至二零二三年十二月三十一日止年度的約2.98%。

### PROFIT BEFORE INCOME TAX

As a result of the foregoing, the Group recorded profit before income tax of RMB381.0 million for the year ended December 31, 2023, increased by approximately 10.0% from RMB346.4 million for the year ended December 31, 2022.

### INCOME TAX EXPENSE

Income tax expense increased by approximately 2.0% from RMB40.2 million for the year ended December 31, 2022 to RMB41.0 million for the year ended December 31, 2023, primarily due to the increase in the Group's taxable income. The difference in magnitude of the increment in the Group's profit before income tax and its taxable income in 2023 was primarily because some of the Group's subsidiaries enjoyed preferential tax treatments and tax exemptions during the year ended December 31, 2023.

### PROFIT FOR THE YEAR

As a result of the foregoing, the Group's net profit increased by approximately 11.1% from RMB306.1 million for the year ended December 31, 2022 to RMB340.0 million for the year ended December 31, 2023. The Group's net profit margin increased from approximately 2.71% for the year ended December 31, 2022 to approximately 2.98% for the year ended December 31, 2023.

### 非香港財務報告準則計量 – 經調整純利及經調整純利率

為補充本集團根據香港財務報告準則呈列的合併財務資料，本集團呈列經調整純利及經調整純利率（各自為非香港財務報告準則計量）作為額外財務計量。經調整純利界定為扣除上市費用前的年內利潤，並按相關年度的純利加回上市開支計算。經調整淨利潤率乃按年內經調整淨利潤除以有關年度的總收入計算。上市費用指有關本集團於二零二三年一月完成的全球發售及上市的費用。

本集團使用未經審計非香港財務報告準則計量作為額外財務計量，以補充合併財務資料及透過撇除本集團認為並非本集團業務表現指標的若干非經常性項目的影響評估本集團的財務表現。本集團經營所在行業的其他公司的非香港財務報告準則計量可能與本集團不同。非香港財務報告準則計量並非香港財務報告準則項下經營表現或流動資金的計量，且不應被視為替代或優於香港財務報告準則項下除稅前利潤或經營活動所得現金流量。

非香港財務報告準則計量作為分析工具存在局限性，閣下不應視其為獨立於或可替代本集團根據香港財務報告準則所呈報業績的分析。本集團呈列該非香港財務報告準則項目不應被視為本集團未來業績將不受不尋常或非經常性項目影響的推斷。

### NON-HKFRS MEASURES – ADJUSTED NET PROFIT AND ADJUSTED NET PROFIT MARGIN

To supplement the Group's consolidated financial information, which are presented in accordance with HKFRS, the Group presents adjusted net profit and adjusted net profit margin, each a non-HKFRS measure, as additional financial measures. Adjusted net profit is defined as profit for the year before listing expenses and is calculated by adding back the listing expenses to net profit for the relevant year. Adjusted net profit margin is calculated as adjusted net profit for the year divided by total revenue for the relevant year. Listing expenses represents expenses in relation to the Group's Global Offering and Listing completed in January 2023.

The Group uses unaudited non-HKFRS measures as an additional financial measure to supplement the consolidated financial information and to evaluate the financial performance of the Group by eliminating the impact of certain non-recurring item that the Group does not consider indicative of the performance of the business of the Group. Other companies in the industry the Group operates in may calculate the non-HKFRS measures differently than the Group does. The non-HKFRS measures are not a measure of operating performance or liquidity under HKFRS and should not be considered as a substitute for, or superior to, profit before tax or cash flow from operating activities in accordance with HKFRS.

The non-HKFRS measures have limitation as an analytical tool, and you should not consider it in isolation or as a substitute for analysis of the Group's results as reported under HKFRS. The Group's presentation of this non-HKFRS item should not be construed as an inference that the Group's future results will be unaffected by unusual or non-recurring items.

### 流動資金及資金來源

截至二零二三年十二月三十一日止年度，本集團主要通過經營活動、股東出資及銀行借貸為經營提供資金。

此外，本公司於二零二三年第一季度完成全球發售及上市，並收到所得款項淨額約474.0百萬港元(包括部分行使超額配股權而獲得的所得款項淨額)。本集團目前有意主要以其自身的內部資源為其擴張及業務經營撥付資金，並有意動用自全球發售收到的所得款項淨額。

### LIQUIDITY AND CAPITAL RESOURCES

For the year ended December 31, 2023, the Group financed its operations primarily through cash generated from its business operations, capital contributions by Shareholders and bank borrowings.

In addition, the Company completed its Global Offering and Listing in the first quarter of 2023 and received net proceeds in the amount of approximately HK\$474.0 million (including net proceeds received from the partial exercise of the over-allotment option). The Group currently intends to finance its expansion and business operation mainly by using its own internal resources, as well as to use the net proceeds received from the Global Offering.

### 資本結構

截至二零二三年十二月三十一日，本集團的資產淨值為人民幣3,337.1百萬元，而截至二零二二年十二月三十一日則為人民幣3,019.5百萬元。截至二零二三年十二月三十一日的資產淨值主要包括流動資產人民幣5,265.8百萬元、非流動資產人民幣2,325.1百萬元、流動負債人民幣3,517.6百萬元及非流動負債人民幣736.3百萬元。

### 現金及銀行結餘

截至二零二二年十二月三十一日，本集團的現金及銀行存款為人民幣1,776.2百萬元，而截至二零二三年十二月三十一日則為人民幣2,537.1百萬元，其包括不受限制現金及現金等價物人民幣2,224.8百萬元以及限制性銀行存款人民幣312.3百萬元。

截至二零二二年及二零二三年十二月三十一日，本集團的現金及現金等價物主要以人民幣計值。

### 財務風險

本集團面臨與現金及銀行結餘、銀行借款及固定利率應收貸款有關的利率風險。管理層認為整體利率風險屬不重大。本集團在銀行存有外幣現金，使本集團面臨外匯風險。本集團並無使用任何衍生合約以對沖外匯風險。管理層通過密切監控外幣匯率的變動來管理其貨幣風險，並將採取謹慎措施將貨幣折算風險降至最低。

### 全球發售的所得款項用途

本公司於二零二三年第一季度完成全球發售及上市，且其H股於二零二三年一月十六日於聯交所主板成功上市。在扣除承銷佣金及與全球發售有關的其他估計費用後，本公司自全球發售（包括部分行使超額配股權）籌得的所得款項淨額約為474.0百萬港元（「所得款項淨額」）。

### CAPITAL STRUCTURE

As of December 31, 2023, the Group had net assets of RMB3,337.1 million, as compared to RMB3,019.5 million as of December 31, 2022. Net assets as of December 31, 2023 primarily comprised current assets of RMB5,265.8 million, non-current assets of RMB2,325.1 million, current liabilities of RMB3,517.6 million and non-current liabilities of RMB736.3 million.

### CASH AND BANK BALANCES

As compared with RMB1,776.2 million as of December 31, 2022 the Group had cash and bank deposits of RMB2,537.1 million as of December 31, 2023, which was consisted of unrestricted cash and cash equivalents of RMB2,224.8 million and restricted bank deposits of RMB312.3 million.

As of December 31, 2022 and 2023, the cash and cash equivalents of the Group were mainly denominated in Renminbi.

### FINANCIAL RISKS

The Group is exposed to interest rate risk in relation to its cash and bank balances, bank borrowings and fixed rate loan receivables. The management considers the overall interest rate risk is insignificant. The Group has cash at banks denominated in foreign currencies, which subject the Group to foreign exchange risk. The Group does not use any derivative contracts to hedge against its exposure to foreign exchange risk. The management manages its currency risk by closely monitoring the movement of the foreign currency rates and will take prudent measures to minimize the currency translation risk.

### USE OF PROCEEDS FROM THE GLOBAL OFFERING

The Company completed its Global Offering and Listing in the first quarter of 2023 and its H shares were successfully listed on the Main Board of the Stock Exchange on January 16, 2023. Net proceeds the Company raised from the Global Offering (including the partial exercise of the over-allotment option), after deducting the underwriting commission and other estimated expenses in connection with the Global Offering amounted to approximately HK\$474.0 million (the “**Net Proceeds**”).

截至二零二三年十二月三十一日，未動用所得款項淨額已存入中國持牌銀行作為短期計息存款。本集團擬按招股章程中「未來計劃及所得款項用途」一節所披露的方式使用其所得款項淨額。

### 債務

截至二零二三年十二月三十一日，本集團擁有非即期銀行借貸總額人民幣126.3百萬元及短期銀行借貸人民幣1,768.9百萬元。該等未償還銀行借款以人民幣計值及大部分以固定利率計息，其餘部分以浮動利率計息。

本集團使用資產負債比率（資產負債比率=年末借貸總額／總權益再乘以100%）以監控其資本結構。本集團的資產負債比率由截至二零二二年十二月三十一日的44.2%增加至截至二零二三年十二月三十一日的56.8%，主要是由於銀行借款增加，並被利率較低的銀行借款取代，從而導致銀行借款利息開支由截至二零二二年十二月三十一日止年度的人民幣52.8百萬元降至截至二零二三年十二月三十一日止年度的人民幣50.3百萬元。

### 抵押資產

截至二零二三年十二月三十一日，本集團就其銀行借款抵押使用權資產人民幣49.1百萬元及本集團分類為物業、廠房及設備的樓宇人民幣23.2百萬元。

As of December 31, 2023, the Net Proceeds unutilized had been deposited into short-term interest bearing deposits placed in licensed banks in China. The Group intends to continue to utilize the Net Proceeds in the manner as disclosed in the section headed "Future Plans and Use of Proceeds" in the Prospectus.

### INDEBTEDNESS

As of December 31, 2023, the Group had an aggregate non-current bank borrowings of RMB126.3 million and short-term bank borrowings of RMB1,768.9 million. Such outstanding bank borrowings were denominated in Renminbi and the majority portion was at fixed interest rates with the remaining at variable interest rates.

The Group uses the gearing ratio (gearing ratio = total borrowings/total equity at the end of year and multiplied by 100%) to monitor its capital structure. The Group's gearing ratio increased from 44.2% as of December 31, 2022 to 56.8% as of December 31, 2023, which was primarily due to increase in bank borrowings which were replaced with bank borrowings with lower interest rate which, in turn, led to decrease in interest expenses on bank borrowings from RMB52.8 million for the year ended December 31, 2022 to RMB50.3 million for the year ended December 31, 2023.

### PLEDGED ASSETS

As of December 31, 2023, the Group's right-of-use assets of RMB49.1 million and the Group's building classified under property, plant and equipment of RMB23.2 million were pledged as collateral for the Group's bank borrowings.

截至二零二三年十二月三十一日止年度，經營活動所用現金淨額為人民幣48.5百萬元，而截至二零二二年十二月三十一日止年度，經營活動所得現金淨額為人民幣589.2百萬元，主要是由於除所得稅項前利潤人民幣381.0百萬元，並就折舊及攤銷總額人民幣127.3百萬元及財務成本淨額人民幣34.9百萬元等若干非現金項目作為調整。影響本集團經營活動所用現金的其他因素包括按金、預付款項及其他應收款項增加人民幣306.2百萬元，主要由於購買水果及其他食品的預付款項增加人民幣247.9百萬元，以確保本集團發展戰略實施所需的優質水果，貿易應付款項減少人民幣145.8百萬元。

截至二零二三年十二月三十一日止年度，投資活動所得現金淨額為人民幣282.6百萬元，而截至二零二二年十二月三十一日止年度，投資活動所得現金淨額為人民幣619.8百萬元，主要是由於截至二零二三年十二月三十一日止年度，贖回以公允價值計量且其變動計入損益的金融資產淨額為人民幣469.3百萬元，而截至二零二三年十二月三十一日止年度，應收貸款的預付款項淨額為人民幣118.3百萬元。

截至二零二三年十二月三十一日止年度，融資活動所得現金淨額為人民幣414.9百萬元，而截至二零二二年十二月三十一日止年度，融資活動所用現金淨額為人民幣307.8百萬元，主要是由於截至二零二三年十二月三十一日止年度銀行借款所得款項淨額為人民幣560.3百萬元，而截至二零二二年十二月三十一日止年度的償還銀行借款淨額為人民幣117.6百萬元，以及於二零二三年期間，首次公開發售所得款項淨額為人民幣426.8百萬元及派發股息為人民幣120.8百萬元。

## CASH FLOWS

For the year ended December 31, 2023, net cash used in operating activities was RMB48.5 million while net cash generated from operating activities was RMB589.2 million for the year ended December 31, 2022, which was mainly attributable to profit before income tax of RMB381.0 million, adjusted for certain non-cash items such as depreciation and amortization in the aggregate amount of RMB127.3 million and finance cost, net of RMB34.9 million. Additional factors that affected the Group's cash used in operating activities included an increase in deposits, prepayments and other receivables of RMB306.2 million mainly attributable to increase in prepayments for purchases of fruits and other food products of RMB247.9 million to ensure high-quality fruits for the Group's development strategies implementation, and a decrease in trade payables of RMB145.8 million.

For the year ended December 31, 2023, net cash generated from investing activities was RMB282.6 million, while net cash generated from investing activities was RMB619.8 million for the year ended December 31, 2022, which was mainly attributable to net redemption of financial assets at FVTPL of RMB469.3 million for the year ended December 31, 2023 net with net advance to loan receivables of RMB118.3 million for the year ended December 31, 2023.

For the year ended December 31, 2023, net cash generated from financing activities was RMB414.9 million, while the net cash used in financing activities was RMB307.8 million for the year ended December 31, 2022, which was mainly attributable to net proceeds from bank borrowings of RMB560.3 million for the year ended December 31, 2023 compared to net repayments of bank borrowings of RMB117.6 million for the year ended December 31, 2022 and net proceeds from initial public offering of RMB426.8 million and dividends paid of RMB120.8 million during the year of 2023.

### 金融資產、資本及投資管理

本集團不時投資理財產品（主要為結構性存款），以更方便現金管理。結構性存款為保本型產品，通常有固定的短期期限，並可在各自的到期日贖回，因此本質上風險相對較低。本集團的結構性存款列賬為以公允價值計量且其變動計入損益的金融資產。在較小程度上，本集團亦錄得以公允價值計量且其變動計入損益的長期金融資產的公允價值收入，即主要為與相關協議項下可轉換為借款人股權的貸款有關的可轉換債務。此外，本集團亦錄得以公允價值計量且其變動計入其他合併收益的金融資產，包括(i)非上市股本證券及(ii)本集團投資於其認為具備發展潛力的公司的上市股本證券。

截至二零二三年十二月三十一日止年度，本集團擁有(i)結構性存款（列為以公允價值計量且其變動計入損益的金融資產）人民幣180.4百萬元（二零二二年：人民幣623.8百萬元）；(ii)以公允價值計量且其變動計入損益的其他金融資產人民幣86.5百萬元（二零二二年：人民幣86.6百萬元）；及(iii)以公允價值計量且其變動計入其他合併收益的金融資產人民幣30.6百萬元（二零二二年：人民幣18.4百萬元）。

本集團已實施資本及投資政策以監控及控制與投資活動相關的風險。本集團一般只在有剩餘現金時才投資於理財產品，原則上僅有權投資於低風險及高流動性產品，且該等投資應屬非投機性質。本集團的資本及投資政策亦規定了選擇投資項目的標準，以及每項建議投資項目應經過的詳細審查程序。

鑒於低利率趨勢下賺取較活期儲蓄或定期存款利率相對高的回報的裨益，以及結構性存款的保本性質及於相對短期內到期，董事認為，結構性存款對本集團的風險為小，且結構性存款的條款及條件屬公平合理，且符合本公司及其股東的整體利益。

### FINANCIAL ASSETS, CAPITAL AND INVESTMENT MANAGEMENT

The Group from time to time invests in wealth management products, primarily structured deposits, in order to better facilitate its cash management. Structured deposits were principal-protected products which typically had a fixed short term and may be redeemed upon had their respective expiry dates, therefore, were relatively low risk in nature. The Group's structured deposits were accounted as financial assets measured at FVTPL. To a lesser extent, the Group also recorded fair value gains on long-term financial assets at FVTPL which mainly represented convertible debts in connection with loans convertible to equity interests in the borrowers pursuant to the relevant agreements. Moreover, the Group also recorded financial assets at FVOCI, which comprised (i) unlisted equity securities and (ii) listed equity securities whereby the Group invested in companies that it considered have development potentials.

As of December 31, 2023, the Group had (i) structured deposits which accounted for as financial assets at FVTPL of RMB180.4 million (2022: RMB623.8 million), (ii) other financial assets at FVTPL of RMB86.5 million (2022: RMB86.6 million), and (iii) financial assets at FVOCI of RMB30.6 million (2022: RMB18.4 million).

The Group has implemented capital and investment policies to monitor and control the risks relating to its investment activities. The Group generally only makes investments in asset management products when it has surplus cash, and in principle, is only entitled to invest in products with low-risk and high liquidity, and such investments should be non-speculative in nature. The Group's capital and investment policies also specify the criteria for selecting investments to be considered and the detailed review procedures that each proposed investment shall go through.

In view of an upside of earning a relatively higher return than current saving or fixed deposit rate under the low interest rate trend, as well as the principal-protected nature and a relatively short term of maturity of the structured deposits, the Directors are of the view that the structured deposits pose little risk to the Group and the terms and conditions of each of the structured deposits are fair and reasonable and are in the interests of the Company and its Shareholders as a whole.

本集團主要通過經營所得現金及銀行借款為我們的資本開支提供資金。

### 認購理財產品

於二零二三年一月十六日及二零二三年二月二十二日，本公司認購交通銀行股份有限公司（「交通銀行」）發行的本金總額為人民幣350百萬元的結構性定期存款理財產品，預期年化收益率為1.75%或3.00%或3.02%（視乎基準價早盤價而定）（「認購事項」）。交通銀行結構性定期存款理財產品是由知名商業銀行發行的相關風險相對較低的短期保本理財產品。因此，認購事項被認為具有相對較低的風險，且亦符合本集團內部風險管理、現金管理及投資政策。認購事項被視為本集團庫務管理的一部分，以在考慮（其中包括）風險水平、投資回報及到期期限後最大限度地提高本公司未動用資金的回報，並帶來更高的資本回報。認購相關的理財產品已到期且於年內悉數贖回。有關進一步詳情，請參閱本公司日期為二零二三年二月二十二日的公告。

### CAPITAL EXPENDITURE

The Group's capital expenditures amounted to RMB112.6 million for the year ended December 31, 2023, mainly for the payments of construction in progress of the Group's new office building located in Yantian District, Shenzhen, China.

The Group financed its capital expenditures primarily with cash generated from operations and bank borrowings.

### CONTINGENT LIABILITIES AND GUARANTEES

As of December 31, 2023, the Group did not have any contingent liabilities, guarantees or any significant litigation against it.

### SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS, AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

### SUBSCRIPTIONS OF WEALTH MANAGEMENT PRODUCTS

On January 16, 2023 and February 22, 2023, the Company subscribed for wealth management structured time deposit products offered by Bank of Communications Co., Ltd.\* (交通銀行股份有限公司) ("BOCOM") with an aggregated principal amount of RMB350 million with expected annual return rates of 1.75% or 3.00% or 3.02% depending on the benchmark price AM (the "Subscriptions"). The BOCOM wealth management structured time deposit products are short-term principal-protected wealth management products that have relatively low associated risks issued by a reputable commercial bank. Therefore, the Subscriptions were considered to have relatively low risk and are also in line with the internal risk management, cash management and investment policies of the Group. The Subscriptions are considered to be part of the Group's treasury management to maximize the return on the unutilized funds of the Company after taking into account, among others, the level of risk, return on investment and the term to maturity, and to bring higher return on capital. The wealth management products underlying the Subscriptions were matured and fully redeemed during the year. For further details, please refer to the Company's announcement dated February 22, 2023.

### 週轉率

存貨平均週轉天數由二零二二年的10.7天略微增加至二零二三年的12天，主要由於本集團儲存期相對較長的蘋果等其他水果的海外直銷量上漲。

貿易應收款項平均週轉天數由二零二二年的36.7天減少至二零二三年的35天，主要是由於本集團主動收款。

貿易應付款項平均週轉天數基本穩定，由二零二二年的15.6天略微增加至二零二三年的15.8天，乃由於截至二零二三年十二月三十一日止年度的供應商結算政策無重大變動。

Save as disclosed above, the Company had no significant investments, material acquisitions or disposals of subsidiaries, associates and joint ventures in 2023.

In addition, save for the expansion plans as disclosed in the sections headed “Business” and “Future Plans and Use of Proceeds” in the Prospectus, the Group currently has no specific plan for material investment in or acquisition of major assets or other business, or disposal of subsidiaries, associates and joint ventures. However, the Group will continue to identify new opportunities for business development.

### TURNOVER RATIOS

Average inventory turnover days slightly increased from 10.7 days in 2022 to 12 days in 2023, primarily due to increase in the Group's overseas direct sales of apple and other fruits that typically have a relatively long storage time.

Average trade receivables turnover days decreased from 36.7 days in 2022 to 35 days in 2023, primarily due to the Group's proactive payment collection.

Average trade payables turnover days slightly increased from 15.6 days in 2022 to 15.8 days in 2023, which remained stable as no significant change in supplier settlement policy for the year ended December 31, 2023.

## 僱員及僱員福利開支

截至二零二三年十二月三十一日，本集團共有2,637名僱員，其中約18.7%來自營銷部門，15.7%來自運營及門店管理部門，20.4%來自生產及物流部門以及13.7%來自IT部門。

本集團高度重視人才的發展及儲備，以支持可持續性發展。其為管理層及其他員工建立了完善的人才培養系統。本集團提供全方位的人才培養計劃，分別培養綜合管理、上游種植及市場運營各領域英才。

本集團已開發出一套績效評估系統，用來每年評估其僱員的表現，這構成了釐定僱員可能收取的薪酬水準、獎金及晉升的基準。銷售及營銷人員亦可根據彼等完成的銷售目標，經計及相關期間相同區域市場的門店整體銷售表現收取獎金。

於二零二三年，本集團產生的僱員福利開支總額為人民幣653.2百萬元，佔本集團同年總收入的約5.7%。

此外，本公司於二零二三年九月二十八日採納了一項股份獎勵計劃，以激勵或獎勵對本集團作出貢獻的合資格人員（包括對本集團作出突出貢獻的本集團經理級別或以上的管理人員及其他核心僱員及董事會認為合適的服務供應商）。

## EMPLOYEES AND EMPLOYEE BENEFIT EXPENSES

As of December 31, 2023, the Group had a total of 2,637 employees, among which approximately 18.7% were from marketing department, 15.7% were from operating and store management department, 20.4% were from production and logistics department and 13.7% were from IT department.

The Group attaches great importance to the development and retention of talents to support the sustainable growth. It has established a comprehensive talent training system for its management and other employees. It offers all-round talent training programs, respectively focusing on developing talents in various fields of general management, upstream planting and market operation.

The Group has developed a performance evaluation system to assess the performance of its employees annually, which forms the basis for determining the salary levels, bonuses and promotions an employee may receive. Sales and marketing personnel may also receive bonuses based on the sales targets they accomplish, by taking into account the overall sales performance of the stores in the same regional market in the relevant period.

In 2023, the Group incurred total employee benefit expenses of RMB653.2 million, representing approximately 5.7% of total revenue of the Group for the same year.

In addition, the Company adopted a share award scheme on September 28, 2023 to incentivize or reward eligible persons, including management personnel of the Group at manager level or above, other core employees who made outstanding contribution to the Group and service providers as the Board deems fit, for their contribution to the Group.

截至二零二三年十二月三十一日止年度，本集團最大客戶貢獻的收入佔本集團同年總收入的約1.7%，而其前五大客戶貢獻的總收入佔本集團同年總收入的約7.4%。前五大客戶包括三家加盟商和兩家區域代理。

### 儲備

截至二零二三年十二月三十一日，本公司可供分派予股東的儲備為約人民幣300.0百萬元。

### MAJOR SUPPLIERS AND MAJOR CUSTOMERS

For the year ended December 31, 2023, purchases from the Group's largest supplier in terms of dollar amount accounted for approximately 5.3% of total purchase cost of the Group for the same year, and the aggregate purchases from its top five suppliers in aggregate accounted for 19.0% of total purchase cost of the Group for the same year.

For the year ended December 31, 2023, revenue contributed by the Group's largest customer accounted for approximately 1.7% of total revenue of the Group for the same year, and the aggregate revenue contributed by its top five customers accounted for approximately 7.4% of total revenue of the Group for the same year. The top five customers include three franchisees and two regional dealers.

### RESERVES

As of December 31, 2023, the Company's reserves available for distribution to Shareholders amounted to approximately RMB300.0 million.

We are the largest fruit retail operator in China. On the one hand, based on the nationwide store network of over 6,000 stores, we provide consumers with high-quality fruits and fruit products through an integrated online and offline model, and also sell fruits directly to domestic and overseas enterprises and merchants through multiple channels. Analysis of the principal activities of the Group during the year ended December 31, 2023 is set out in the consolidated financial statements of the Report.

### 遵守法律及法規

截至二零二三年十二月三十一日止年度，據董事會所知，本集團已在所有重大方面遵守對本集團有重大影響的相關法律及法規。

### 主要風險及不確定因素

董事知悉本集團的財務狀況、經營業績、業務及前景可能受多項風險及不確定因素影響。主要風險及不確定因素可分類為(i)與我們的行業及業務有關的風險，及(ii)與在中國經營業務有關的風險。例如，我們業務很大程度取決於我們「百果園」及其他商標及品牌的市場認受性，對我們的商標、品牌或聲譽的任何損害，或未能有效推廣我們的品牌，都可能對我們的業務及經營業績產生重大不利影響；而加盟門店的表現對我們的經營業績產生重大影響，我們無法控制及可能無法有效監察該等門店的運營或維持我們與加盟商或區域代理的現有關係；極端天氣狀況、自然災害、農作物病蟲害及其他自然條件或突發事件可能導致我們業務及經營業績產生重大波動；未能維持食品安全及始終如一的質量可能會對我們的品牌、業務及財務表現造成重大不利影響；倘出現重大商譽及／或無形資產減值，則可能對我們的財務狀況及經營業績產生不利影響。

### COMPLIANCE WITH LAWS AND REGULATIONS

During the year ended December 31, 2023, as far as the Board is aware, the Group has complied with the relevant laws and regulations that have a significant impact on the Group in all material aspects.

### PRINCIPAL RISKS AND UNCERTAINTIES

The Directors are aware that the Group's financial condition, results of operations, businesses and prospects may be affected by a number of risks and uncertainties. The key risks and uncertainties can be categorized into (i) risks relating to our industry and business and (ii) risks relating to doing business in the PRC. For example, our business depends significantly on market recognition of our "Pagoda" and other trademarks and brands, and any damage to our trademarks, brand names or reputation, or any failure to effectively promote our brands, could materially and adversely impact our business and results of operations; while our results of operations are significantly subject to the store performance of our franchised stores, we cannot control and may not be able to effectively monitor the operations of these stores or maintain our current relationship with the franchisees or regional dealers; extreme weather conditions, natural disasters, crop diseases, pests and other natural conditions and other unexpected events may create substantial volatility for our business and results of operations; any failure to maintain food safety and consistent quality could have a material and adverse effect on our brands, business and financial performance; impairment of our goodwill and/or intangible assets, if material, could negatively affect our financial condition and results of operations.

The principal risks and uncertainties mentioned above are not exhaustive, for other risks and uncertainties faced by the Group, please refer to the section headed "Risk Factors" in the Prospectus.

The ESG Committee is responsible for guiding and reviewing the development and implementation of the Company's ESG vision and strategy; evaluating and identifying ESG-related risks and opportunities; paying attention to important information on ESG matters related to the Company's business; reviewing the Company's annual ESG report and reporting to the Board with recommendations; and coordinating with other specialized committees and the Company's management department to incorporate ESG into the areas of strategic planning, risk management, internal control, compensation and incentives, etc., and reporting to the Board on the results of ESG implementation and major plans.

### FINAL DIVIDEND

The Board has recommended the payment of a final dividend of RMB0.043 per ordinary share (tax inclusive) for the year ended December 31, 2023. The proposed final dividend shall be declared in RMB and paid to H Shareholders in Hong Kong dollars. The final dividend payable in Hong Kong dollars will be converted from RMB at the average exchange rate of RMB against the Hong Kong dollars issued by the People's Bank of China five business days before the forthcoming AGM, and the final dividend paid to the holders of unlisted shares of the Company will be paid in RMB. This proposed final dividend is subject to the approval of the Shareholders at the forthcoming AGM and is expected to be paid on or around Friday, July 19, 2024.

In accordance with the Enterprise Income Tax Law of the People's Republic of China and its implementation rules (the "EIT Law"), non-resident enterprises shall pay enterprise income tax on income derived from China, and the applicable tax rate is 10.0%. To this end, any H shares registered in the name of non-individual Shareholders, including HKSCC Nominees Limited, other nominees, trustees or other organizations and groups will be treated as being held by non-resident enterprise Shareholders (as defined in the EIT Law), and the Company will distribute the final dividend to such non-resident enterprise Shareholders after withholding such 10.0% enterprise income tax.

The Board is not aware that any shareholder of the Company has waived or agreed to waive any dividends.

## DIVIDEND POLICY

We may distribute dividends by way of cash or by other means that we consider appropriate, based on various factors such as our results of operations, cash flows, financial condition, statutory and regulatory restrictions on the payment of dividends by us, our capital requirements, future business plans and prospects and other factors that we may consider relevant. A decision to declare and pay any dividend would require the approval of the Board and will be at their discretion. In addition, any final dividend for a financial year will be subject to Shareholders' approval.

We have adopted a general annual dividend policy of declaring and paying dividends on an annual basis of no less than 20% of our distributable net profit for any particular year. The declaration and payment of dividends is subject to, among other things, our operational needs, earnings, financial condition, working capital requirements and future business plans as our Board may deem relevant at such time. There can be no assurance that we will be able to declare or distribute any dividend in the amount set out in any plan of the Board or at all.

As such, as at December 31, 2023, CICC Capital and CICC are deemed under the SFO to be interested in the aggregate of 9.87% of the total issued share capital of our Company held by Bole No. 1, Baima No. 4, Henan Zhanxin, CICC Haoze and Xinyu Unicorn.

Save as disclosed above, as at December 31, 2023, the Directors were not aware of any persons (who were not Directors, Supervisors or chief executive of the Company) who had interests or short positions in the Shares or underlying Shares which would fall to be disclosed to the Company under the provisions of Divisions 2 and 3 of Part XV of the SFO, or which would be required, pursuant to Section 336 of the SFO, to be entered in the register referred to therein.

### 二零二三年股份獎勵計劃

本公司已於二零二三年九月二十八日採納二零二三年股份獎勵計劃，以表彰若干合資格參與者對本集團作出的貢獻。二零二三年股份獎勵計劃的概要載於本公司日期為二零二三年九月十二日的通函。

#### 目的

二零二三年股份獎勵計劃的目的是：(i)使股東、本公司和員工的利益結合在一起，使其關注本公司戰略發展目標的實現；(ii)進一步完善本公司長效激勵機制；及(iii)吸引及挽留優秀人才，充分調動本集團高管團隊及核心骨幹人員的積極性，以及表彰對本集團有重大貢獻的人才或服務供應商。

#### 合資格參與者

二零二三年股份獎勵計劃的合資格參與者包括於本集團任職的經理級別或以上管理層人員、其他對本集團有突出貢獻的核心員工及服務提供商（定義見本公司日期為二零二三年九月十二日的通函），不包括於授出獎勵股份日期(i)為獨立非執行董事；(ii)於過去12個月被證券監管機構公開譴責或宣佈為不適當人選；(iii)最近12個月內因重大違法違規行為被證券監管機構予以行政處罰；(iv)根據中國公司法或上市規則的規定，不得擔任本公司董事或高級管理人員情形；(v)具有法律法規規定的禁止參與二零二三年股份獎勵計劃情形；(vi)有其他嚴重違反本集團有關規定或董事會認定的對本集團利益造成重大損害的行為；或(vii)董事會為維護本集團利益及確保遵守二零二三年股份獎勵計劃運作有關的適用法律及法規而規定的任何其他情形。

### 2023 SHARE AWARD SCHEME

The Company adopted the 2023 Share Award Scheme on September 28, 2023 as a means of recognizing the contributions made by certain eligible participants to the Group. A summary of the 2023 Share Award Scheme was set out in the circular of the Company dated September 12, 2023.

#### PURPOSES

The purposes of the 2023 Share Award Scheme are: (i) to align the interests of Shareholders, the Company and the employees, and bring their attention to the realization of the Company's strategic development goals; (ii) to further improve the Company's long-term incentive mechanism; and (iii) to attract and retain outstanding employees, fully motivate the management and core personnel of the Group, as well as to recognize significant contribution made by talents or Service Providers to the Group.

#### ELIGIBLE PARTICIPANTS

Eligible participants of the 2023 Share Award Scheme include any management personnel of the Group at manager level or above, other core employees who made outstanding contribution to the Group and Service Provider (as defined in the circular of the Company dated September 12, 2023) as the Board deems fit, excluding a person who, as at the date of the grant of Awarded Share(s) is to be made, (i) is an independent non-executive Director, (ii) has been publicly censured or declared as an ineligible candidate by securities regulatory institutions in the last 12 months; (iii) has been imposed with administrative penalties by securities regulatory institutions in the last 12 months due to material non-compliance of laws or regulations; (iv) is prohibited from acting as a Director or a member of the senior management of the Company as required by the PRC Company Law or the Listing Rules; (v) is prohibited from participating in the 2023 Share Award Scheme as required by laws and regulations; (vi) has committed other material violation of relevant requirements of the Group or caused material damage to the interest of the Group as determined by the Board; or (vii) any other circumstances prescribed by the Board for the purpose of safeguarding the Group's interests and ensuring the compliance of applicable laws and regulations relating to the operation of the 2023 Share Award Scheme.

**有效期**

二零二三年股份獎勵計劃的有效期為自其採納日期起計10年，惟董事會提早終止。

**計劃限額及可獲授上限**

於二零二三年股份獎勵計劃有效期內，根據二零二三年股份獎勵計劃可授出的獎勵股份最高數目不得超過本公司於二零二三年股份獎勵計劃採納日期已發行股本總額的5.0%，即79,427,200股H股，約佔本公司於本報告日期已發行股本總額的5.0%。

各受託人在整個存續期內根據二零二三年股份獎勵計劃可不時購買及持有的獎勵股份最高數目不得超過本公司於二零二三年股份獎勵計劃採納日期已發行H股股本總額的5.0%，即59,130,830股H股，佔本公司於本報告日期已發行股本總額的約3.7%。

除股東在股東大會上批准外，根據二零二三年股份獎勵計劃任何合資格參與者可獲得的獎勵股份總數不得超過本公司H股已發行股本的1%，即於本報告日期的11,826,166股H股。

**管理**

二零二三年股份獎勵計劃由董事會及／或其授權人士（包括董事會主席、董事會秘書、本公司委任以服務二零二三年股份獎勵計劃的受託人）根據二零二三年股份獎勵計劃的規則及本公司與上述受託人訂立的信託契據的條款進行管理。

**DURATION**

Unless early terminated by the Board, the 2023 Share Award Scheme shall be valid and effective for a term of 10 years commencing on its adoption date.

**SCHEME LIMITS AND MAXIMUM ENTITLEMENT**

The maximum number of Award Share(s) that can be granted under the 2023 Share Award Scheme throughout its duration of shall not exceed 5.0% of the total issued share capital of the Company as at the adoption date of the 2023 Share Award Scheme, being 79,427,200 H Shares, representing approximately 5.0% of the total issued share capital of the Company as at the date of the Report.

The maximum number of Award Share(s) that each trustee can acquire and hold from time to time under the 2023 Share Award Scheme throughout its duration shall not exceed 5.0% of the total issued share capital of the Company's H Shares as at the adoption date of the 2023 Share Award Scheme, being 59,130,830 H Shares, representing approximately 3.7% of the total issued share capital of the Company as at the date of the Report.

The aggregate number of Award Share(s) to be obtained by any eligible participant under the 2023 Share Award Scheme shall not exceed 1% of the total issued share capital of the Company's H Shares, being 11,826,166 H Shares as at the date of the Report, unless approved by the Shareholders at a general meeting.

**ADMINISTRATION**

The 2023 Share Award Scheme is subject to the administration of the Board and/or its delegatee, including the chairman of the Board, the secretary of the Board, trustee(s) appointed by the Company to service the 2023 Share Award Scheme, in accordance with the rules of the 2023 Share Award Scheme and terms of the trust deed(s) entered into between the Company and the aforementioned trustee(s).

二零二三年股份獎勵計劃由以下行政機構管理：

- (1) 股東大會。股東大會作為本公司的最高權力機構，負責考慮及批准採納、執行、修訂及終止二零二三年股份獎勵計劃。股東大會可授權董事會及／或其授權人士在其權限範圍內辦理與二零二三年股份獎勵計劃有關的相關事宜。
- (2) 董事會。董事會為二零二三年股份獎勵計劃的授權執行機構，負責二零二三年股份獎勵計劃的實施和管理。董事會或其授權人士可在股東大會授權範圍內辦理與二零二三年股份獎勵計劃的所有事宜。董事會還可以委託獨立第三方（如受託人）來協助管理二零二三年股份獎勵計劃。此外，薪酬委員會負責審議二零二三年股份獎勵計劃相關事宜（包括但不限於績效評估標準及程序），並向董事會提出建議以供其審議。董事會對有關二零二三年股份獎勵計劃的所有相關事務及相關條款的解讀擁有最終決定權。
- (3) 受託人。本公司（透過董事會及／或其授權人士）可委託一名或多名合資格代理擔任二零二三年股份獎勵計劃項下受託人，以幫助管理二零二三年股份獎勵計劃以及據此的獎勵股份的授予和歸屬。董事會及／或其授權人士將指示受託人透過公開市場購買H股作為二零二三年股份獎勵計劃的獎勵股份。

The 2023 Share Award Scheme shall be subject to the administration of the following administrative bodies:

- (1) *Shareholders' Meeting.* The general meeting of the Shareholders, as the highest organ of authority of the Company, is responsible for the consideration and approval of the adoption, execution, amendment and termination of the 2023 Share Award Scheme. The general meeting of the Shareholders may authorize the Board and/or its delegatee to deal with relevant matters pertaining to the 2023 Share Award Scheme to the extent of its authority.
- (2) *The Board.* The Board is the executive body of authority of the 2023 Share Award Scheme, in charge of the execution and administration of the 2023 Share Award Scheme. The Board or its delegatee may handle all matters pertaining to the 2023 Share Award Scheme within the authorization by the general meeting of the Shareholders. The Board may also delegate independent third party, such as a trustee, to assist with the administration of the 2023 Share Award Scheme. In addition, the Remuneration Committee is responsible for the review of relevant matters pertaining to the 2023 Share Award Scheme (including but not limited to performance appraisal criteria and procedures) and makes recommendation to the Board for consideration. The Board's decisions on all relevant matters relating to the 2023 Share Award Scheme and its interpretation on the terms of the 2023 Share Award Scheme are final.
- (3) *The Trustee(s).* The Company, through the Board and/or its delegatee, may entrust one or more qualified agent(s) to act as the trustee(s) under the 2023 Share Award Scheme to assist with the administration of the 2023 Share Award Scheme as well as the granting and vesting of the Award Share(s) in accordance therewith. The Board and/or its delegatee may instruct the trustee(s) to purchase H Shares through open market as the Award Share(s) for the 2023 Share Award Scheme.

**授予價格**

董事會將參考H股的市場交易價格釐定獎勵所涉每股獎勵股份的授予價格，而有關授予價格不得超過緊接授出日期前120個聯交所普通交易日H股平均收市價的10.0%。

**股份獎勵協議**

於確認授出獎勵後，本公司與參與者須簽署股份獎勵協議，當中須載列（其中包括）參與者（作為承授人）的姓名、作為獎勵股份將予授出的H股數目及其歸屬條件及歸屬時間表、授予價格以及董事會釐定與二零二三年股份獎勵計劃的規則不一致的其他條款及條件。

**GRANT PRICE**

The Board shall determine the grant price of each Award Share underlying the Award(s) with reference to the market trading price of the H Shares and such grant price shall not be more than 10.0% of the average closing price of the H Shares in the 120 ordinary trading days of the Stock Exchange immediately prior to the Grant Date.

**SHARE AWARD AGREEMENTS**

Once the grant of the Award(s) is confirmed, the Company and the participant shall sign a share award agreement which shall set out, among others, the name of the participant (as the grantee), number of H Shares to be granted as Award Share(s) and their vesting conditions and vesting schedule, the grant price as well as other terms and conditions that are not consistent with the rules of the 2023 Share Award Scheme as decided by the Board.

**VESTING OF AWARDED SHARE(S)**

The Board shall determine the vesting schedule, including the vesting time and vesting percentage, in respect of Award Share(s) underlying the award(s) and details of which shall be set out in the abovementioned share award agreement.

Within a reasonable time after the vesting conditions and schedule have been reached, fulfilled, satisfied or waived, the Board or its delegatee shall send the vesting notice to each of the relevant participants. The vesting notice will confirm the extent to which the vesting conditions and schedule have been reached, fulfilled, satisfied or waived, and the number of Award Share(s) to be vested for that relevant vesting period (and, if applicable, the cash or non-cash income, dividends or distributions and/or the sale proceeds of non-cash and non-scrip distributions in respect of those Award Share(s)).

### 投票權及股息

參與者或獲本公司委任為二零二三年股份獎勵計劃項下設立的信託服務的受託人，均不得行使相關受託人於相關信託項下持有的任何H股（包括任何未歸屬H股）所附帶的任何投票權。根據二零二三年股份獎勵計劃持有未歸屬H股的受託人，除非法律另行規定須根據實益擁有人的指示投票且該指示已發出，否則應當按照上市規則就須經股東批准的事項放棄投票。

倘獎勵（失效的獎勵除外）未歸屬，就未歸屬獎勵相關的獎勵股份支付的任何股息應屬於參與者，並於歸屬時支付予參與者。

### 可供授出獎勵股份

自於二零二三年九月二十八日採納二零二三年股份獎勵計劃起至二零二三年十二月三十一日及直至本報告日期，本公司概無授出任何獎勵，亦無任何獎勵根據二零二三年股份獎勵計劃獲歸屬、註銷或失效，且於上述日期，並無根據二零二三年股份獎勵計劃尚未行使的獎勵。因此，於二零二三年九月二十八日及二零二三年十二月三十一日，根據二零二三年股份獎勵計劃可供授出的獎勵股份數目為79,427,200股H股，佔本公司於二零二三年十二月三十一日已發行股本總額的5.0%。於本報告日期，二零二三年股份獎勵計劃的剩餘年期約為九年七個月。

本公司已分別委任中誠信託有限責任公司和中航信託股份有限公司為二零二三年股份獎勵計劃的受託人。中誠信託有限責任公司和中航信託股份有限公司為根據中國境內法律成立的信託公司，且為獨立第三方，與本公司及／或其關連人士並無關連。

自二零二三年九月二十八日至二零二三年十二月三十一日，受託人按照董事會的指示通過公開市場購買了合共66,701,500股H股，約佔本公司於二零二三年十二月三十一日已發行股本總額的4.2%。受託人根據二零二三年股份獎勵計劃的規則及本公司與受託人訂立的信託契約的條款持有該等H股。

### VOTING RIGHTS AND DIVIDENDS

Neither the participant nor the trustee(s) appointed by the Company to service the trust(s) established under the 2023 Share Award Scheme may exercise any voting rights attached to any H Shares (including any unvested H Shares) held by such trustee(s) under such trust(s). The trustee(s) holding unvested H Shares under the 2023 Share Award Scheme shall abstain from voting on matters requiring the consent of the Shareholders in accordance with the Listing Rules, unless otherwise required by law to vote in accordance with the beneficial owner's direction and such a direction is given.

Any dividends paid to the Award Share(s) underlying the Award(s) shall belong to the participants when the Award(s) are yet to be vested (except for those Award(s) that are forfeited) and be paid to the participants at the time of vesting.

### AWARD SHARE(S) AVAILABLE FOR GRANT

Since the adoption of the 2023 Share Award Scheme on September 28, 2023 to December 31, 2023 and up to the date of the Report, no award was granted by the Company, nor any award was vested, cancelled or lapsed under the 2023 Share Award Scheme, and there was no award outstanding under the 2023 Share Award Scheme as at the above date. Therefore, as at September 28, 2023 and December 31, 2023, the number of Award Share(s) available for grant under the 2023 Share Award Scheme is 79,427,200 H Shares, representing 5.0% of the total issued share capital of the Company as at December 31, 2023. As at the date of the Report, the remaining life of the 2023 Share Award Scheme is approximately nine years and seven months.

The Company has appointed Zhongcheng Trust Co., Ltd. and Zhonghang Trust Co., Ltd. as the trustees for the 2023 Share Award Scheme. Each of Zhongcheng Trust Co., Ltd. and Zhonghang Trust Co., Ltd. is a trust company established in accordance with the PRC laws and a third party independent of the Company and/or its connected persons.

From September 28, 2023 to December 31, 2023, the trustees, as instructed by the Board, purchased a total of 66,701,500 H Shares, representing approximately 4.2% of the total issued share capital of the Company as at December 31, 2023, through the open market. The trustees hold these H Shares in accordance with the rules of the 2023 Share Award Scheme and terms of the trust deeds entered into between the Company and the trustees.

## 關連交易

### 概覽

根據上市規則的規定，本公司與其關連人士（定義見上市規則第14A章）之間的交易構成本公司的關連交易或持續關連交易。本公司根據上市規則及所有其他適用法律及法規監管及管理該等交易。

### 相關關連人士

方舜真女士於十二個月內曾擔任海陽津成泰的董事，因此為本公司的關連人士。單基球先生為方舜真女士的配偶，因此，其為本公司聯繫人（定義見上市規則第14A章）及關連人士。

此外，(a)方舜真女士(i)控制於FRECO Asia Co., Ltd.（「**FRECO**」）股東大會上行使49%的投票權；(ii)控制於成記欄有限公司（「**成記欄**」）股東大會上行使50%的投票權；及(iii)控制山東良枝農業科技有限公司（「**山東良枝**」）股東大會上行使55%的投票權；及(b)單基球先生(i)控制於世紀環球私人有限公司（「**世紀環球**」）股東大會上行使50%投票權；(ii)控制於成記欄股東大會上行使50%投票權；(iii)控制於山東匯果農業發展有限公司股東大會上行使35%投票權（「**山東匯果**」）。因此，FRECO、世紀環球、成記欄、山東良枝及山東匯果均為本公司的關連人士。

深圳市天圖東峰中小微企業股權投資基金合夥企業（有限合夥）（「**深圳天圖東峰**」）及海南天圖興周創業投資合夥企業（有限合夥）（「**海南天圖**」）均由其普通合夥人深圳天圖資本管理中心（有限合夥）全權控制及管理，而深圳天圖資本管理中心（有限合夥）則由本公司主要股東深圳市天圖投資管理股份有限公司（「**天圖投資**」）最終全資擁有。因此，深圳天圖東峰及海南天圖各自為天圖投資的聯繫人，故為本公司的關連人士。

## CONNECTED TRANSACTIONS OVERVIEW

Pursuant to the requirements of the Listing Rules, the transactions between the Company and its connected persons (as defined under Chapter 14A of the Listing Rules) constitute connected transactions or continuing connected transactions of the Company. The Company regulates and manages such transactions in compliance with the Listing Rules and all other applicable laws and regulations.

### RELEVANT CONNECTED PERSONS

Ms. Fong Shun Chun (方舜真) was a director of Haiyang Jinchengtai within 12 months and hence a connected person of the Company. Mr. Sin Kei Kau (單基球) is the spouse of Ms. Fong Shun Chun, and hence an associate (as defined under Chapter 14A of the Listing Rules) and a connected person of the Company.

In addition, (a) Ms. Fong Shun Chun (i) controls the exercise of 49% of the voting power at the general meeting of FRECO Asia Co., Ltd. (“**FRECO**”), (ii) controls exercise of 50% of the voting power at the general meeting of Shing Kee Lan Co., Ltd. (成記欄有限公司) (“**Shing Kee Lan**”), and (iii) controls exercise of 55% of the voting power at the general meeting of Shandong Liangzhi Agricultural Technology Co., Ltd.\* (山東良枝農業科技有限公司) (“**Shandong Liangzhi**”); and (b) Mr. Sin Kei Kau (i) controls exercise of 50% of the voting power at the general meeting of Century Global PTE Ltd. (“**Century Global**”), (ii) controls exercise of 50% of the voting power at the general meeting of Shing Kee Lan, (iii) controls exercise of 35% of the voting power at the general meeting of Shandong Huiguo Agricultural Development Co., Ltd.\* (山東匯果農業發展有限公司) (“**Shandong Huiguo**”). Therefore, each of FRECO, Century Global, Shing Kee Lan, Shandong Liangzhi and Shandong Huiguo is a connected person of the Company.

Each of Shenzhen Tiantu Dongfeng Small, Medium and Micro Enterprise Equity Investment Fund Partnership (Limited Partnership)\* (深圳市天圖東峰中小微企業股權投資基金合夥企業（有限合夥）) (“**Shenzhen Tiantu Dongfeng**”) and Hainan Tiantu Xingzhou Venture Capital Partnership (Limited Partnership)\* (海南天圖興周創業投資合夥企業（有限合夥）) (“**Hainan Tiantu**”) is fully controlled and managed by its general partner, Shenzhen Tiantu Capital Management Center Limited Partnership\* (深圳天圖資本管理中心（有限合夥）), which is in turn ultimately wholly owned by Tian Tu Capital Co., Ltd. (深圳市天圖投資管理股份有限公司) (“**Tiantu Capital**”), a substantial shareholder of the Company. As such, each of Shenzhen Tiantu Dongfeng and Hainan Tiantu is an associate of Tiantu Capital and therefore a connected person of the Company.

## (a) 與FRECO、世紀環球及成記欄訂立的銷售框架協議

於二零二二年十二月二十日，本公司（為其本身及作為其附屬公司的受託人）與FRECO、世紀環球及成記欄各自訂立銷售框架協議（統稱「銷售框架協議」），據此，本集團同意按大致相同的條款向FRECO、世紀環球及成記欄各自銷售指定水果，期限自上市日期起至二零二四年十二月三十一日止，惟另行重續則除外。

## 定價政策

本集團向FRECO、世紀環球及成記欄供應指定水果的售價乃參考：(i)相關交易前十二個月內獲獨立第三方接納且性質及規模相當的產品的平均售價；(ii)倘無法得出平均售價，則由本集團提供獲獨立第三方接納且性質及規模相當的產品的任何最新可得售價；或(iii)性質及規模相當的產品的現行市場售價，在任何情況下對本集團的價格均不得遜於獨立第三方可得的價格，並經公平磋商後釐定。董事認為，交易乃按正常商業條款進行，且符合本公司及股東的整體利益。

FRECO, Century Global and Shing Kee Lan are long term and/or reliable corporate customers of Haiyang Chiang Mai Thai Agri-products Co., Ltd.\* (海陽津成泰農產品發展有限公司) (“**Haiyang Jinchengtai**”), which became a wholly-owned subsidiary of the Company in March 2019. ## 非完全豁免持續關連交易的豁免申請

由於(i)FRECO、世紀環球、成記欄、山東匯果及山東良枝均通過關聯方(即方舜真女士及單基球先生(方舜真女士配偶))互相關連,及(ii)根據保理框架協議提供的保理服務與採購框架協議項下的採購金額有關,董事認為上述(a)、(b)、(c)、(d)及(e)項下的交易應按照上市規則第14A.81條及第14A.82(1)條合併計算,並視為一項交易。因此,銷售框架協議、採購框架協議、供應框架協議、保理框架協議及服務框架協議項下擬進行交易的年度上限已合併計算,並在根據上市規則第14章計算相關百分比率時使用該總額。

Accordingly, the annual caps in respect of the transactions contemplated under the Sales Framework Agreements, the Procurement Framework Agreements, the Supply Framework Agreements, the Factoring Framework Agreements and the Service Framework Agreements are aggregated, and such aggregate amount is used when calculating the relevant percentage ratios under Chapter 14 of the Listing Rules.

As the highest applicable percentage ratio under all of the above agreements is expected to be more than 0.1% but less than 5% on an annual basis, the transactions contemplated therein will constitute continuing connected transactions of our Company and will be exempted from the circular (including independent financial advice) and independent shareholders' approval requirements, but subject to the annual reporting and announcement requirements under Chapter 14A of the Listing Rules.

As the above non-exempt continuing connected transactions are expected to continue a recurring and continuing basis, our Directors consider that compliance with the above announcement requirements will be impractical, will incur unnecessary administrative costs for us, and will be unduly burdensome to us. Accordingly, we have applied to the Stock Exchange for, and the Stock Exchange has granted, a waiver to us under Rule 14A.105 of the Listing Rules from compliance with the announcement requirements in respect of the above non-exempt continuing connected transactions.

Pursuant to Rule 14A.56 of the Listing Rules, the Company's external auditor, PricewaterhouseCoopers, was engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standards on Assurance Engagements 3000 (Revised) "Assurance Engagements Other than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 (Revised) "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. PricewaterhouseCoopers has issued an unmodified letter containing findings and conclusions in respect of the above continuing connected transactions (a) to (e) as disclosed by the Group in accordance with Rule 14A.56 of the Listing Rules.

## (a) 收購於深圳般果的股權

於二零二三年十月十日，百果園投資與深圳天圖東峰訂立股權轉讓協議（「**股權轉讓協議**」），據此，深圳天圖東峰同意出售而百果園投資同意購買深圳般果約19.58%的股權（相當於註冊資本人民幣3,975,345元），現金代價為人民幣14,376,591元。

於股權轉讓協議項下擬進行的股權轉讓完成後，深圳般果將成為本公司的間接附屬公司（由百果園投資擁有約51.00%的權益），其財務業績將併入本公司的財務報表。

## 進行交易的理由

深圳般果主要從事向小型企業提供採購平台，該等企業通常由家庭經營（如自有水果店及獨立便利店），並無成熟的供應鏈系統，因此彼等難以採購具成本效益的產品及缺乏議價能力。進一步收購深圳般果的股權並將其財務業績併入本公司的財務報表，將為本公司及深圳般果的業務帶來戰略協同效應，從而進一步提升本集團的整體供應鏈能力及本集團向2B（企業對企業）消費者供應水果的市場份額。此外，相信中國小型企業對綜合採購平台供應商的潛在需求在產生流動資金及提供週轉更快、成本更低的健康水果供應鏈方面具有重大商業價值。

## NON-EXEMPT ONE-OFF CONNECTED TRANSACTIONS

Below set out the details of non-exempt one-off connected transactions conducted by the Group during the Reporting Period.

## (a) ACQUISITION OF EQUITY INTEREST IN SHENZHEN BANGUO

On October 10, 2023, Pagoda Investment and Shenzhen Tiantu Dongfeng entered into an equity transfer agreement (the “**Equity Transfer Agreement**”), pursuant to which Shenzhen Tiantu Dongfeng agreed to sell and Pagoda Investment agreed to acquire approximately 19.58% of equity interest (equivalent to registered capital of RMB3,975,345) in Shenzhen Banguo at a cash consideration of RMB14,376,591.

Upon completion of the equity transfer as contemplated under the Equity Transfer Agreement, Shenzhen Banguo will become an indirect subsidiary of the Company (owned as to approximately 51.00% by Pagoda Investment) and its financial results will be consolidated into the financial statements of the Company.

## REASONS FOR THE TRANSACTION

Shenzhen Banguo is principally engaged in the provision of procurement platform to small business enterprises which are typically operated by family (such as self-owned fruit stores and independent convenience stores) without an established supply chain system and therefore they have difficulty in procuring cost-effective products and are lack of bargaining power. Further acquisition of equity interest in Shenzhen Banguo and consolidating its financial results into the Company's financial statements will bring strategic synergies to the business of the Company and Shenzhen Banguo, which will further enhance the supply chain capabilities of the Group as a whole and the Group's market share of fruits supply to 2B (business-to-business) consumers. In addition, it is believed that the potential needs of the small business enterprises in China for an integrated procurement platform provider is of significant commercial value in terms of generating liquidities and providing a healthy fruit supply chain with faster turnover and lower costs.

### (b) 視作出售海南三個零的股權

於二零二三年十月十日，百果園投資、深圳三個零共創企業管理中心(有限合夥)(「三個零共創有限合夥」)、深圳三個零弘善企業管理中心(有限合夥)(「三個零弘善有限合夥」)、智心百農、海南天圖、海南三個零農業科技發展有限公司(「海南三個零」)及余惠勇先生訂立一項投資協議(「投資協議」)，據此，海南天圖同意以現金方式向海南三個零注資人民幣22.00百萬元，其中人民幣12.76百萬元將注入海南三個零的註冊資本，人民幣9.24百萬元將計入海南三個零的資本公積。

於投資協議項下擬進行的注資前，海南三個零由本公司(透過百果園投資、三個零共創有限合夥及三個零弘善有限合夥)擁有約68.97%及由智心百農(獨立第三方)擁有31.03%。注資完成後，海南天圖將持有海南三個零經擴大註冊資本總額約18.03%，而本公司(透過百果園投資、三個零共創有限合夥及三個零弘善有限合夥)及智心百農於海南三個零的持股比例將分別相應攤薄至約56.53%及25.44%；及海南三個零將繼續為本公司的附屬公司。

### (b) DEEMED DISPOSAL OF EQUITY INTEREST IN HAINAN SANGELING

On October 10, 2023, Pagoda Investment, Shenzhen Sangeling Gongchuang Enterprise Management Center Partnership (Limited Partnership) (深圳三個零共創企業管理中心(有限合夥)) (“**Sangeling Gongchuang LLP**”), Shenzhen Sangeling Hongshan Enterprise Management Center Partnership (Limited Partnership) (深圳三個零弘善企業管理中心(有限合夥)) (“**Sangeling Hongshan LLP**”), Zhixin Bainong, Hainan Tiantu, Hainan Sangeling Agricultural Technology Development Co., Ltd.\* (海南三個零農業科技發展有限公司) (“**Hainan Sangeling**”) and Mr. YU Huiyong entered into an investment agreement (the “**Investment Agreement**”), pursuant to which Hainan Tiantu agreed to inject RMB22.00 million into the capital of Hainan Sangeling by way of cash, of which RMB12.76 million will be contributed to the registered capital of Hainan Sangeling and RMB9.24 million will be credited to the capital reserve of Hainan Sangeling.

Prior to the capital injection as contemplated under the Investment Agreement, Hainan Sangeling was owned as to approximately 68.97% by the Company (through Pagoda Investment, Sangeling Gongchuang LLP and Sangeling Hongshan LLP) and 31.03% by Zhixin Bainong, being an independent third party. Upon completion of the capital injection, Hainan Tiantu will hold approximately 18.03% of the total enlarged registered capital of Hainan Sangeling, and the shareholding of the Company (through Pagoda Investment, Sangeling Gongchuang LLP and Sangeling Hongshan LLP) and Zhixin Bainong in Hainan Sangeling will correspondingly be diluted to approximately 56.53% and 25.44%, respectively; and Hainan Sangeling will continue to be a subsidiary of the Company.

The capital injection made by Hainan Tiantu into Hainan Sangeling will enable Hainan Sangeling to finance its further enhancement on its supply chain capabilities in the agricultural industry as well as to satisfy the expected capital needs for its plan to become a high quality vegetable brand. In addition, Tiantu Capital (the ultimate controller of Hainan Tiantu) is a market leading investor in the consumer industry and their capital investment and professional perspectives on branding and consumption activities analysis will benefit Hainan Sangeling's branding strategy and continuous development, which in turn will benefit the Group in the long run.

## 董事於競爭業務之權益

海南勝傑為一家中國有限責任公司，專注於從事瓜類種植業務，截至本報告日期，由本公司持有30%的權益，張葵傑先生持有63%的權益及其他兩名個人獨立第三方持有7%的權益。上海牛果為一家中國有限責任公司，專注於從事牛油果熟化及銷售，截至本報告日期由本公司持有26.28%的權益，以及由獨立第三方上海集友農產品有限公司（一家農產品零售商）及Mission Produce Asia Limited（一家優質牛油果供應商）分別持有40.39%及33.33%的權益。

## NON-COMPETITION UNDERTAKING

On December 20, 2022, each of Mr. YU Huiyong, Ms. XU Yanlin and Mr. TIAN Xiqiu entered into a deed of non-competition (the “Undertakings”) in favor of the Company (for itself and as trustee for its subsidiaries) pursuant to which, each of Mr. YU Huiyong, Ms. XU Yanlin and Mr. TIAN Xiqiu has, among other things, irrevocably and unconditionally undertaken to the Company that he/she/it will not, and will procure his/her/its close associates not to compete with the Group’s business. The Undertakings has taken effective since Listing Date. Details of the Undertakings are set out in the section headed “Relationship with Our Controlling Shareholders – Deeds of Non-Competition” in the Prospectus.

The independent non-executive Directors have reviewed the status of compliance and the annual confirmation provided by each of Mr. YU Huiyong, Ms. XU Yanlin and Mr. TIAN Xiqiu as part of the annual review process. During the Reporting Period, none of, any Mr. YU Huiyong, Ms. XU Yanlin and Mr. TIAN Xiqiu has reported any competing business and there has been no particular situation rendering the compliance of the Undertakings being questionable.

## DIRECTORS’ INTEREST IN COMPETING BUSINESS

Hainan Shengjie is a PRC-based limited liability company with a focus on the growing business of melons and as of the date of this report, was owned as to 30% by our Company, 63% by Mr. Zhang Kuijie (張葵傑) and 7% by two other individuals, who are all independent third parties. Shanghai Niuguo is a PRC-based limited liability company focusing on the avocado ripening and sales and as of the date of this report, was owned as to 26.28% by our Company, 40.39% by Shanghai Jiyou Agricultural Products Co., Ltd.\* (上海集友農產品有限公司) (an agricultural product retailer) and 33.33% by Mission Produce Asia Limited (a high-quality supplier of avocados), who are all independent third parties.

Hainan Shengjie is ultimately controlled and managed by Mr. Zhang Kuijie, the single largest shareholder and chairman of the board of Hainan Shengjie. Shanghai Niuguo is managed by Mr. John Jiang Tao Wang, chairman of the board of Shanghai Niuguo. Mr. Zhu is and will continue to be primarily involved in the day-to-day procurement, wholesale and sales-related matters of our Group.

Save as disclosed above, during the Reporting Period, none of the Directors or their respective associates (as defined under the Listing Rules) had engaged in or had any interest in any business which competes or may compete, either directly or indirectly, with the business of the Group which would require disclosure under Rule 8.10 of the Listing Rules.

### PERMITTED INDEMNITY PROVISIONS

Pursuant to the Articles of Association and subject to the applicable laws, the Company has arranged for appropriate insurance to cover all costs, charges, losses, expenses and liabilities incurred by any Directors, Supervisors or senior management in the execution and discharge of his/her duties or in relation thereto. The relevant provisions in the Articles of Association and such directors, supervisors and senior management liability insurance were in force for the year ended December 31, 2023 and as of the date of this report.

### PUBLIC FLOAT

As of the date of this report, based on the information publicly available to the Company and to the best knowledge of its Directors, the Company has maintained sufficient public float as required under the Listing Rules since the Listing Date and up to the date of this report. The Company maintained the minimum level of public float of at least 25% of its total registered share capital.

於本報告日期，除上文所披露者外，於二零二三年十二月三十一日後並無發生影響本集團的重大事件。

## LEGAL PROCEEDINGS AND COMPLIANCE

The Group may from time to time be involved in various legal procedures, arbitrations or proceedings in the course of its ordinary business. During the Reporting Period, the Group was not involved in any legal procedures, arbitrations or proceedings that we believe would have a material adverse effect on the ordinary business, financial condition or business performance.

The Group's business operations are subject to applicable PRC laws and regulations. During the Reporting Period, the Group has not been involved in, nor does it involve in any non-compliance incidents resulting in fines, enforcement actions or other penalties that may individually or collectively have a material adverse impact on the Group's business, financial condition or operating performance, and the Group has complied with applicable laws and regulations in all material respects.

## SUBSEQUENT EVENTS

The following significant events took place subsequent to December 31, 2023:

(a) during the year ended December 31, 2023, Guangdong Pagoda Agricultural Products Preliminary Processing Co., Ltd. ("Pagoda Preliminary Processing"), a wholly-owned subsidiary of the Company, as the defendant, received a notice of acceptance of case from The People's Court of Tianhe District (the "Court") in relation to the financial contract disputes with a domestic bank (the "Plaintiff") of approximately RMB20.0 million. On March 19, 2024, the Court ruled that it did not support the lawsuit initiated by the Plaintiff and rejected the Plaintiff's claim against Pagoda Preliminary Processing.

As at the date of this report, save as disclosed above, there was no significant event affecting the Group which occurred after December 31, 2023.

The board of Supervisors worked actively, supervised the regulatory compliance and operation, financial condition, acquisition and sale of the Company's assets, internal control, related party transactions and guarantee provided by the Company to external parties of the Company through attending Shareholders' general meetings and Board meetings and audit and inspection center as non-voting delegates and onsite inspections. The board of Supervisors has arrived at the following opinions:

Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee, the Nomination Committee, the Strategic Committee and the ESG Committee.

As regards the code provision under the CG Code requiring directors to disclose the number and nature of offices held in public companies or organizations and other significant commitments as well as their identity and the time involved to the issuer, the Directors have agreed to disclose their commitments to the Company in a timely manner.

## 獨立意見及建議

董事會已建立機制以確保董事會可獲得獨立意見及建議。董事會確保委任至少三名獨立非執行董事，且至少三分之一的成員為獨立非執行董事。此外，獨立非執行董事將根據上市規則的規定在切實可行的情況下委任加入董事委員會，以確保獲得獨立意見及建議。提名委員會嚴格遵守上市規則所載有關提名及委任獨立非執行董事的獨立性評估標準，並須每年評估獨立非執行董事的獨立性，以確保彼等可持續行使獨立判斷。概無向獨立非執行董事授予與表現掛鈎的以股權為基礎的薪酬，因為此舉可能導致其決策有所偏頗，並損害其客觀性及獨立性。最後，於合約或安排中擁有重大權益的董事（包括獨立非執行董事）不得就批准該合約或安排的任何董事會決議案投票或計入法定人數。

此外，本公司亦透過正式及非正式途徑建立渠道，據此，獨立非執行董事可在有需要的情況下以公開、坦誠及保密的方式發表意見。該等渠道包括定期董事會調查及董事會檢討、與董事會主席舉行專門會議及與本公司管理層及其他董事會成員（包括董事會主席）進行互動。

董事會已審閱上述已實施的機制並認為該等機制於自二零二三年一月十六日起至二零二三年十二月三十一日止期間有效。

## INDEPENDENT VIEWS AND INPUT

The Board has established mechanisms to ensure independent views and input are available to the Board. The Board ensures the appointment of at least three independent non-executive Directors and at least one-third of its members being independent non-executive directors. Further, independent non-executive directors will be appointed to the Board Committees as required under the Listing Rules and as far as practicable to ensure independent views and input are available. The Nomination Committee strictly adheres to the independence assessment criteria as set out in the Listing Rules with regard to the nomination and appointment of independent non-executive Directors, and is mandated to assess annually the independence of independent non-executive Directors to ensure that they can continually exercise independent judgement. No equity-based remuneration with performance-related elements will be granted to independent non-executive Directors as this may lead to bias in their decision-making and compromise their objectivity and independence. Last, a Director (including independent non-executive Director) who has a material interest in a contract or arrangement shall not vote or be counted in the quorum on any Board resolution approving the same.

In addition, the Company also established channels through formal and informal means whereby independent non-executive Directors can express their views in an open and candid manner as well as in a confidential manner, should circumstances required. Such channels include regular Board surveys and Board reviews, dedicated meeting sessions with the chairman of the Board and interaction with the management of the Company and other Board members including the chairman outside the boardroom.

The Board has reviewed the above mechanisms implemented and considered such mechanisms were effective during the period from January 16, 2023 to December 31, 2023.

### 董事會多元化政策

為提升董事會的效率及維持高標準的企業管治，我們已於二零二二年十二月二十日採納董事會多元化政策（「**董事會多元化政策**」），當中載列實現及維持董事會多元化的目標及方法。根據董事會多元化政策，我們力求通過考慮多項因素實現董事會多元化，包括但不限於專業經驗、技能、知識、性別、年齡、文化及教育背景、種族及服務年期以及作為本公司董事所投入的時間。

本公司亦將不時考慮與其自身業務模式及特定需要的因素。本公司明白並深信董事會成員多元化裨益良多，並認為董事會層面日益多元化（包括性別多元化）乃維持本公司競爭優勢及提升其從最廣泛可用人才庫吸引、挽留及激勵僱員的能力的關鍵元素。

於報告期間，本公司十二名董事在投資、會計、管理、法律、教育和生鮮及水果等不同行業和實踐方面擁有均衡的知識、技能及經驗。彼等已獲得多個專業學位證書，包括經濟、商業管理、會計、法律及園藝學。我們擁有五位具有不同行業背景的獨立非執行董事，佔董事會成員三分之一以上。此外，董事會成員年齡層跨度較大，介乎35歲至68歲。我們已採取措施並將繼續採取措施促進本公司各級性別多元化，包括但不限於董事會和管理層。目前，董事會兩名成員為女性。儘管我們認識到董事會的性別多元化可以改善，但我們將繼續參照董事會多元化政策採用任人唯賢的原則。

### BOARD DIVERSITY POLICY

To enhance the effectiveness of the Board and to maintain the high standard of corporate governance, we have adopted the board diversity policy (the “**Board Diversity Policy**”) on December 20, 2022, which sets out the objective and approach to achieve and maintain diversity of our Board. Pursuant to Board Diversity Policy, we seek to achieve board diversity by taking into consideration of various factors, including but not limited to professional experience, skills, knowledge, gender, age, cultural and education background, ethnicity and length of service and the time to be devoted as a director of the Company.

The Company will also take into account factors relating to its own business model and specific needs from time to time. The Company recognizes and embraces the benefits of having a diverse Board and sees increasing diversity at the Board level, including gender diversity, as an essential element in maintaining the Company’s competitive advantage and enhancing its ability to attract, retain and motivate employees from the widest possible pool of available talent.

During the Reporting Period, the twelve Directors of the Company have a balanced mix of knowledge, skills and experience, of various industries and practices covering investment, accounting, management, legal, education and fresh and fruit industries. They obtained academic degrees in various majors, including economics, business administration, accounting, law and horticulture. We have five independent non-executive Directors with different industry backgrounds, representing more than one-third of the members of the Board. Furthermore, the Board has a wide range of age, ranging from 35 years old to 68 years old. We have also taken, and will continue to take steps to promote gender diversity at all levels of our Company, including but not limited to the Board and the management levels. Currently, two members of the Board are female. While we recognize that the gender diversity at the Board can be improved, we will continue to apply the principle of appointments based on merits with reference to our Board Diversity Policy.

本公司鼓勵董事參與持續專業發展，以發展及更新其知識及技能。本公司不時更新及向董事提供有關彼等角色、職能及職責的書面培訓材料。

The Nomination Committee is responsible for ensuring the diversity of our Board members and compliance with relevant codes governing board diversity under the CG Code. Our Nomination Committee will review and revisit the Board Diversity Policy and our diversity profile (including gender balance) at least once annually to ensure its continued effectiveness and discuss any revisions that may be required, and recommend any such revisions to our Board for consideration and approval. We will also disclose in our corporate governance report about the implementation of the Board Diversity Policy on an annual basis.

For details on the Company's gender ratio in the workforce (including senior management), its plans or measurable objectives for achieving gender diversity across the workforce (including senior management) are set out in the Company's environmental, social and governance report for the year ended December 31, 2023 published on the website of the Company and on the website of the Stock Exchange.

## TRAINING AND CONTINUOUS PROFESSIONAL DEVELOPMENT

Each newly appointed Directors would be provided with necessary induction and information to ensure that he/she has a proper understanding of the Company's operations and businesses as well as his/her responsibilities under relevant statutes, laws, rules and regulations. The Company also arranges regular seminars to provide the Directors with updates on the latest development and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. The Directors are also provided with regular updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties.

Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The Company have from time to time updated and provided the Directors with written training materials in relation to their roles, functions and duties.

## 獨立非執行董事

董事會符合上市規則有關委任至少三名獨立非執行董事（佔董事會成員人數三分之一，其中一名獨立非執行董事擁有適當的專業資格或會計或相關財務管理專業知識）及至少一名獨立非執行董事須常駐香港的規定。

本公司已接獲各獨立非執行董事根據上市規則第3.13條所載獨立性指引就其獨立性發出的年度確認書。本公司認為所有獨立非執行董事均為獨立人士。

## 委任及重選董事

各執行董事、非執行董事及獨立非執行董事已與本公司訂立服務合約或委任書，固定任期自各自委任日期至下一屆董事會換屆選舉的股東大會召開為止。

董事應由股東大會選舉產生，每屆任期三年。董事由股東大會選舉或更換，任期三年。董事任期屆滿，可連選連任。董事任期屆滿未及時改選，在改選出的董事就任前，原董事仍應當依照相關法律、行政法規、部門規章、上市規則和章程的規定，履行董事職務。

委任、重選及罷免董事的程序及過程載於本公司的章程及提名政策。提名委員會負責審閱董事會架構、規模及組成，評估獨立非執行董事的獨立性，並就委任或重選董事及董事繼任計劃向董事會提出推薦建議。

## INDEPENDENT NON-EXECUTIVE DIRECTORS

The Board met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise and at least one independent non-executive director must be ordinarily reside in Hong Kong.

The Company has received written annual confirmation from each of the independent non-executive Directors in respect of his/her independence in accordance with the independence guidelines as set out in Rule 3.13 of the Listing Rules. The Company considers all independent non-executive Directors are independent.

## APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of the executive Directors, non-executive Directors and independent non-executive Directors has entered into a service contract or letter of appointment with the Company for a fixed term of three years commencing from the respective appointment date until the date of convening the Shareholders' meeting to elect directors at the expiry of that session.

Directors shall be elected at a general meeting and shall serve a term of three years. Directors shall be elected or replaced at the shareholders' general meetings to hold for a term of three years. Upon maturity of the term of office, a director shall be eligible to offer himself/herself for re-election and re-appointment. If the term of office of a director expires but re-election is not made responsively, the said director shall continue fulfilling the duties as director pursuant to relevant laws, administrative regulations, departmental rules, the Listing Rules and the Articles of Association until a new director is elected.

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles of Association and the nomination policy of the Company. The Nomination Committee is responsible for reviewing the Board's structure, size and composition, assessing the independence of independent non-executive Directors and making recommendations to the Board on the appointment or re-election of Directors and succession planning for Directors.

### 董事會

### BOARD MEETINGS

The Company adopts the practice of holding Board meetings regularly, at least four times a year, and at approximately quarterly intervals in accordance with the CG Code. Notices of no less than 14 days are given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting.

For other Board meetings and Board Committee meetings, reasonable notice is generally given. The agenda and accompanying Board documents are provided to the Directors or Board Committee members before the meetings to ensure that they have sufficient time to review the documents and are adequately prepared for the meetings and that each Director can participate the board proceedings in a meaningful and effective manner. When Directors or Board Committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the Chairman/Chairperson prior to the meeting. Minutes of meetings shall be kept by the company secretary of the Company with copies circulated to all Directors for information and records.

Minutes of the Board meetings and Board Committee meetings are recorded in sufficient detail about the matters considered by the Board and the Board Committees and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and Board Committee meeting are sent to the Directors for comments within a reasonable time after the date on which the meeting is held. Minutes of the Board meetings are available for inspection by the Directors.

During the Reporting Period, nine Board meetings were held and five general meetings and class meetings were convened.

### 證券交易的標準守則

自上市日期起，本公司已採納上市規則附錄C3所載標準守則，作為本公司董事、本公司監事及有關僱員進行所有證券交易的操守守則。

經向董事及監事作出具體查詢後確認，全體董事及監事自上市日期起至二零二三年十二月三十一日止期間，一直遵守標準守則所載的規定標準。於上述期間，本公司並無發現相關僱員違反標準守則的事件。

### 董事會之職權委託

董事會保留對本公司所有主要事項之決策權，包括：批准及監察所有政策事宜、整體戰略及預算、內部控制及風險管理系統、重大交易（特別是可能涉及利益衝突的交易）、財務資料、委任董事以及其他重大財務及營運事宜。董事可尋求獨立專業意見以履行其職責，本公司承擔費用並鼓勵董事獨立接觸本公司高級管理層並與其商議。

本集團之日常管理、行政及營運已授權高級管理層處理。授權職能及責任由董事會定期審查。管理層訂立任何重大交易前須取得董事會之批准。

### MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code as set out in Appendix C3 to the Listing Rules as its own code of conduct regarding all dealings by Directors, Supervisors and relevant employees of securities in the Company since the Listing Date.

Having made specific enquiry with the Directors and Supervisors, all of the Directors and Supervisors confirmed that he/she has complied with the required standards as set out in the Model Code during the period from the Listing Date to December 31, 2023. No incident of non-compliance of the Model Code by the relevant employees was noted by the Company for the aforesaid period.

### DELEGATION BY THE BOARD

The Board reserves for its decision on all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters. The Directors could have recourse to seek independent professional advice in performing their duties at the Company's expense and are encouraged to access and to consult with the Company's senior management independently.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

- (a) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board;
- (b) to review and monitor the training and continuous professional development of Directors and senior management;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors; and
- (e) to review the Company's compliance with the CG Code and disclosures in the Corporate Governance Report.

The Board reviewed the Company's corporate governance policies and practices, training and continuous professional development of Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, the compliance of the Model Code and written employee guidelines, and the Company's compliance with the Code and disclosure in this Corporate Governance Report.

### BOARD COMMITTEES

#### AUDIT COMMITTEE

The Audit Committee comprises three members, including two independent non-executive Directors, namely, Dr. WU Zhanchi and Mr. MA Ruiguang, and one non-executive Director, namely, Mr. PAN Pan (who resigned on April 12, 2024). The Audit Committee is chaired by Dr. WU Zhanchi (being the independent non-executive Director with the appropriate professional qualifications).

The Company has adopted a nomination policy (the “**Nomination Policy**”) on December 20, 2022, which sets out the selection criteria and procedures for nomination and appointment of Directors and considerations for succession plan of the Board, with an aim of ensuring the balance of skills, experience, knowledge and diverse perspectives of the Board to satisfy the requirements of the Company's business. The Nomination Committee will review the Nomination Policy, as appropriate, to ensure its effectiveness.

In accordance with the Nomination Policy, the Nomination Committee will consider the following factors when selecting candidates for the Board members:

- (i) the views and perspectives, skills and experience that the candidate can bring to the Board;
- (ii) the expected benefits and contributions that the candidate can bring to the Board;
- (iii) the achievements and experience of the candidate in the same industry of the Company;
- (iv) the time the candidate is expected to devote to the Company;
- (v) how the candidate promotes diversity of the Board members; and
- (vi) various factors related to the diversity of the Board members, including but not limited to gender, age, culture, educational background, ethnicity, professional experience, skills, knowledge and period of service of the candidate.

## NOMINATION PROCEDURES

The Company has also adopted procedures for nomination and election of Directors. The policy sets out the criteria and procedures for selection and performance evaluation and provides guidance to the Board on the nomination and appointment of Directors. The Board believes that a clear selection process facilitates corporate governance, ensures the continuity of the Board, maintains the leadership of the Board, and enhances the efficiency and diversity of the Board.

Both the Nomination Committee and the Board can nominate candidates for Directors. When evaluating the suitability of recommended candidates and their potential contributions to the Board, the Nomination Committee may refer to certain selection criteria such as integrity, professional qualifications and skills, achievements and experience in the industries, commitment and related contributions. The Nomination Committee shall report the evaluation results to the Board on the appointment of suitable Director candidates and provide relevant recommendations to the Board to make decisions and formulate a general election plan which should be proposed at the general meeting for the Shareholders' approval.

The Board has adopted a board diversity policy which sets out the basic principles to be followed to ensure that the Board has an appropriate balance of required skills, experience and diversity of perspectives to enhance the effective operation of the Board and maintain a high level of corporate governance. The Nomination Committee shall review this policy and measurable objectives at least annually when appropriate to ensure the continued and effective operation of the Board.

Taking into account various factors, the Company has proposed a target of not less than two female members in the Board. By the end of 2023, the Company had two female members on the Board and had achieved the goal of gender diversity. The Company believes that the current composition of the Board is in line with the principles of the board diversity policy. When selecting and making recommendation on suitable candidates for appointments of directors, the Board will take full account of the proportion of female members.

The Board acknowledges the key role that the Company's risk management and internal control systems play in the Company's risk management and ongoing compliance with laws and regulations. The Company is aware of the responsibilities of the Board and the management in risk management and internal control systems:

- (1) **The Board** evaluates and determines the nature and extent of the risks it is willing to undertake in order to achieve its strategic objectives and confirm the establishment and maintenance of appropriate and effective risk management and internal control systems; continuously monitor the Group's risk management and internal control systems to ensure that they are reviewed at least annually for effectiveness; supervise the management's design, implementation and monitoring of risk management and internal control systems.
- (2) **The management** provides validation to the Board regarding the effectiveness of risk management and internal control systems.

Such risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives and provide reasonable instead of absolute assurance against material misstatement or loss.

### 風險管理及內部控制系統

本集團持續推進及運行自上而下、自下而上的風險管理架構，明確風險管理流程，採用積極、結構化的方法，促進內部風險管理文化的完善。截至二零二三年十二月三十一日止年度，本集團通過開展以下工作，建立並健全風險管理體系架構，以及指導全公司開展風險評估及持續風險監控活動：

有關風險管理及內部控制系統旨在管理而非消除未能達成業務目標的風險，並就重大失實陳述或損失提供合理而非絕對的保證。

### RISK MANAGEMENT AND INTERNAL CONTROL SYSTEMS

The Group has continued to promote and operate top-down and bottom-up risk management structures, defined the risk management process, and adopted active and structured methods to promote the improvement of internal risk management culture. For the year ended December 31, 2023, the Group established and improved the risk management system structures as well as guided the development of risk assessment and continuous risk monitoring activities throughout the Company by conducting the following work:

Such risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

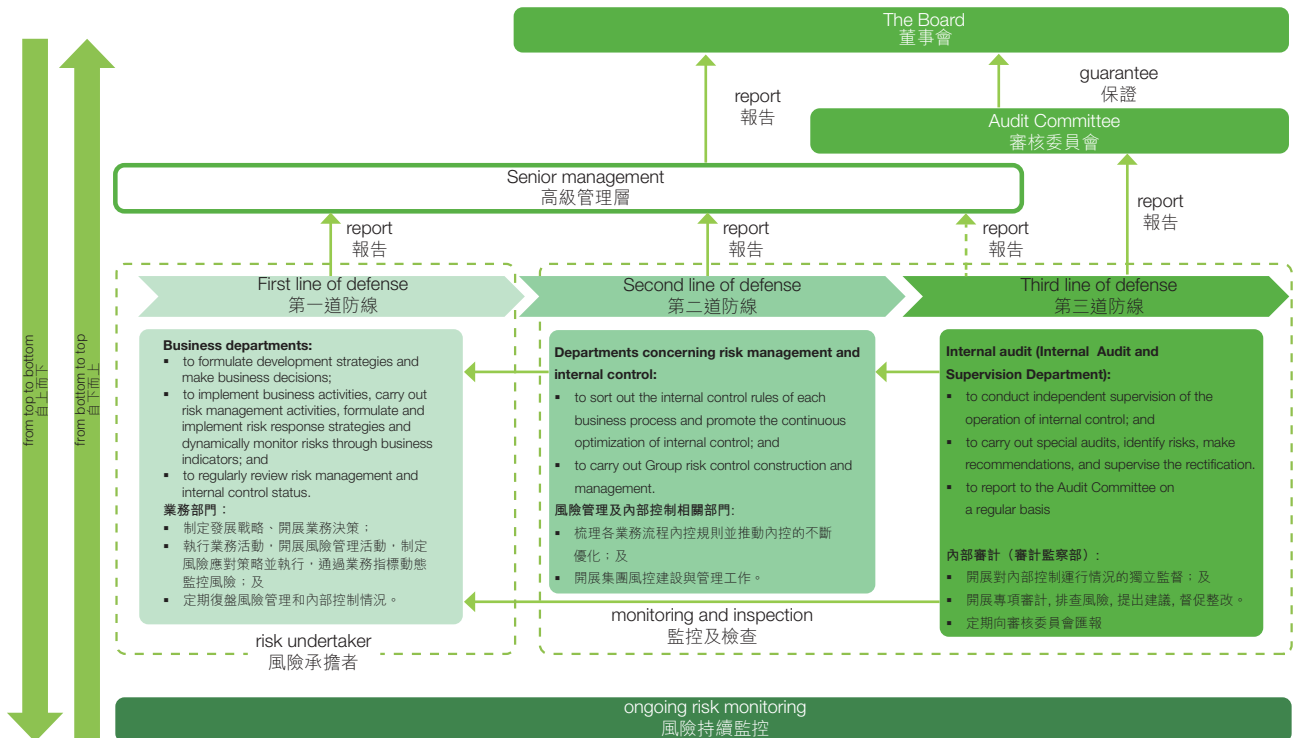


Fig.1: Risk Management Organizational Structure

為了保證風險管理及內部監控系統的有效性，本集團採取了三道防線模型建立的風險管理組織架構，該架構貫穿決策層面（董事會）、監督層面（審計監察部）、執行層面（高級管理層及職能中心管理層）（如圖1：風險管理組織架構所示），明確劃分了風險管理職責，明確了管理層及各職能部門的風險管理職責及風險信息報告路線。董事會從上而下監督、識別及評估企業層面的風險，而集團職能中心從下而上識別、管理及報告運營層面的風險。

To ensure the efficiency of risk management and internal control systems, the Group has adopted a risk management organization based on a three lines of defense model that spans the decision-making level (the Board of Directors), the oversight level (the Audit and Supervision Department), and the executive level (the senior management and functional center management) (as shown in Fig.1: Risk Management Organizational Structure), clearly divided the responsibilities of risk management and defined the risk management responsibilities and risk information reporting routes of the management and various functional departments. The Board supervises, identifies and evaluates risks at the corporate level from top to down, while the group functional center identifies, manages and reports risks at the operational level from bottom to top.

In order to carry out risk management procedures in a systematic and standardized way, we help identify, cope with and manage major risks facing the Group prospectively through the implementation of the following risk management framework, and carry out risk assessment and report at least once a year.

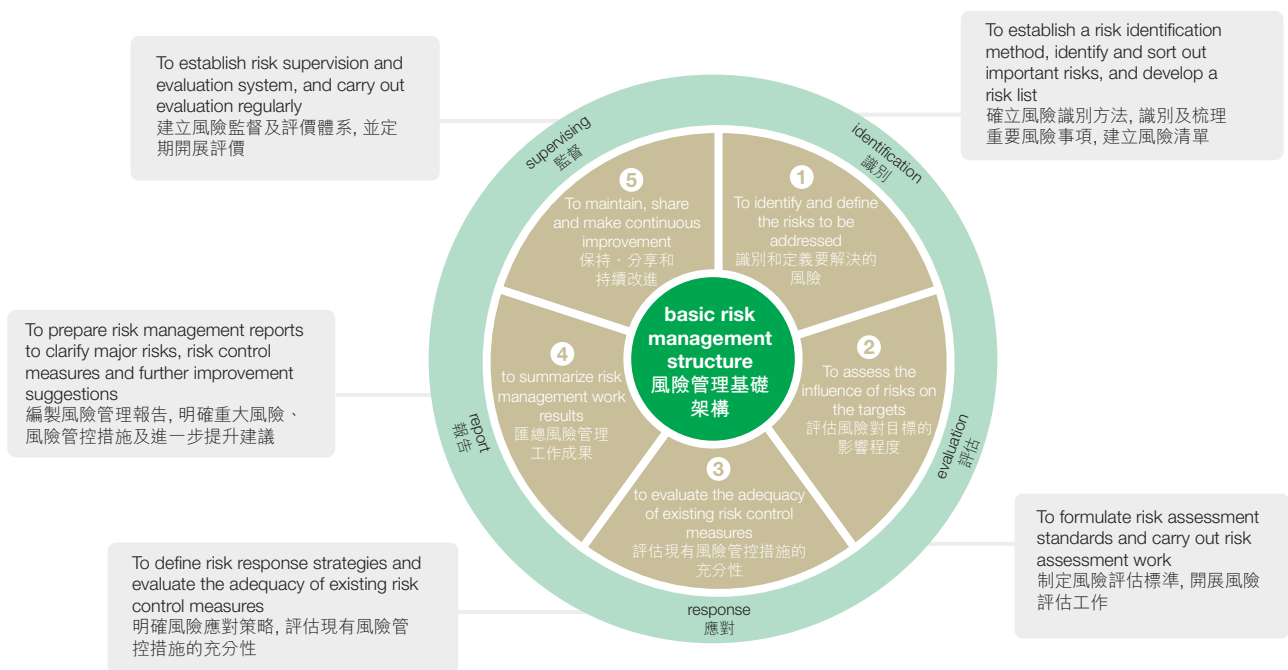


Fig. 2: Risk management framework

## 實施風險管理及內部控制

截至二零二三年十二月三十一日止年度，管理層根據宏觀環境、本集團所處行業及本集團業務特點，制定了涵蓋策略風險、運營風險、財務風險、環境、社會及管治風險、合規風險五大風險類別的風險清單。我們通過各業務單位的管理實施風險評估流程。通過系統的風險管理流程，我們確定重點關注和優先控制的主要風險，梳理風險控制現狀，制定應對措施及改進方案，將風險控制在可接受水平。於報告期間，管理層向審核委員會報告十大風險的評估結果。

本集團的內部控制系統乃根據 Committee of Sponsoring Organizations of the Treadway Commission (即COSO委員會) 頒佈的內部控制框架建立。審核委員會每年檢討該系統的有效性及充分性。

本集團已設立審計監察部履行內部審計職能，負責獨立監督本集團的內部控制措施，以協助董事會推動本集團內部控制系統的持續改進。未來，內部審計職能將繼續採用以風險為導向的內部審計方法，以確保在審計範圍內考慮重大關注事項及重大風險。

## IMPLEMENTATION OF RISK MANAGEMENT AND INTERNAL CONTROL

For the year ended December 31, 2023, based on the macro environment, the industry in which the Group operates and the business characteristics of the Group, the management established a risk list covering five risk categories, namely strategic risk, operational risk, financial risk, environmental, social and governance risk, and compliance risk. We implemented the risk assessment process through the management of each business unit. Through the systematic risk management procedure, we determined the major risks of concern and priority control, sorted out the status quo of risk control and developed countermeasures and improvement plans, so as to maintain the risk within an acceptable level. During the Reporting Period, the management reported to the Audit Committee the assessment results of the top 10 risks.

The internal control system of the Group is built based on the internal control framework issued by the Committee of Sponsoring Organizations of the Treadway Commission (namely, the COSO Committee). The Audit Committee reviews the effectiveness and adequacy of the system annually.

The Group has set up the Internal Audit and Supervision Department to perform the function of internal audit, which is responsible for independently supervising the internal control measures of the Group, so as to assist the Board in promoting the continuous improvement of the internal control system of the Group. In the future, the internal audit function will continue to adopt a risk-oriented internal audit approach to ensure that significant concerns and significant risks are taken into account within the scope of the audit.

本集團已建立並實施一系列反舞弊制度，包括但不限於《廉潔自律及反舞弊管理制度》、《廉潔自律管理規定》、《員工廉潔自律管理規定》、《反舞弊與反腐敗制度》等，以營造廉潔合規文化，不斷強化董事和員工的廉潔自律意識。此外，我們設有各種舉報渠道，包括熱線、電郵等，以供公眾舉報及監督。審計監察部負責及時跟進及調查涉嫌舞弊或貪污的個案，協助本集團宣揚廉潔自律、反舞弊及反貪污文化。

The Group has established and implemented a series of anti-fraud systems, including but not limited to the Integrity and Self-discipline and Anti-Fraud Management System, Administrative Regulations on Integrity and Self-Discipline Supervision, Administrative Regulations on Employee Integrity and Self-Discipline, and Anti-Fraud and Anti-Corruption System, in order to create a culture of integrity and compliance, and continuously strengthen the awareness of integrity and self-discipline of Directors and employees. In addition, we have set up a variety of reporting channels, including hotline, email and mailbox for public report and supervision. The Audit and Supervision Department will be responsible for and promptly follow up and investigate the suspected fraud or corruption cases, and assist the Group in promoting integrity, self-discipline, anti-fraud and anti-corruption culture.

During the year ended December 31, 2023, the Board, through the Audit Committee, has conducted a review of the effectiveness of risk management and internal control systems of the Group and is of the view that such systems are effective and adequate.

During the year ended December 31, 2023, the Company has adopted various measures to ensure the effective implementation of its risk management and internal control systems, including (i) establishing the Audit Committee to review and supervise our financial reporting process and internal control system; (ii) adopting various policies to ensure compliance with the Listing Rules, including but not limited to aspects related to risk management, connected transactions and information disclosure; (iii) organizing training sessions for our Directors and senior management in respect of the relevant requirements of the Listing Rules and duties of directors of companies listed in Hong Kong; (iv) conducting regular internal training for our employees and management on applicable laws and regulations to ensure awareness and compliance which cover various aspects of employee behavior during the ordinary business operations; (v) appointing Somerley Capital Limited as our compliance adviser to advise on ongoing compliance with the Listing Rules and other applicable securities laws and regulations in Hong Kong; and (vi) appointing a PRC legal adviser to advise us on PRC laws and regulations related to the Group's operations.

### 股息政策

我們可根據經營業績、現金流量、財務狀況、對我們支付股息的法定及監管限制、我們的資本要求、未來業務計劃及前景以及我們可能認為相關的其他因素等各種因素，以現金或我們認為合適的其他方式分派股息。宣派及支付任何股息的決定須經董事會批准，並由其酌情決定。此外，任何財政年度的末期股息均須經股東批准。

### DISCLOSURE POLICY

The Company has adopted other internal rules and policies on December 20, 2022, which includes procedures for disclosure policy and provides a general guide to its Directors, officers, senior management and relevant employees in handling confidential information, monitoring information disclosure and responding to enquiries. Control procedures have been implemented to ensure that unauthorized access and use of inside information are strictly prohibited.

### DIVIDEND POLICY

We may distribute dividends by way of cash or by other means that we consider appropriate, based on various factors such as our results of operations, cash flows, financial condition, statutory and regulatory restrictions on the payment of dividends by us, our capital requirements, future business plans and prospects and other factors that we may consider relevant. A decision to declare and pay any dividend would require the approval of the Board and will be at their discretion. In addition, any final dividend for a financial year will be subject to Shareholders' approval.

We have adopted a general annual dividend policy of declaring and paying dividends on an annual basis of no less than 20% of our distributable net profit for any particular year. The declaration and payment of dividends is subject to, among other things, our operational needs, earnings, financial condition, working capital requirements and future business plans as our Board may deem relevant at such time. There can be no assurance that we will be able to declare or distribute any dividend in the amount set out in any plan of the Board or at all.

Shareholders may make any enquiries with respect to the Company by following the steps set out in the paragraph headed "Putting Forward Enquiries to the Board" below.

At the annual general meeting, Directors (including non-executive Directors), in particular, the chairman or chairperson of the Board Committees or their delegates, appropriate senior executives and external auditor are available to meet Shareholders, understand their views and answer their enquiries.

The implementation and effectiveness of the shareholders' communication policy are reviewed on an annual basis. The Board has reviewed the implementation and effectiveness of the shareholders' communication policy during the Reporting Period, and believes that the Company's shareholders' communication policy has been properly implemented and deemed effective during the Reporting Period.

### SHAREHOLDERS' RIGHTS

To safeguard Shareholders' interests and rights, separate resolution should be proposed for each substantially separate issue at general meetings, including the election of individual Director. All resolutions put forward at general meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and the Stock Exchange after each general meeting.

According to the Articles of Association, the procedures for Shareholders to convene an extraordinary general meeting and put forward proposals at general meetings, and to put forward enquiries to the Board are as follows:

### 召開臨時股東大會及於股東大會上提出建議

根據公司章程第六十一條，單獨或者合計持有公司10%或以上股份的股東有權向董事會請求召開臨時股東大會，並應當以書面形式向董事會提出。董事會應當根據法律、行政法規和公司章程的規定，在收到請求後10日內給出同意或不同意召開臨時股東大會的書面反饋意見。董事會同意召開臨時股東大會的，應當在作出董事會決議後的五日內發出召開股東大會的通知。通知中對原請求的變更，應當經相關股東批准。董事會不同意召開臨時股東大會，或者在收到請求後10日內未作出反饋的，單獨或者合計持有公司10%或以上股份的股東有權在擬召開的會議上向監事會提議召開臨時股東大會，並應當以書面形式向監事會提出請求。監事會同意召開臨時股東大會的，應在收到請求5日內發出召開股東大會的通知。通知中對原請求的變更，應當經相關股東批准。監事會未在規定期限內發出股東大會通知的，視為監事會不召集和主持股東大會，連續90日以上單獨或者合計持有公司10%或以上股份的股東可以自行召集和主持。

### CONVENING AN EXTRAORDINARY GENERAL MEETING AND PUTTING FORWARD PROPOSALS AT GENERAL MEETINGS

According to Article 61 of the Articles of Association, Shareholder(s) who individually or jointly hold 10% or more of the shares of the Company shall have the right to request the Board to convene an extraordinary general meeting, and shall make such request to the Board in writing. The Board shall, pursuant to the provisions of laws, administrative regulations and the Articles of Association, give a written reply on whether to convene the extraordinary general meeting or not within ten days upon receipt of the request. In case that the Board agrees to convene an extraordinary general meeting, the Board shall, within five days after the Board resolution is made, issue a notice calling for the meeting. Changes to the original request in the notice shall be subject to the approval of relevant Shareholders. In case that the Board refuses to convene an extraordinary general meeting, or does not give any response within ten days upon receipt of the request, Shareholders who individually or jointly hold 10% or more of the shares of the Company at such proposed meeting shall have the right to propose to the Board of Supervisors for convening of such meeting, and shall make such request to the Board of Supervisors in writing. In case that the Board of Supervisors agrees to convene an extraordinary general meeting, the Board of Supervisors shall, within five days upon receipt of the request, issue a notice calling for the meeting. Changes to the original request in the notice shall be subject to the approval of relevant Shareholders. In case that the Board of Supervisors fails to give the notice of such a meeting within the specified time limit, the Board of Supervisors shall be deemed to have failed to convene or preside over the meeting, in which case, Shareholders who either individually or jointly hold 10% or more of the Company's shares for more than ninety consecutive days may convene and preside over the meeting by themselves.

## CORPORATE GOVERNANCE REPORT

According to Articles 62, 63 and 64 of the Articles of Association, when the Board of Supervisors or the Shareholders decide to convene a general meeting by themselves, they must notify the Board in writing and at the same time file the notice with the relevant securities regulatory authority of the place where the Company is domiciled and the stock exchange where the Company's shares are listed in accordance with applicable regulations (if needed). Before an announcement on general meeting resolutions is made, the shareholding of the convening Shareholders shall not be less than 10%. When the Board of Supervisors or convening Shareholders decide to send a notice of the Shareholders' general meeting and the announcement of the resolution of the Shareholders' general meeting, they shall also submit the relevant certification materials to the securities regulatory authorities where the Company is domiciled and the stock exchange where the Company's shares are listed in accordance with applicable regulations. The Board and the secretary to the Board shall cooperate with the Shareholders' general meeting convened by the Board of Supervisors or the Shareholders on their own. The Board shall provide the register of members as at the record date. When the Board of Supervisors or the Shareholders convene a general meeting on their own, the expenses necessary for the meeting shall be borne by the Company.

Pursuant to Article 65 of the Articles of Association, Shareholders individually or jointly holding more than 3% of the shares of the Company may propose and submit new provisional resolutions in writing to the convener 10 days prior to the general meeting. The convener of the general meeting shall issue a supplemental notice of general meeting to other Shareholders within 2 days after the receipt of such resolutions and incorporate the matters falling within the scope of duties of the general meeting into the agenda of such meeting for the consideration.

As at 31 December 2023, the net carrying amount of trade receivables and other receivables of the Group are RMB1,063.4 million and RMB620.0 million, respectively, after loss allowances of RMB53.8 million and RMB14.8 million were made respectively.

Trade receivables mainly represent sales proceeds receivable from the Group's customers. The Group applies the simplified approach to measure expected credit loss ("ECL") for its trade receivables, which requires expected lifetime losses to be recognised at the reporting date.

- Understood and evaluated key controls over impairment assessment of trade receivables and other receivables, and assessed the inherent risk of material misstatement by considering the degree of estimation uncertainty and level of other inherent risk factors;

Management assessed the ECL of trade receivables based on estimation about risk of default and expected credit loss rates. Management calculated the historical default rates based on the past payment profile of customers, including historical settlement pattern in the most recent year. The expected lifetime loss is estimated based on historical default rate with adjustment to reflect current conditions and forward-looking factors on macroeconomic factors affecting the ability of the customers to settle the receivables.

On the other hand, the Group applies the general approach to measure ECL for its other receivables, mainly comprising of interest-bearing loans to franchisees and factoring amounts to regional dealers (franchisees and regional dealers are collectively referred to as "counterparties"), which requires the Group to consider the probability of default upon initial recognition and whether there has been a significant increase in credit risk on an ongoing basis.

# 合併財務報表附註

## NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

### 1 一般資料

本公司於二零零一年十二月三日在中華人民共和國（「中國」）註冊成立，是一家根據《中華人民共和國公司法》成立的有限責任公司，並於二零二零年四月十日轉為股份有限公司。本公司註冊辦公地址為：中國廣東省深圳市鹽田區沙頭角街道田心社區沙鹽路3018號鹽田現代產業服務中心（一期）A座6層6A-2。

本公司股份已自二零二三年一月十六日起於香港聯合交易所有限公司（「聯交所」）主板上市。

本公司及其附屬公司（統稱「本集團」）主要從事經營加盟零售網絡及水果交易。本集團的最終控制方為余惠勇先生（「余先生」）。

除另有說明外，該等合併財務報表以人民幣千元（「人民幣千元」）呈列。該等合併財務報表已於二零二四年三月二十七日獲董事會批准。

### 1 GENERAL INFORMATION

The Company was incorporated in the People's Republic of China (the "PRC") on 3 December 2001 as a limited liability company under Company Law of the PRC and was converted into a joint stock company with limited liability on 10 April 2020. The address of the Company's registered office is 6A-2, 6/F, Block A, Yantian Modern Industry Service Center (Phase I), No. 3018 Shayan Road, Tianxin Community, Shatoujiao Street, Yantian District, Shenzhen, Guangdong Province, China.

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") since 16 January 2023.

The Company and its subsidiaries (together, the "Group") are principally engaged in operating a franchised retail network and trading of fruits. The ultimate controlling party of the Group is Mr. Yu Huiyong ("Mr. Yu").

These consolidated financial statements are presented in thousands of units of Renminbi ("RMB'000") unless otherwise stated. These consolidated financial statements have been approved by the Board of directors on 27 March 2024.

## NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

### 2 編製基準及會計政策變動

#### 2.1 編製基準

本集團的合併財務報表乃根據香港財務報告準則（「香港財務報告準則」）及香港公司條例第622章的披露規定編製。合併財務報表已根據歷史成本法編製，惟以下除外：

- 若干金融資產及投資物業 – 以公允價值計量；及
- 若干生物資產 – 以公允價值減去出售成本計量。

編製符合香港財務報告準則之合併財務報表須採用若干關鍵會計估計。在應用本集團會計政策過程中，管理層亦須行使其判斷。涉及高度判斷或複雜性之範疇，或假設及估計對合併財務報表而言屬重要之範疇披露於附註4。

### 2 BASIS OF PREPARATION AND CHANGES IN ACCOUNTING POLICIES

#### 2.1 BASIS OF PREPARATION

The consolidated financial statements of the Group have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRS”) and the disclosure requirements of the Hong Kong Companies Ordinance Cap. 622. The consolidated financial statements have been prepared under the historical cost basis, except for the following:

#### 3.1 財務風險因素

本集團業務面臨多種財務風險：市場風險（包括外匯風險、公允價值利率風險、現金流量利率風險及價格風險）、信貸風險及流動資金風險。本集團的整體風險管理計劃重點關注金融市場的不可預測性，並尋求盡量減低對本集團財務表現的潛在不利影響。

##### (A) 市場風險

###### (I) 外匯風險

本集團在中國經營業務，其大部分交易以人民幣計價。本集團主要因以美元（「美元」）計價的若干買賣交易面臨外匯風險。本集團通過監控外幣收支水平管理外幣交易的風險敞口。本集團不時確保外匯風險敞口淨額保持在可接受的水平。

倘美元兌人民幣升值／貶值5%，且所有其他變量保持不變，則截至二零二三年十二月三十一日止年度的除所得稅前利潤將增加／減少人民幣3,489,000元（二零二二年：人民幣4,213,000元），主要由於以美元計價的金融資產淨值換算所產生的外匯收益。

### 3 FINANCIAL RISK MANAGEMENT

#### 3.1 FINANCIAL RISK FACTORS

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, fair value interest rate risk, cash flow interest rate risk and price risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

##### (A) MARKET RISK

###### (I) FOREIGN EXCHANGE RISK

The Group operates in the PRC and most of their transactions are denominated in RMB. The Group is exposed to foreign exchange risk primarily through certain sales and purchases transactions that are denominated in United States dollar ("US\$"). The Group manages its exposures to foreign currency transactions by monitoring the level of foreign currency receipts and payments. The Group ensures that the net exposure to foreign exchange risk is kept to an acceptable level from time to time.

If US\$ had strengthened/weakened by 5% against RMB, with all other variables held constant, the profit before income tax for the year ended 31 December 2023 would have been RMB3,489,000 (2022: RMB4,213,000) higher/lower, mainly as a result of foreign exchange gains on translation of US\$ denominated net financial assets.

本集團的利率風險主要來自受現金流量利率風險影響的現金及現金等價物、浮息限制性銀行存款及銀行借款。倘現金及現金等價物、限制性銀行存款及銀行借款的利率提高／降低50個基點，截至二零二三年十二月三十一日止年度的除所得稅前利潤將增加／減少約人民幣10,469,000元（二零二二年：人民幣6,215,000元）。

於二零二三年十二月三十一日，本集團面臨與固定利率應收貸款及長期銀行存款有關的公允價值利率風險。管理層認為，截至二零二三年十二月三十一日止年度，公允價值利率風險敞口對本集團而言屬不重大（二零二二年：相同）。

The Group's interest rate risk mainly arises from cash and cash equivalents, restricted bank deposits and bank borrowings at variable interest rates which are subject to cash flow interest rate risk. If the interest rate of cash and cash equivalents, restricted bank deposits and bank borrowings had been 50 basis points higher/lower, the profit before income tax for the year ended 31 December 2023 would have been approximately RMB10,469,000 (2022: RMB6,215,000) higher/lower.

As at 31 December 2023, the Group is exposed to fair value interest rate risk in relation to fixed rate loan receivables and long-term bank deposits. Management considers the fair value interest rate risk exposure is insignificant to the Group during the year ended 31 December 2023 (2022: same).

The Group's exposure to price risk arises from investments in structured deposits, compound financial instruments and equity securities held by the Group that are classified as financial assets at FVTPL and FVOCI in the consolidated statement of financial position.

To manage its price risk arising from investments, the Group diversifies its portfolio. Each investment is managed by management on a case by case basis. Sensitivity analysis of these financial investments is performed by management, see Note 3.3 for details.

##### (B) CREDIT RISK

Credit risk is managed at group basis. Credit risk primarily arises from trade receivables, deposits and other receivables, amounts due from associates and joint venture, loans to related parties, and cash and bank balances included in the consolidated statement of financial position which represent the Group's maximum exposure to credit risk in relation to its financial assets.

為管理貿易應收款項產生的風險，本集團已制定相關政策確保向具有合適信貸記錄的交易對手提供信貸條款，並確保管理層對其交易對手持續進行信貸評估。授予客戶的信貸期通常不超過90日且該等客戶的信貸質量通過考慮其財務狀況、歷史經驗及其他因素進行評估。鑒於應收該等客戶的貿易應收款項的良好收款記錄，管理層認為，該等未付本集團的貿易應收款項結餘內在信貸風險屬不重大。

To manage risk arising from cash and bank balances, the Group mainly transacts with state-owned or reputable financial institutions in the PRC. Management believes that there is no significant credit risk as these commercial banks have a high reputation and their credit rating ranges from AA- to AAA.

To manage risk arising from trade receivables, the Group has policies in place to ensure that credit terms are made to counterparties with an appropriate credit history and management performs ongoing credit evaluations of its counterparties. The credit period granted to the customers is usually no more than 90 days and the credit quality of these customers is assessed, which takes into account their financial position, past experience and other factors. In view of the sound collection history of trade receivables due from them, management believes that the credit risk inherent in these Group's outstanding trade receivable balances is not significant.

While cash and cash equivalents, restricted bank deposits and long-term bank deposits are also subject to the impairment requirements of HKFRS 9, the identified impairment loss was immaterial.

The Group applies the simplified approach to provide for ECL prescribed by HKFRS 9, which requires the use of the lifetime expected loss provision for all trade receivables.

The Group considers the credit risk characteristics and the invoice date ageing of the trade receivables to measure the ECL. The Group has assessed the ECL by considering historical default rates, existing market conditions and forward-looking information. For details, please refer to Note 23.

There are no significant concentrations of credit risk arise from trade receivables from its customers. Management does not expect significant losses from non-performance by these counterparties based on historical settlement pattern. The Group maintains frequent communications with these customers to ensure relevant transactions are running effectively and smoothly and balances are reconciled. Settlements from these customers are closely monitored on an ongoing basis by management of the Group to ensure any overdue debts are identified. Follow-up action is taken to recover the overdue debts.

Trade receivables are written off when there is no reasonable expectation of recovery. Impairment losses on trade receivables are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

To assess whether there is a significant increase in credit risk, the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forwarding-looking information. Especially the following indicators are incorporated:

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group monitors capital on the basis of the gearing ratio. This ratio is calculated as net debt divided by total capital (the sum of total equity and net debt), as shown in the consolidated statement of financial position. Net debt is calculated as total bank borrowings and lease liabilities less cash and cash equivalents, long-term bank deposits and restricted bank deposits.

The Group collects sales proceeds on behalf of the franchisees and settle with them regularly by remitting the sales proceeds to the franchisees after deducting the monthly royalty fee, repayment of interest-bearing loans provided and the outstanding purchase amounts of fruits and other products from the Group. The relevant amounts have therefore been presented net in the consolidated statement of financial position.

### 4 重大會計估計及判斷

#### (A) 合併基礎

本集團於其一般業務過程中與加盟商訂立特許經營協議。本集團及加盟商的權利及義務由各特許經營協議規定。由於該等安排的複雜性，故需作出重大判斷，以釐定本集團是否有權控制加盟商並因此應將其合併入賬。

倘本集團承擔或享有參與有關實體業務所得可變回報之風險或權利，並能通過其在該實體之權力影響該等回報時，本集團對該實體具有控制權。本集團亦會特別考慮其是否從行使對該實體之控制權而取得利益，包括非財務利益。因此，加盟商是否受本集團控制需透過分析多項因素（包括本集團於加盟商相關活動的權限）作出判斷。根據本集團之分析，本集團認為，其並無控制加盟商的有關權力。

### 4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of consolidated financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Group's accounting policies.

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

#### (A) BASIS OF CONSOLIDATION

In the normal course of business, the Group enters into franchise agreements with franchisees. The rights and obligations of the Group and the franchisees are stipulated in the respective franchise agreements. Because of the complexity of the arrangements, significant judgement is needed in determining whether the Group has the power to control and therefore should consolidate the franchisees.

The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group also considers, in particular, whether it obtains benefits, including non-financial benefits, from its power to control the entity. As such, the conclusion whether the franchisees is under the control of the Group requires the application of judgement through the analysis of various factors including the extent of power the Group has on the relevant activities of the franchisees. Based on the Group's analysis, it has concluded that it does not has such power to control the franchisees.

### 4 重大會計估計及判斷(續)

#### (B) 即期及遞延所得稅

本集團須於中國繳納所得稅。釐定所得稅撥備須涉及重大判斷。本集團根據是否需要繳付額外稅款之估計，就預期稅務審計問題確認負債。倘該等事件的最終稅務後果與最初記錄金額不同，該等差額將影響作出該等釐定期間之即期及遞延所得稅資產與負債。

當管理層認為可動用暫時差額或稅務虧損以抵銷未來應課稅溢利時，將確認若干暫時差額相關遞延所得稅項資產及稅務虧損。倘預期與原定估計不同，有關差額將影響估計出現變動期內的遞延稅項資產及所得稅的確認。

#### (C) 非金融資產減值

本集團評估所有非金融資產於各報告期末是否有任何減值指標。當有指標顯示賬面值可能無法收回時，則對非金融資產進行減值測試。當資產或現金產生單位(「現金產生單位」)(定義見附註42.4)的賬面值高於其可收回金額時，即存在減值，現金產生單位可收回金額為其公允價值減去處置成本(「公允價值減去處置成本」)及使用價值(「使用價值」)的較高者。用於商譽減值評估的關鍵假設及輸入數據詳情披露於附註17的表格中。

#### (B) CURRENT AND DEFERRED INCOME TAX

The Group is subject to income taxes in the PRC. Significant judgement is required in determining the provision for income taxes. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences would impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and tax losses are recognised when management considers it is probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectation is different from the original estimates, such difference will impact the recognition of deferred tax assets and income tax in the period in which such estimates are changed.

#### (C) IMPAIRMENT OF NON-FINANCIAL ASSETS

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each reporting period. Non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash generating unit ("CGU" as defined in Note 42.4) exceeds its recoverable amount, which is the higher of its fair value less cost of disposal ("FVLCOB") and its value-in-use ("VIU"). Details of the key assumptions and inputs used for goodwill impairment assessment are disclosed in the tables in Note 17.

#### (E) FAIR VALUE MEASUREMENT OF FINANCIAL INSTRUMENTS

The fair value of financial instruments that are not traded in an active market is determined by using appropriate valuation techniques and making assumptions that are based on market conditions existing at each reporting date. Refer to Note 3.3(a) for the fair value measurement and the sensitivity analysis of financial instruments.

This measurement basis excludes the effects of fair value gain on structured deposits, legal and professional fees, listing expenses, income tax expense, interest income on bank deposits and certain interest expenses on borrowings. Other information provided to the CODM is measured in a manner consistent with that in the consolidated financial statements.

Franchisees operate their own retail stores for selling the fruit and other food products.

The Group also operates several self-owned retail stores.

###### 加盟商

本集團與所有加盟商(包括區域代理推薦的加盟商)訂立特許經營協議。特許經營協議賦予加盟商使用本集團品牌及相關知識產權(「特許經營權」)的權利。根據特許經營協議,加盟商在簽訂特許經營協議時支付不可退還的初始費用,以及每月支付特許權使用費及其他服務費。特許經營協議的初始期限一般為五年。在雙方同意的前提下,加盟商可在特許經營協議到期後續訂協議,而無需支付初始費用。

特許權使用費佔月費的較大部分,並根據預先釐定的累進費率按各加盟商門店毛利的適用百分比計算。特許權使用費及其他費用一般按月開具發票並進行結算。根據目前與加盟商的結算安排,本集團代加盟商收取所有門店的銷售款項,並在每個日曆月末,於扣除加盟商的貸款還款及購買金額後進行結算。本集團根據香港財務報告準則第15號應用「以銷售為基礎的特許權使用費」以於向終端客戶銷售時確認特許權使用費。

###### Franchisees

The Group enters into franchise agreements with all franchisees, including those referred by regional dealers. Franchise agreements entitle the franchisees to access the brand of the Group and associated intellectual property (the “franchise right”). Under the franchise agreement, franchisee pays a non-refundable initial fee upon entering into franchise agreement, and monthly royalty and other service fees. The initial term of franchise agreement is typically 5 years. Subject to mutual agreement, a franchisee may renew the franchise agreement upon its expiration with no initial fees.

The royalty fee represents the majority of the monthly fee and is determined based on a predetermined progressive rate as a percentage of the applicable franchisee’s stores gross profits. Royalties and other fees are generally invoiced and settled on a monthly basis. Under the current settlement arrangements with franchisees, the Group collects all the store sales proceeds on behalf of the franchisees and settles at the end of each calendar month, after deducting the loan repayment and purchase amounts from franchisees. The Group applies “sales-based royalty” under HKFRS 15 to recognise the royalty fees when the sales to end customers occurred.

###### Franchisees (Continued)

The Group's franchise agreements also include certain initial franchise fees. Initial franchise fees are charged for pre-opening support services provided to the franchisees, including market and location analysis, certain advisory services like license application, general management training and pre-opening marketing, etc. As those services are highly interrelated with the franchise right, they are not individually distinct from the ongoing licensing arrangement provided to the franchisees. As a result, initial franchise fees are recognised on a straight-line basis over the expected franchise period, aligns with the franchisee's access to the franchise rights.

A contract liability is the Group's obligation to transfer the promised goods to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. Unearned initial franchise fees are recognised as contract liabilities in the consolidated statement of financial position.

###### 區域代理

###### Franchisees (Continued)

The Group provides upfront subsidies to certain franchisees for their pre-opening capital expenditure including decoration and purchasing equipment in return for a higher monthly royalty rate. These subsidies do not represent distinct goods or services provided to the franchisees and are accounted for as a reduction of the royalty income on a straight-line basis over the expected franchise period. The unutilised portion are recognised as other prepayments in the consolidated statement of financial position.

###### Regional dealers

Upon entering into regional dealer contracts, regional dealers have to pay a non-refundable initial fee. The initial term of regional dealer contracts are typically 10 years. Subject to mutual agreement, a regional dealer may renew the regional dealer contracts upon its expiration. Initial fees are recognised on a straight-line basis over the expected contract period, aligns with the regional dealers' access to the franchise rights. Unearned initial fees are recognised as contract liabilities in the consolidated statement of financial position.

對於區域代理每成功推薦一名加盟商，加盟商的部分初始費用及隨後的特許權使用費將作為佣金支付予區域代理。支付予區域代理的佣金並非區域代理的單項明確履約責任，因此被視為支付予客戶的代價，並與特許權使用費及特許經營收入所抵銷。

For every successful referral of franchisee by regional dealers, part of the initial fee and the subsequent royalty fee from franchisees are paid to regional dealers as commission. The commission paid to regional dealers is not a distinct performance obligation by the regional dealers and hence regarded as consideration payable to customers and offsetting with the royalty and franchising income.

##### (II) SALES OF FRUITS AND OTHER FOOD PRODUCTS – FRANCHISED STORES AND REGIONAL DEALERS

The Group sells fruits and other food products to regional dealers and franchisees. The regional dealers would further sell the fruits and other food products to the franchisees in specific region.

本集團負責將產品運送至加盟門店。收入於產品交付至加盟門店時確認，相關運輸成本於銷售成本確認。另一方面，本集團與區域代理安排在本集團的倉庫提貨，因此收入於區域代理提貨時確認。概無產生任何運輸成本。

Revenue are recognised when control of the products has transferred, being when the products are delivered to the customers, the customer has accepted the products, the collection of the related consideration is probable and there is no unfulfilled obligation that could affect the customer's acceptance of the products. This is the time when the right to collect the consideration becomes unconditional and only the passage of time is required before the payment is due.

The Group is responsible for delivering products to franchised stores. Revenue is recognised upon delivery of products to the franchised stores and the related transportation cost is recognised in cost of sales. On the other hand, the Group arranges with regional dealers for pick-up of the goods at the Group's warehouses and therefore revenue is recognised upon picking up by regional dealers. No transportation cost is incurred.

When the legal title of goods is transferred to regional dealers and franchisees, regional dealers and franchisees are regarded as the principal as they are exposed to the inventory risk before the goods are transferred to franchisees or sold to end customers, respectively. Due to the nature of fruits, when the goods are accepted by the regional dealers and franchisees, they cannot be returned to the Group, except for the defective or wrong products that are identified. Only immaterial return is noted during year ended 31 December 2023 (2022: same).

Accumulated experience is used to estimate the variable consideration to the extent that it is highly probable that a significant reversal will not occur, using the expected value method, to be included in the transaction price. The validity of this assumption and the estimated amount of rebates are reassessed at each reporting date.

##### (IV) MEMBERSHIP PROGRAM

The Group established membership program on behalf of the franchisees by offering discounts to the end customers of the retail stores for purchasing fruits and other food products. Members joining the membership program can enjoy the additional discount rates and promotion coupons for purchasing fruits and other food products in the retail stores. The Group does not reimburse its franchisees for those additional discounts and promotion coupons incurred in the promotion activities. These activities are borne at franchisees' own costs.

The Group initiated Xinxiang VIP paid membership plan since late 2018. End customers of franchisees may subscribe for the VIP membership for a 12-month period at a fixed fee payable to the Group. The VIP members will enjoy discount from the purchases at franchised stores equivalent to at least the membership fee paid. Otherwise, the Group will refund any shortfall to the end customers. Revenue is recognised in the same period when the obligation to refund to the end customers expires at the end of the 12th month, without considering the breakage. Any unexpired fee is recognised as financial liabilities in the consolidated statement of financial position.

The Group provides other services including system maintenance and support services to franchisees. Revenue are recognised when (or as) these services are performed in the accounting period in which the services are rendered.

Revenue is recognised when control of the products is transferred, being when the products are delivered to the customers, the customer has accepted the products, the collection of the related consideration is probable and there is no unfulfilled obligation that could affect the customer's acceptance of the products.

##### (D) FINANCING COMPONENTS

Except the initial franchisee fee payment by the franchisees and regional dealers exceeds one year, the Group does not expect to have any contracts where the period between the transfer of the promised goods or services to the customer and payment by the customer exceeds one year. The Group determines that the payment terms for initial franchisee fee payment were structured primarily for reasons other than the provision of finance to the Group. As a consequence, no significant element of financing is present and the Group does not adjust any of the transaction prices for the time value of money.

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Other borrowing costs are expensed in the year in which they are incurred.

### ACCOUNTING POLICY OF INTEREST INCOME

Interest income from financial assets at FVTPL is included in the fair value gains on these assets.

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income (Note 6).

Interest income is presented as other income where it is arisen from loans to franchisees and factoring amounts to regional dealers.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit-impaired financial assets the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

Such entities were entitled to a preferential CIT rate of 15% up to the expiry of the latest certificates in 2026. The further entitlement to such HNTE tax incentive is subject to the successful renewal of certificates by the PRC tax authority. According to Article 27 of the China Corporate Income Tax Law and Article 86 of the Implementation Regulation of the CIT Law, income and expenses attributable to processing of agricultural products are exempted from the CIT for the years ended 31 December 2022 and 2023, subject to annual review by the local PRC tax authority of the Company's subsidiaries.

在建資產按歷史成本減去任何減值虧損列賬。歷史成本包括直接與資產開發有關的支出，包括建築成本、建築期間土地使用權的攤銷、合格資產的借款成本以及開發期間產生的專業費用。於完成後，資產將轉至物業及設備項下的樓宇。

在建資產不計提折舊撥備。倘在建資產的賬面值高於其估計可收回金額，則有關資產的賬面值將及時撇減至可收回金額(附註42.4)。

#### DEPRECIATION METHODS AND USEFUL LIVES (CONTINUED)

The Group's fruit trees qualify as bearer plants under the definition in HKAS 41 "Agriculture" and are therefore accounted for under the principles for plant and equipment. Fruit trees are classified as immature until the produce can be commercially harvested which usually takes 2 to 4 years. At that point they are reclassified to mature fruit trees and depreciation commences. Immature fruit trees are measured at accumulated cost less impairment.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 42.4).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within "other gains, net" in the consolidated statement of profit or loss.

Assets under construction are stated at historical cost less any impairment loss. Historical cost includes expenditure that is directly attributable to the development of the assets which comprises construction costs, amortisation of land use rights during the construction period, borrowing costs on qualifying assets and professional fees incurred during the development period. On completion, the assets are transferred to buildings within property and equipment.

No depreciation is provided for assets under construction. The carrying amount of an asset under construction is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 42.4).

Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets may not be used as security for borrowing purposes.

### (D) EXTENSION OPTIONS

Extension options are included in a number of leases across the Group. These are used to maximise operational flexibility in terms of managing the assets used in the Group's operations. The majority of extension options held are exercisable only by the Group and not by the respective lessors.

#### ACCOUNTING POLICY OF LEASES

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of fixed payments (including in-substance fixed payments), less any lease incentives receivable.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and
- restoration costs.

就深圳易秒通、海陽津成泰、深圳般果及優果聯品牌以及優農道北京的業務合併分別確認商譽人民幣38,832,000元、人民幣130,946,000元、人民幣25,592,000元及人民幣678,000元。商譽不攤銷，但每年進行減值測試，倘事件或情況變化表明商譽可能受損，則測試頻率更高。商譽會被分配至本集團已識別現金產生單位，即運營附屬公司，即分別為深圳易秒通、海陽津成泰、深圳般果、優果聯品牌及優農道北京。與深圳易秒通、優果聯品牌和優農道北京相關的商譽屬於其他分部；而與海陽津成泰及深圳般果相關的商譽屬於交易分部。

本集團通過比較其可收回金額與其報告期末的賬面值，完成分配給現金產生單位的商譽的減值測試。商譽減值審查乃於現金產生單位的水平進行。本集團已分配商譽的現金產生單位的可收回金額根據使用價值計算確定。

使用價值乃根據管理層批准的5年財務預算，在稅前現金流預測中應用折現現金流模型釐定。使用的貼現率是稅前的，反映與相關操作相關的特定風險。每個時期的收入額是收入及成本的主要驅動力。收入及相關成本的增長乃根據過去的業績及管理層對市場發展的預期來估計。

Goodwill of RMB38,832,000, RMB130,946,000, RMB25,592,000 and RMB678,000 was recognised in relation to the business combinations of Shenzhen Yimiao Tong, Haiyang Jinchengtai, Shenzhen Banguo and Youguolian Brand and Younongdao Beijing respectively. Goodwill is not amortised but it is tested for impairment annually, or more frequently if events or changes in circumstances indicate that it might be impaired. It is allocated to the Group's CGUs identified, which are the operating subsidiaries, namely Shenzhen Yimiao Tong, Haiyang Jinchengtai, Shenzhen Banguo, Youguolian Brand and Younongdao Beijing respectively. The goodwill relating to Shenzhen Yimiao Tong, Youguolian Brand and Younongdao Beijing belong to the Others segment; whereas the goodwill relating to Haiyang Jinchengtai and Shenzhen Banguo belong to the Trading segment.

The Group completed its impairment test on goodwill allocated to the CGUs by comparing their recoverable amounts to their carrying amounts as at the end of the reporting period. Goodwill impairment reviews have been performed at the level of CGUs. The recoverable amounts of the Group's CGUs with goodwill allocated are determined based on VIU calculations.

The VIU was determined by applying discounted cash flow model on pre-tax cash flow projections based on 5-year financial budgets approved by management. The discount rate used is pre-tax and reflects specific risks related to the relevant operation. The volume of revenue in each period is the main driver for revenue and costs. The growth in revenue and the relevant costs are estimated based on past performance and management's expectations for the market development.

No impairment loss of the associated goodwill should be recognised in view of the fact that there was no significant adverse changes of the financial performance and development of Shenzhen Banguo since the step acquisition on 30 November 2023 and the directors and management have considered and assessed reasonably possible changes for the above assumptions and have not identified any instances that could cause the carrying amount of Shenzhen Banguo to exceed its VIU.

Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold.

Goodwill is allocated to CGUs for the purpose of impairment testing. The allocation is made to those CGUs units or groups of CGUs units that are expected to benefit from the business combination in which the goodwill arose. The units or groups of units are identified at the lowest level at which goodwill is monitored for internal management purposes, being the relevant operating subsidiaries.

##### (B) TRADEMARKS

Separately acquired trademarks are shown at historical cost. Trademarks acquired in a business combination are recognised at fair value at the acquisition date. They have a finite useful life and are subsequently carried at cost less accumulated amortisation and impairment losses.

The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as finance costs.

Where the terms of a financial liability are renegotiated and the entity issues equity instruments to a creditor to extinguish all or part of the liability (debt for equity swap), a gain or loss is recognised in profit or loss, which is measured as the difference between the carrying amount of the financial liability and the fair value of the equity instruments issued.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

- (d) Shenzhen Banguo, a company incorporated in the PRC, which is principally engaged in providing centralised platform services for purchasing of fruits, was a 31.42% associate of the Group before the acquisition. On 30 November 2023, Pagoda Investment entered into a formal sale and purchase agreement, pursuant to which Pagoda Investment conditionally agreed to purchase 19.58% equity interest in Shenzhen Banguo for a cash consideration of RMB14,377,000. Upon completion of the transaction, the Group held 51% equity interest in Shenzhen Banguo, 51% equity interest in Beijing Guolian, a subsidiary of Shenzhen Banguo, and 30% equity interest of Changchun Yueguoduo, a subsidiary of Beijing Guolian. For detail of business combination, please refer to Note 35.

本集團採用收購會計法將業務合併入賬。

集團公司之間的公司間交易、交易結餘及未變現收益均予對銷。除非交易有證據表明已轉移資產已發生減值，否則未變現虧損亦會對銷。附屬公司之會計政策已作出必要變動，以確保與本集團所採納之政策貫徹一致。

##### (A) SUBSIDIARIES

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group.

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss, consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated statement of financial position respectively.

#### (B) 聯營公司

聯營公司為本集團對其具有重大影響力但無控制權或共同控制權的所有實體。這一般為當本集團持有20%至50%投票權的情況。於聯營公司的權益乃於初步按成本確認後，使用權益會計法(見下文(d))入賬。

#### (C) 合營企業

於初步按成本在合併財務狀況表內確認後，於合營企業的權益使用權益法入賬(請參閱下文(d))。

#### (D) 權益會計法

根據權益會計法，於聯營公司及合營企業投資初步按成本確認，並於其後作出調整以在損益中確認本集團應佔的被投資公司的收購後利潤或虧損，及在其他綜合收益中確認本集團應佔的被投資公司的其他綜合收益變動。已收或應收聯營公司股息均確認為投資賬面值的扣減項。

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Interests in associates are accounted for using the equity method of accounting (see (d) below), after initially being recognised at cost.

#### (C) JOINT VENTURE

Interest in joint venture is accounted for using the equity method (see (d) below), after initially being recognised at cost in the consolidated statement of financial position.

#### (D) EQUITY ACCOUNTING

Under the equity method of accounting, the investments in associates and joint venture are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from associates are recognised as a reduction in the carrying amount of the investment.

Unrealised gains on transactions between the Group and its associates and joint venture are eliminated to the extent of the Group's interest in these entities. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of equity accounted investees have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-accounted investments is tested for impairment in accordance with the policy described in Note 42.4.

- fair value of any asset or liability resulting from a contingent consideration arrangement; and

Acquisition-related costs are expensed as incurred. The excess of the consideration transferred, amount of any non-controlling interest in the acquired entity, and acquisition-date fair value of any previous equity interest in the acquired entity over the fair value of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the business acquired, the difference is recognised directly in profit or loss as a bargain purchase.

Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions. Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

Items included in the consolidated financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in RMB, which is the Company's functional and presentation currency and the Group's presentation currency.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equity investments held at FVTPL are recognised in the consolidated statement of profit or loss as part of the fair value gains or losses.

Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's FVLCOD and VIU. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units, or CGUs). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

Regular way purchases and sales of financial assets are recognised on trade-date, which is the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

Financial asset at FVOCI: Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through other comprehensive income, except for the recognition of impairment gains or losses, interest income and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in other comprehensive income is reclassified from equity to profit or loss and recognised in "other gains, net". Interest income from these financial assets is included in finance income using the effective interest rate method.

Financial asset at FVTPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVTPL. A gain or loss on a debt investment that is subsequently measured at FVTPL is recognised in profit or loss and presented net within other losses, net in the period in which it arises.

##### 權益工具

Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

就貿易應收款項而言，本集團應用香港財務報告準則第9號允許的簡化方式，其規定自首次確認應收款項起確認預期全期虧損。進一步詳情見附註3.1(b)及附註23。

貿易應收款項指就於一般業務過程中出售貨品或提供服務而應收客戶之款項。

貿易及其他應收款項初始按無條件代價金額確認，惟倘其包含重大融資部分，則按公允價值確認。本集團持有貿易和其他應收款項的目的是收取合同現金流量，因此其後使用實際利率法按攤銷成本計量。

The Group assesses on a forward looking basis the expected credit losses (“ECL”) associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables. See Note 3.1 (b) and Note 23 for further details.

#### 42.6 TRADE AND OTHER RECEIVABLES

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business.

Trade and other receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade and other receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

尚有多項類似責任，履行責任導致資源流出的可能性乃透過考慮整體責任類別釐定。即便在同一責任類別內任何一個項目相關資源的流出可能性可能屬於輕微，亦須確認撥備。

撥備乃按於報告期末結算現時責任所需之管理層最佳預計開支的現值計量。使用作釐定現值的貼現率為稅前貼現率，其能反映對貨幣時間價值及負債特定風險的現時市場評估。隨著時間流逝增加的撥備乃確認為利息開支。

### 42.7 PROVISIONS

Provisions for legal claims and make good obligations are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

Impairment testing of the investments in subsidiaries and associates is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

經營分部的呈報方式與向主要經營決策者(「主要經營決策者」)提供的內部報告貫徹一致。主要經營決策者負責分配資源及評估經營分部之業績，並已確定為作出策略決定的本公司執行董事。

### 42.10 投資物業

投資物業為賺取長期租金收益而持有，並不由本集團擁有。投資物業最初按成本計量，包括相關交易成本及借款成本(如適用)。隨後，彼等按公允價值列賬。公允價值變動於損益中列示，作為其他收益淨額的一部分。

### 42.11 抵銷金融工具

當本集團有法定可執行權力可抵銷已確認金額，並有意按淨額基準結算或同時變現資產及結算負債時，金融資產與負債可互相抵銷，並在合併財務狀況表內報告其淨額。該法定可執行權力不可以取決於未來事情及必須於日常業務及於集團實體或交易對手違約、無力償債或破產時執行。

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker (“CODM”). The CODM, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors of the Company, who make strategic decisions.

### 42.10 INVESTMENT PROPERTY

Investment properties are held for long-term rental yields and are not occupied by the Group. Investment property is initially measured at cost, including related transaction costs and where applicable borrowing costs. Subsequently, they are carried at fair value. Changes in fair values are presented in profit or loss as part of other gains, net.

### 42.11 OFFSETTING FINANCIAL INSTRUMENTS

Financial assets and liabilities are offset and the net amount is reported in the consolidated statement of financial position when the Group has a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the group entities or the counterparty.

生物資產包括於農場採收前的新鮮水果，由於採收期短，故分類為流動資產。

銷售成本包括增量銷售成本，包括拍賣師的費用、支付給經紀人和交易商的佣金以及估計的市場運輸成本，但不包括財務成本和所得稅。

果樹是承載植物，因此作為財產、廠房及設備列報和核算（附註14）。然而，生長在樹上的新鮮水果果實採收之前被視為生物資產。採收的新鮮水果果實以採收時公允價值減去出售的成本轉入存貨。

採收前的新鮮水果果實的公允價值變動在合併損益表中確認。

農業成本（如化肥、殺蟲劑及勞動力成本）資本化為生物資產。

#### 42.12 BIOLOGICAL ASSETS

Biological assets comprise fresh fruits before harvested in farms and are classified as current assets due to short harvesting period.

Biological assets are measured at fair value less cost to sell, see Note 3.3 for further information on determining the fair value.

Costs to sell include the incremental selling costs, including auctioneers' fees, commission paid to brokers and dealers and estimated costs of transport to the market but excludes finance costs and income taxes.

The fruit trees are bearer plants and are therefore presented and accounted for as property, plant and equipment (Note 14). However, the fresh fruit bunches growing on the trees is accounted for as biological assets until the point of harvest. Harvested fresh fruit bunches are transferred to inventory at fair value less costs to sell when harvested.

Changes in fair value of fresh fruit bunches on trees are recognised in the consolidated statement of profit or loss.

Farming costs such as fertilisers, pesticides and labour costs are capitalised in biological assets.

Where the Company purchases its equity share capital (treasury shares), the consideration paid, including any directly attributable incremental costs (net of income taxes), is deducted from equity attributable to the Company's equity holders until the shares are cancelled or reissued. Where such shares are subsequently reissued, any consideration received, net of any directly attributable incremental transaction costs and the related income tax effects, is included in equity attributable to the Company's equity holders.

### 42.14 TRADE AND OTHER PAYABLES

These amounts represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. The amounts are unsecured. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the date of the consolidated statement of financial position in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

It is probable that taxable profit will be available against which the deductible temporary difference can be utilised. 根據中國的規則及規例，本集團在中國的僱員參加由中國有關市政府和省府組織的多項界定供款退休福利計劃，據此，本集團及在中國的僱員須每月按僱員工資的百分比計算向該等計劃供款。

In accordance with the rules and regulations in the PRC, the PRC based employees of the Group participate in various defined contribution retirement benefit plans organised by the relevant municipal and provincial governments in the PRC under which the Group and the PRC based employees are required to make monthly contributions to these plans calculated as a percentage of the employees' salaries.

Government grants relating to property, plant and equipment are included in non-current liabilities as deferred government grants and are credited to the consolidated statement of profit or loss on a straight line basis over the expected lives of the related assets.
